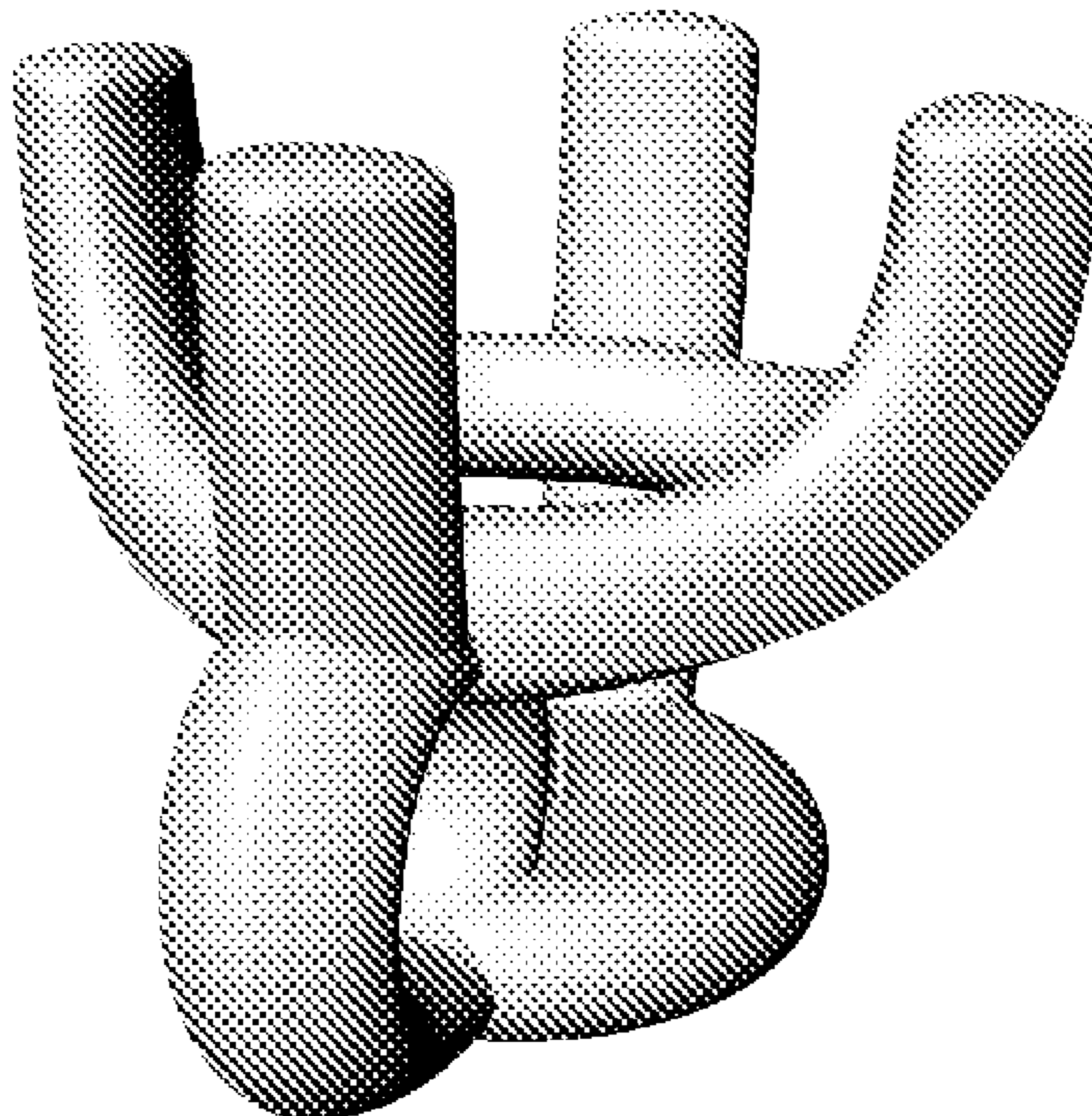
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective of the pendant;
FIG. 2 is a front view of the pendant illustrated in FIG. 1;
FIG. 3 is a top perspective of the pendant illustrated in FIG. 1;
FIG. 4 is a top view of the pendant illustrated in FIG. 1;
FIG. 5 is a right perspective of the pendant illustrated in FIG. 1;
FIG. 6 is a right elevational view of the pendant illustrated in FIG. 1 (the left elevational view is a mirror image of FIG. 1.);
FIG. 7 is a bottom perspective of the pendant illustrated in FIG. 1; and,

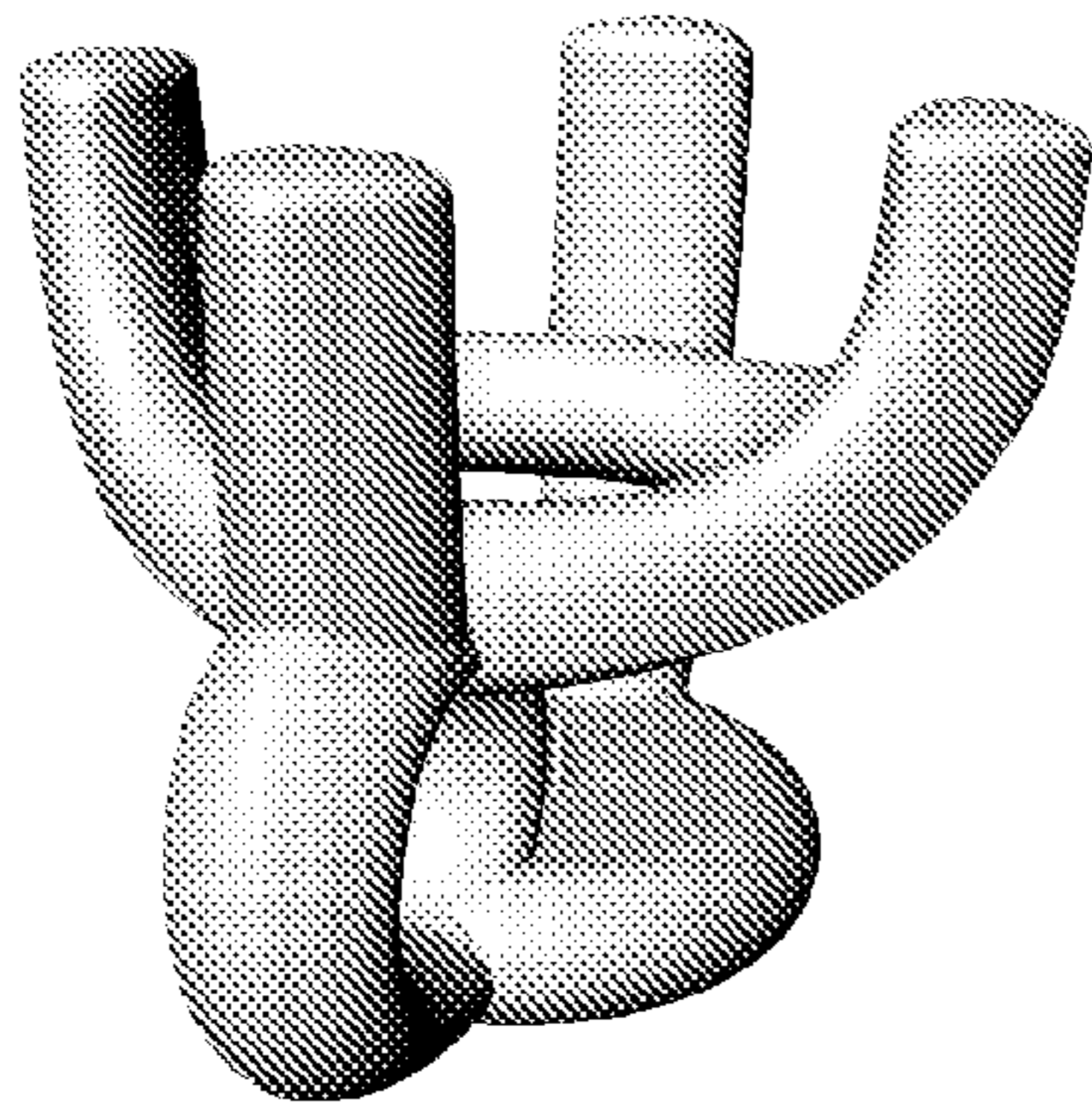

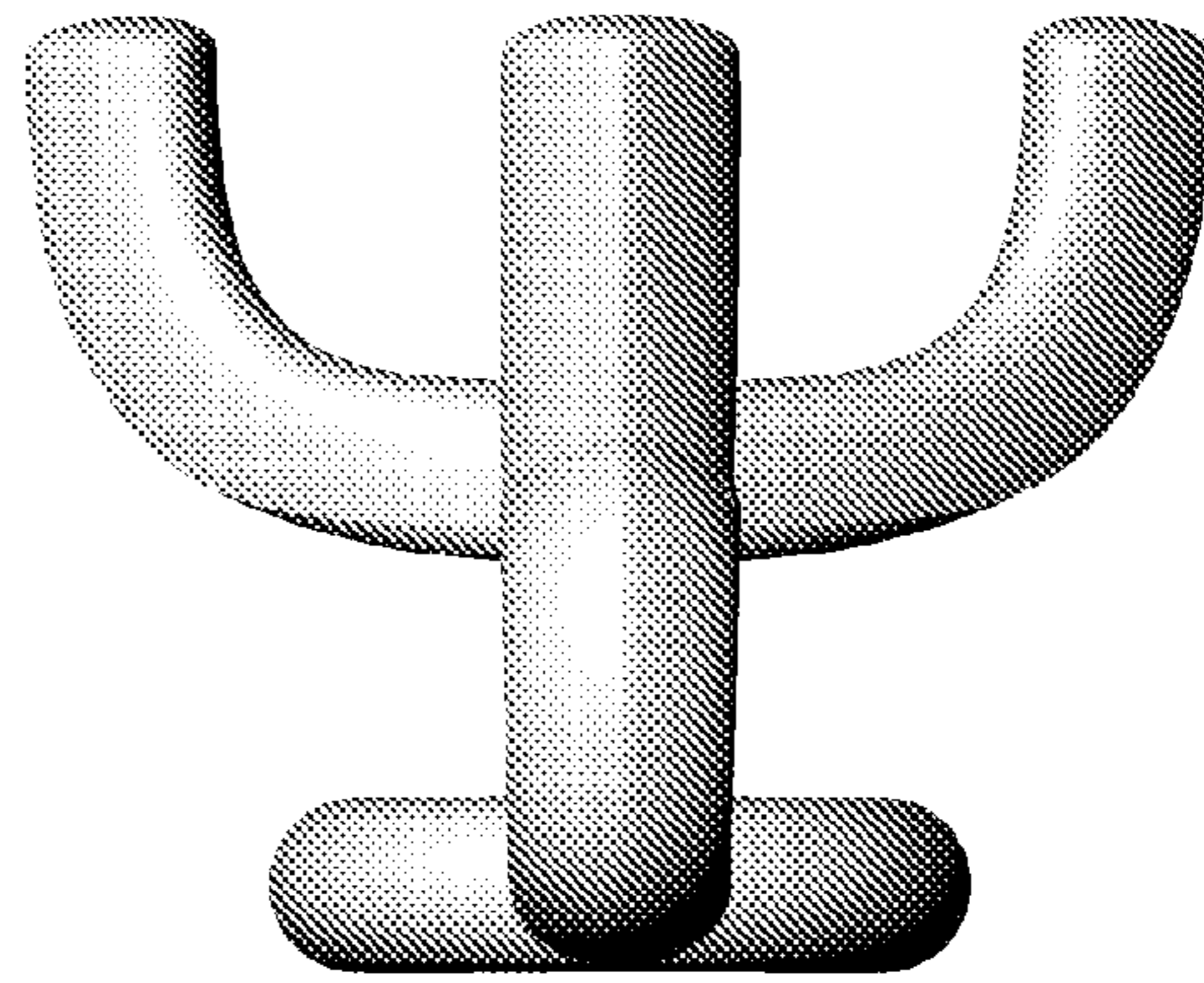

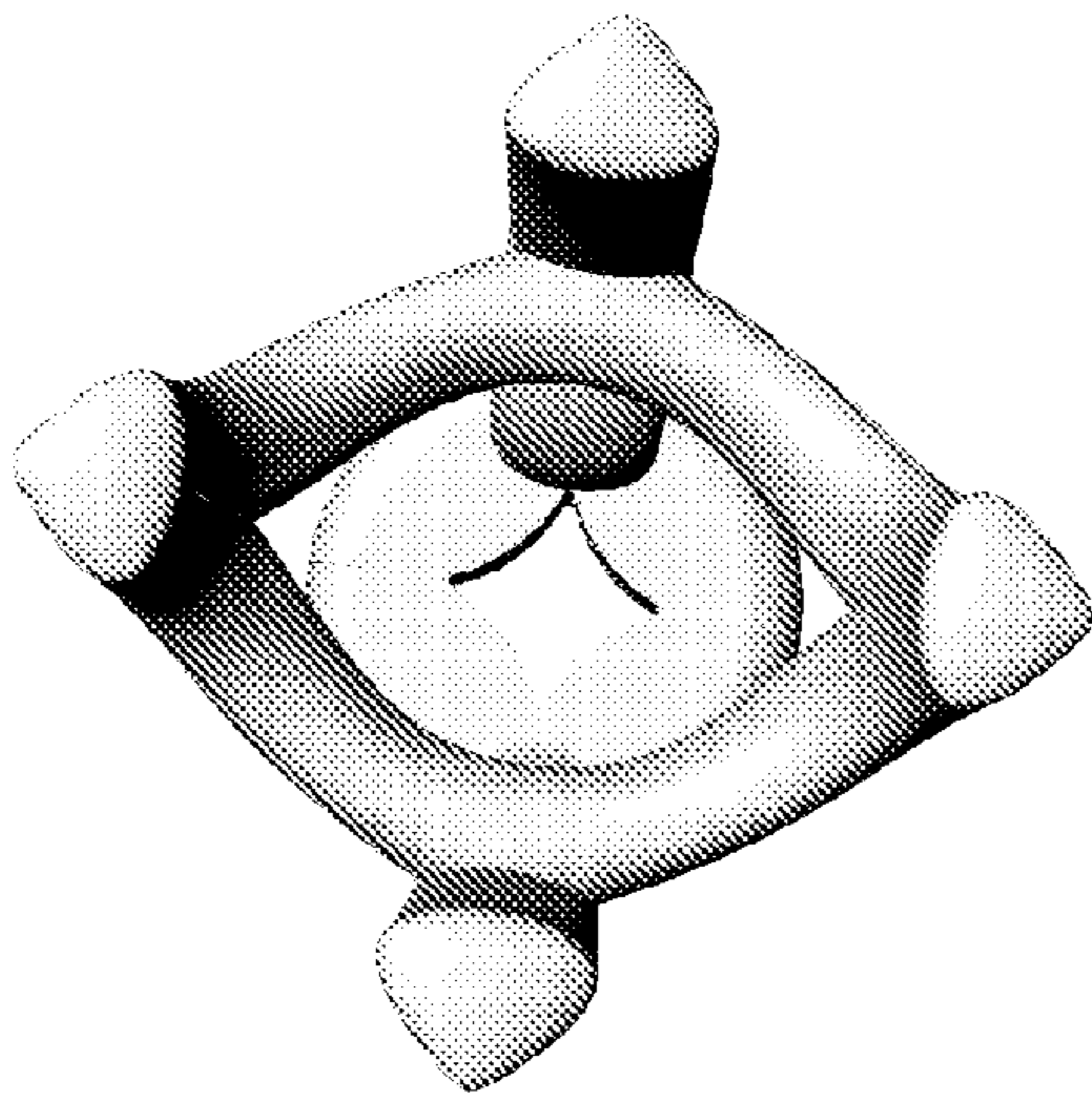

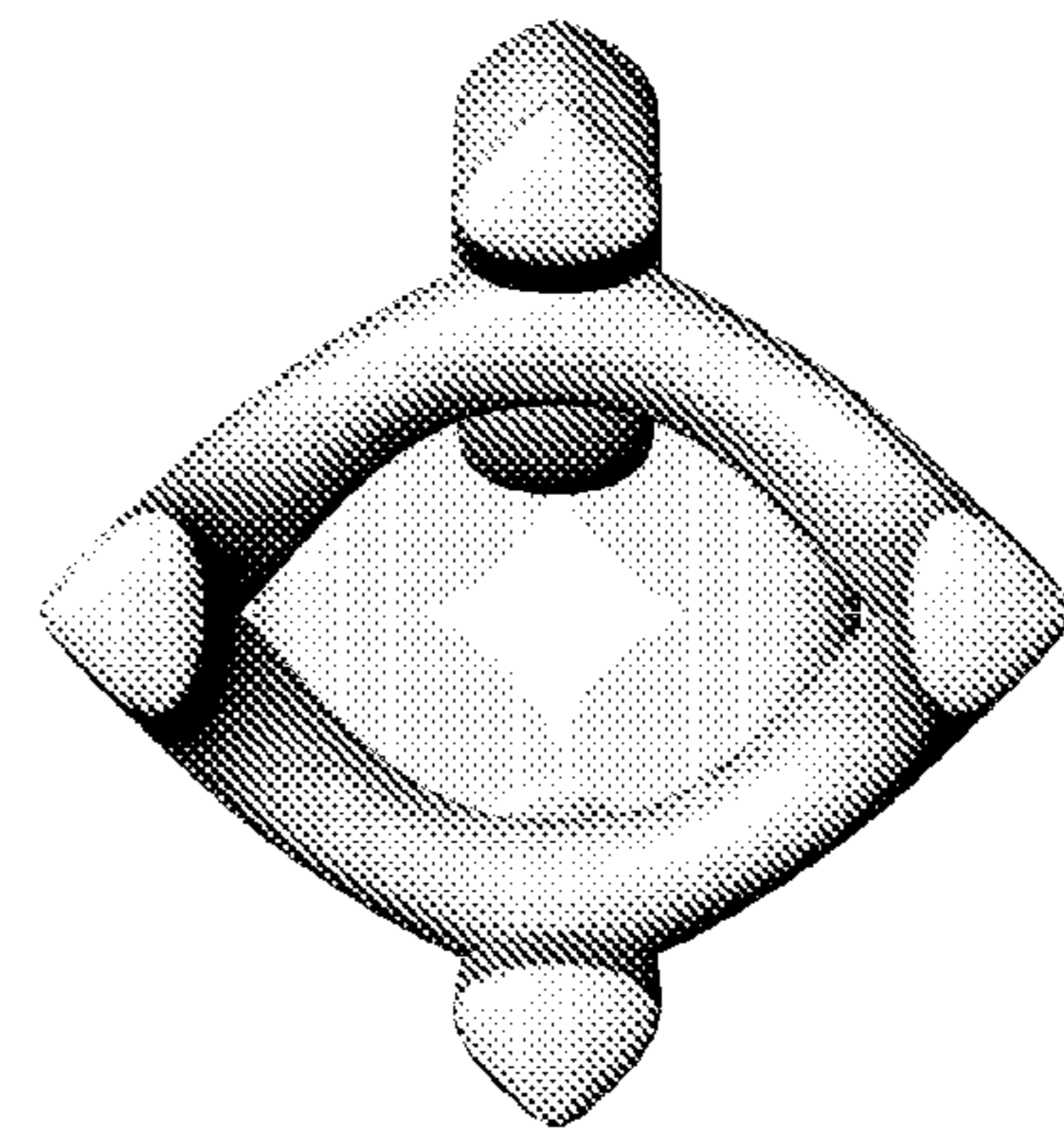

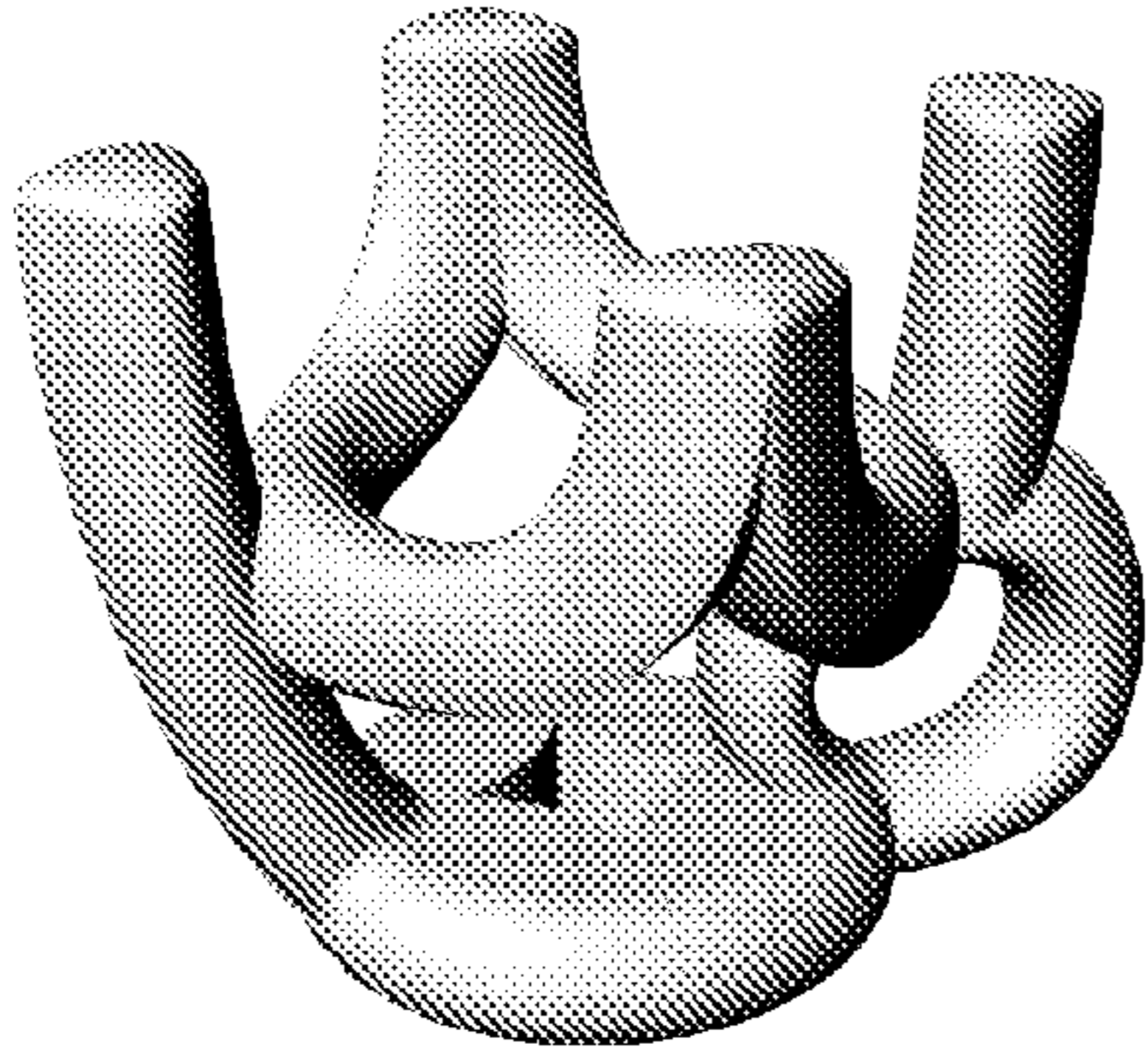

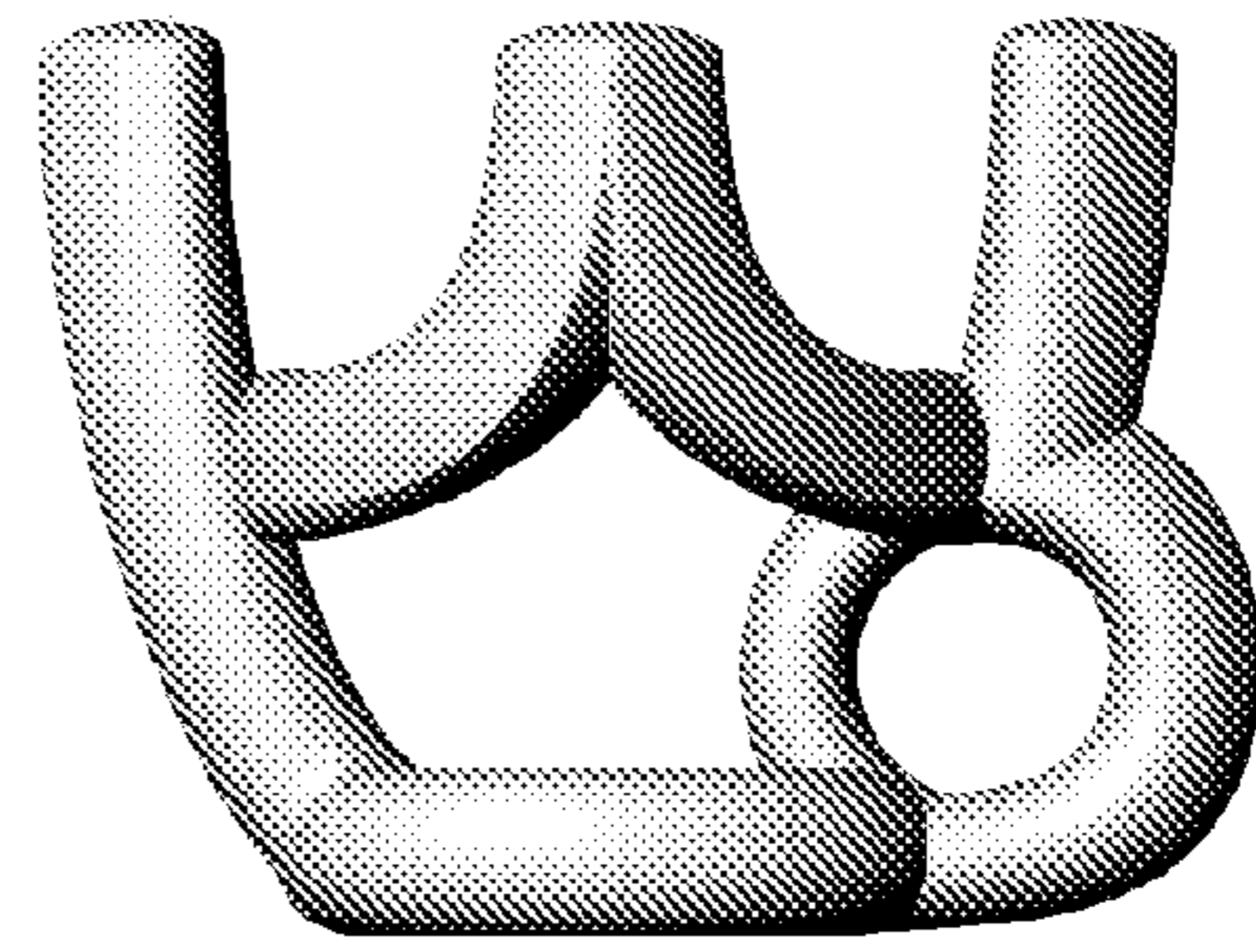

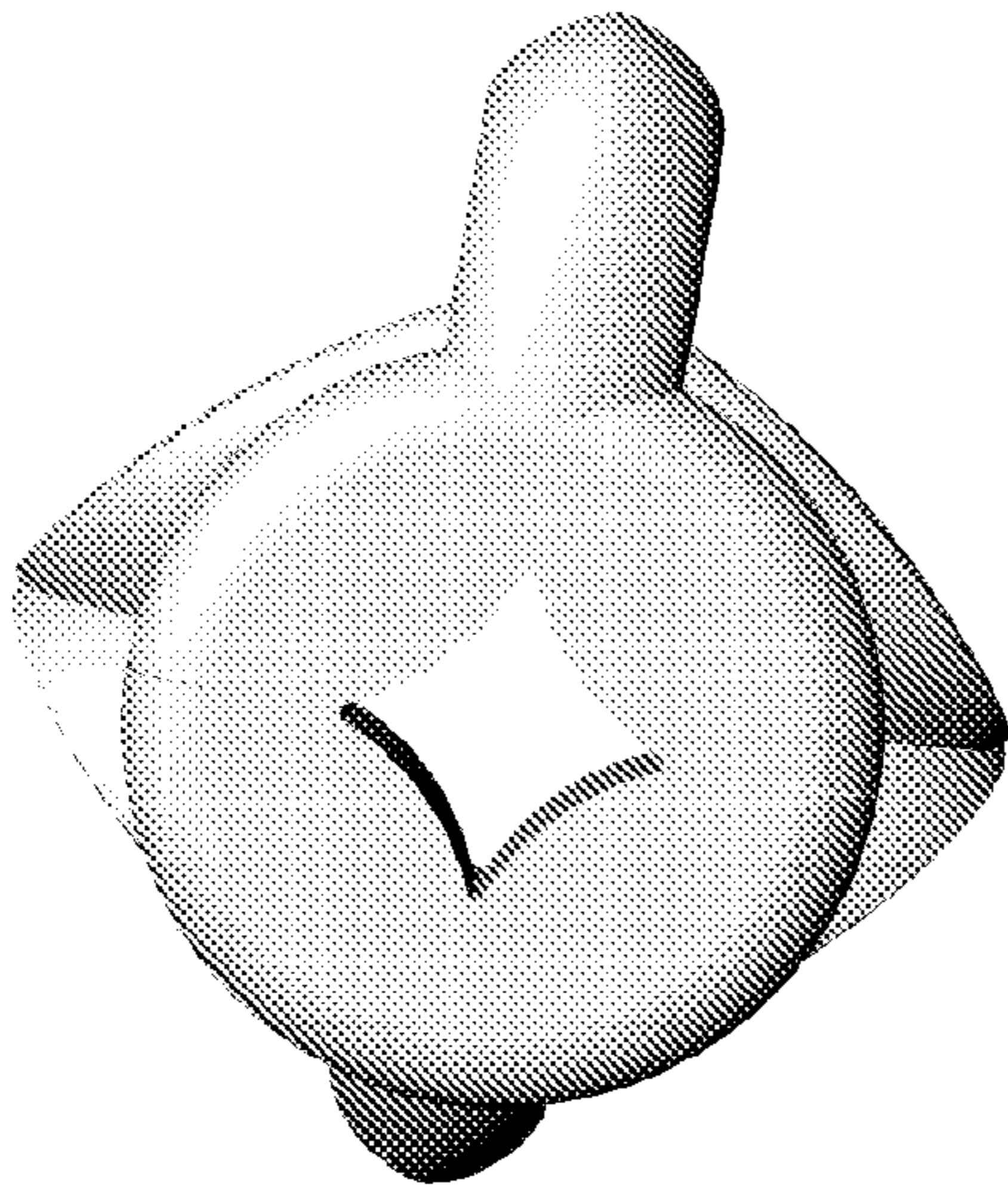

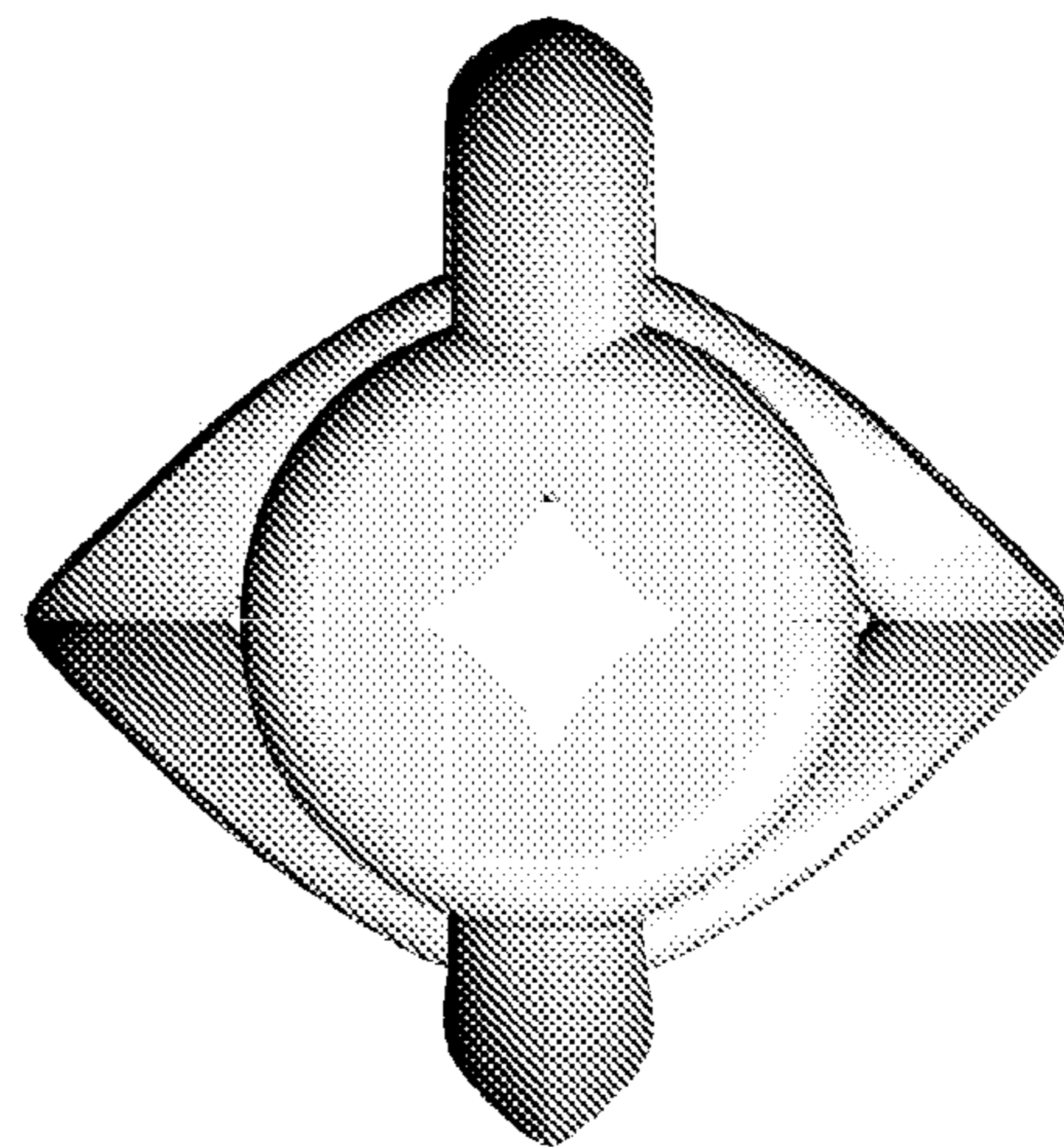
