(57) **CLAIM**

The ornamental design for a plant pot, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a plant pot, showing my new design; FIG. 2 is a rear view thereof; FIG. 3 is a top view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a left side view thereof; and, FIG. 7 is a perspective view thereof.

The broken line showings of the plant pot in FIGS. 3 and 7 are for the purpose of illustrating details of the bottom base of the plant pot and form no part of the claimed design.

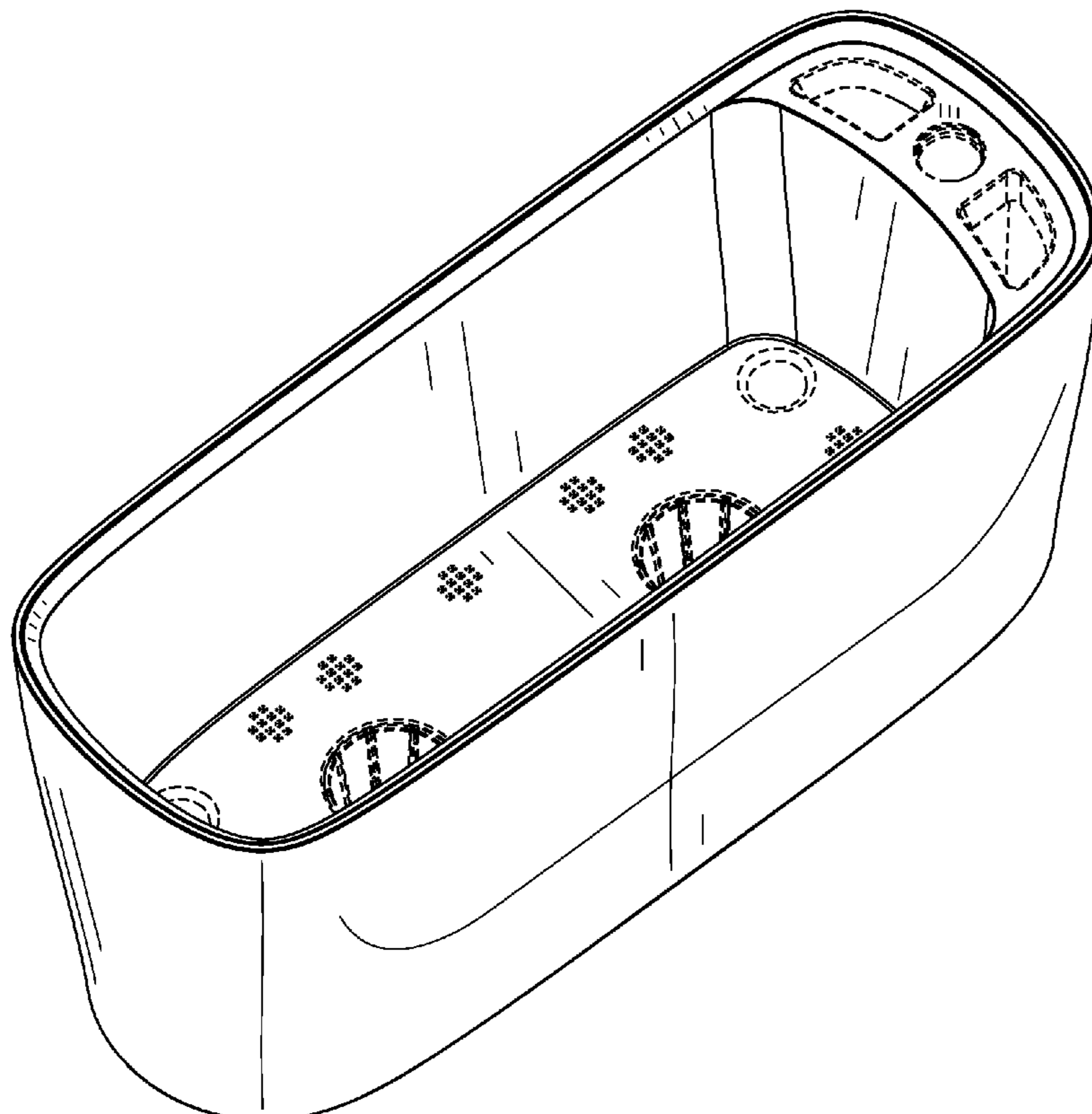

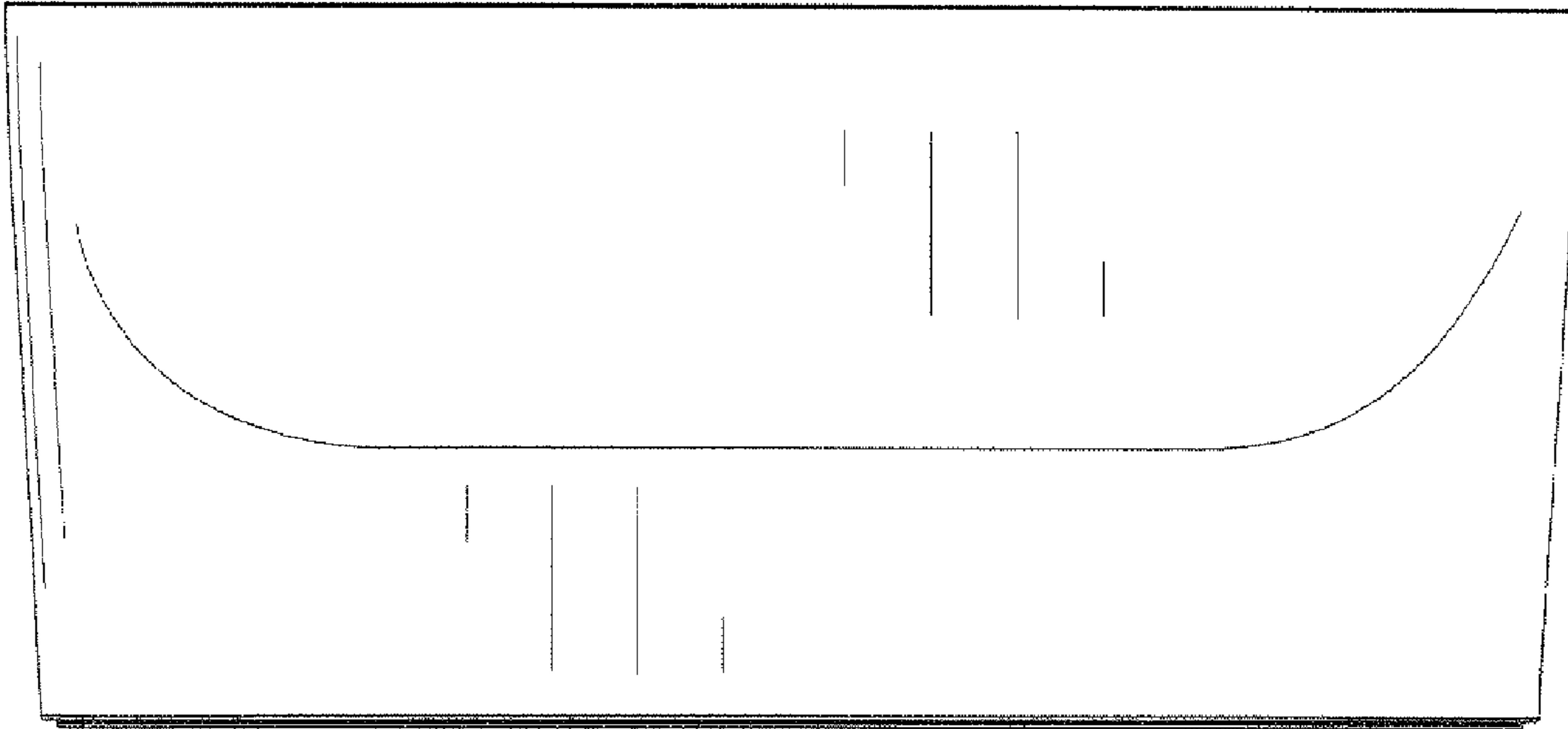

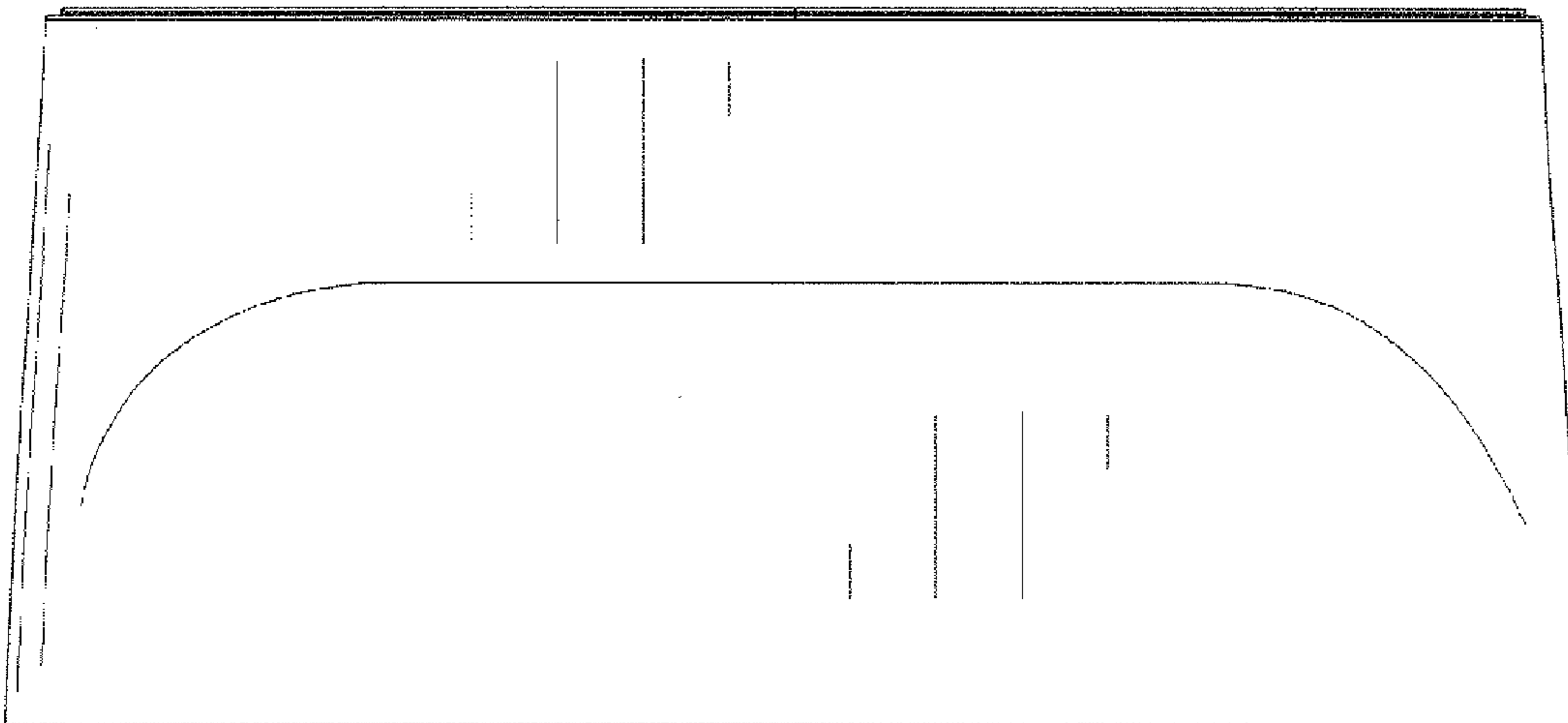

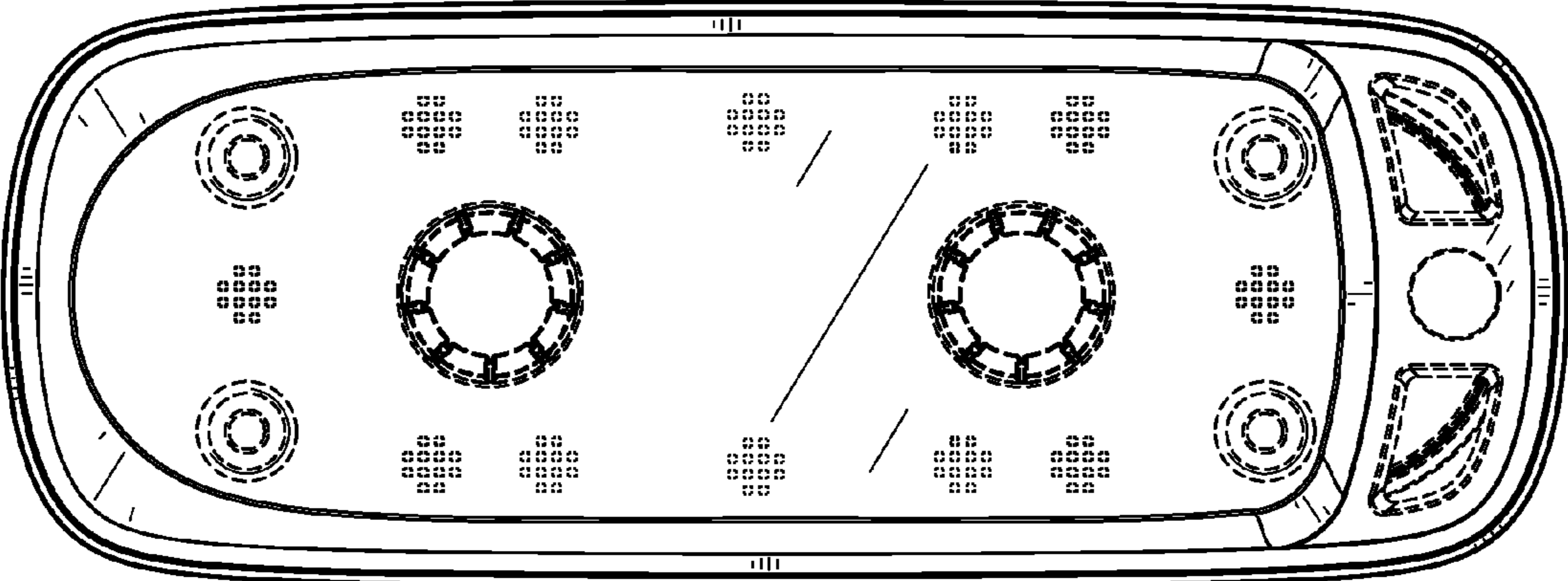

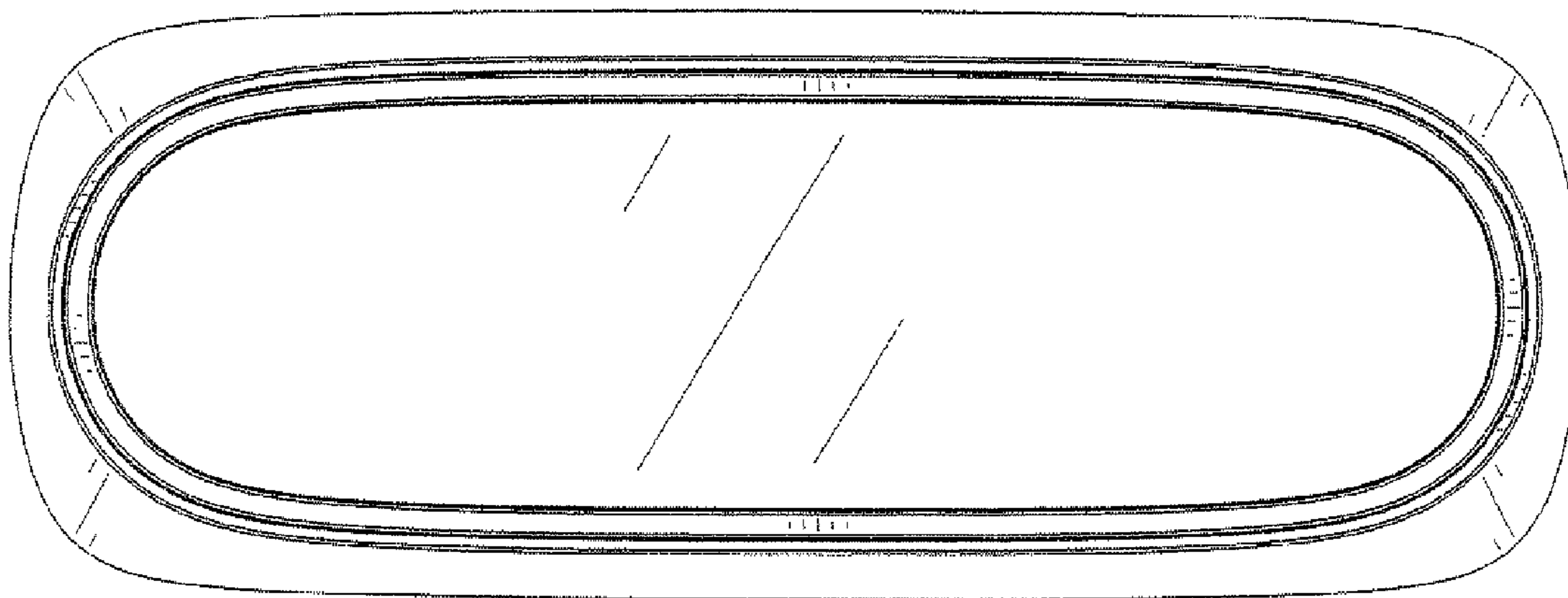

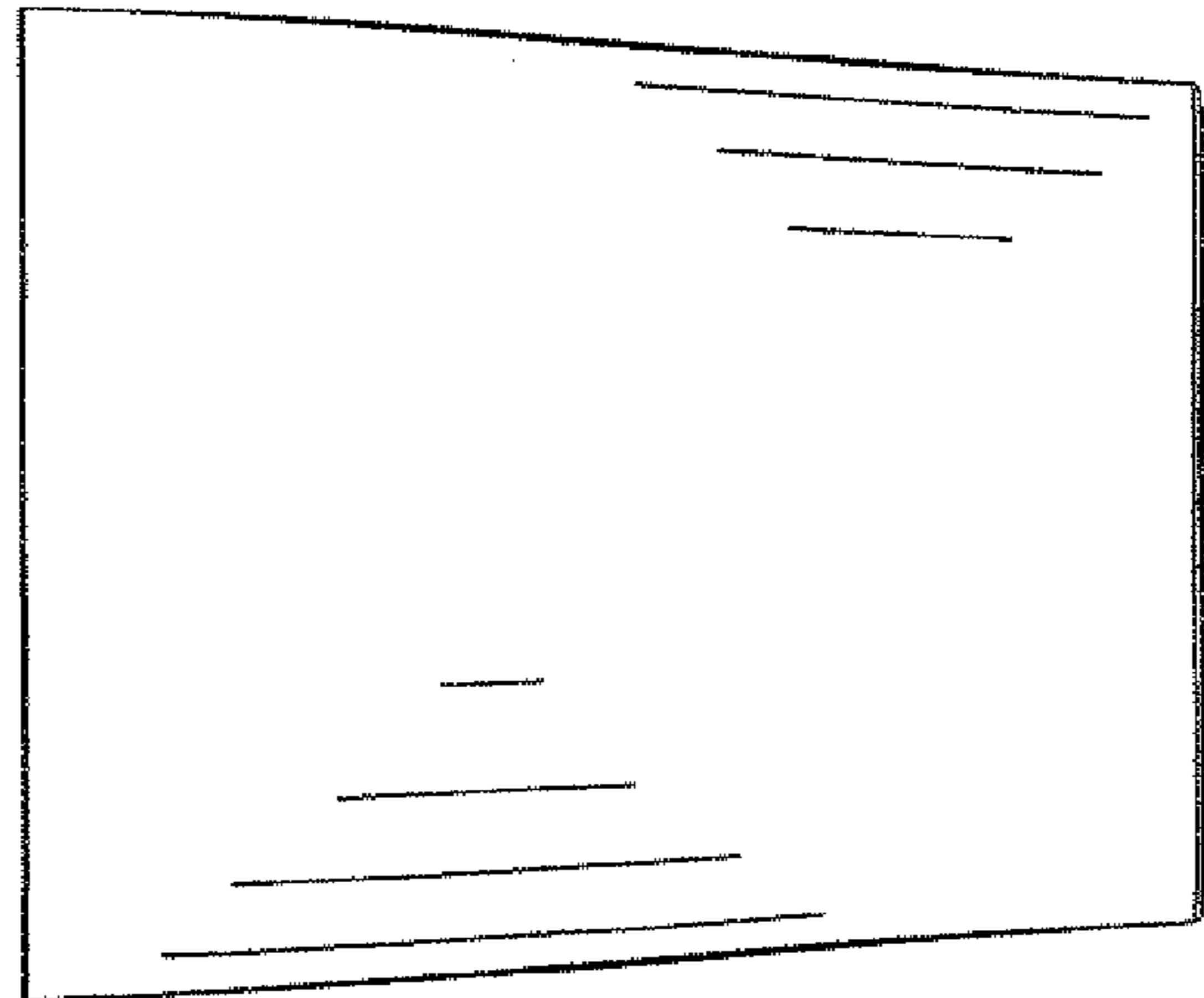
