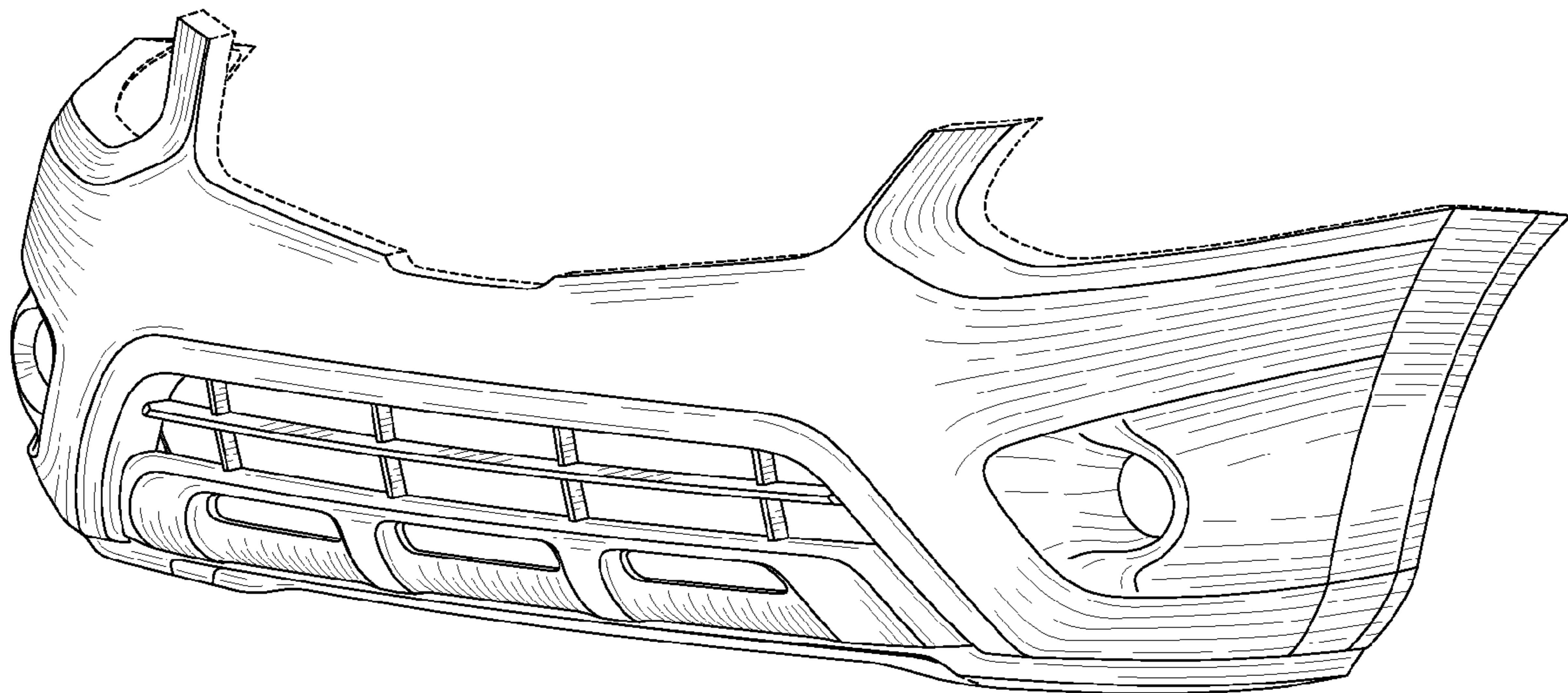
(57) **CLAIM**

The ornamental design for a front bumper for an automobile, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a front bumper for an automobile in accordance with my new design;

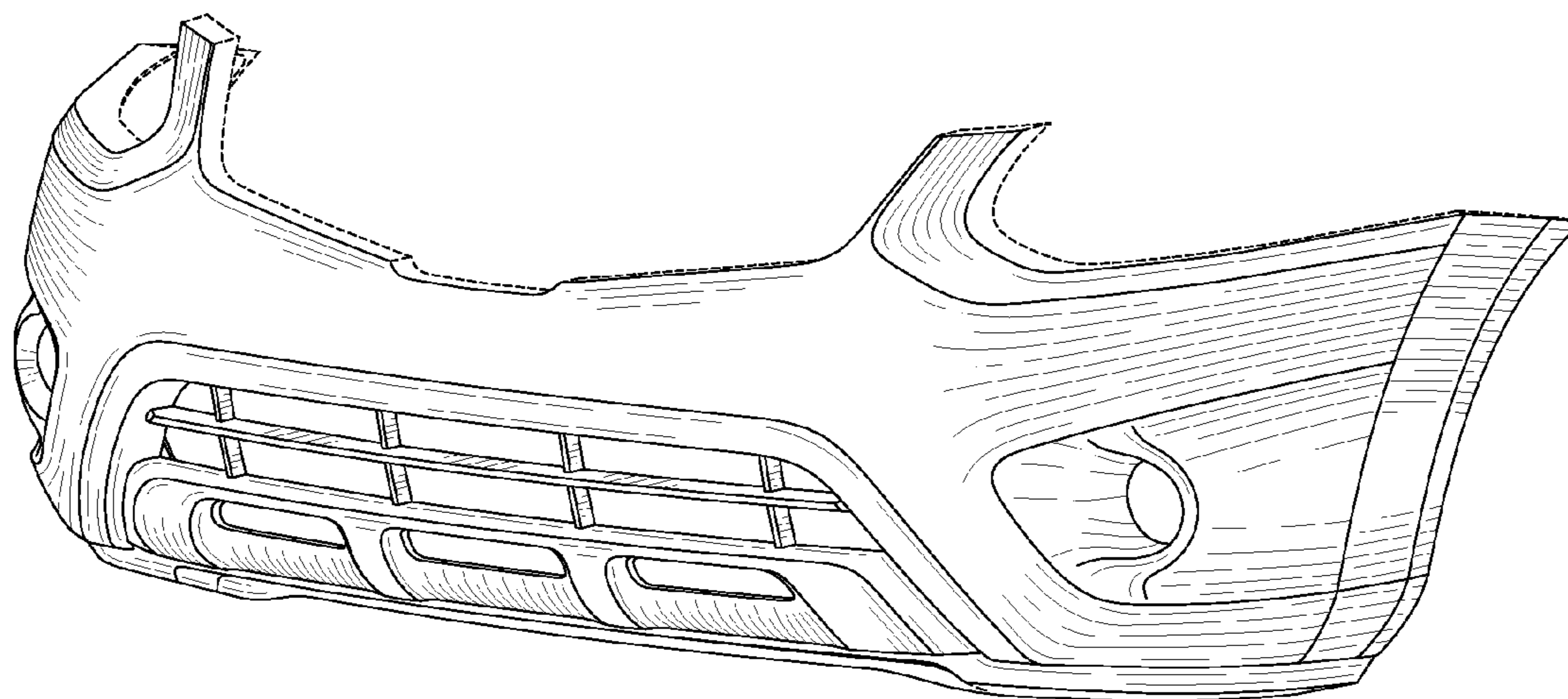

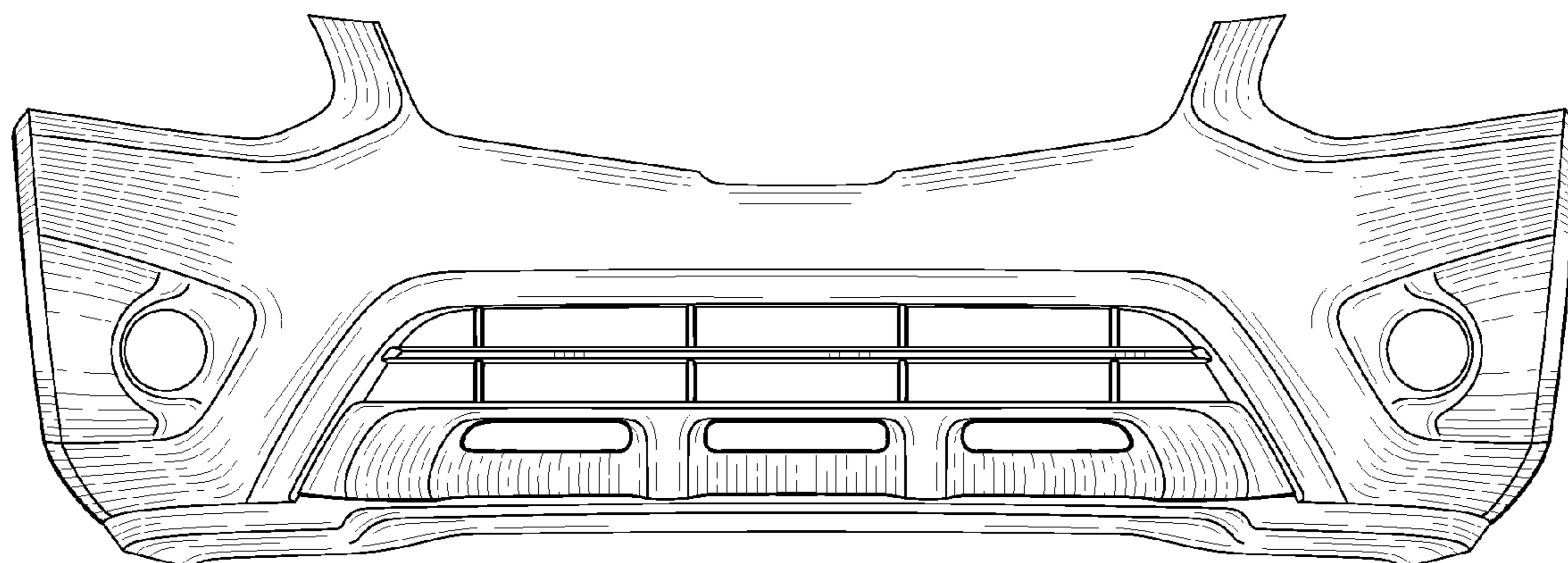

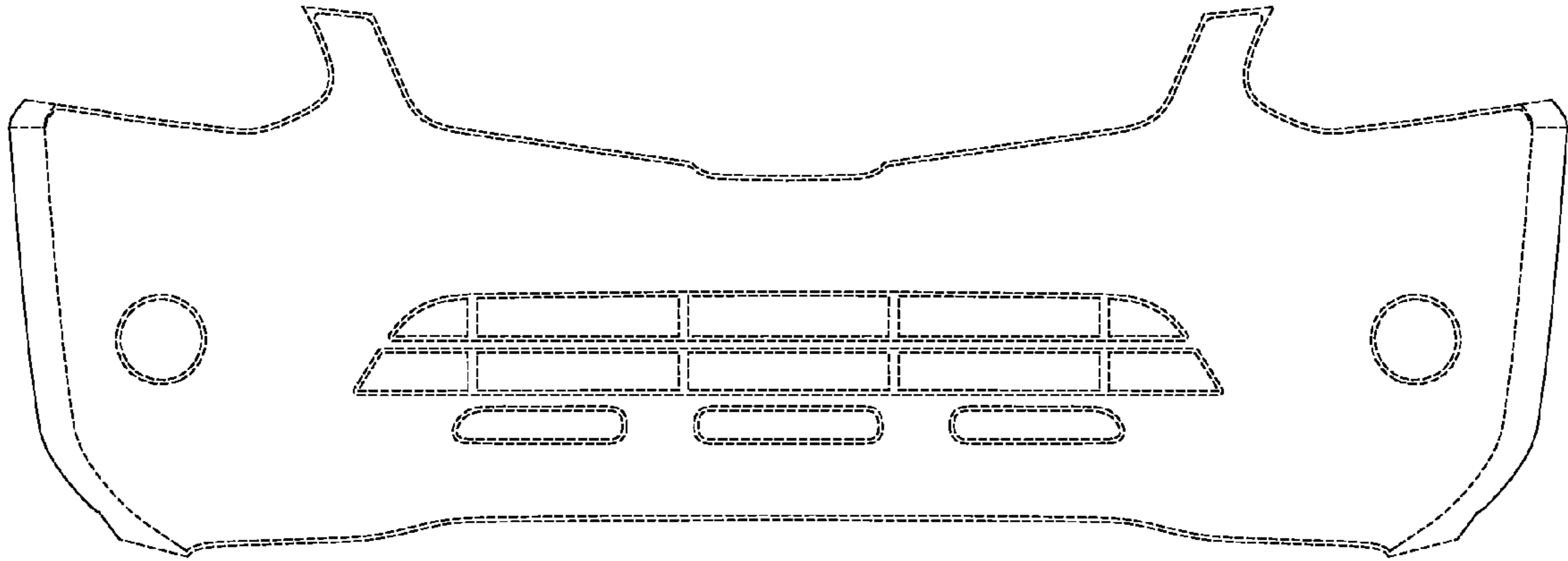

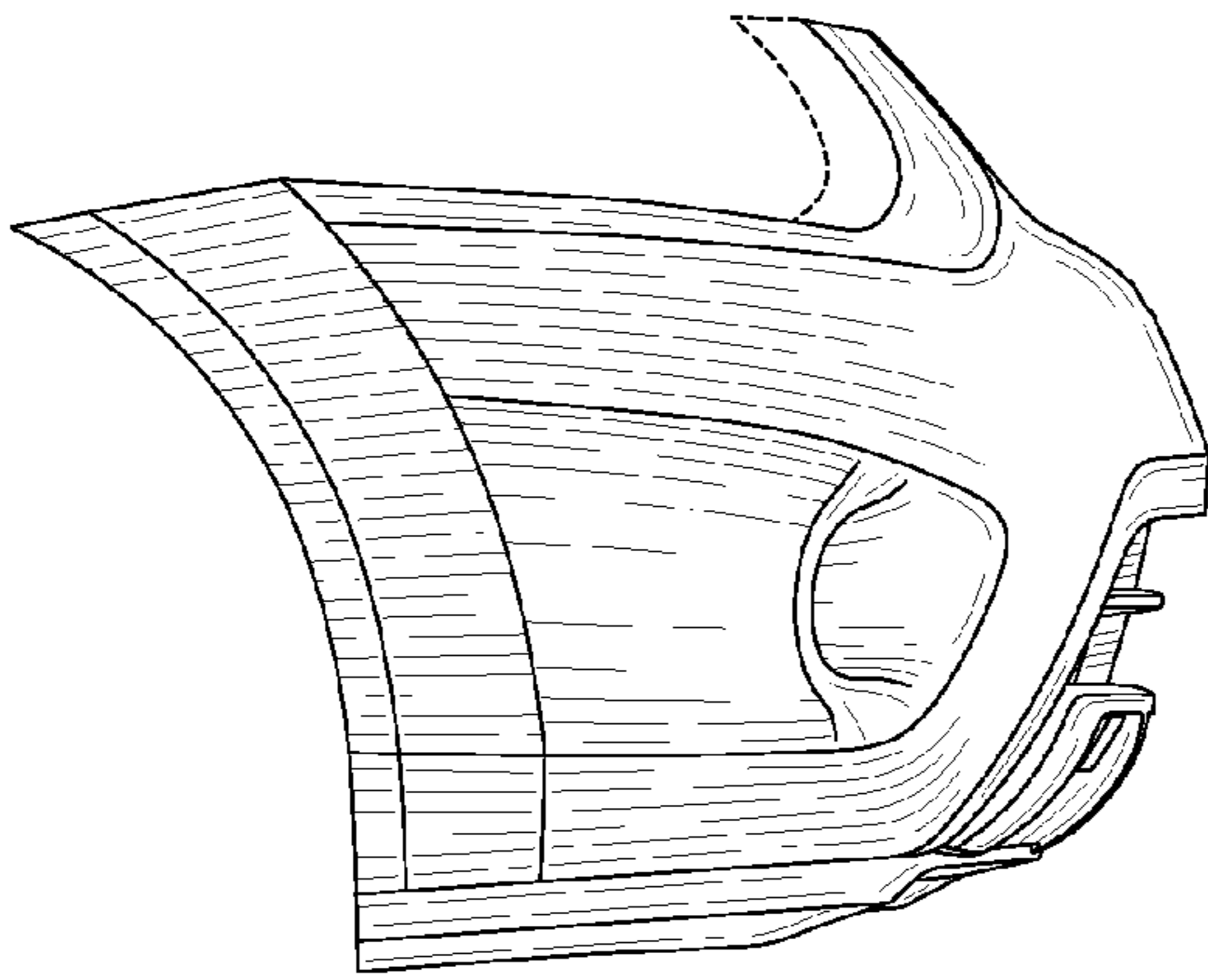

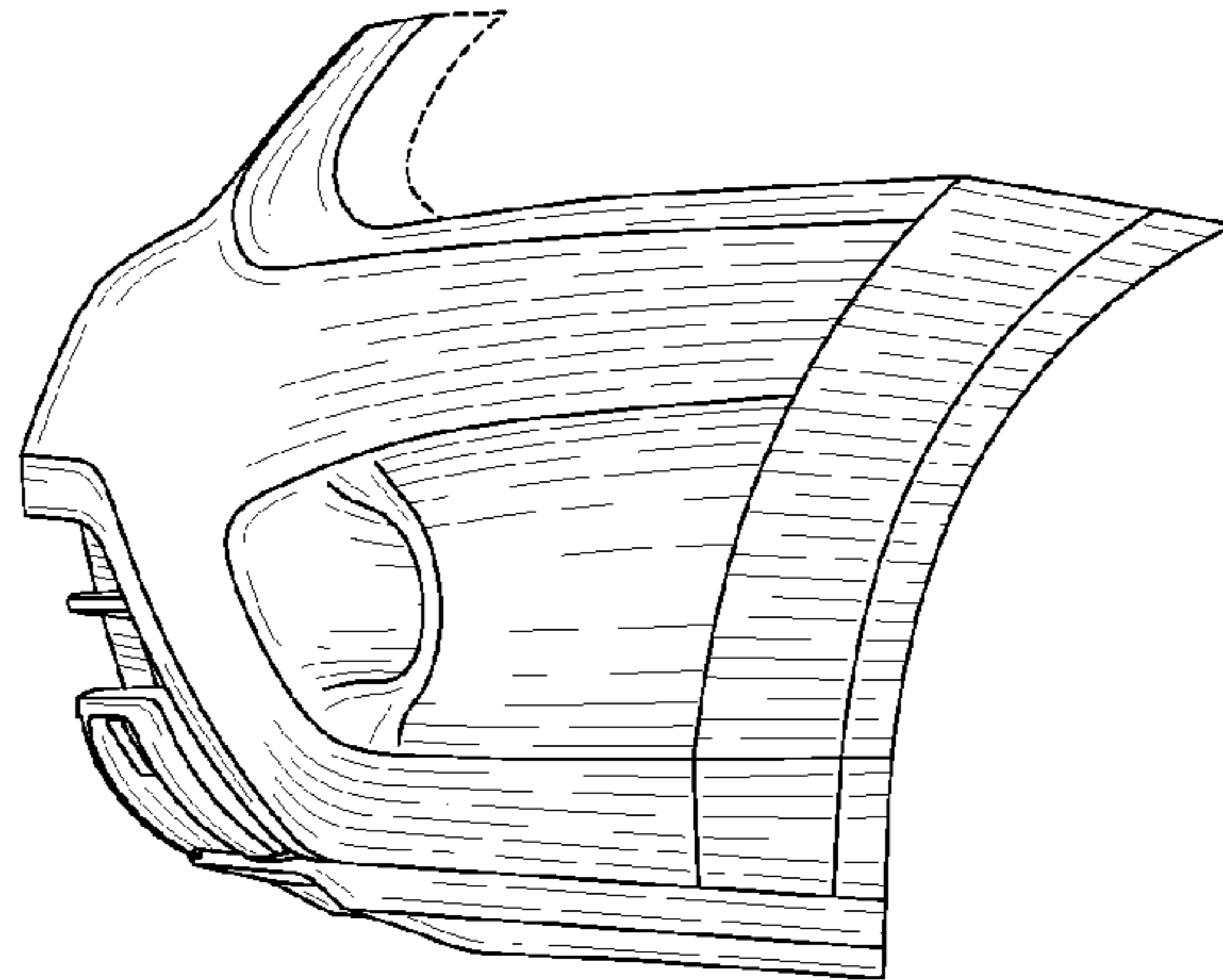

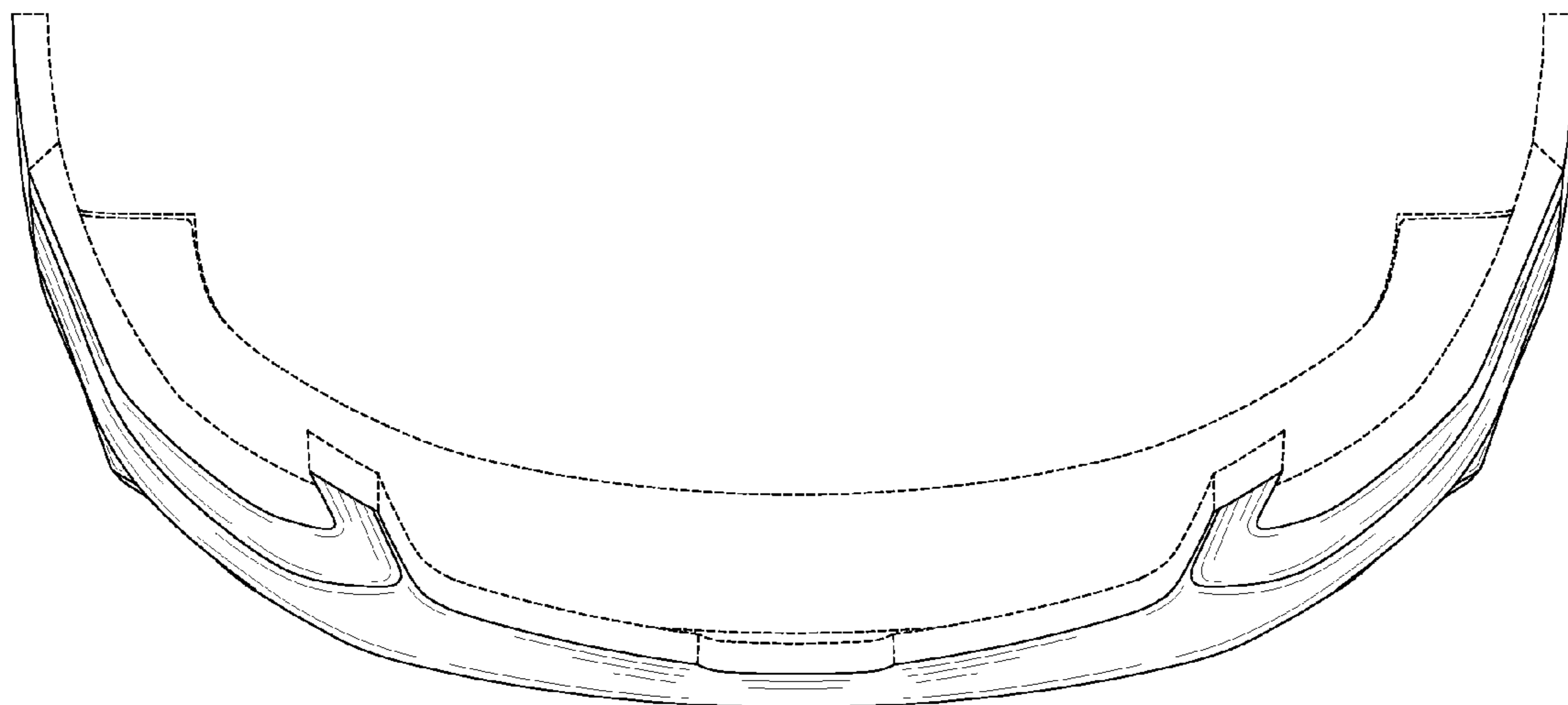

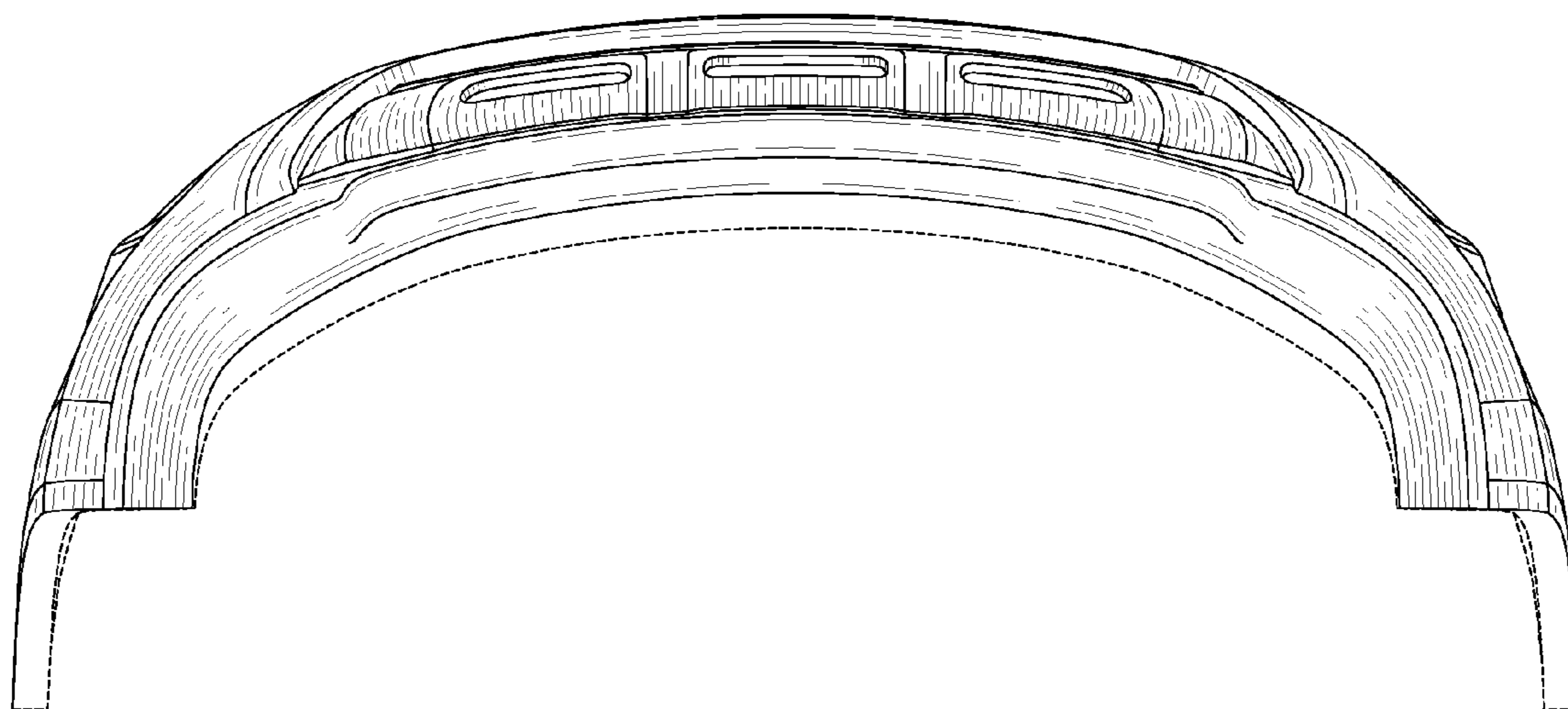
