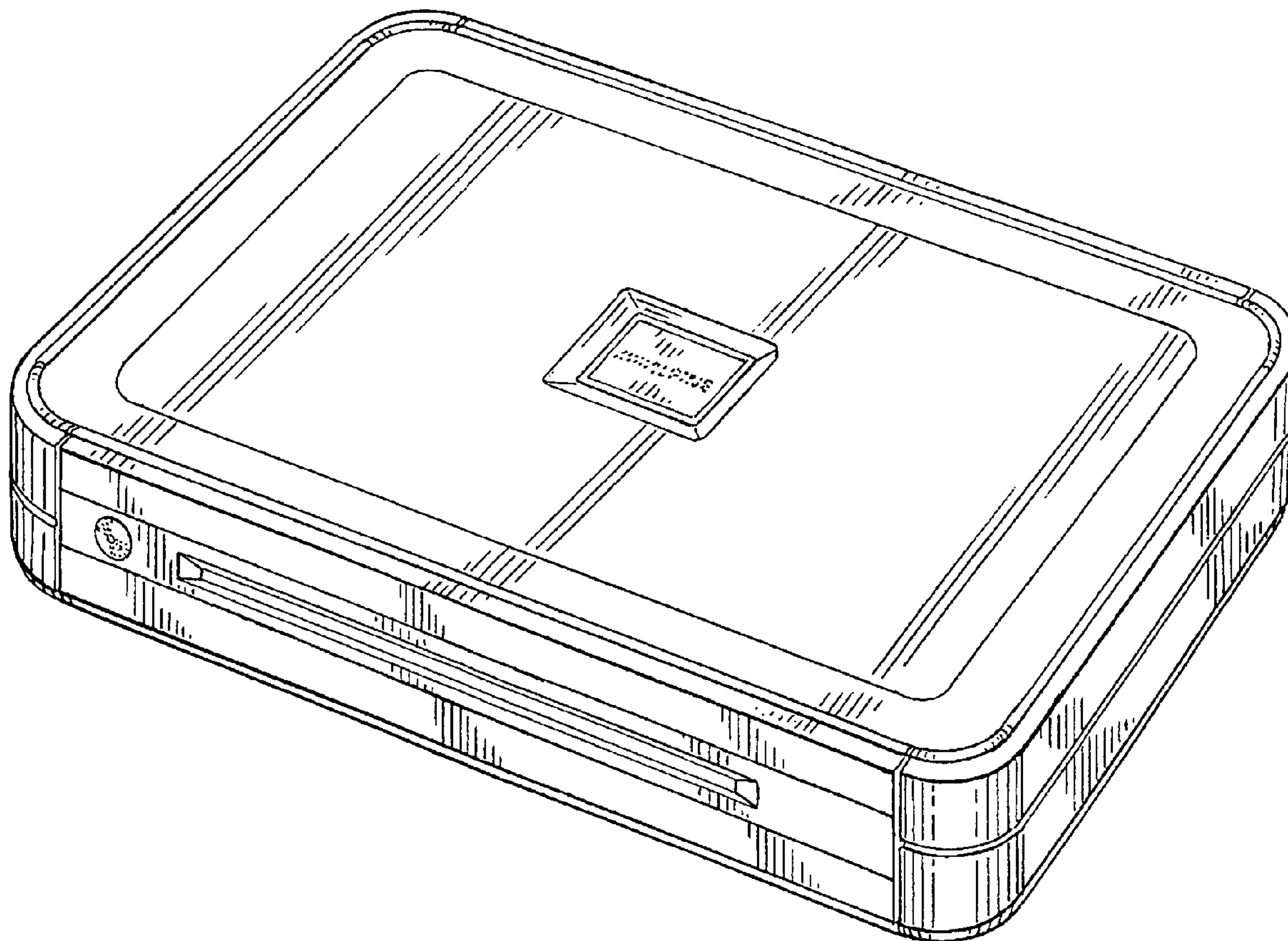
The ornamental design for an amplifier for a vehicle, as shown and described.

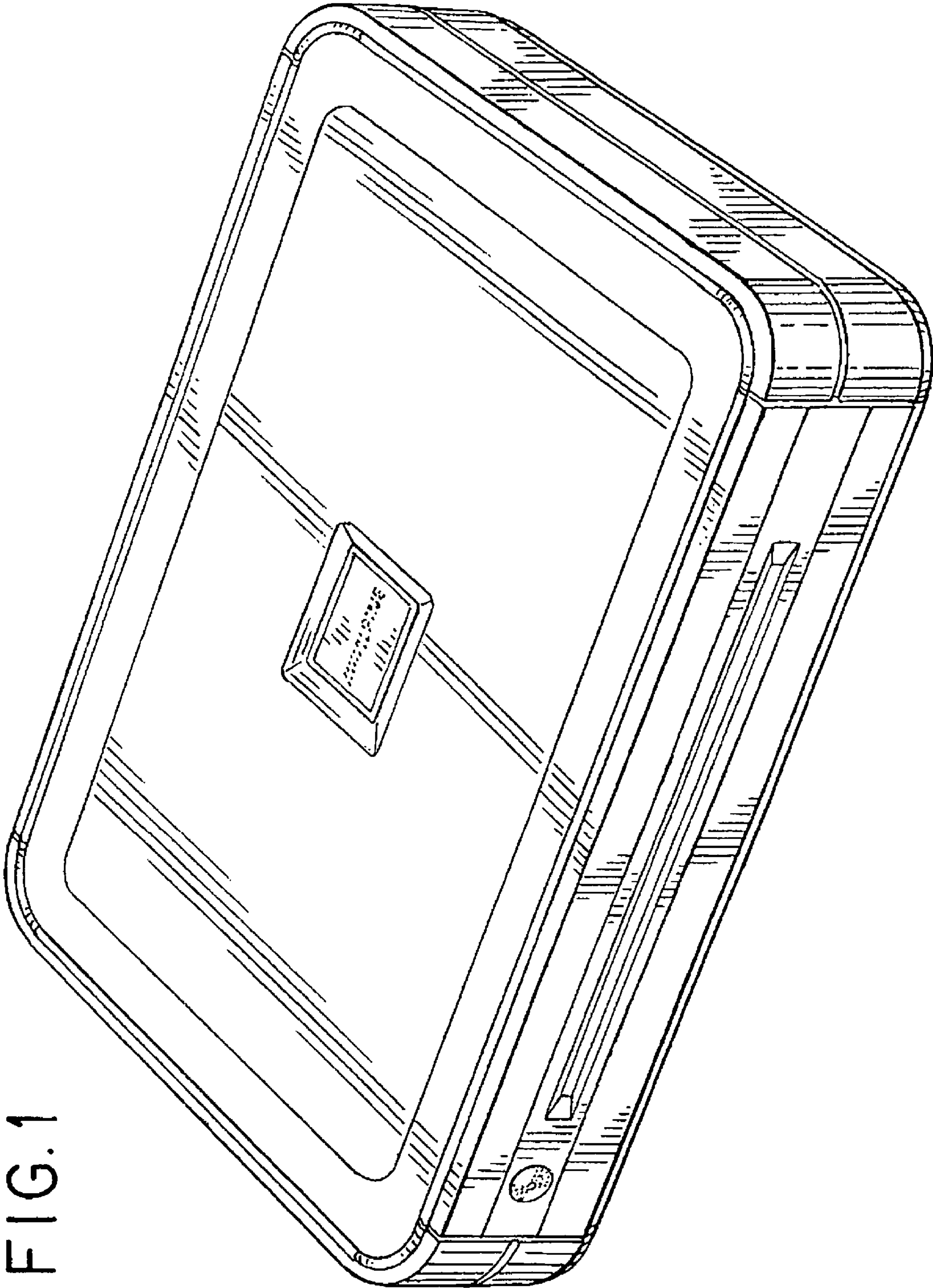

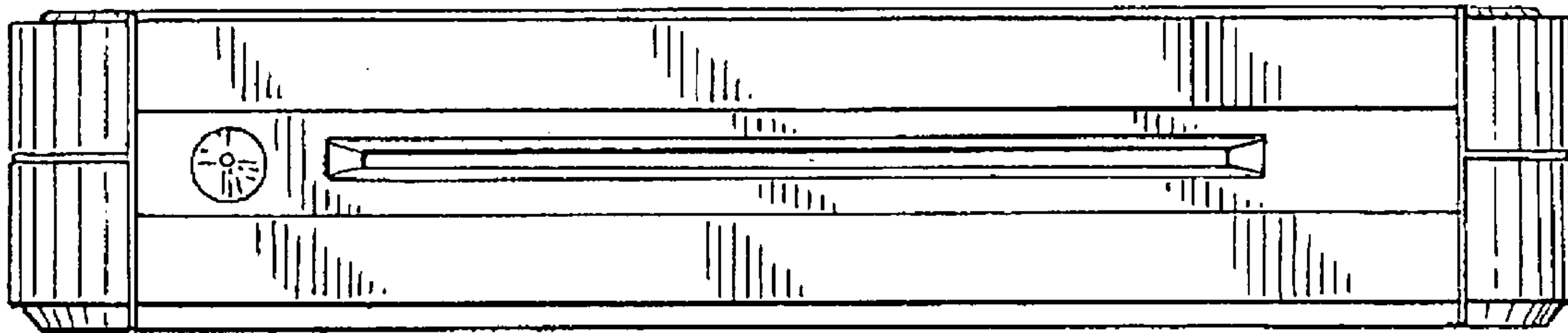

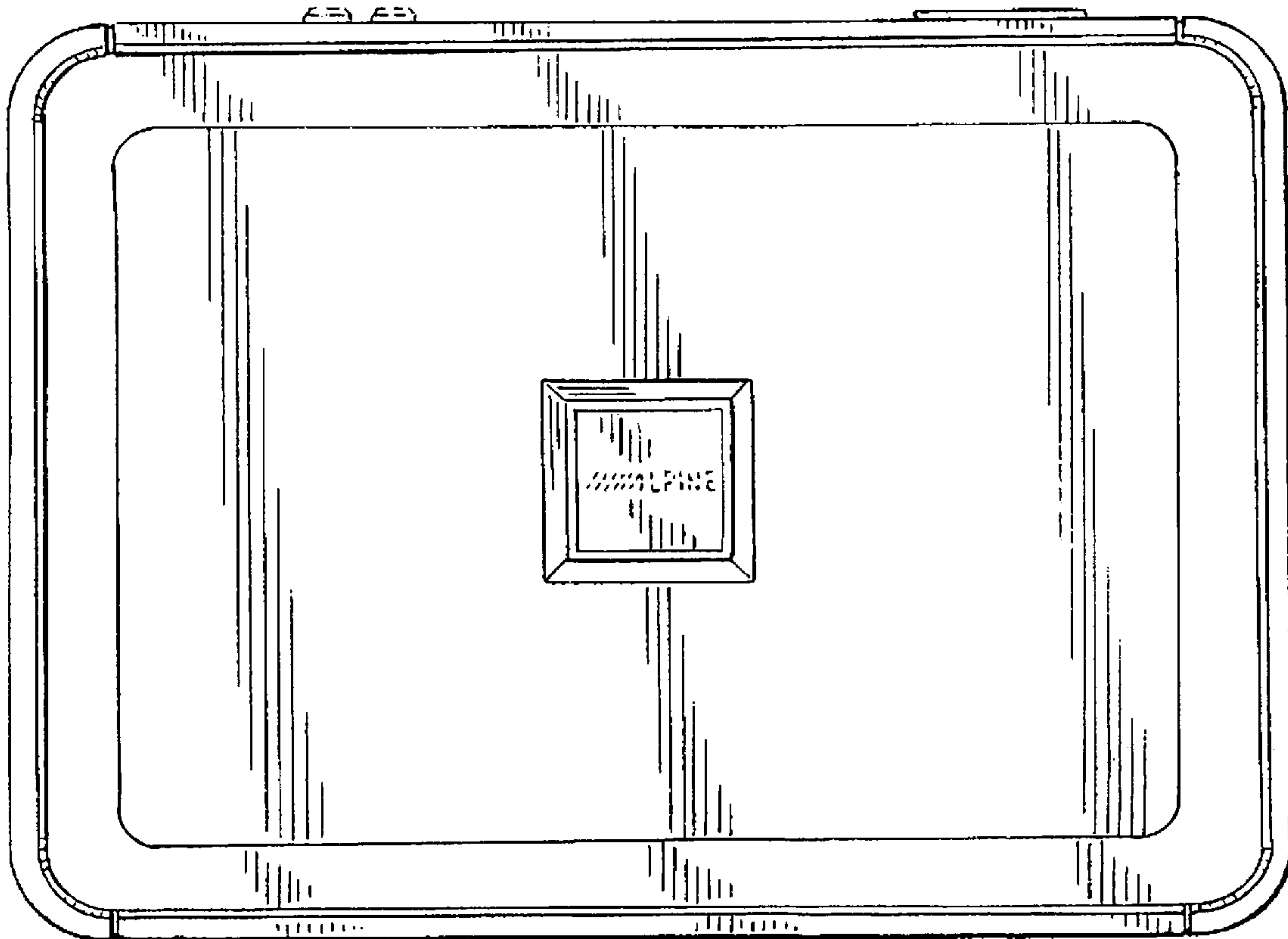

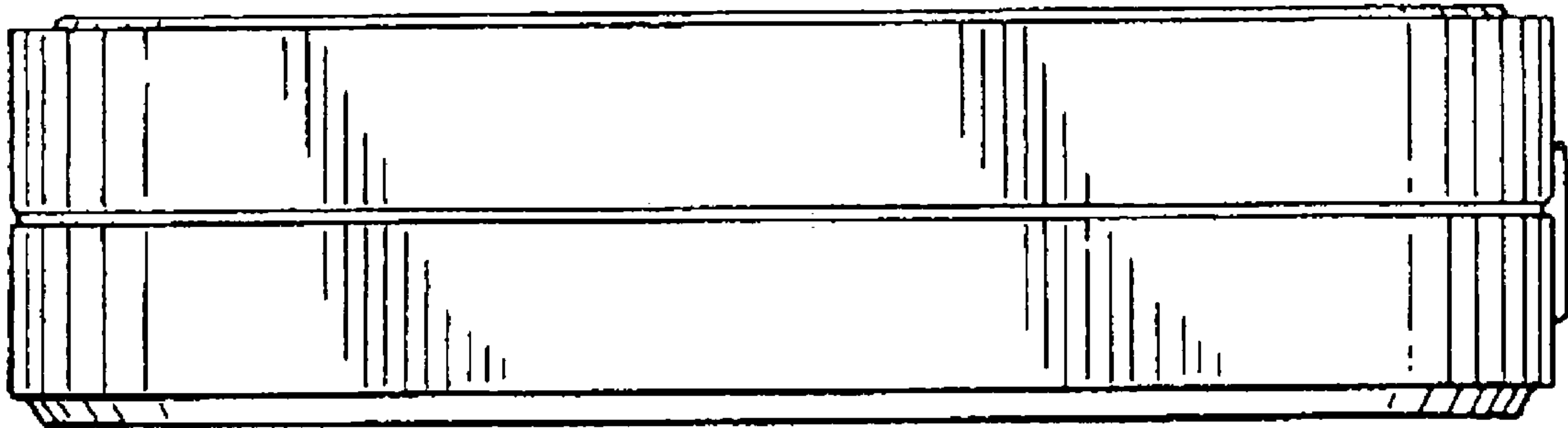

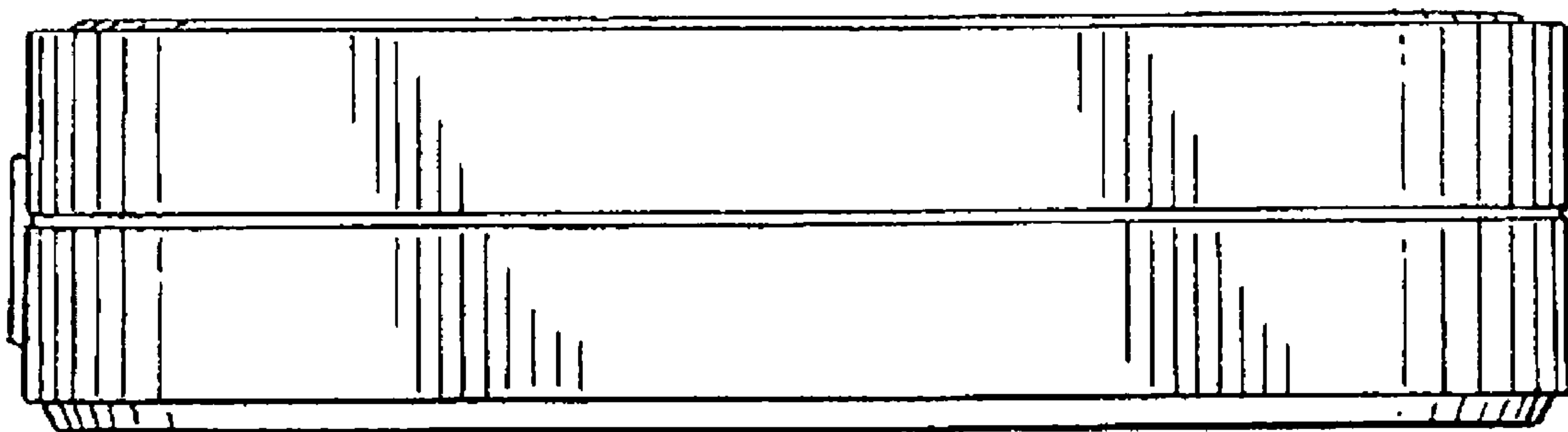

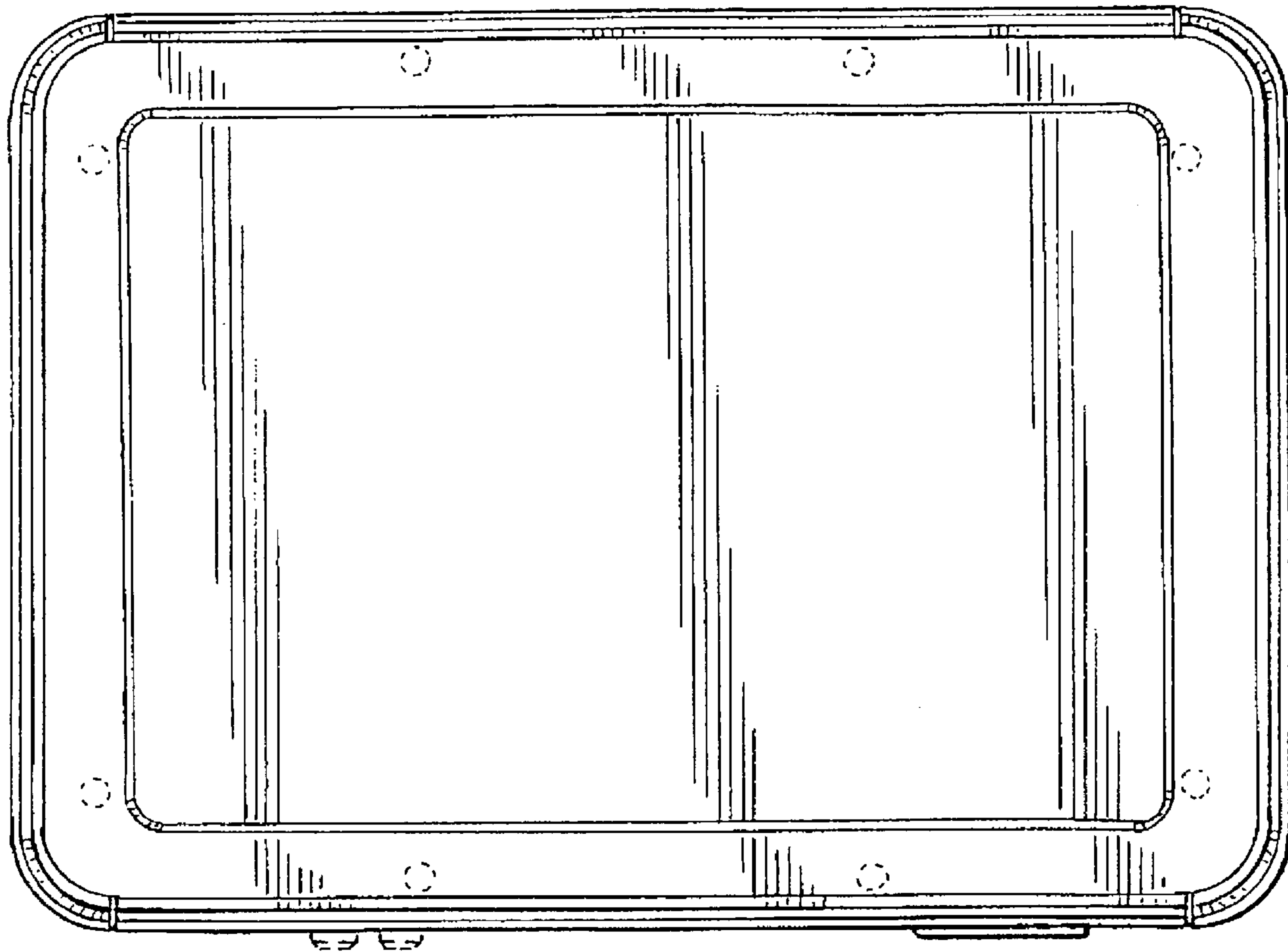
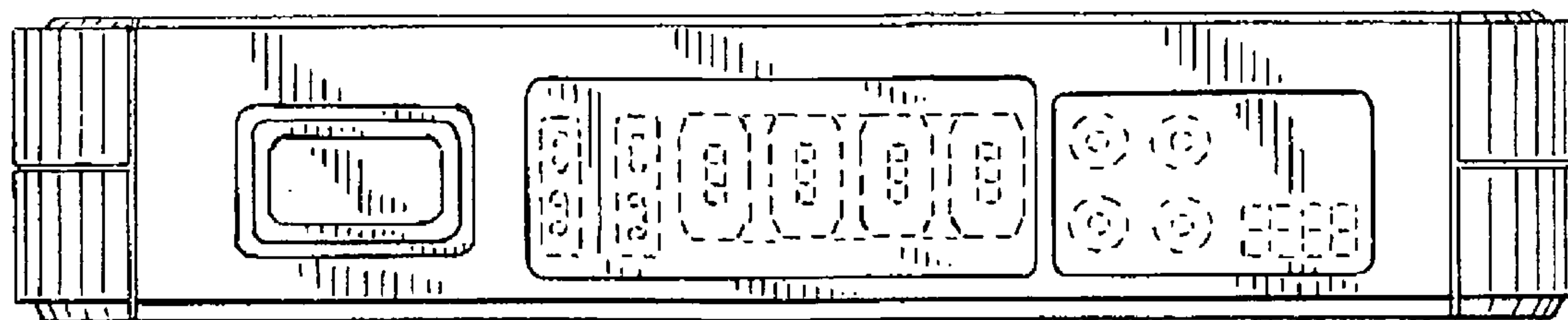
