**DESCRIPTION**

FIG. 1 is a front, top, right perspective view of a headphone showing my new design;

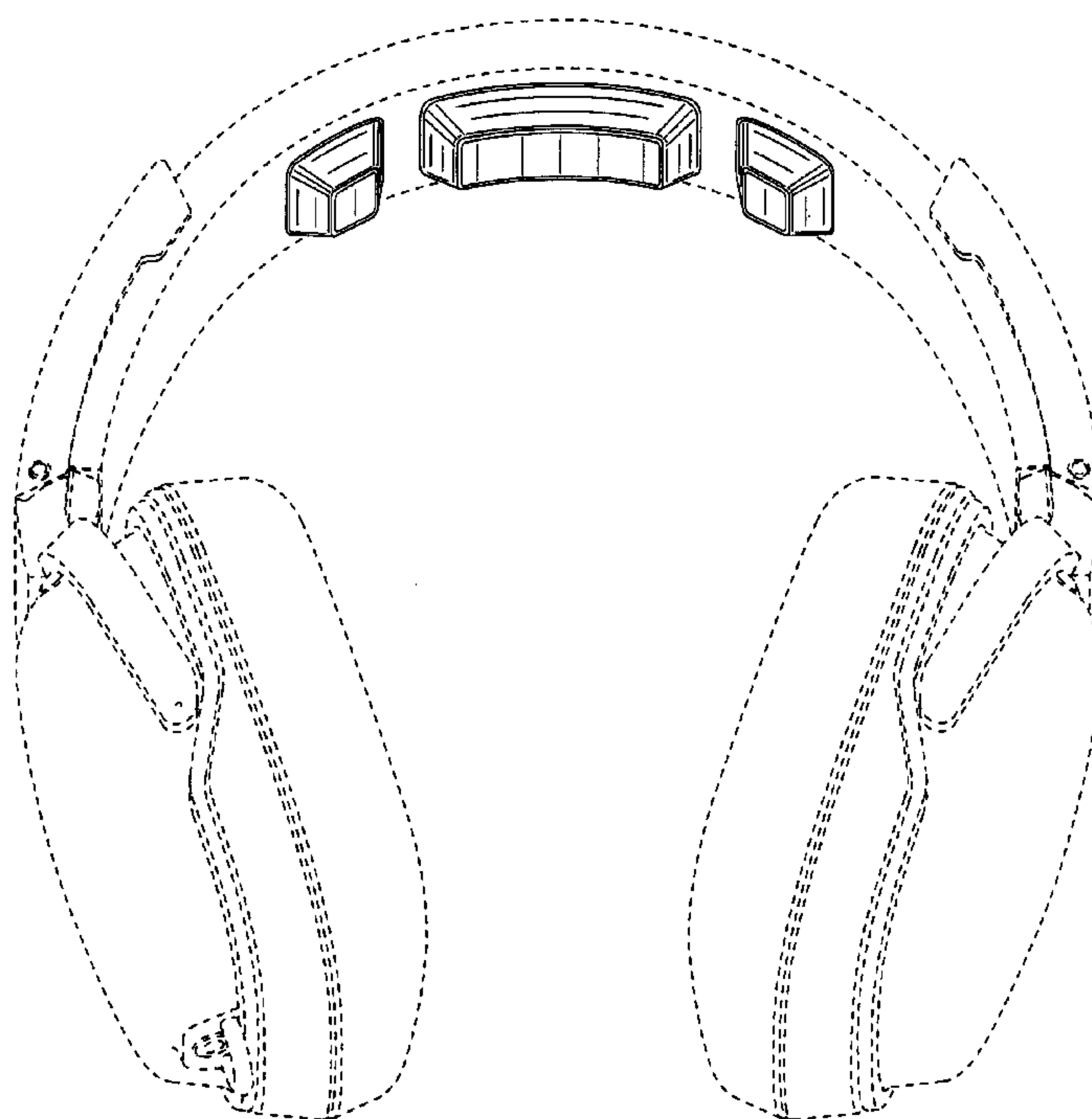

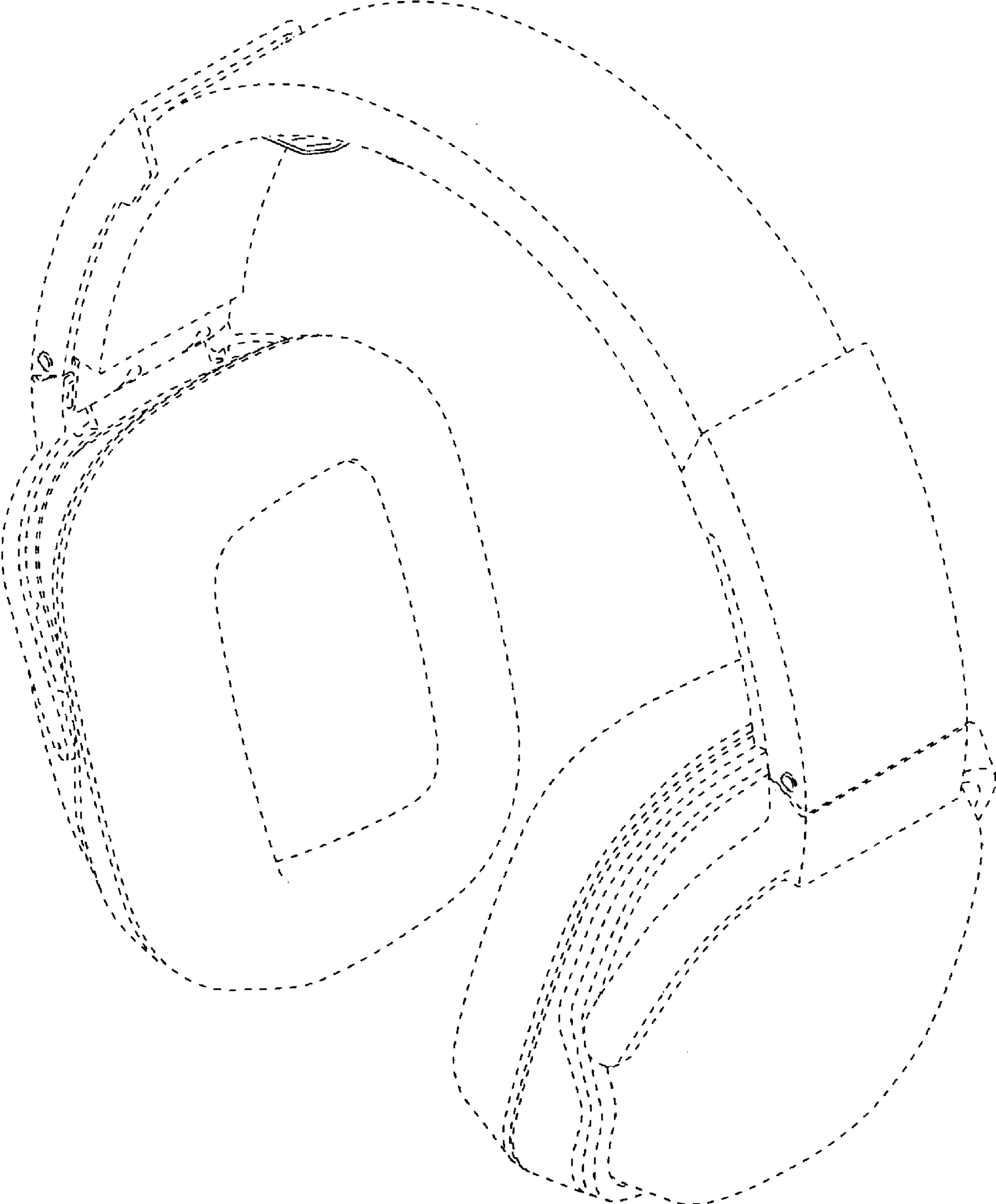

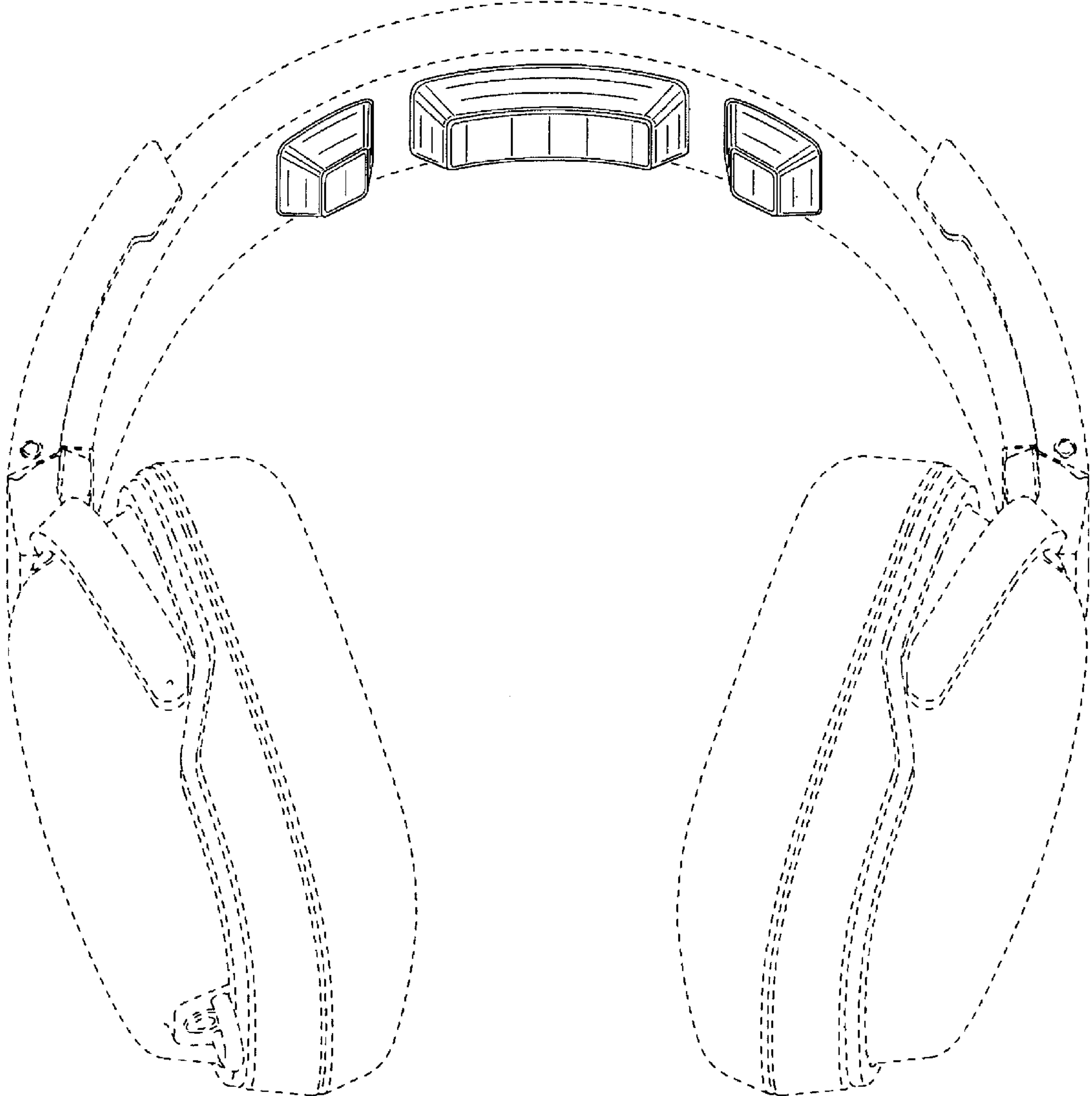

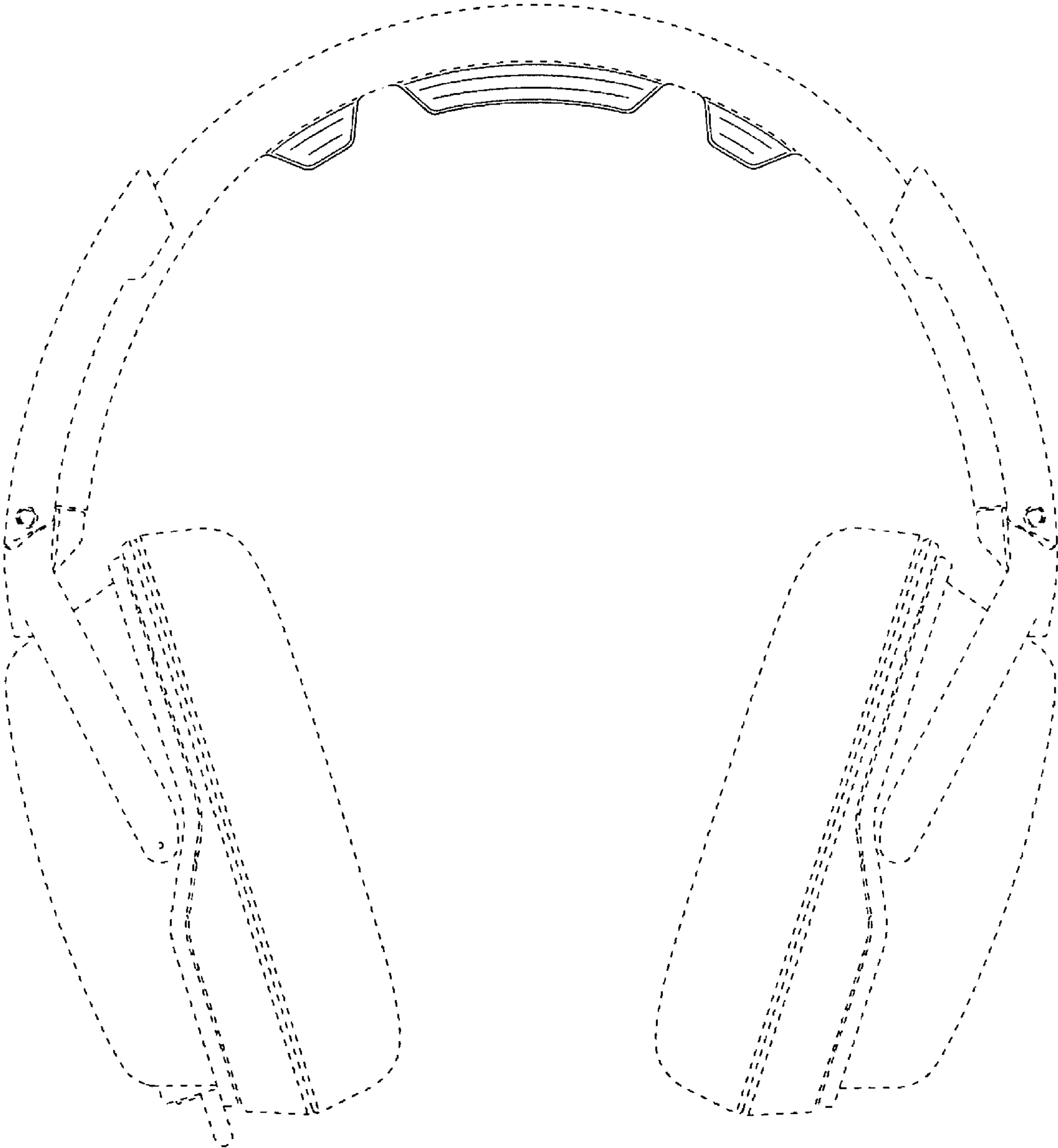

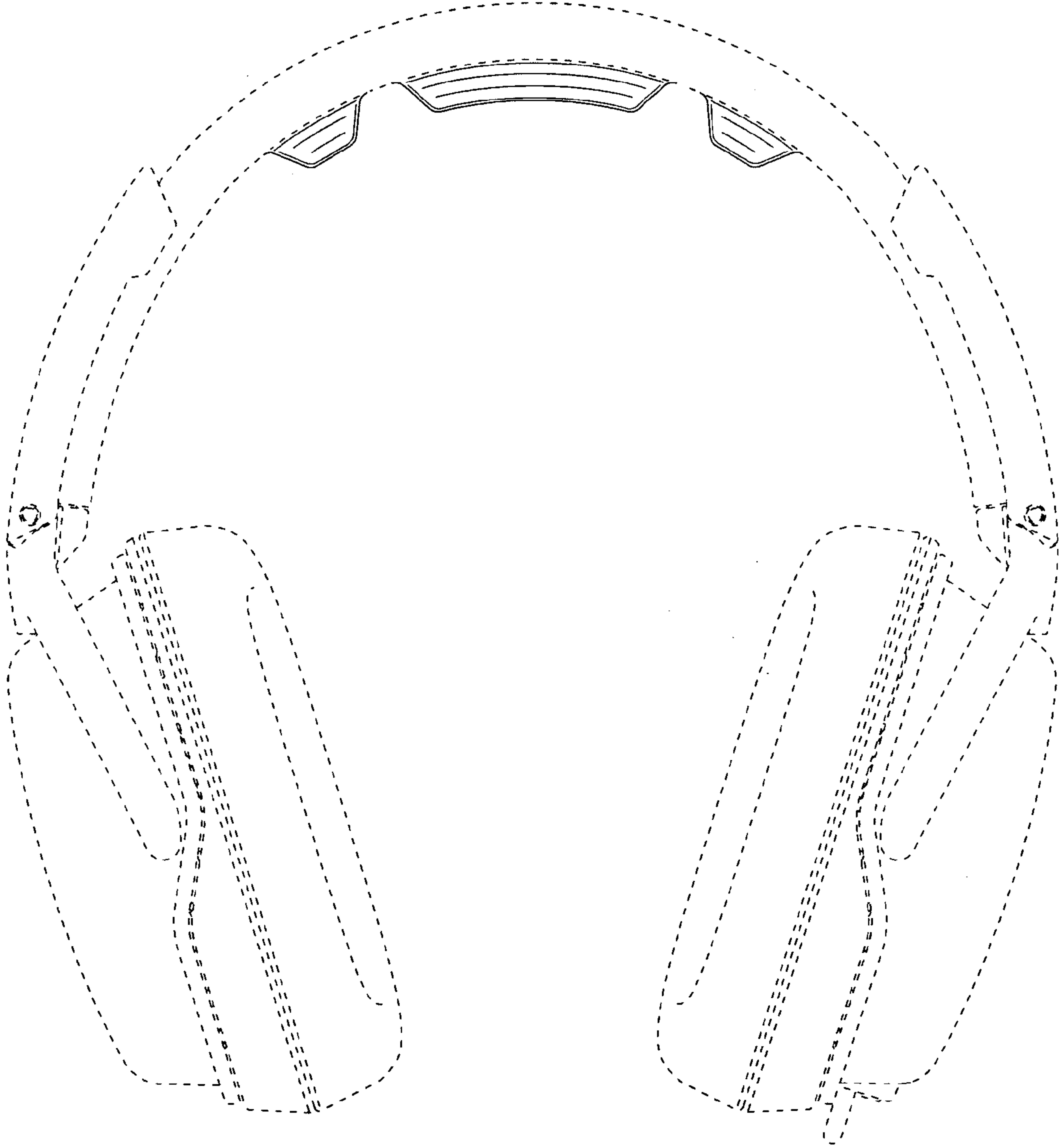
