DESCRIPTION

FIG. 1 is a perspective view of a remote controller for a blue-ray player showing my new design;

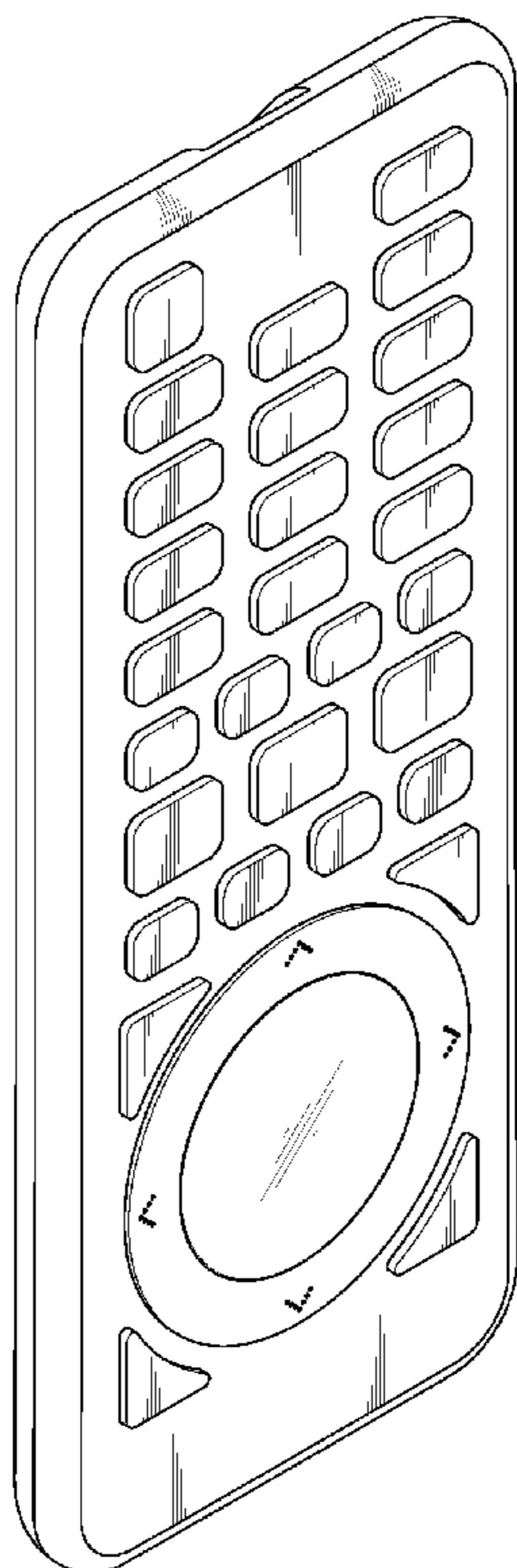

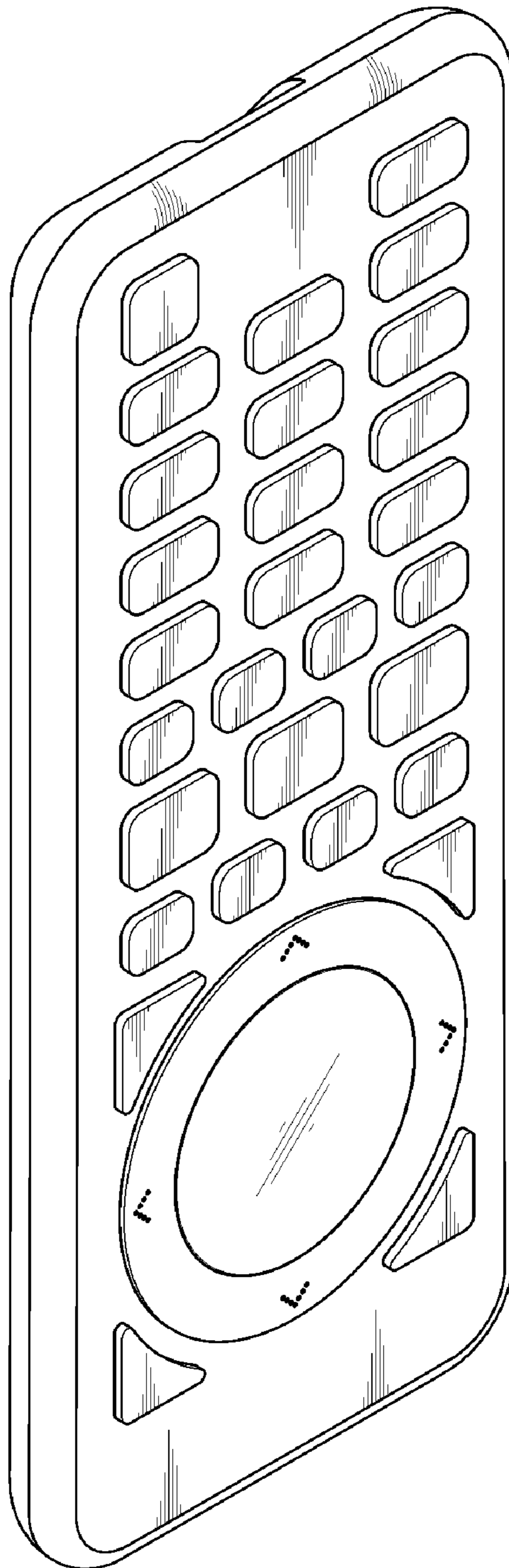

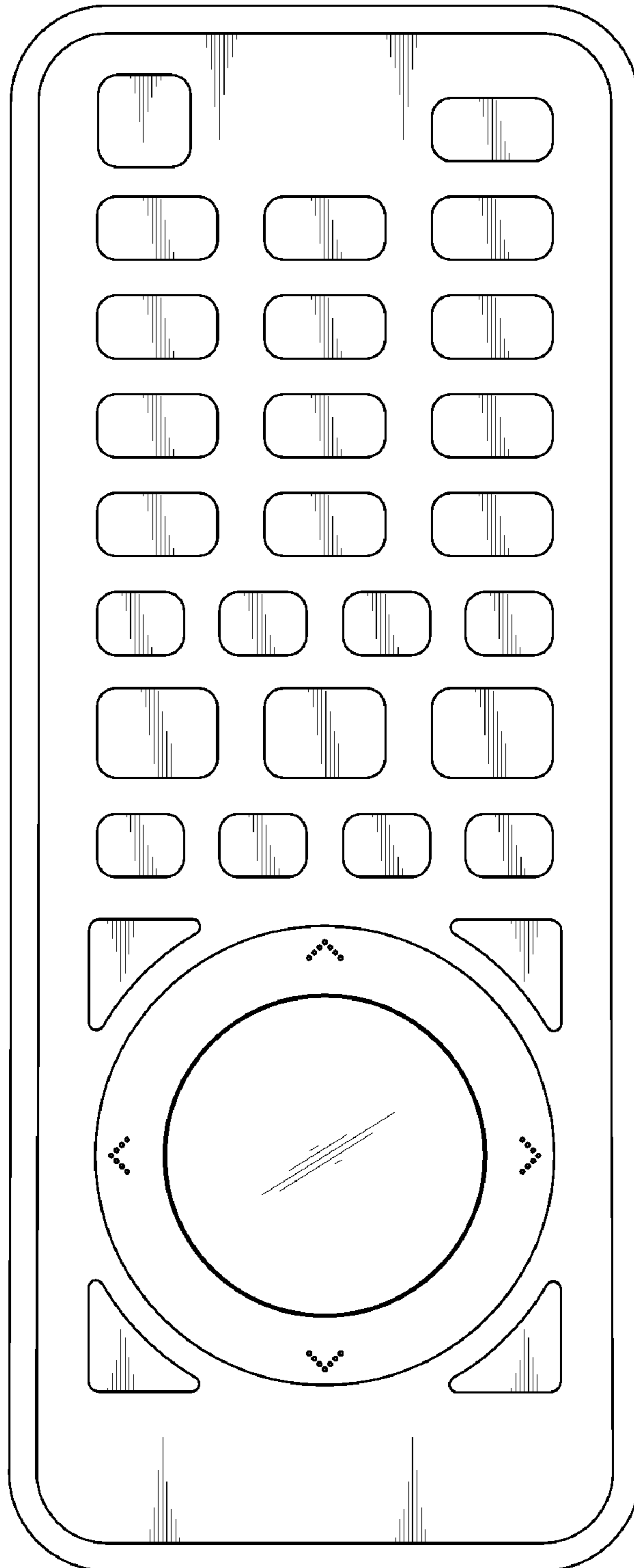

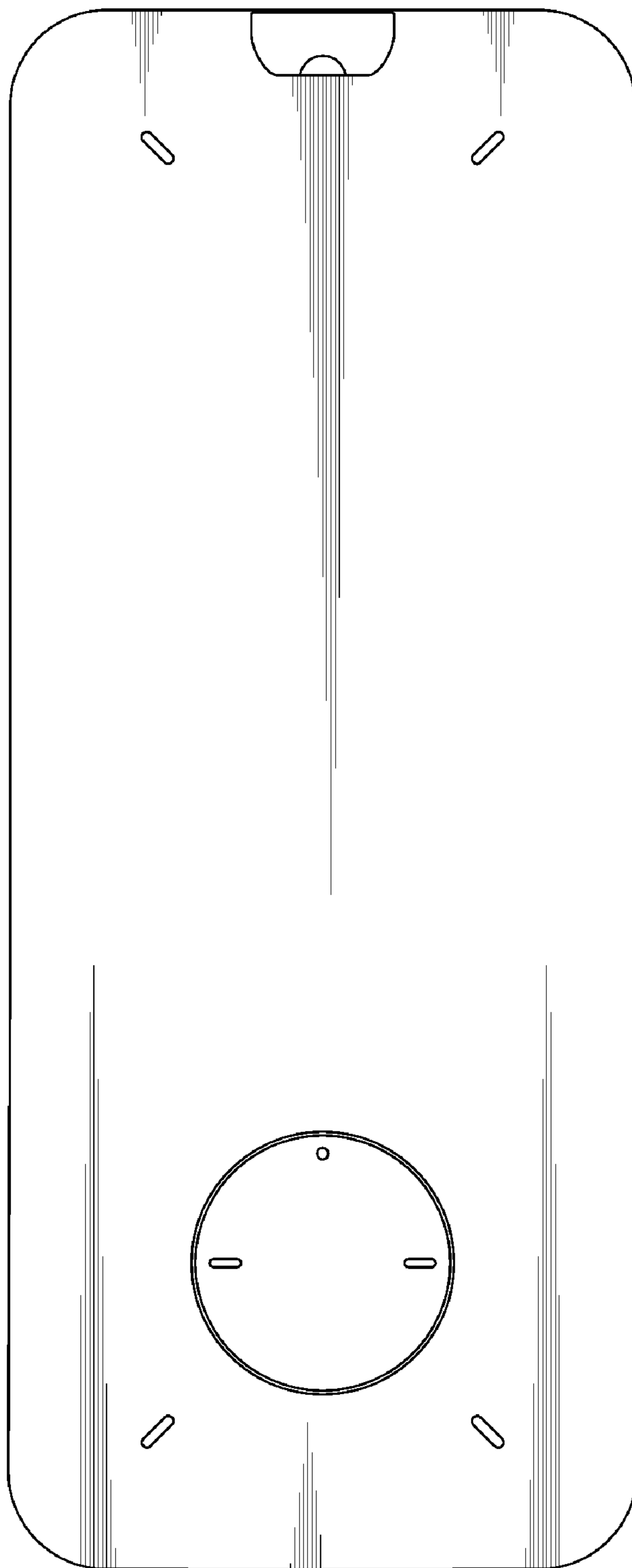

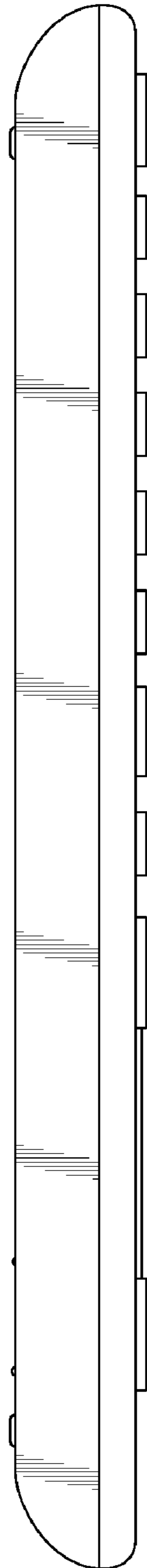

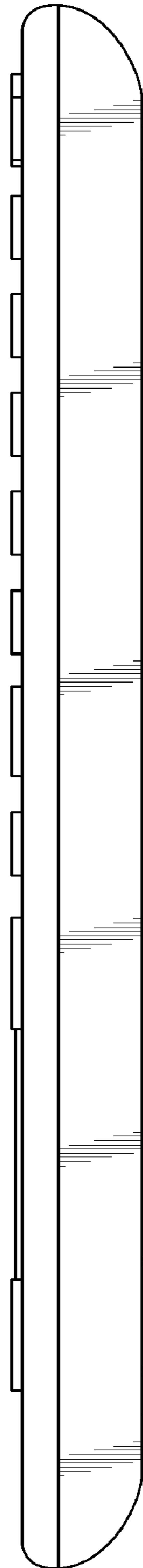

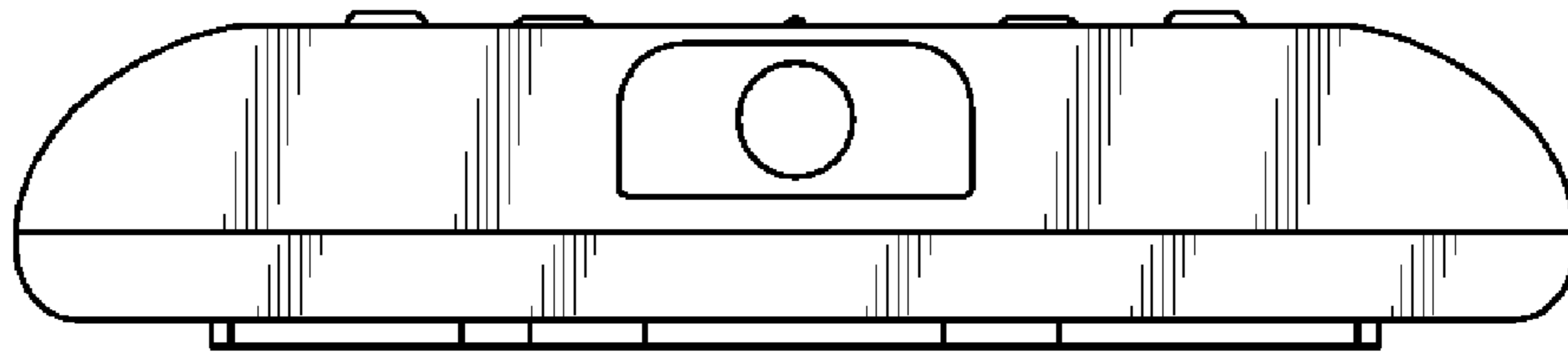
