(57) **CLAIM**

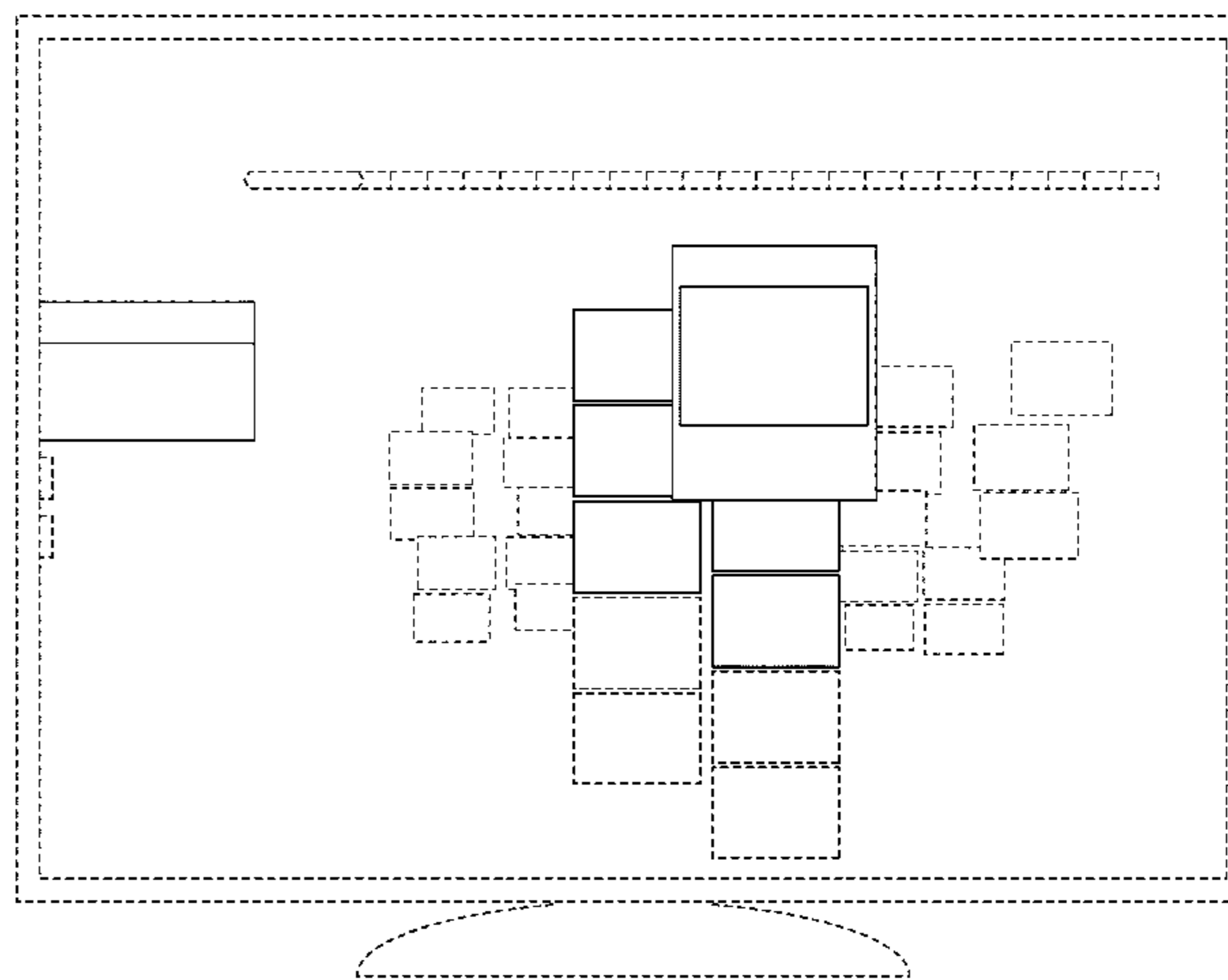
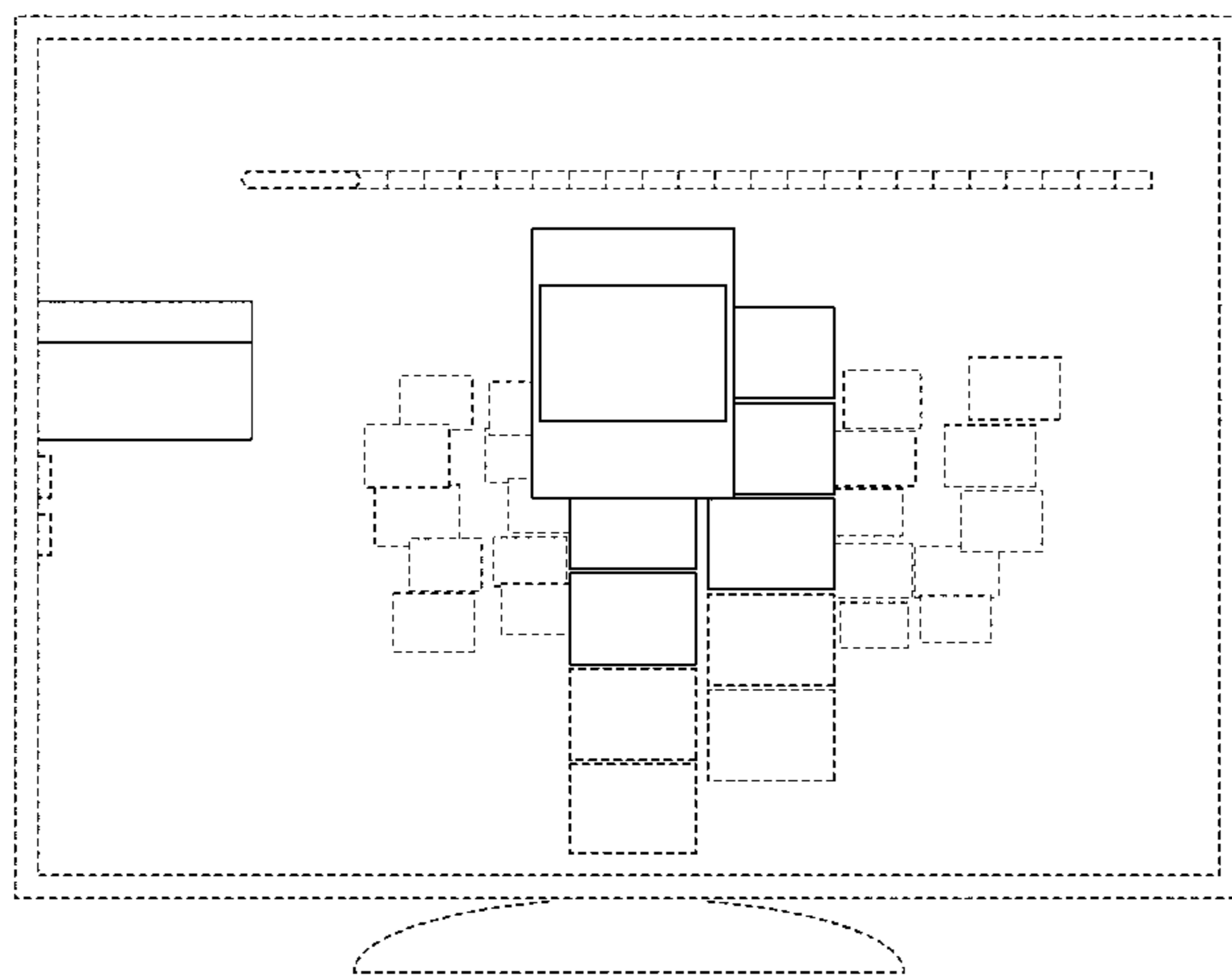
The ornamental design for an display screen with animated user interface, as shown and described.

DESCRIPTION

FIG. 1 is a first image in the sequence for an display screen with animated user interface showing the new design; FIG. 2 is the second image thereof; FIG. 3 is the third image thereof; FIG. 4 is the fourth image thereof; and, FIG. 5 is the fifth image thereof.

The appearance of the display screen sequentially transitions between the images shown in FIGS. 1-5. The process or period in which one image transitions to another forms no part of the claimed design. The broken line display screen and portions of the user interface are included in the drawing for the purpose of illustrating unclaimed environment and form no part of the claimed design.

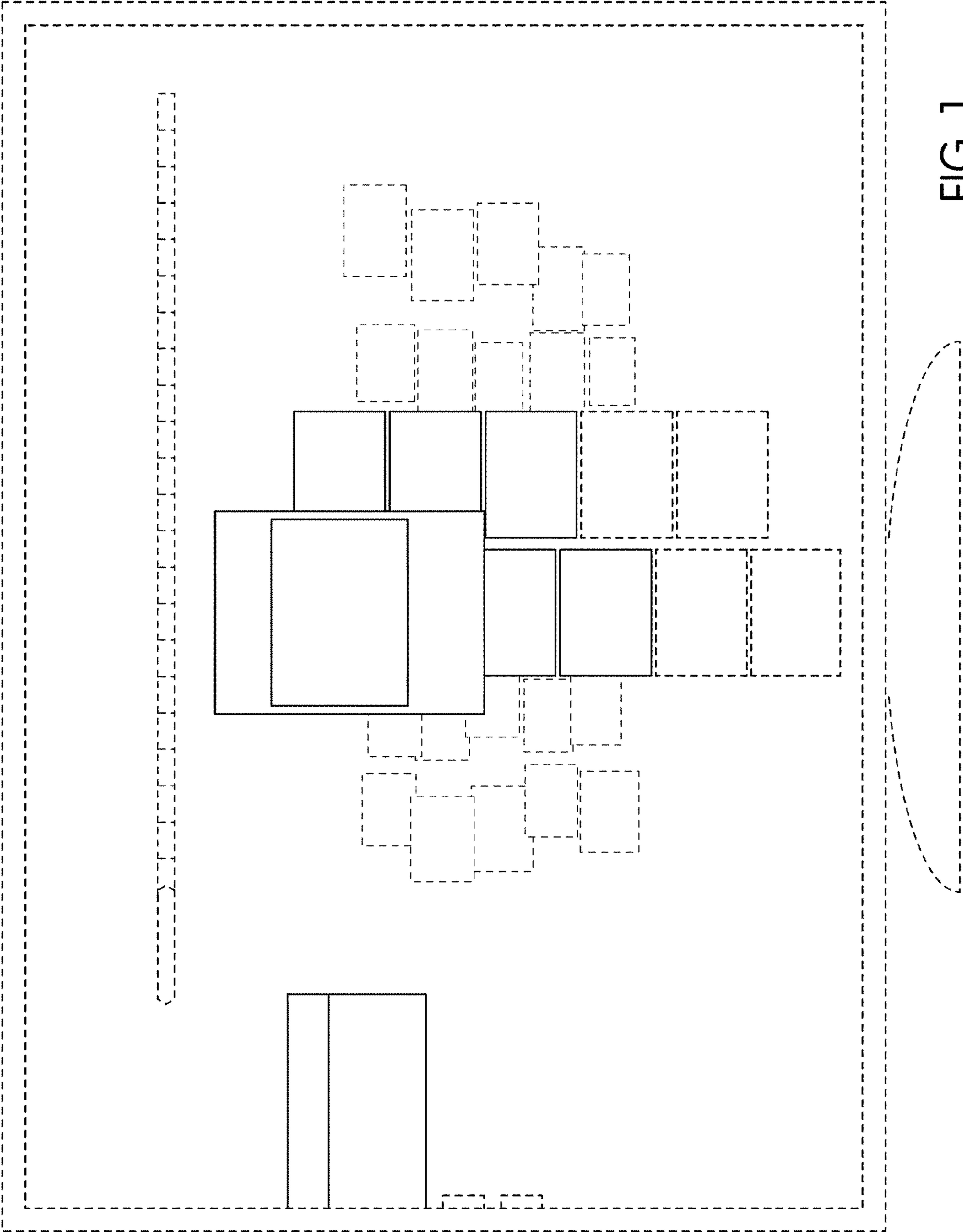

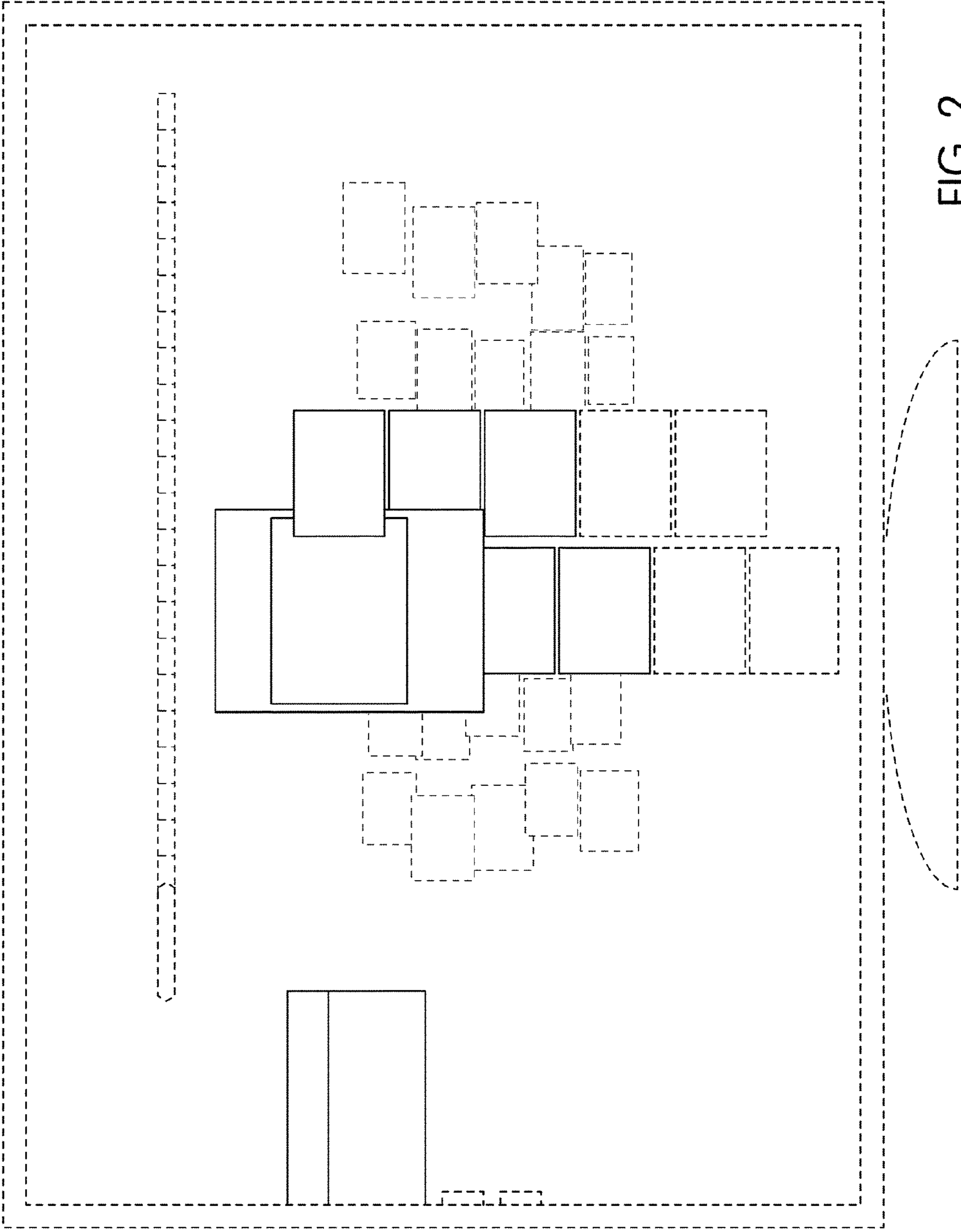

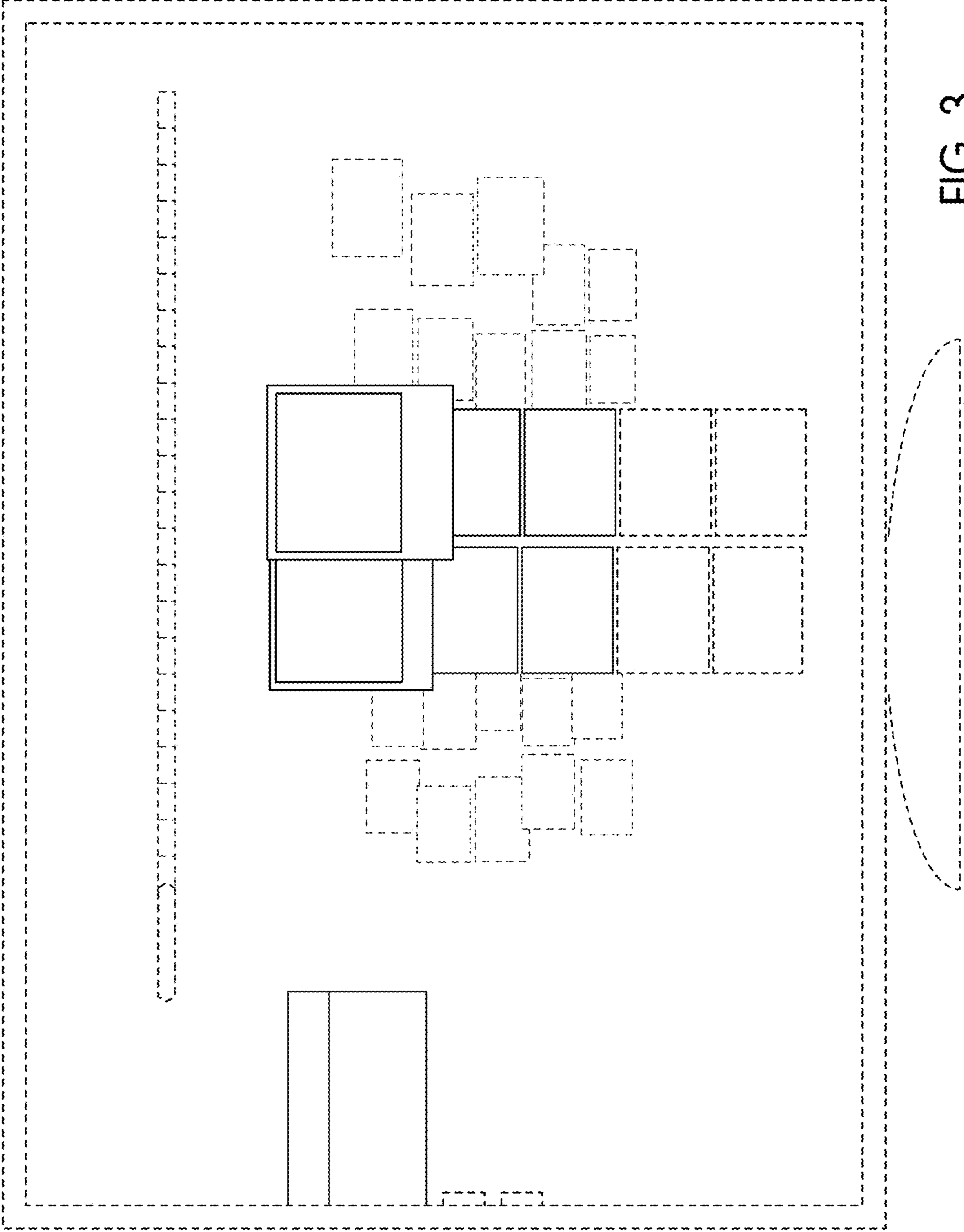

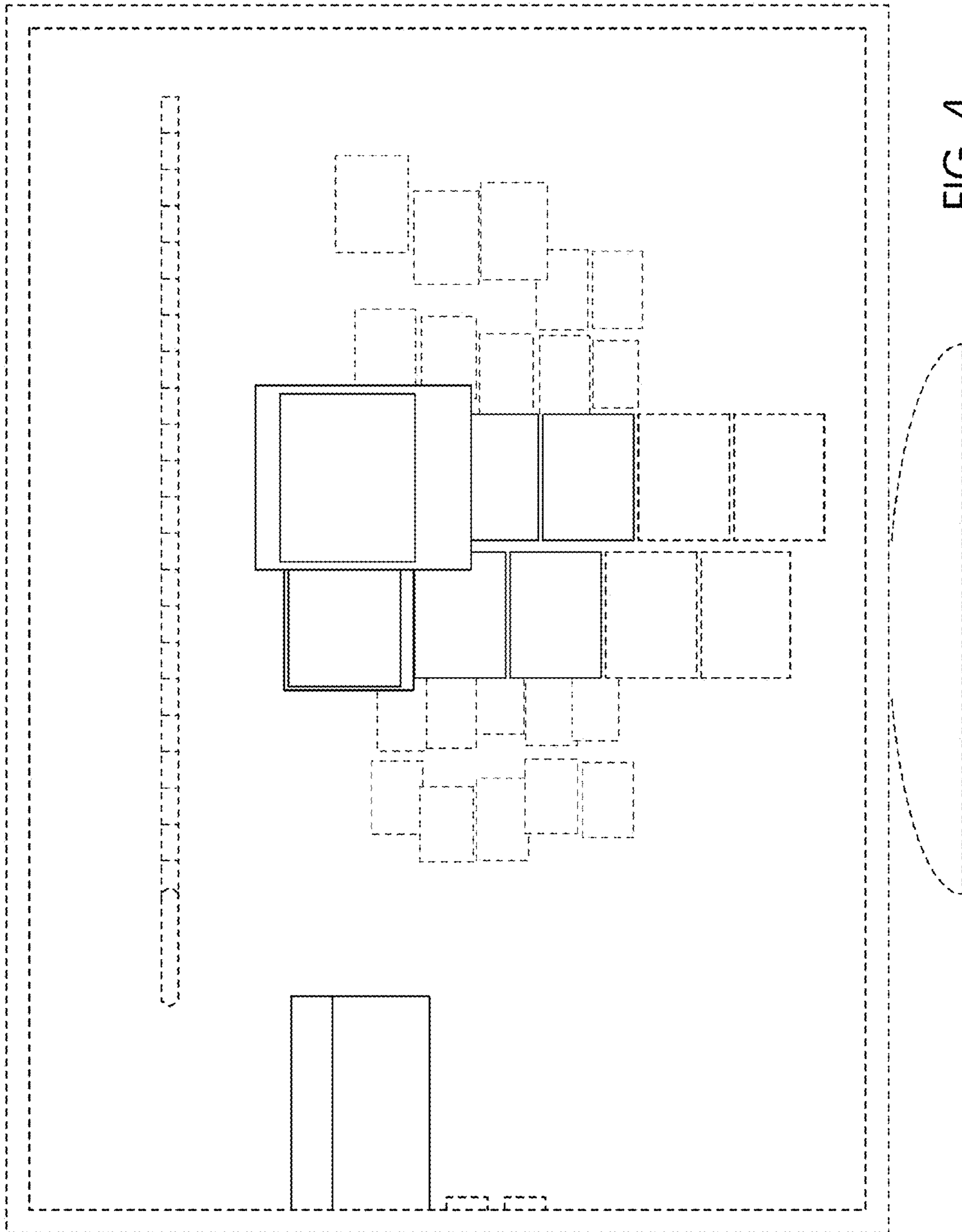

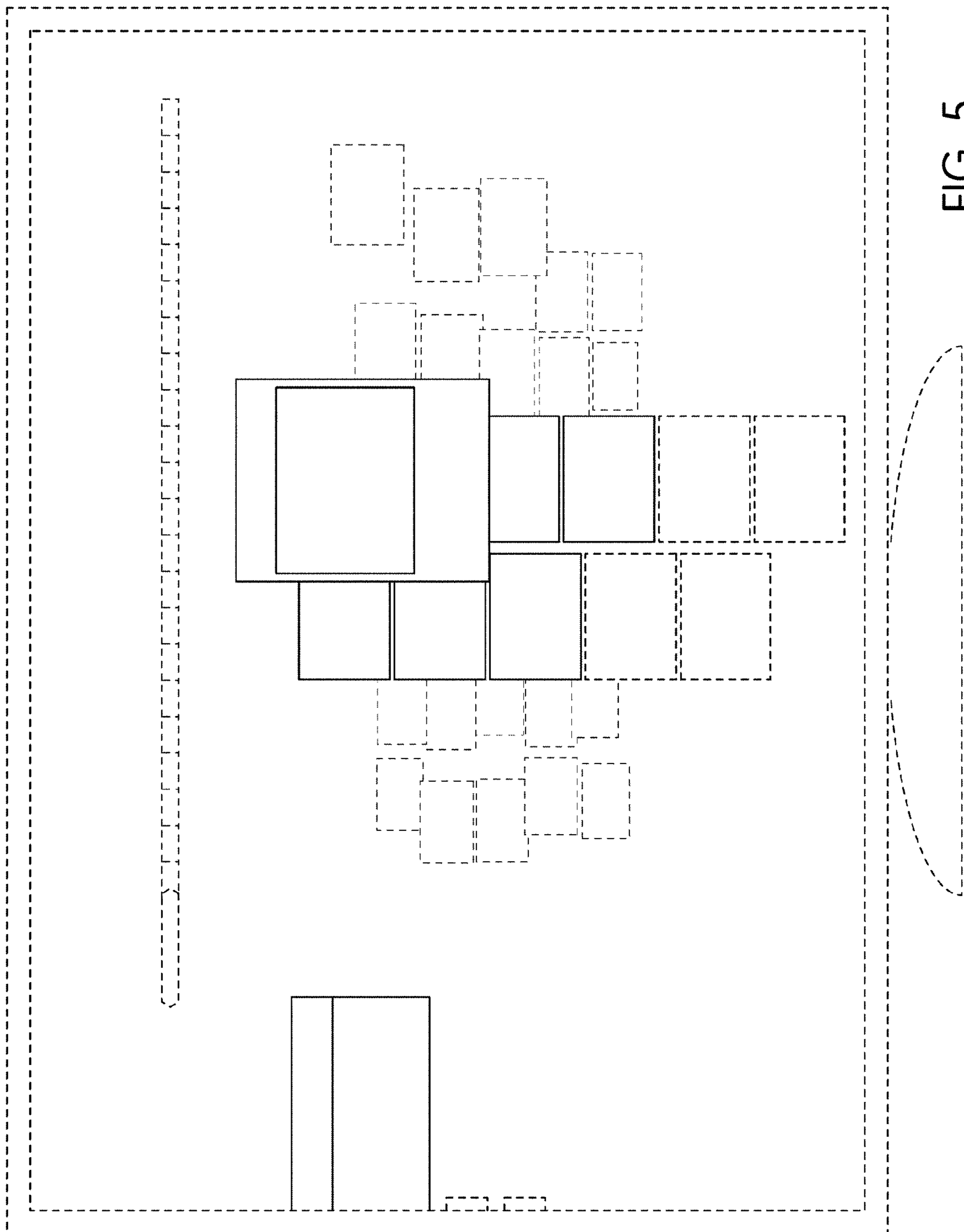
