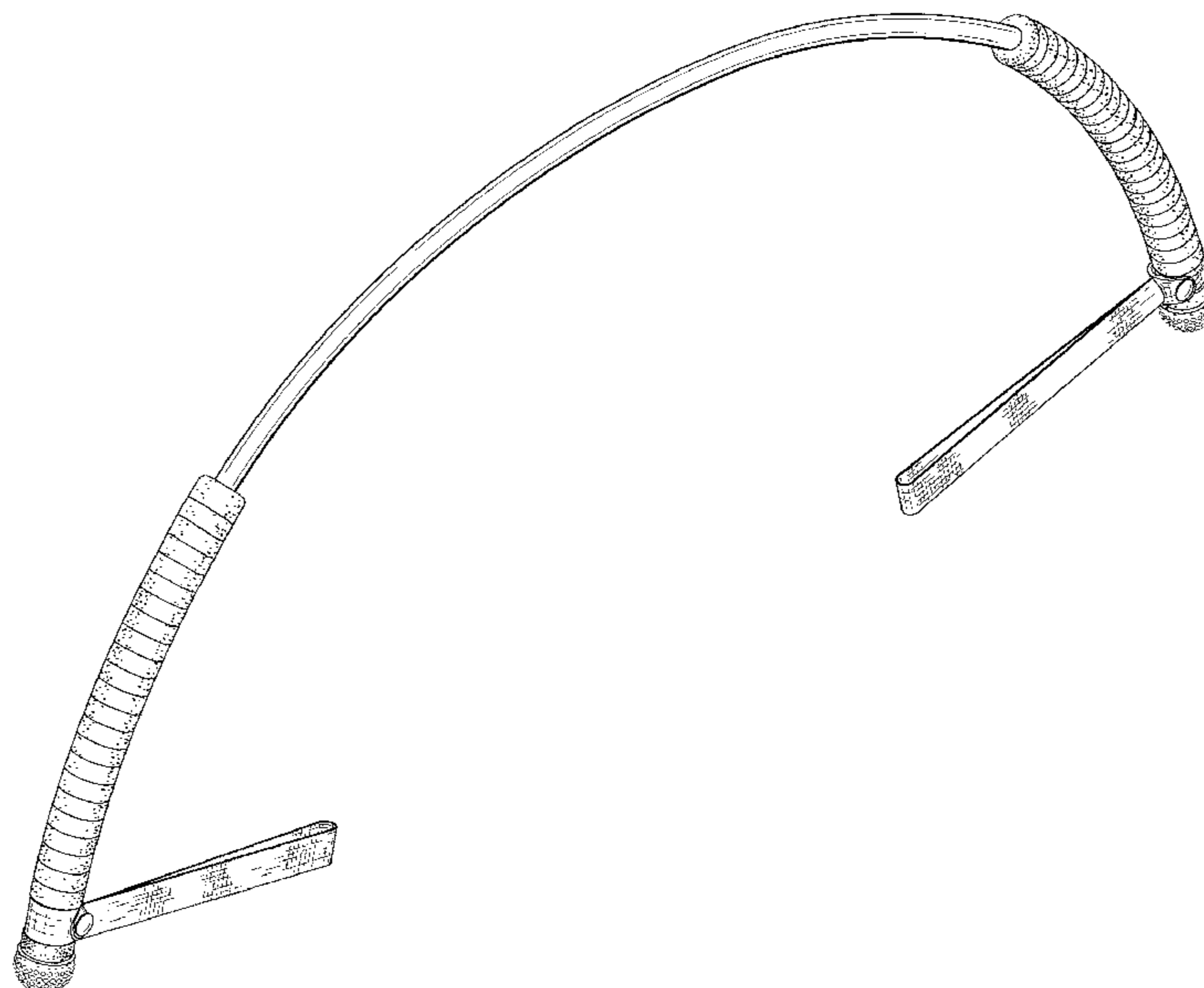
(57) **CLAIM**

The ornamental design for a flexible exercise device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the flexible exercise device; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; and, FIG. 6 is a side view thereof, the other side being a mirror image.

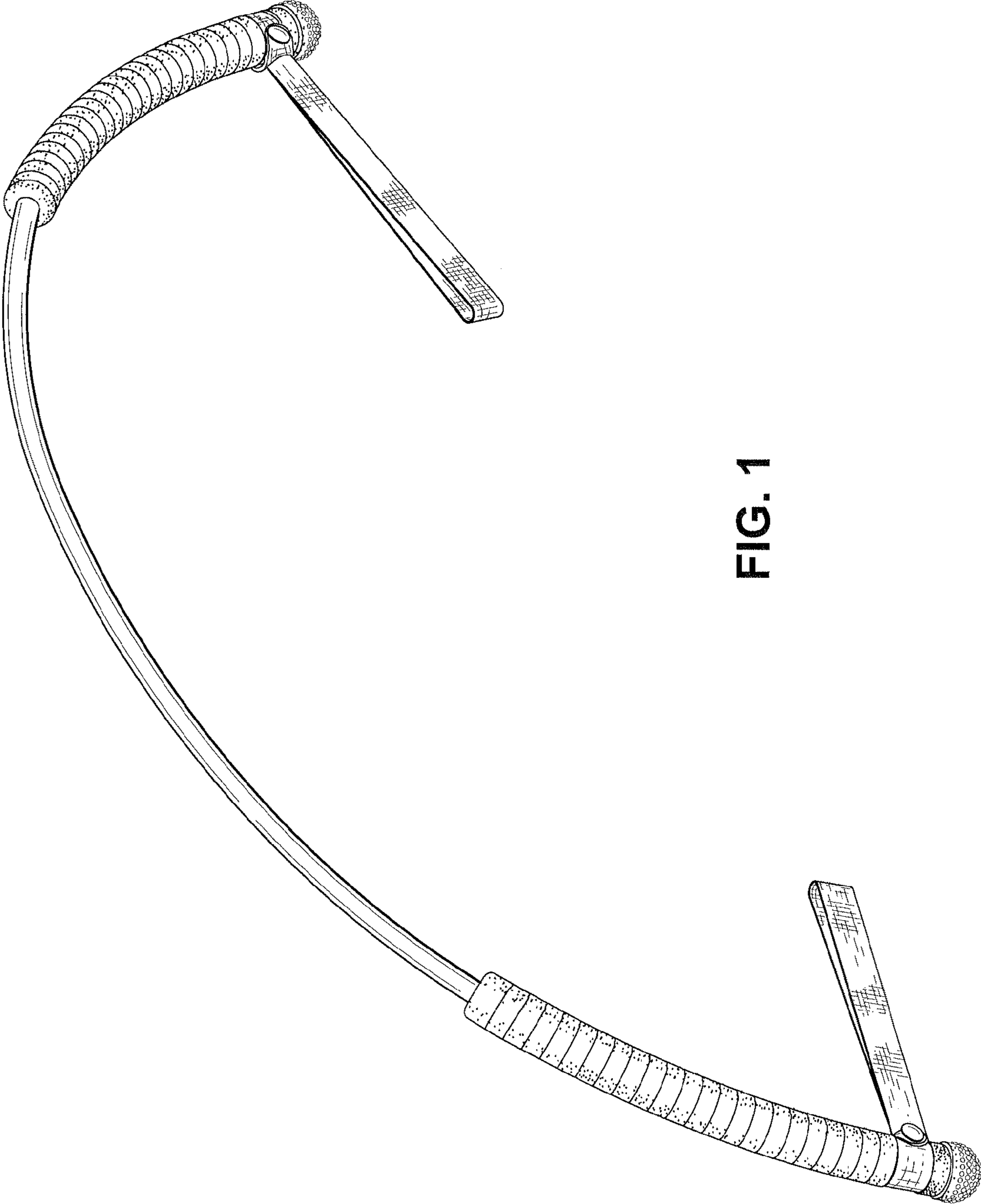

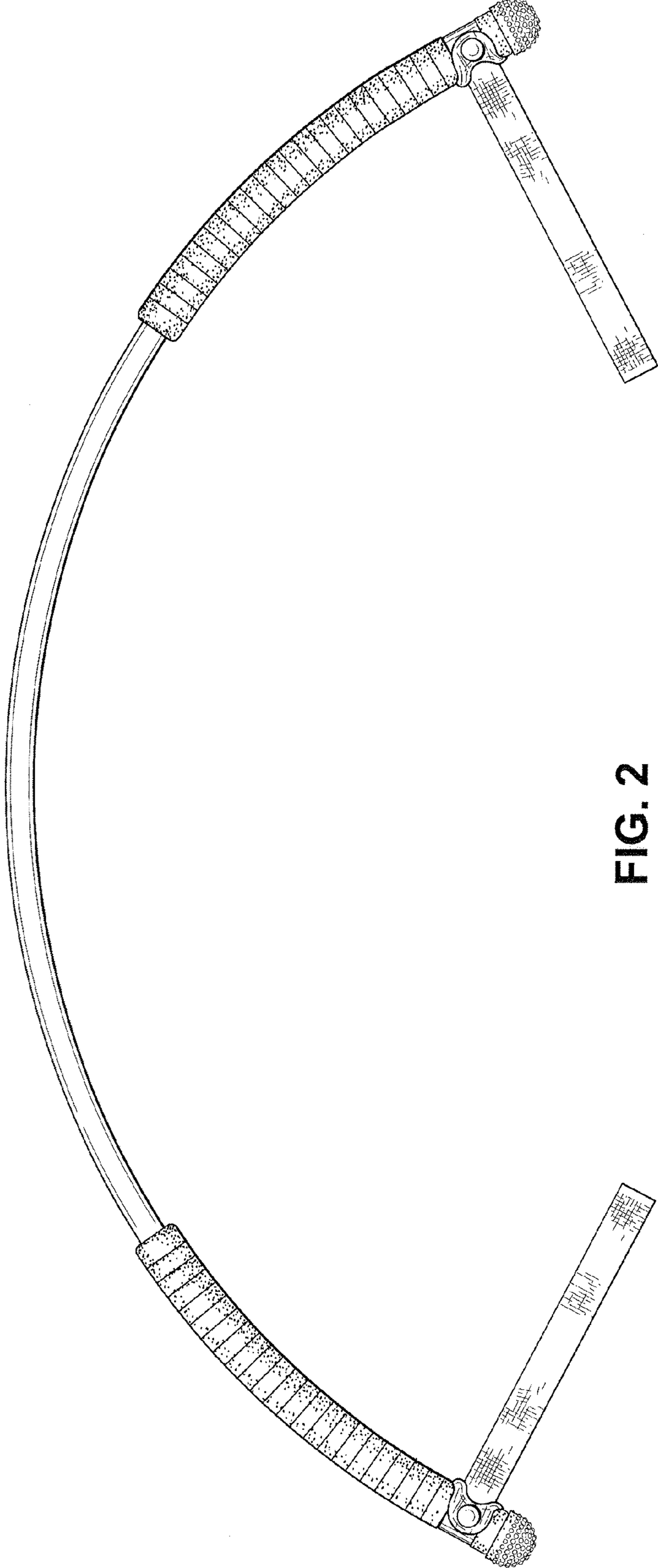

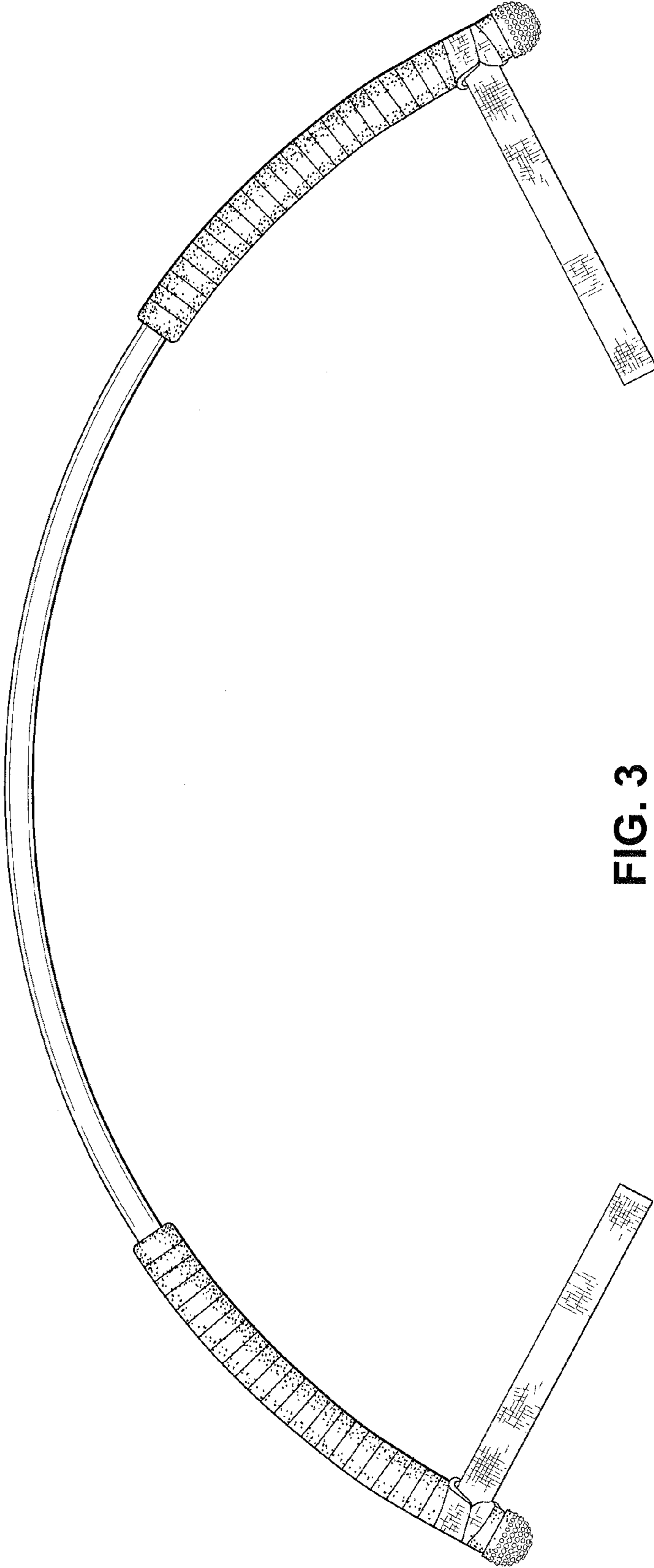

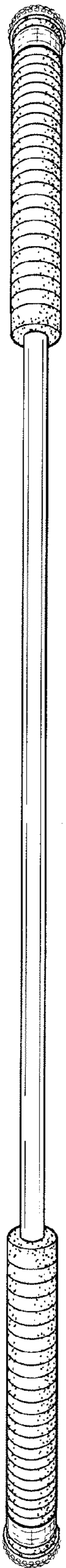

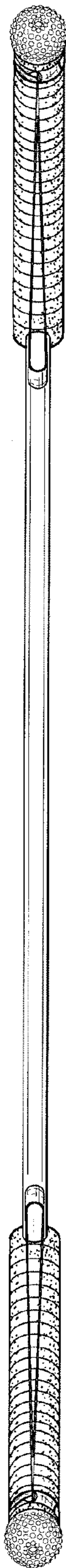
