 FIG. 30 is a front elevational view of a thirtieth embodiment;

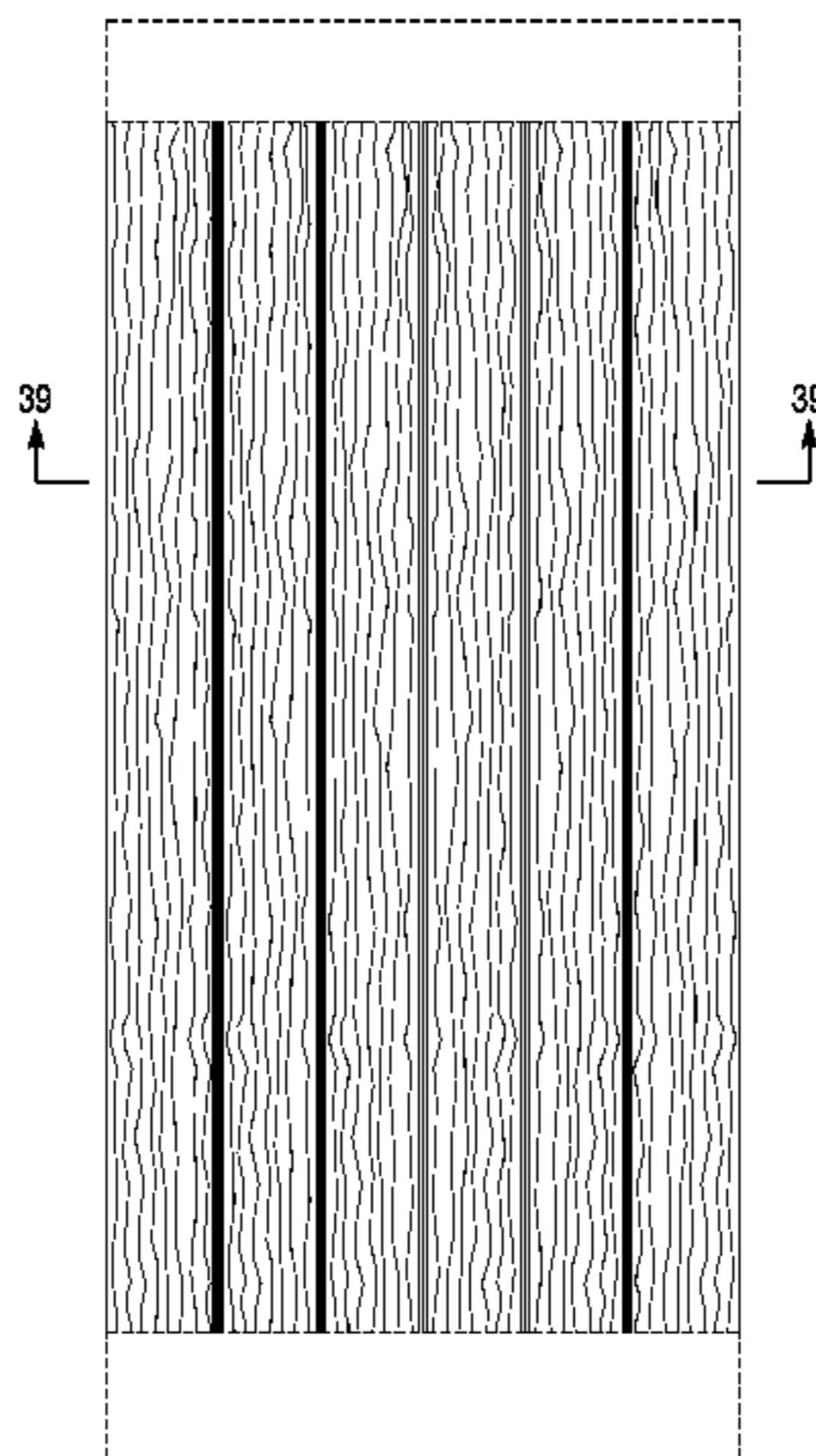


FIG. 31 is a front elevational view of a thirty-first embodiment;

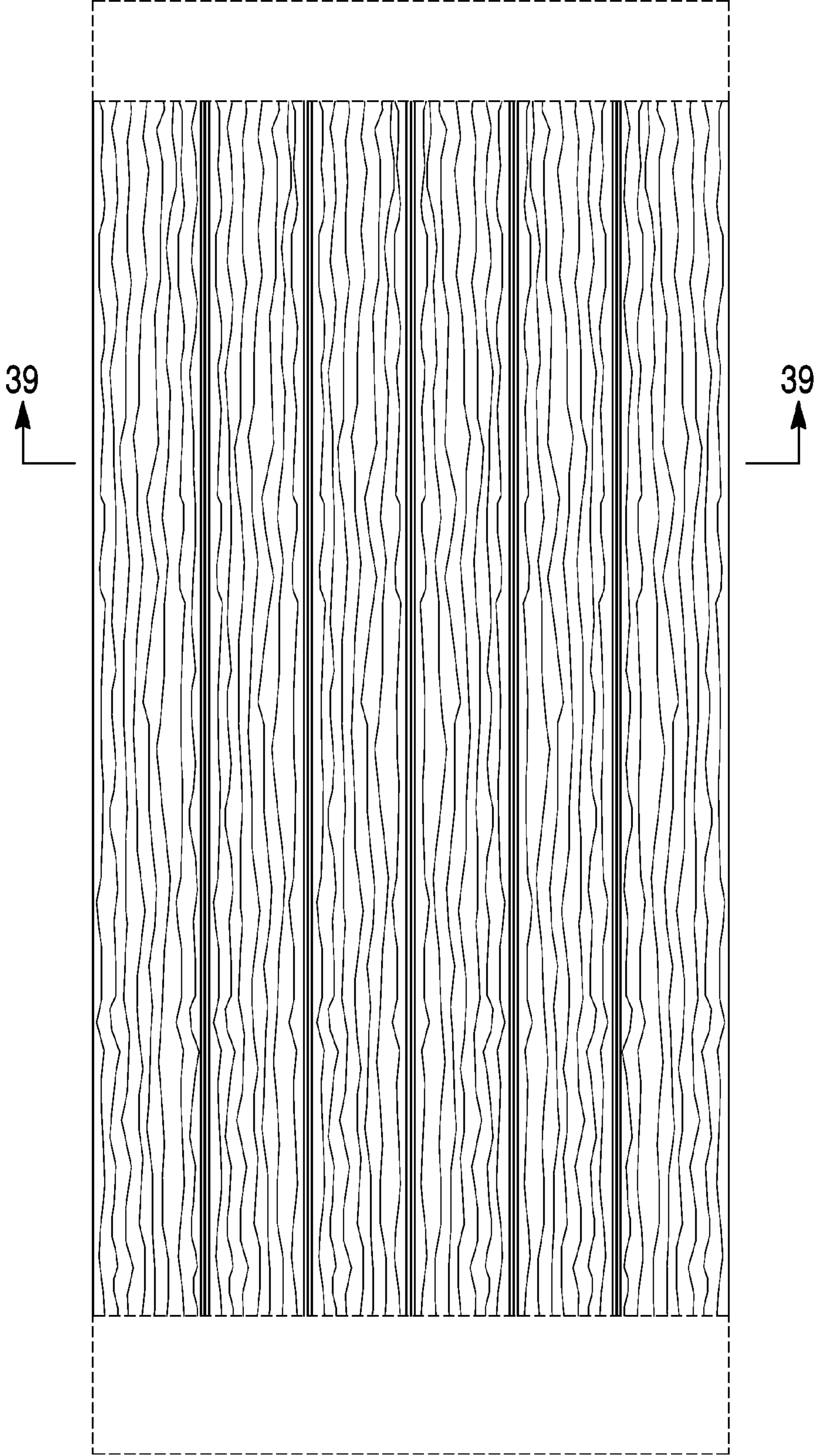

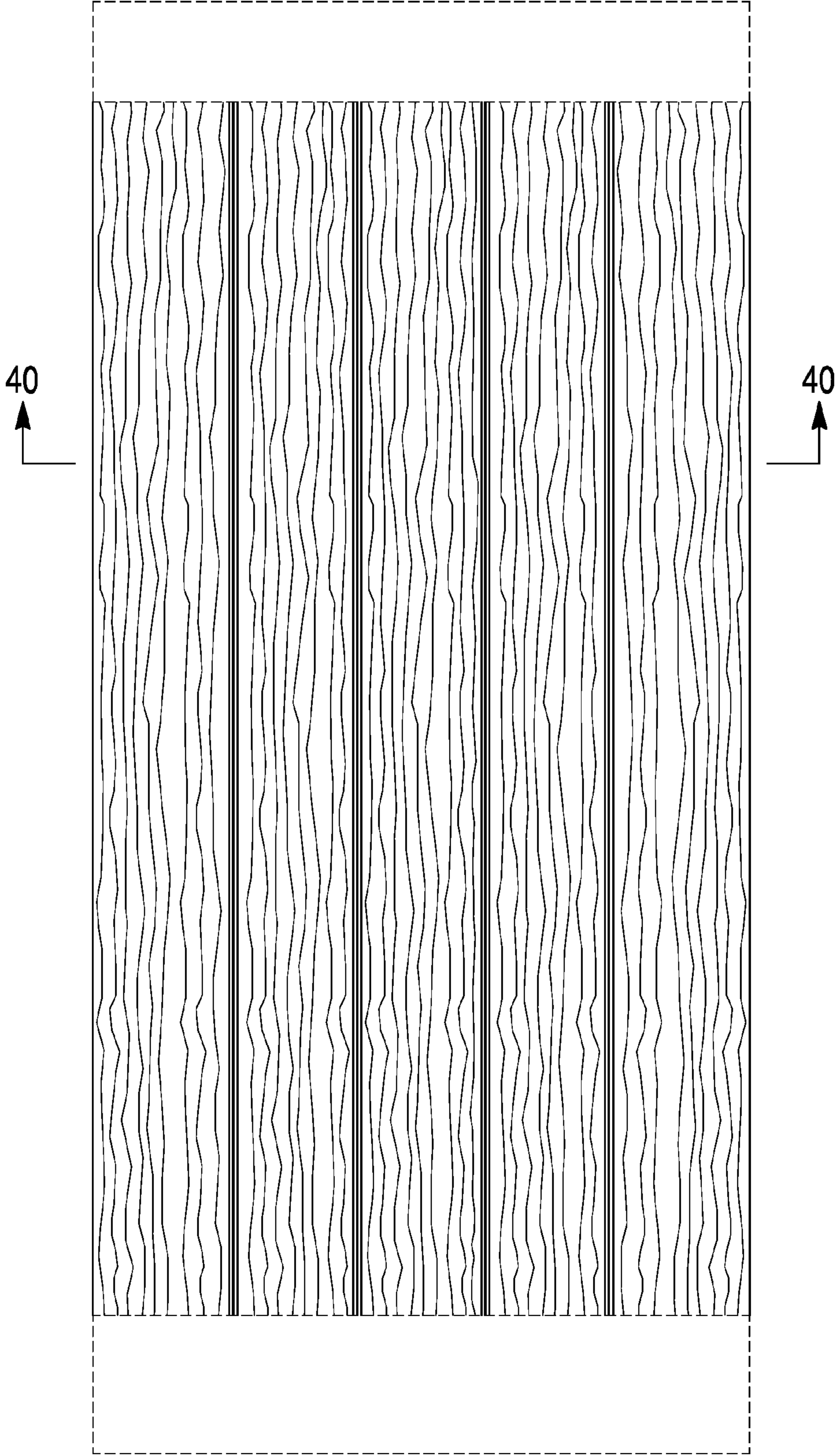

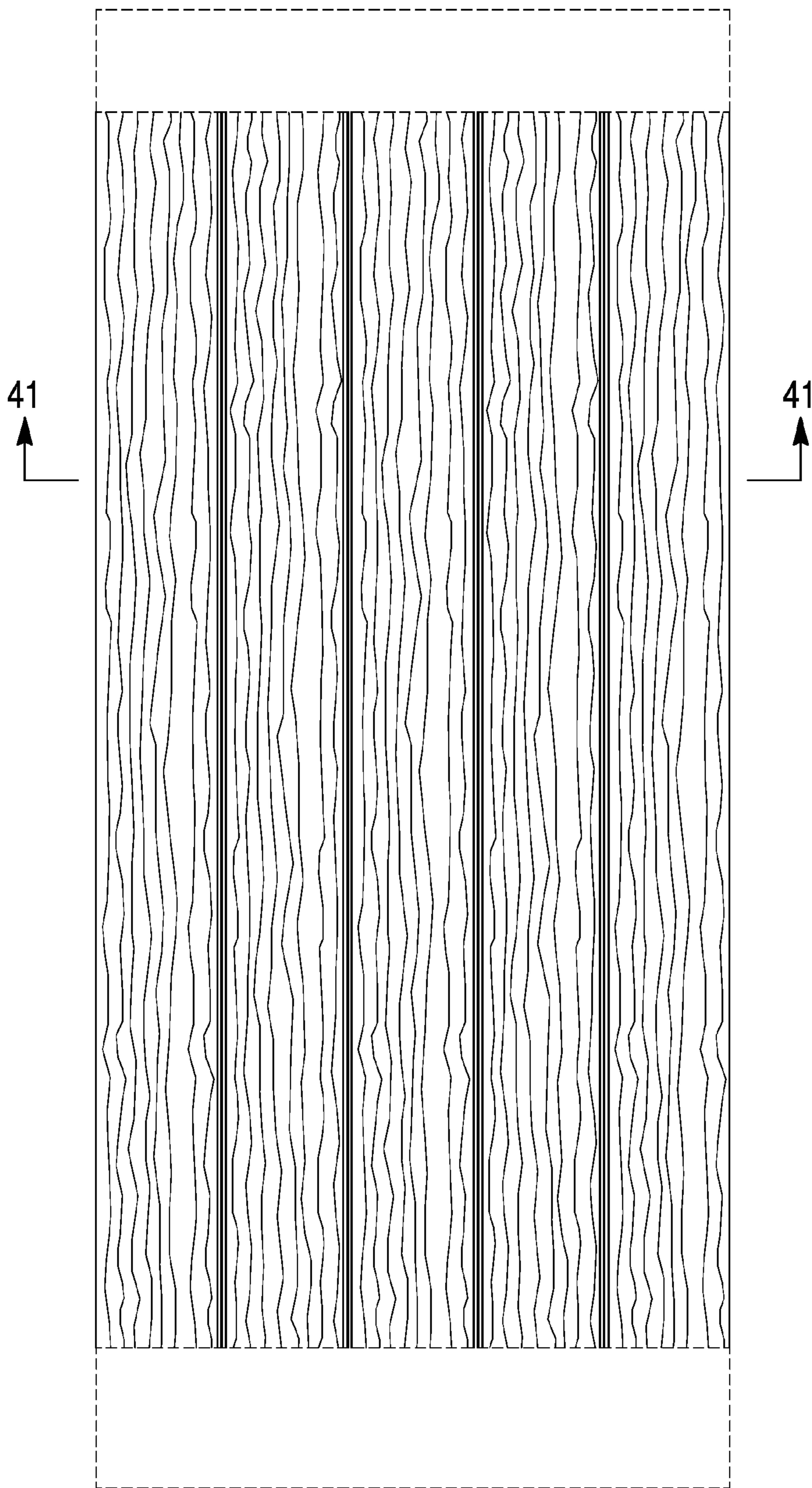

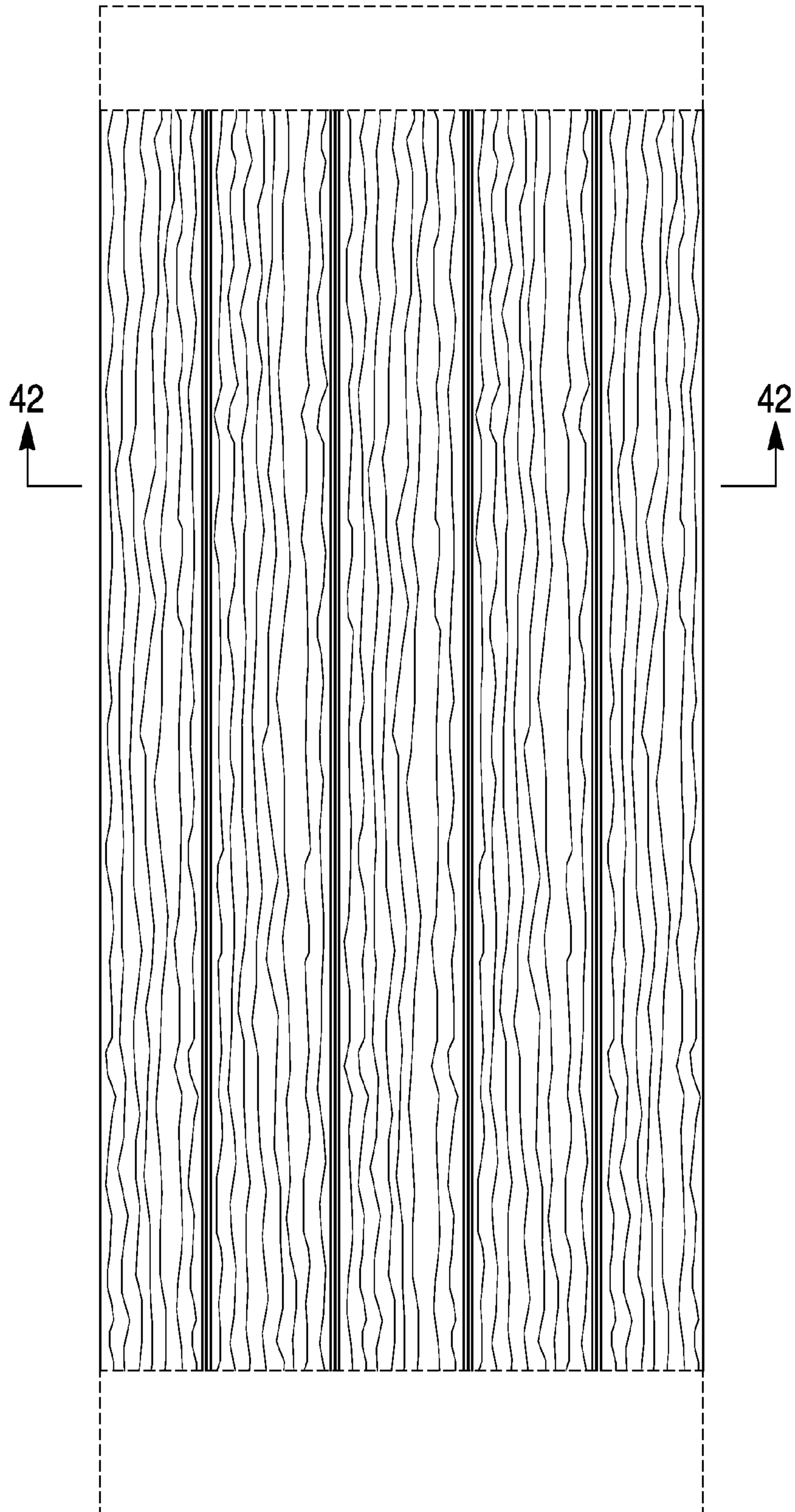

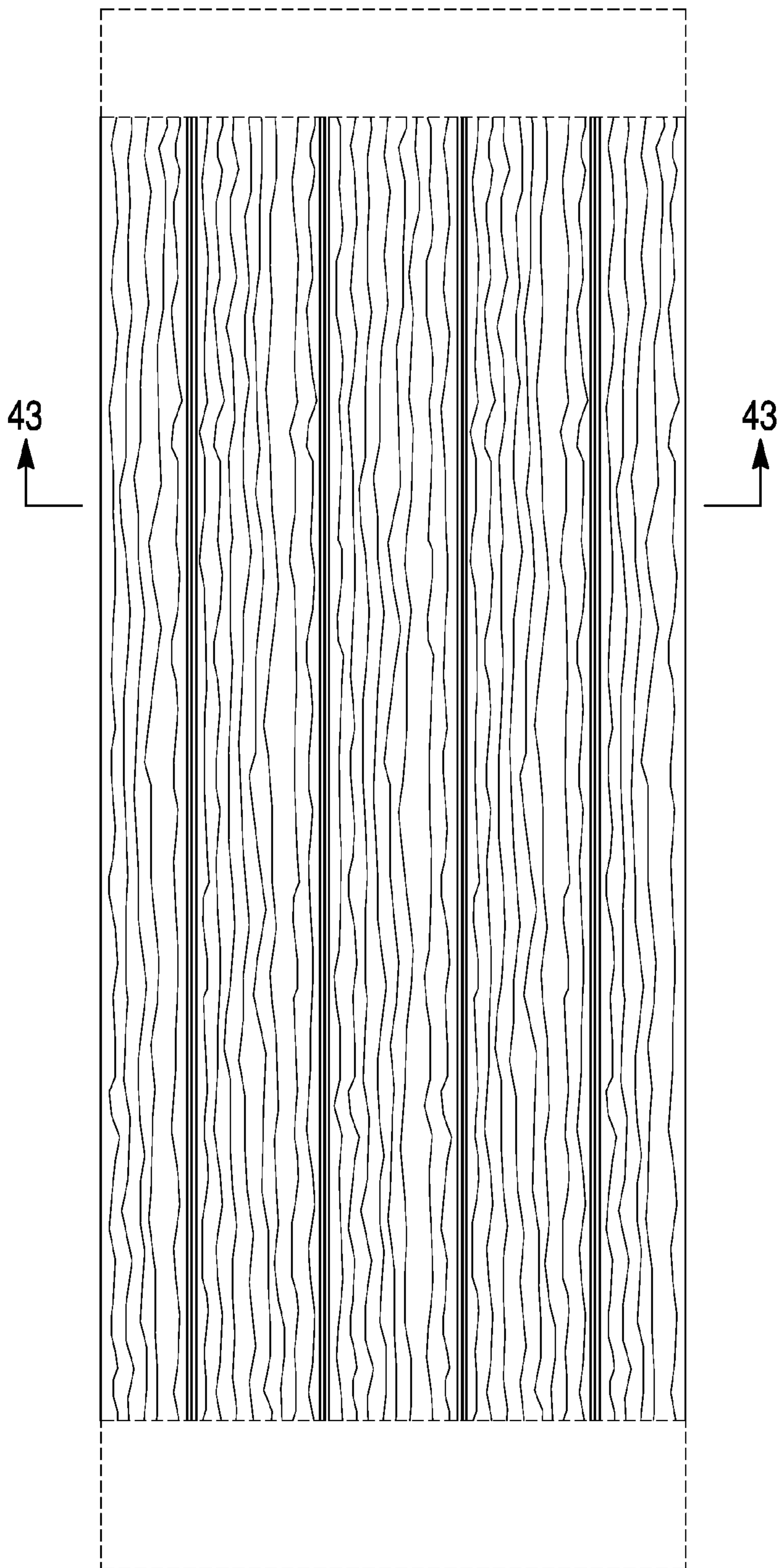

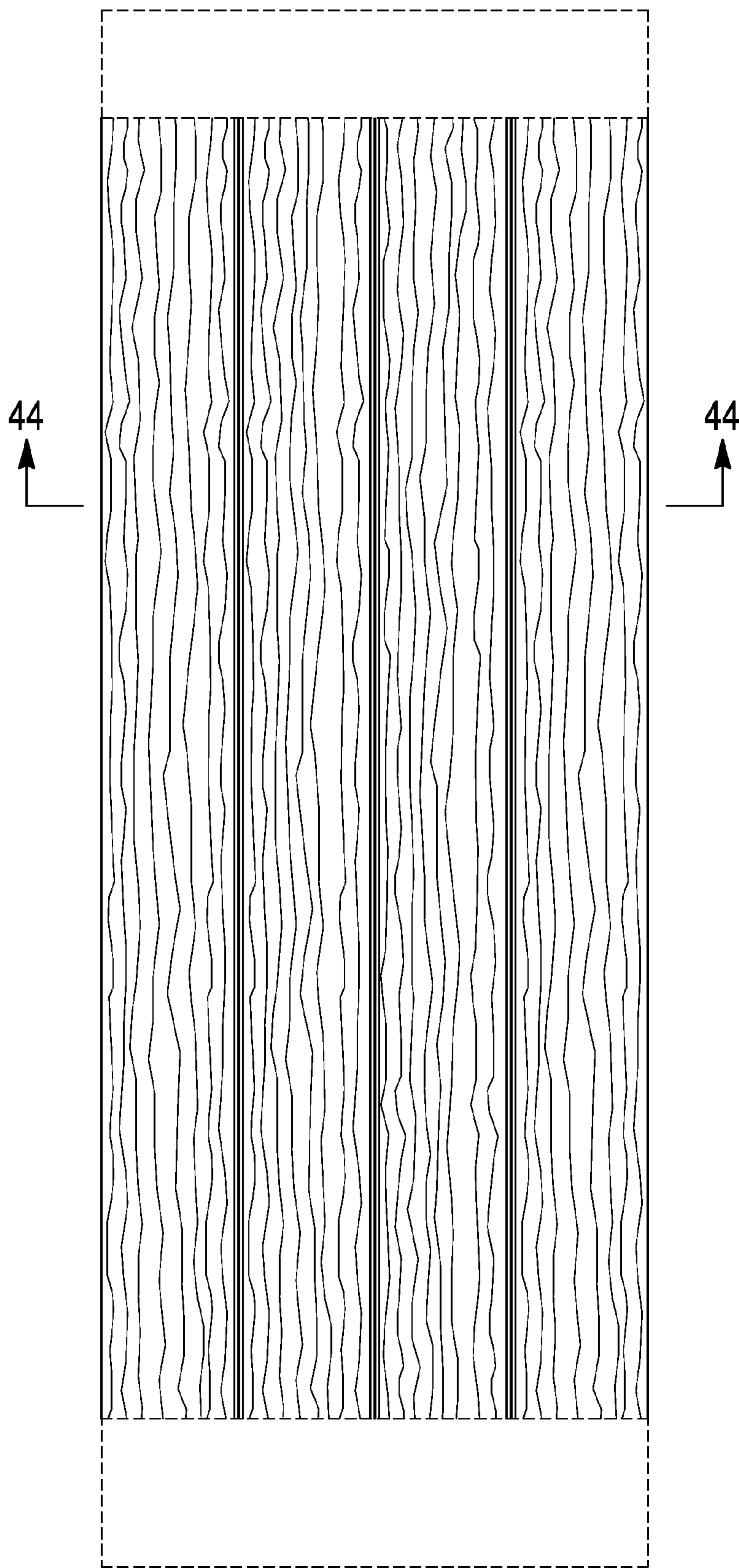

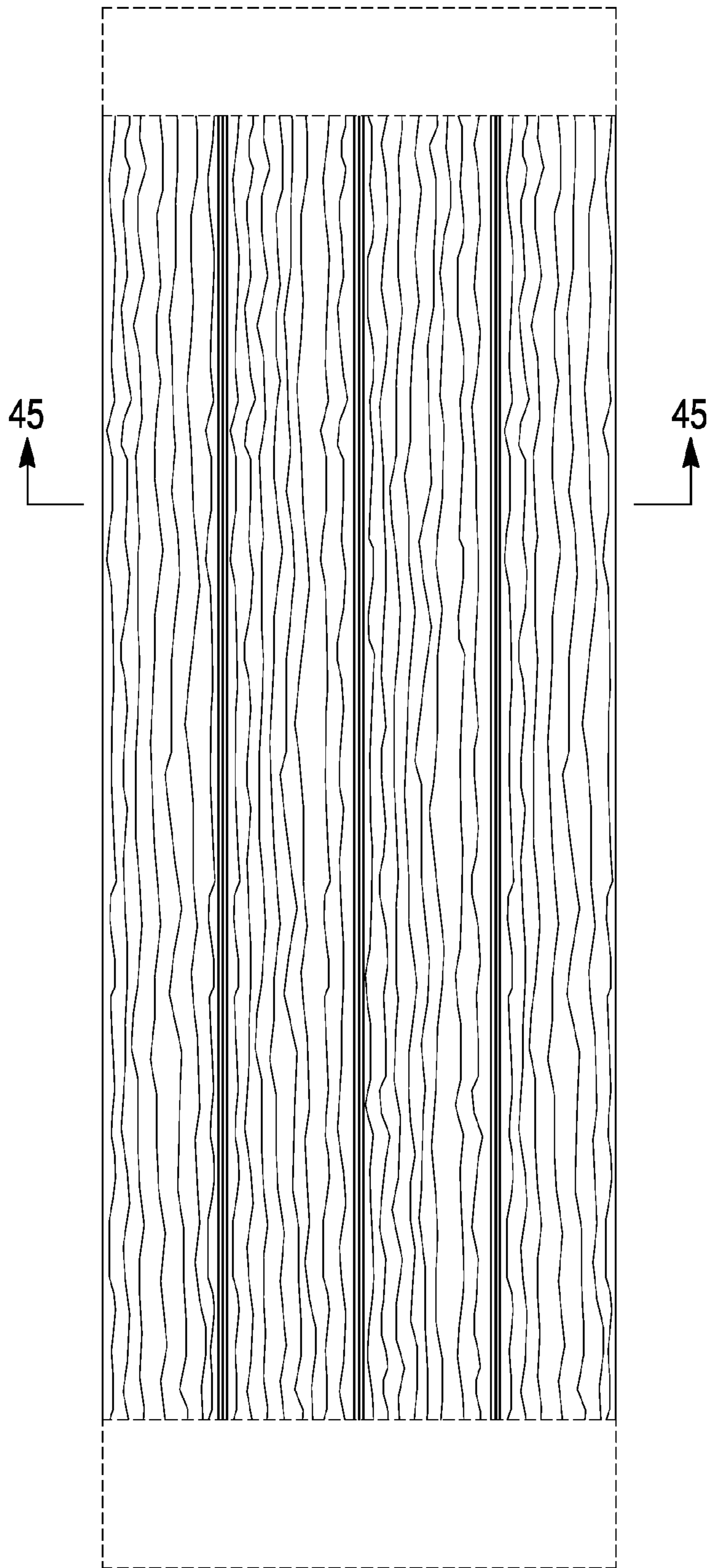

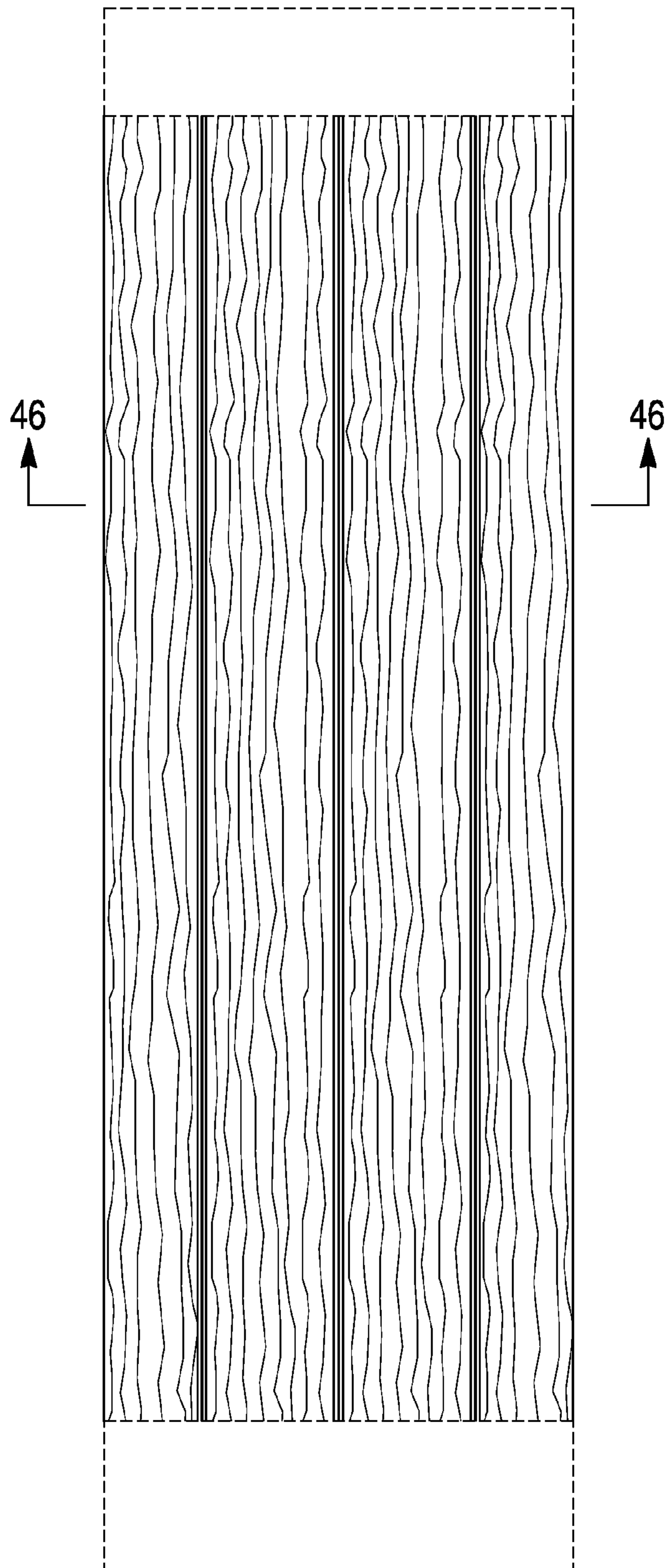

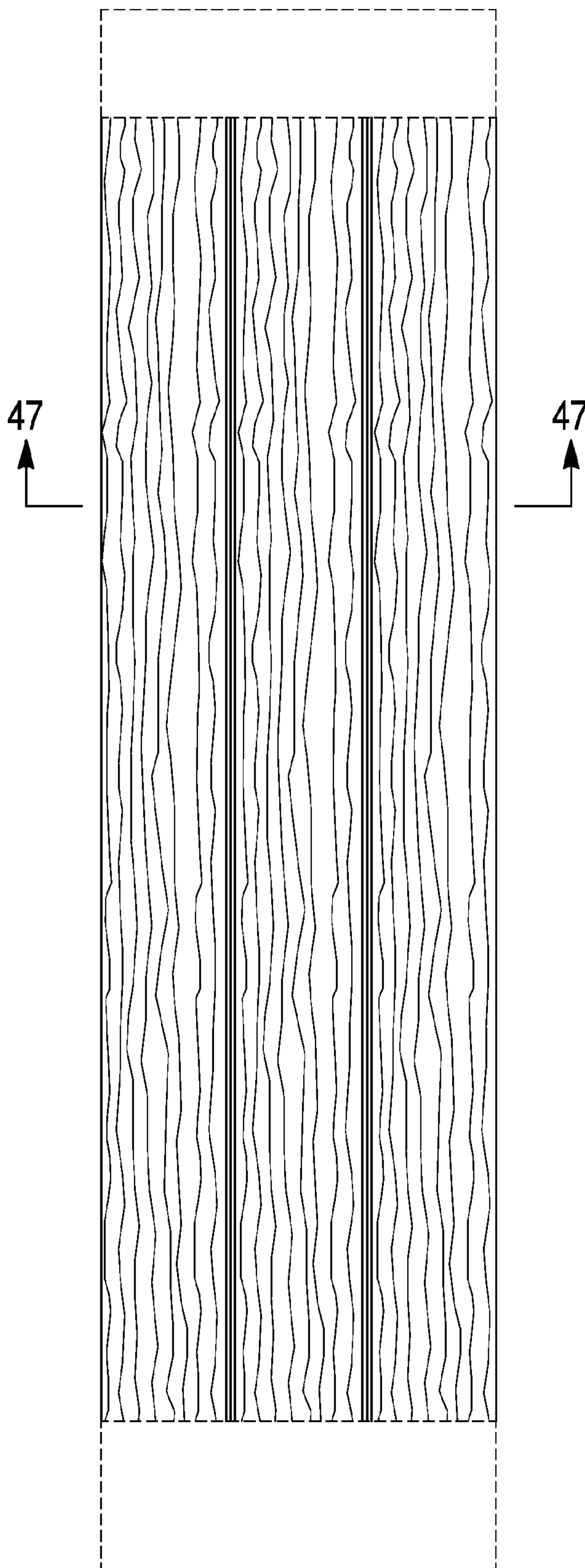

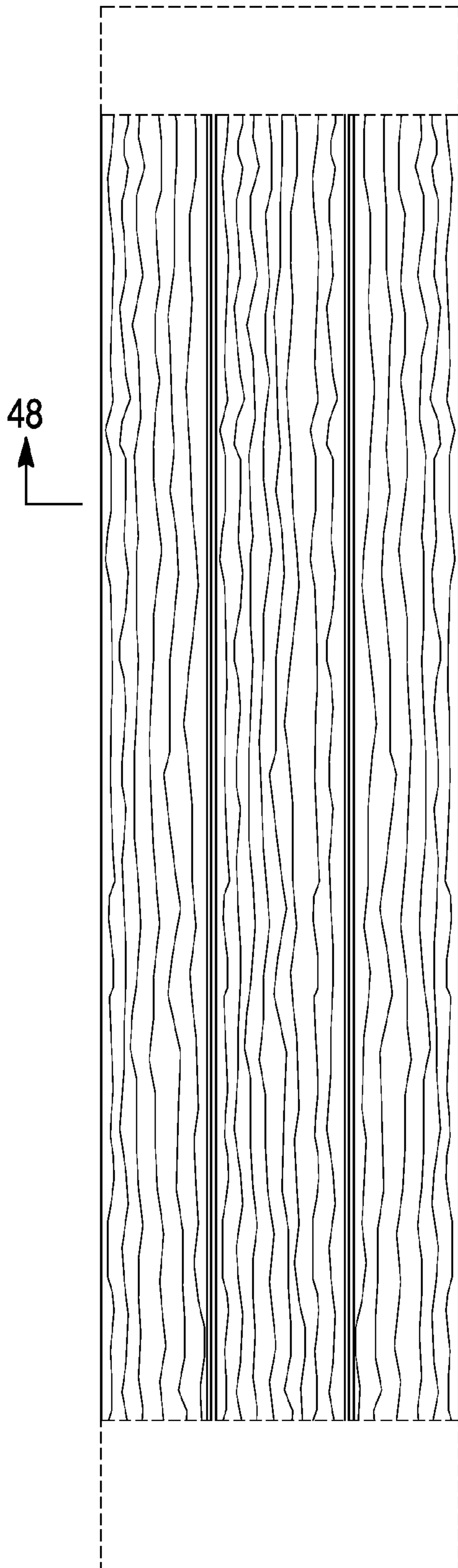

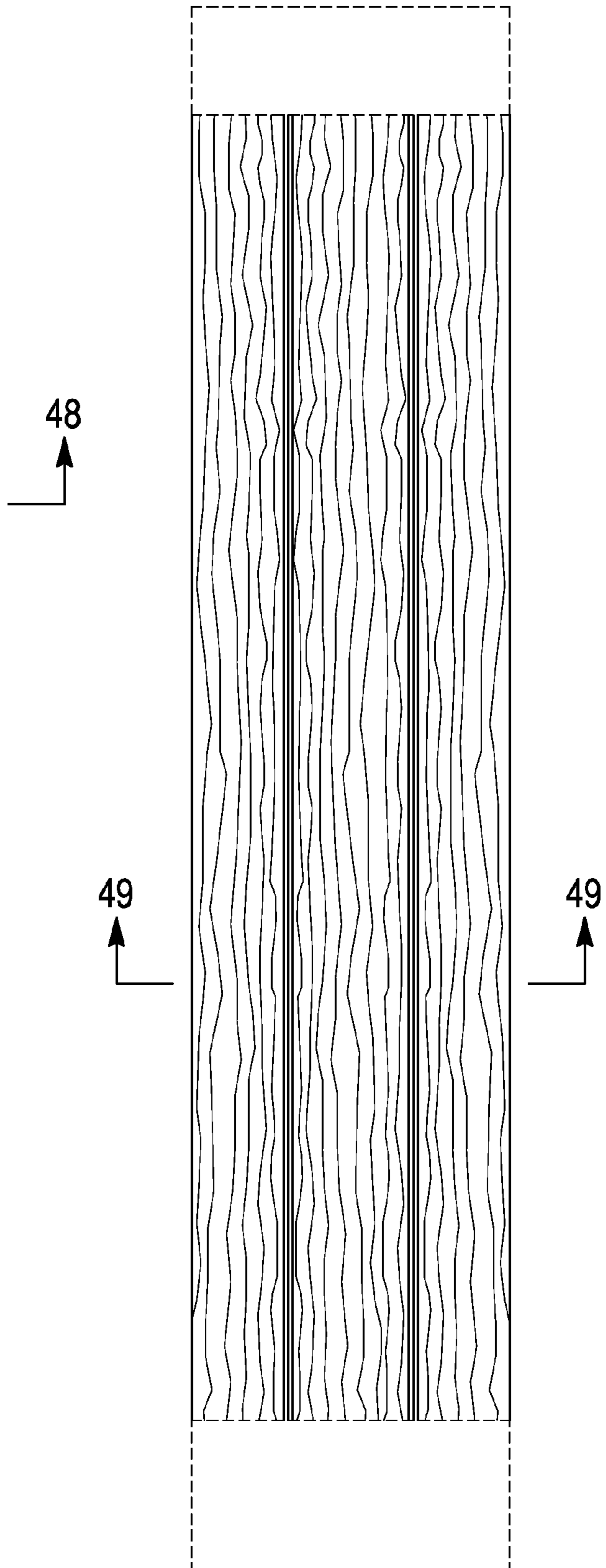

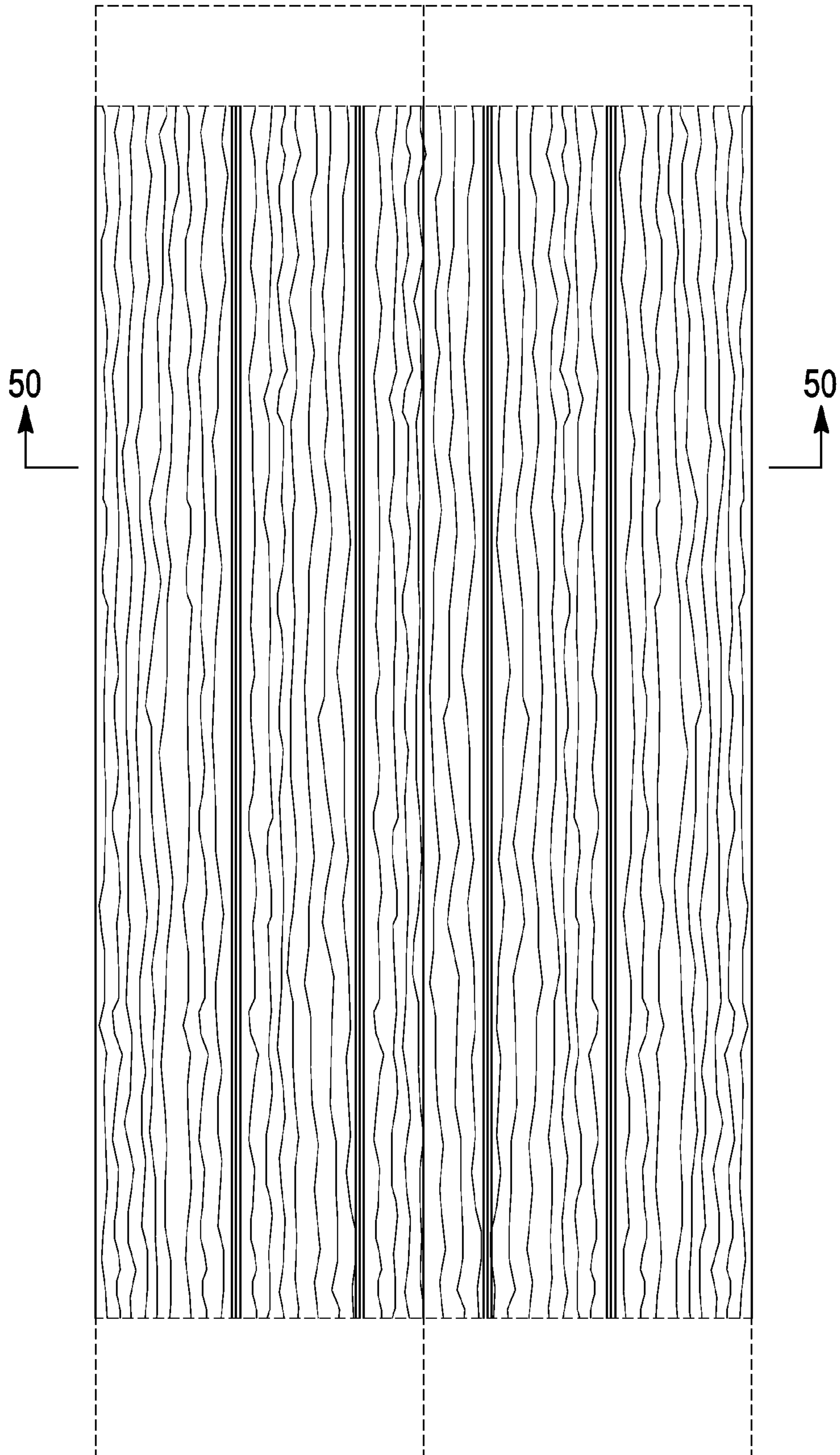

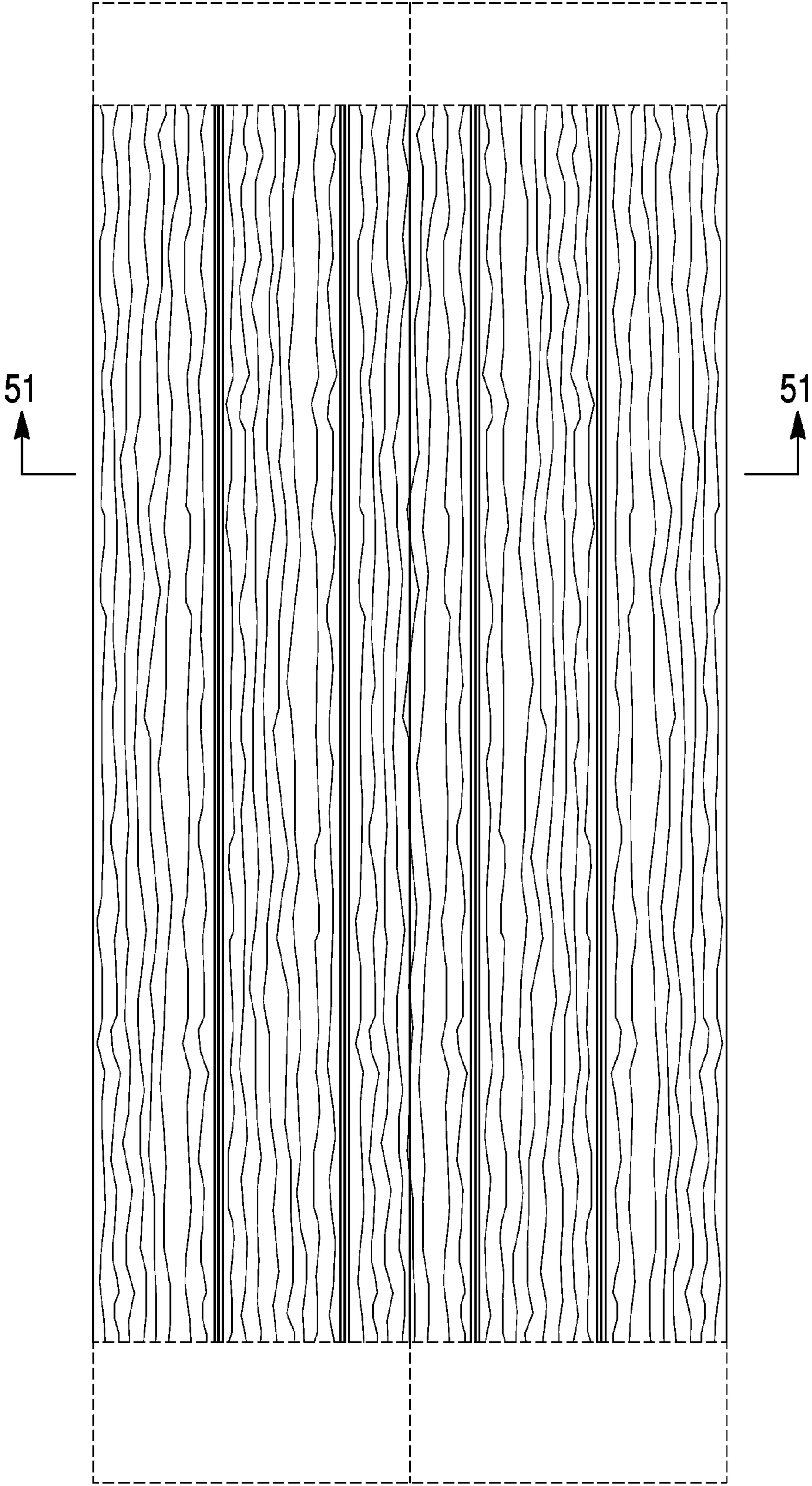

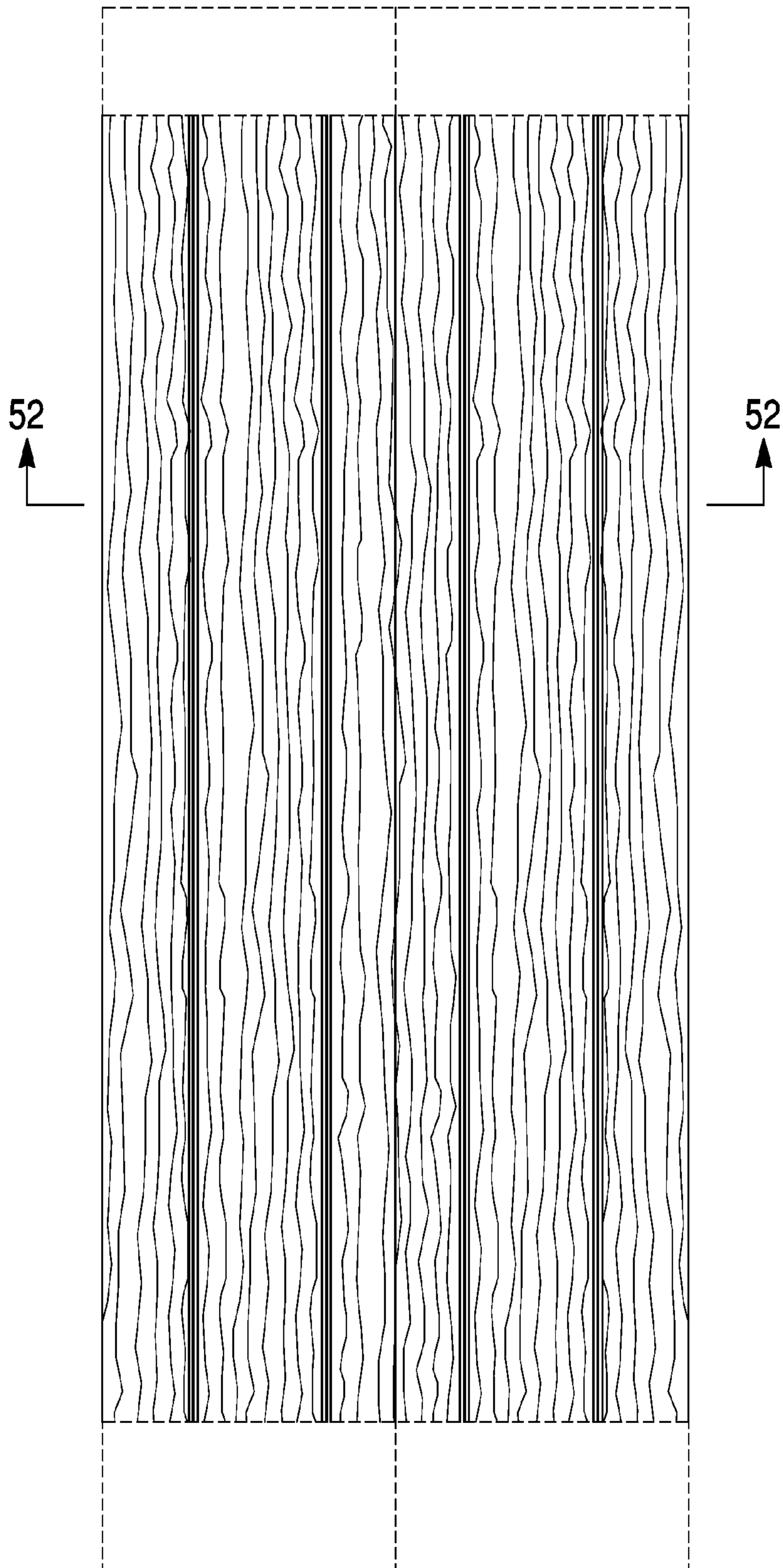

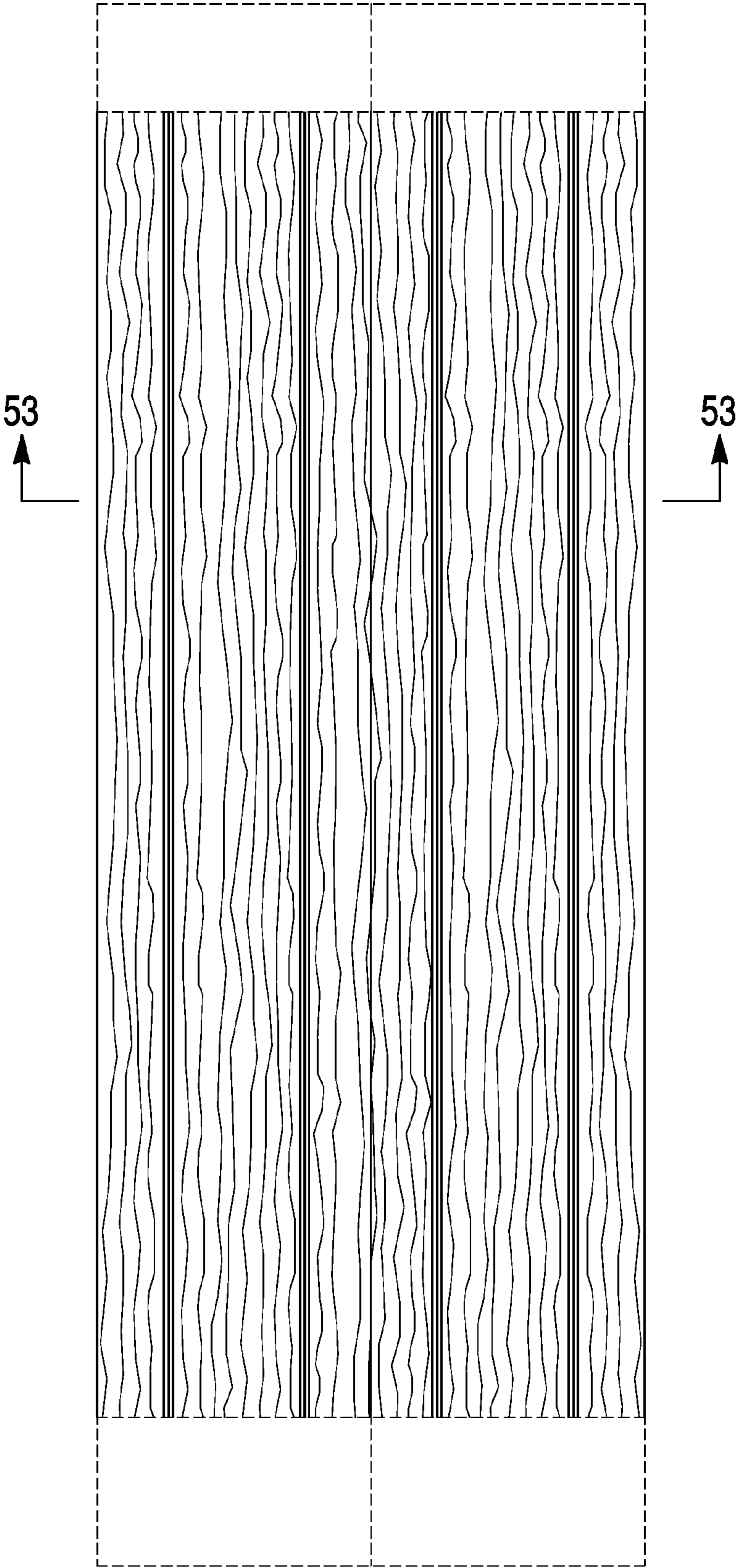

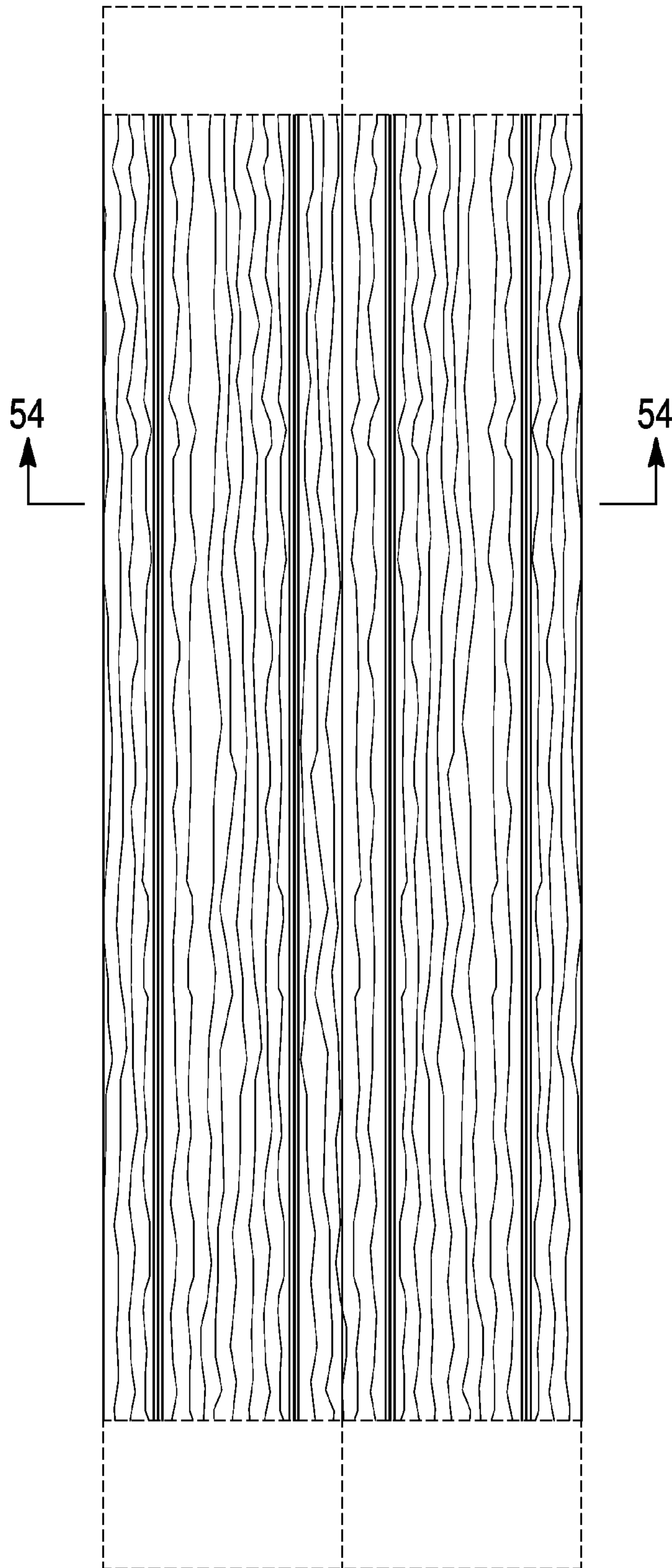

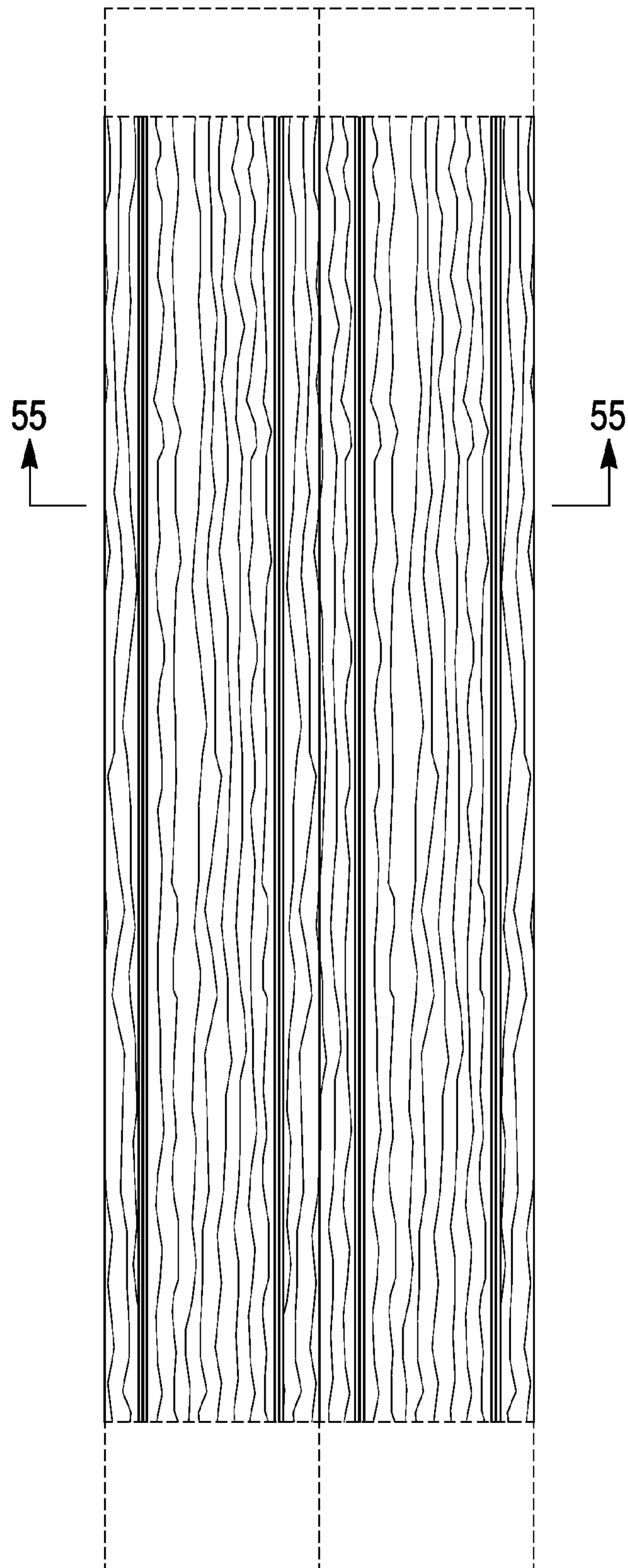

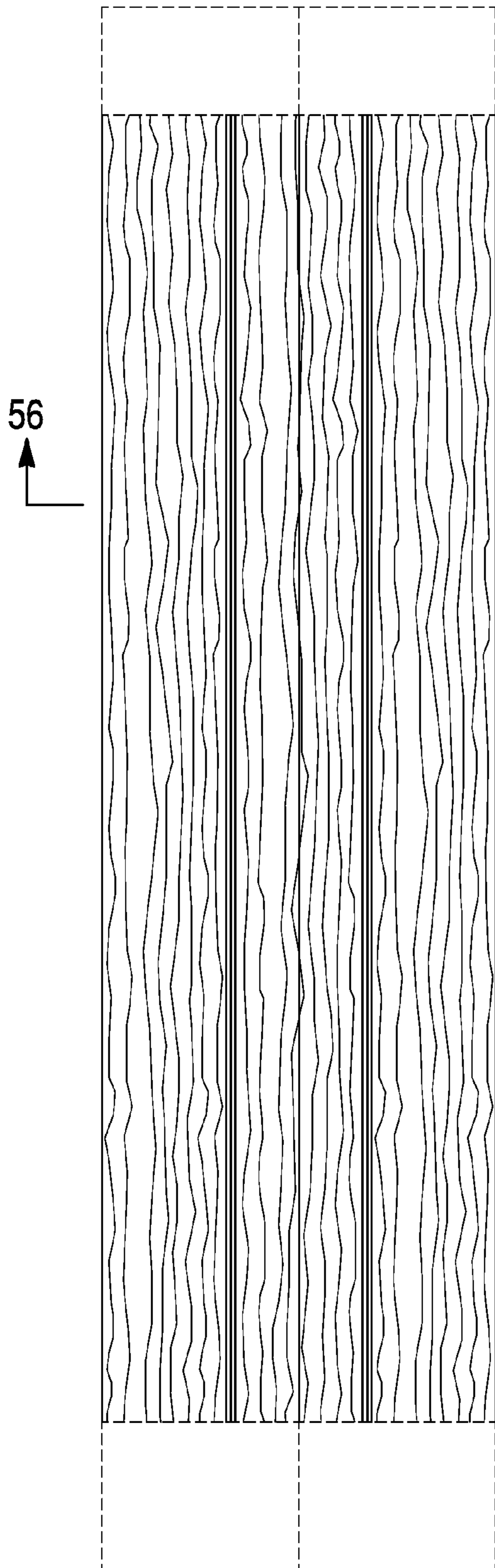

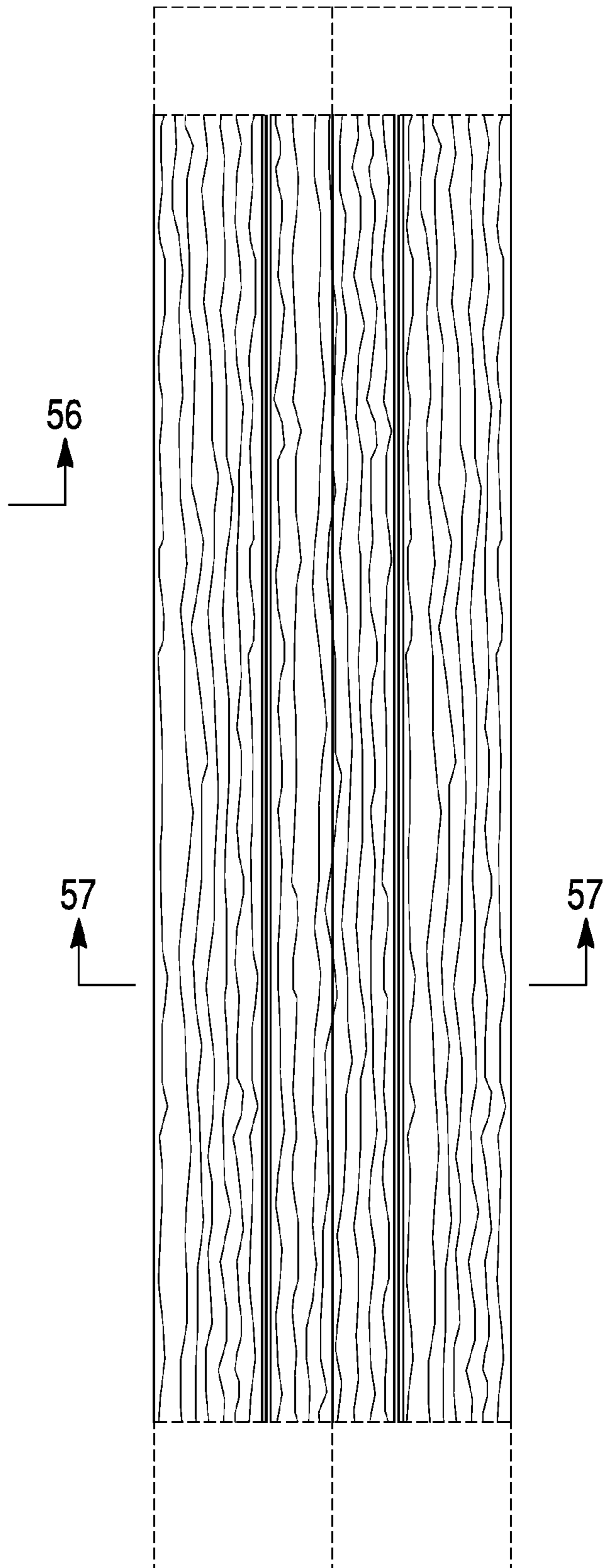

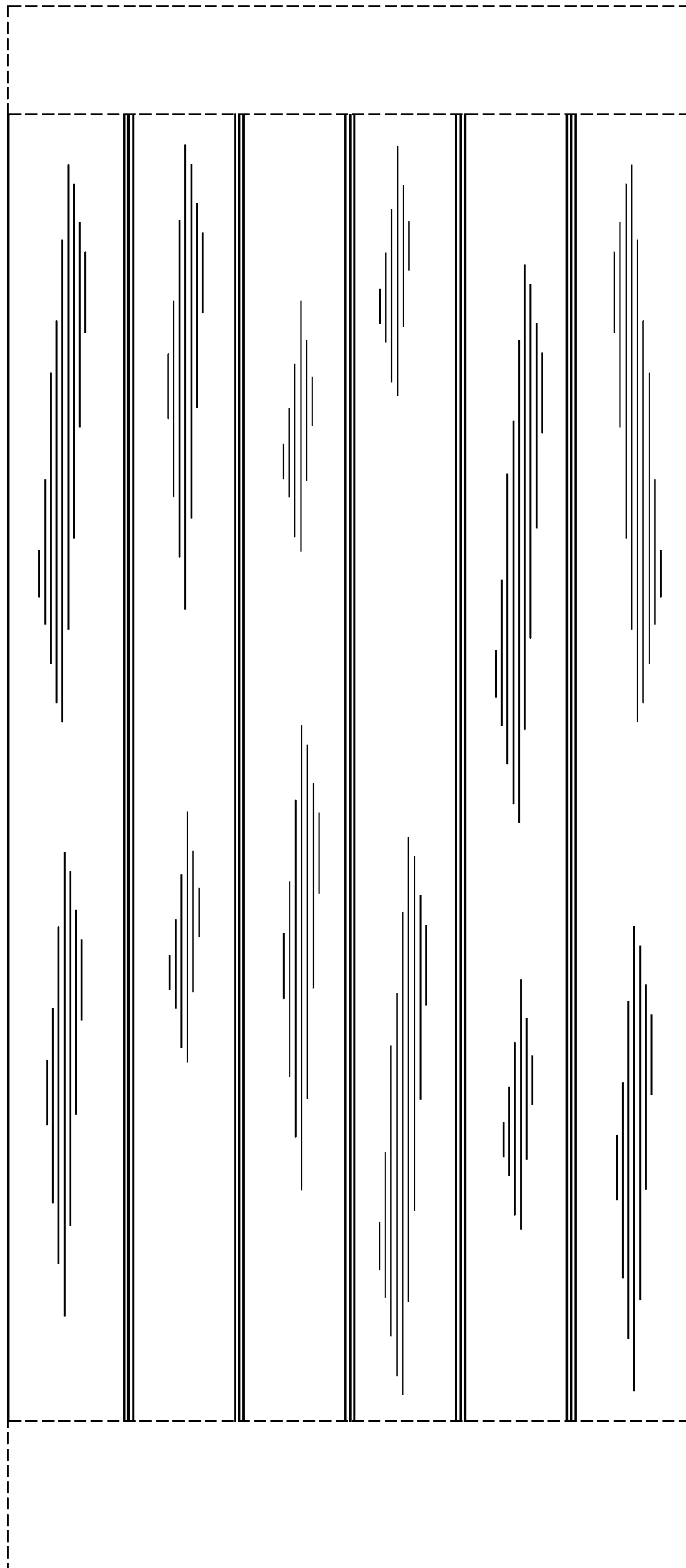

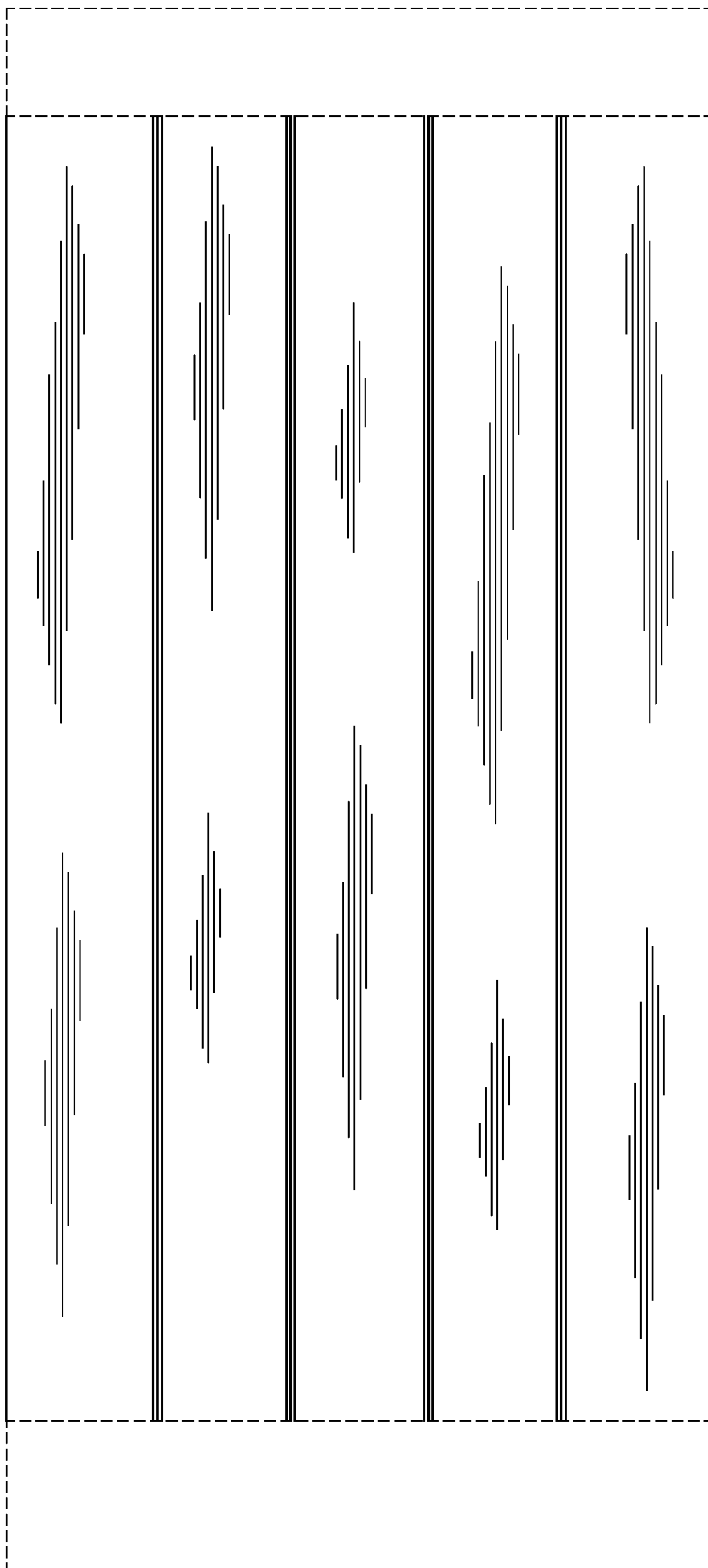

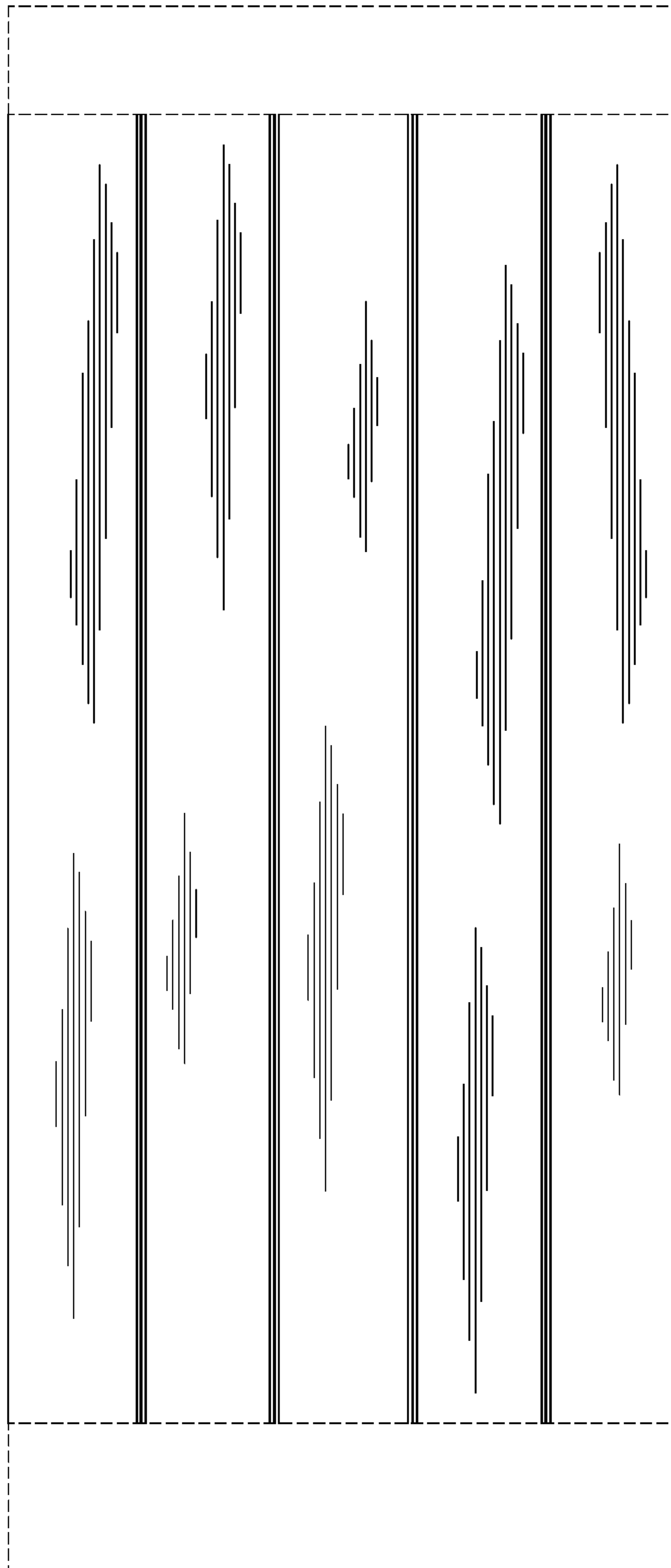

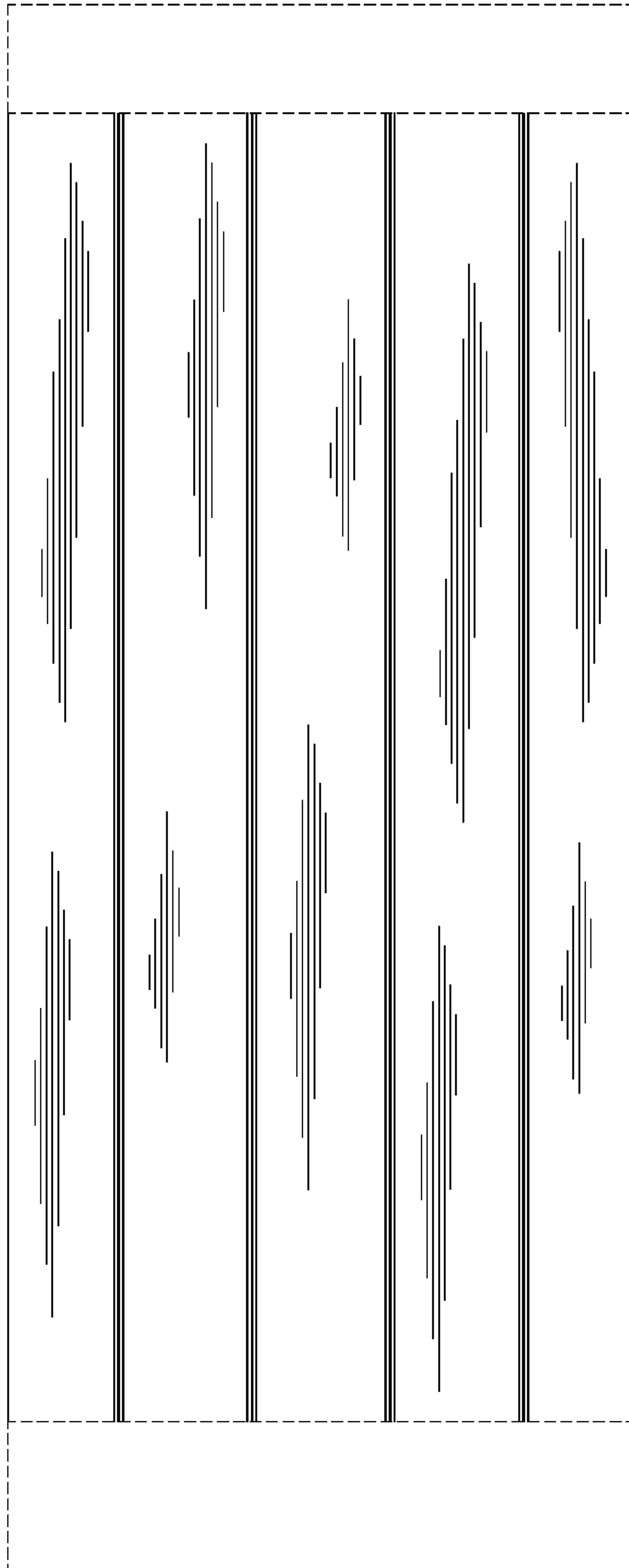

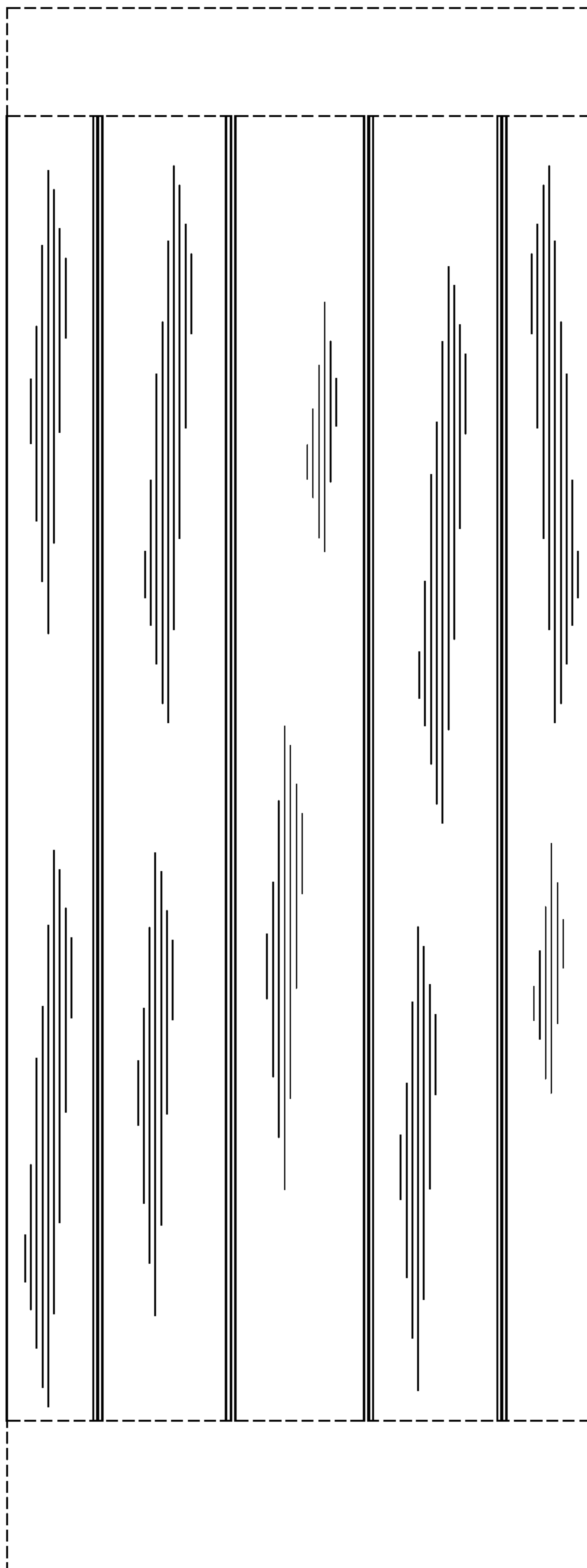

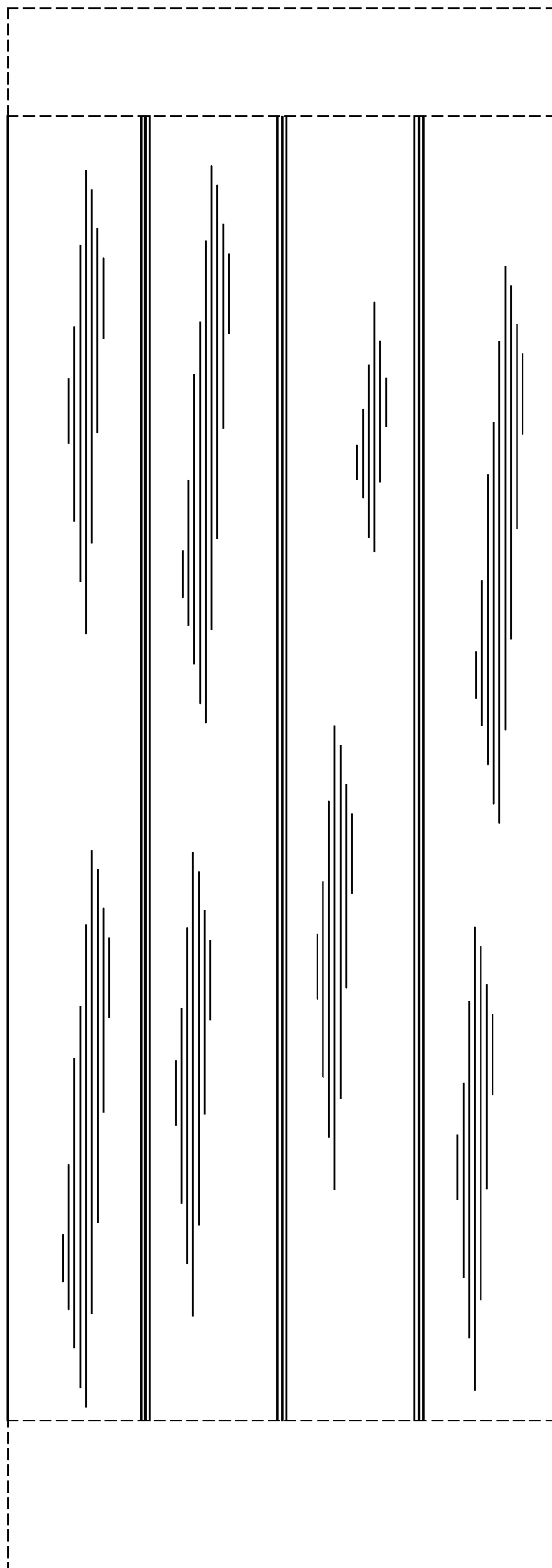

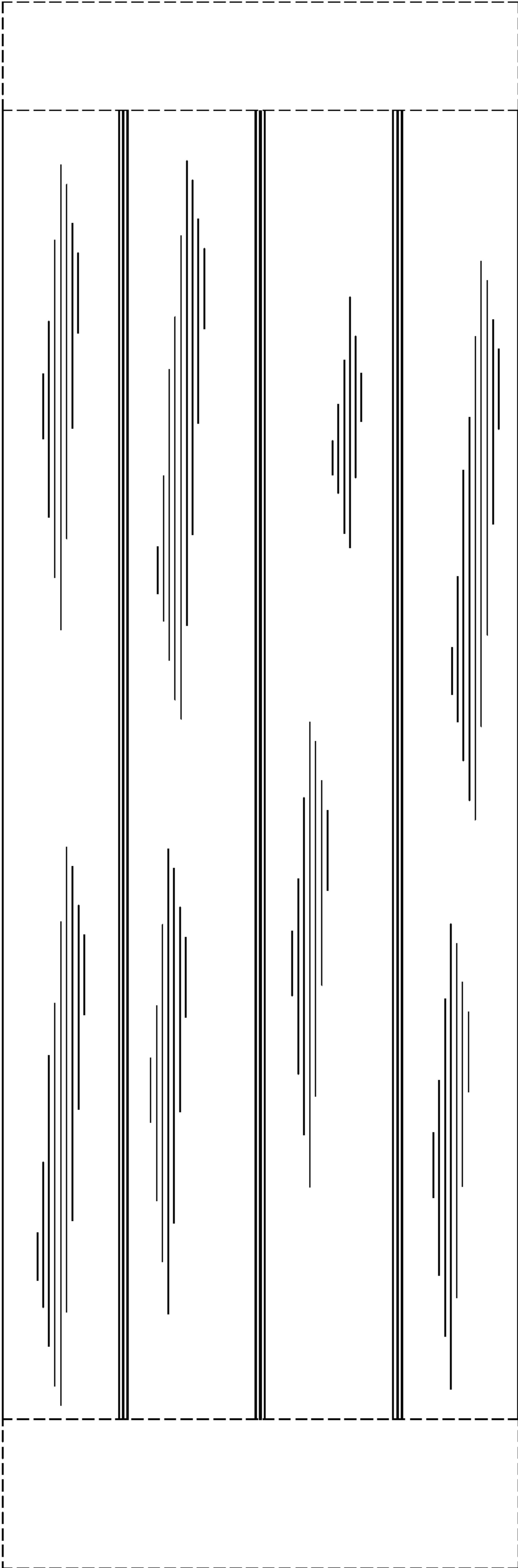

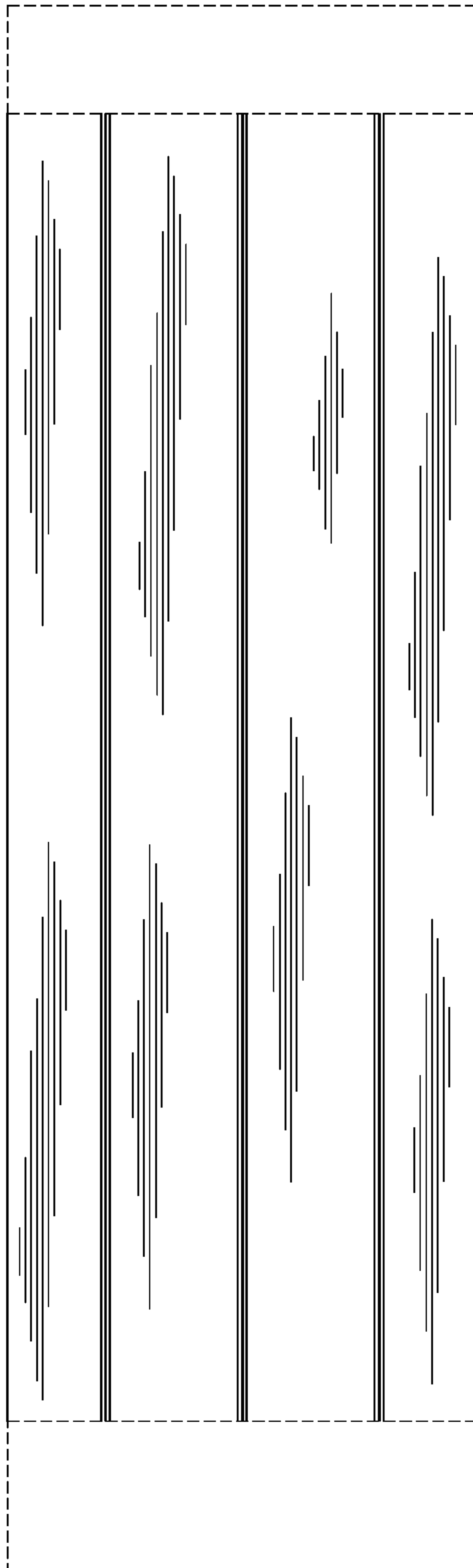

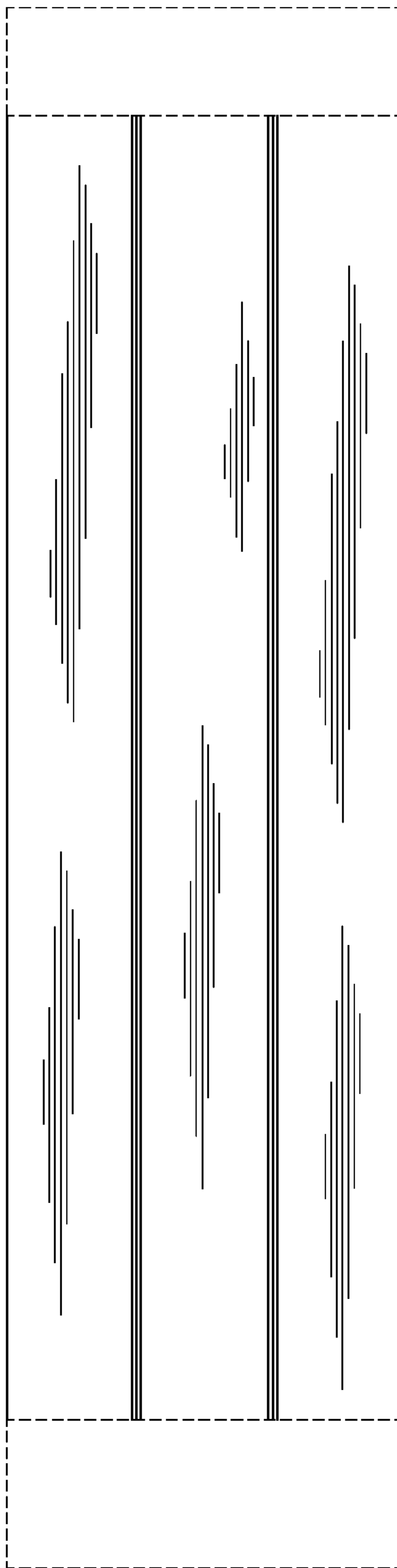

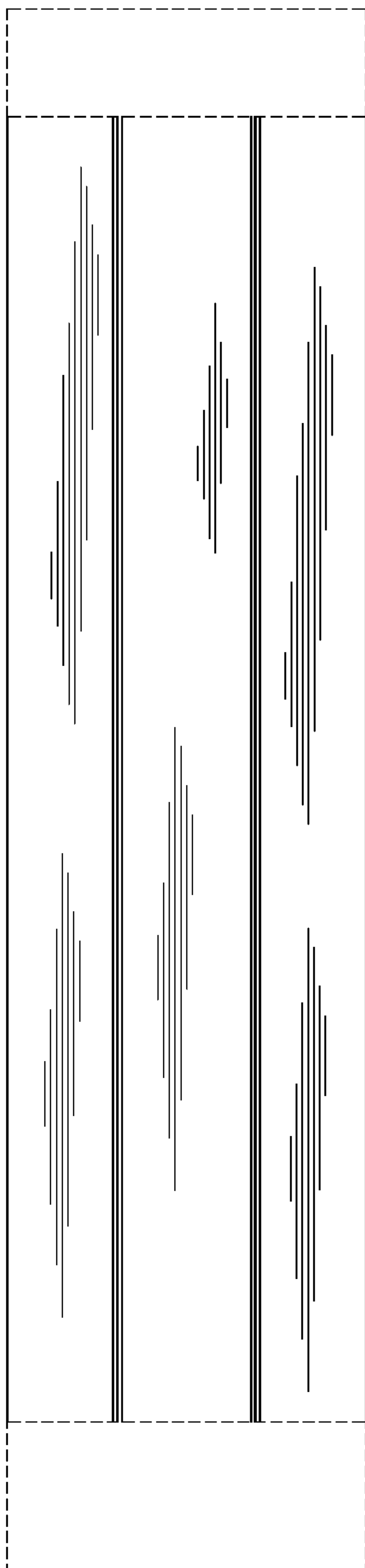

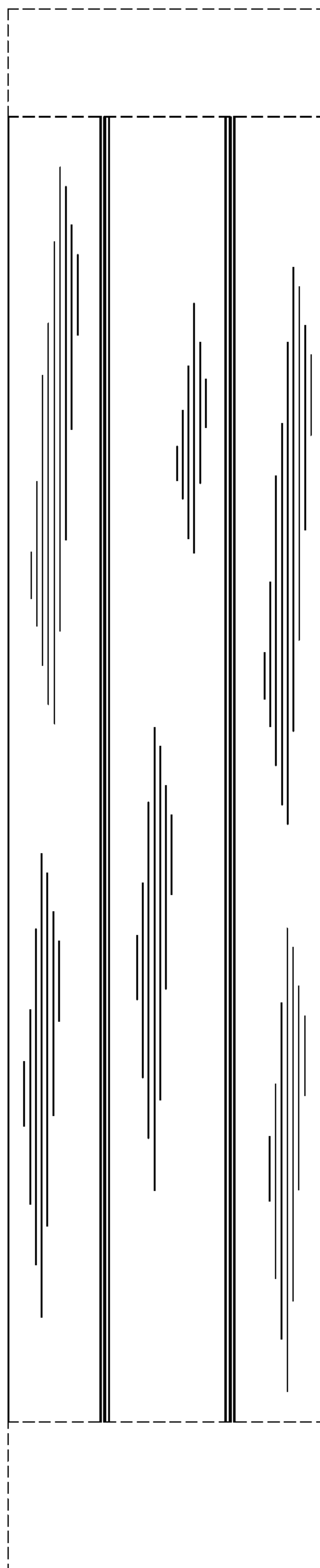

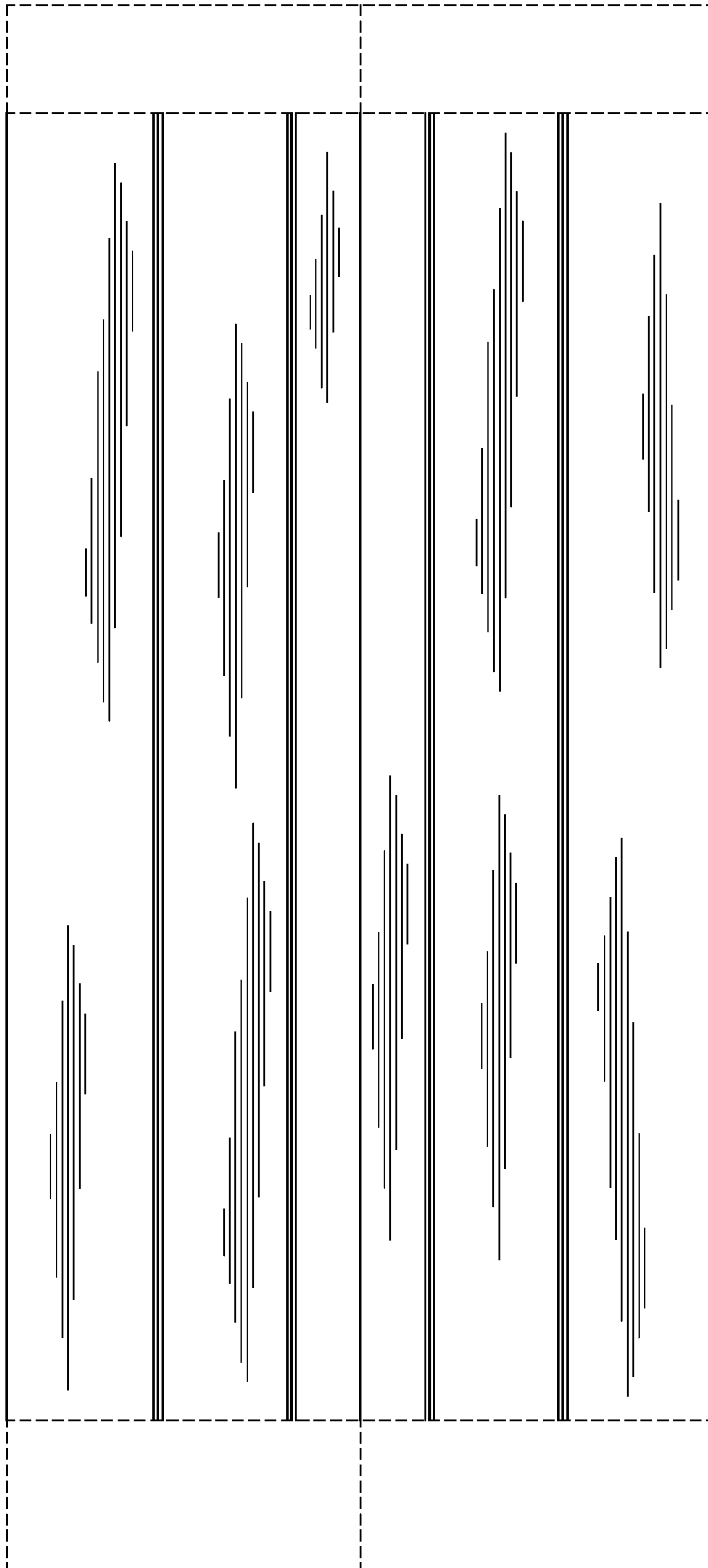

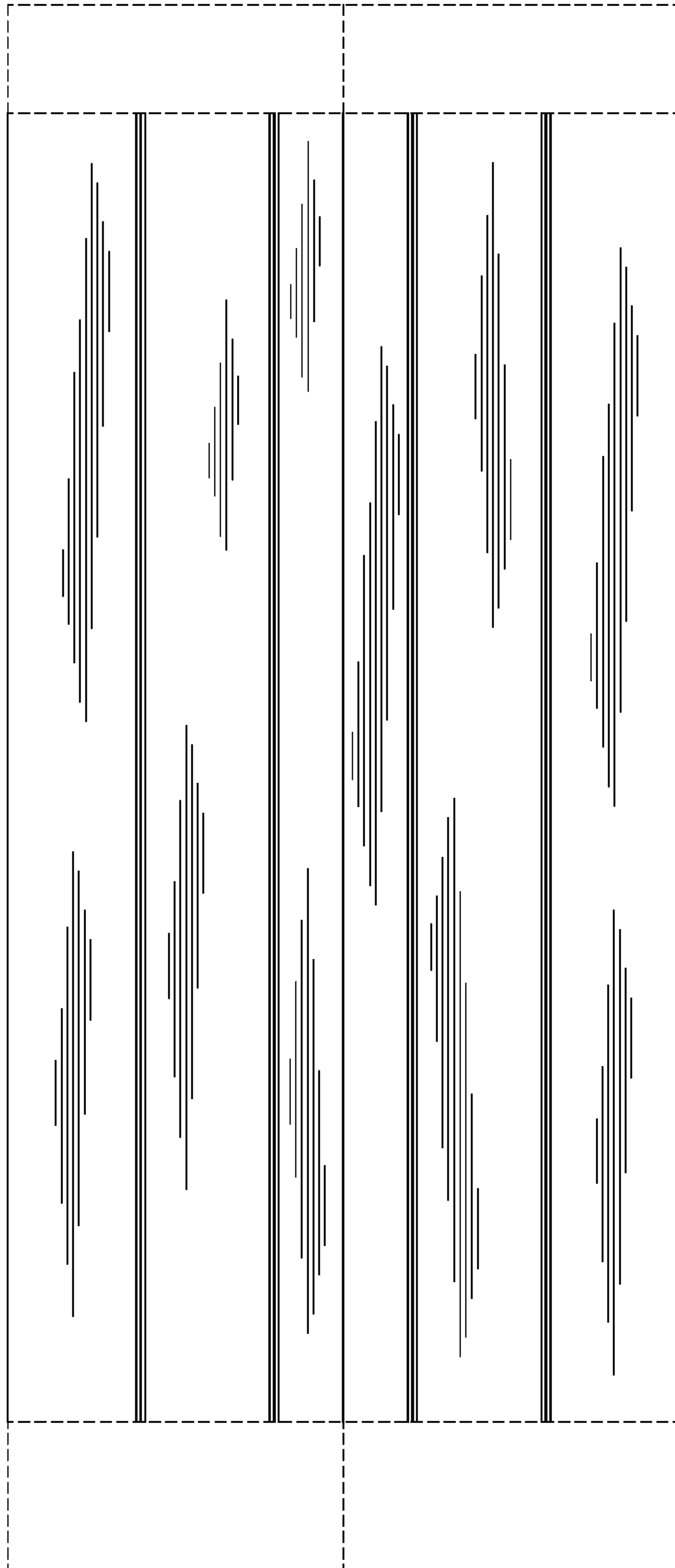

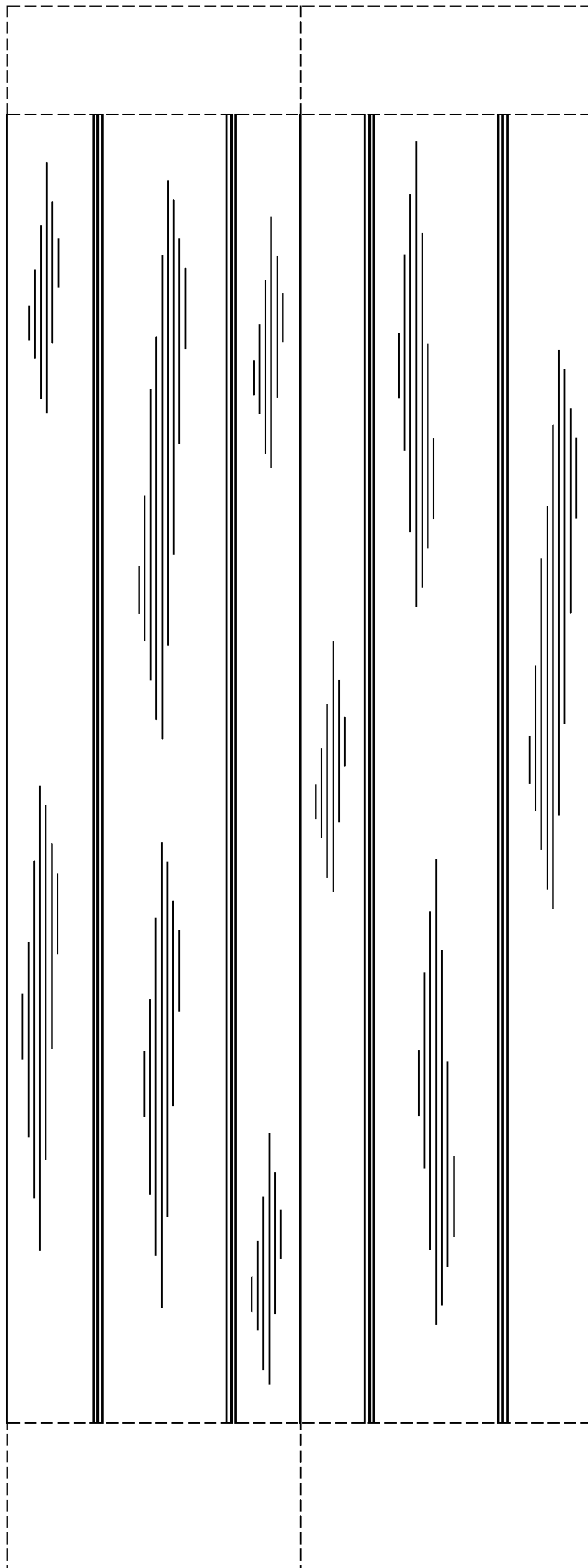

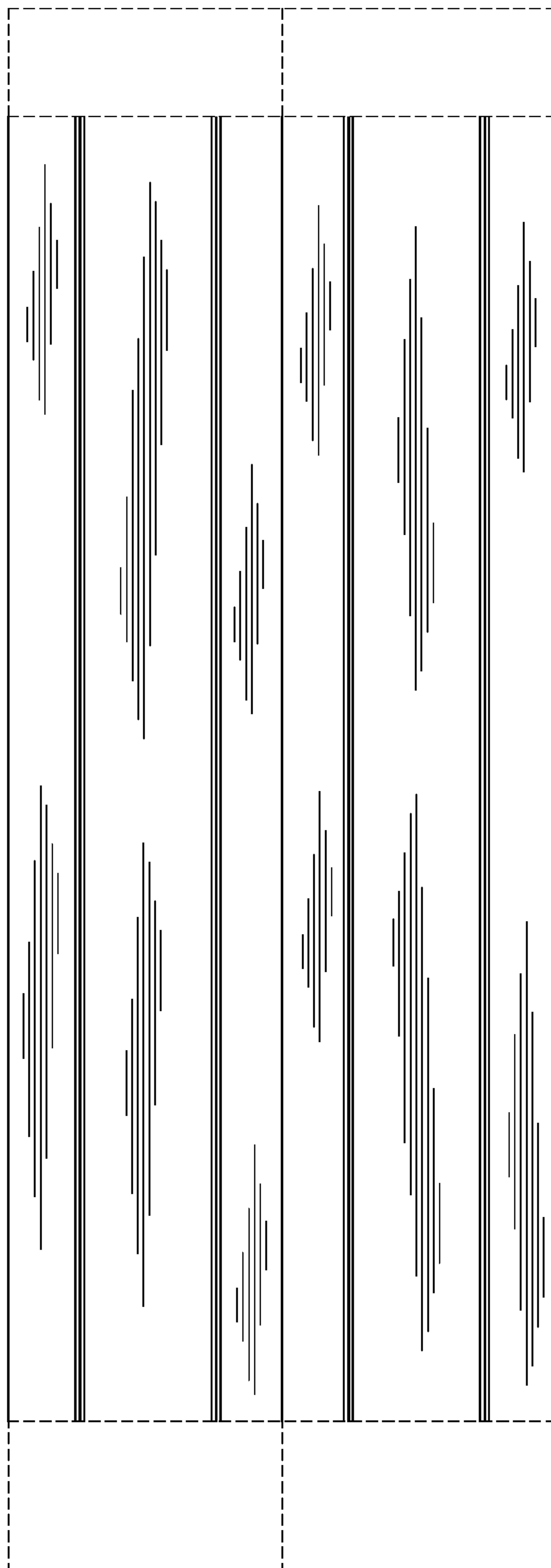

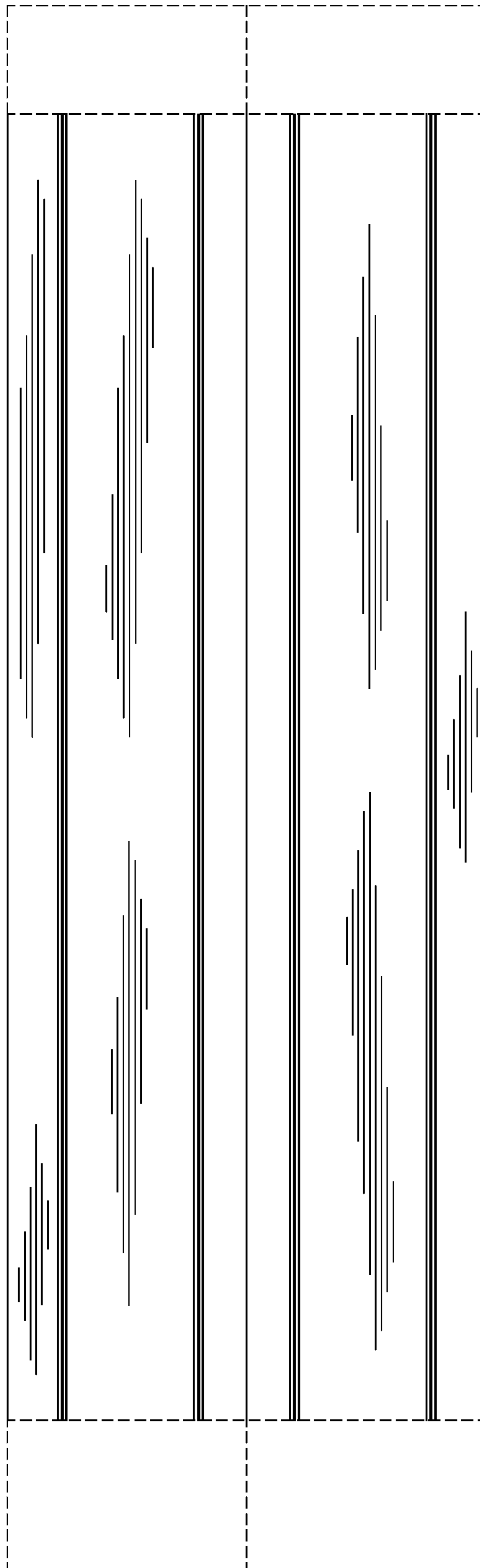

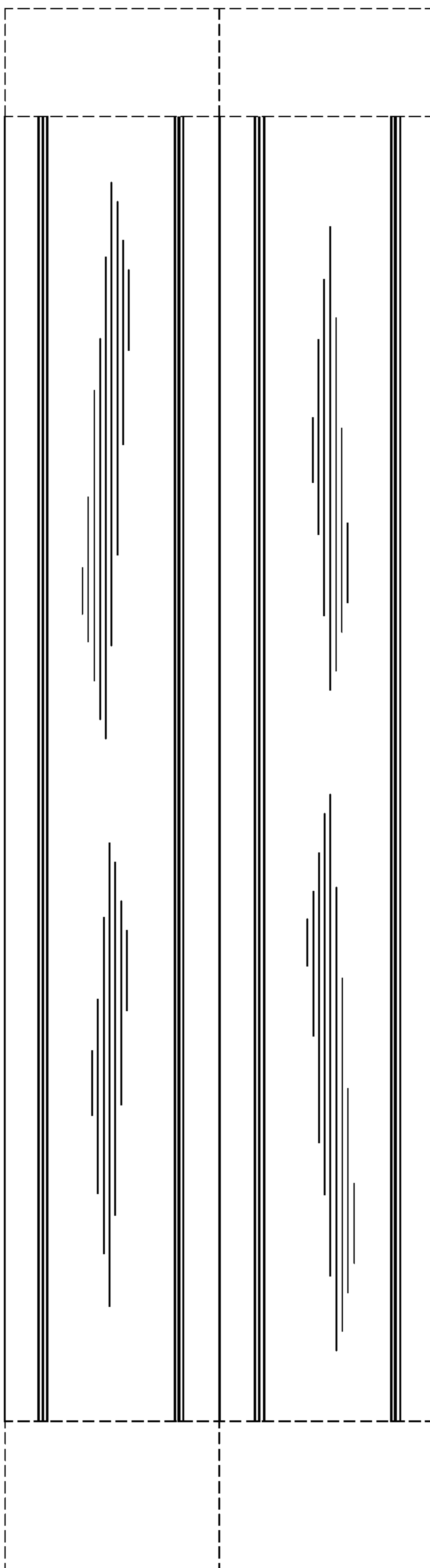

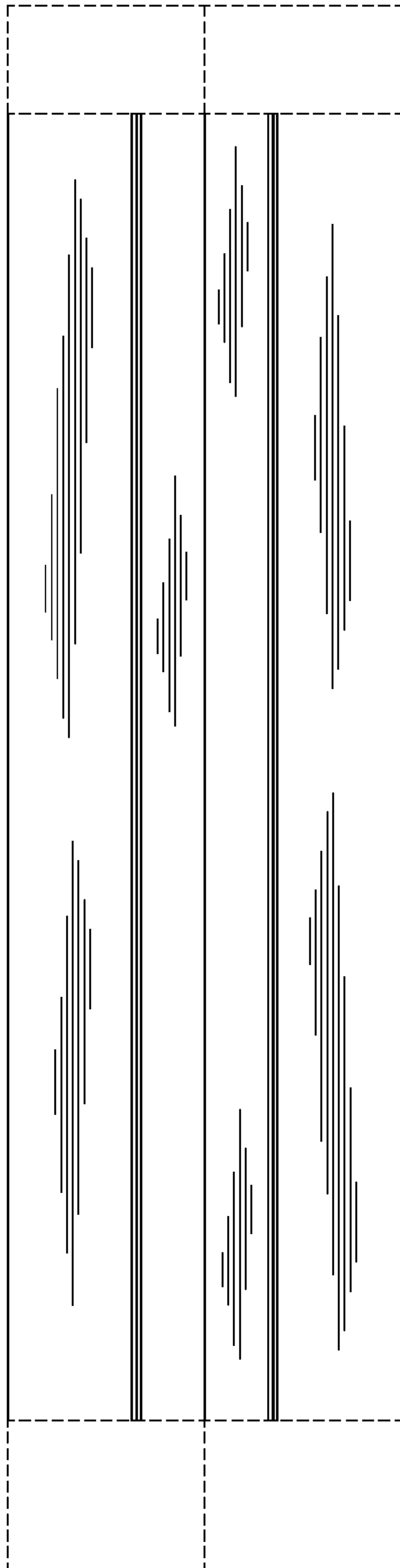

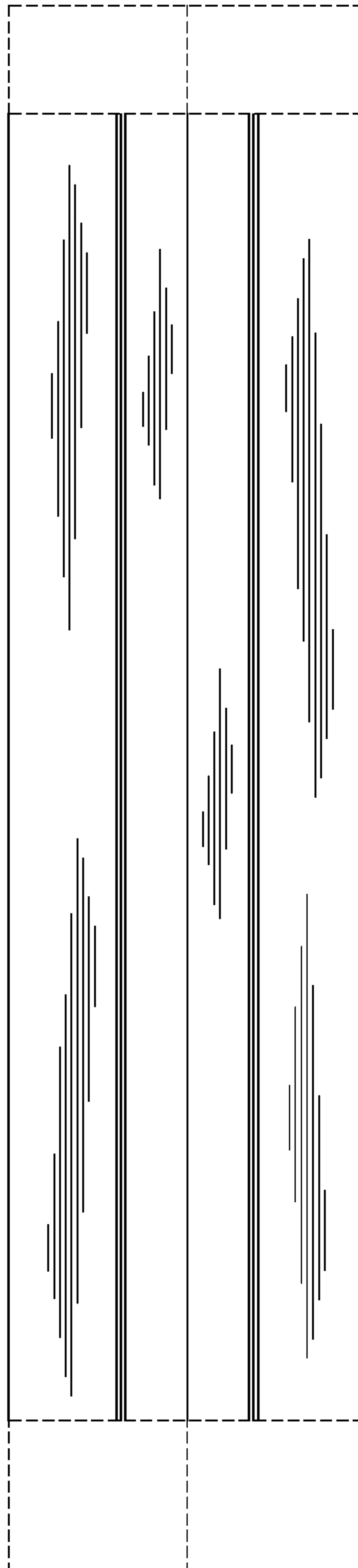
