FIG. 1 is a perspective view from the side of a lamp head in accordance with my design;

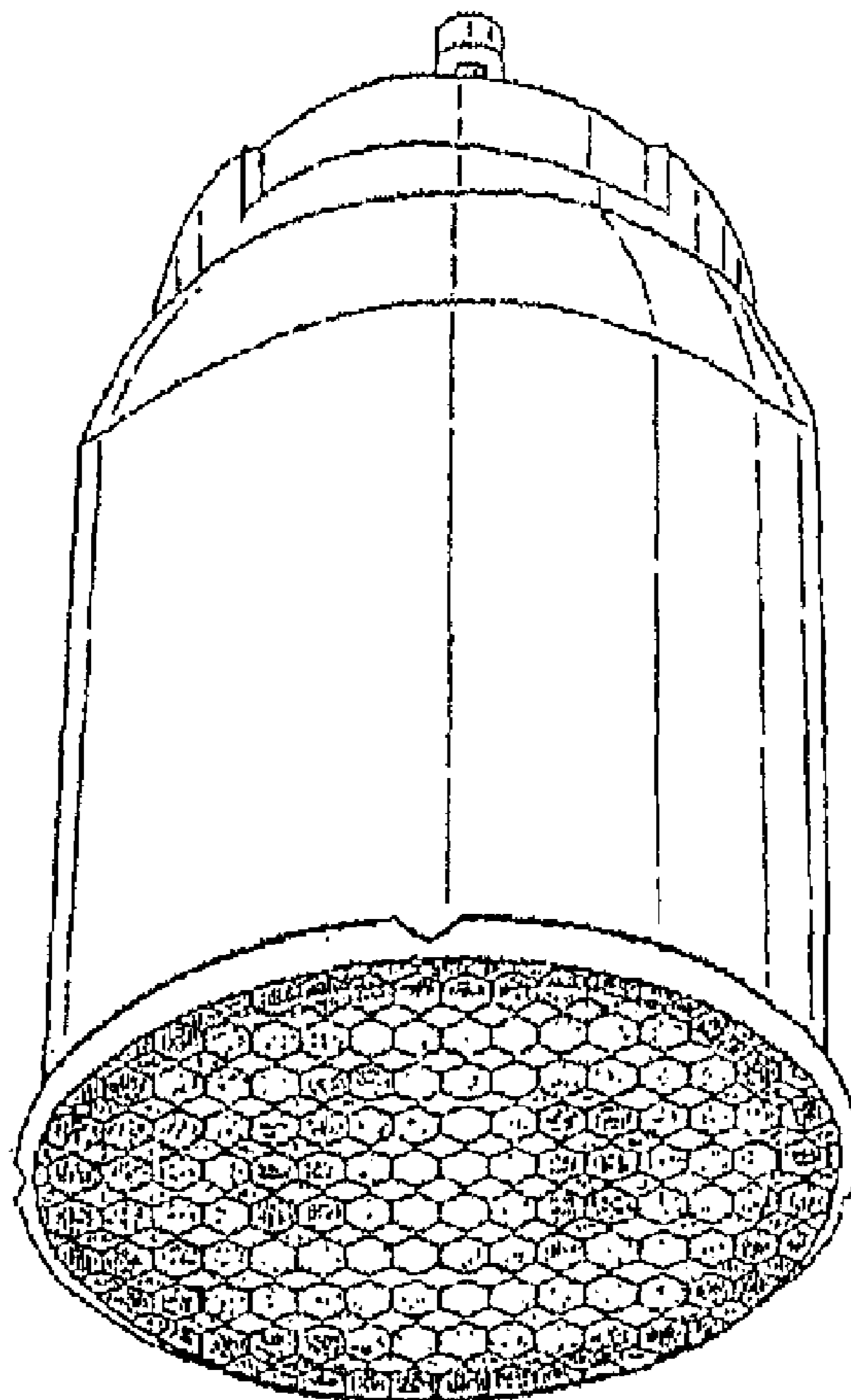
FIG. 2 is a side elevational view thereof;

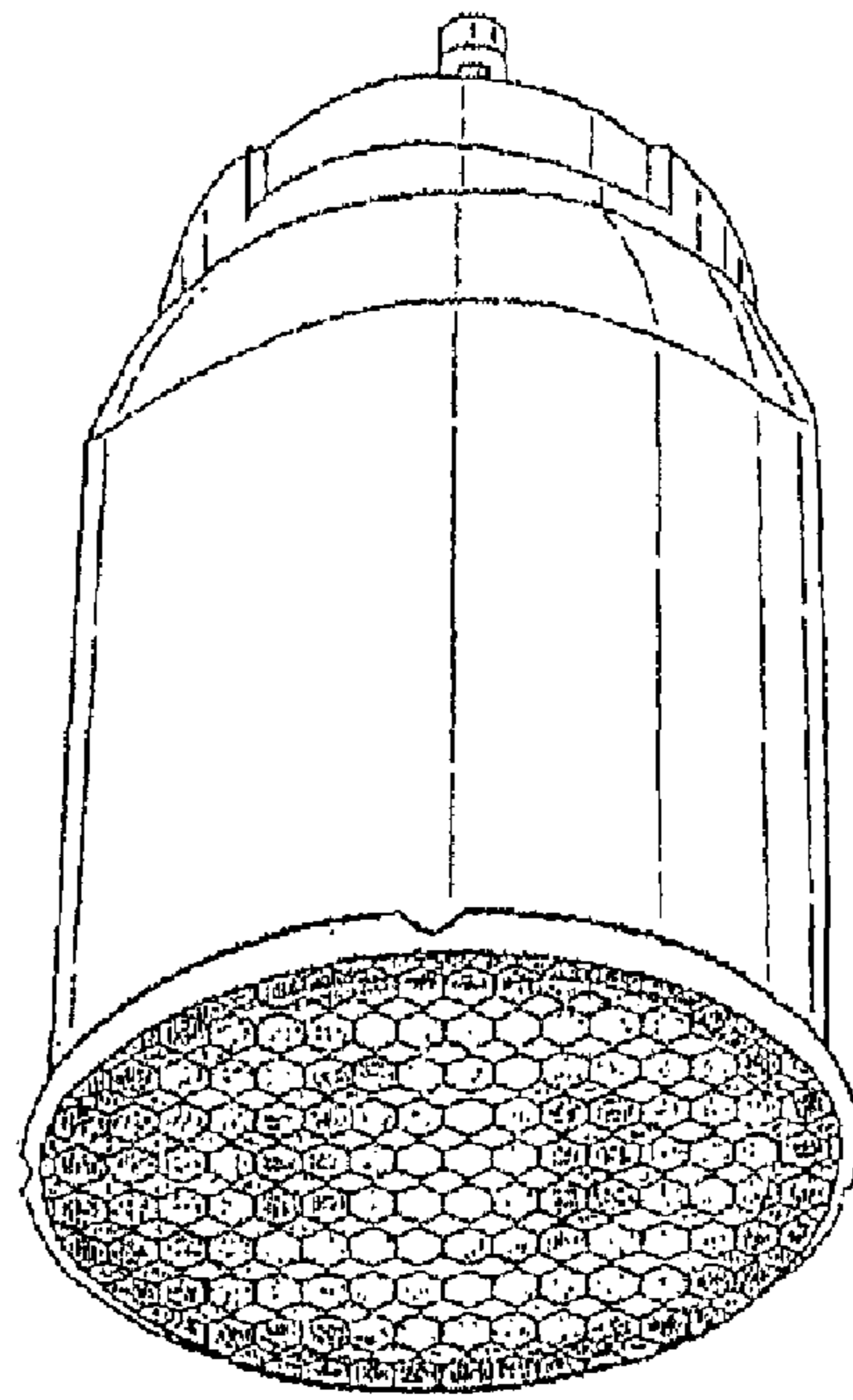

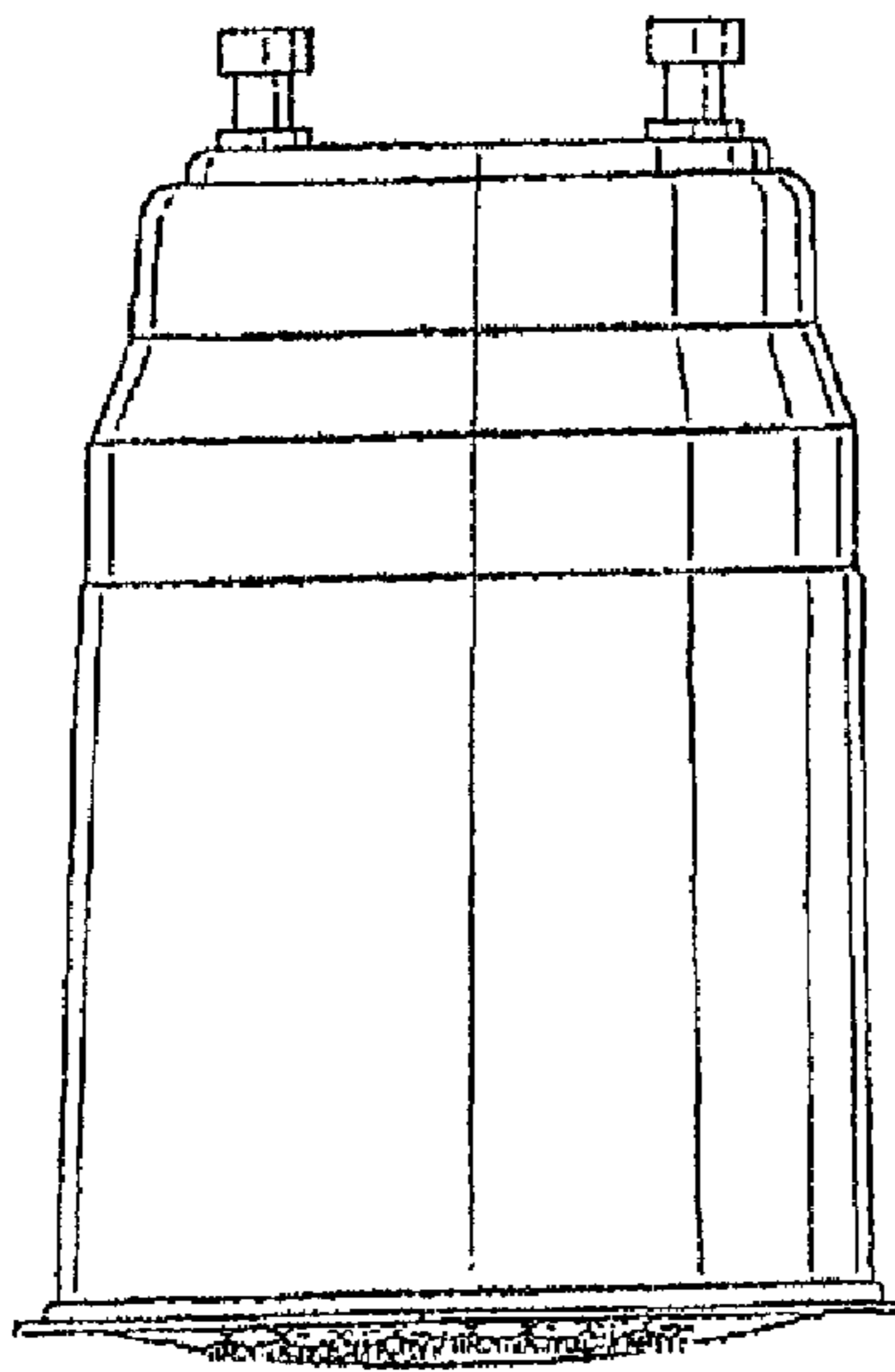

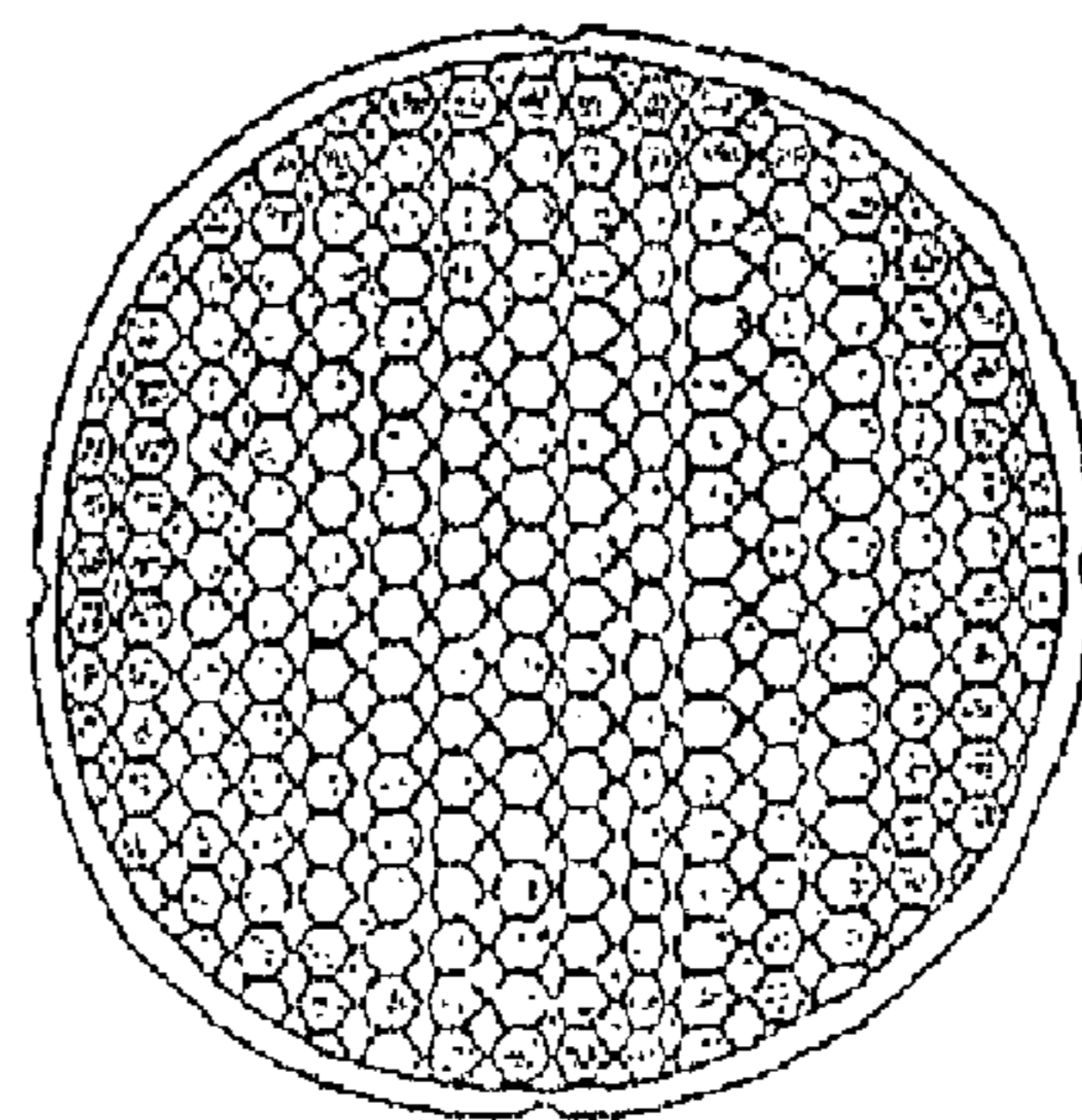

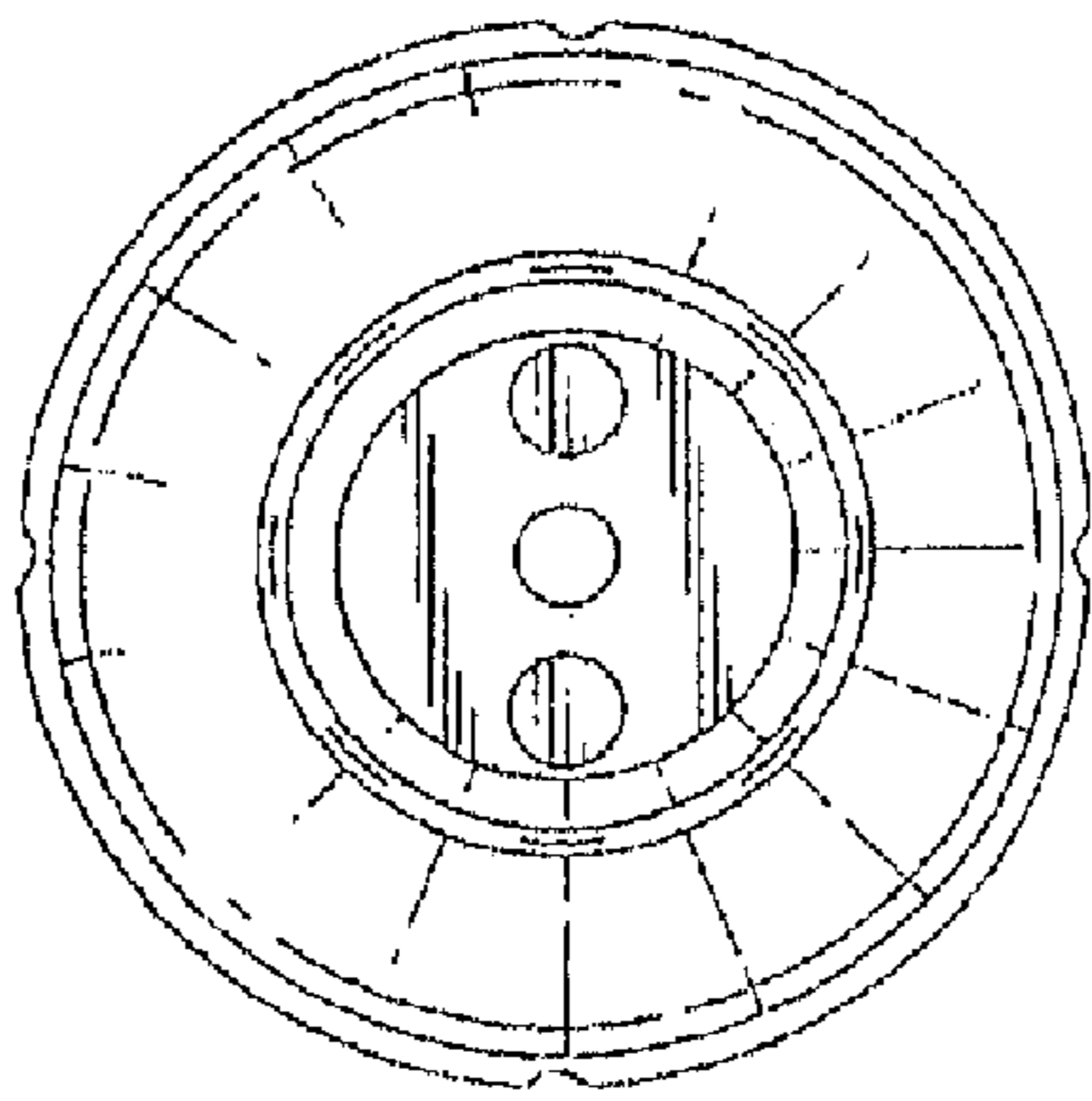
