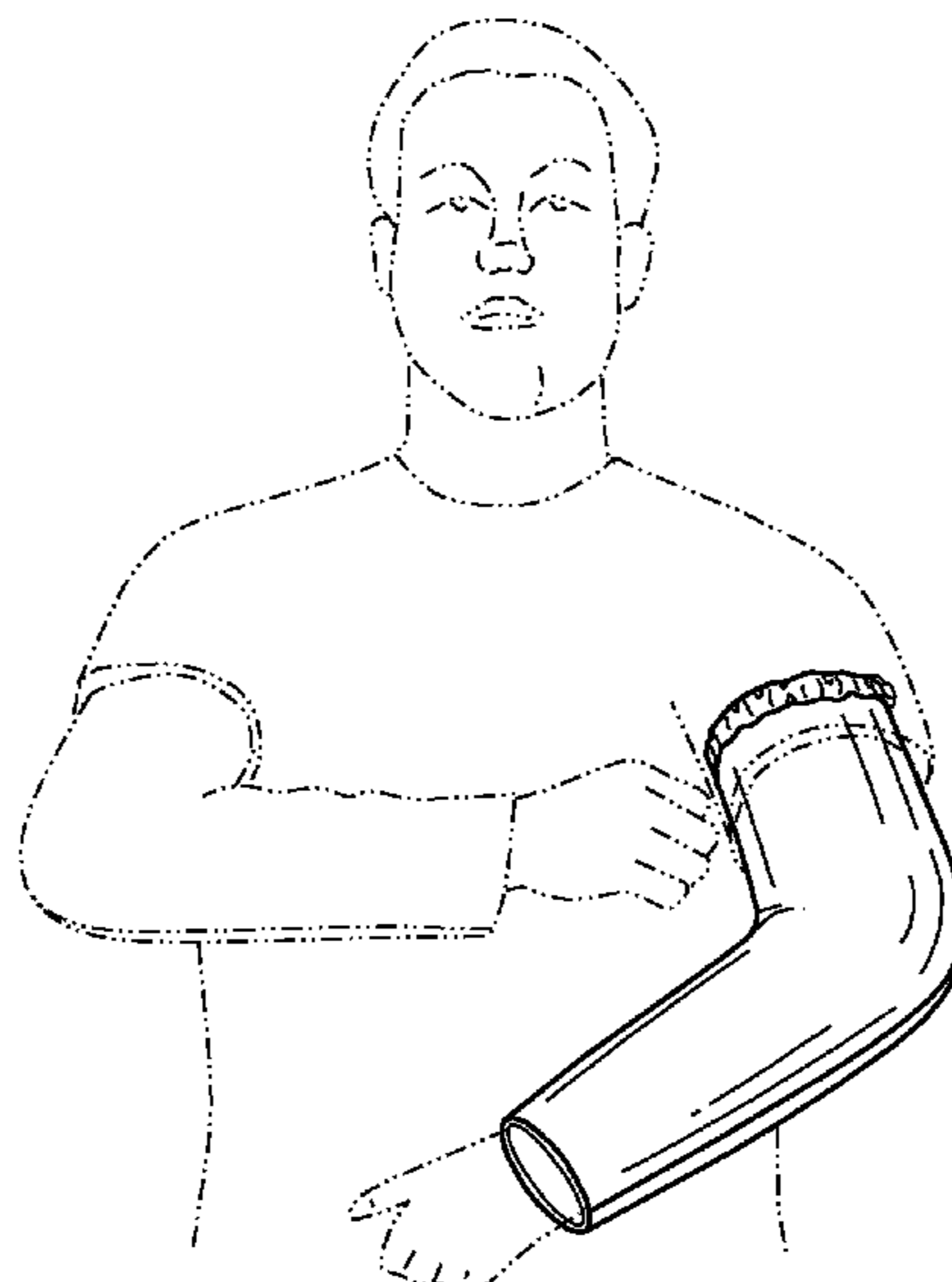
(57) **CLAIM**

What is claimed is the ornamental design for a protective sleeve for welders, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a protective sleeve for welders, showing the new design in a worn configuration; FIG. 2 is a left-side elevational view thereof in a straight configuration; FIG. 3 is a bottom plan view of FIG. 2; FIG. 4 is a top plan view of FIG. 2; FIG. 5 right-side elevational view of FIG. 2; FIG. 6 is a rear elevational view of FIG. 2; and FIG. 7 is a front elevational view of FIG. 2. The broken lines showing a person in FIG. 1 are included for the purpose of illustrating the invention in use, and form no part of the claimed design.

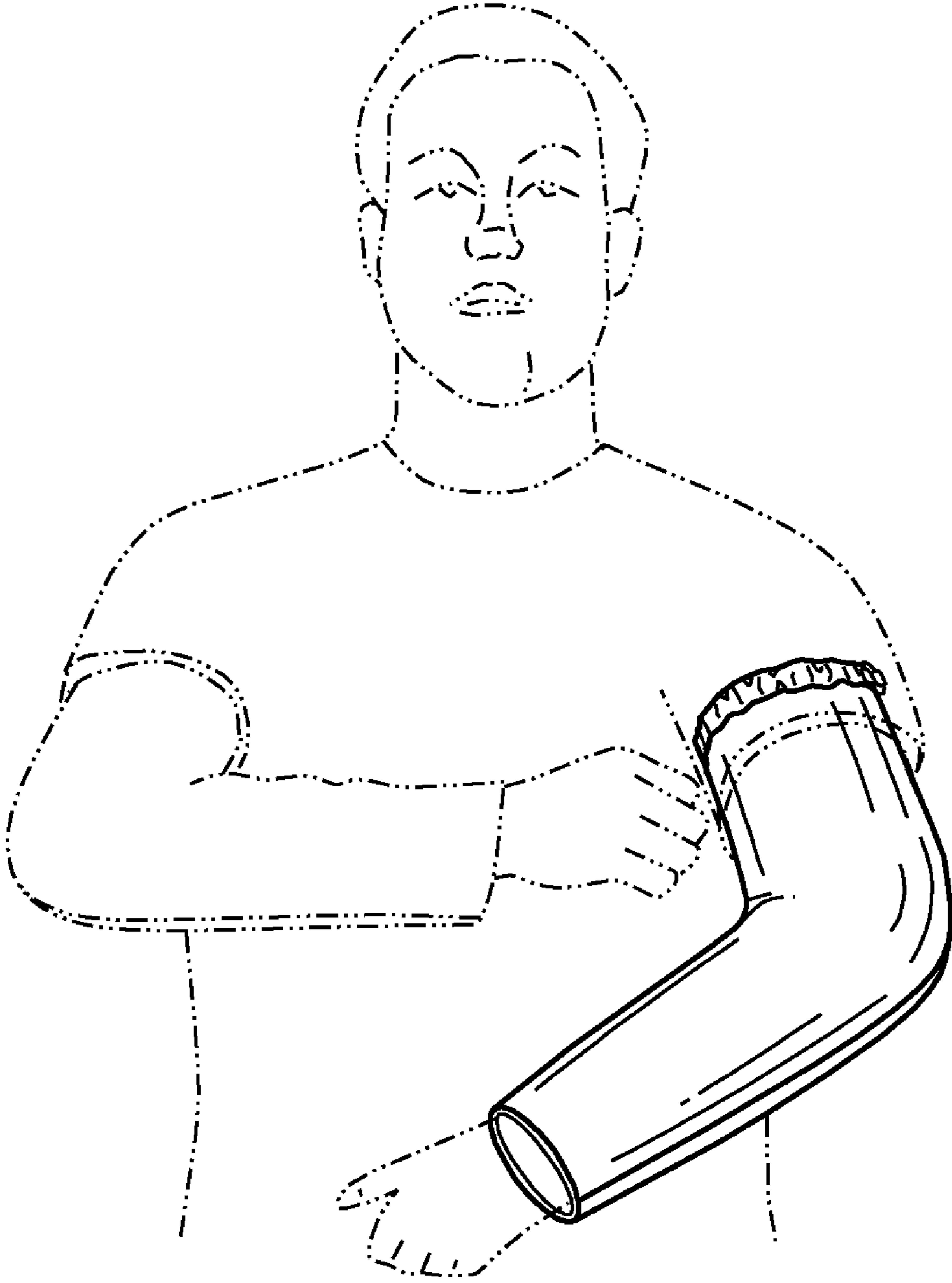

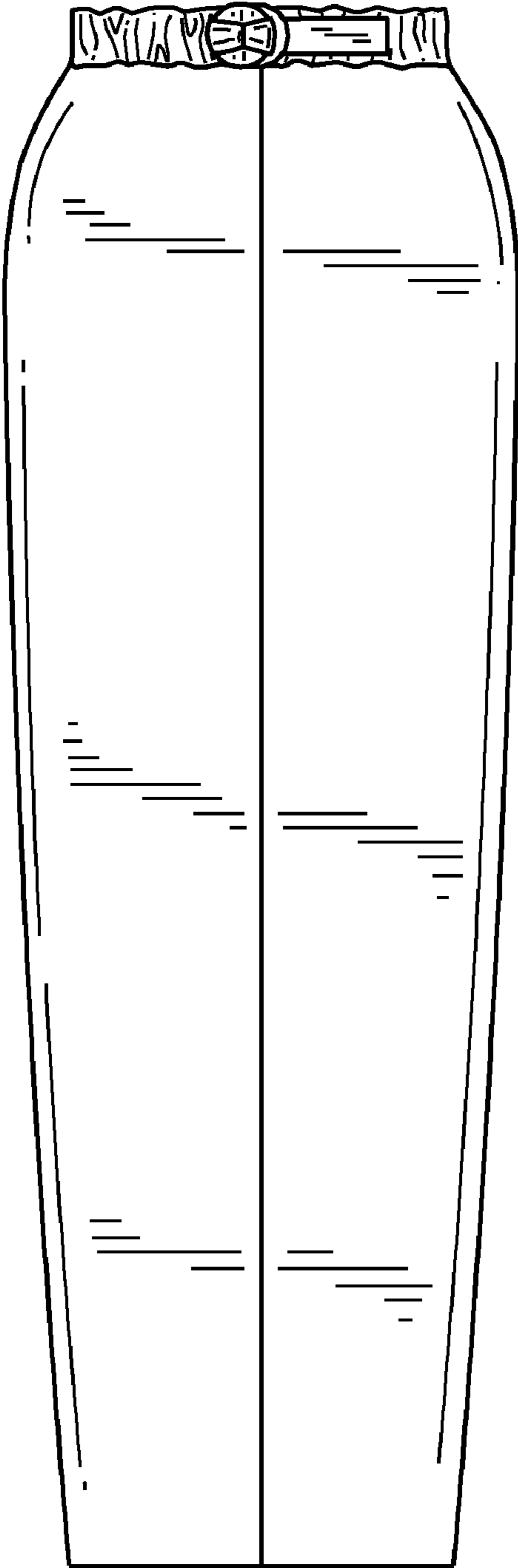

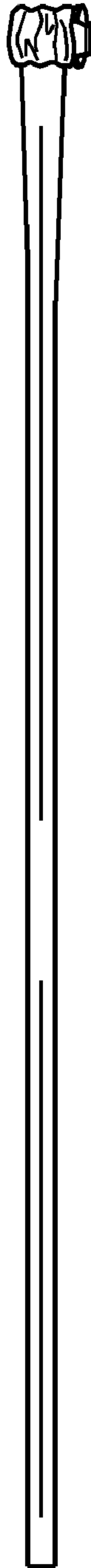

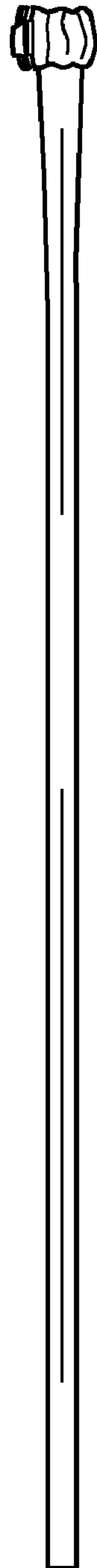

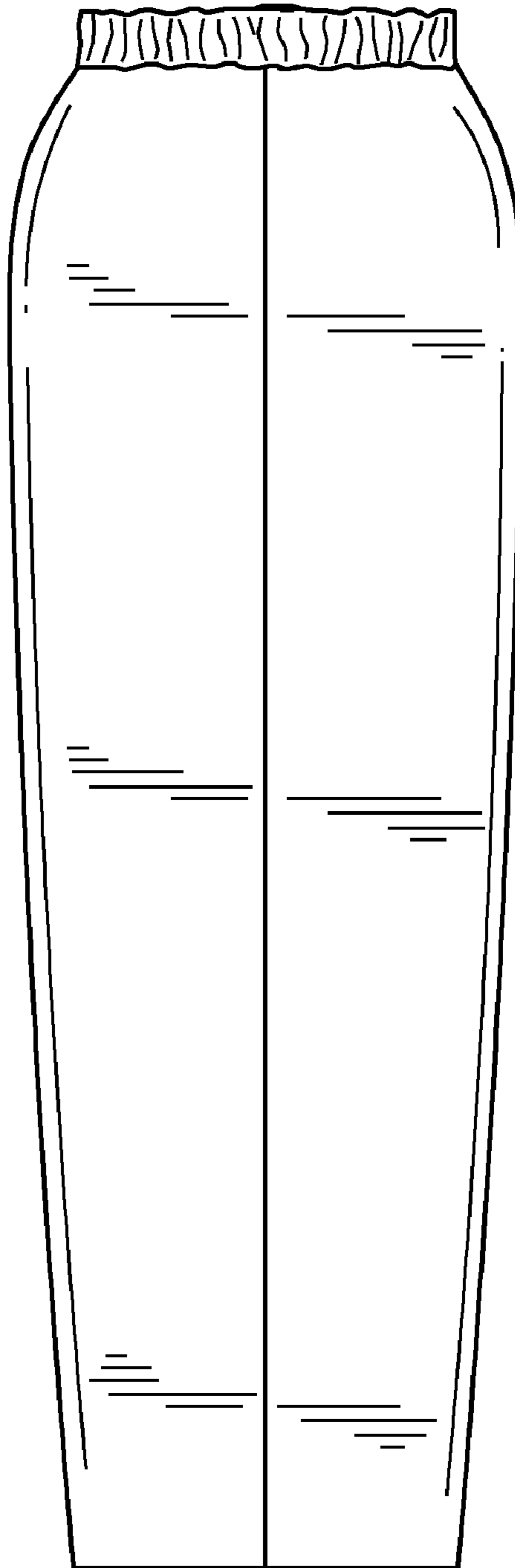

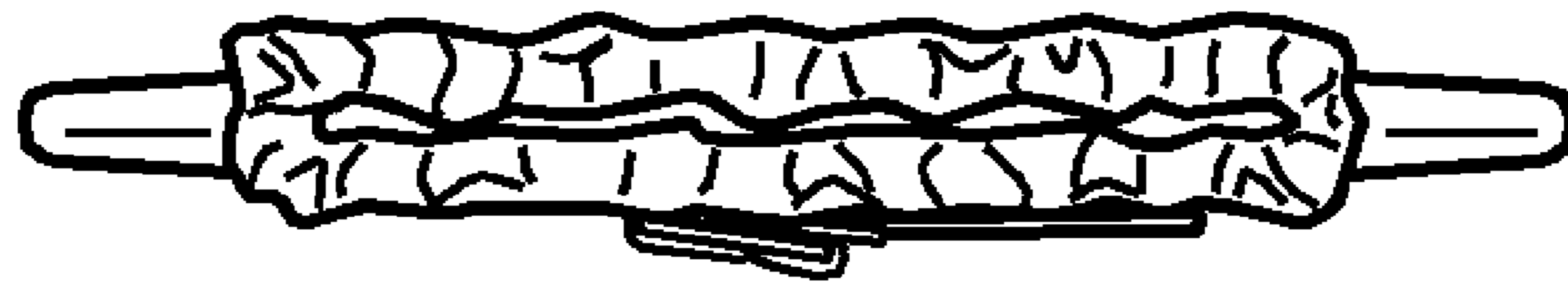
