(57) **CLAIM**

The ornamental design for a shroud for nursing an infant, as shown and described.

DESCRIPTION

FIG. 1 is a front, right-side perspective view of a shroud for nursing an infant, showing a pillow in broken lines, showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a left-side elevational view thereof;

FIG. 5 is a rear elevational view thereof;

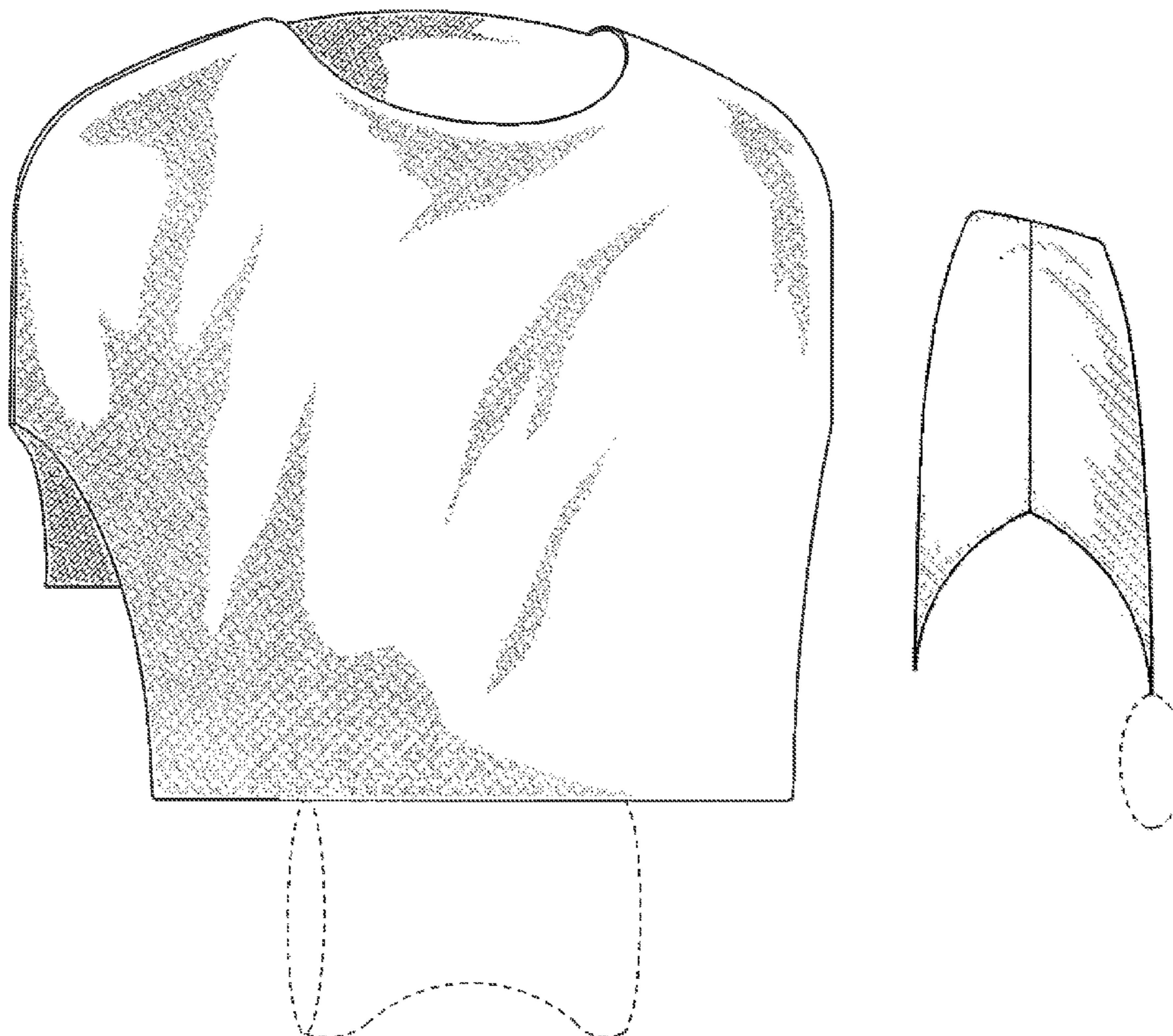
FIG. 6 is a right side elevational view thereof;

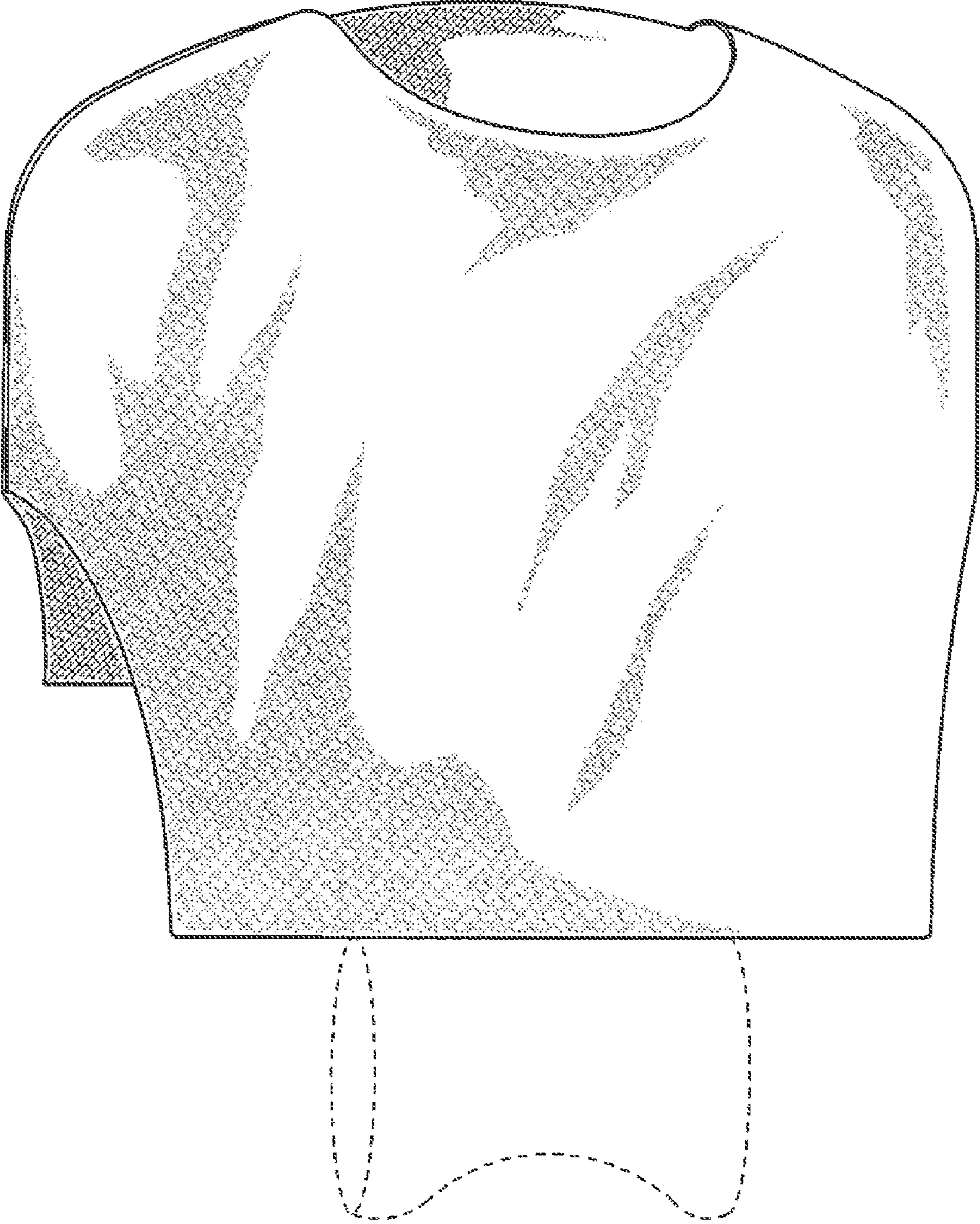

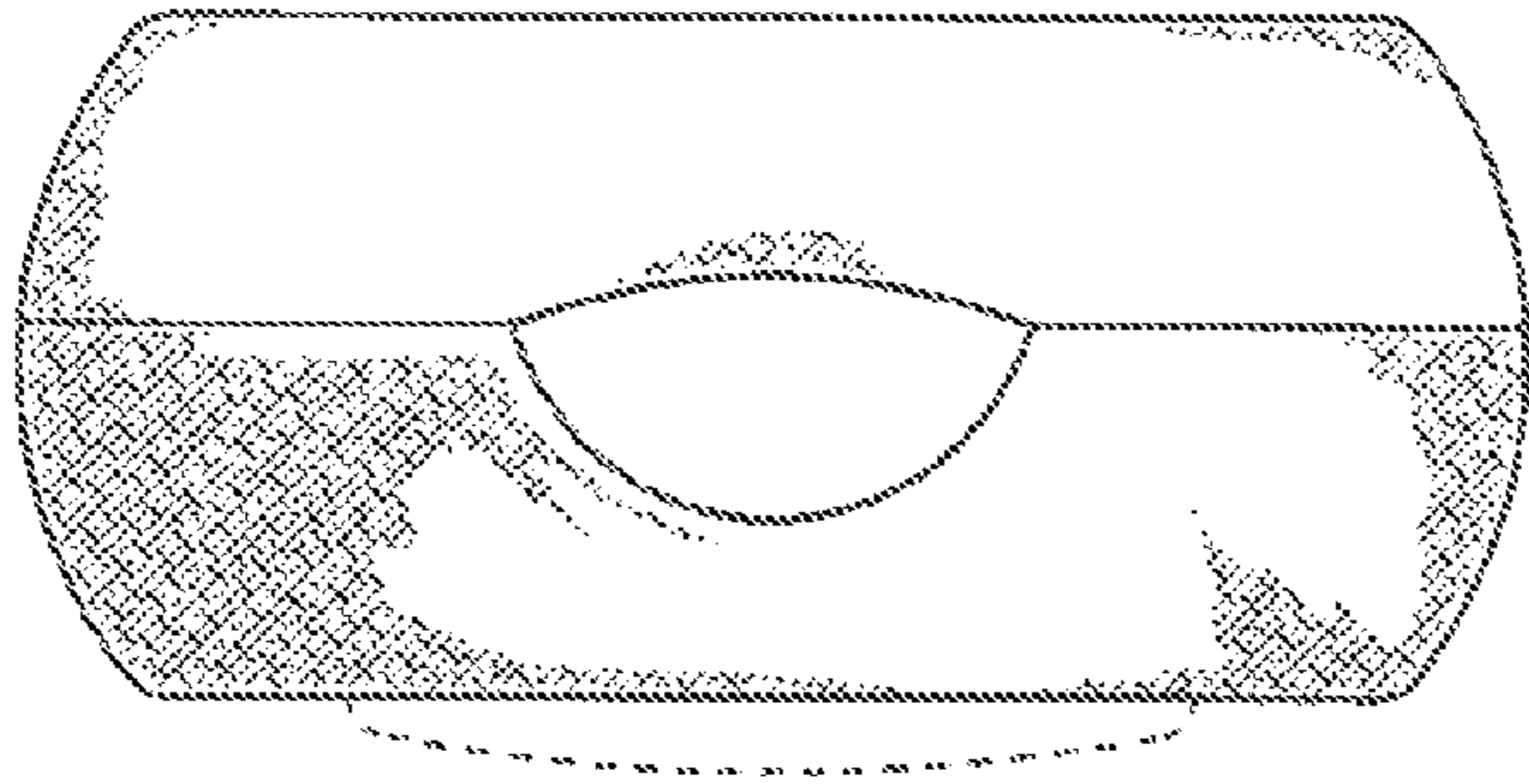

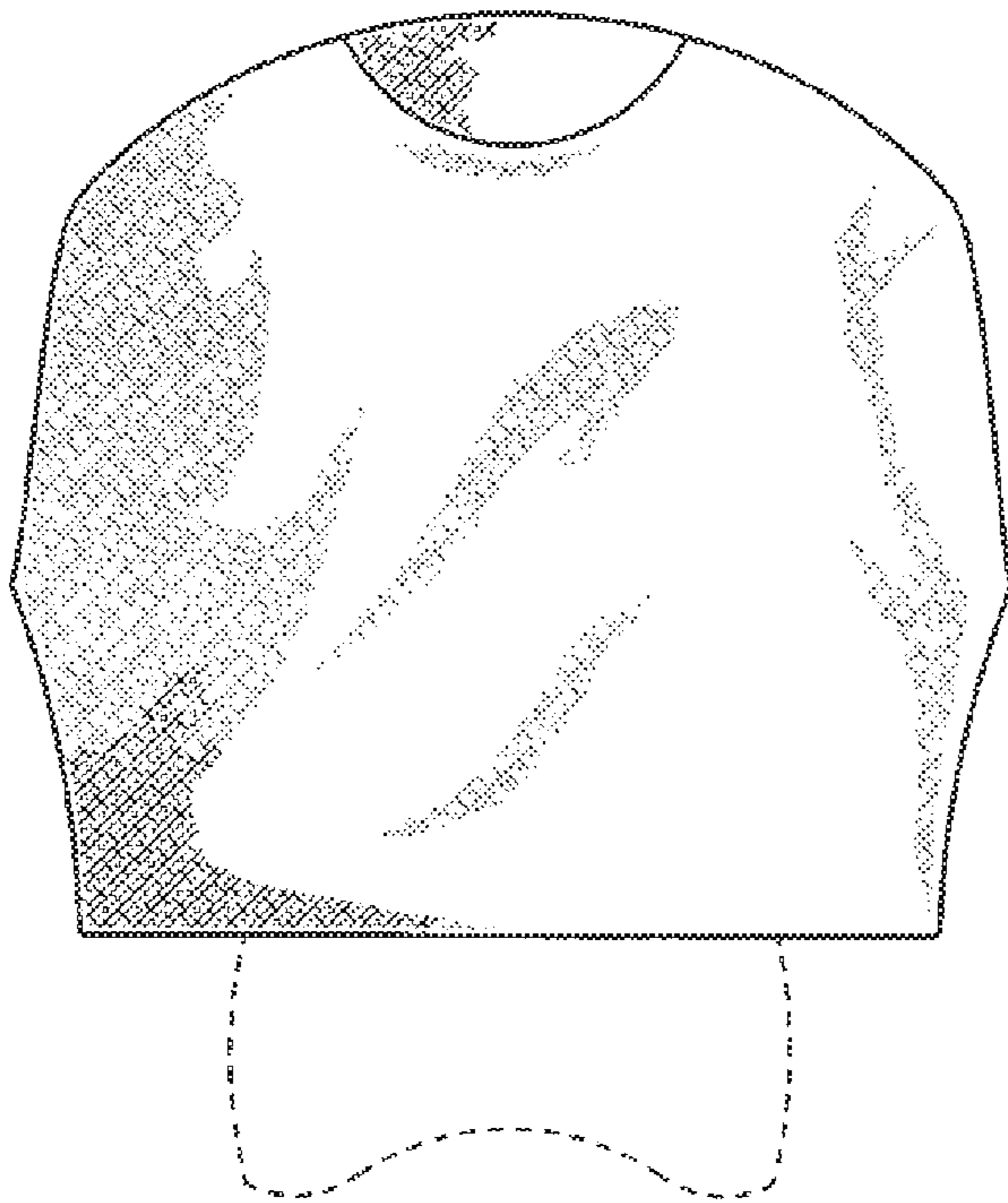

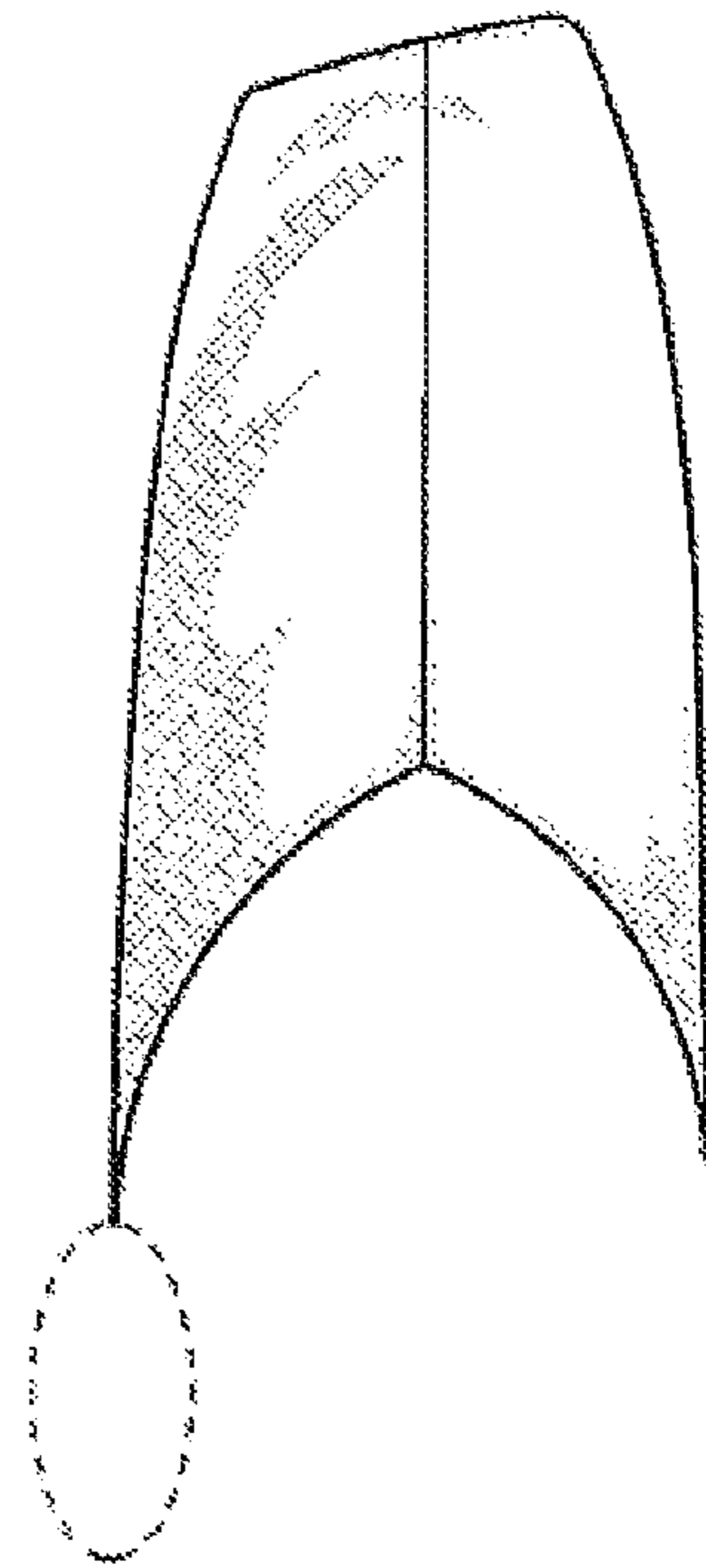

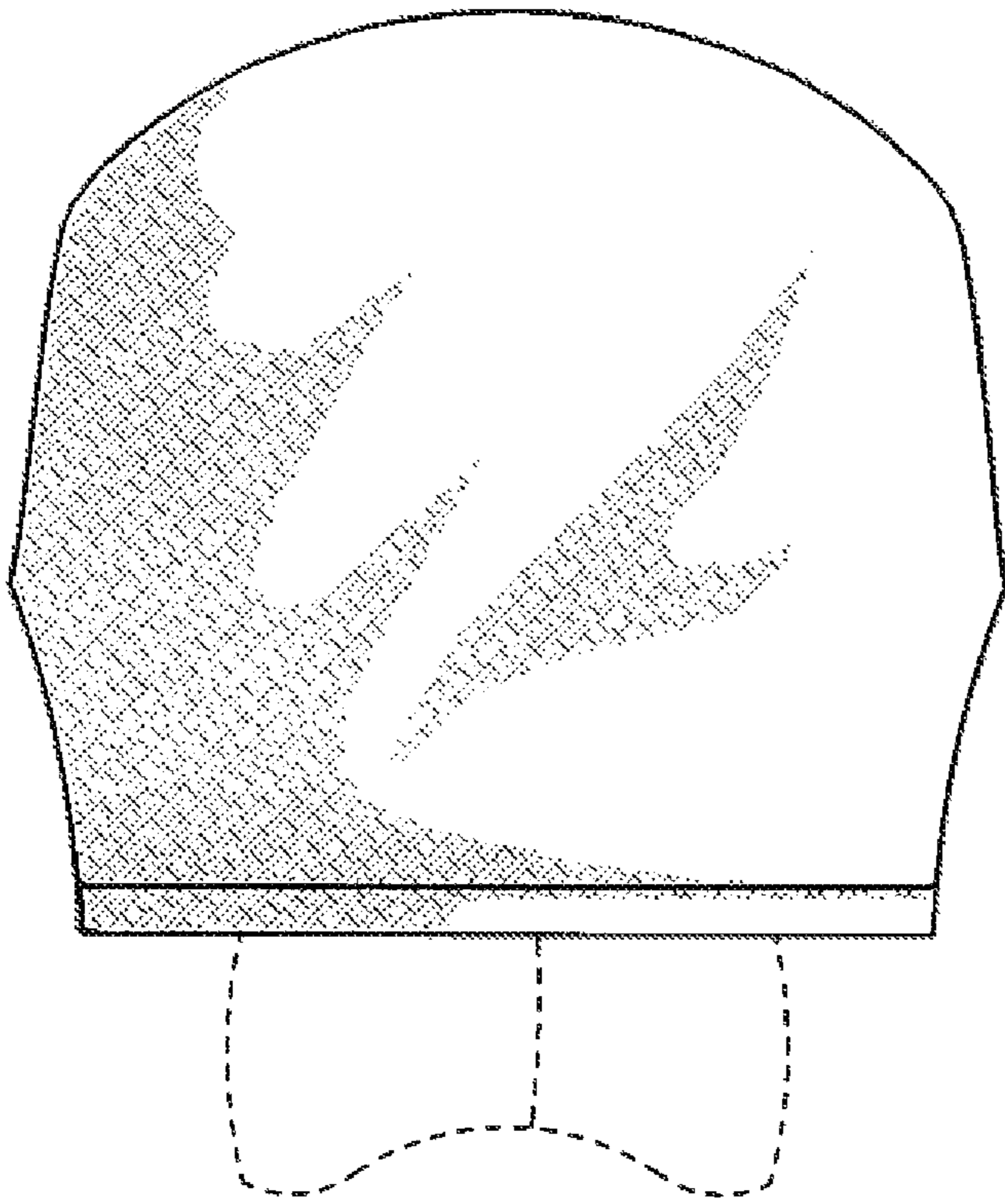

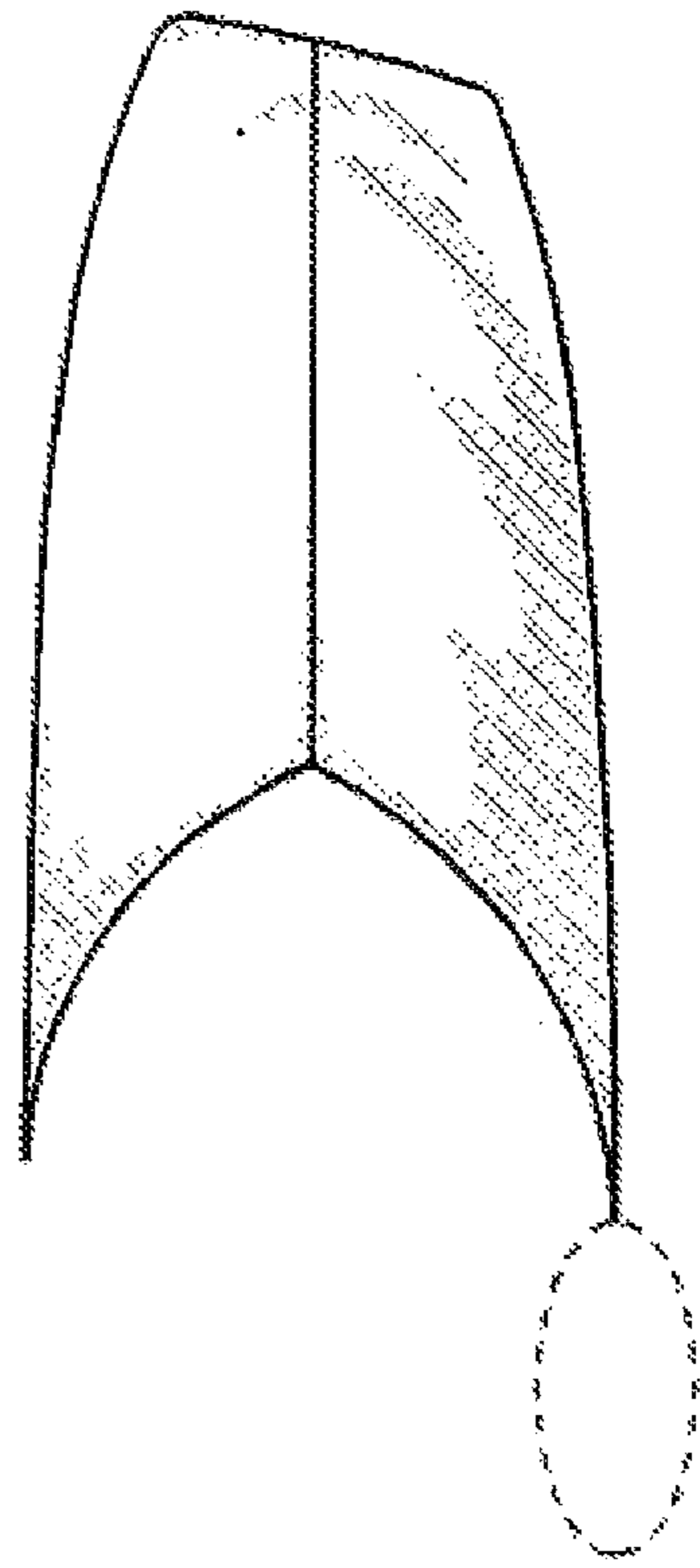

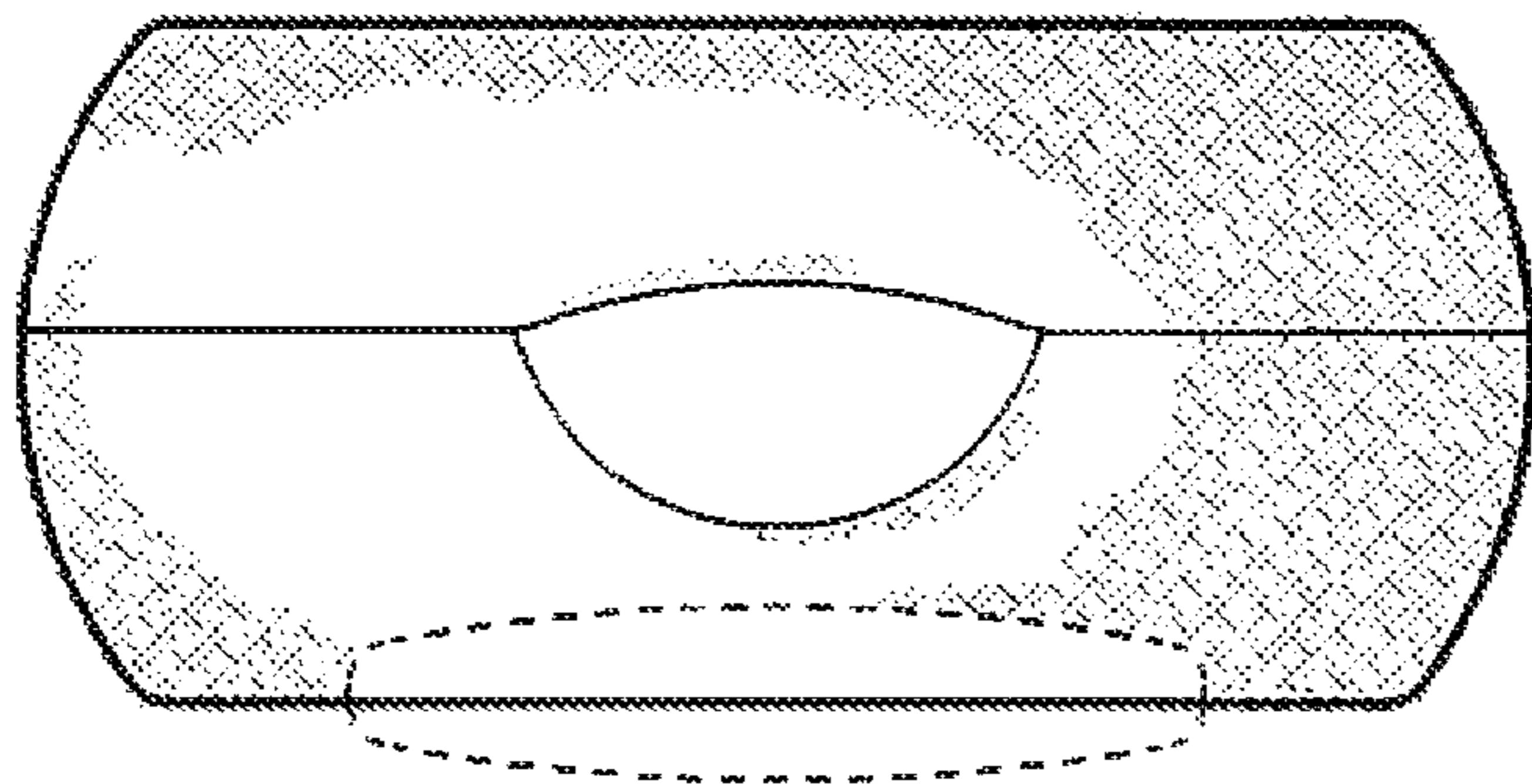
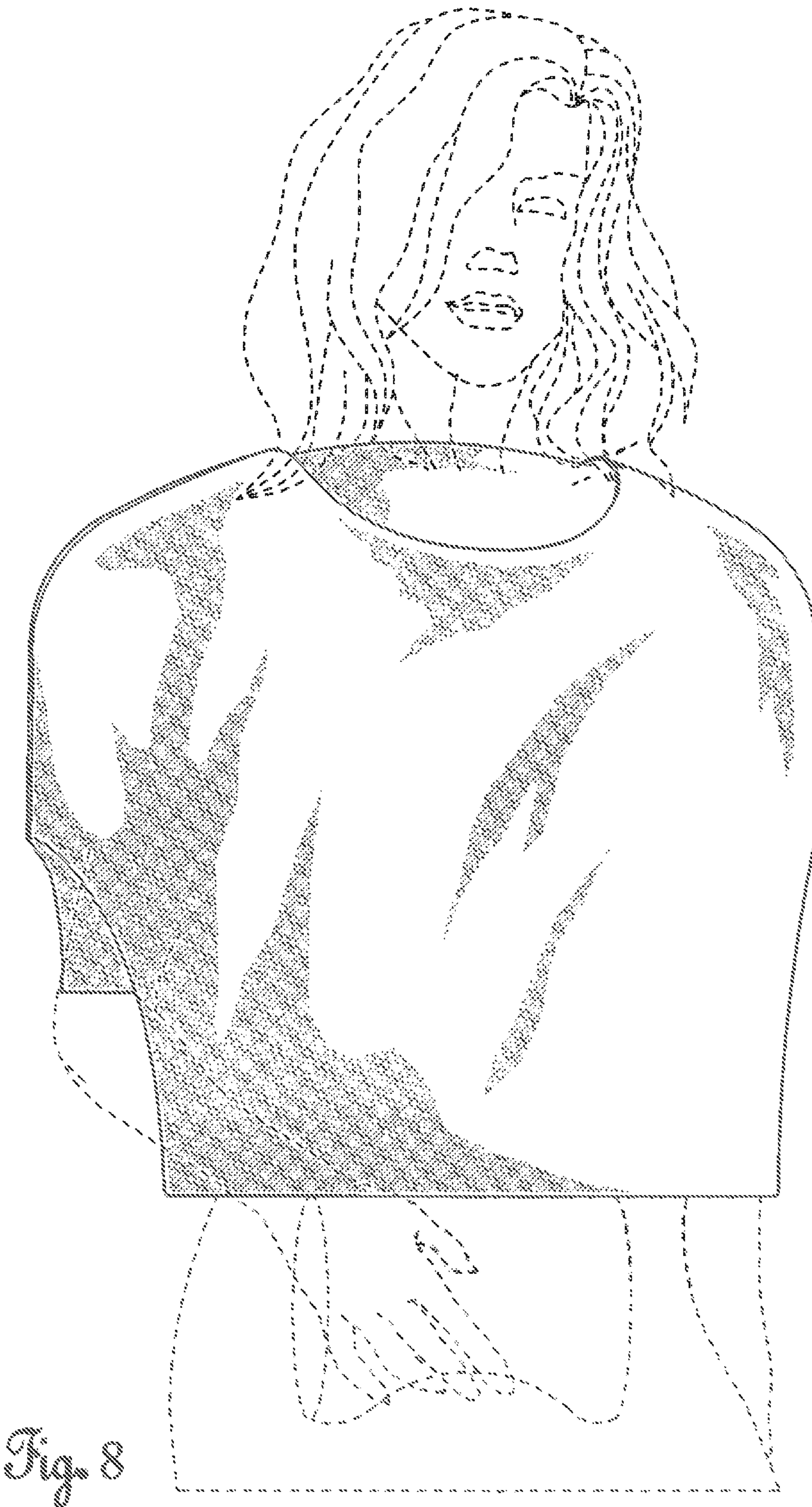
