DESCRIPTION

FIG. 1 is a perspective view of the outlet;
FIG. 2 is a front view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a rear view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a sectional view thereof at cross-section 7—7 of
FIG. 2 with interior components shown in broken lines; and,
FIG. 8 is a perspective view thereof, that shows a lid being
opened.

The portions of the article in broken lines are shown for
illustrative purposes only and form no part of the claimed
design.

A left side view of the outlet is a mirror image of the right side
view, and therefore omitted.

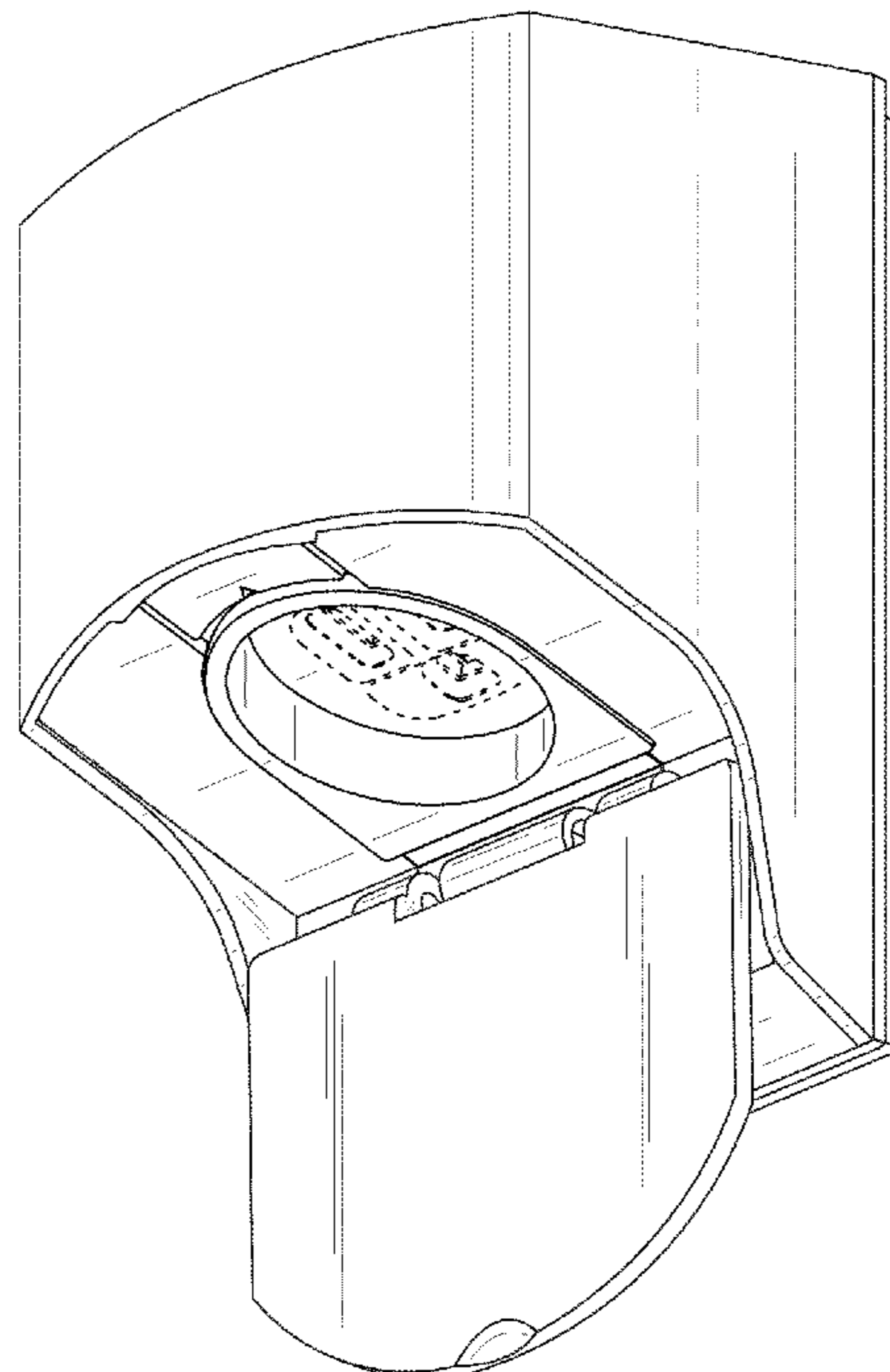
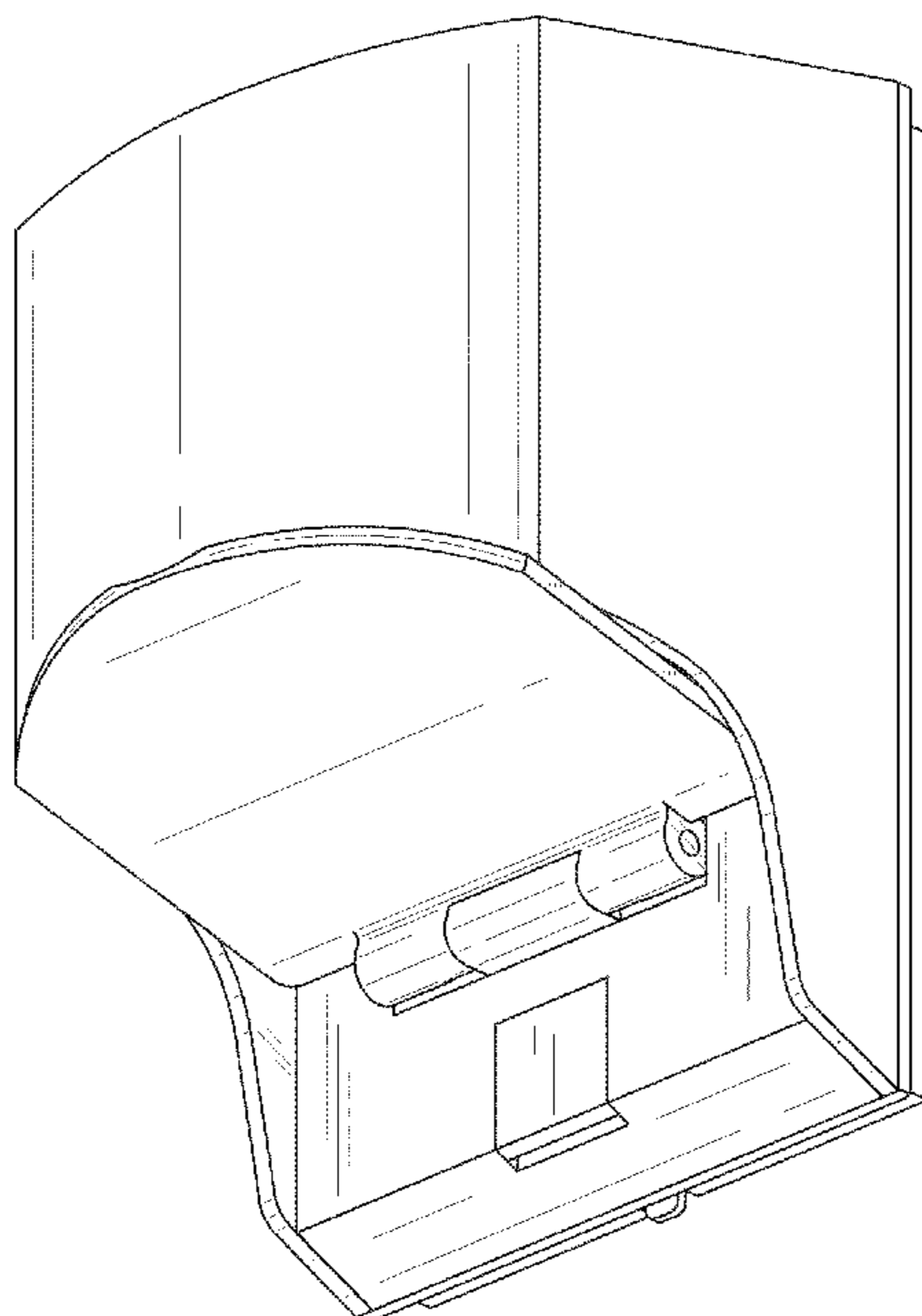

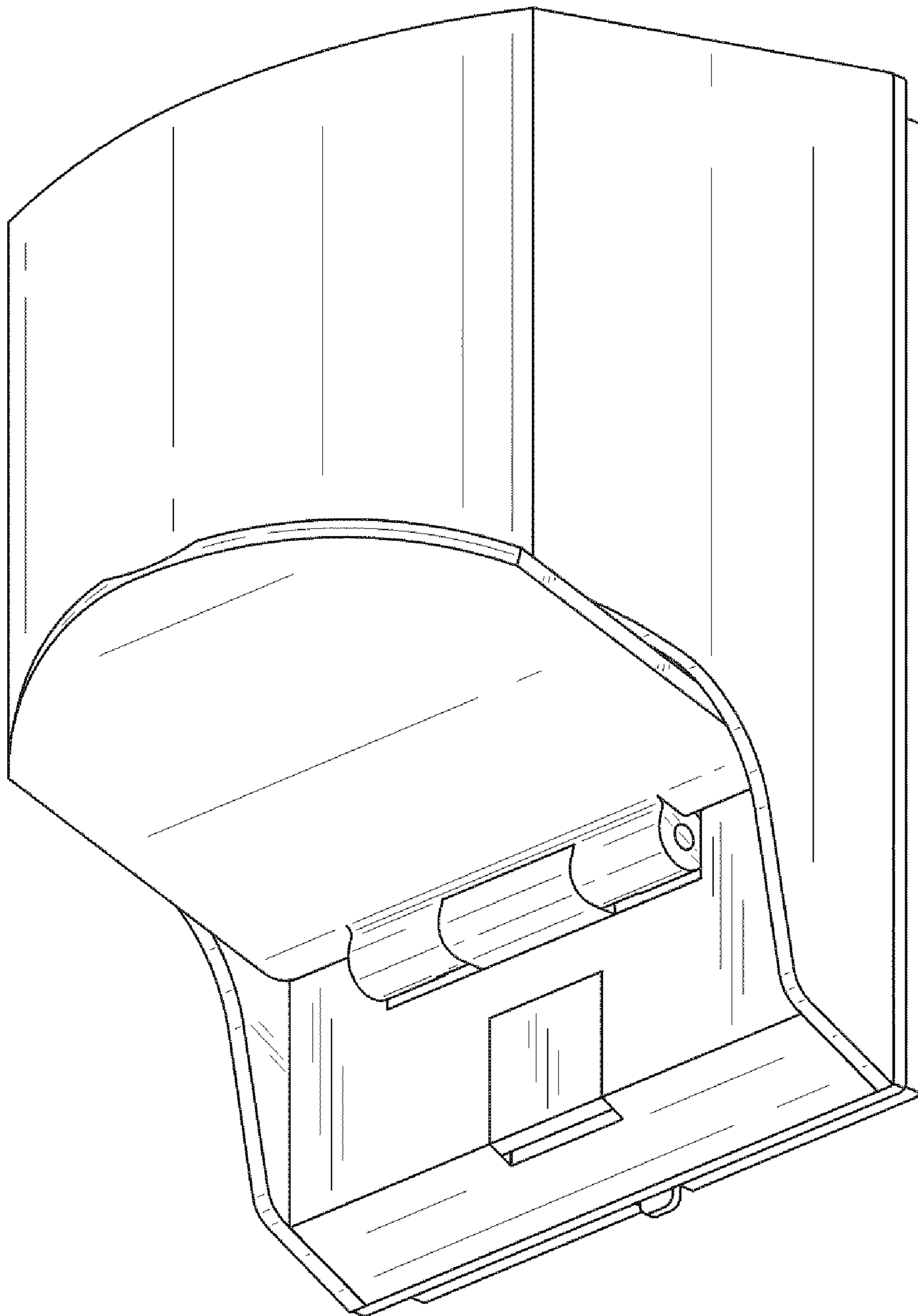
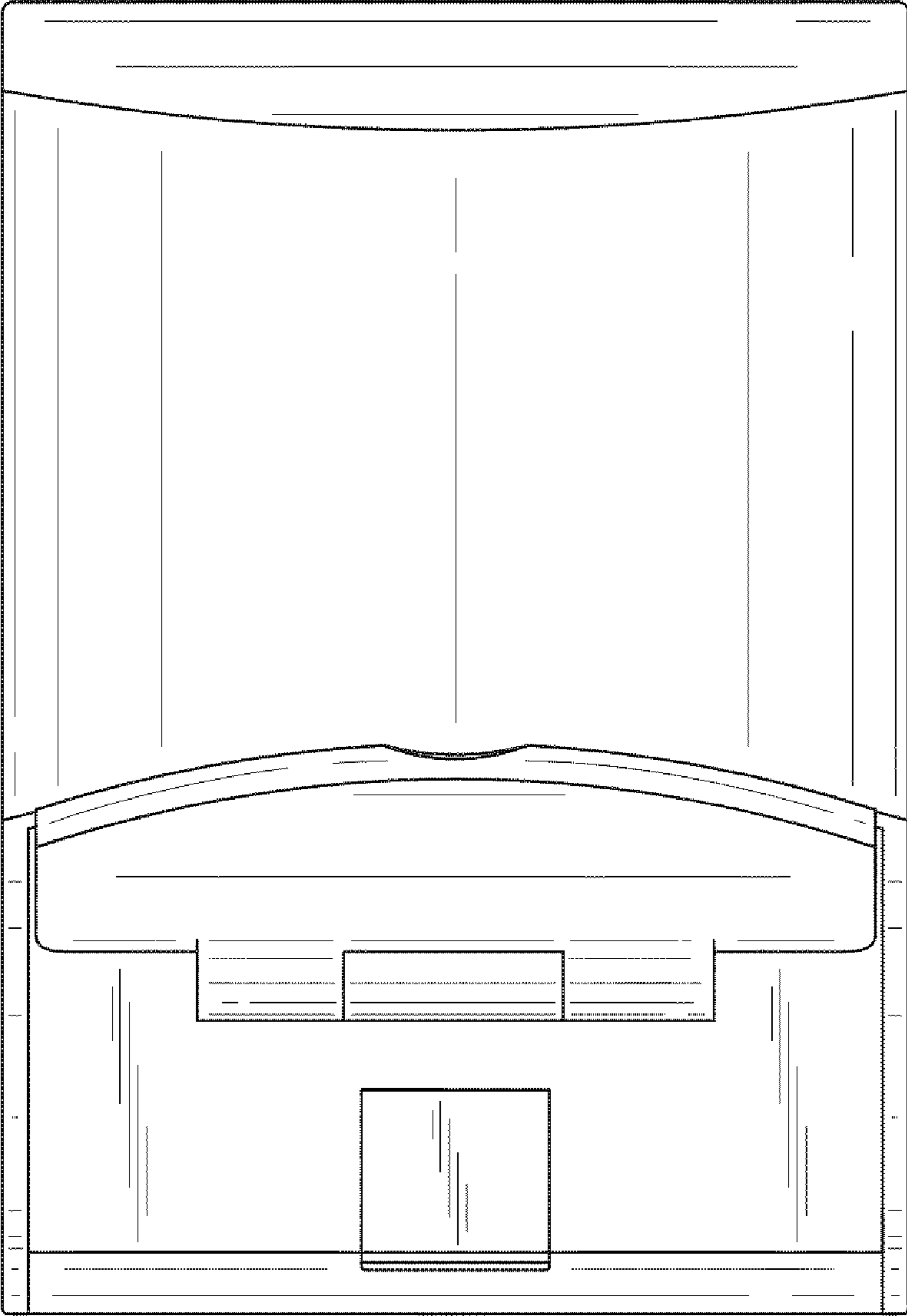

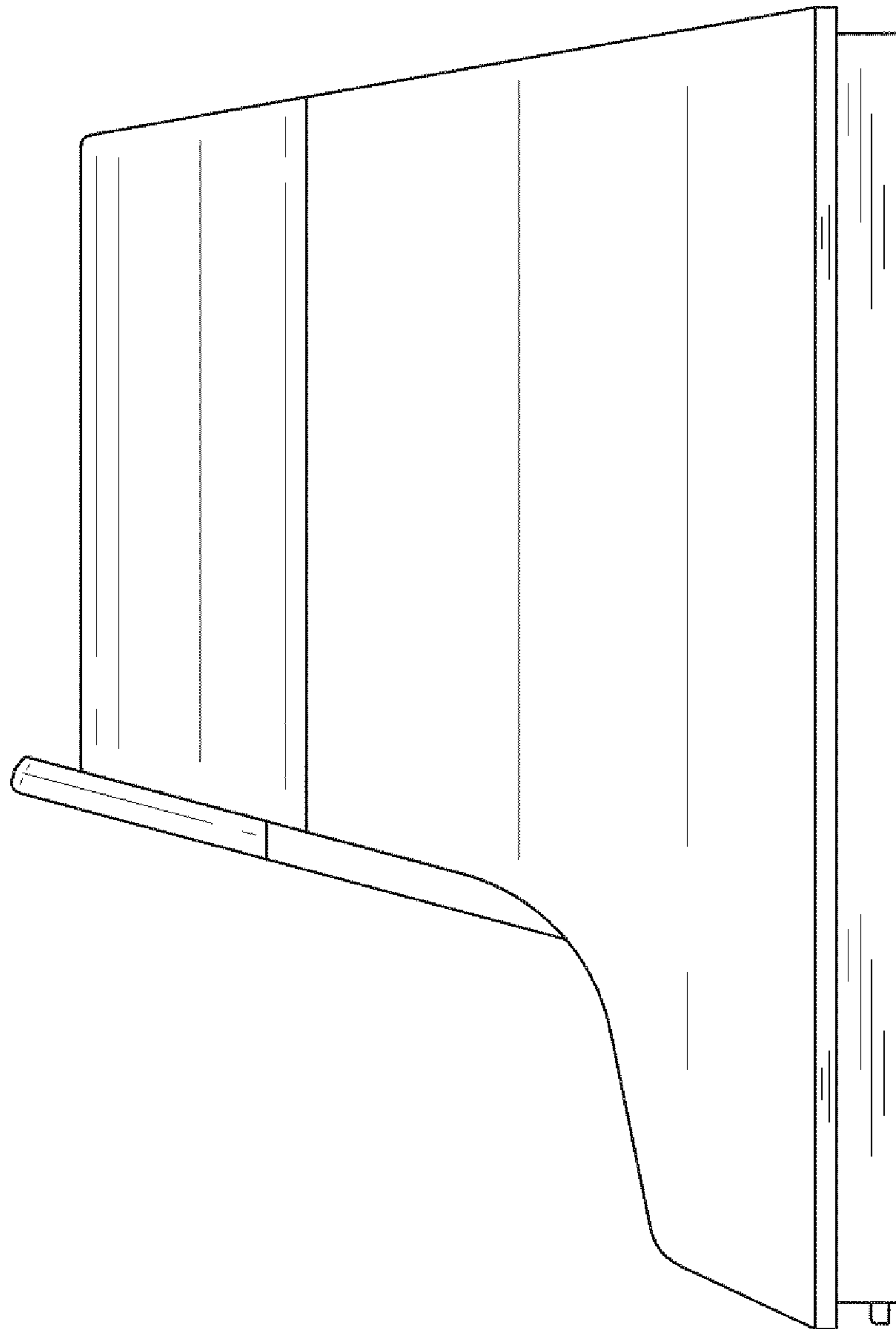

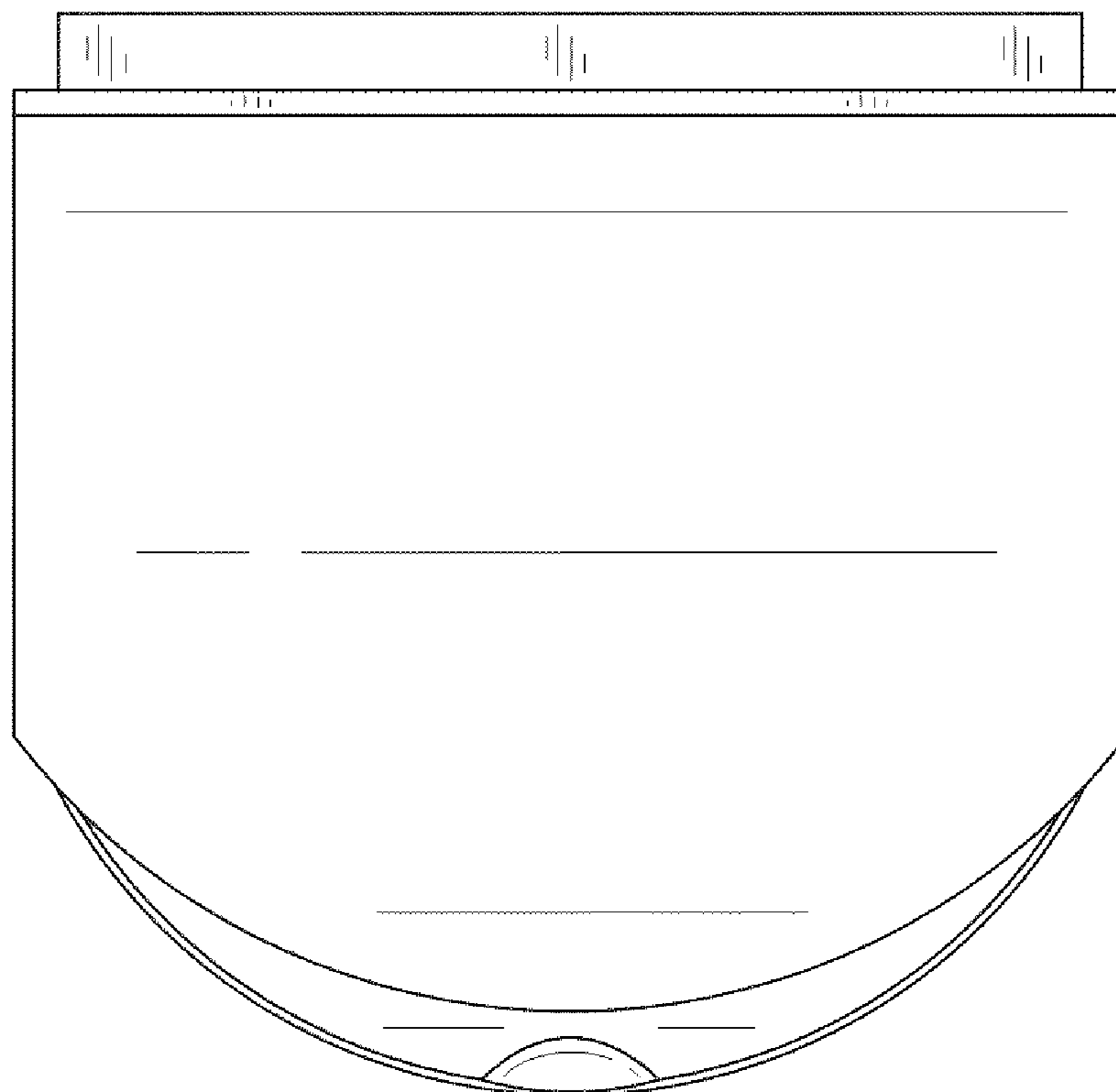

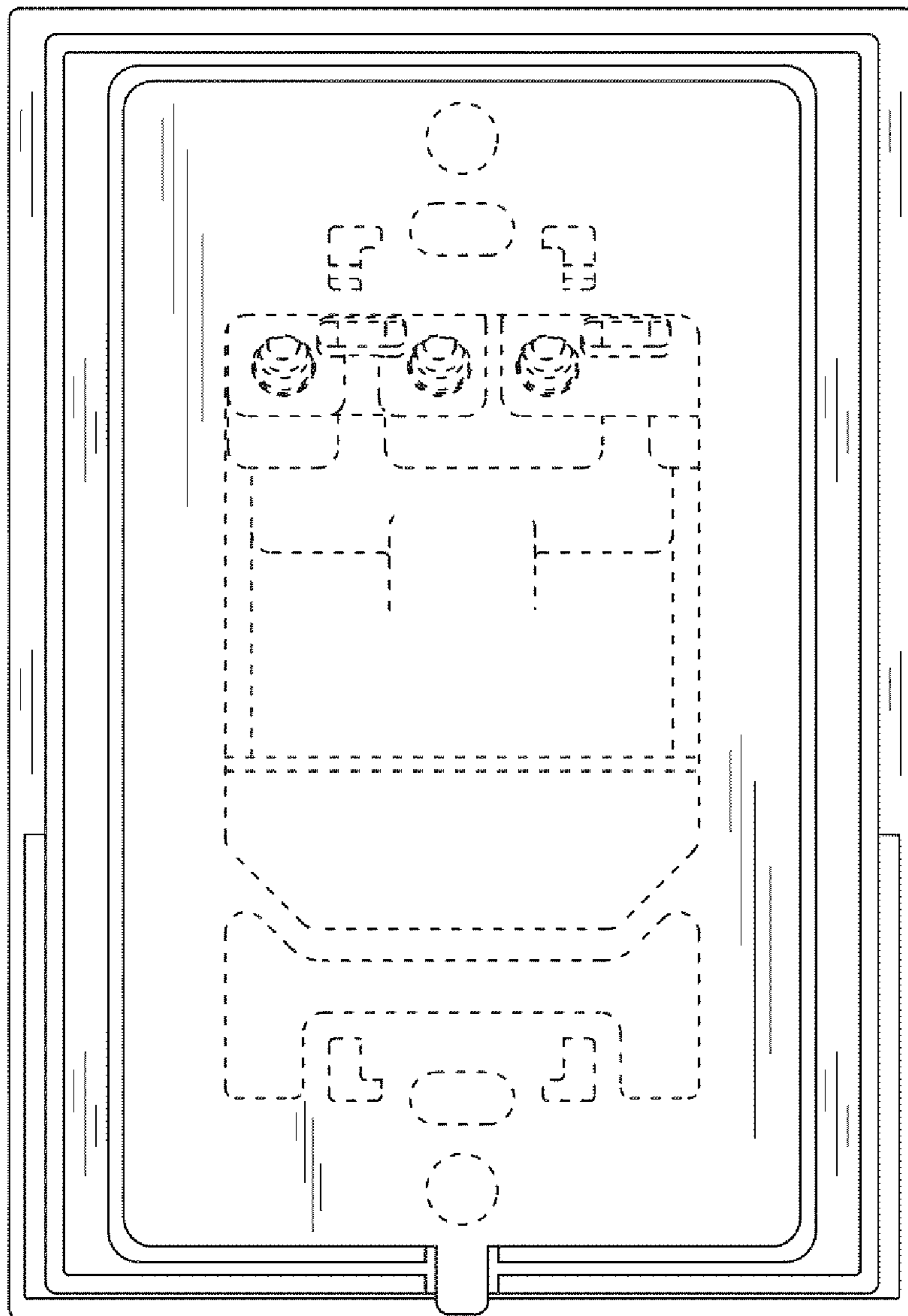

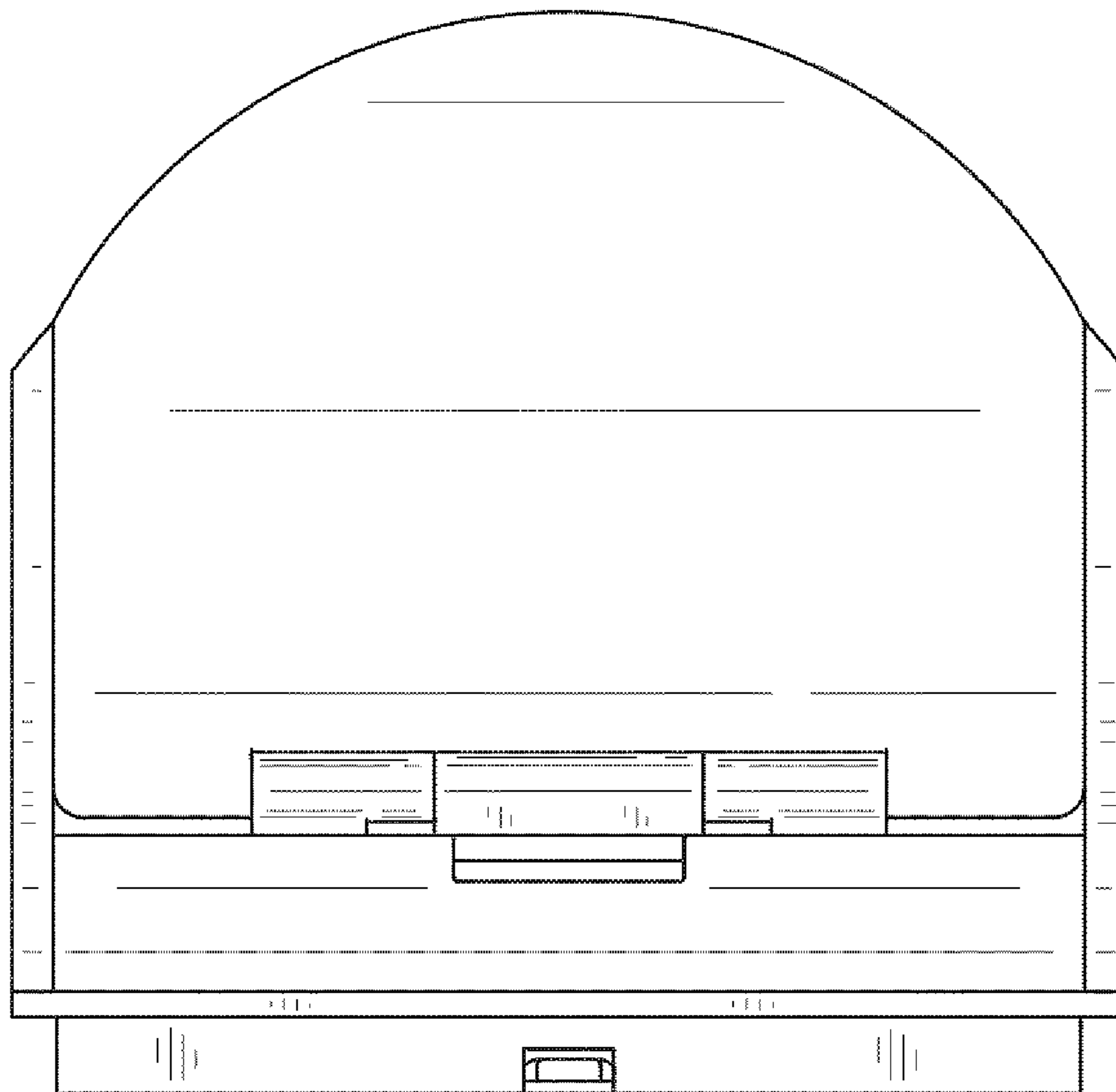

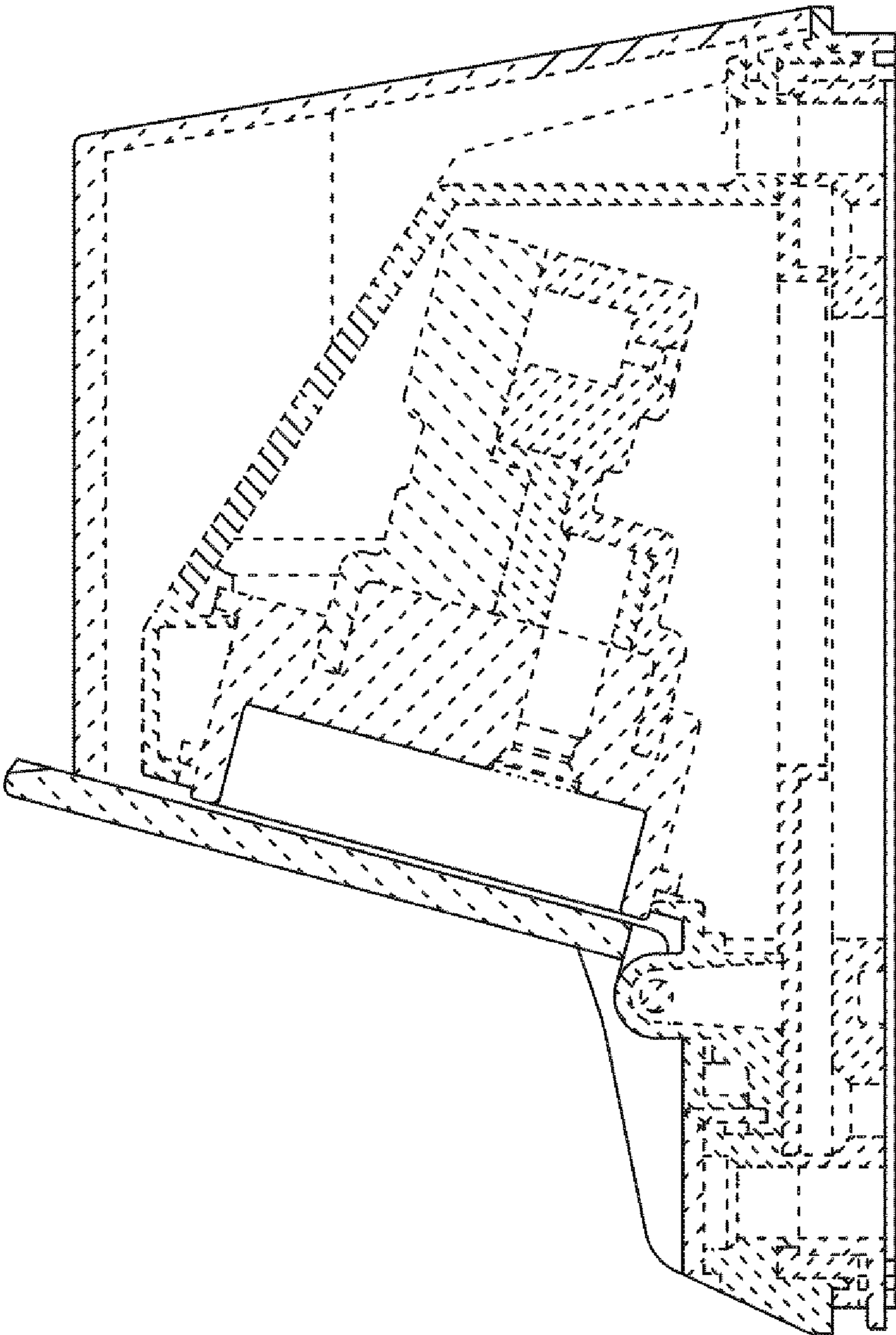
