FIG. 1 is a front elevation view of a control panel in accordance with my new design;

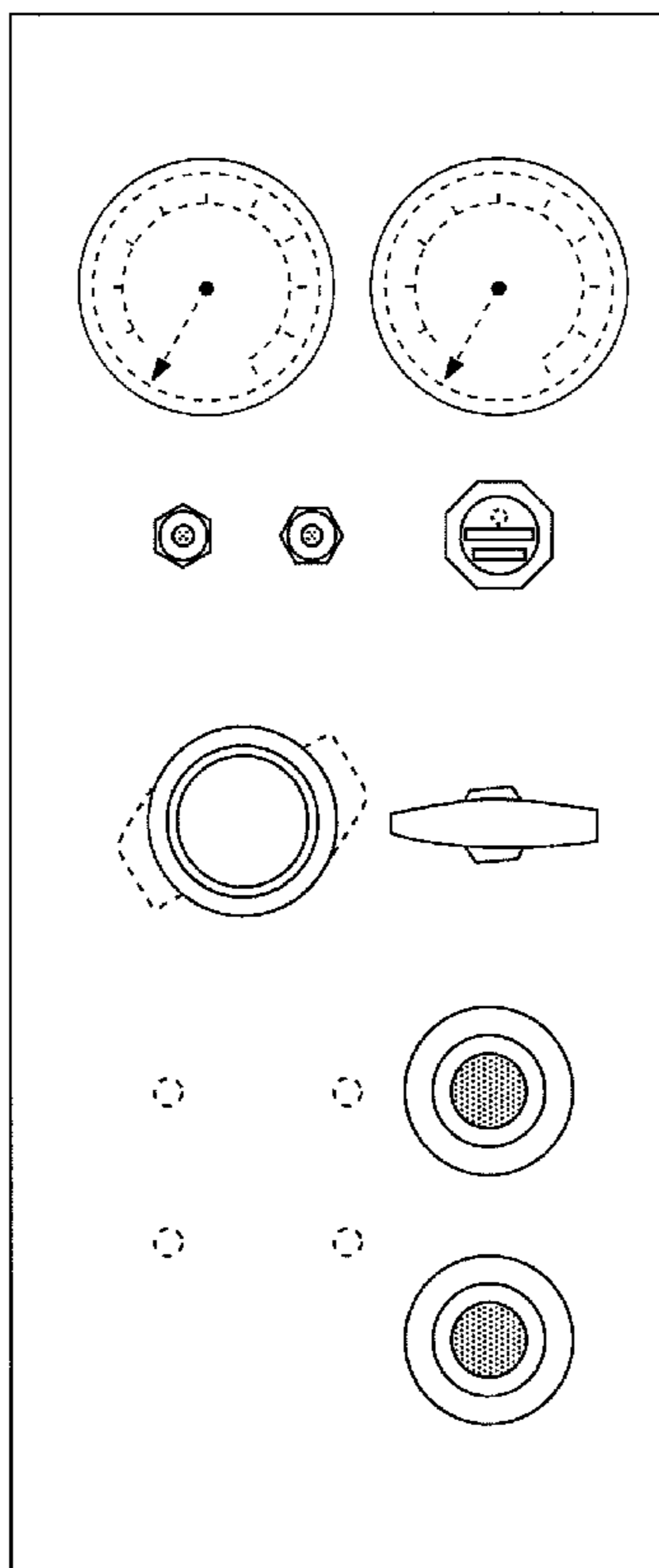
FIG. 2 is a left, side elevation view thereof;

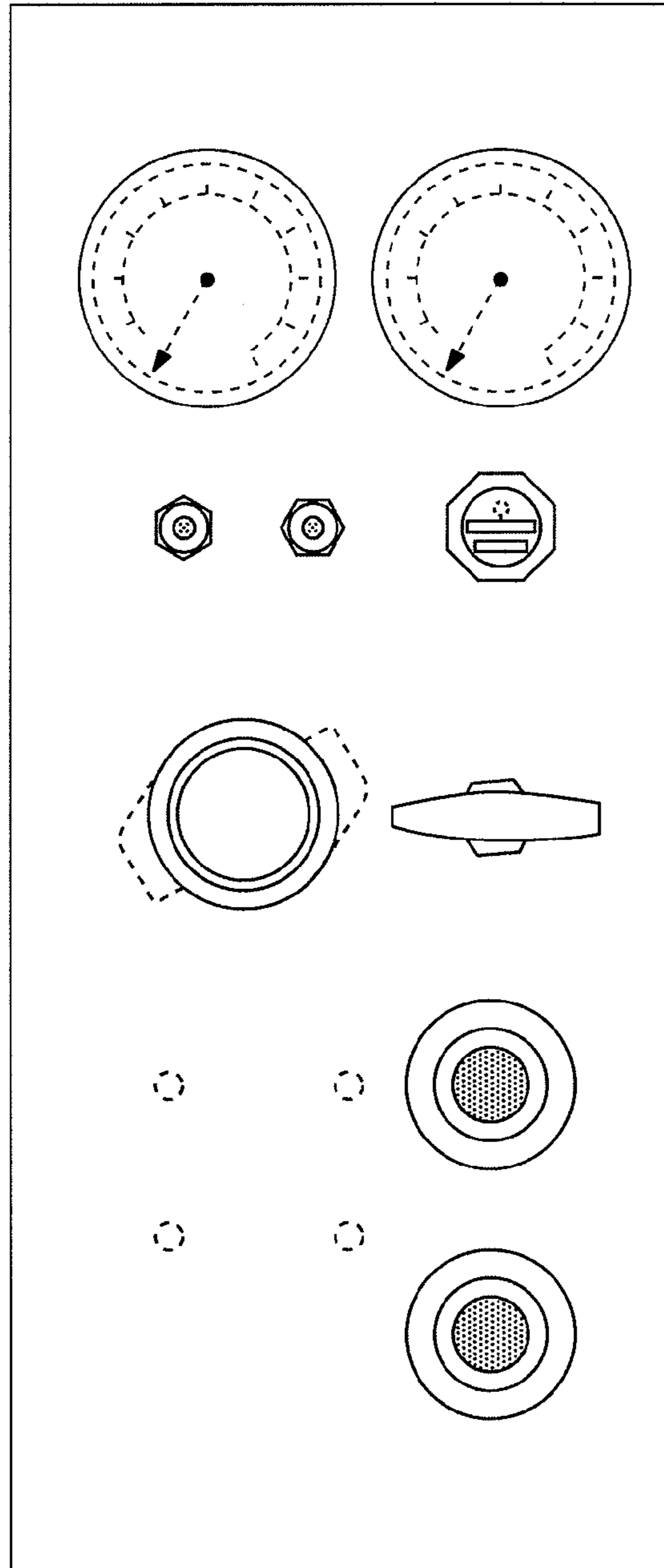

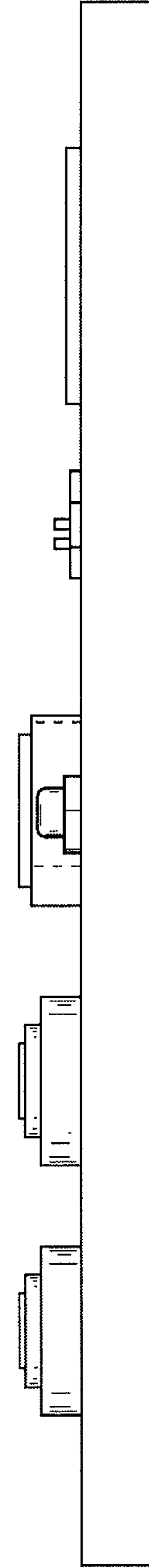

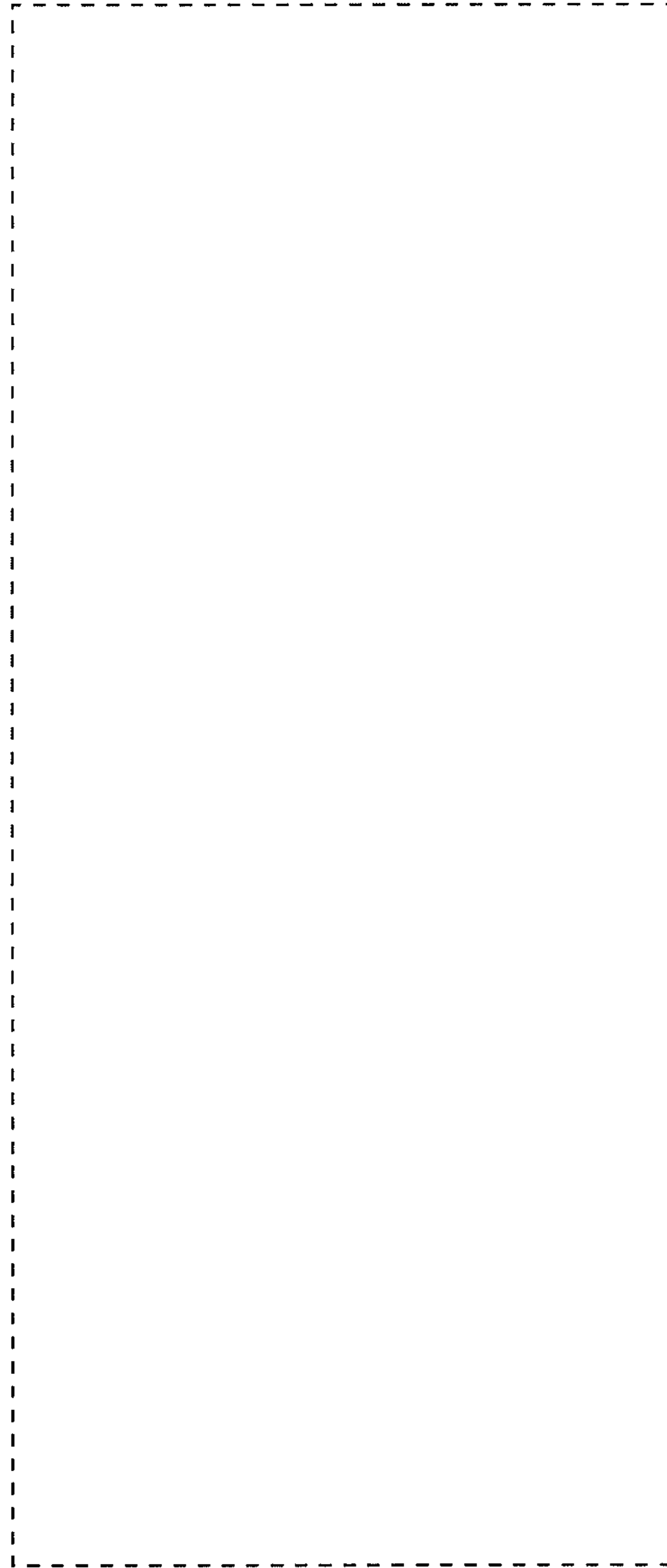
