DESCRIPTION

FIG. 1 is a front view of a wall switch according to our novel design;

FIG. 2 is a side view of the embodiment of FIG. 1, taken from the right side thereof;

FIG. 3 is a rear view of the embodiment of FIG. 1;

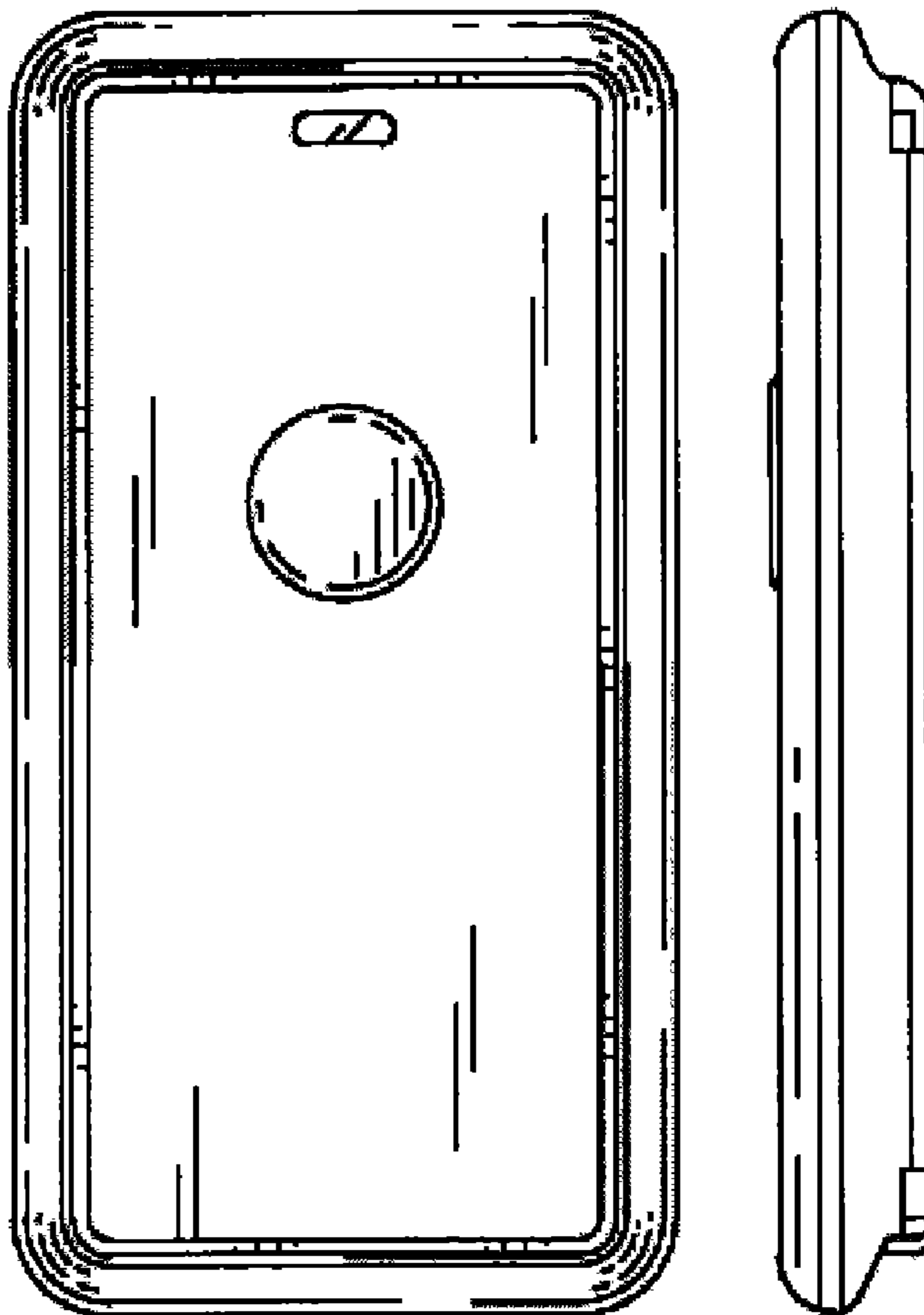
FIG. 4 is a side view of the embodiment of FIG. 1, taken from the left side thereof;

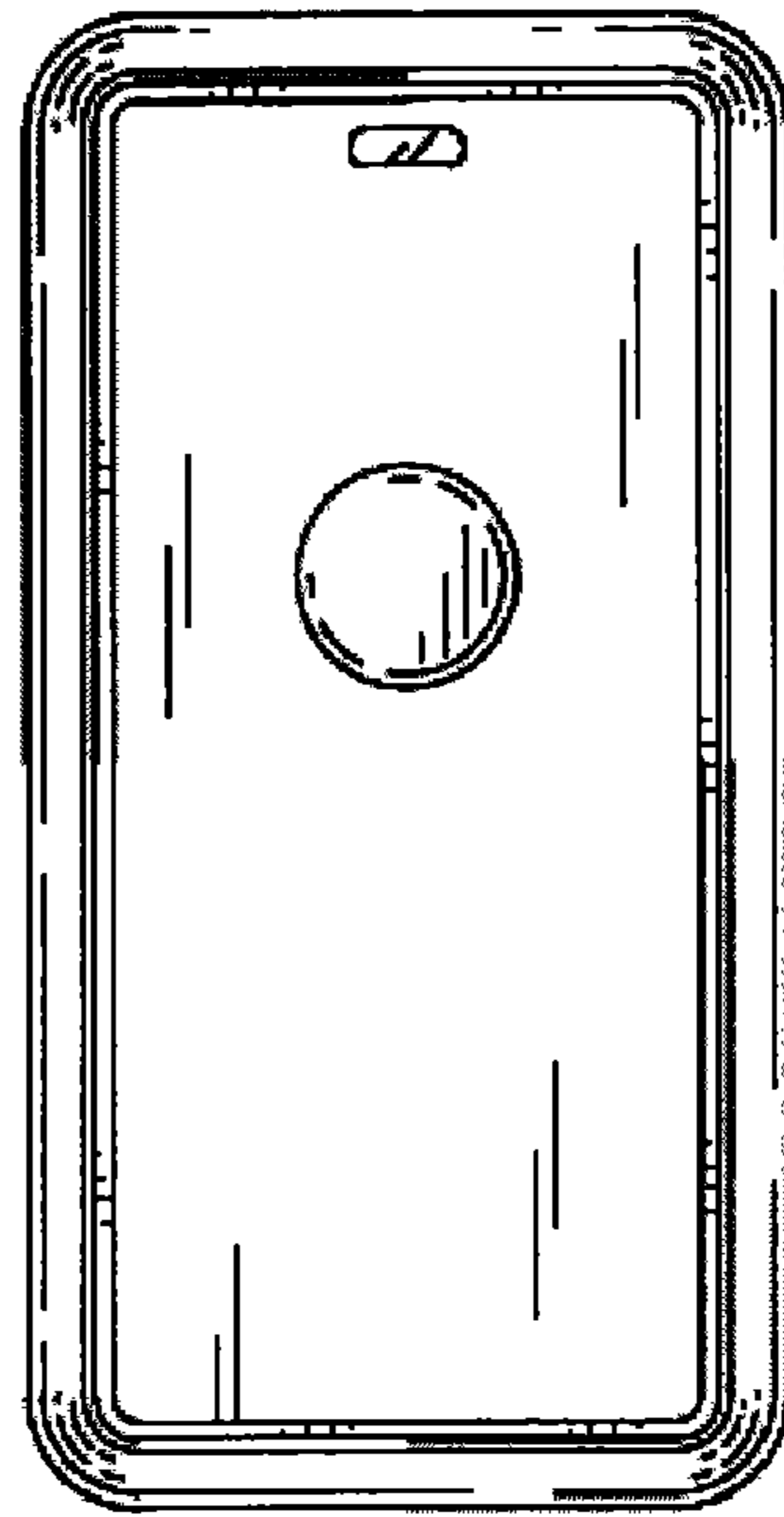

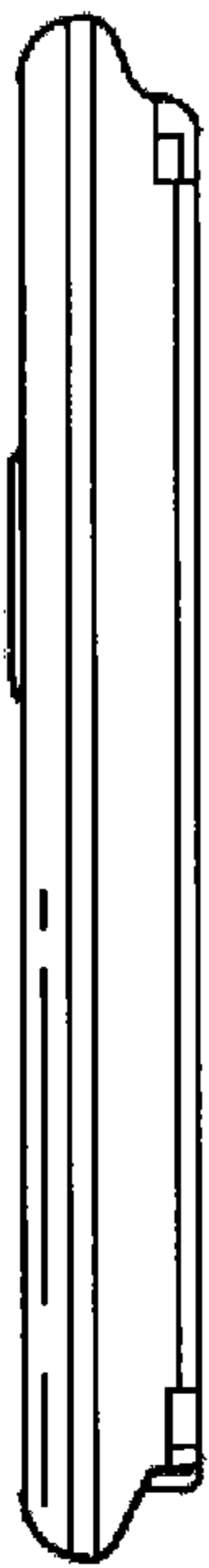

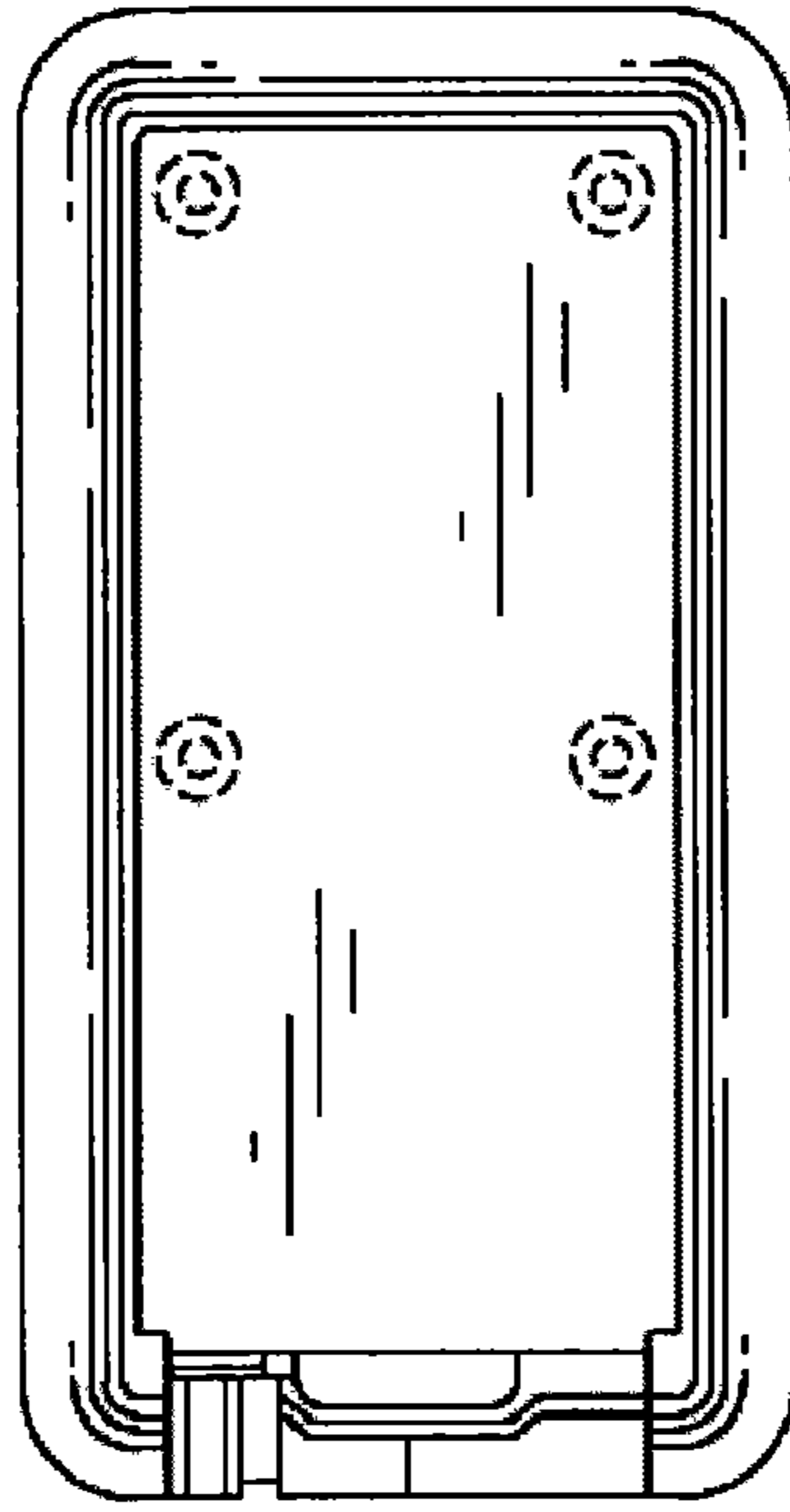

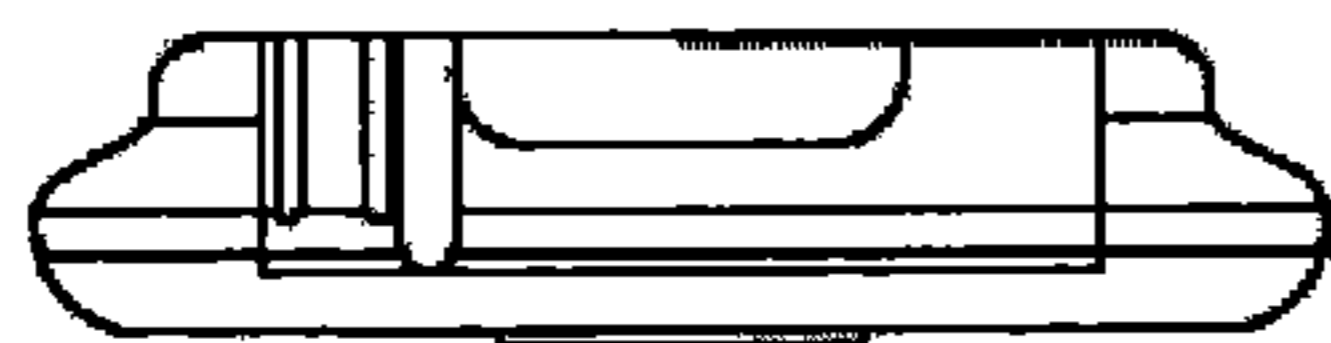

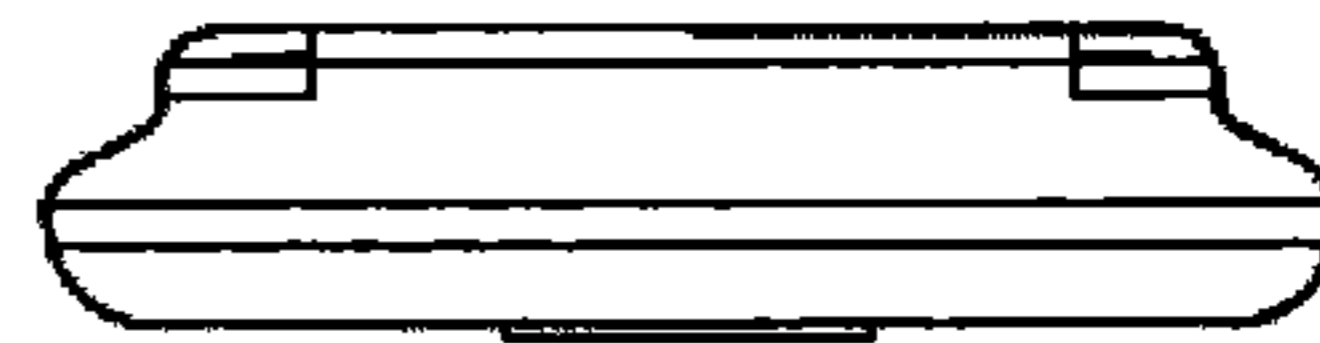
