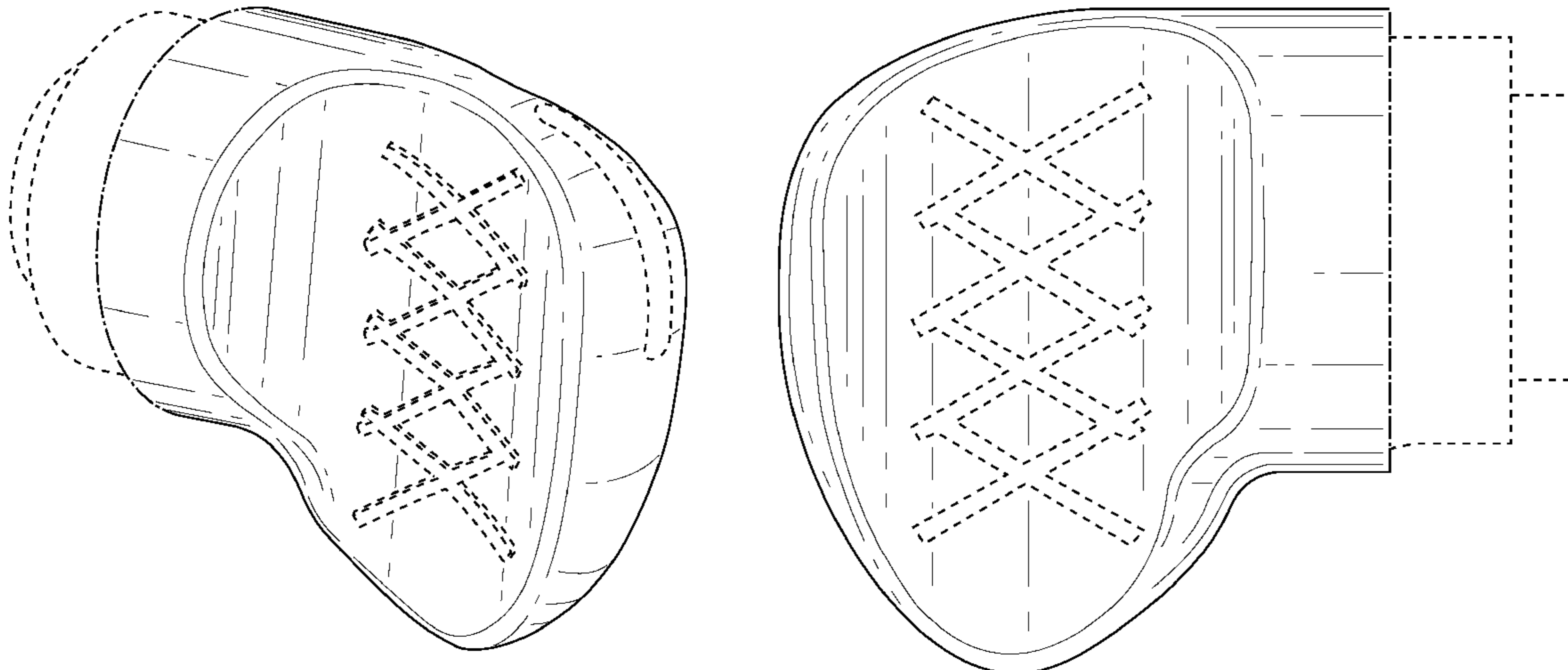
(57) **CLAIM**

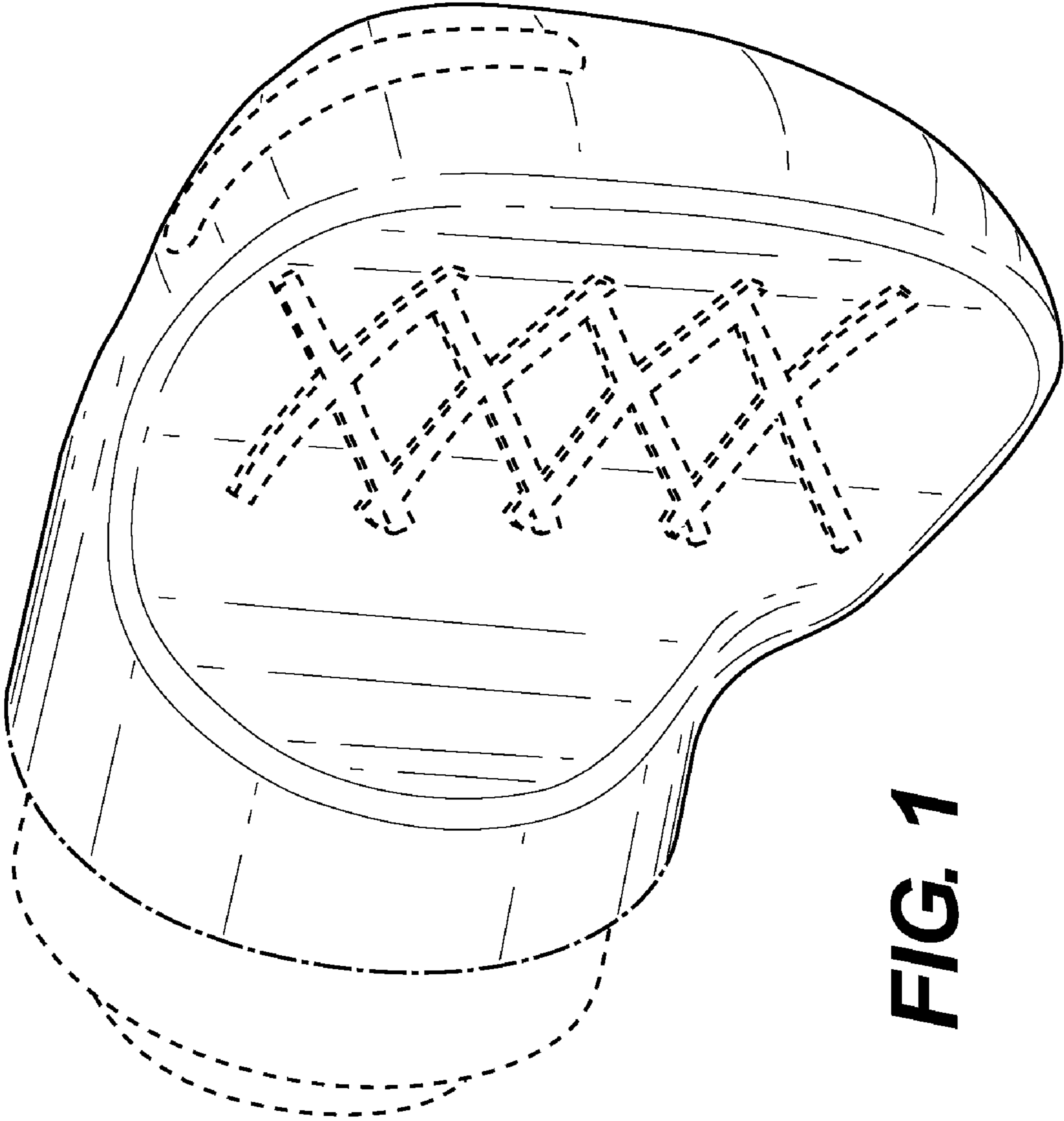
The ornamental design for a button for an aircraft control device, as shown and described.

**DESCRIPTION**

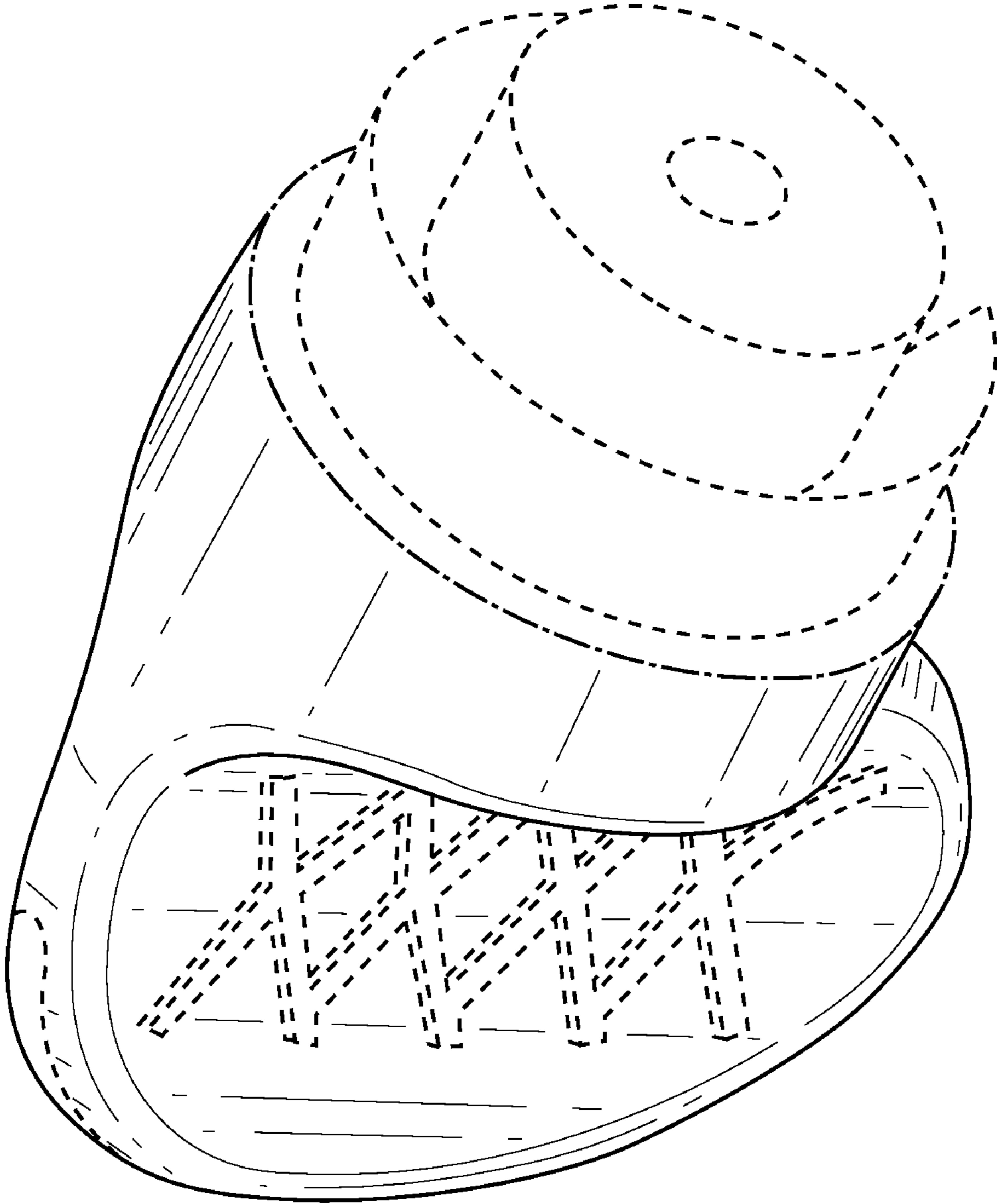
FIG. 1 is a front, right perspective view showing a button for an aircraft control device according to our design; FIG. 2 is a rear, left perspective view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a right side elevation view thereof; FIG. 7 is a front elevation view thereof; FIG. 8 is a rear elevation view thereof; FIG. 9 is a front, left perspective view of the button for an aircraft control device of FIG. 1, shown on an aircraft control device shown in broken lines; and, FIG. 10 is a front, right perspective view of the button for an aircraft control device of FIG. 1, shown with a hand of a user in broken lines interacting with the button. Throughout the Figures, where shown: (i) the dotted lines showing additional structure of the button for an aircraft control device or environment are for illustrative purposes only and form no part of the claimed design; (ii) the unshaded surfaces do not form part of the claimed design; and (iii) the dash-dot lines illustrate unclaimed boundaries of surfaces claimed as part of the design.

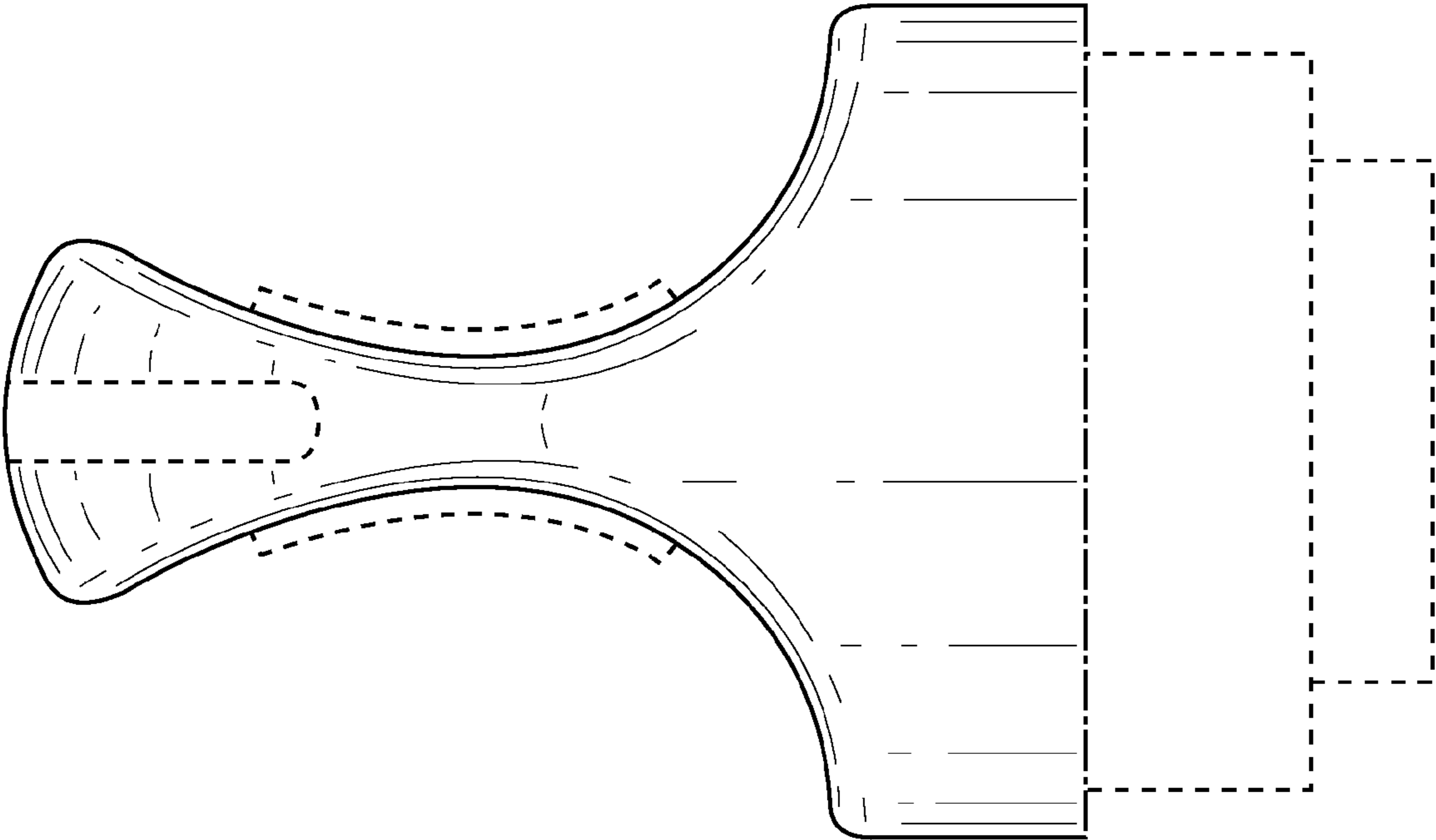




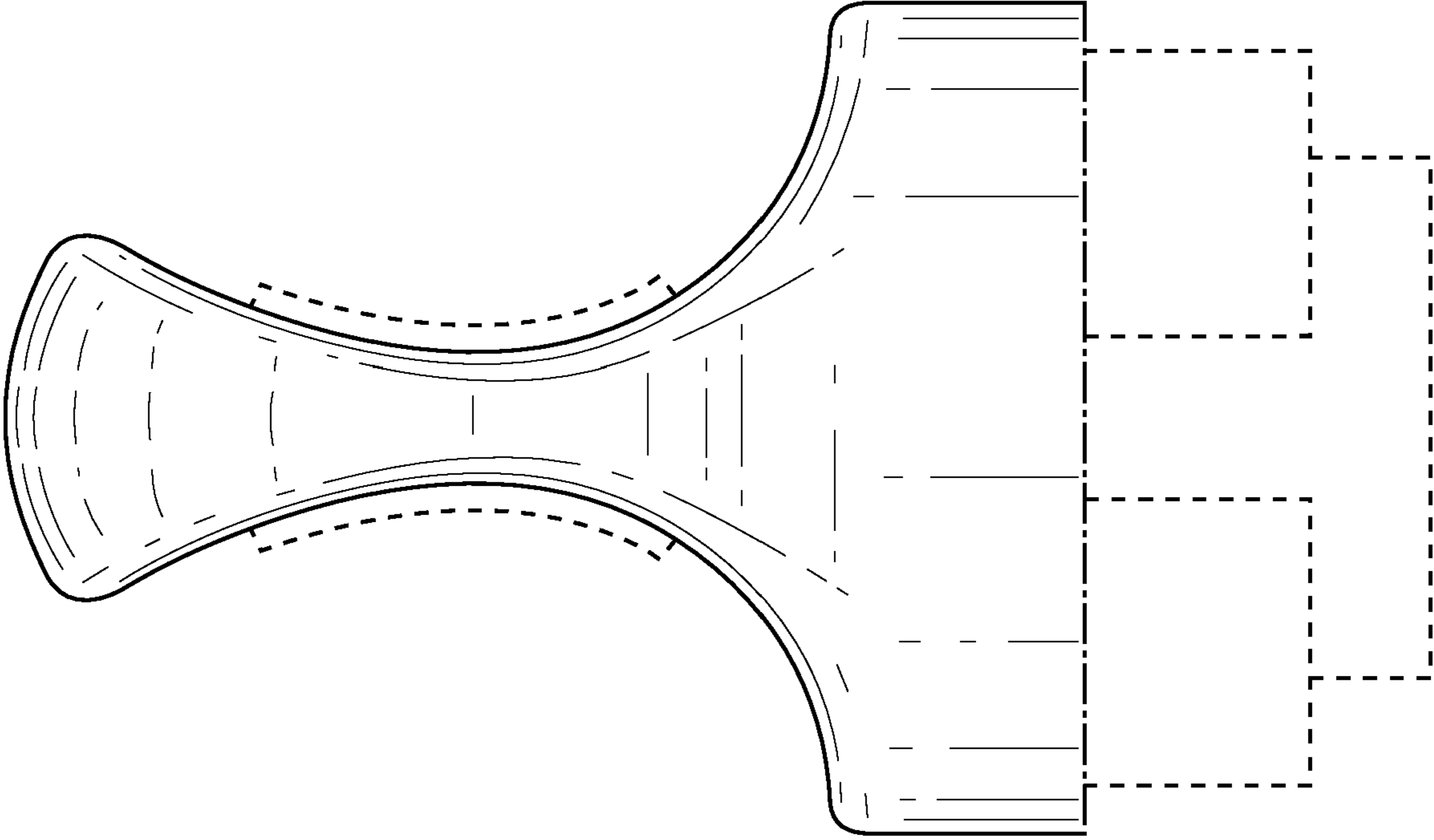

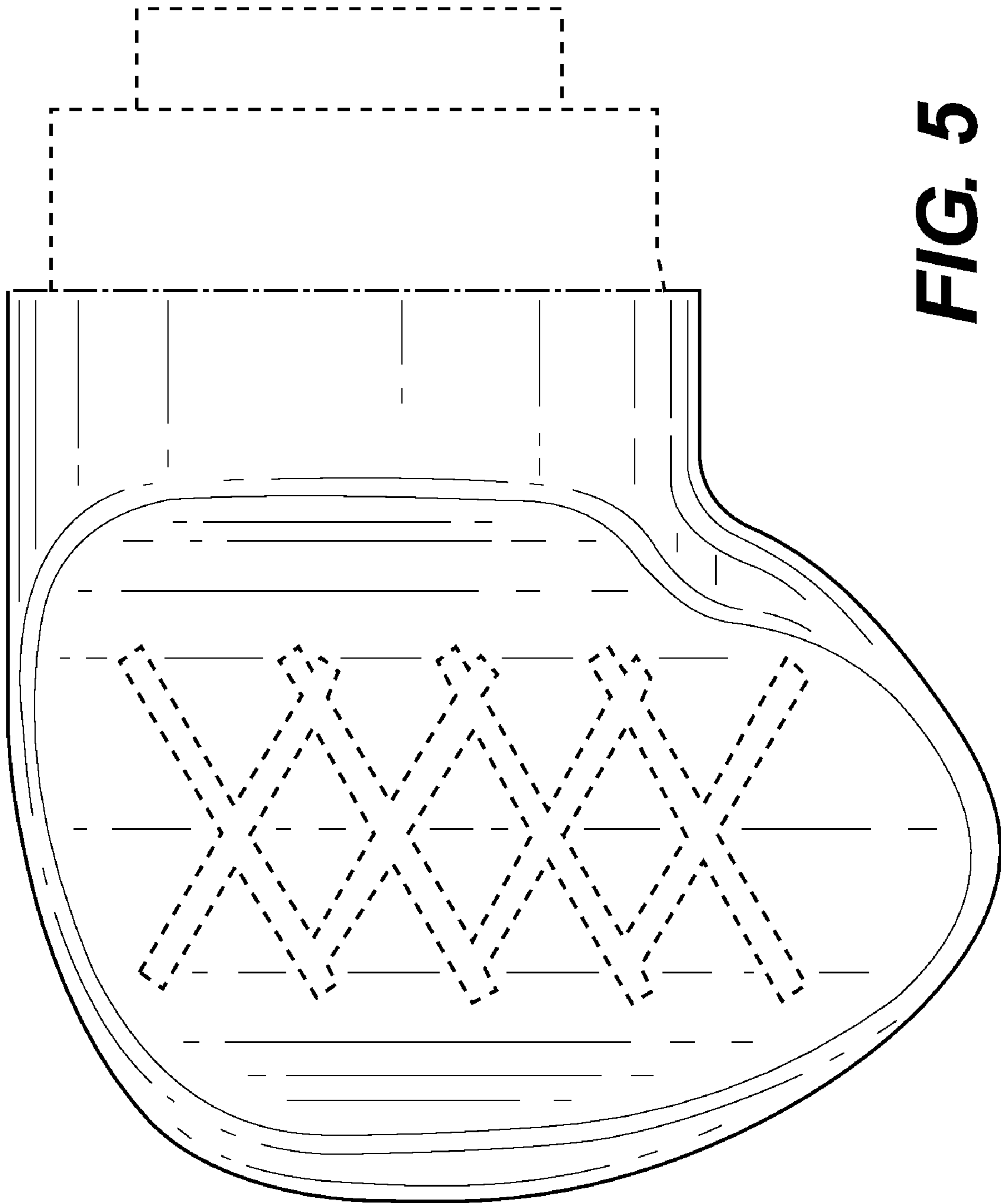

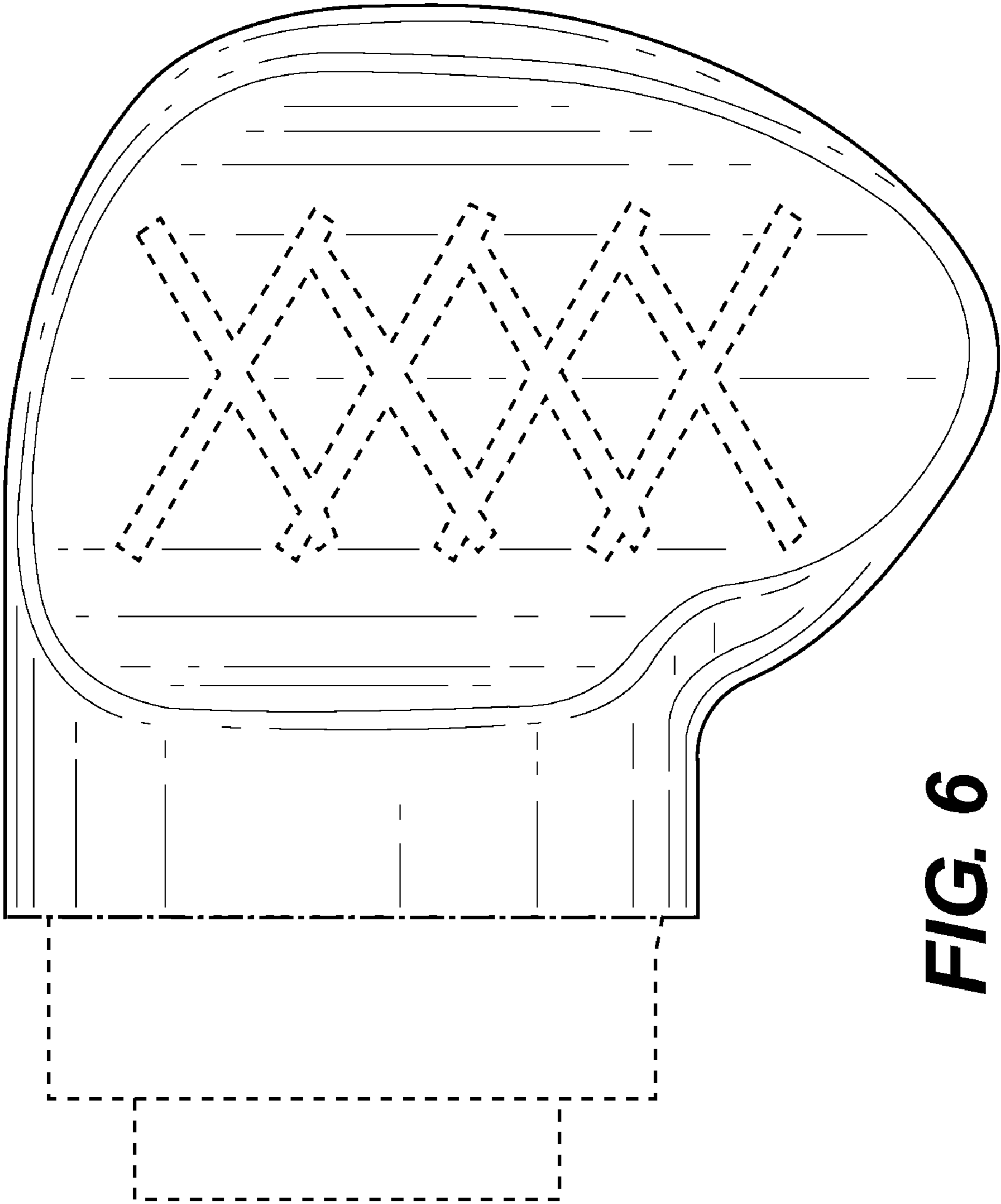

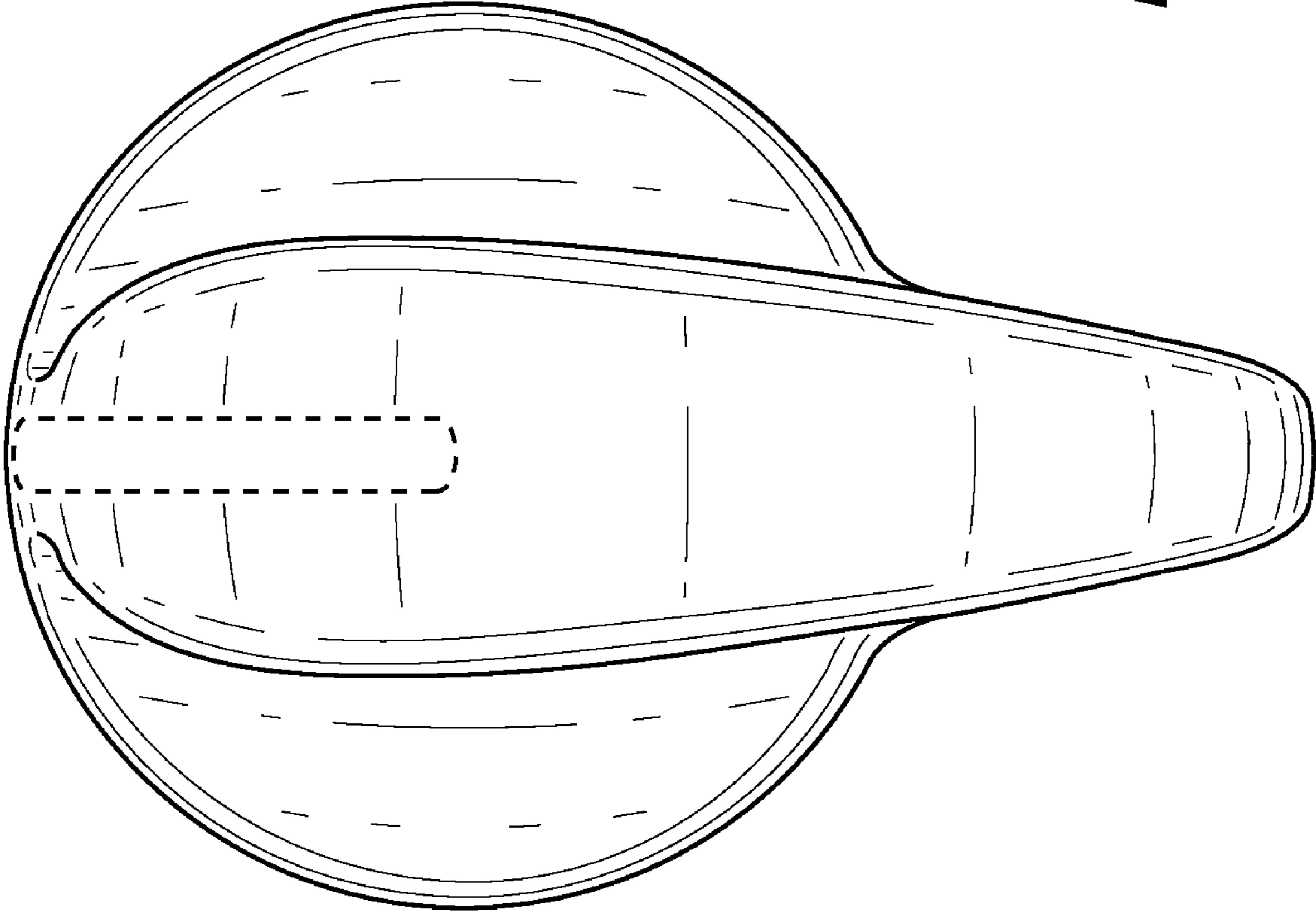

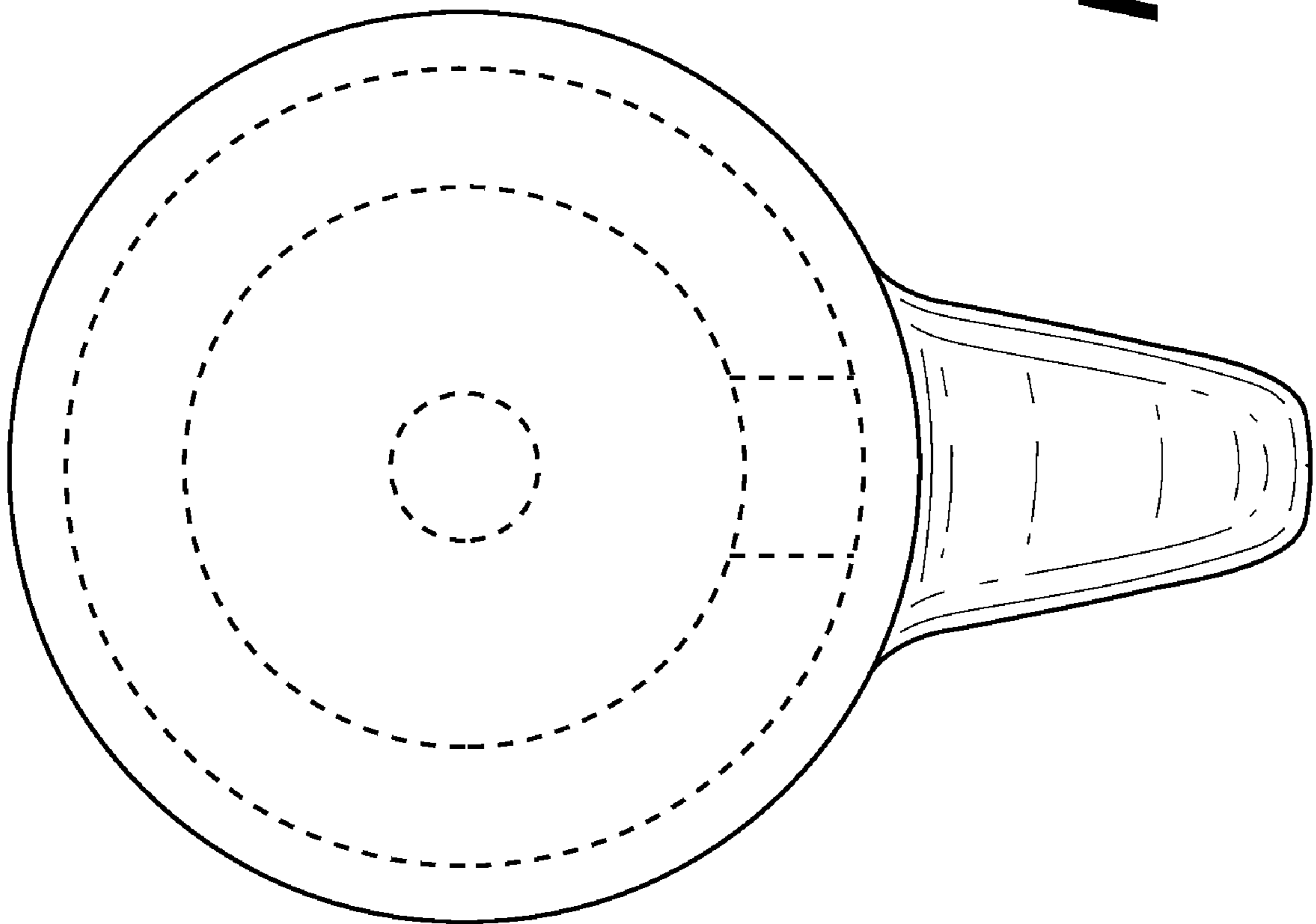

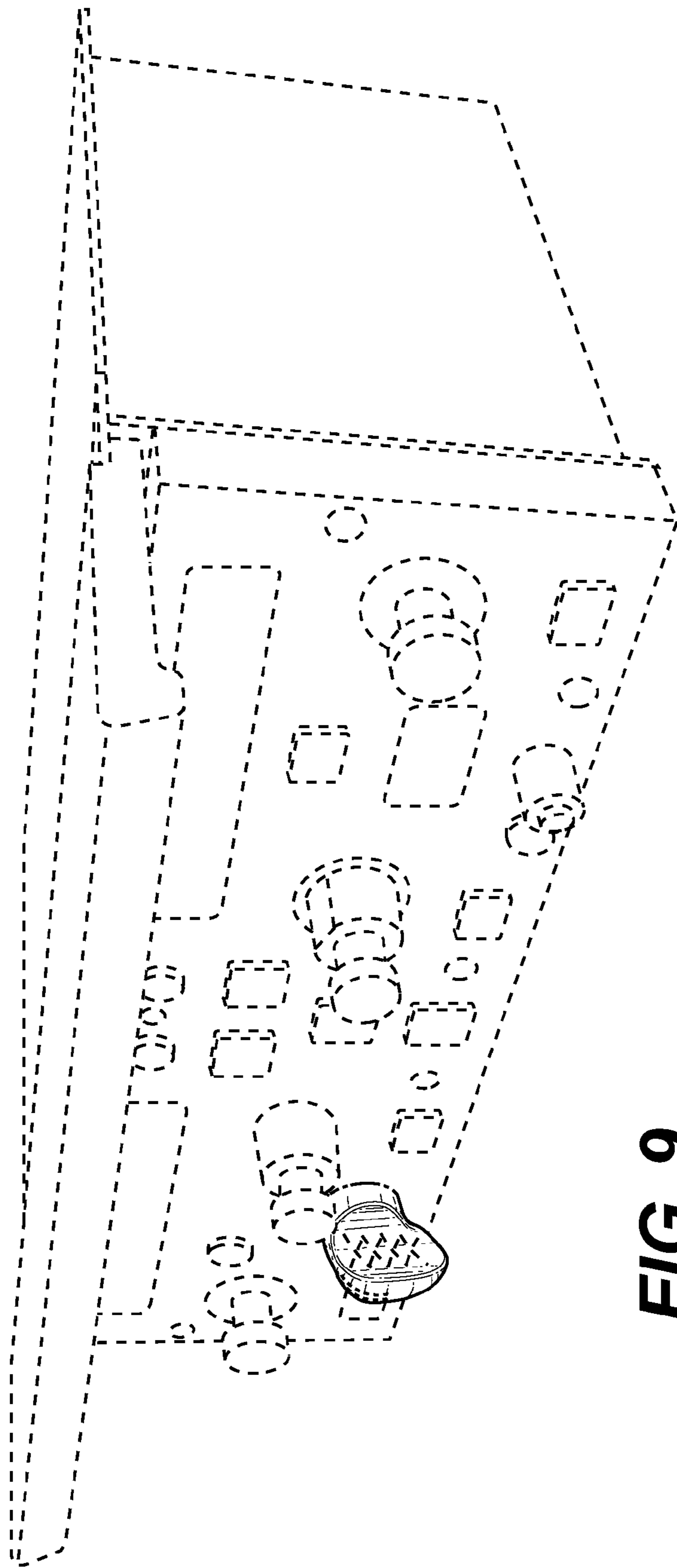

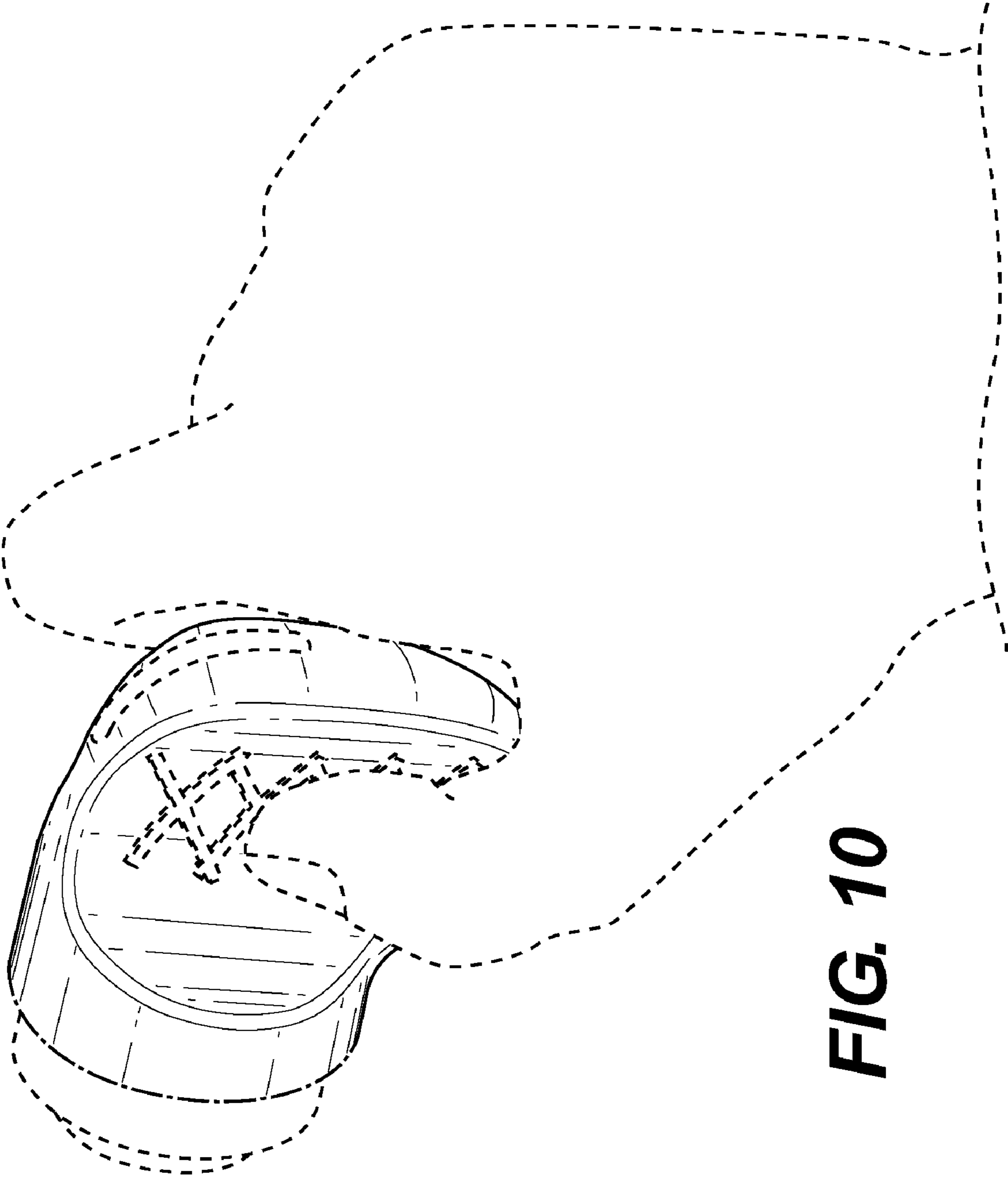
