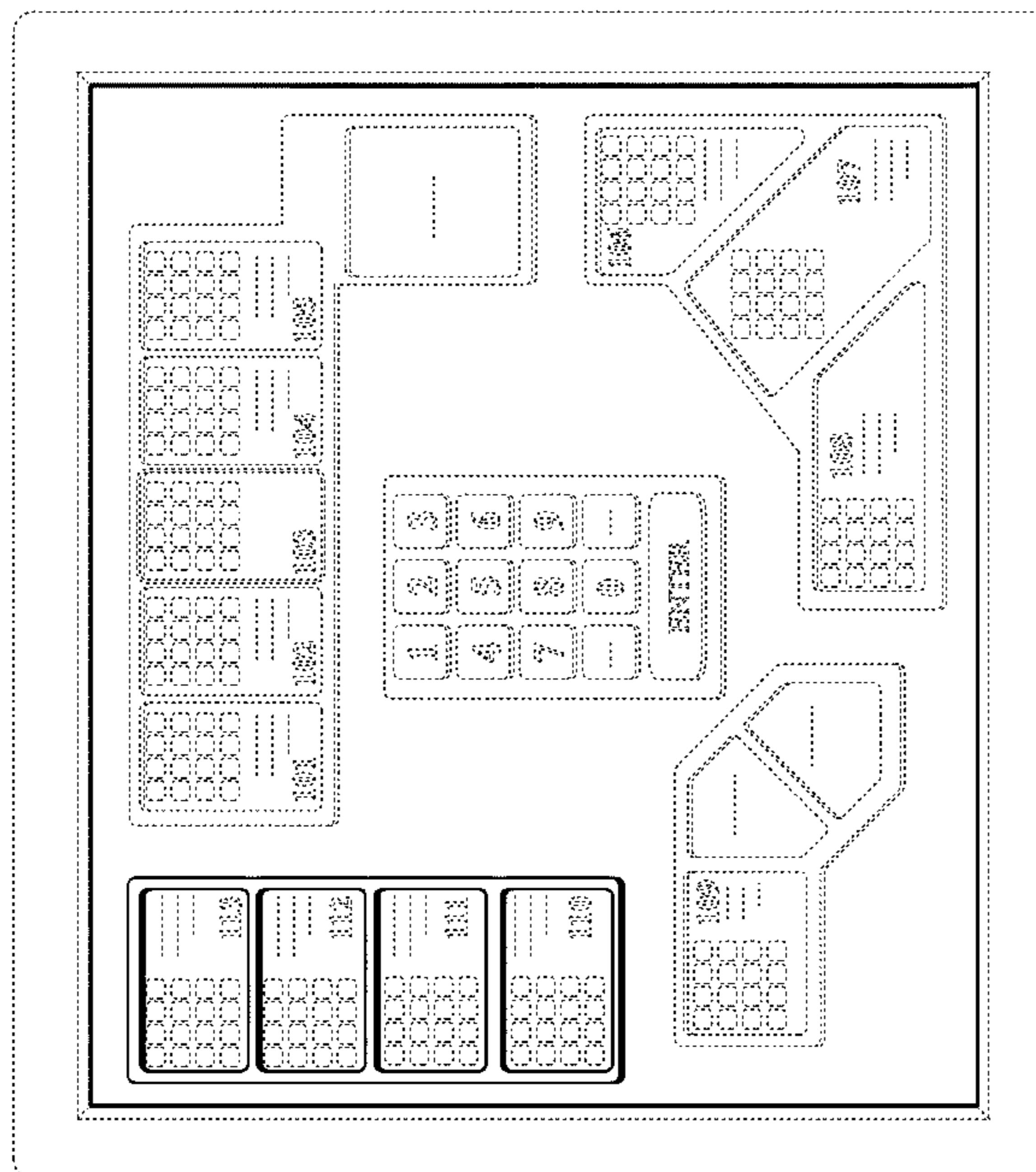
The ornamental design for a graphical user interface for an electronic display, as shown and described.

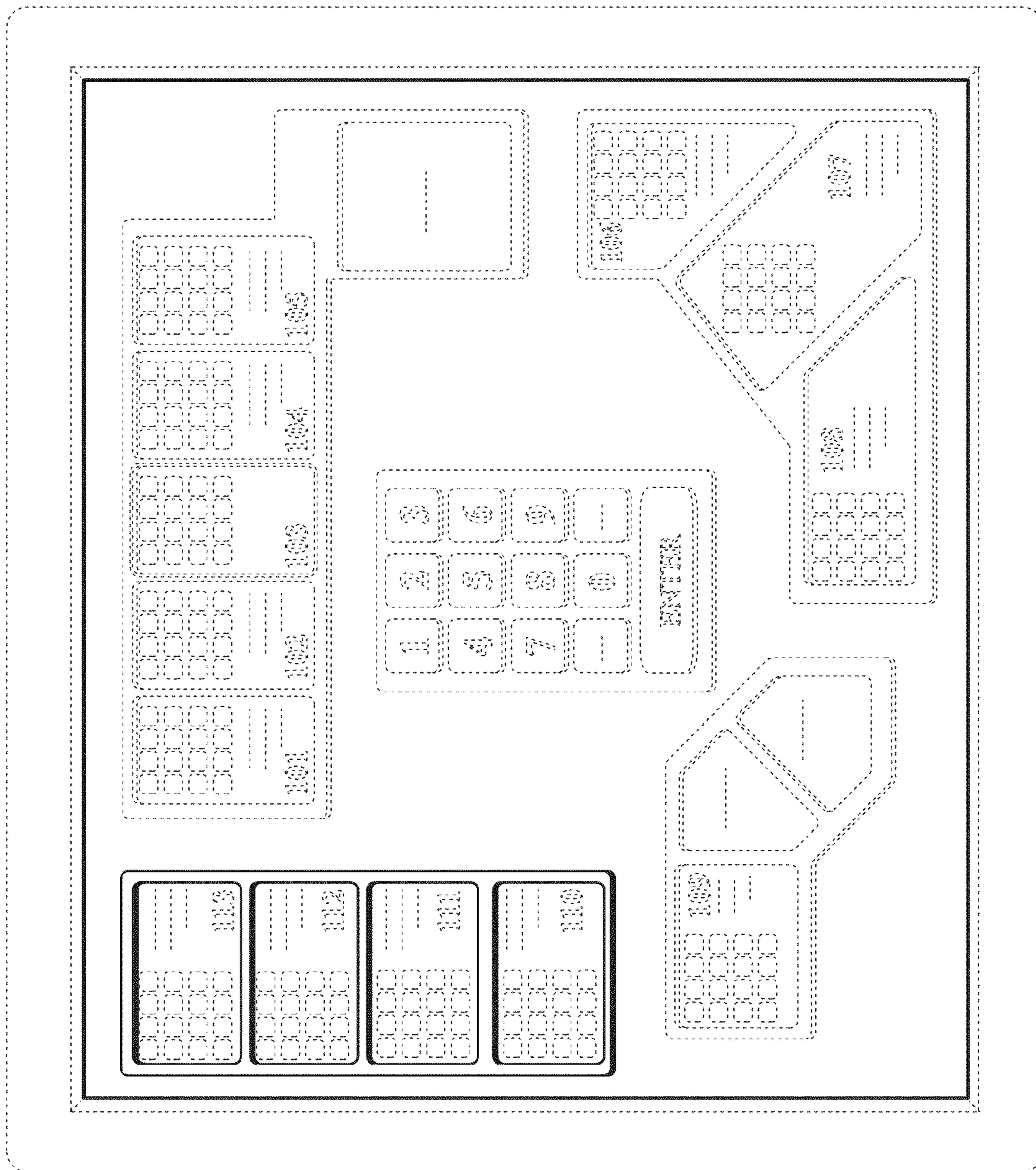
DESCRIPTION
