The broken lines depict environmental subject matter only and form no part of the claimed design.

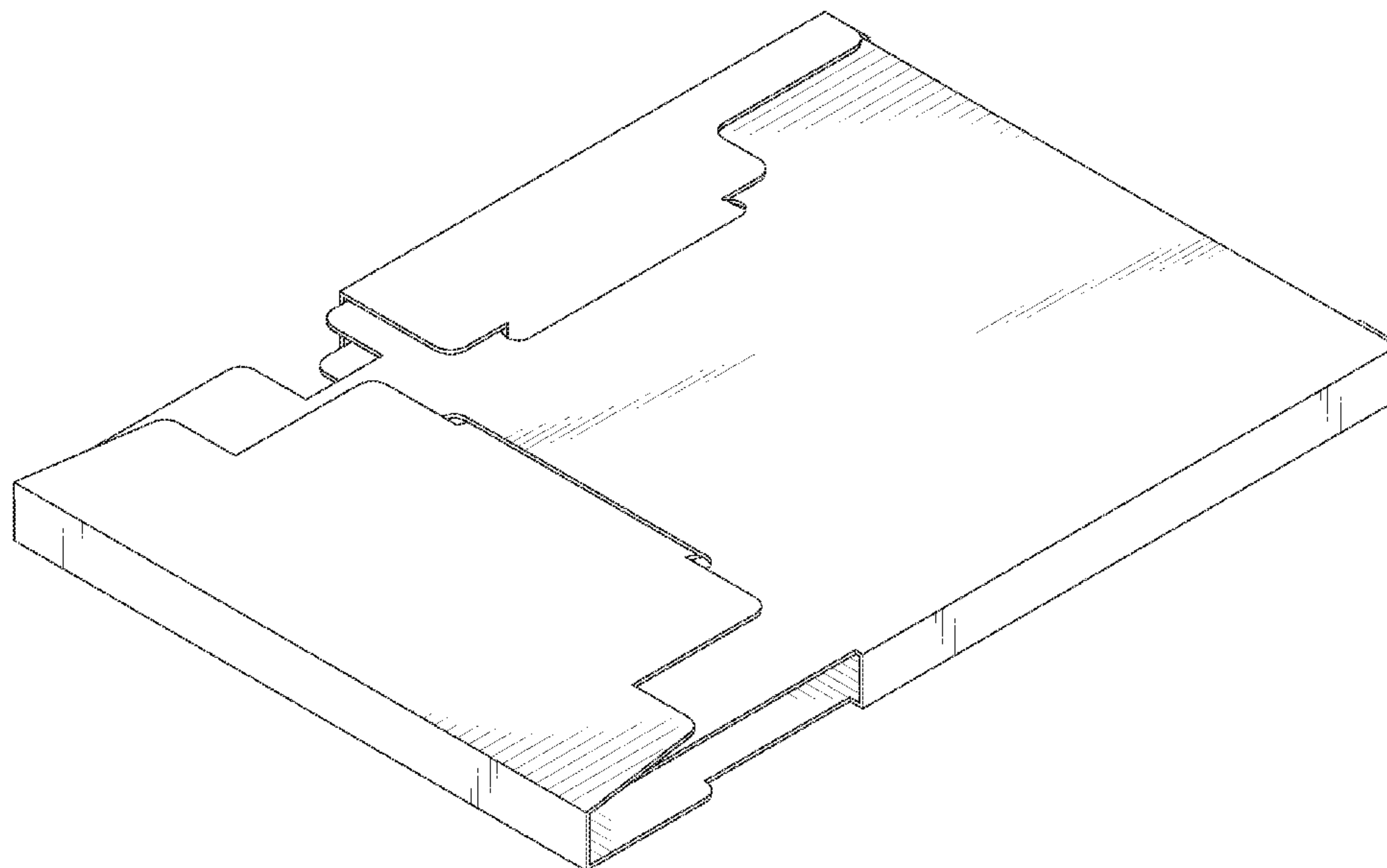

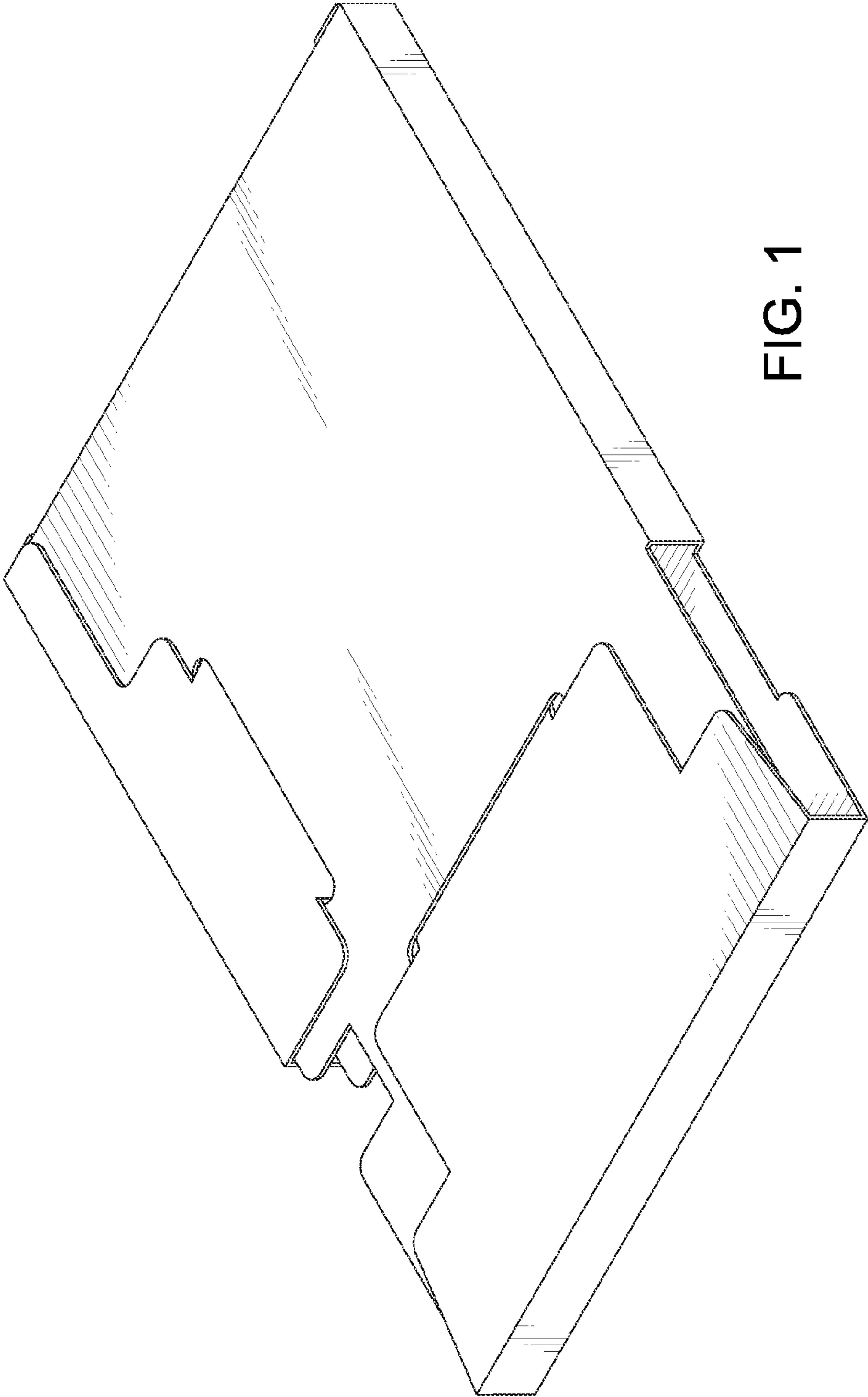

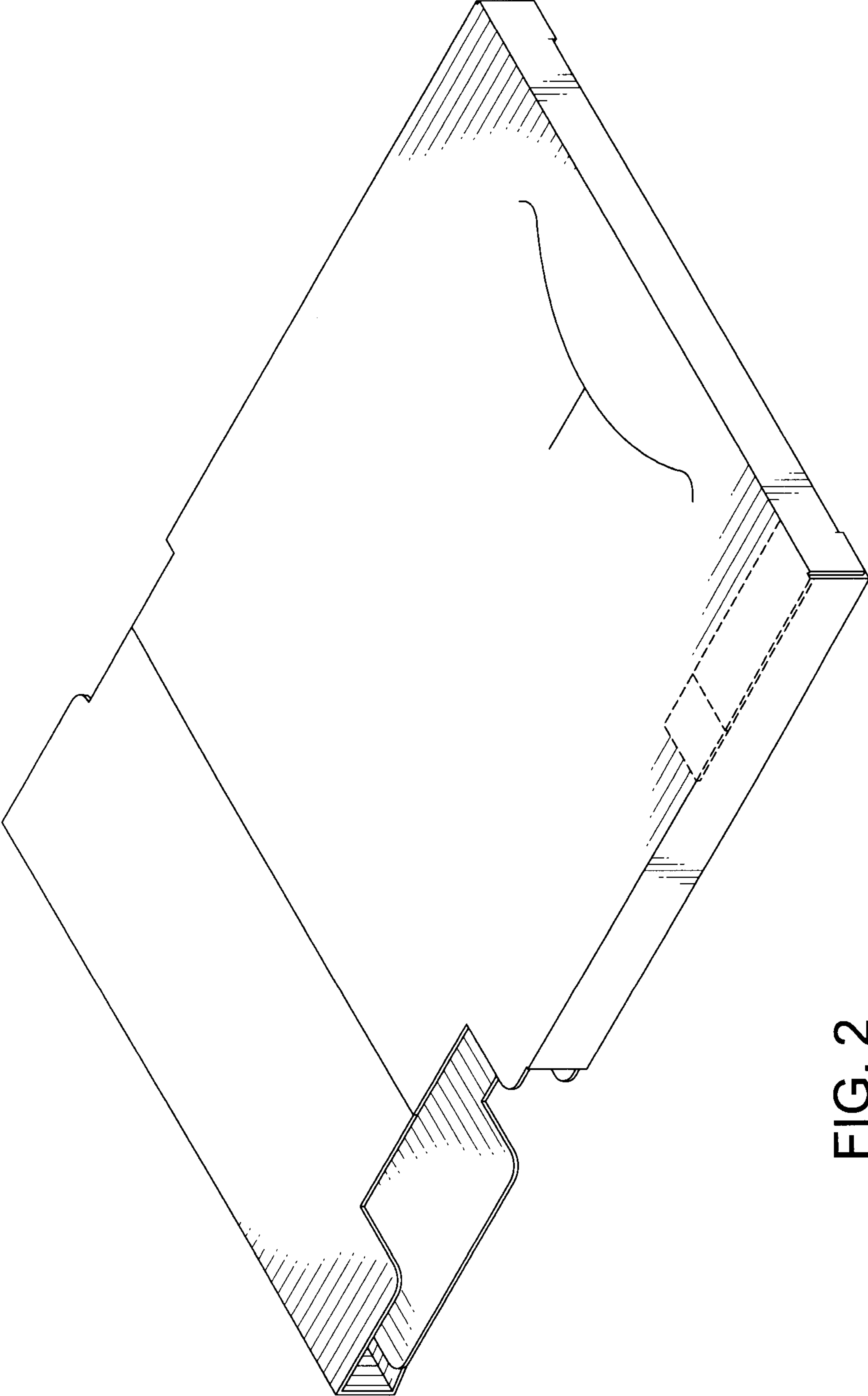

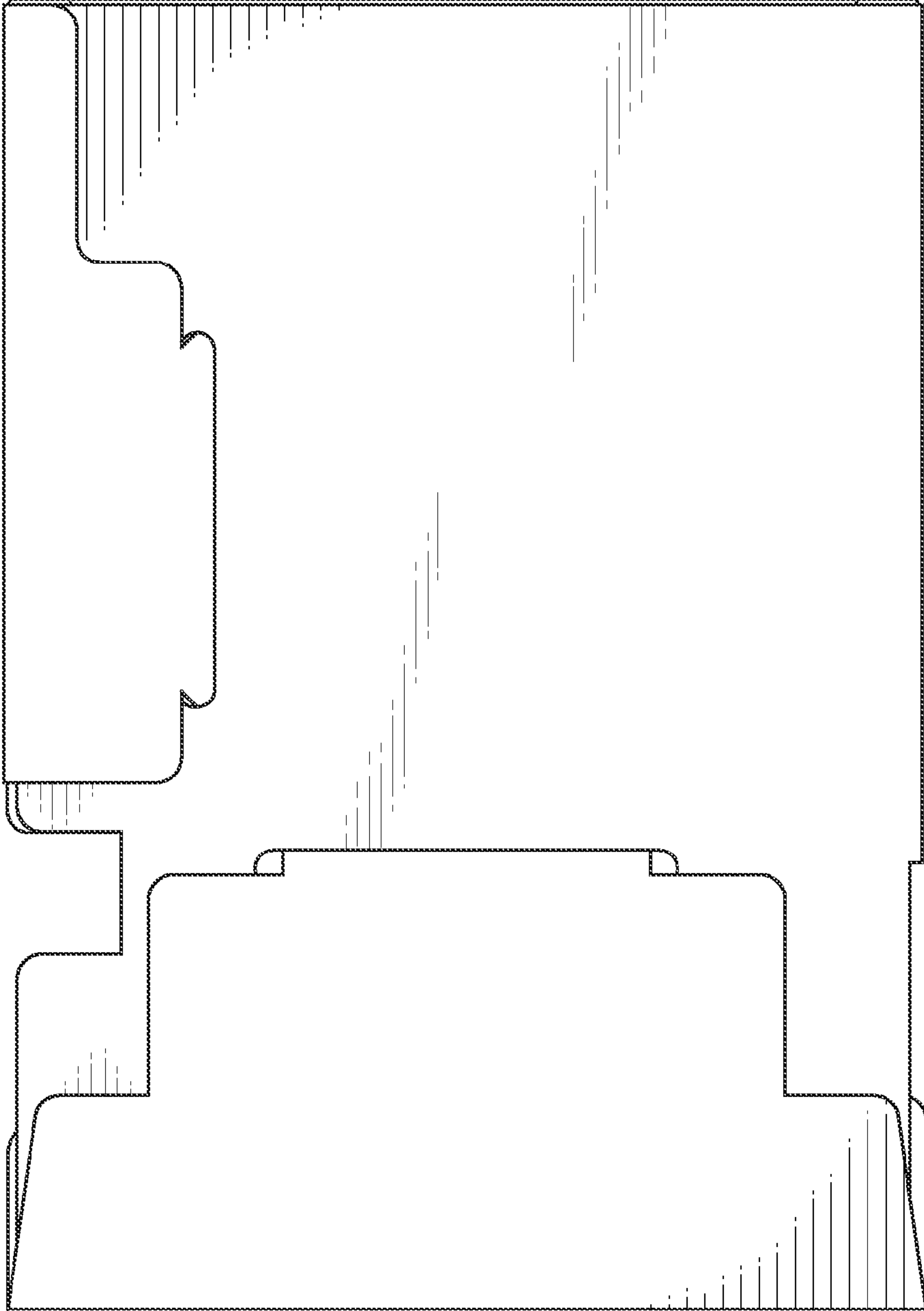

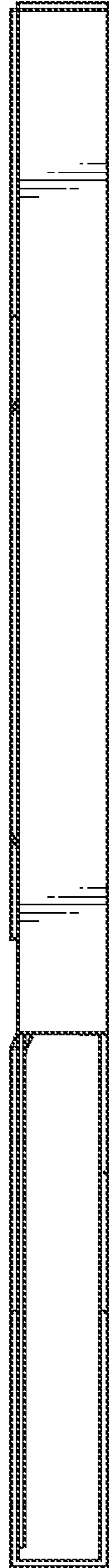

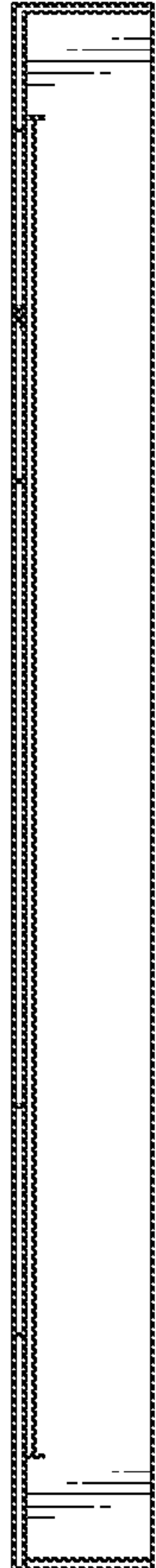

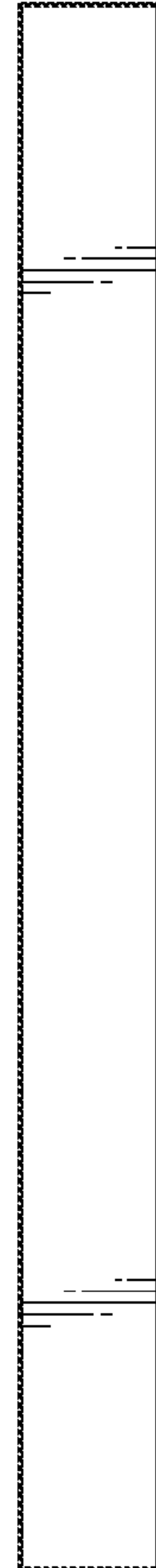

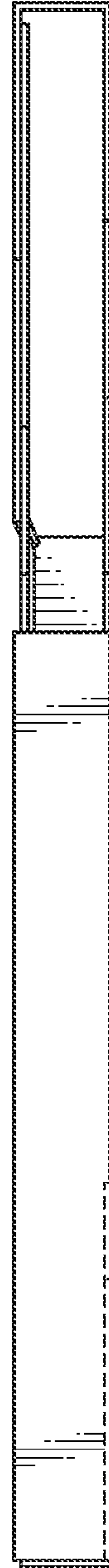

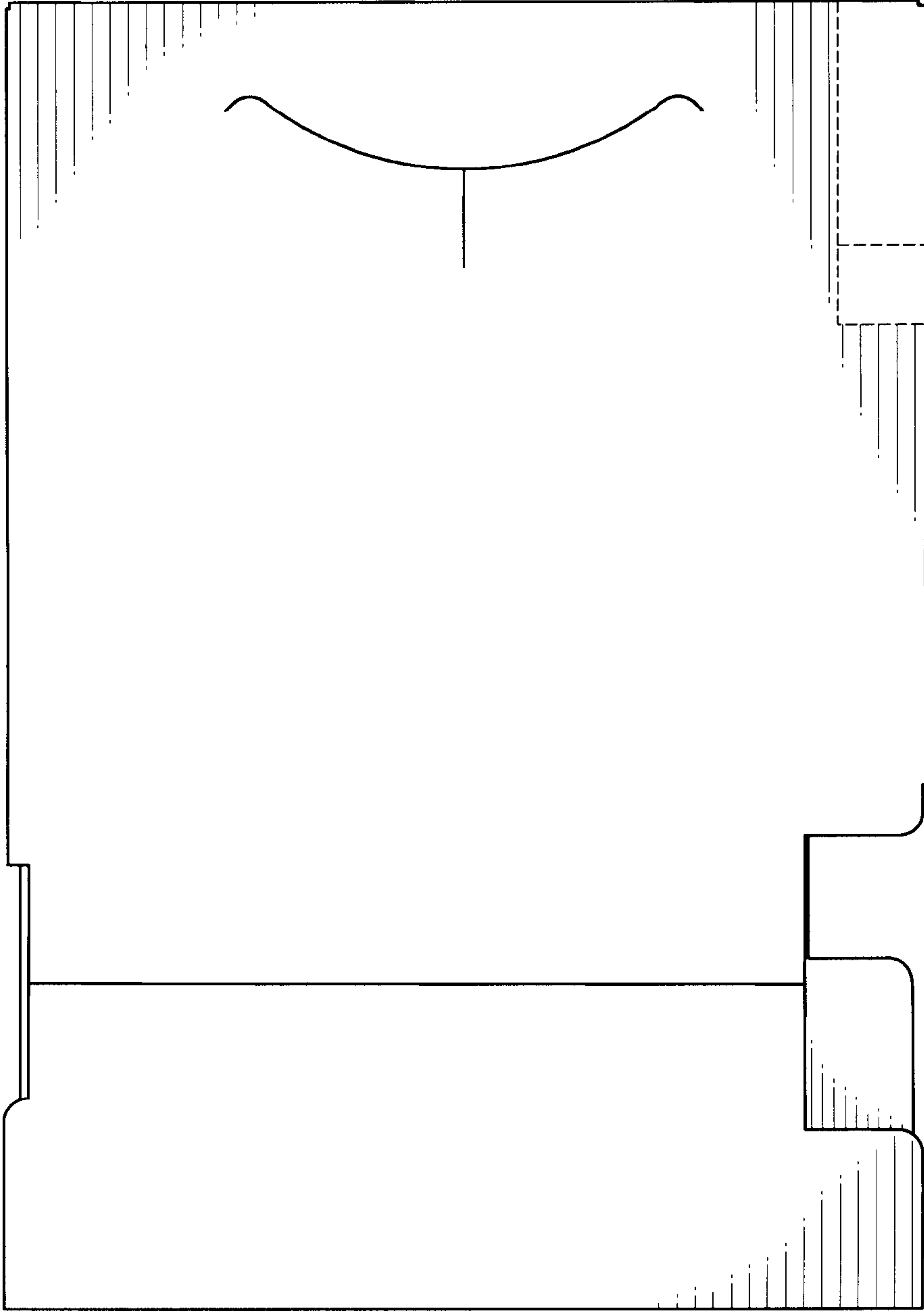

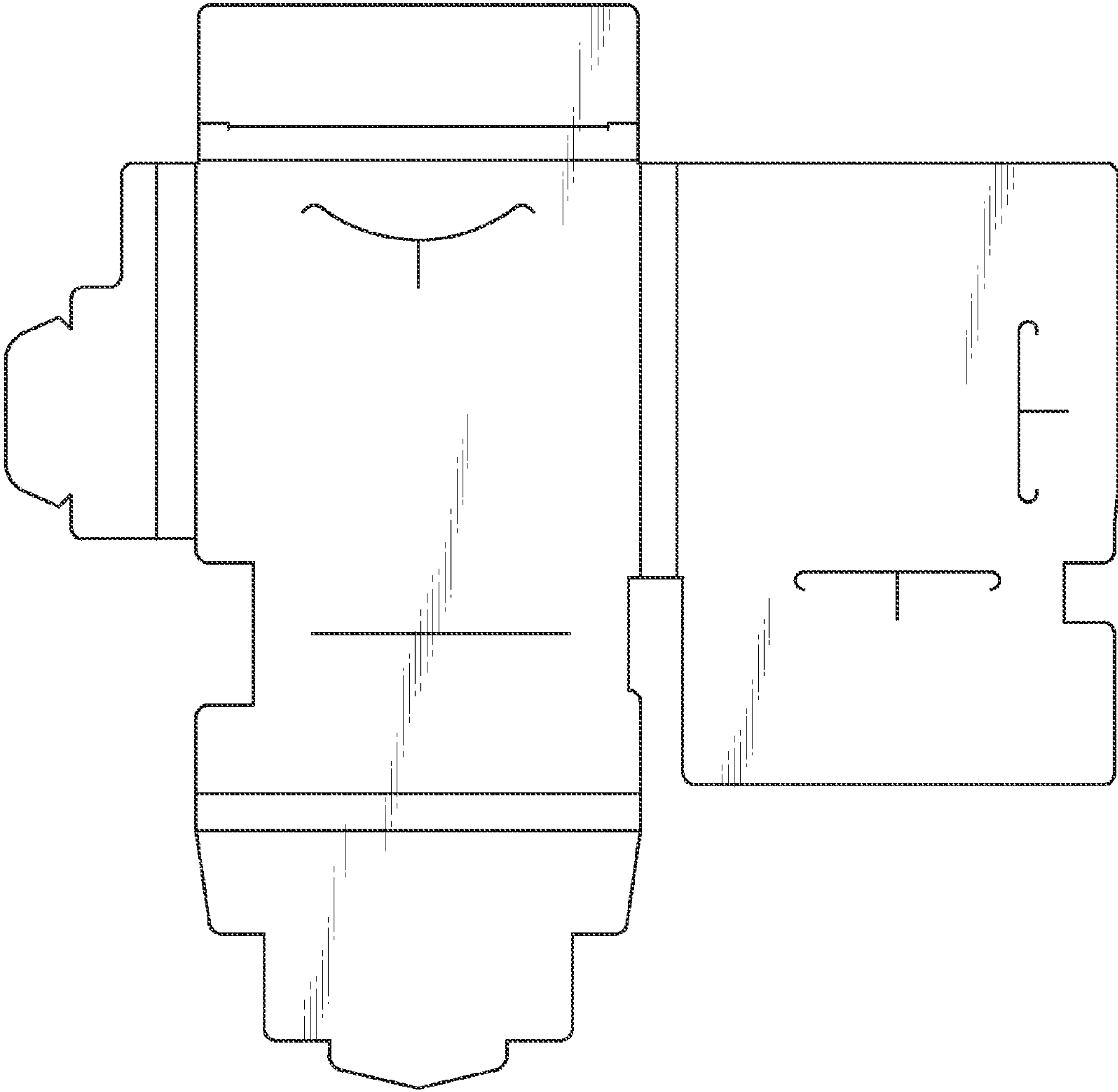

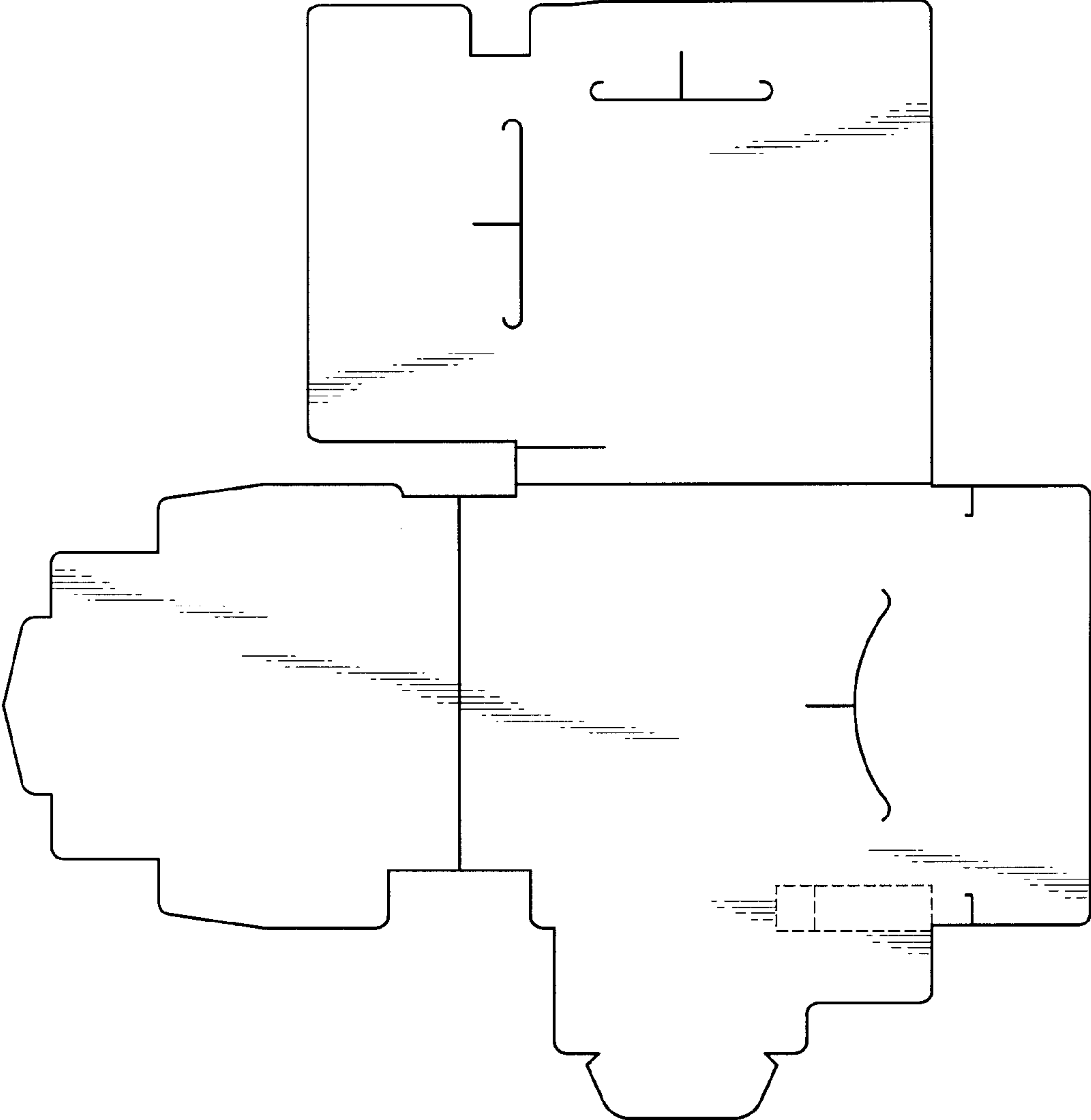

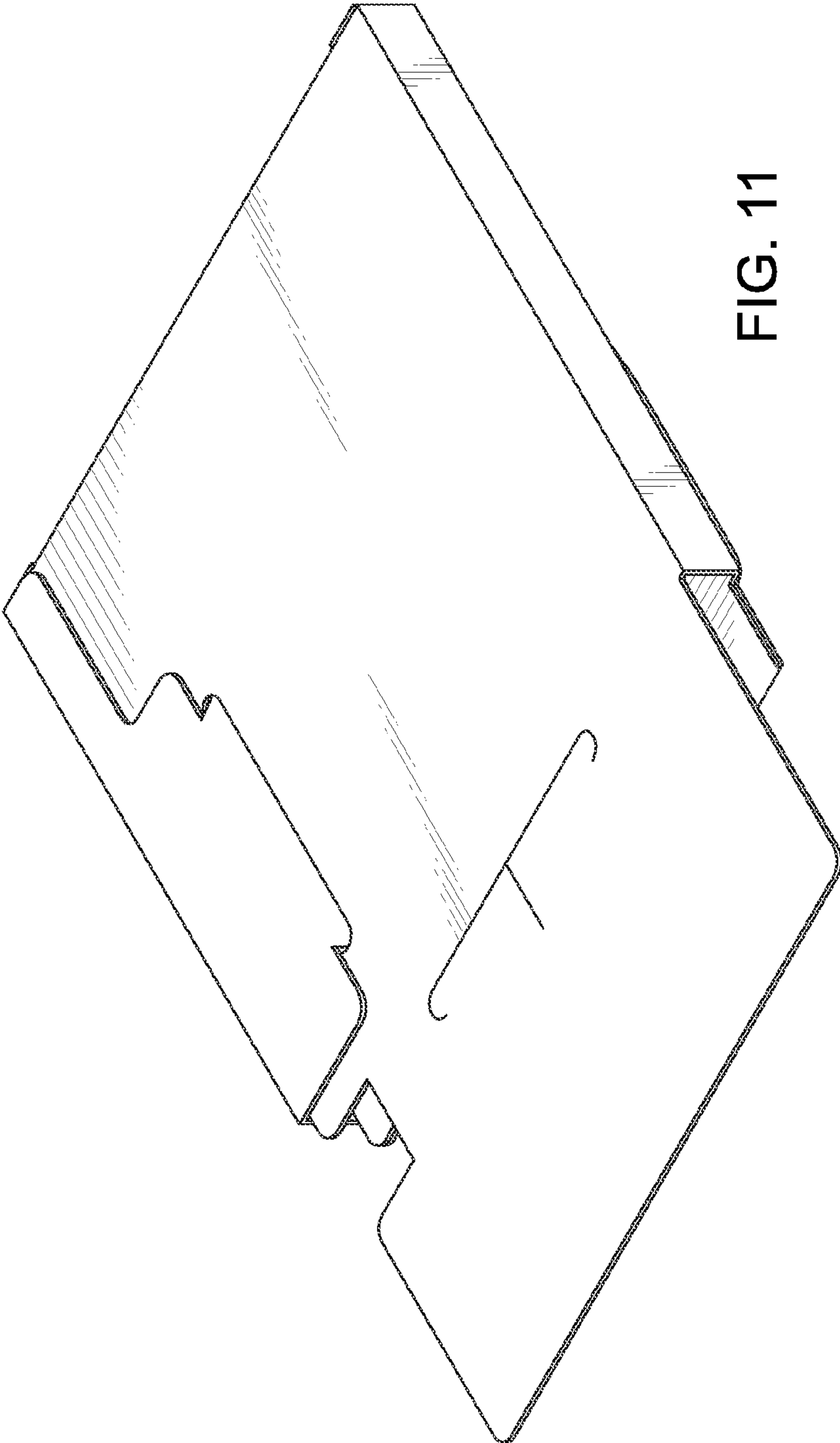

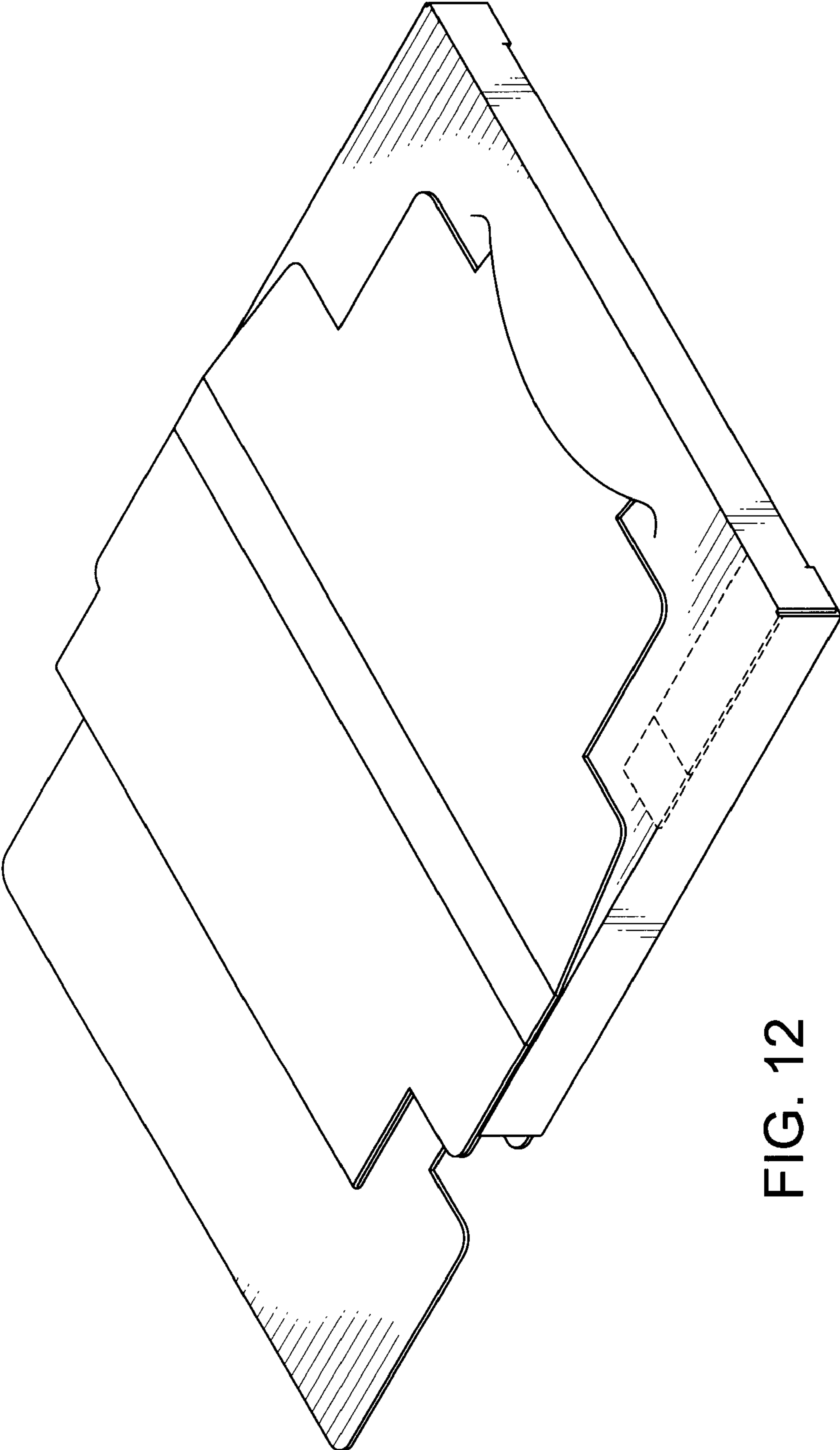

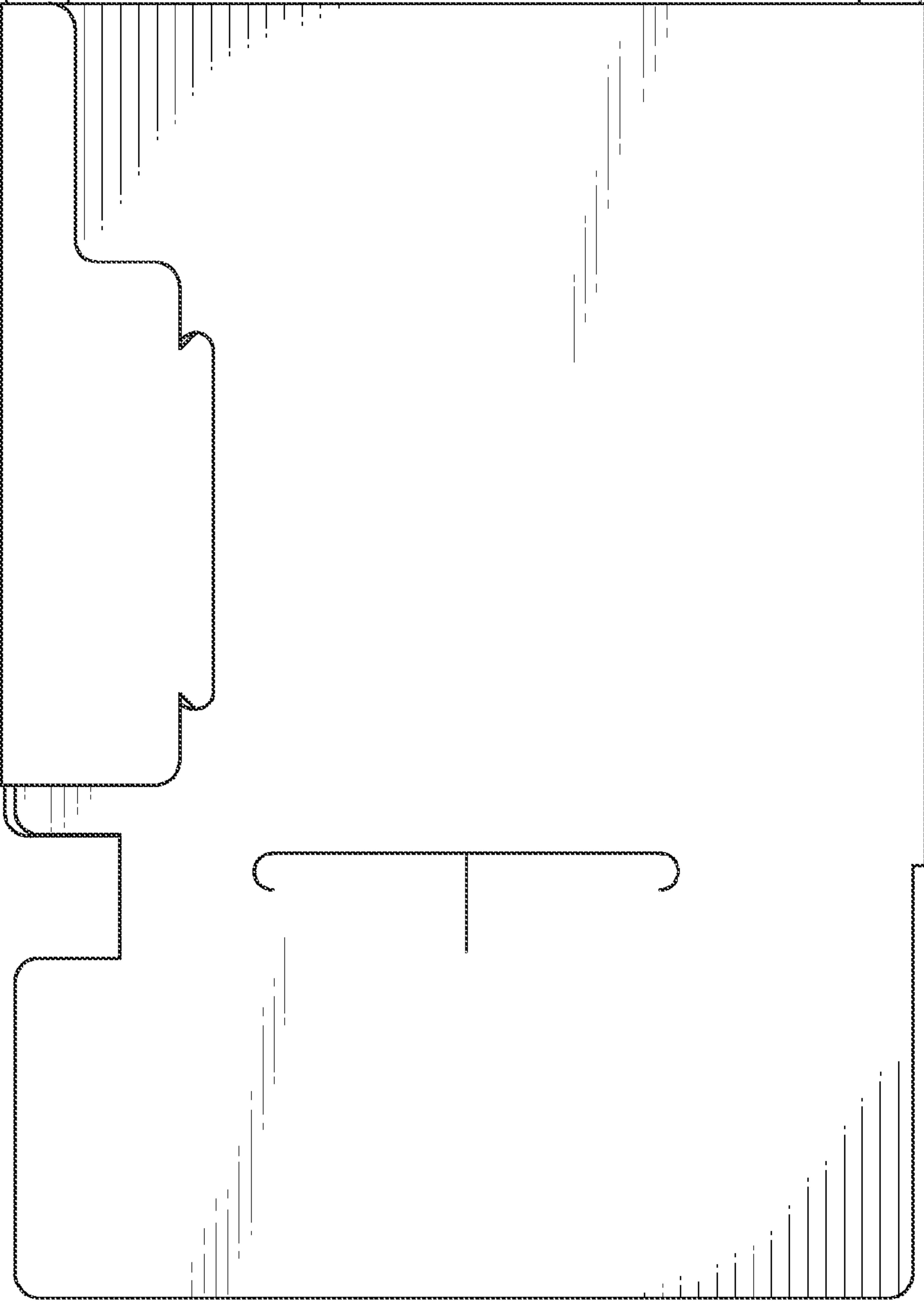

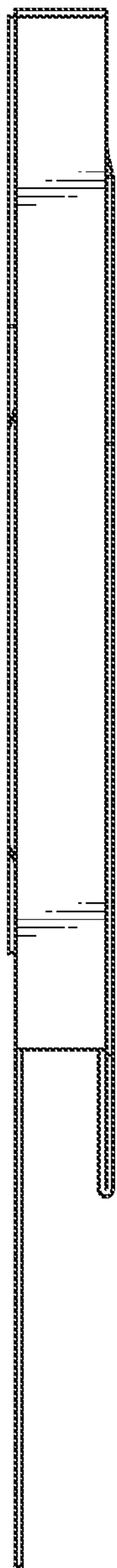

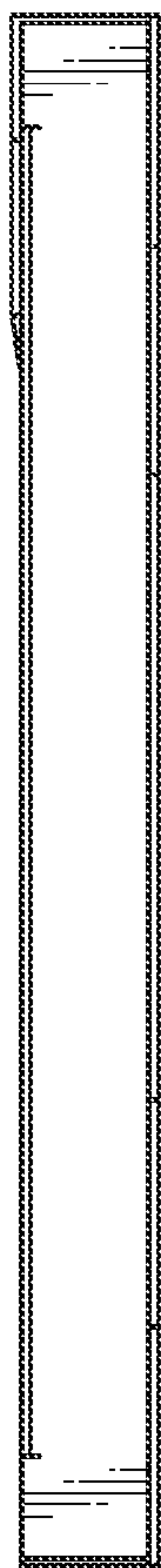

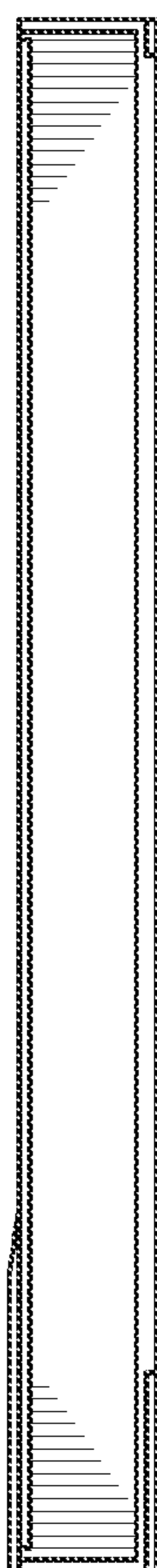

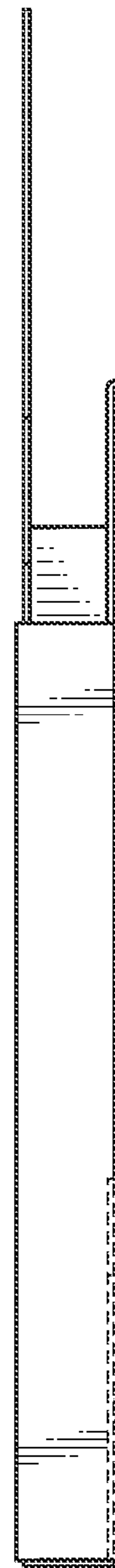

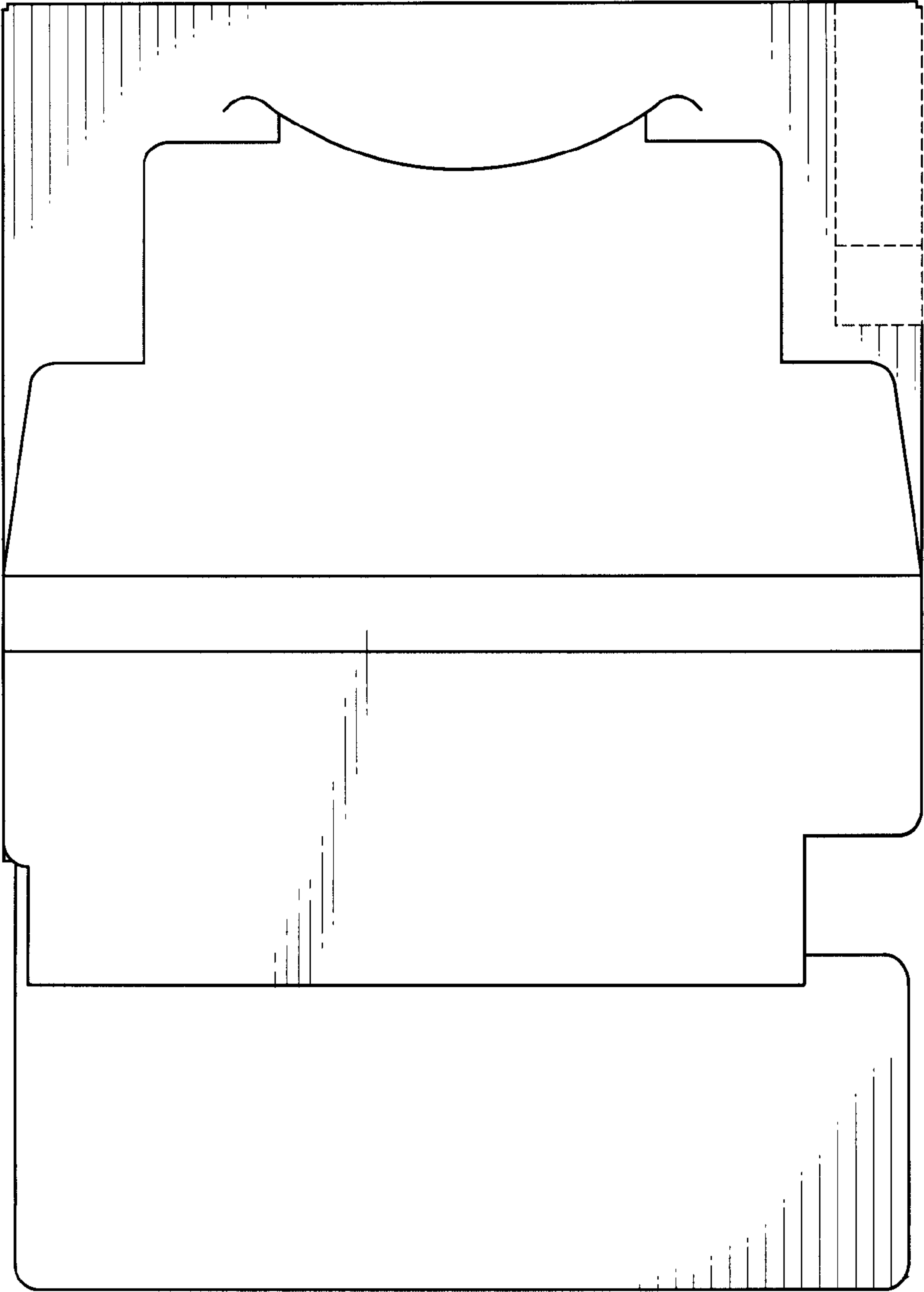
