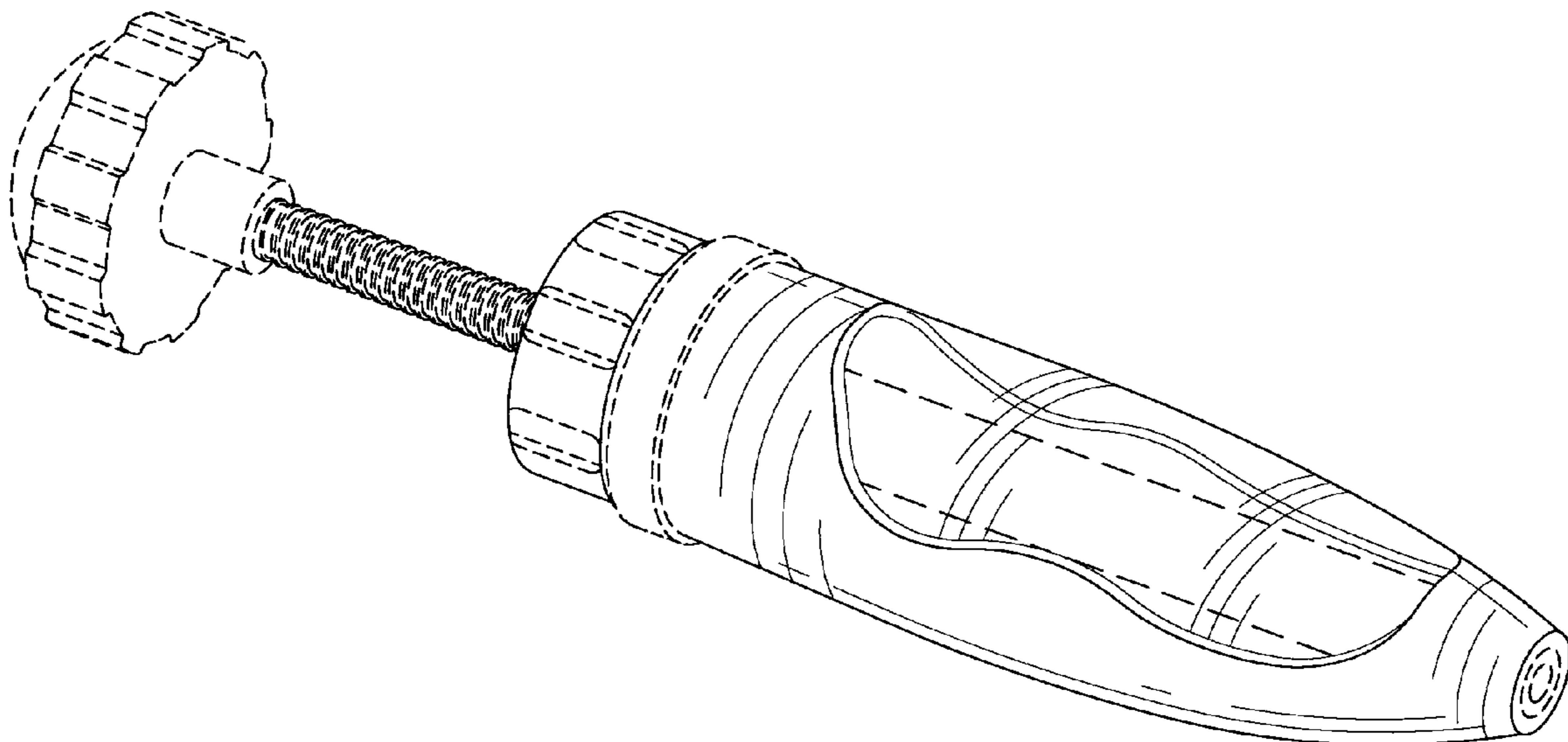
(57) **CLAIM**

The ornamental design for a bone cement dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bone cement dispenser in accordance with my design;
 FIG. 2 is a side view thereof, it being understood that the opposite side is a mirror image;

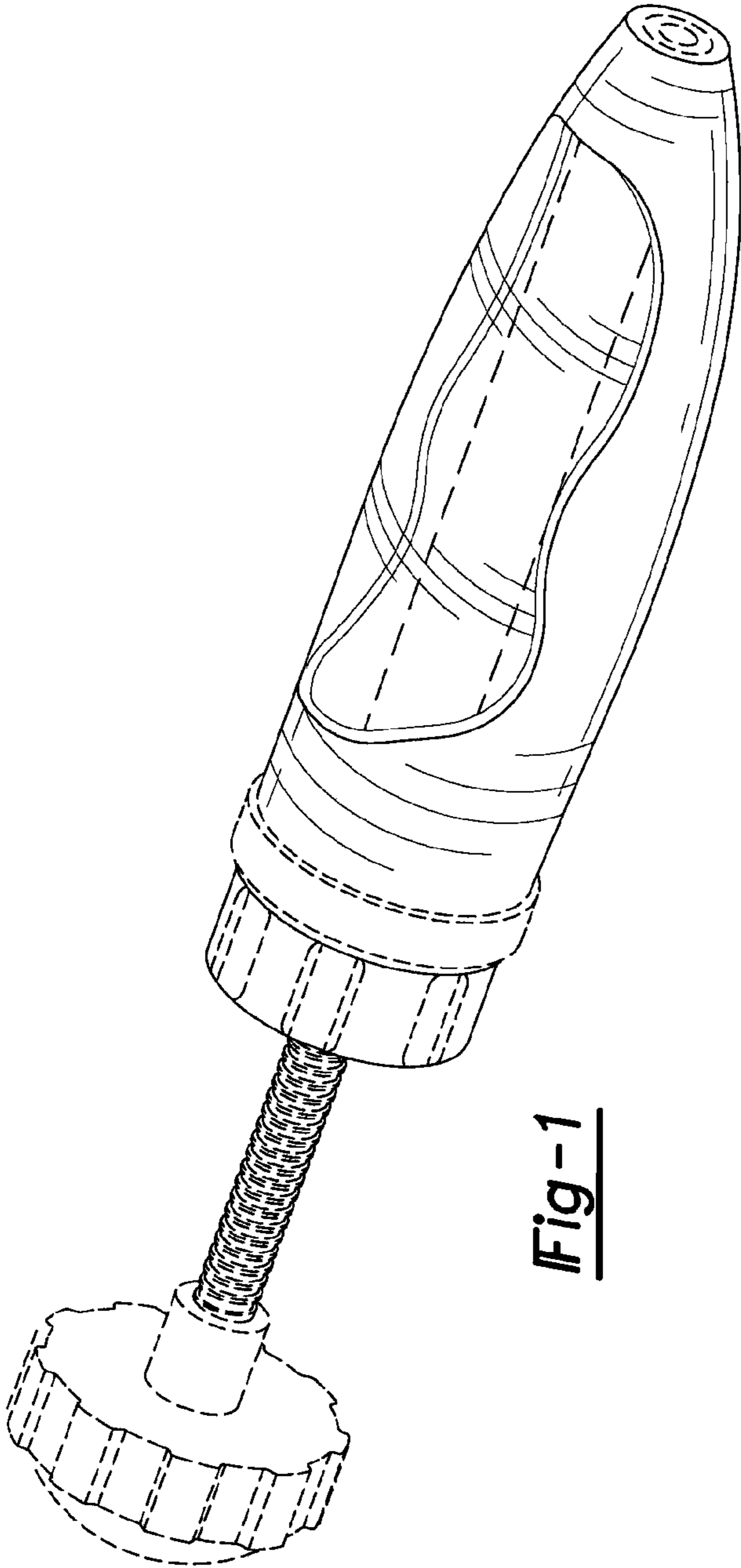

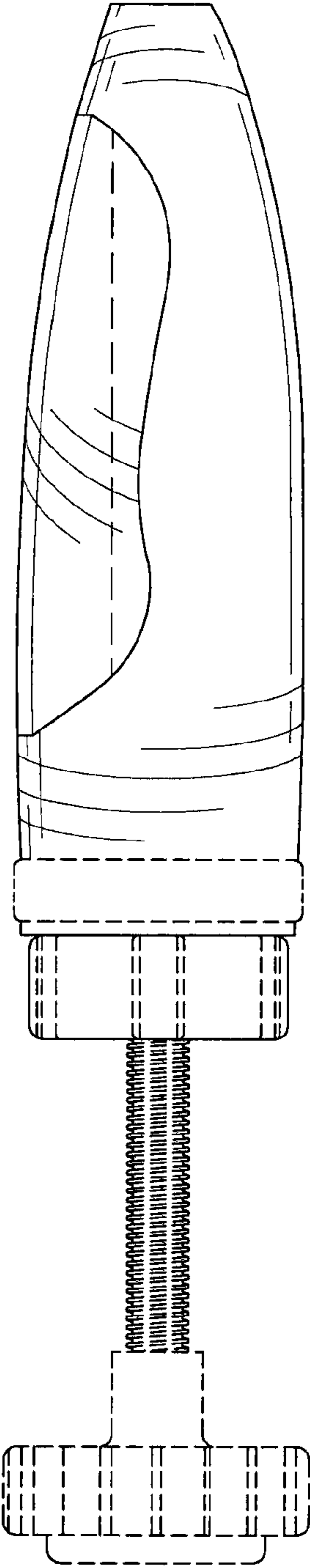

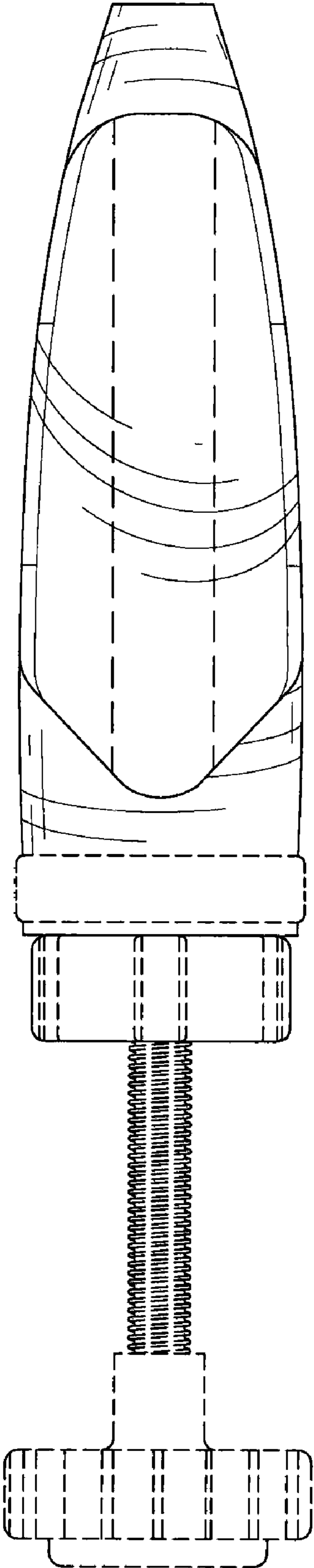

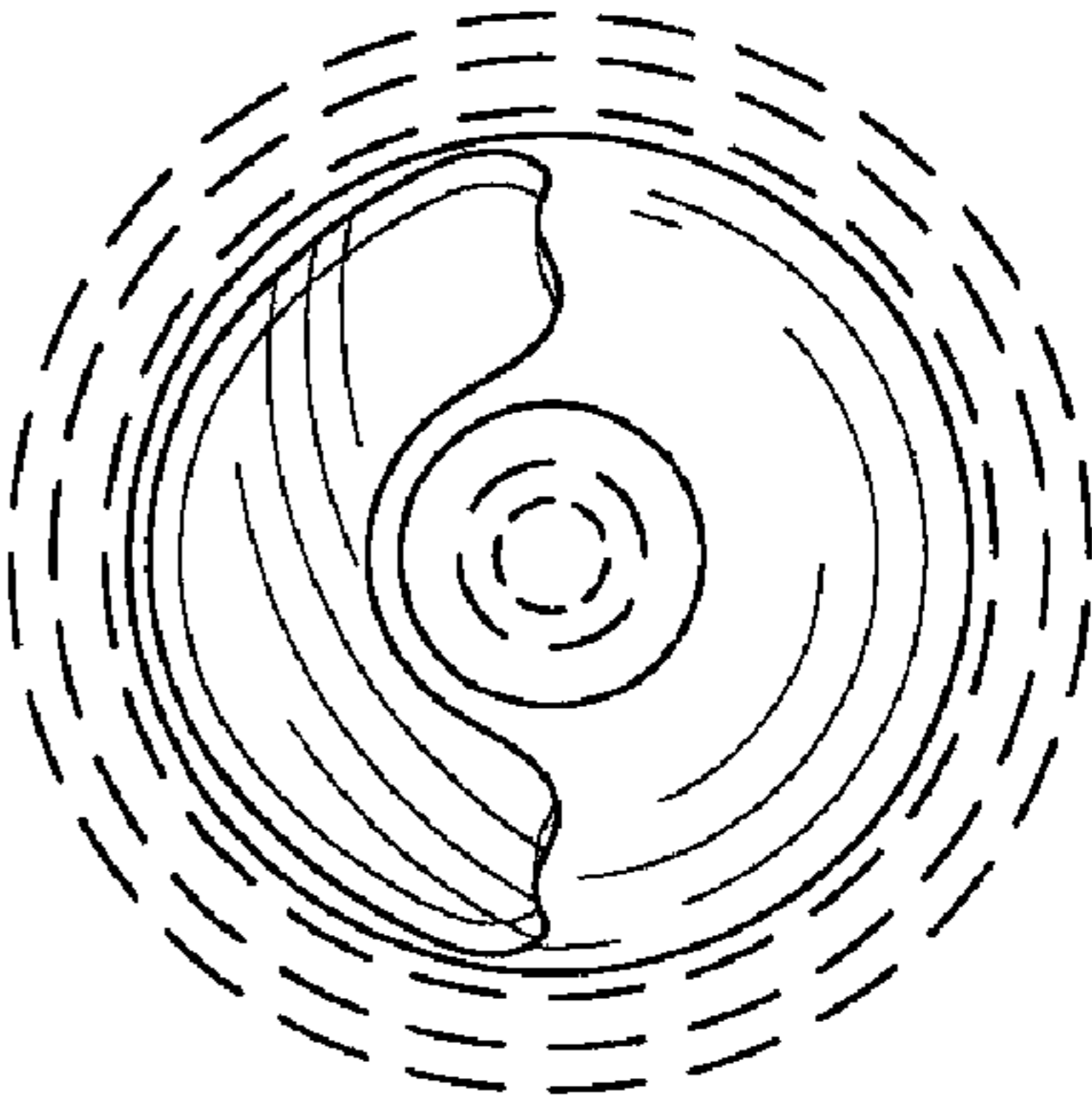

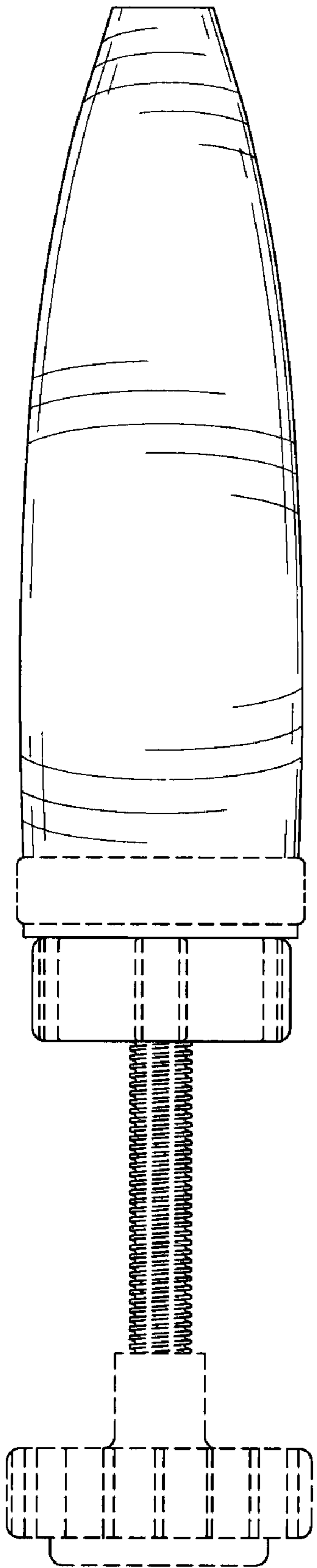

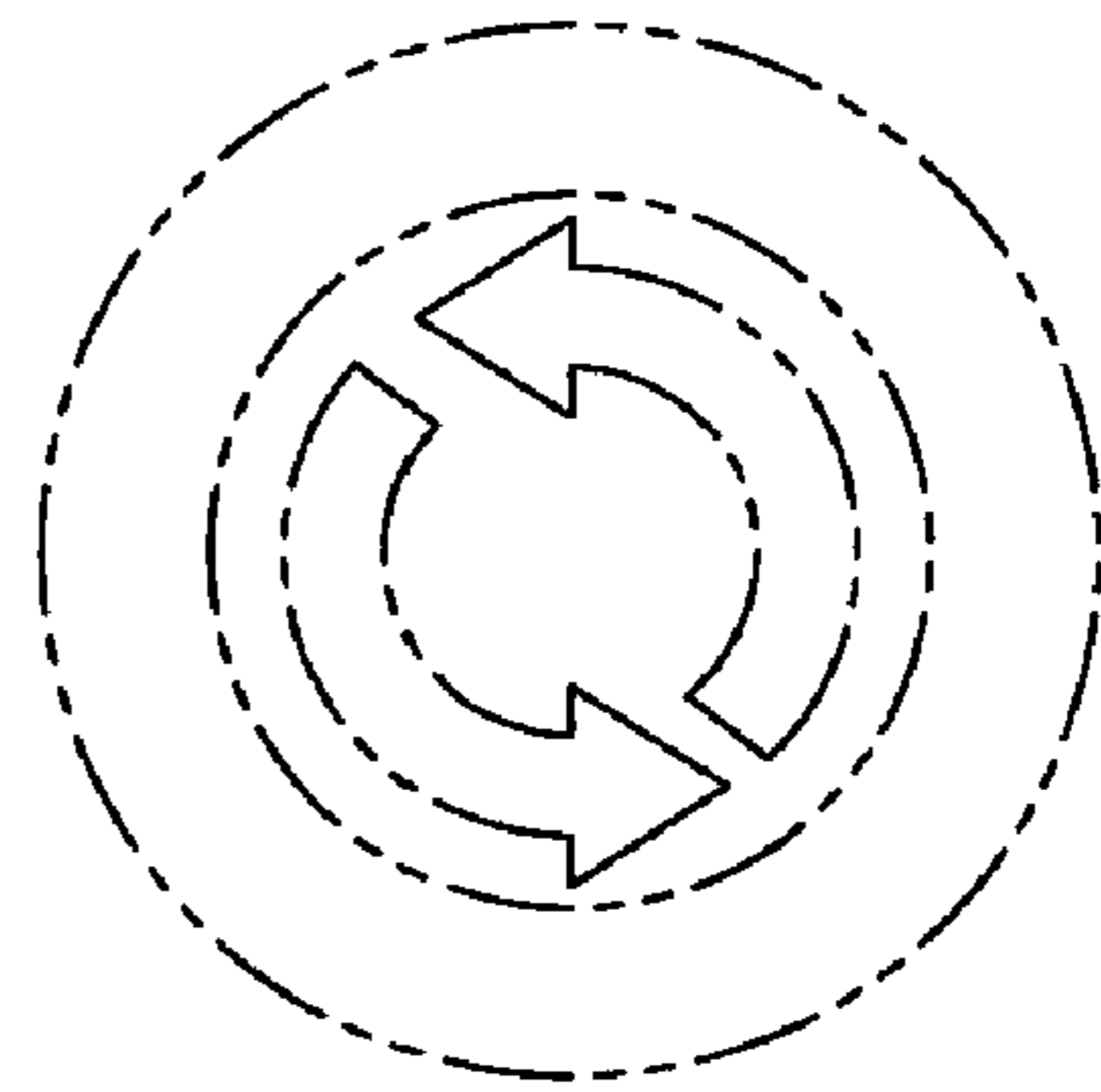
