The ornamental design for a scalpel, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged perspective view of a scalpel in accordance of the present design;

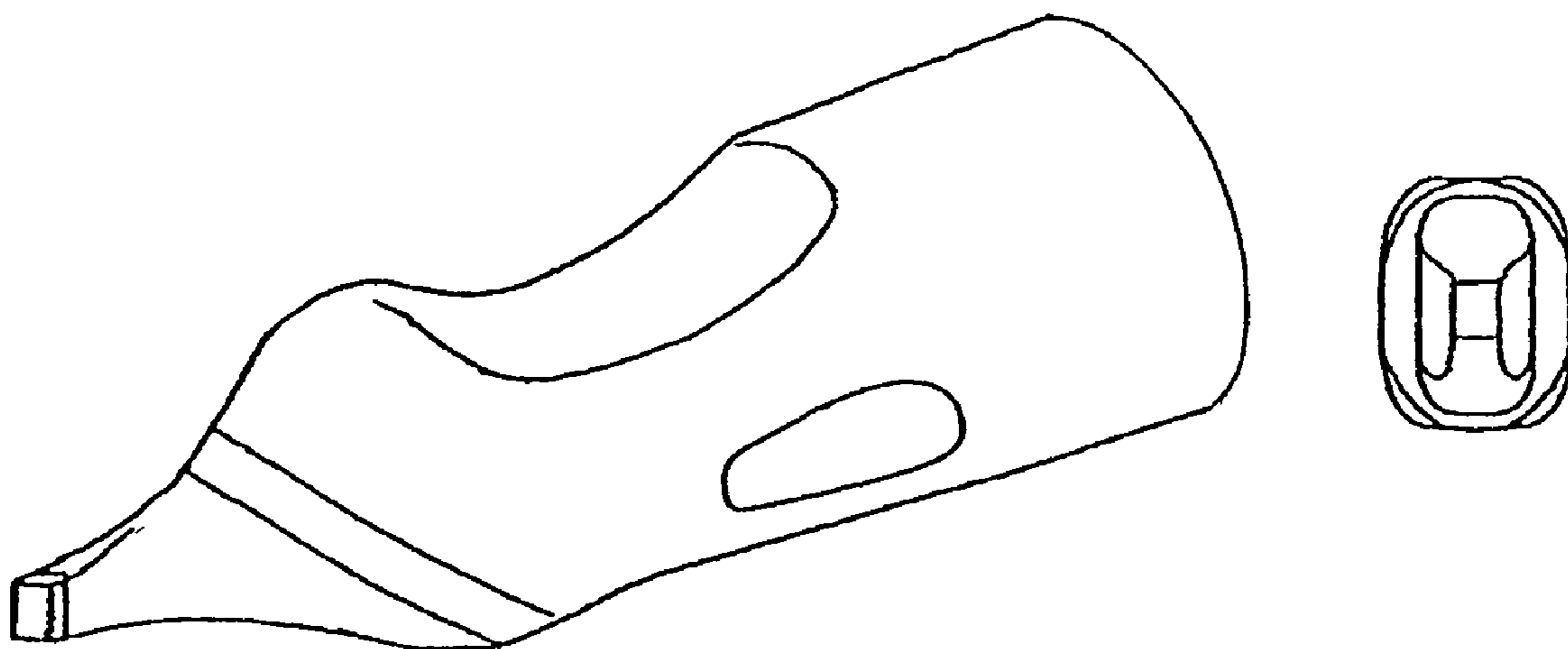

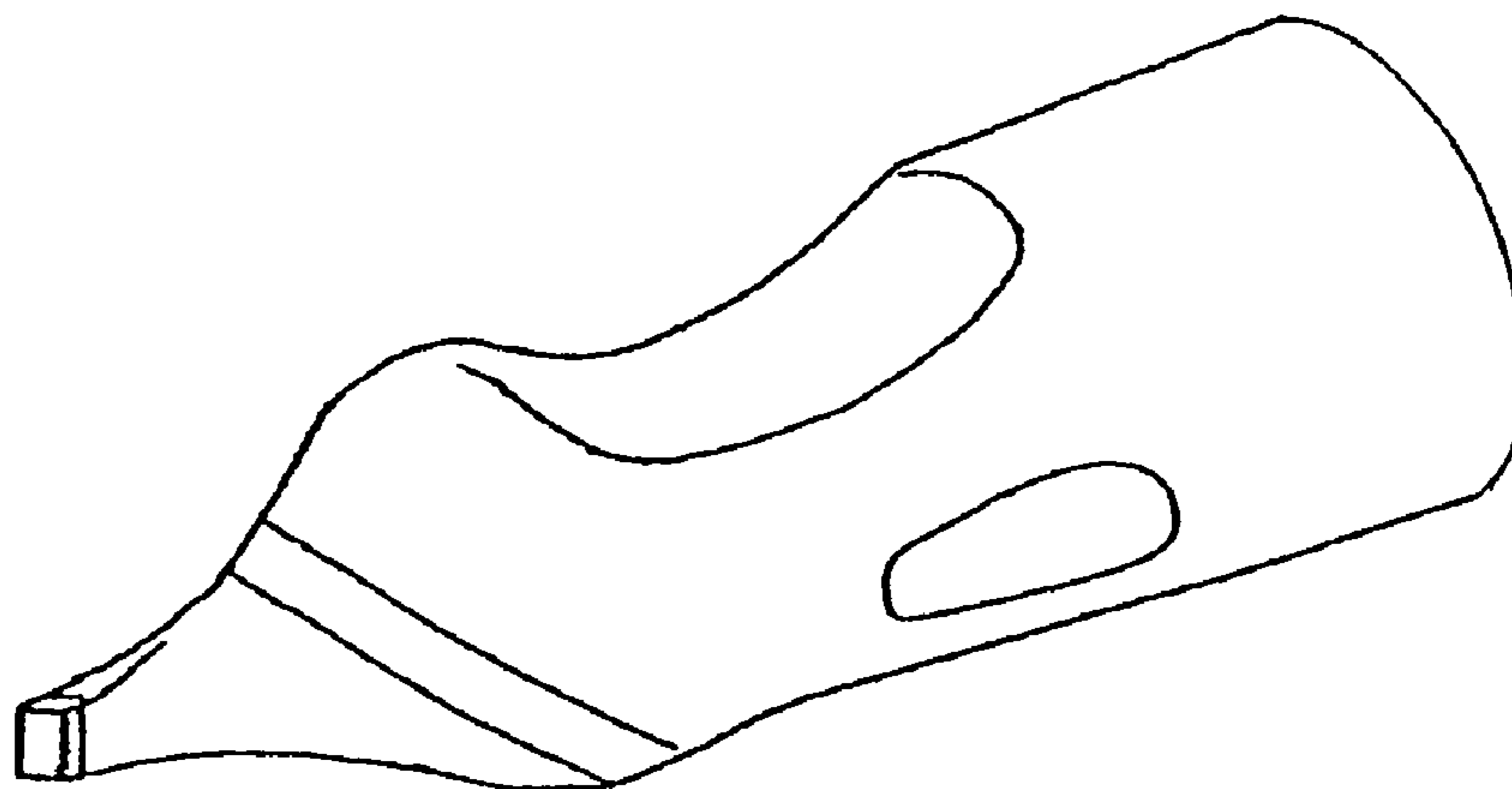

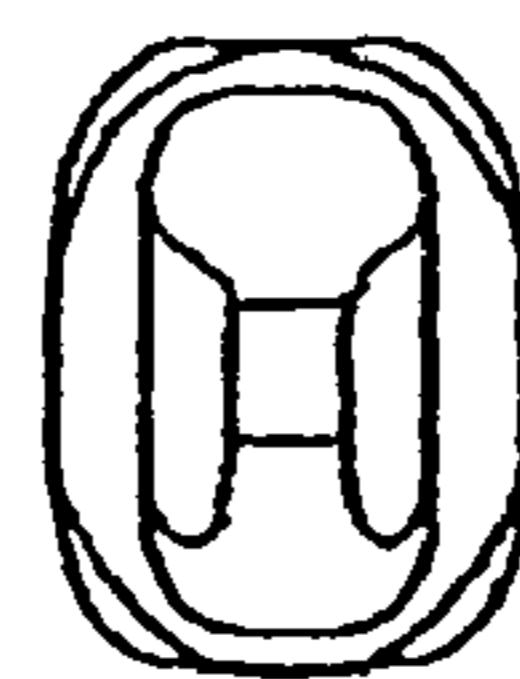
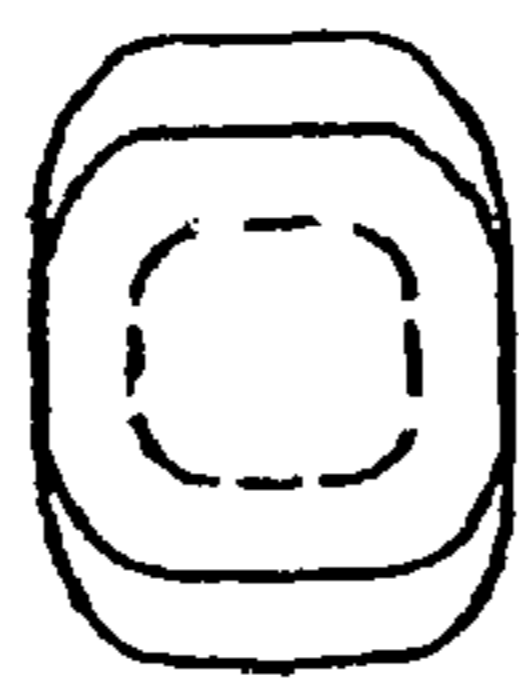

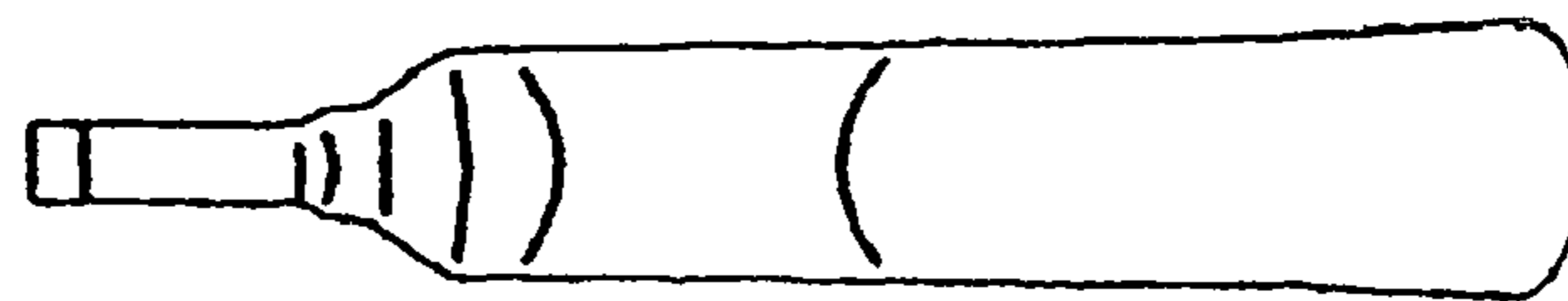
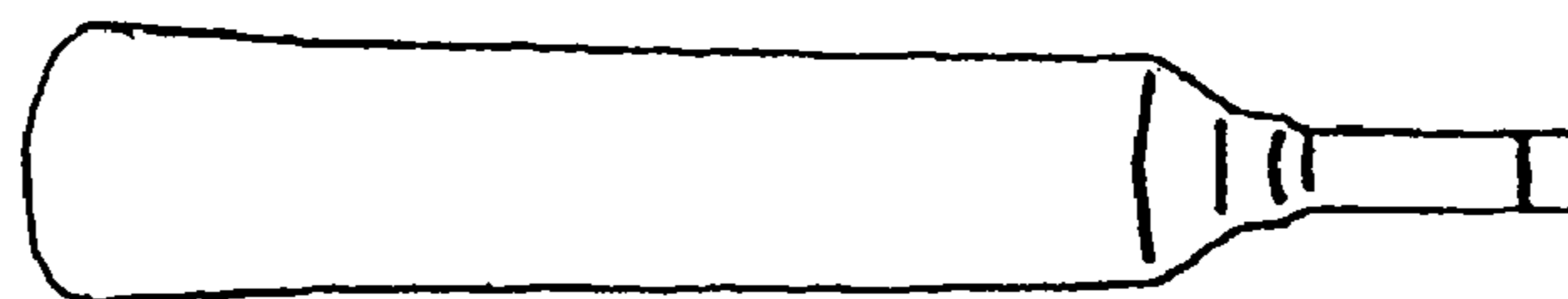
