FIG. 2 is a front view of the cervical wrap of FIG. 1;

FIG. 3 is a rear view of the cervical wrap of FIG. 1;

FIG. 4 is a top end view of the cervical wrap of FIG. 1;

FIG. 5 is a bottom end view of the cervical wrap of FIG. 1;

FIG. 6 is a right side view of the cervical wrap of FIG. 1;

FIG. 7 is a left side view of the cervical wrap of FIG. 1;

FIG. 8 is a perspective view of a second embodiment of a cervical wrap for maintaining electrodes adjacent neck for physical therapy;

FIG. 9 is a front view of the cervical wrap of FIG. 8; and,

FIG. 10 is a rear view of the cervical wrap of FIG. 8.

The top end view, bottom end view, right side view and left side view of the cervical wrap of FIG. 8 are shown in FIGS. 4, 5, 6 and 7 respectively, identified above.

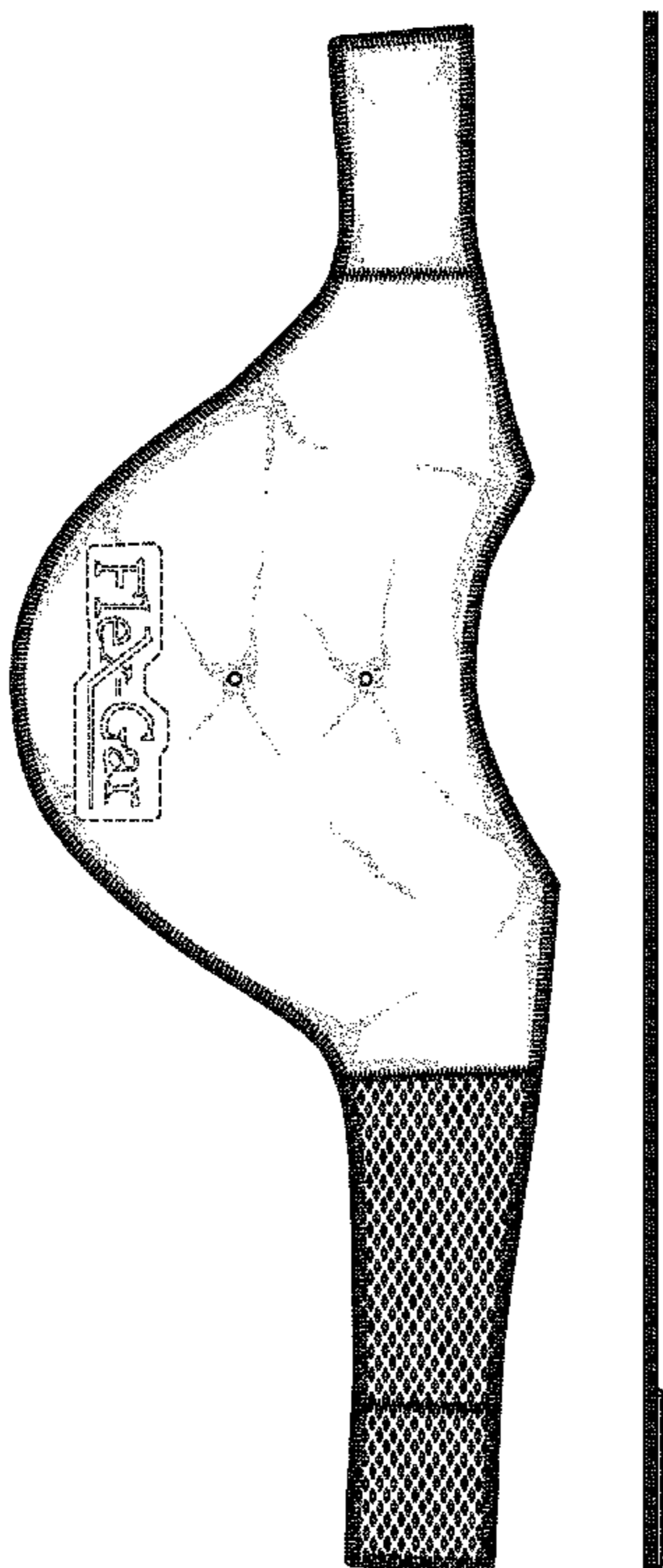
The broken lines illustrate portions of the cervical wrap which form no part of the claimed design.

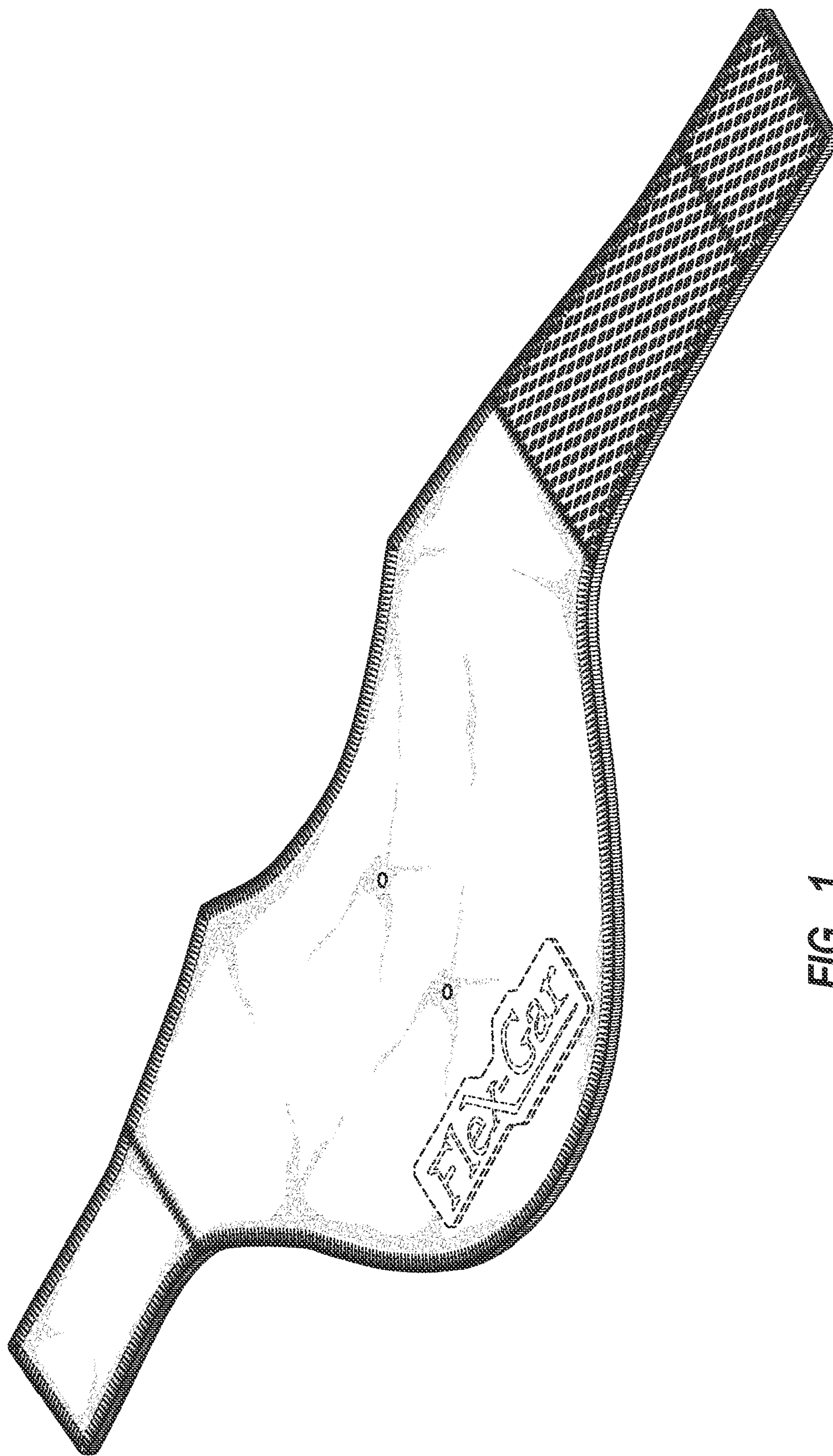

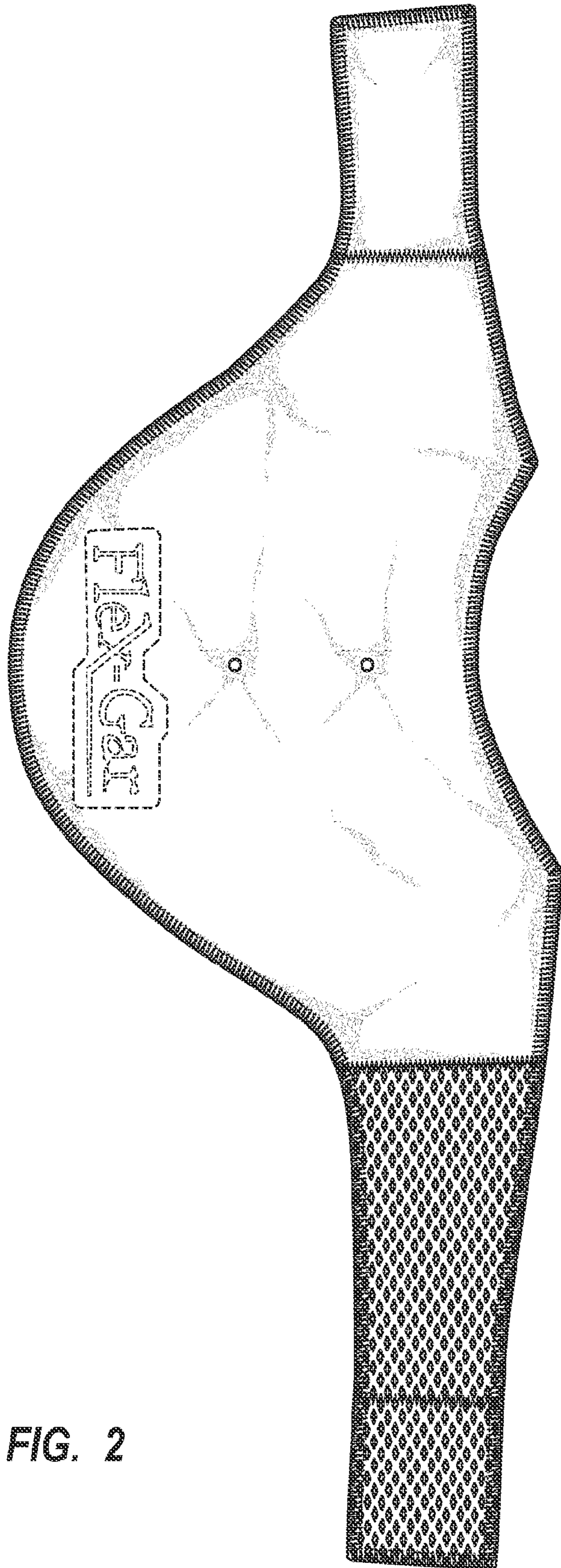

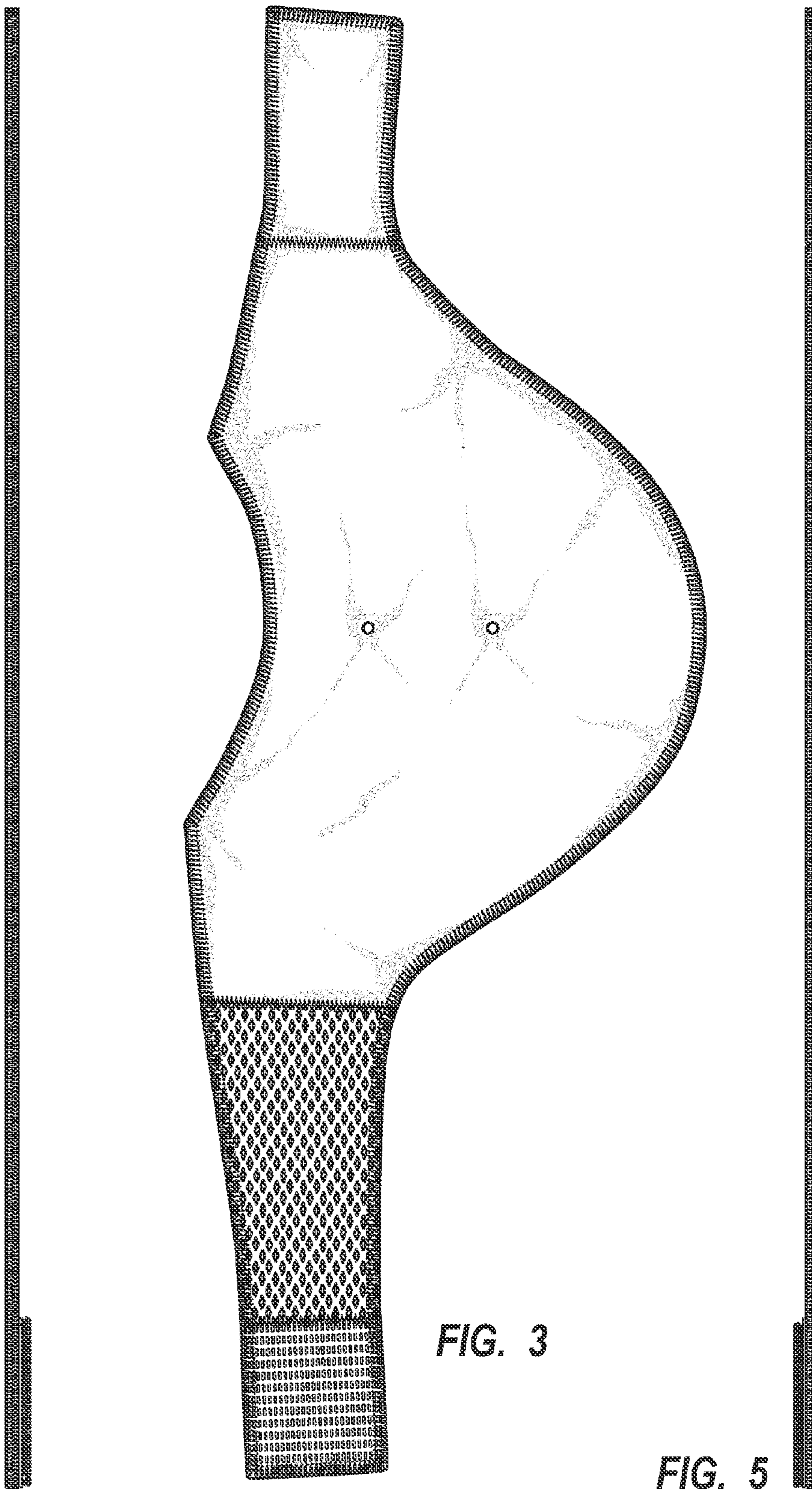

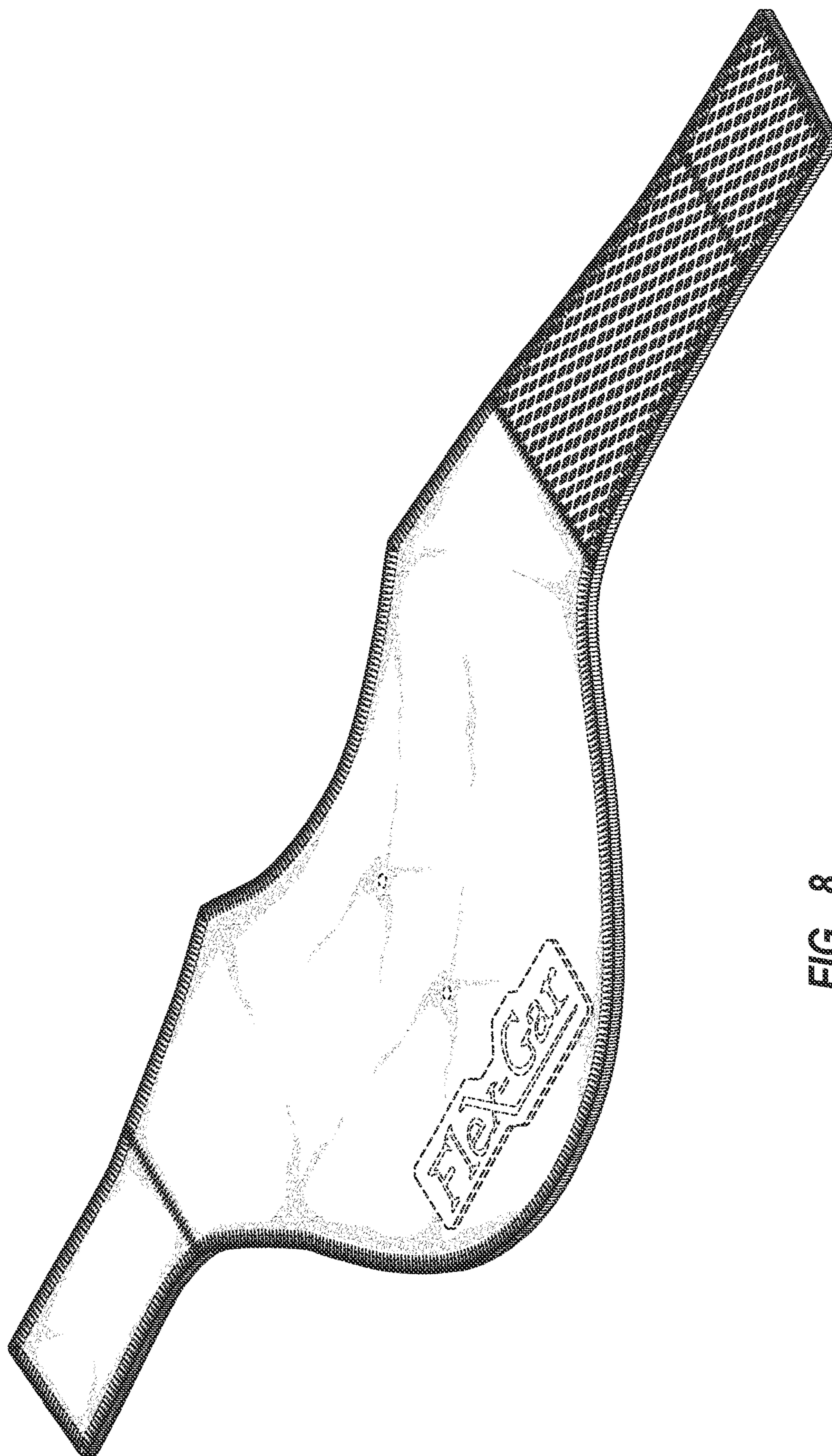

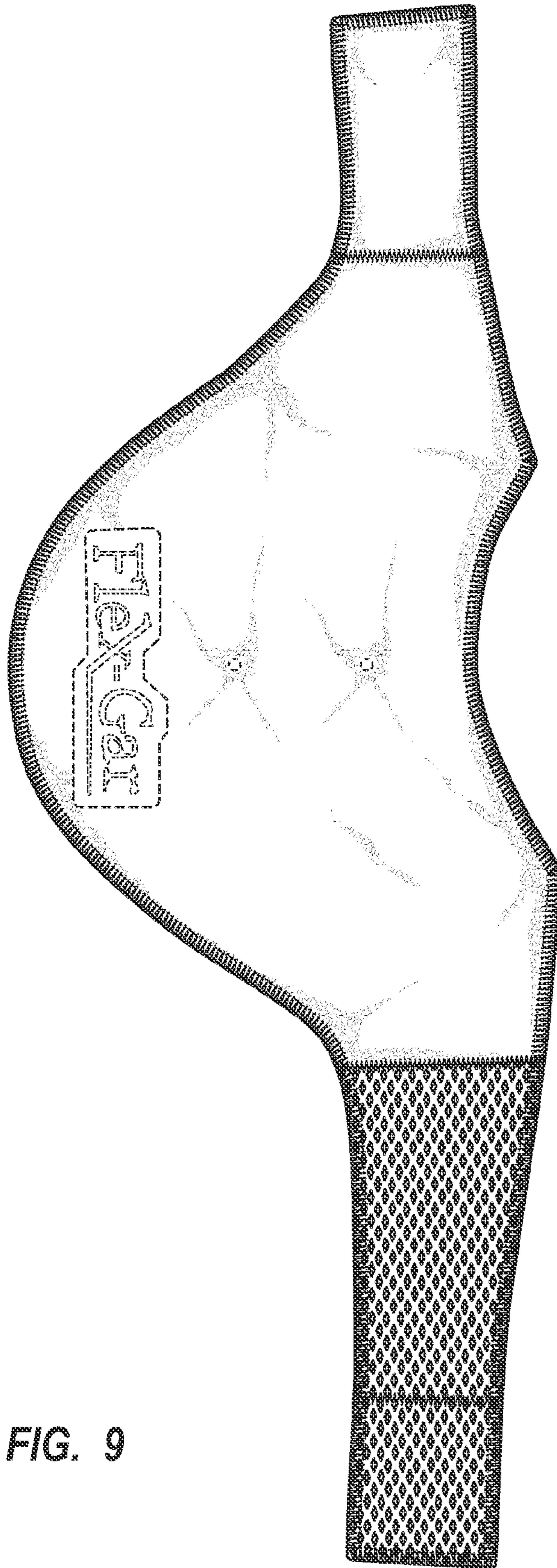

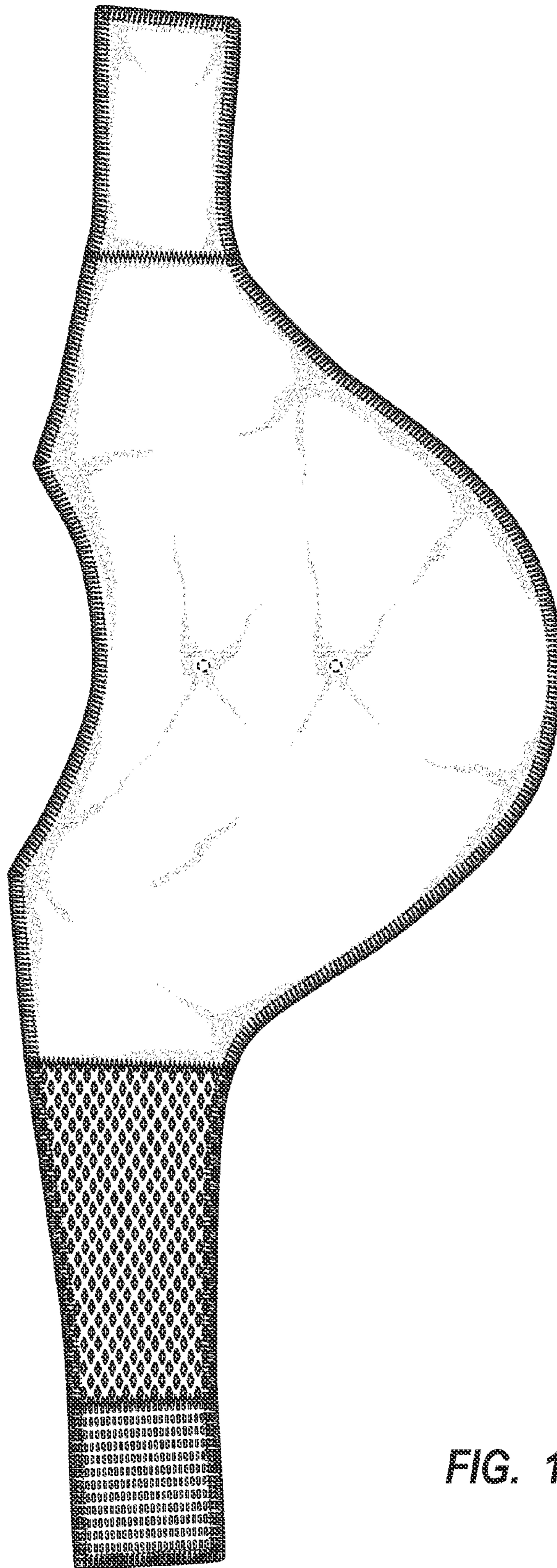
