(57) **CLAIM**

I claim the ornamental design for a pipette hand portion, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a pipette hand portion showing my new design;

FIG. 2 is a top view of the pipette hand portion shown in FIG. 1;

FIG. 3 is a bottom view of the pipette hand portion shown in FIG. 1;

FIG. 4 is a front view of the pipette hand portion shown in FIG. 1;

FIG. 5 is a back view of the pipette hand portion shown in FIG. 1;

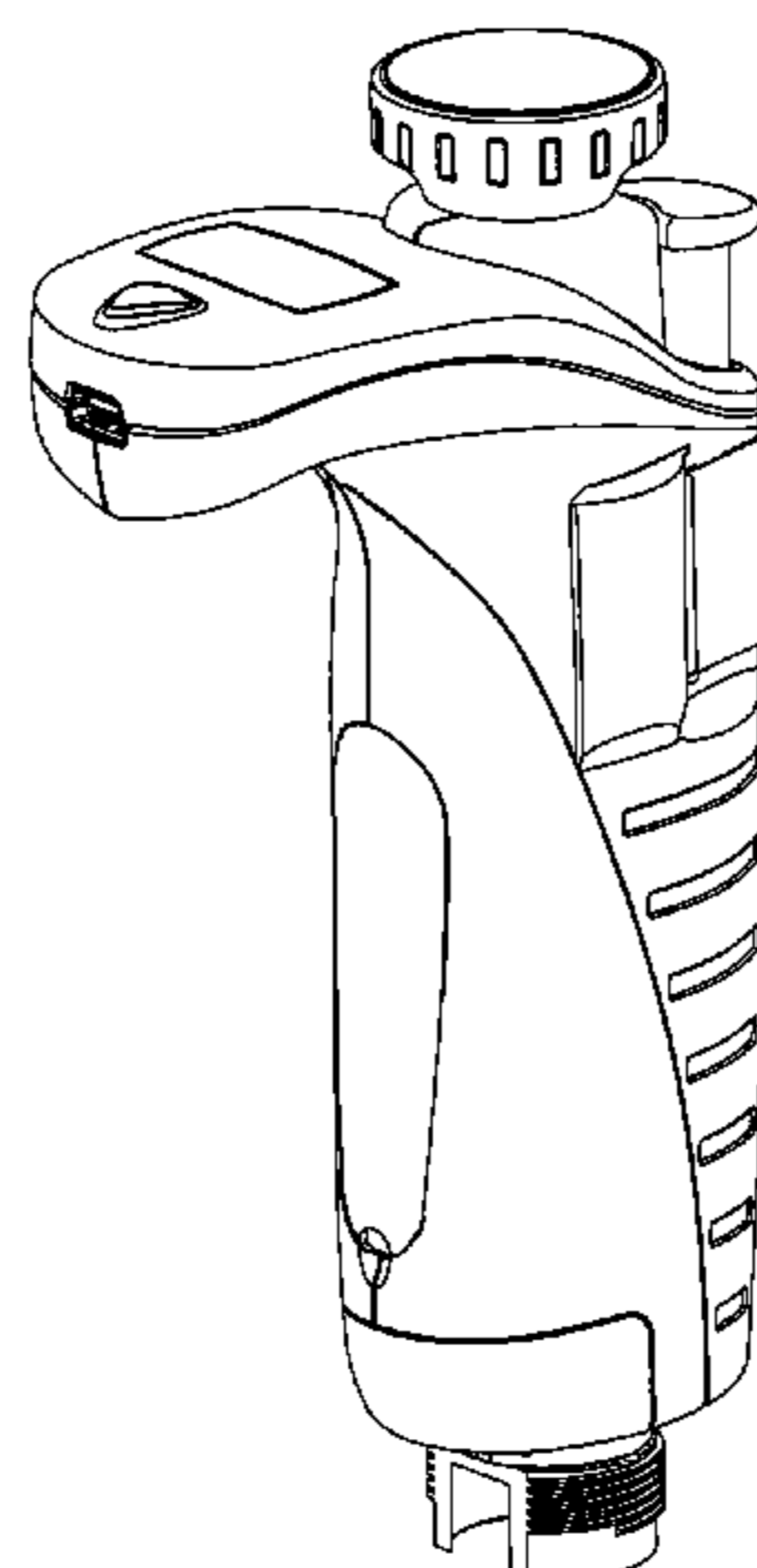
FIG. 6 is a right side view of the pipette hand portion shown in FIG. 1;

FIG. 7 is a left side view of the pipette hand portion shown in FIG. 1; and,

FIG. 8 is a top perspective view of the pipette hand portion of FIG. 1 shown in its environment.

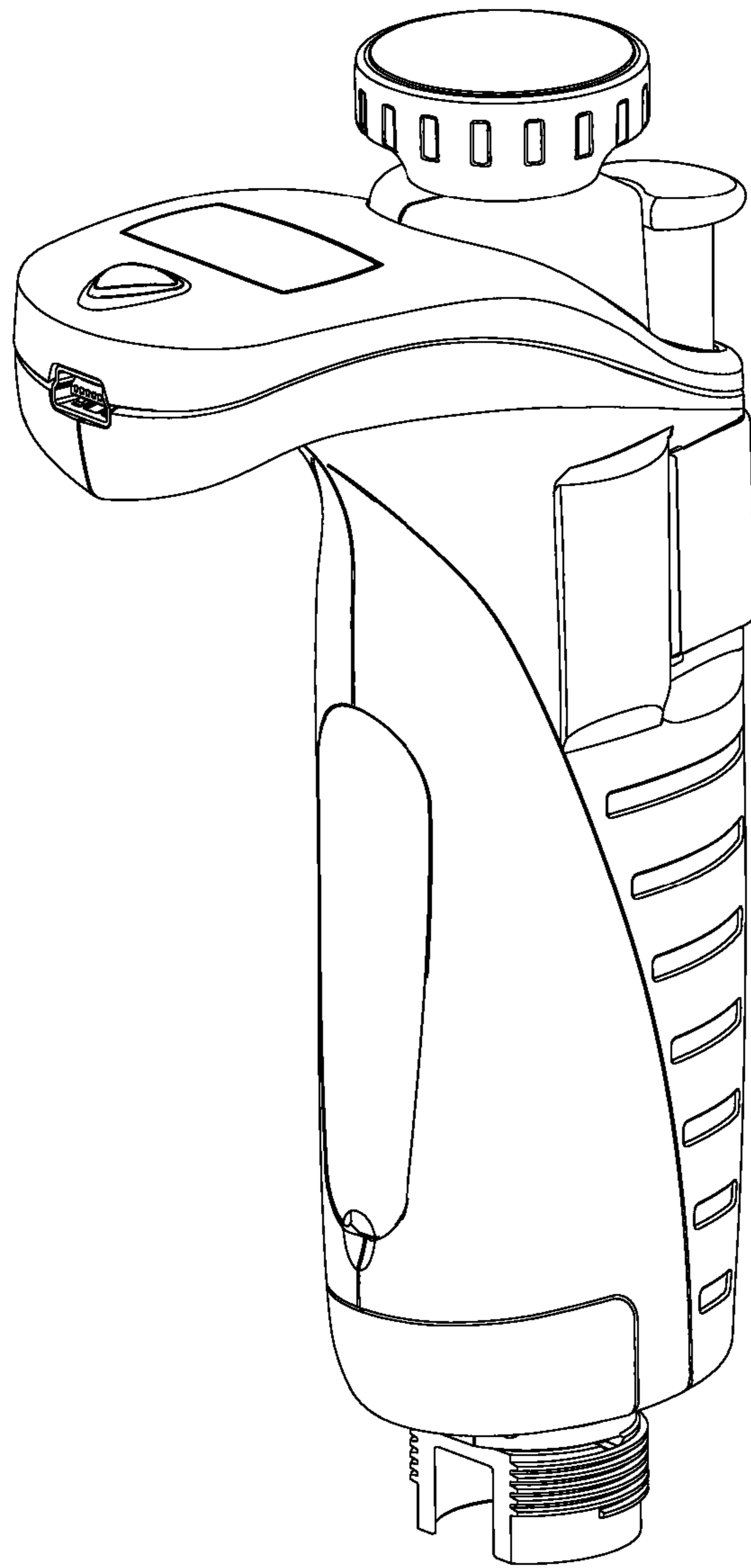
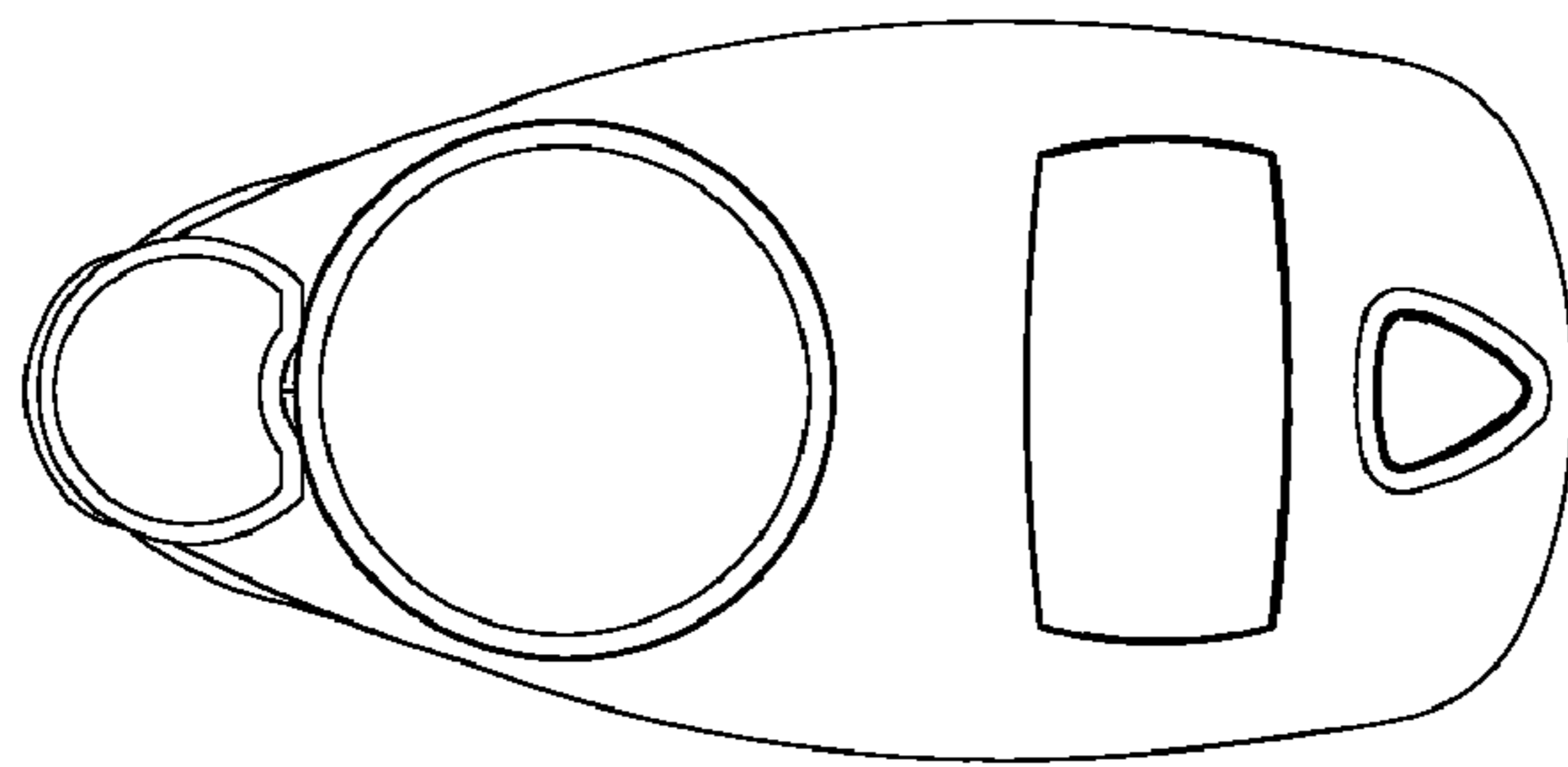
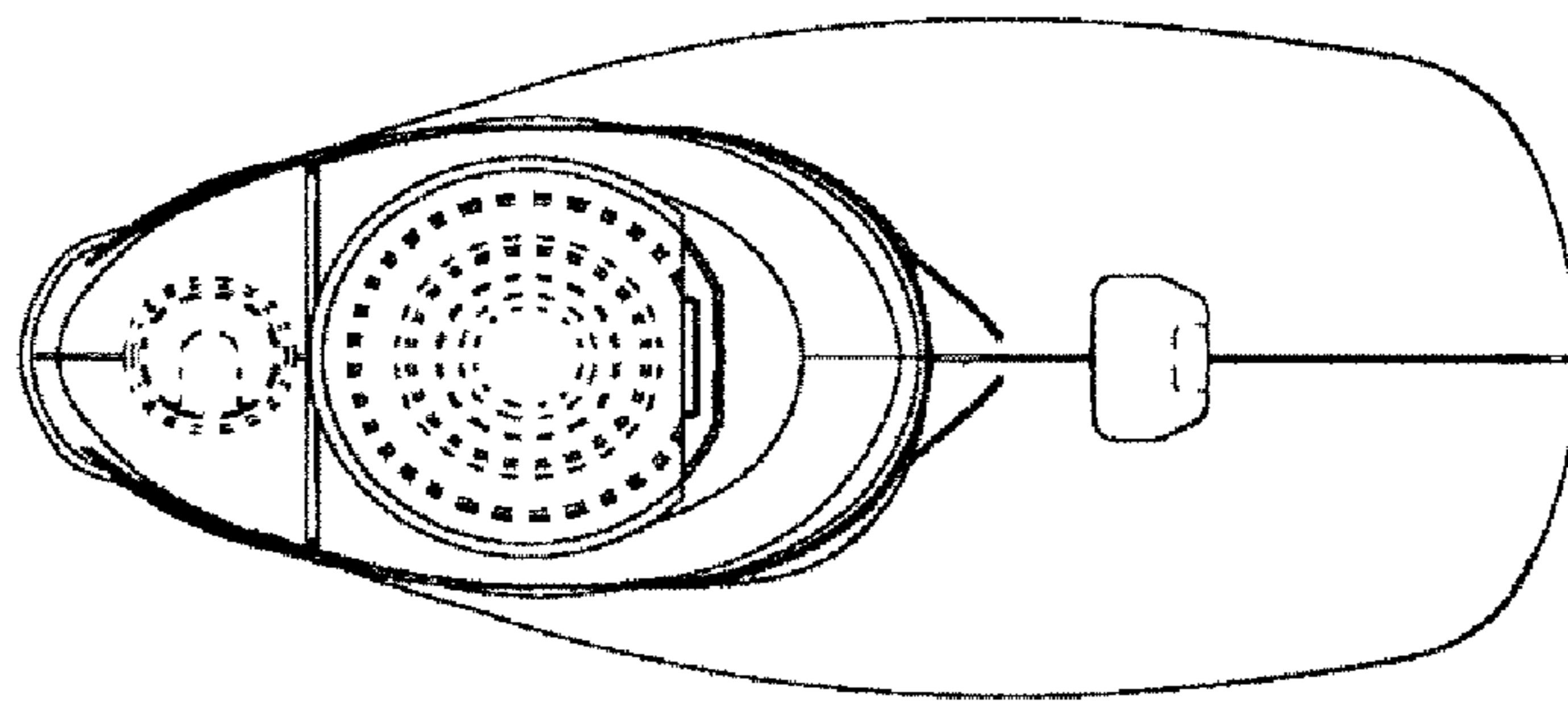


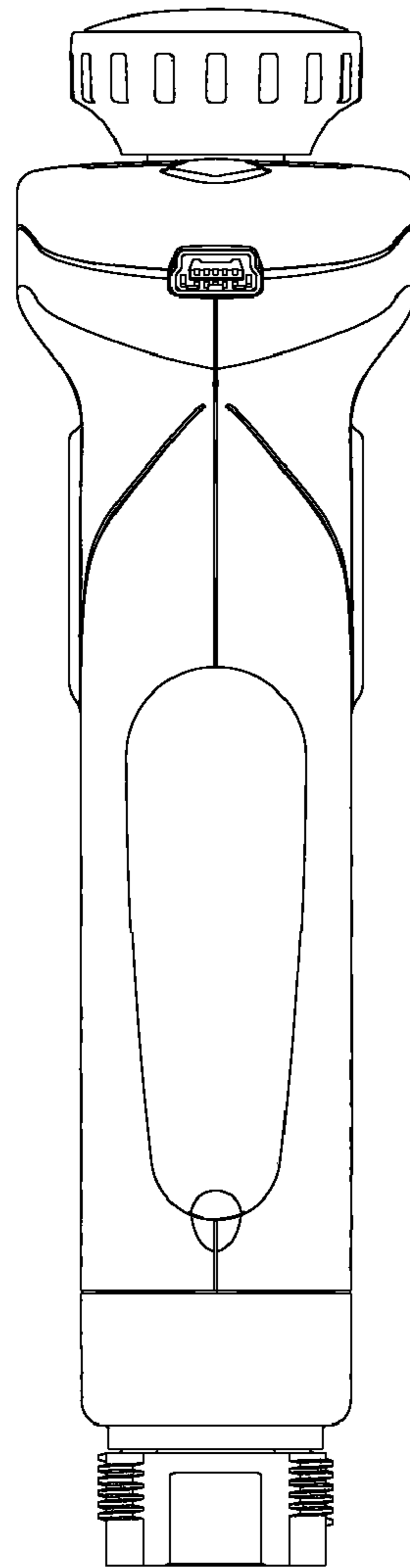

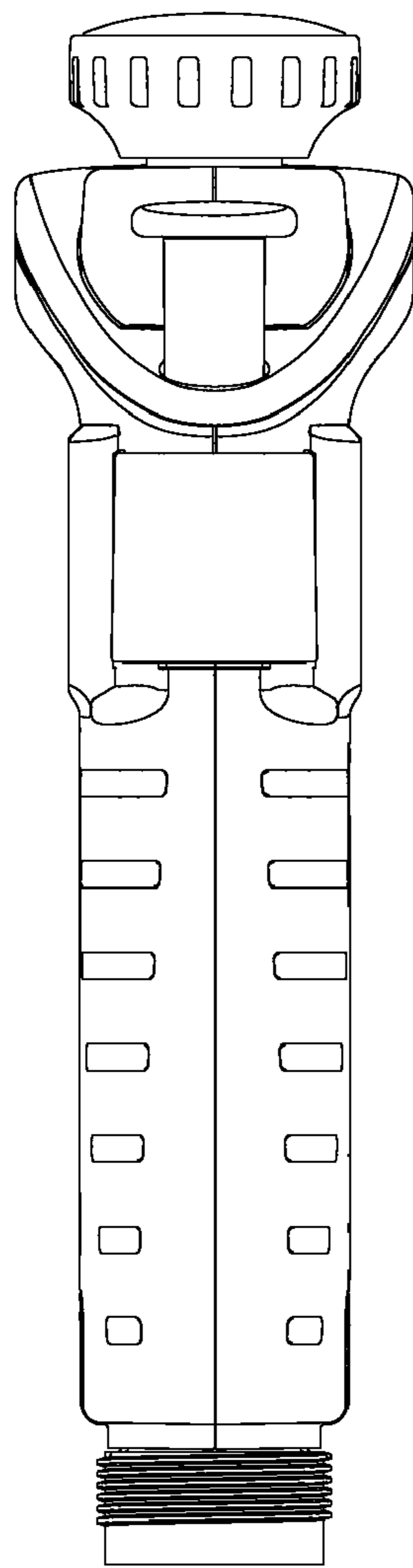

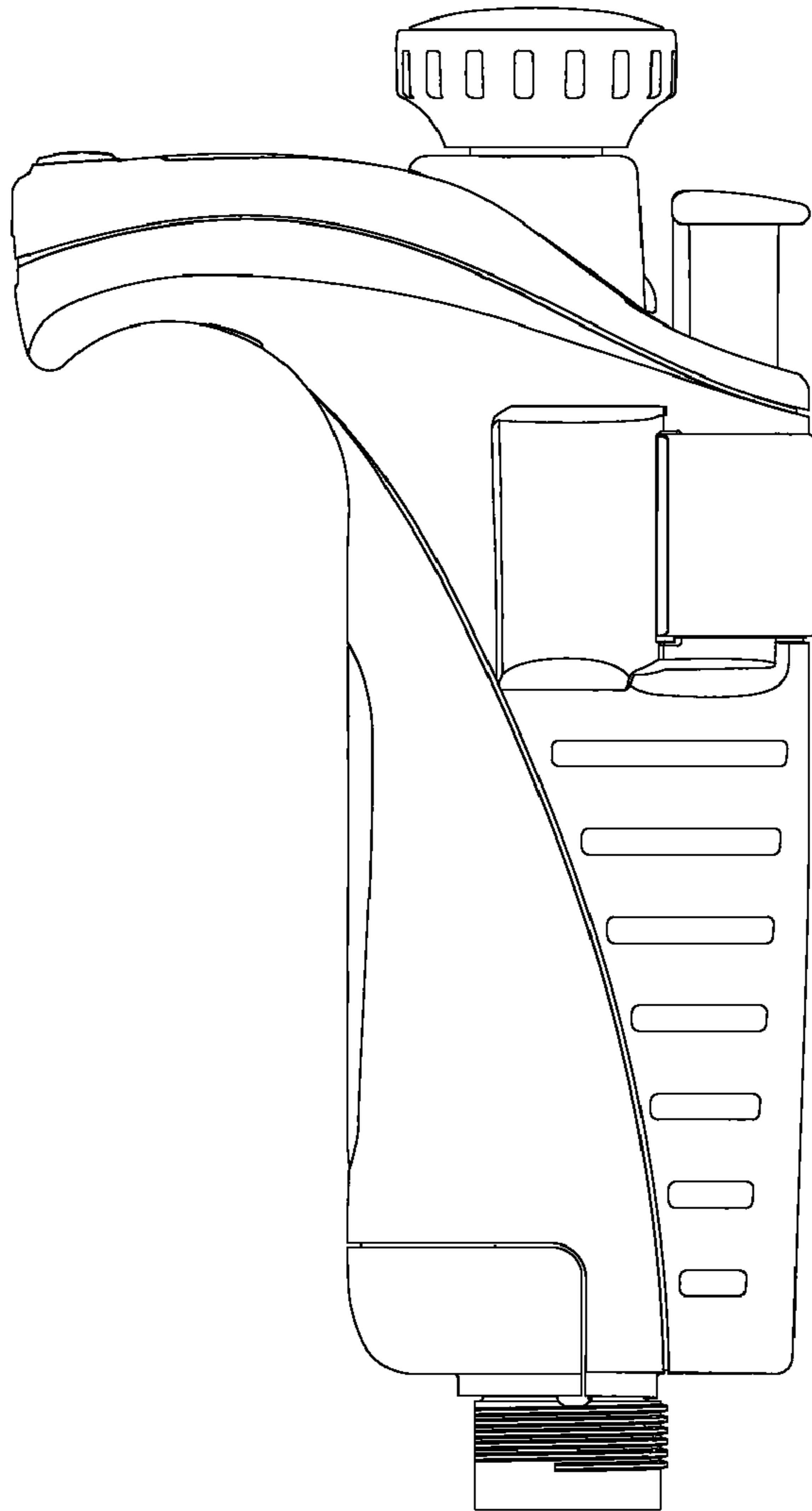

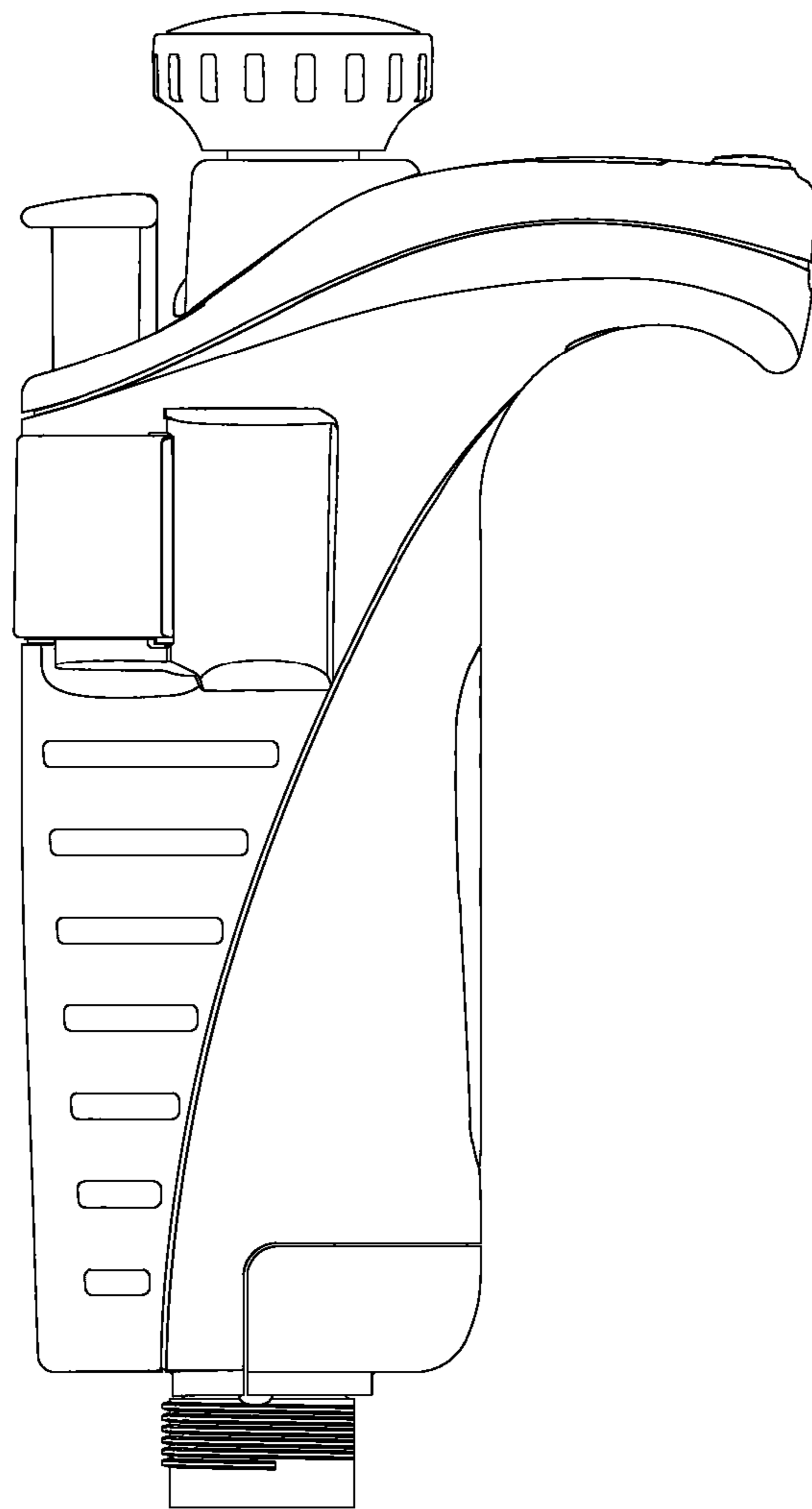

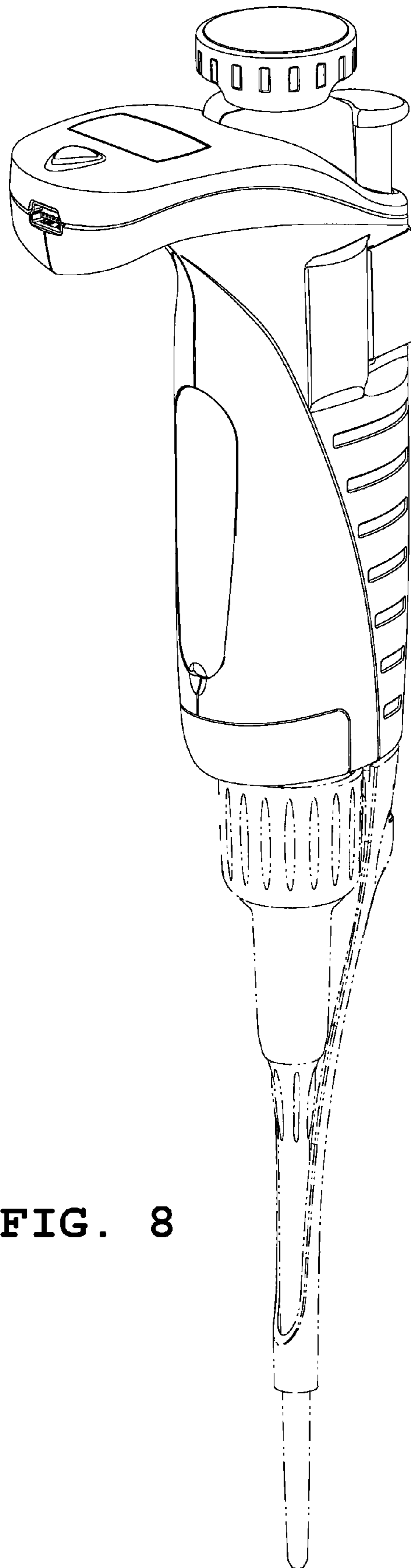
