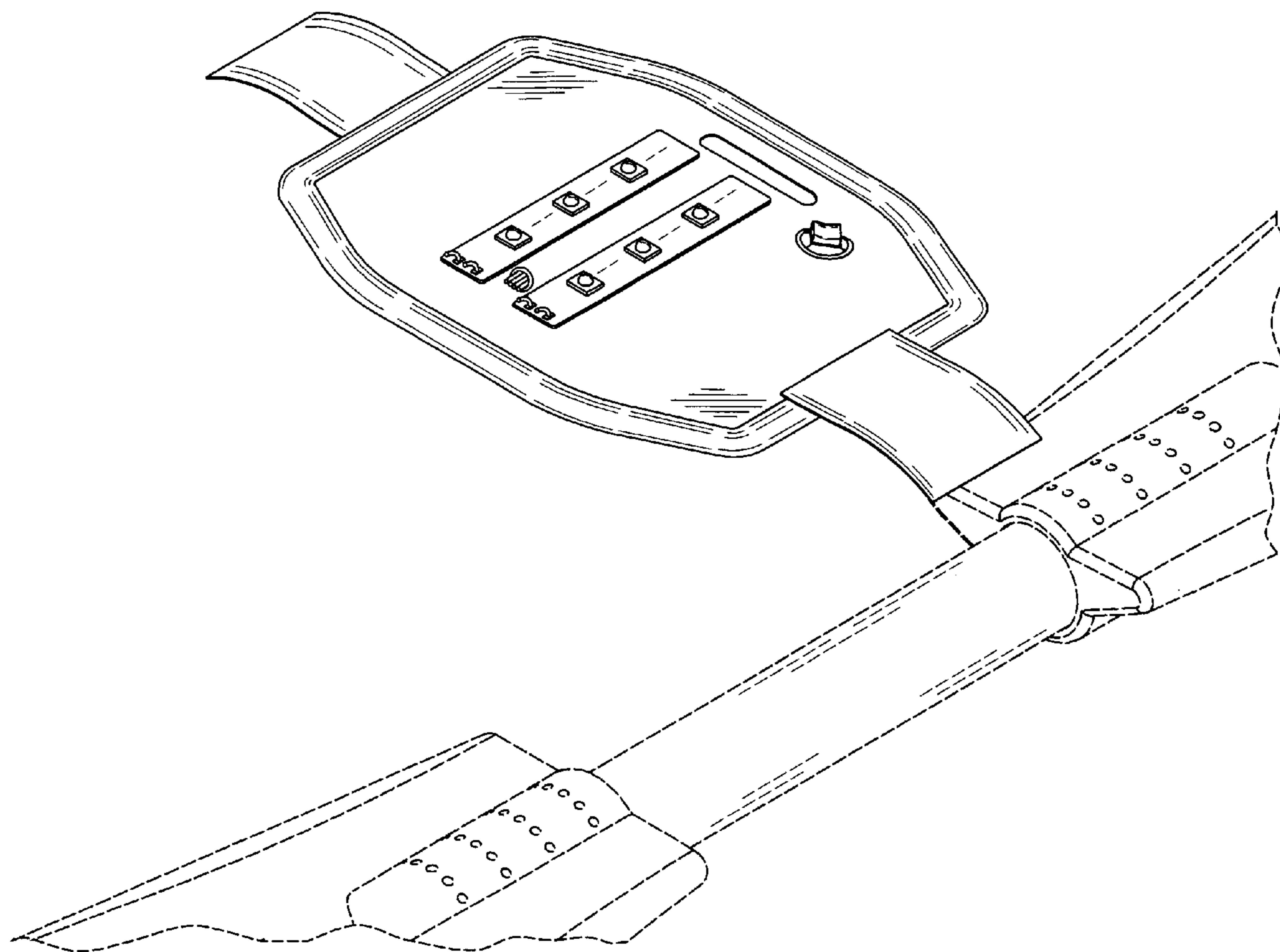
The broken line showing of fragmented skateboard is included for the purpose of illustrating and forms no part of the claimed design.

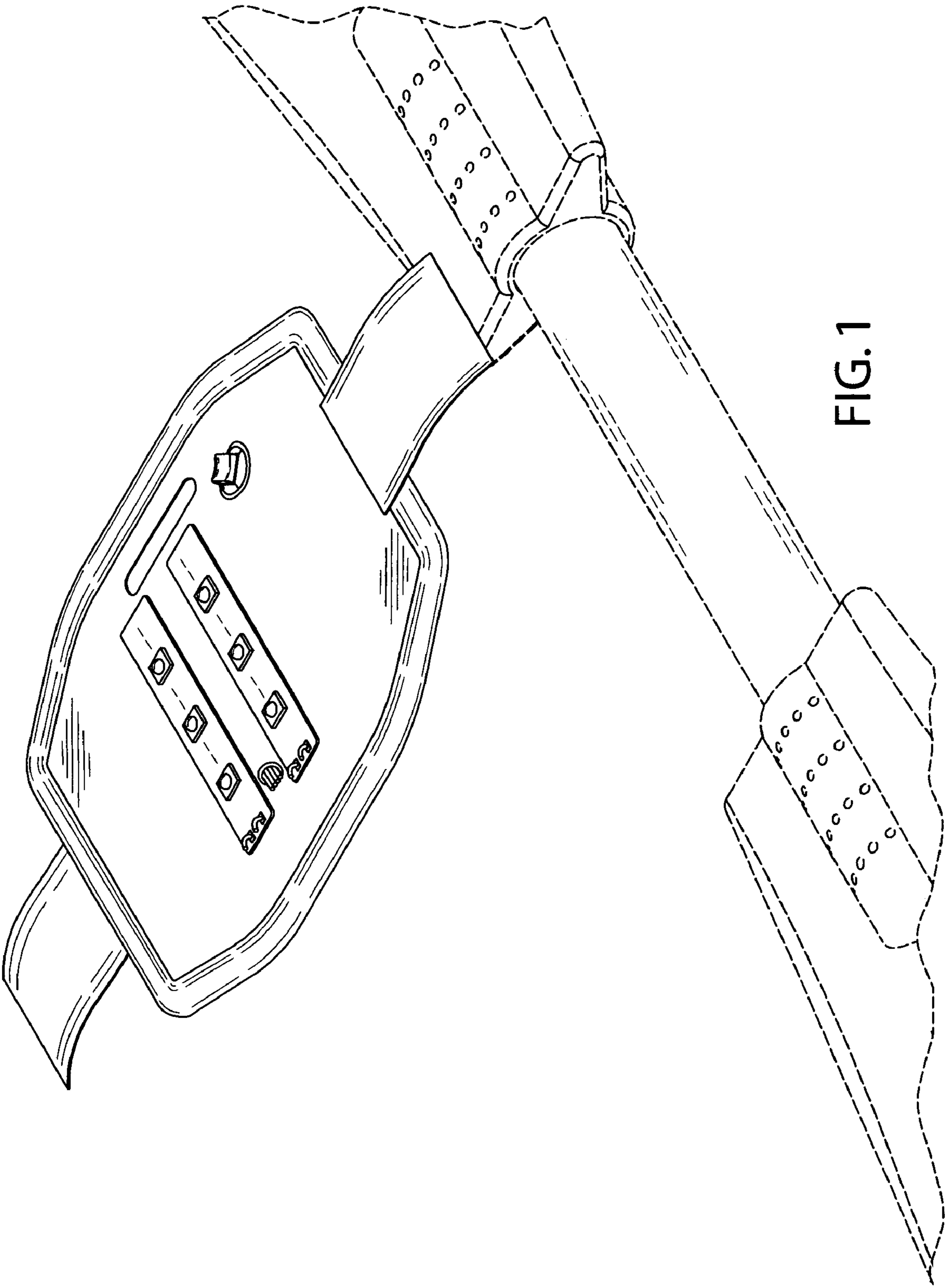

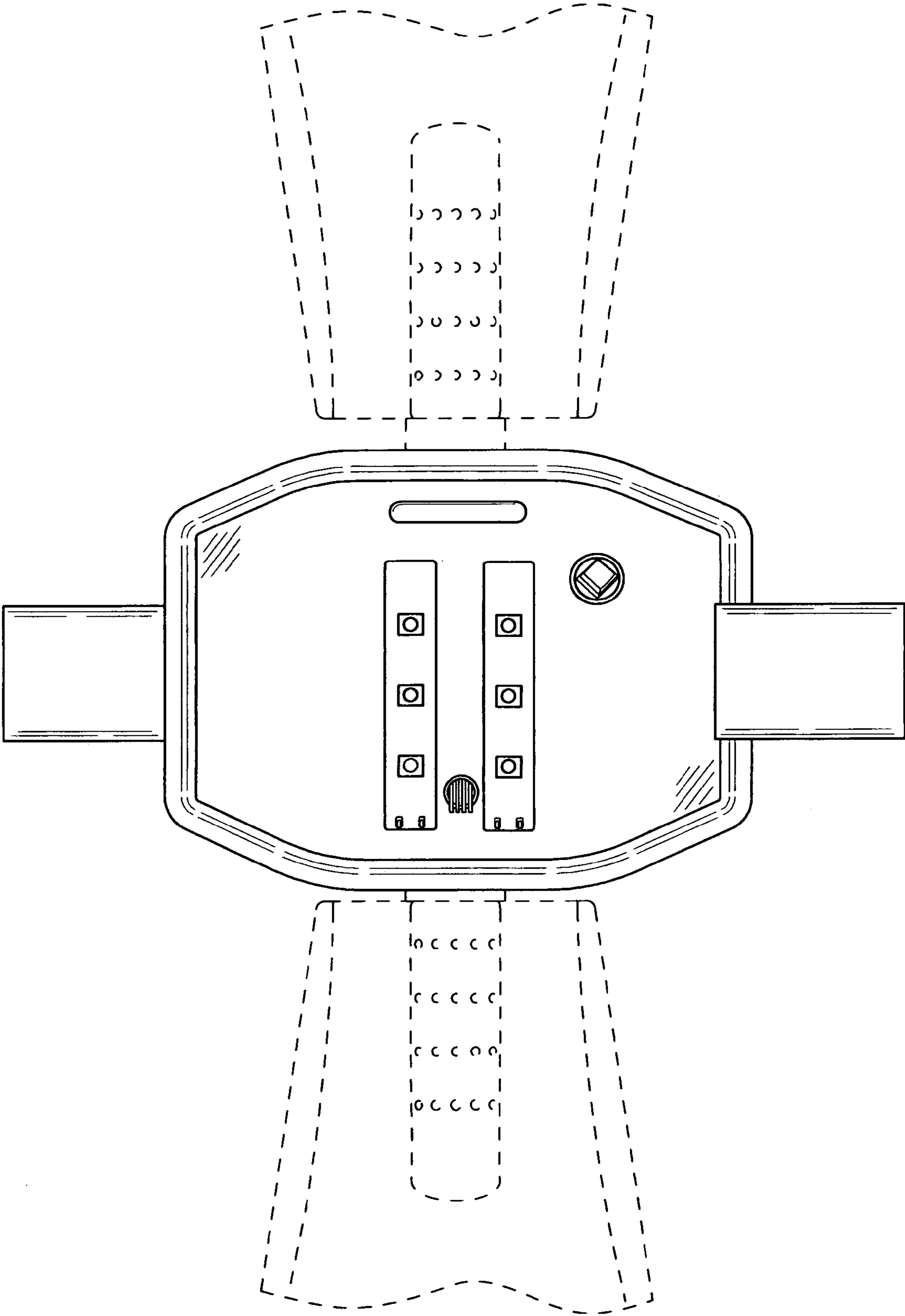

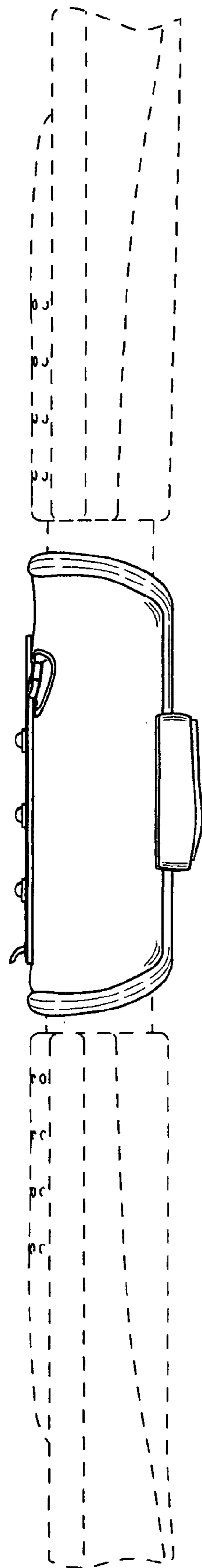
