FIG. 10 is a bottom view of the second embodiment of the dispenser.

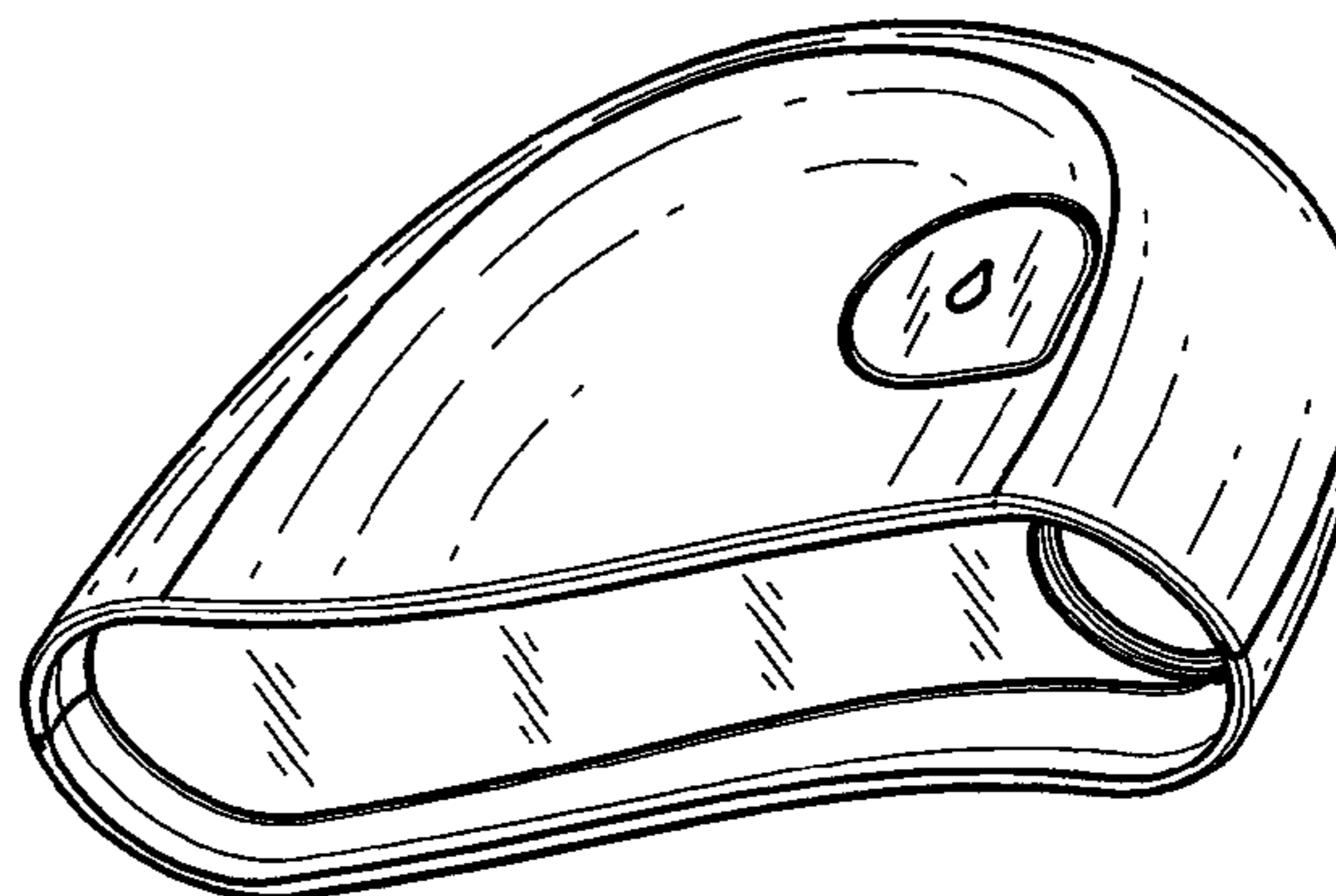
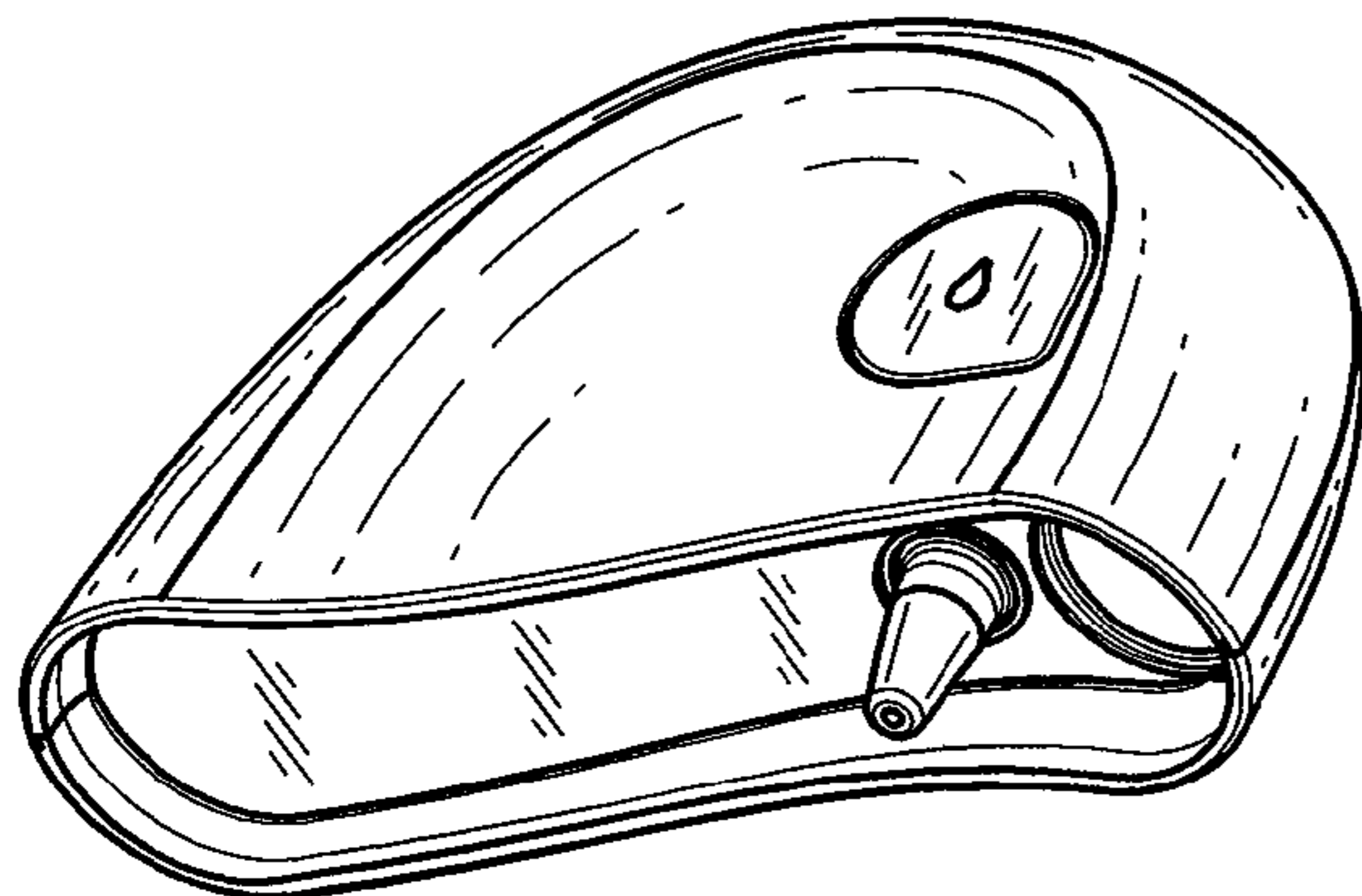
FIG. 11 is a front elevational view of the second embodiment of the dispenser.

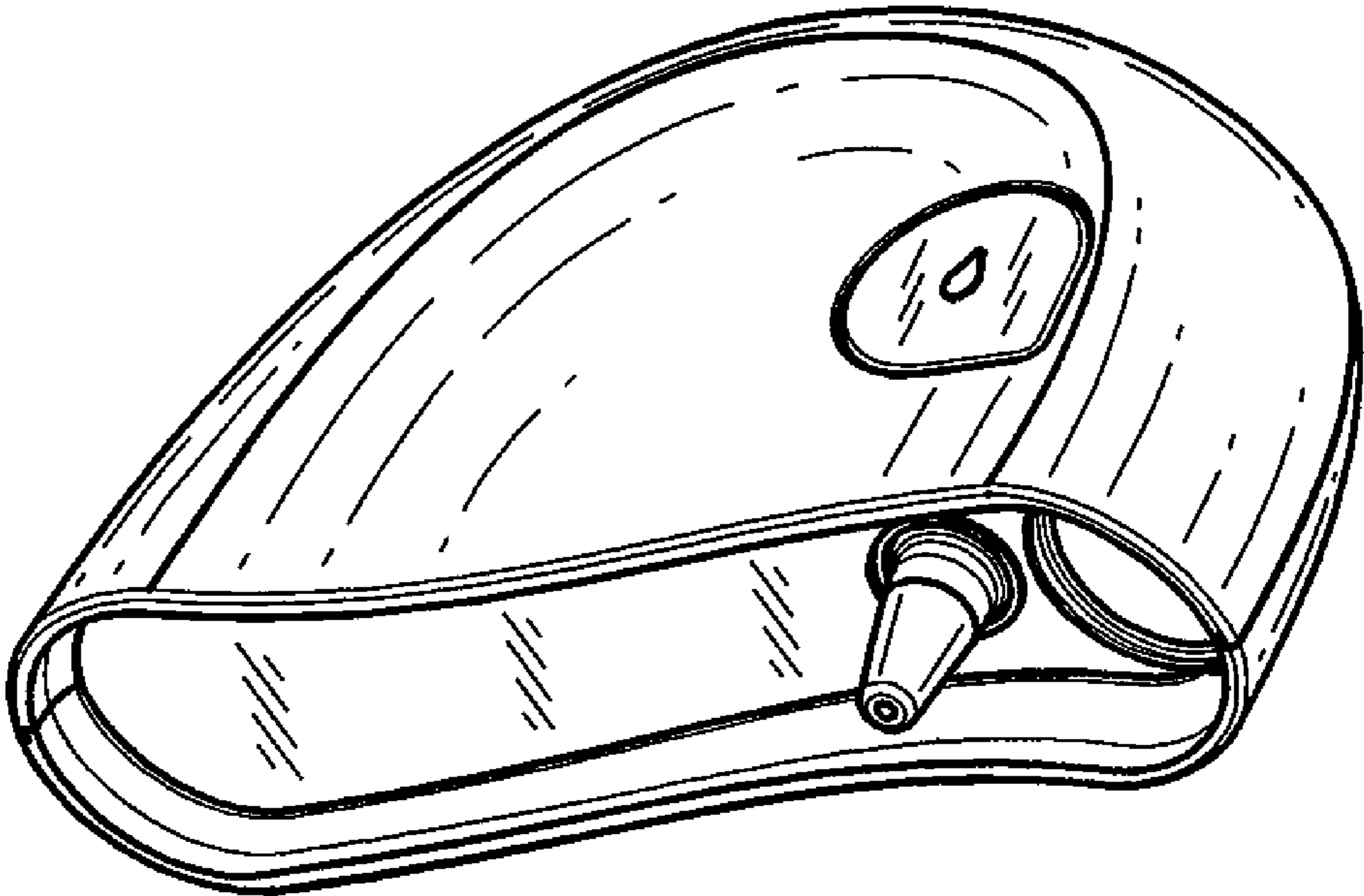

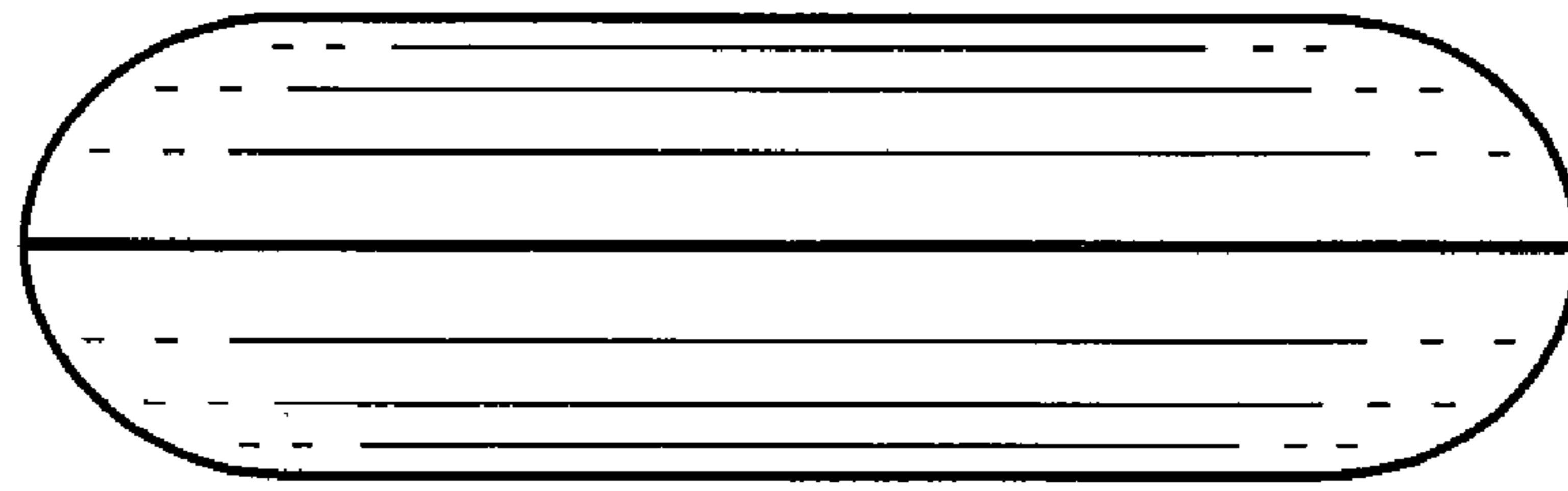

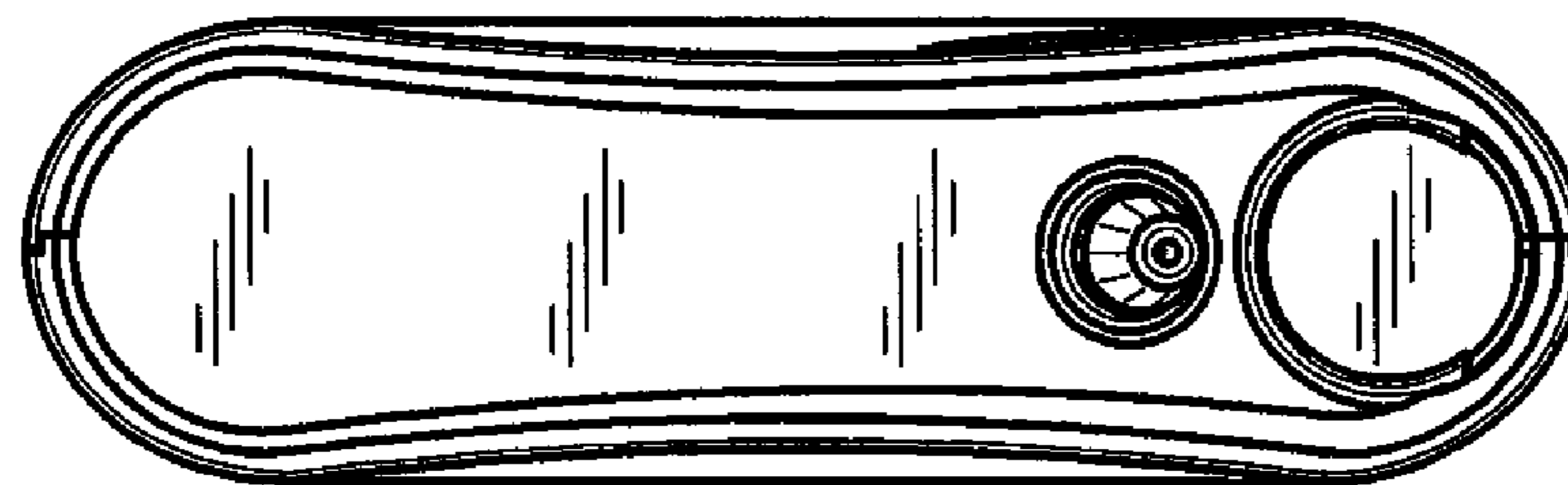

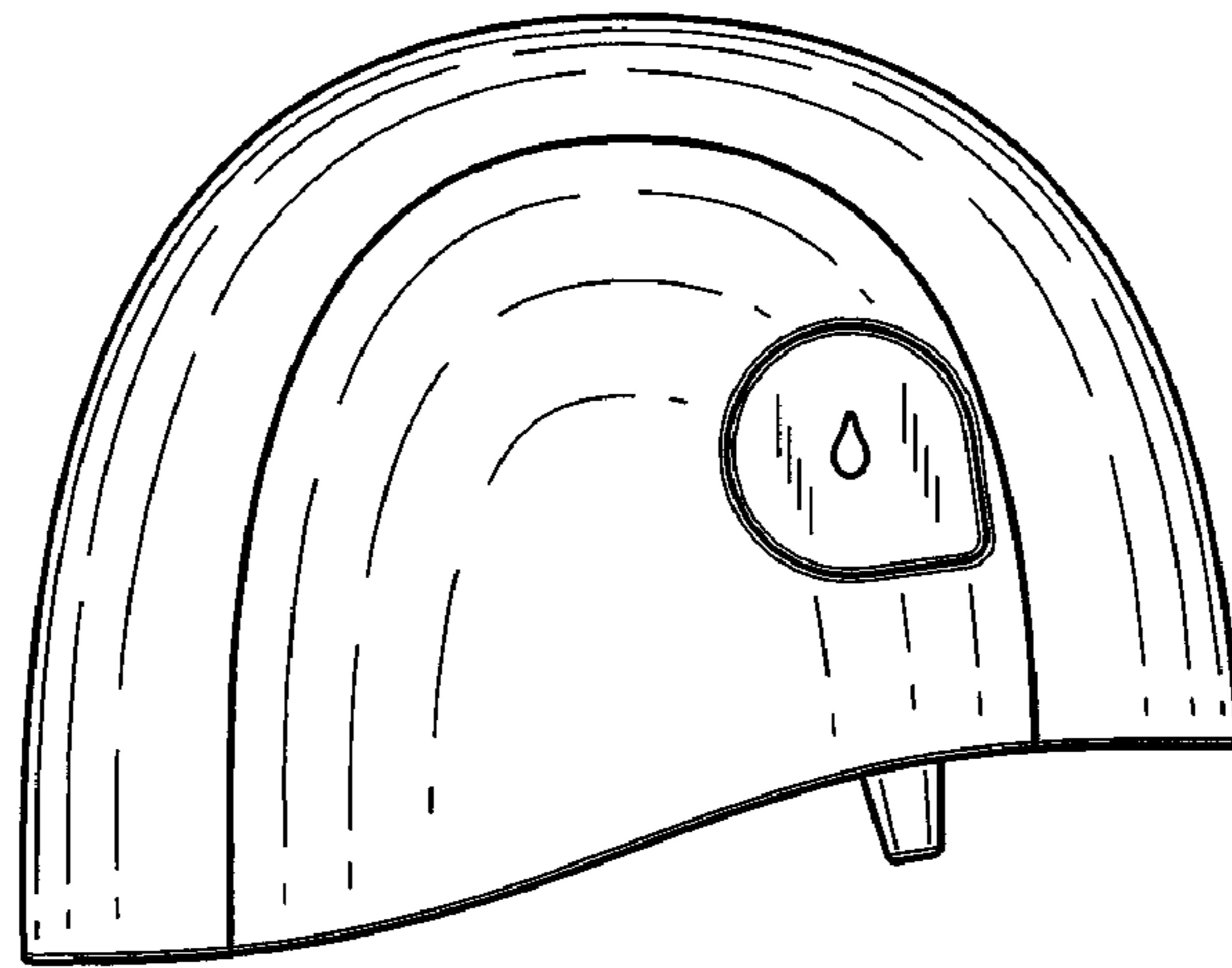

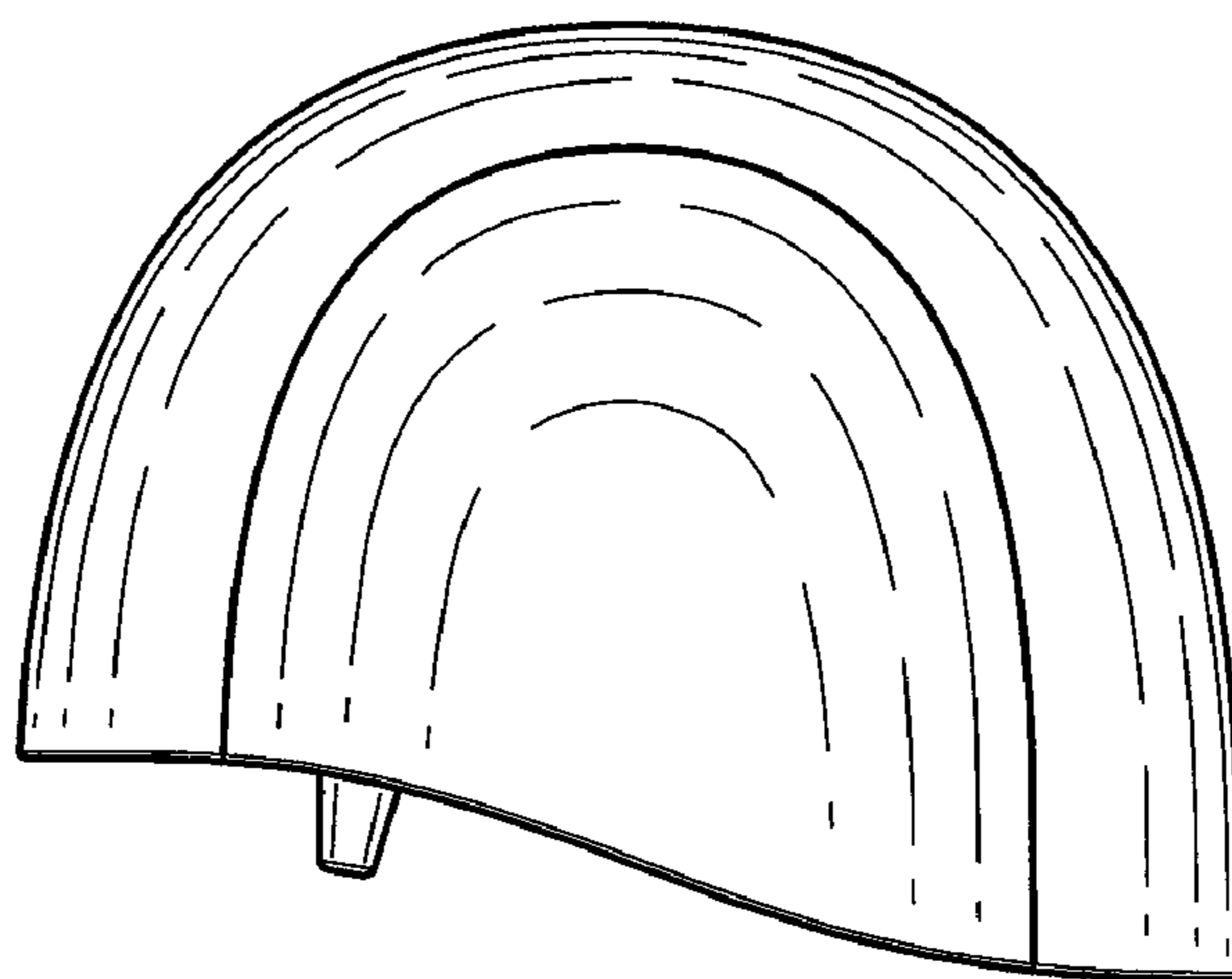

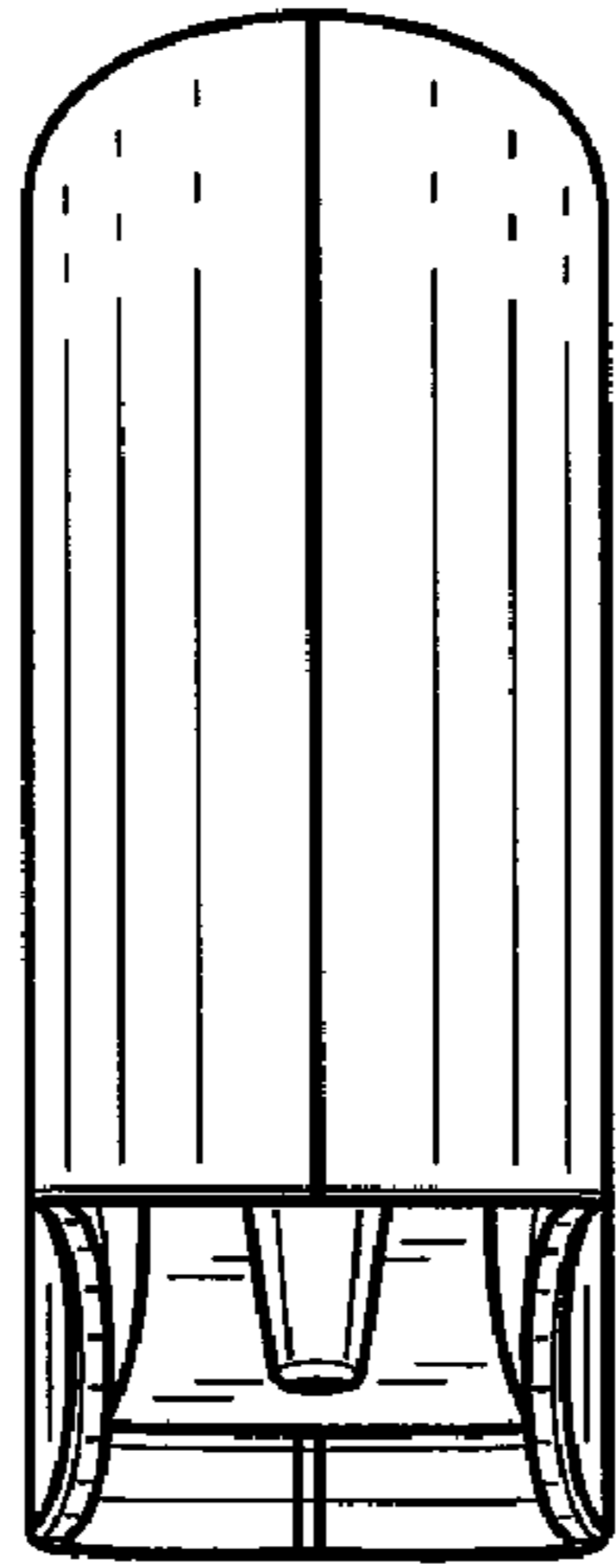

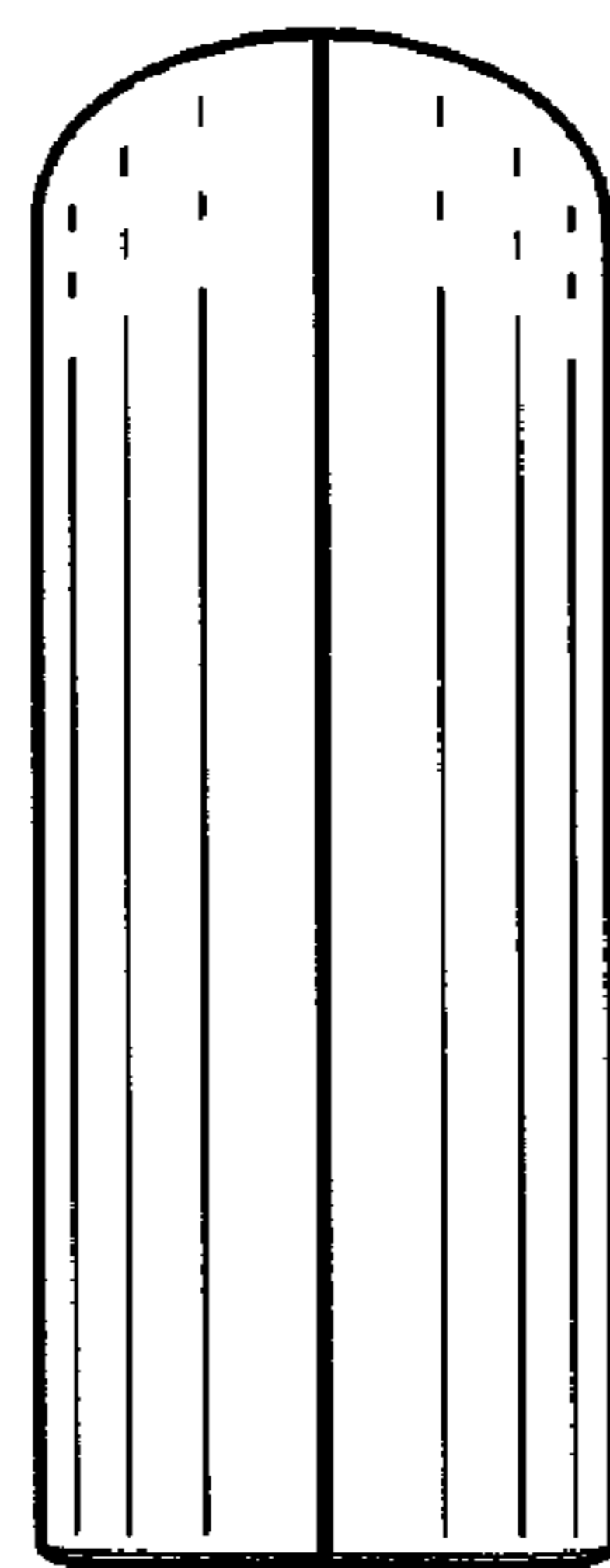

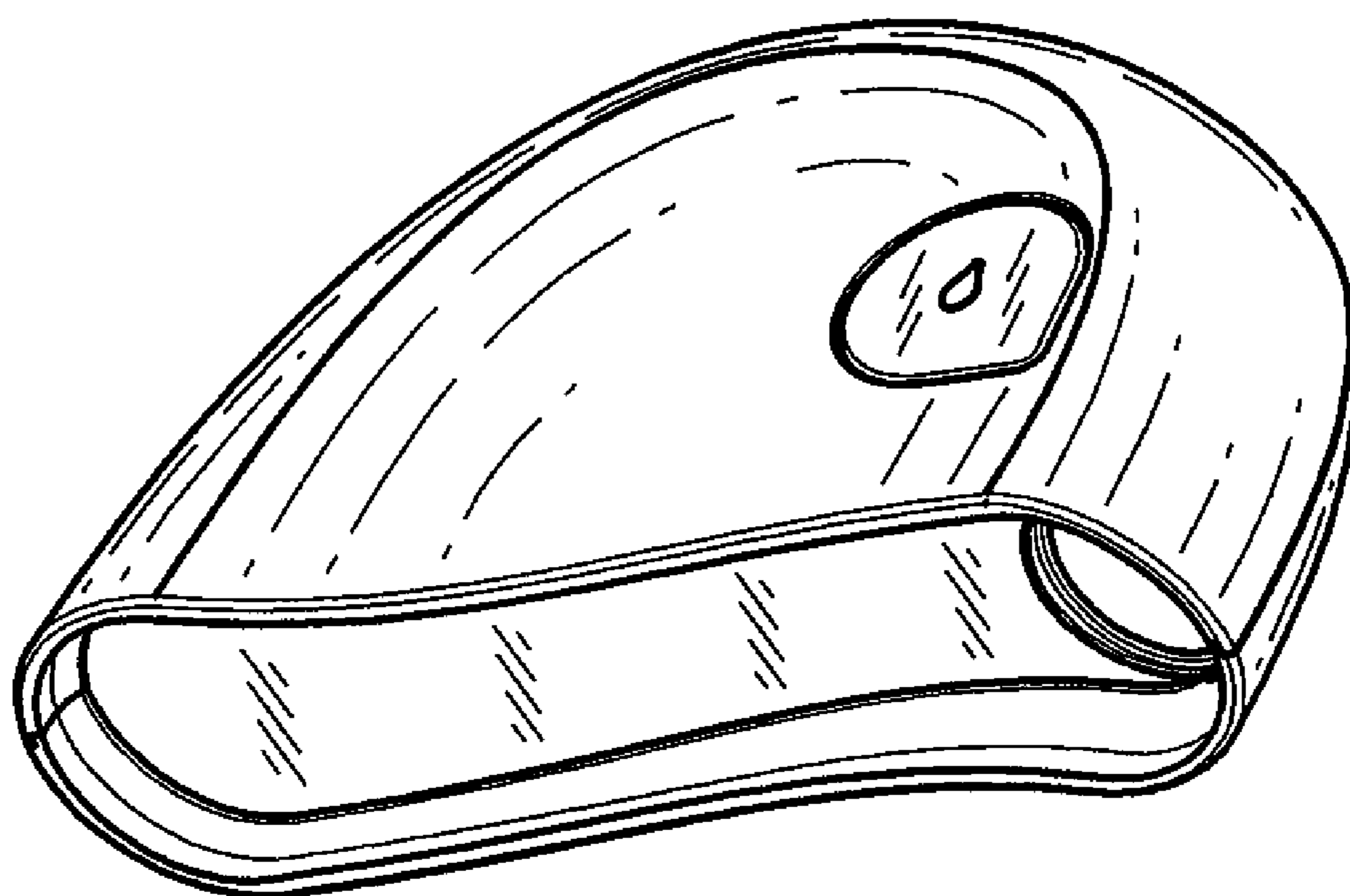

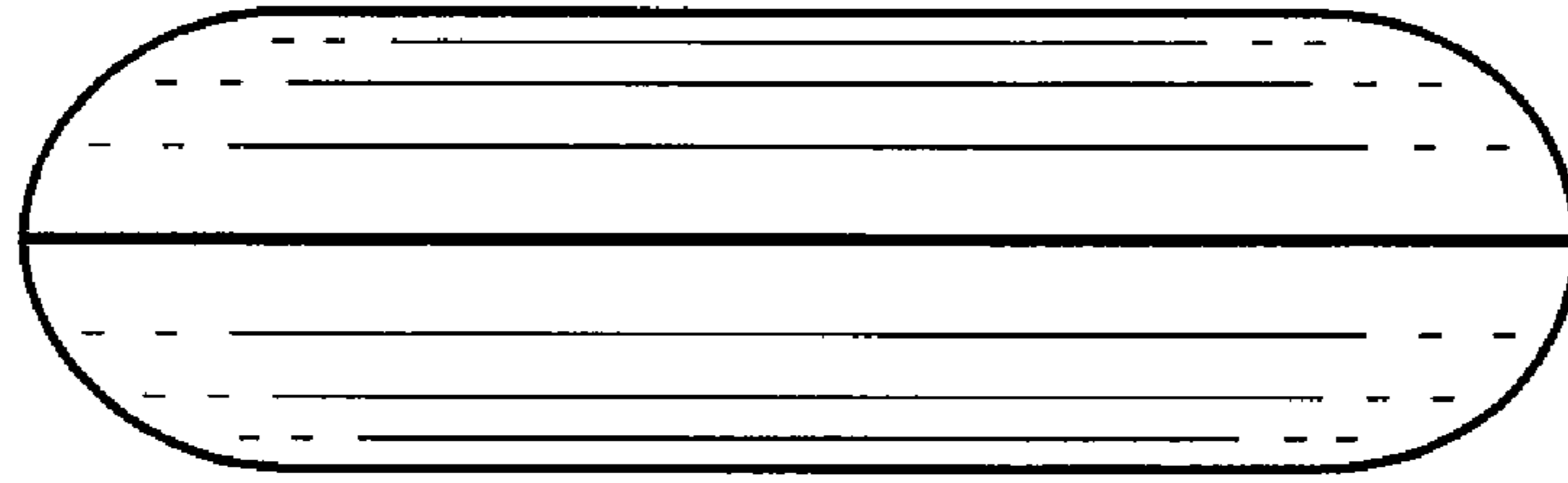

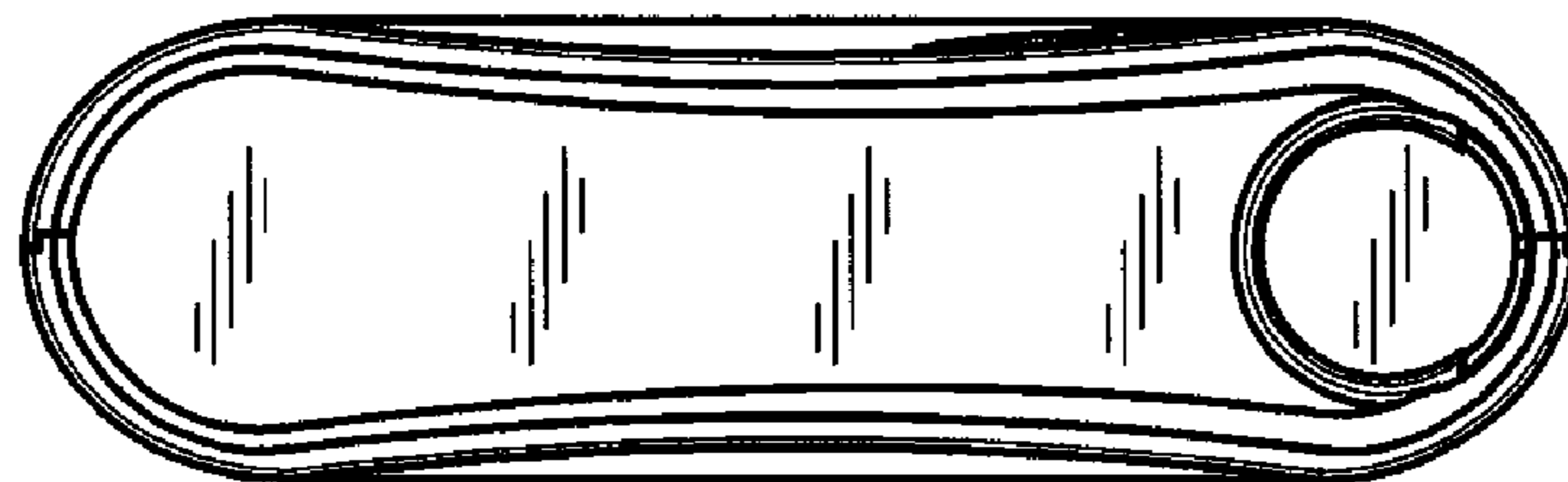

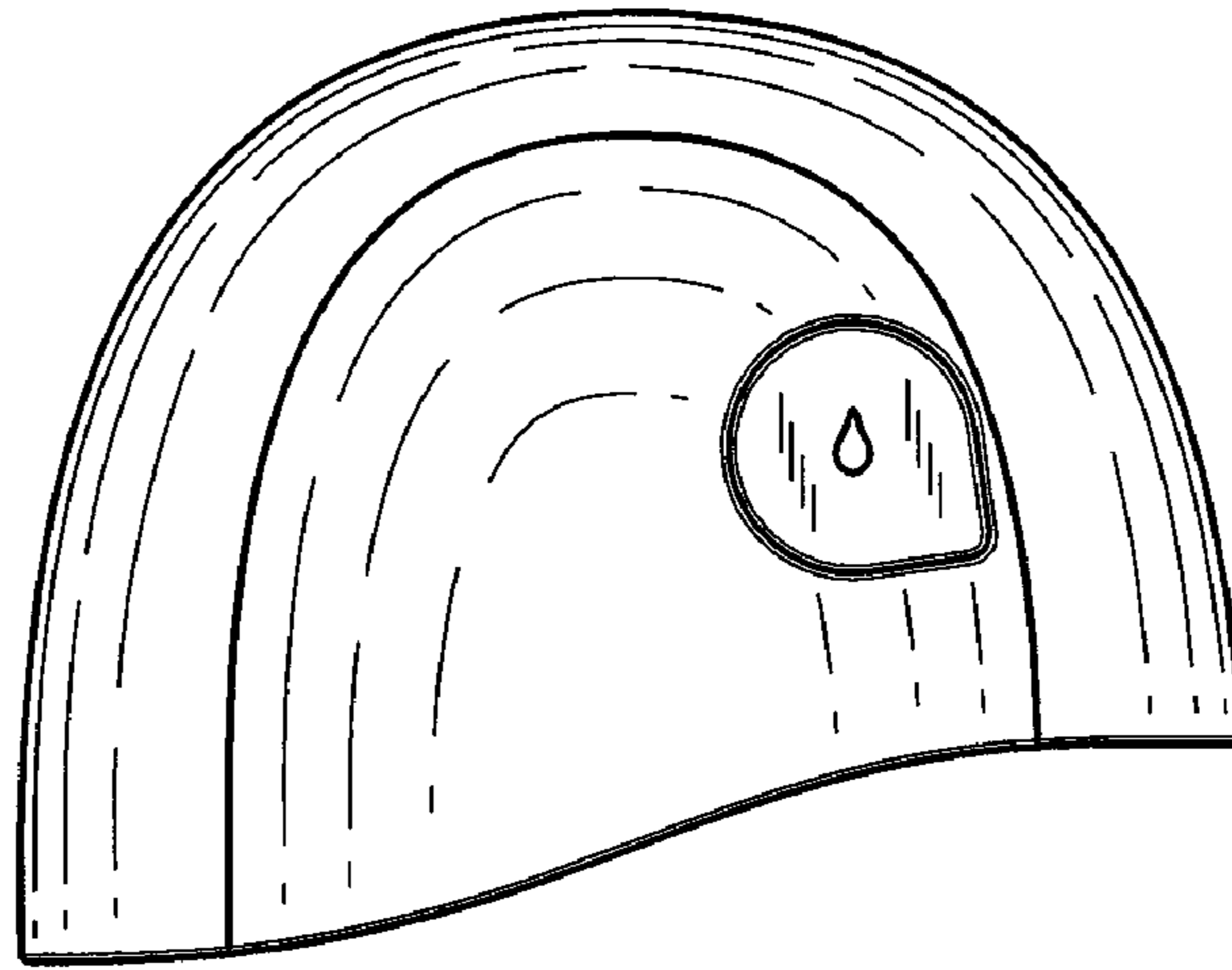

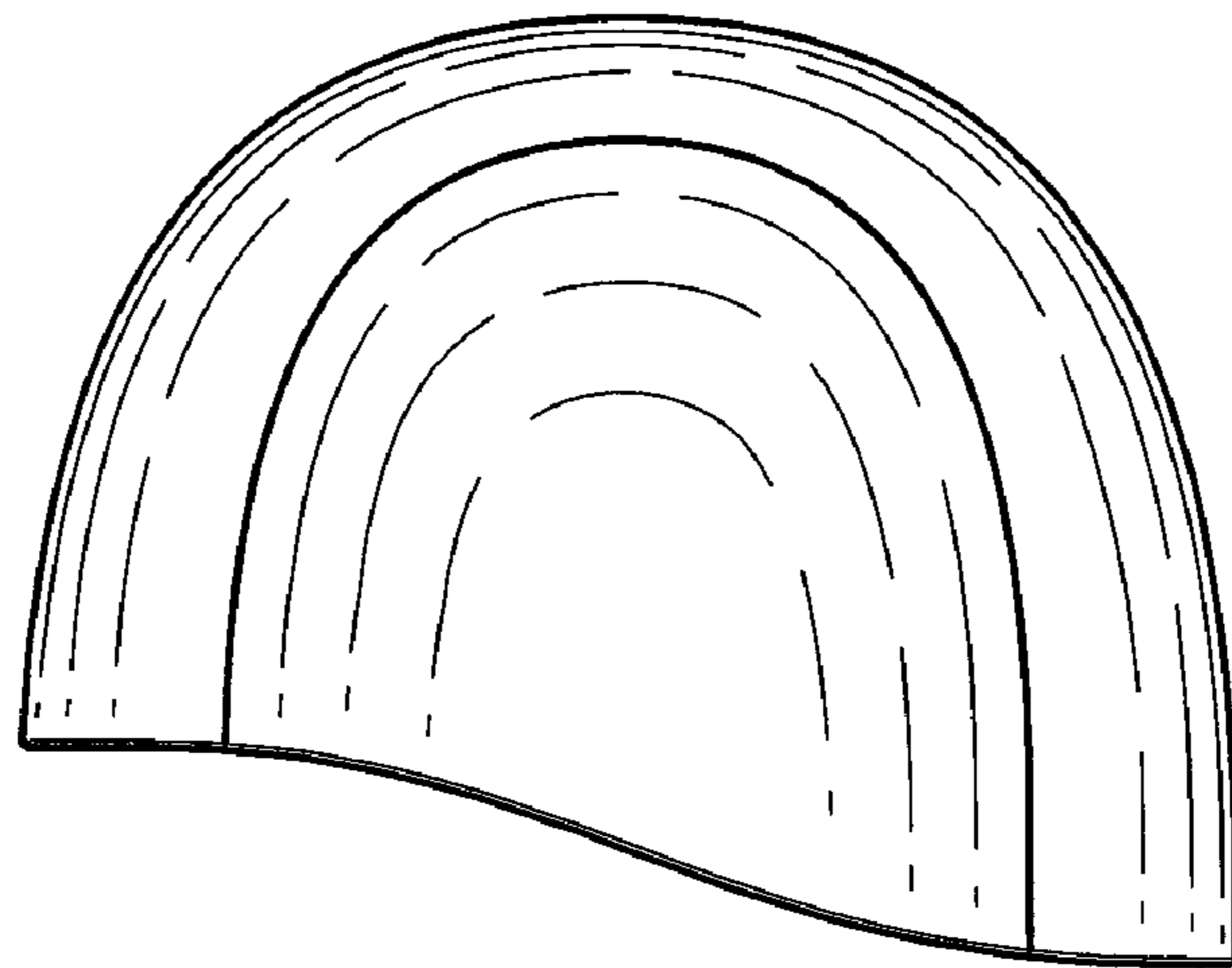

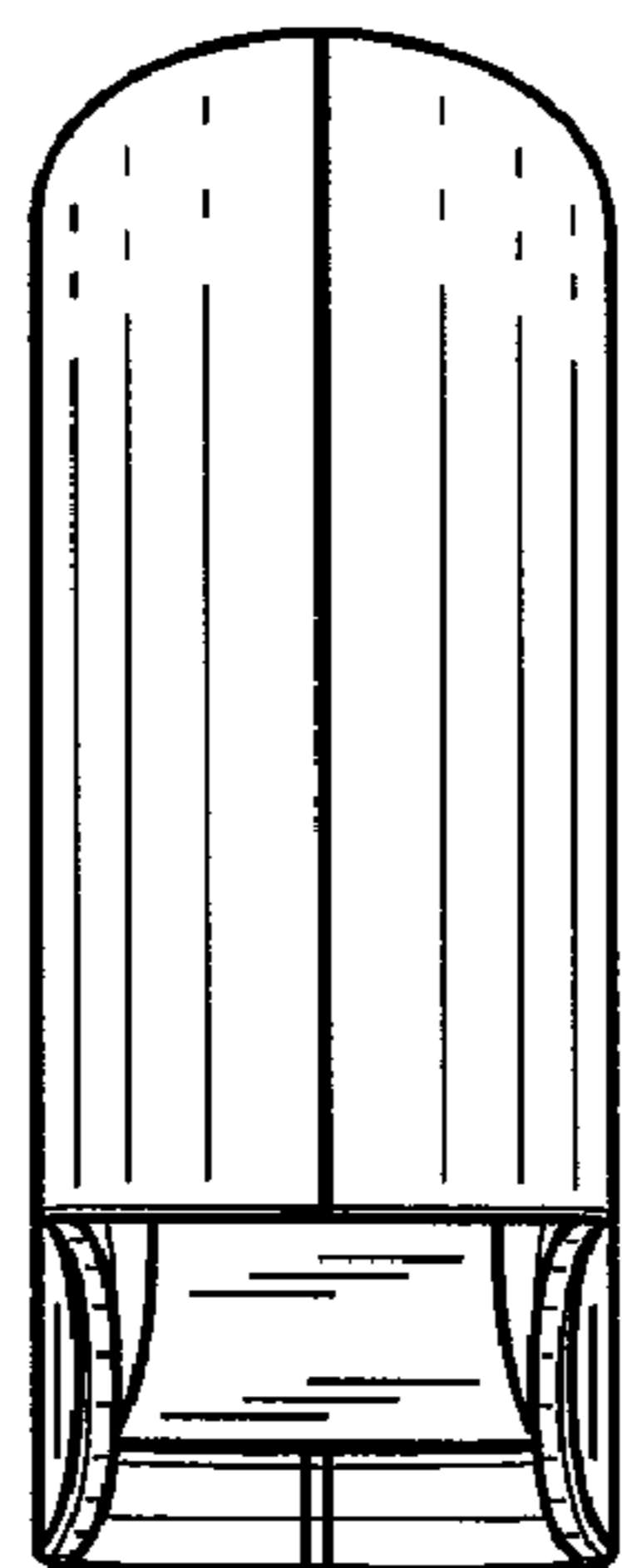

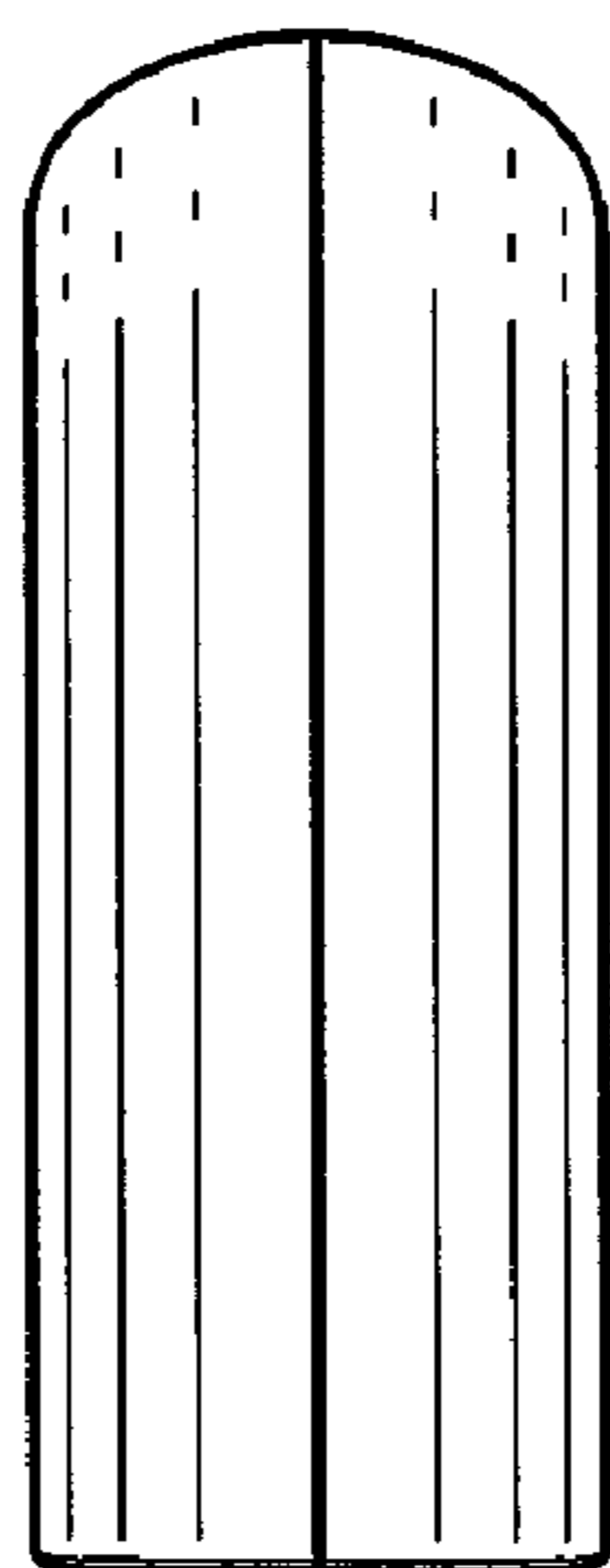
