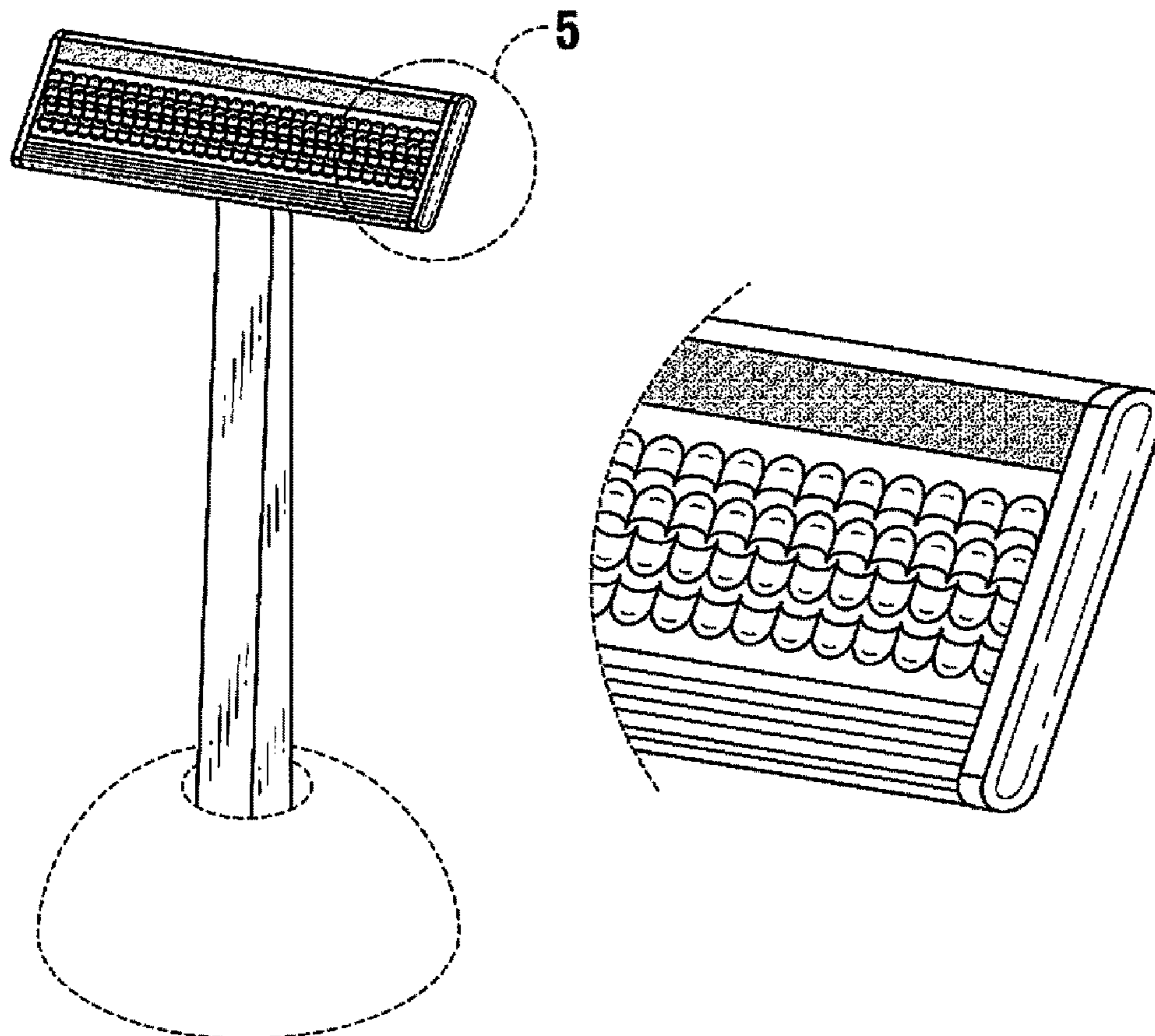
(57) **CLAIM**

The ornamental design for a shaving razor with serrated-edge blades, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view illustrating my new design for a shaving razor with serrated-edge blades; FIG. 2 is a front view thereof; FIG. 3 is a side view thereof; FIG. 4 is a top view thereof; and, FIG. 5 is an enlarged view of the serrated-edge blades. The broken lines shown in the drawings illustrate the environment of the razor and form no part of the claimed design.

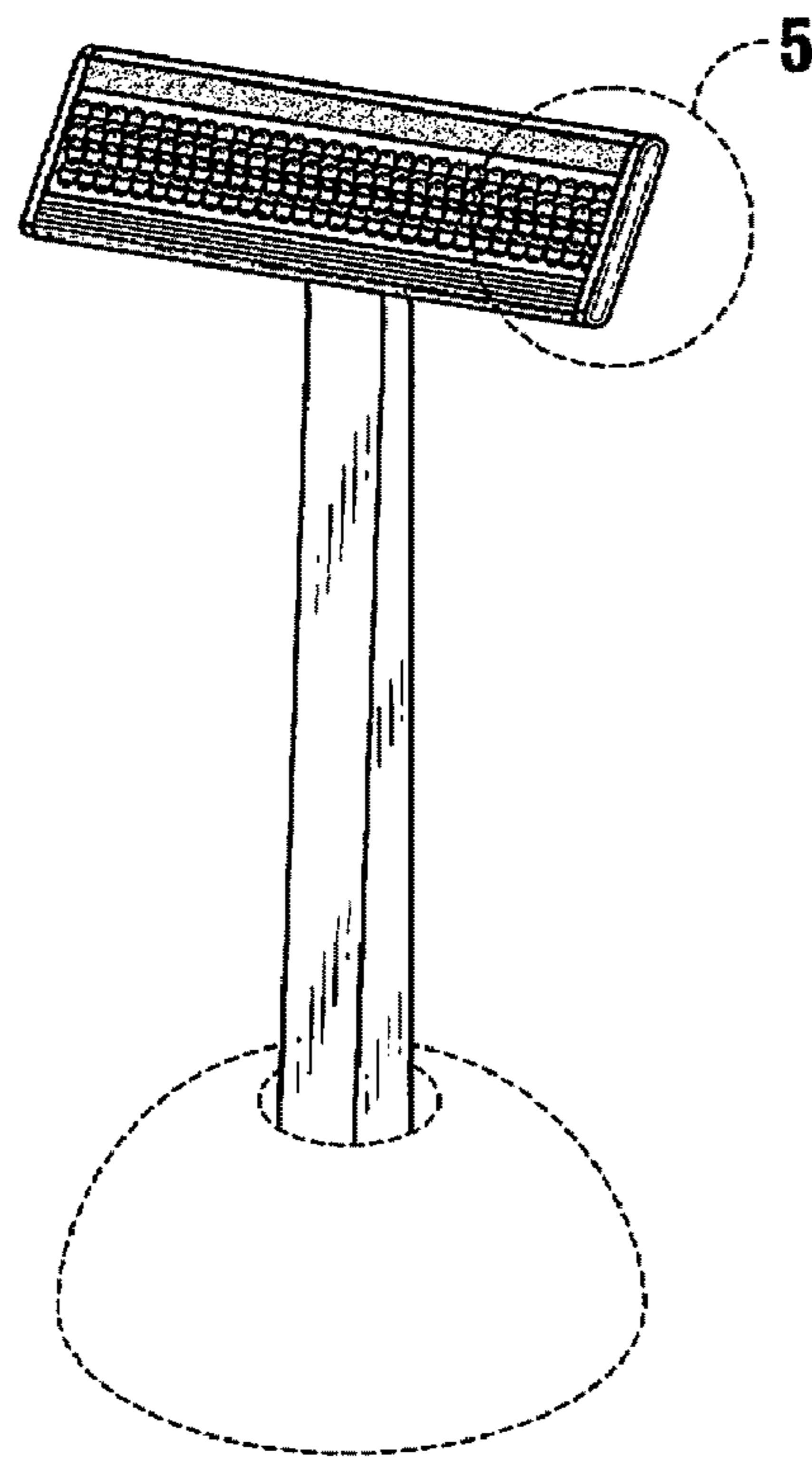

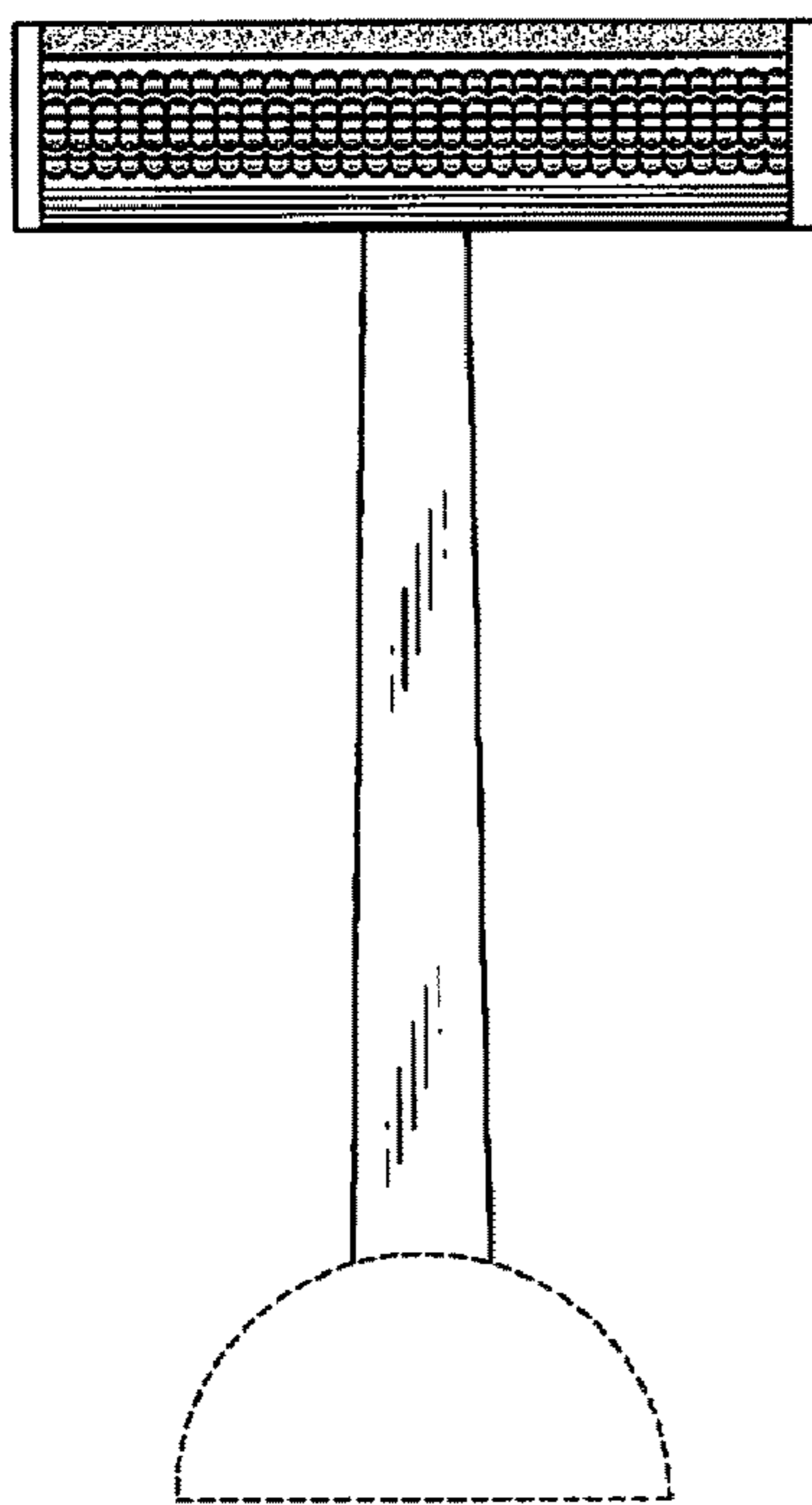

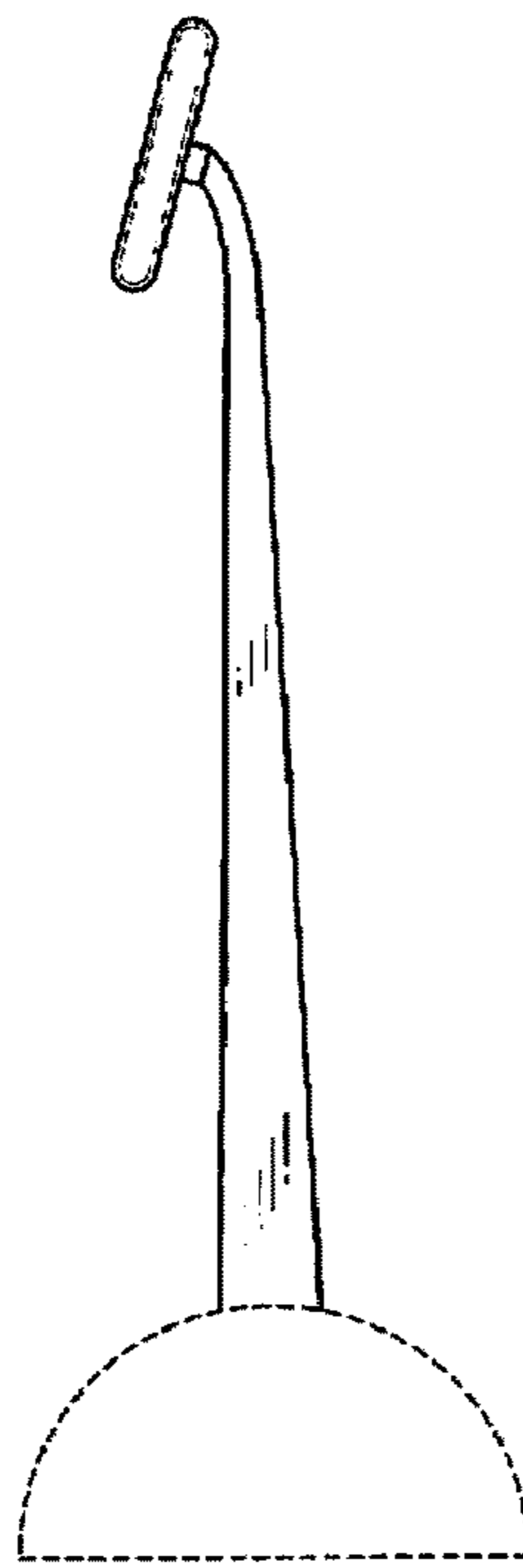

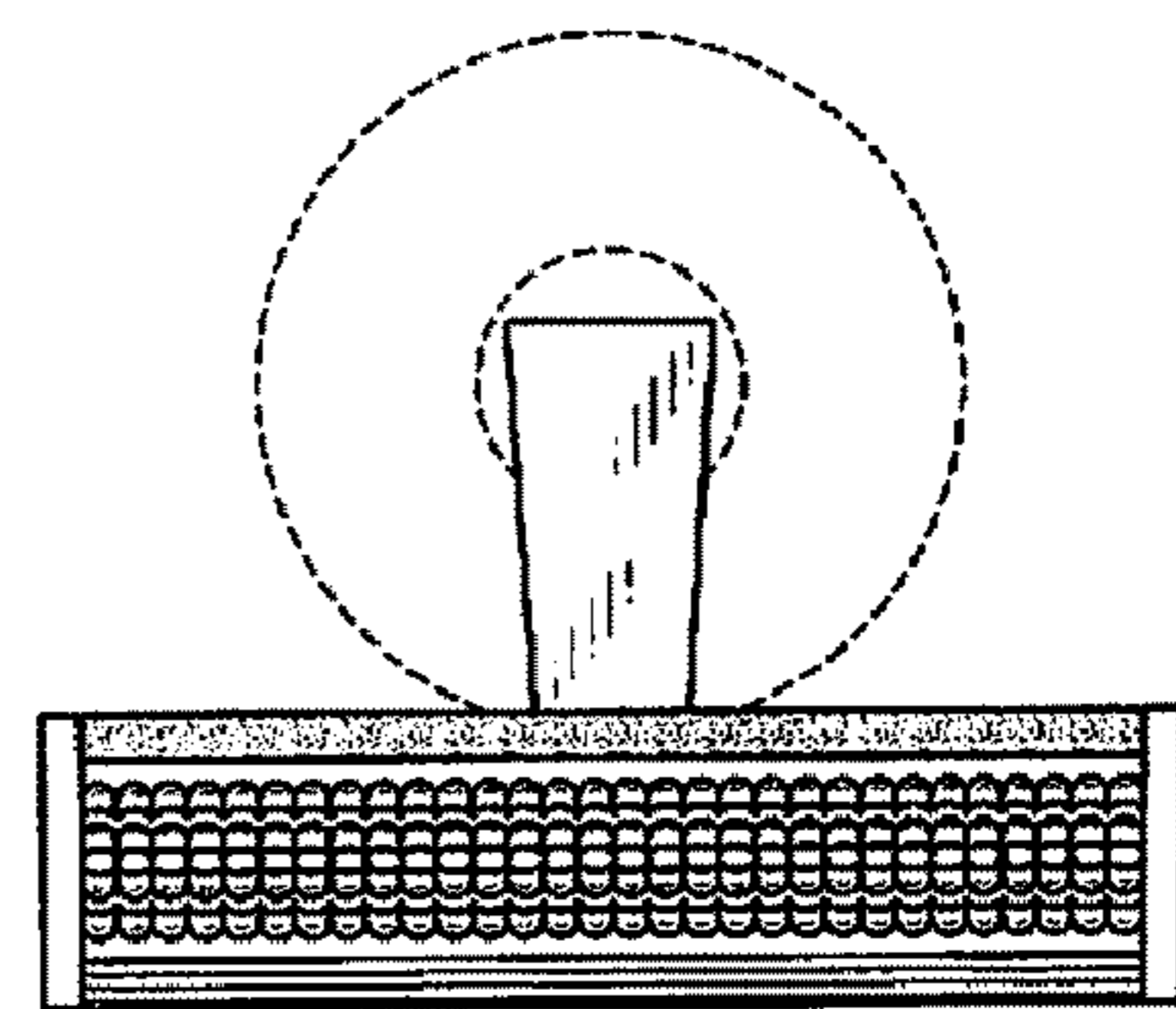

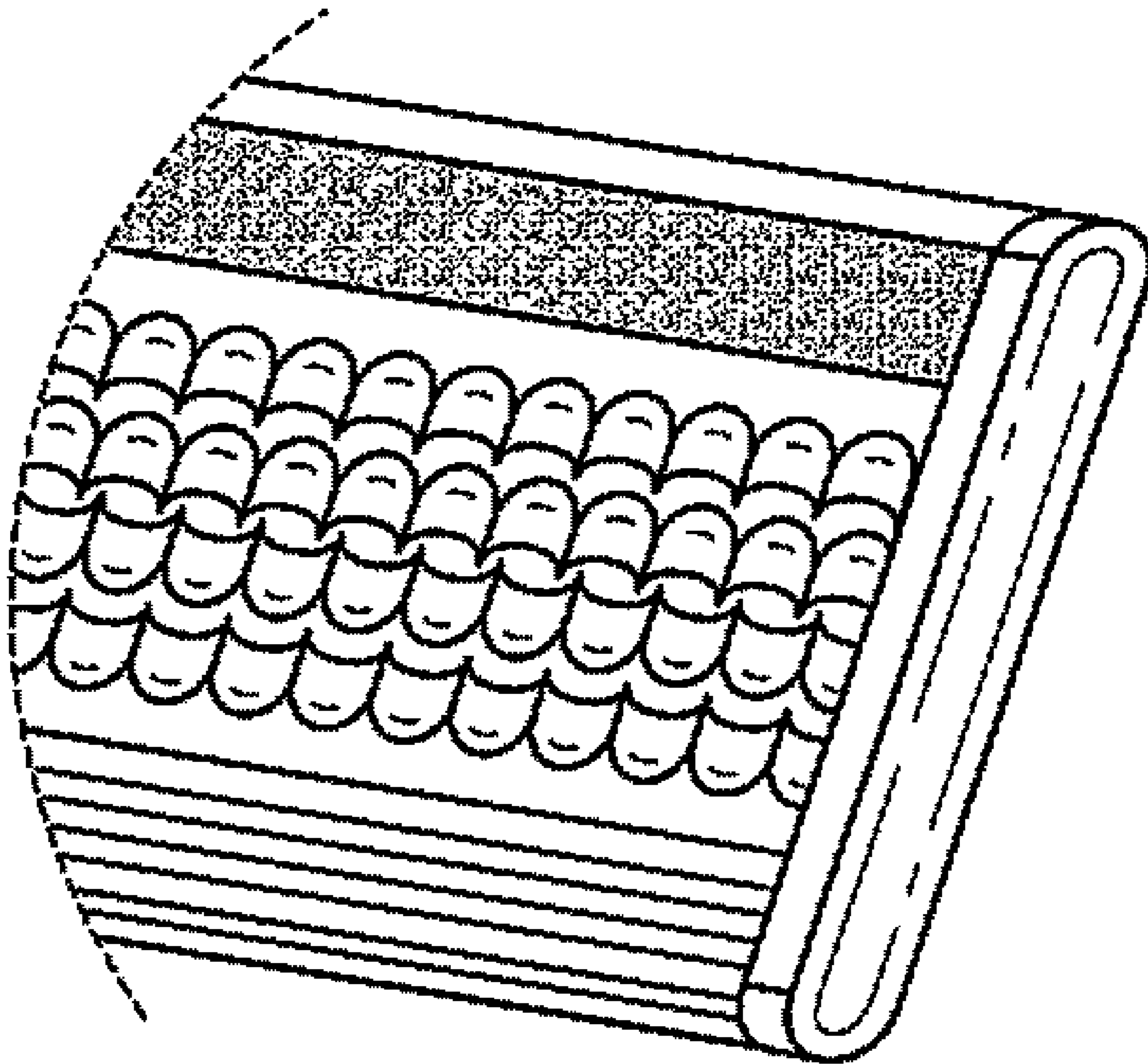
