FIG. 3 is a bottom view of the floppy pet chew of FIG. 1;

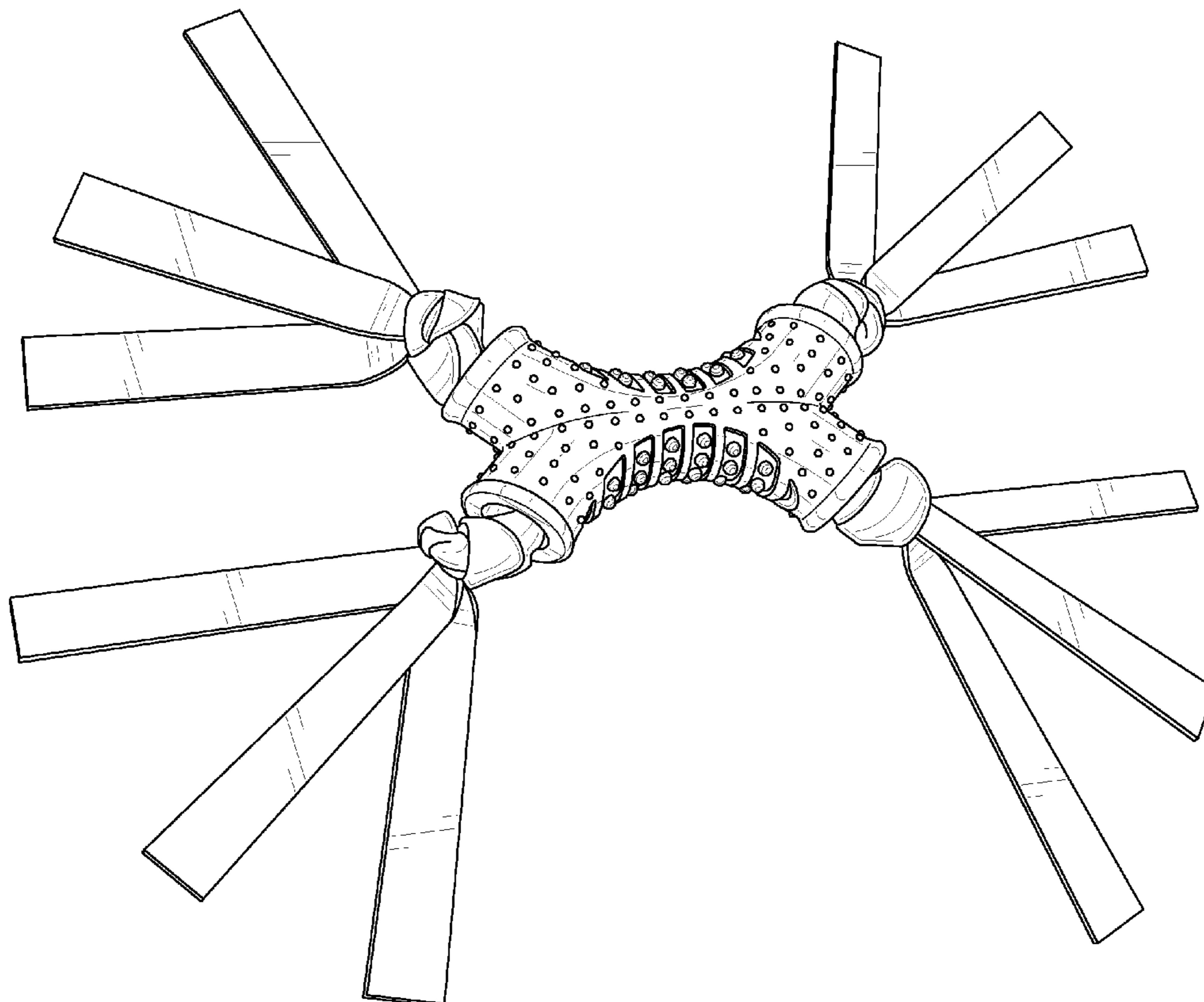
FIG. 4 is a left side view of the floppy pet chew of FIG. 1;

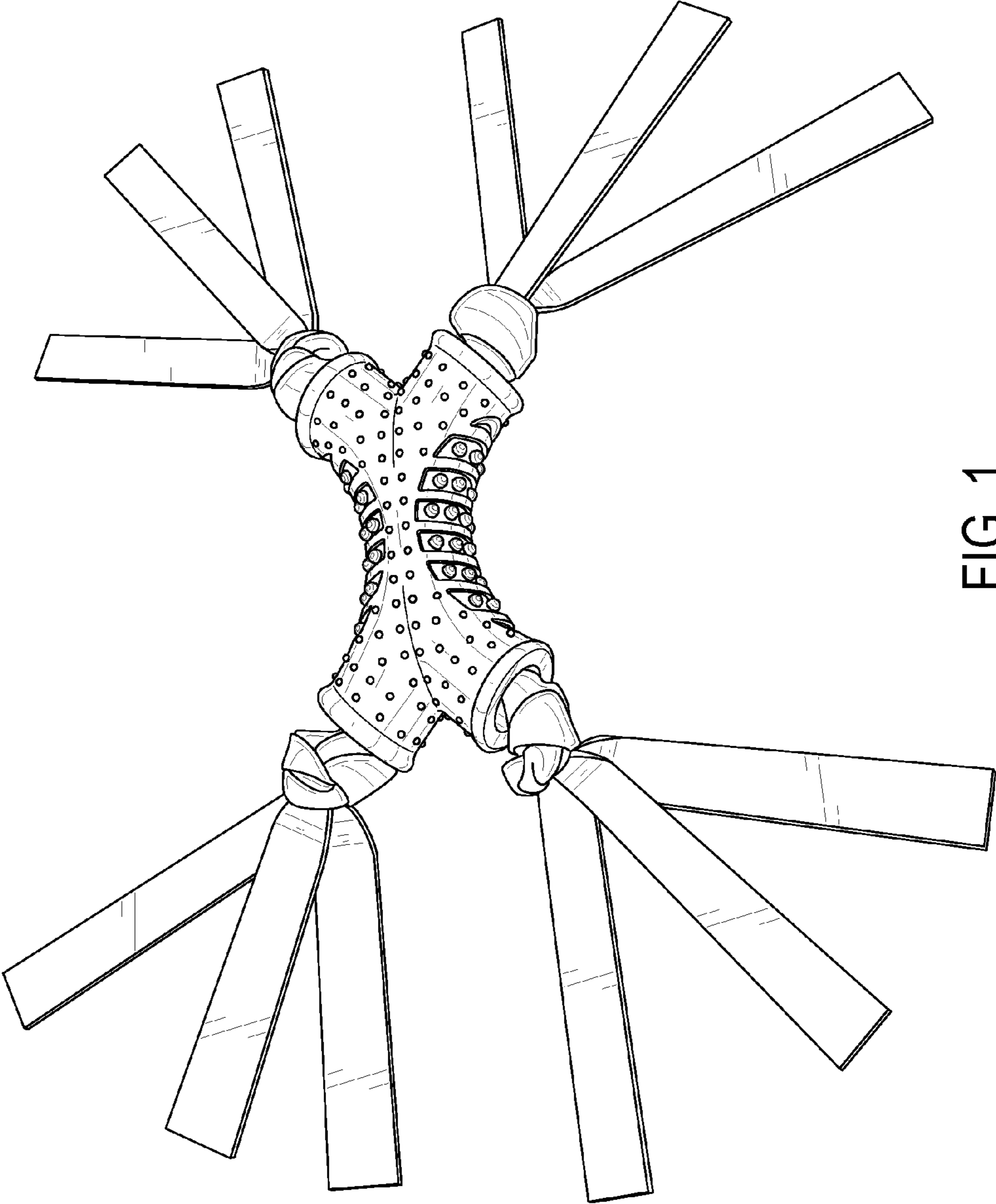

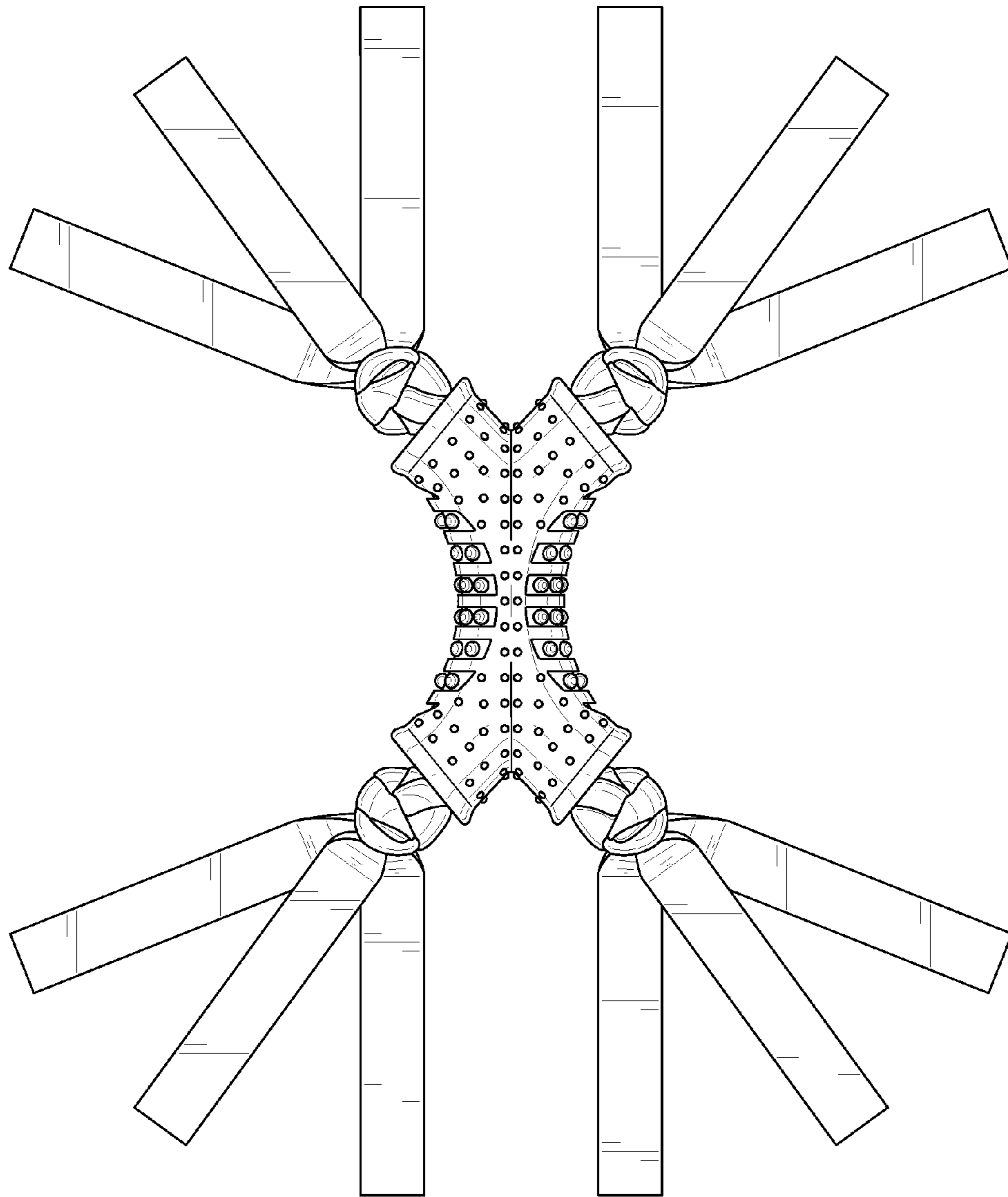

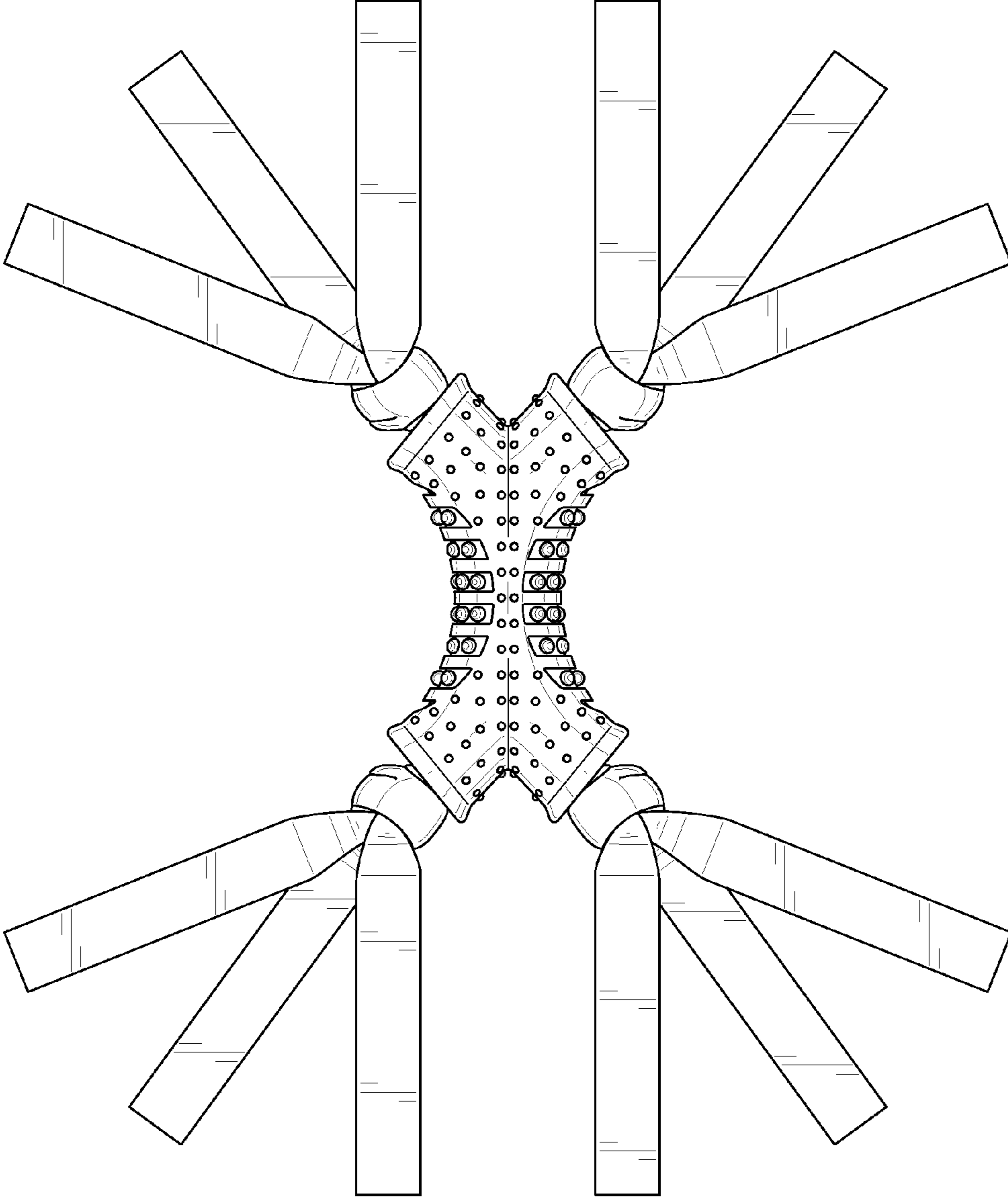

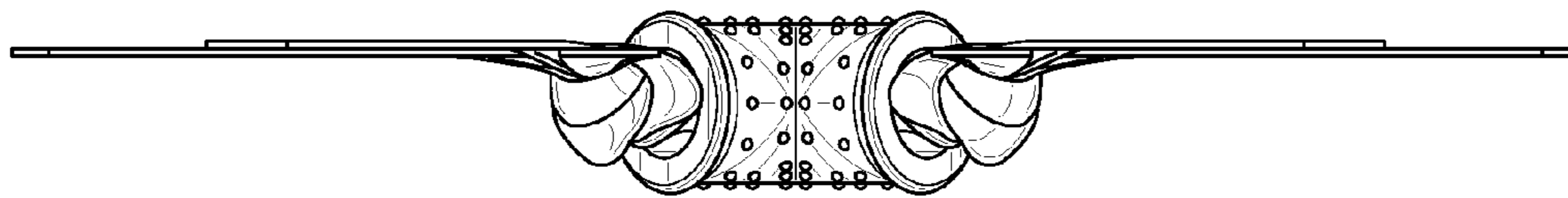

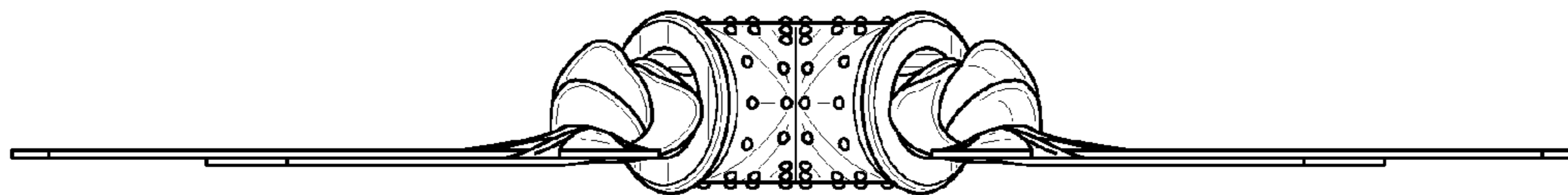

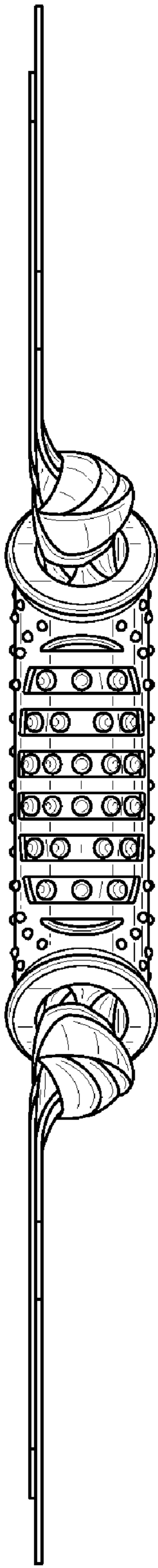

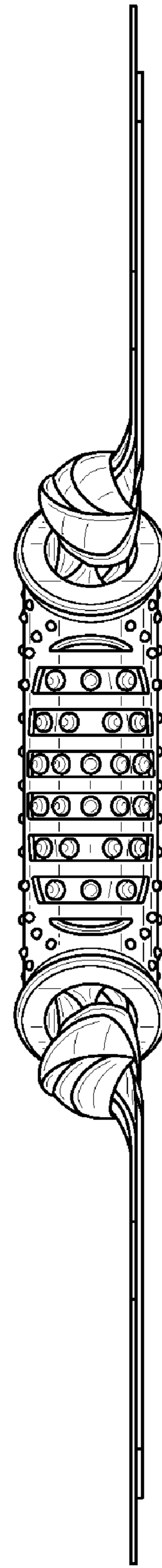
