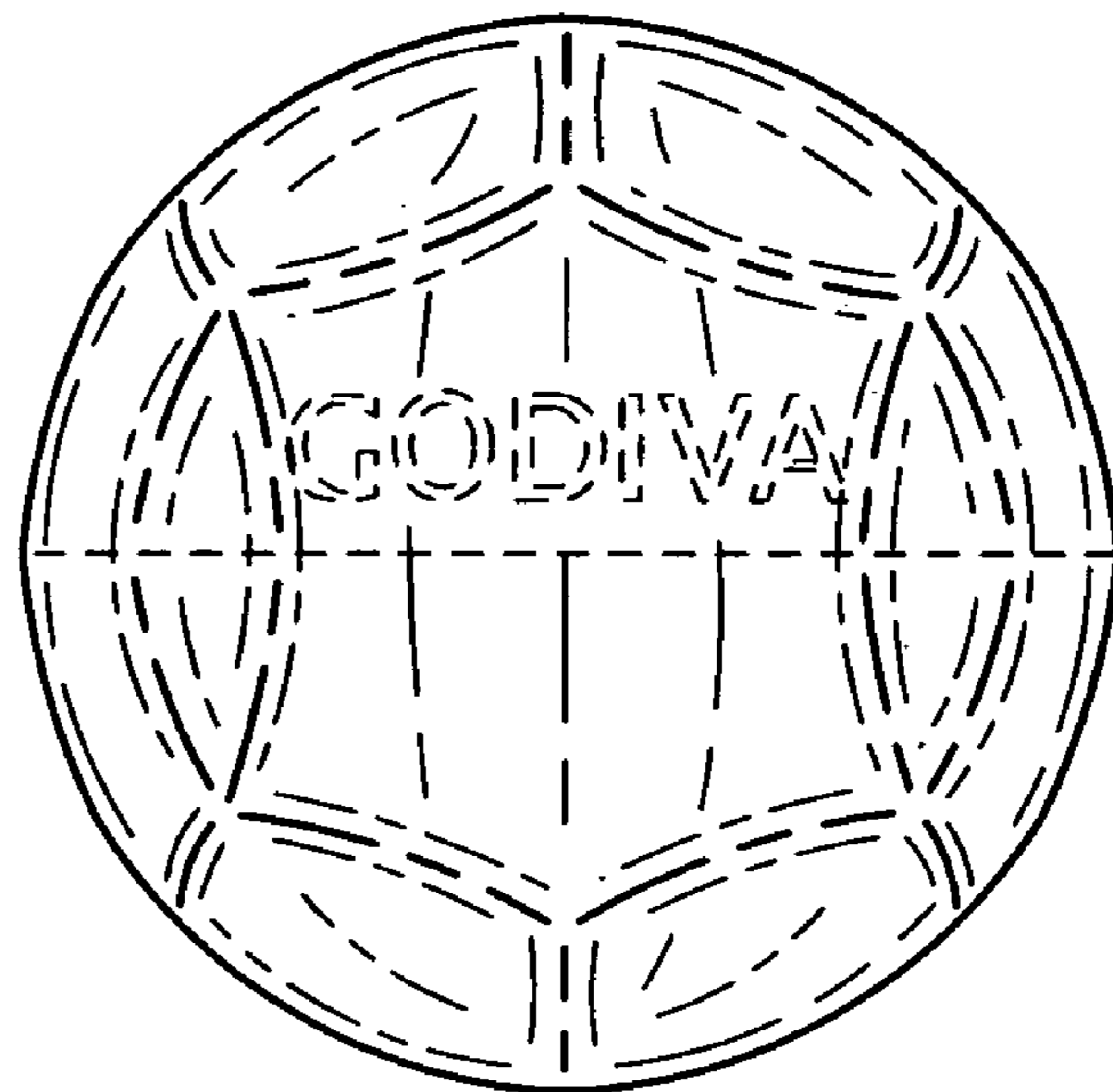
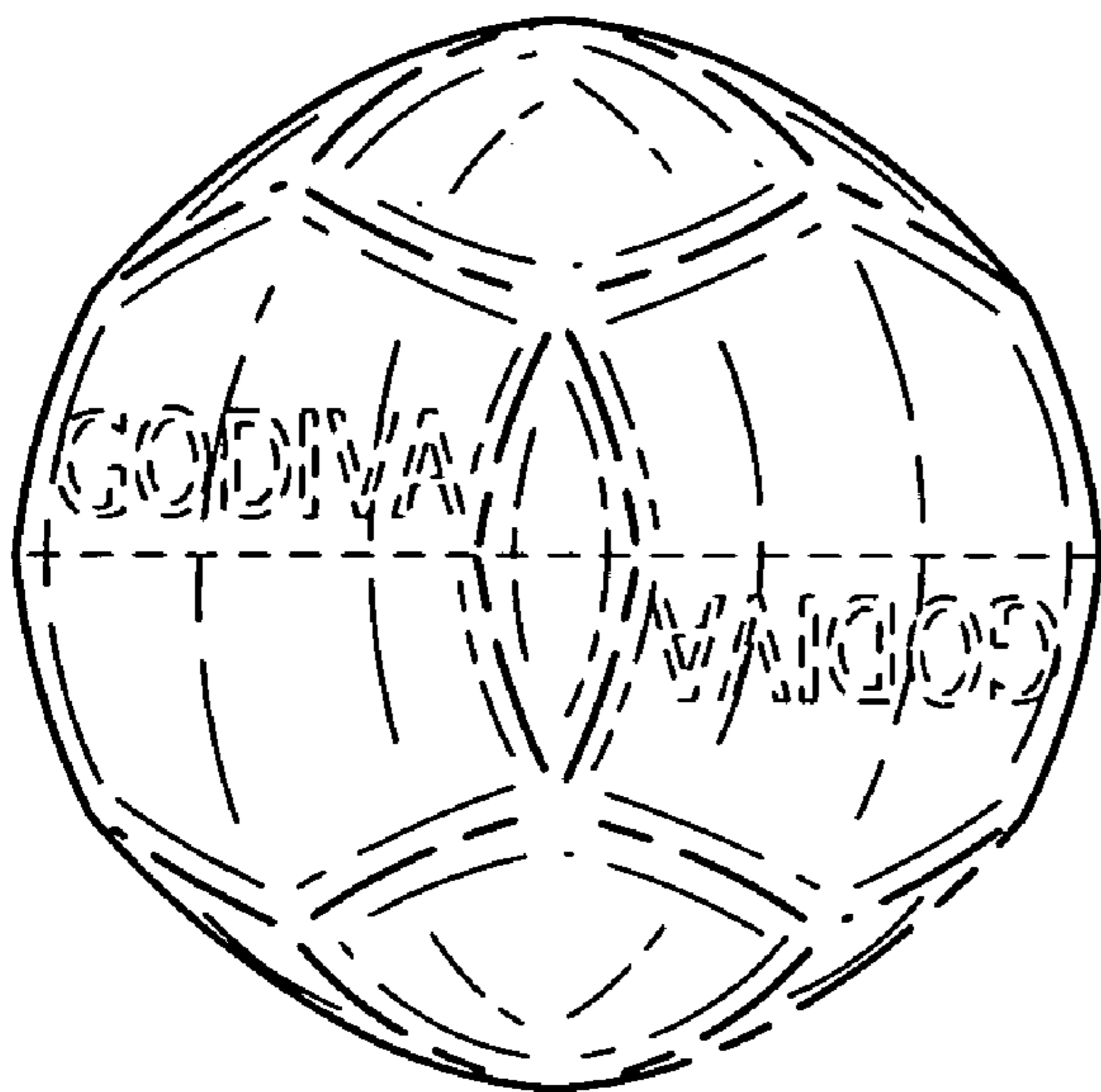
(57) **CLAIM**

The ornamental design for a confection, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a confection;
FIG. 2 is a front view of the confection, which is identical to all other side views thereof; and,
FIG. 3 is a top view of the confection, which is identical to the bottom view thereof.
The regularly spaced broken lines shown in FIGS. 1 and 2 illustrate unclaimed portions of the confection and form no part of the claimed design.

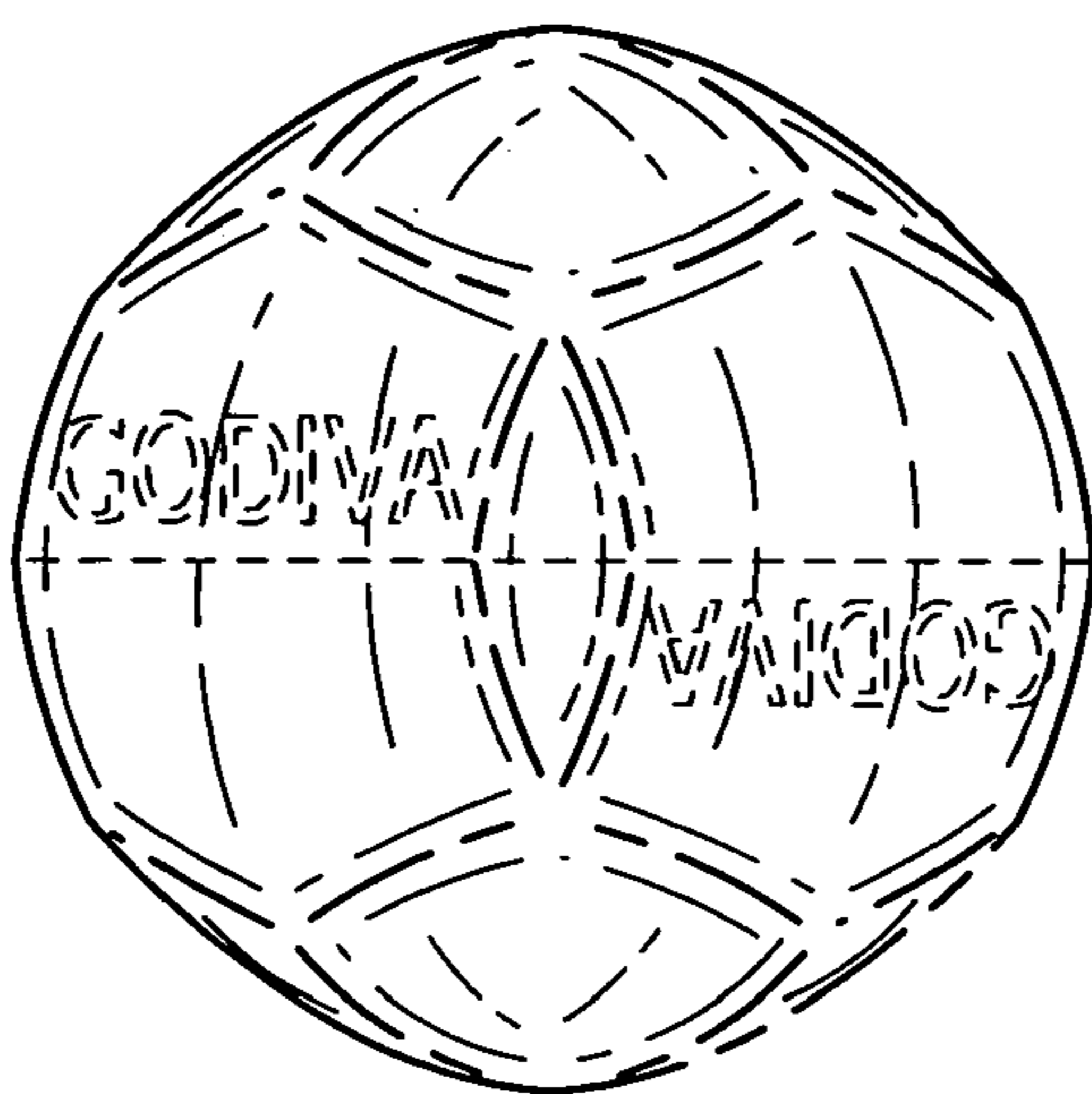

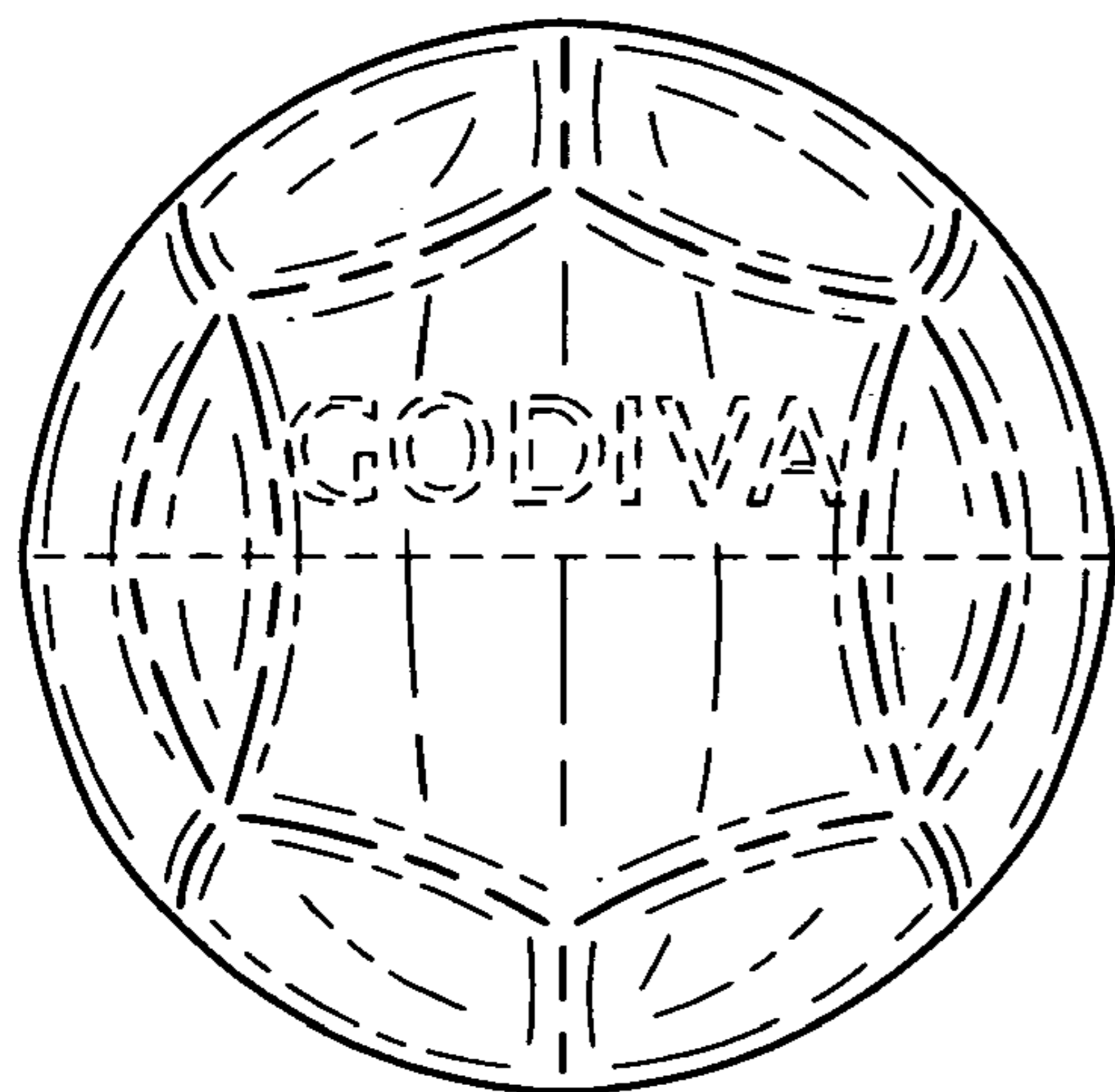

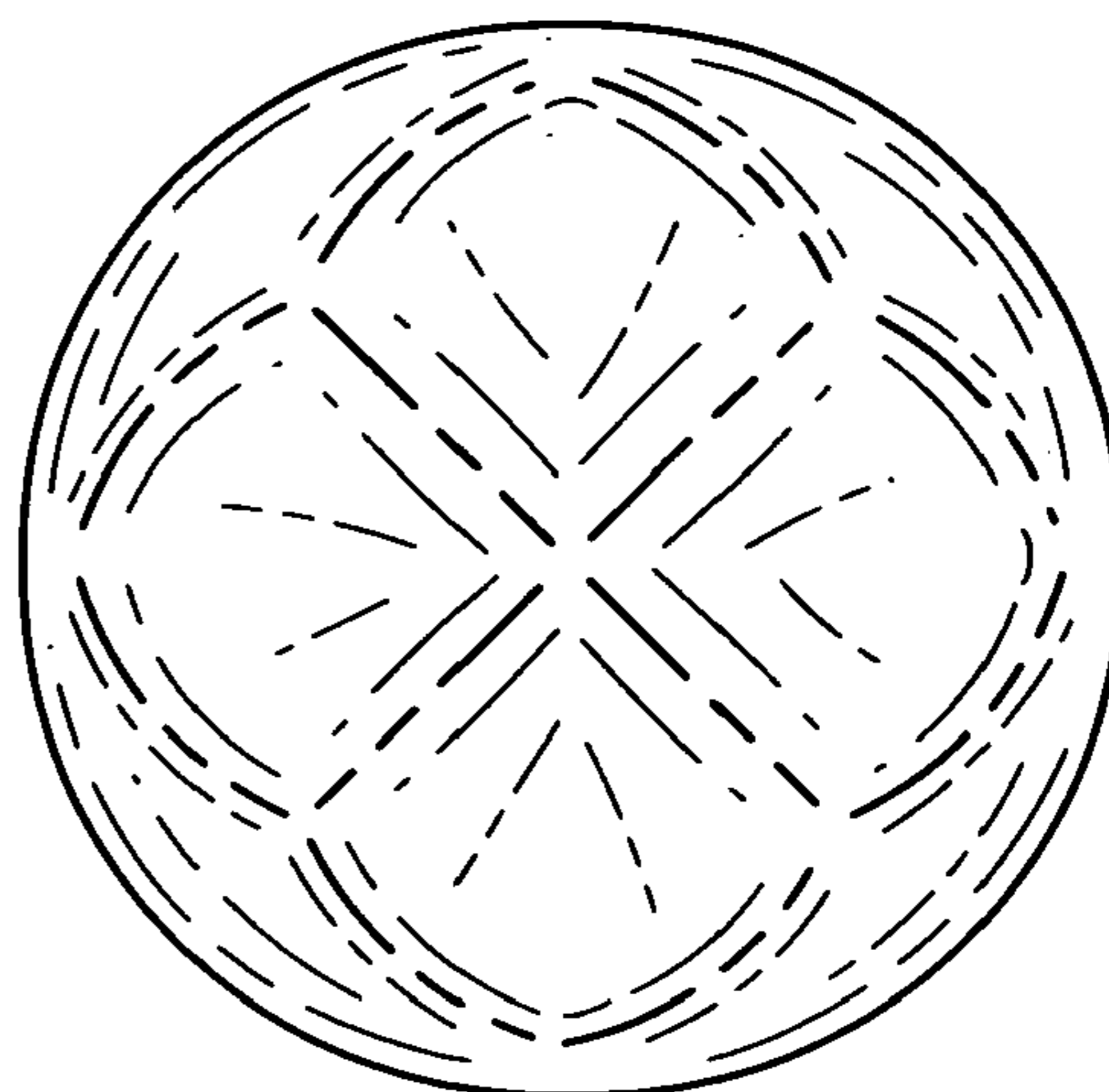
