(57) **CLAIM**

The ornamental design for a combined hooded sweatshirt and jersey garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the combined hooded sweatshirt and jersey garment in full lines with interior areas indicated by broken lines forming no part of the claimed invention and numbers shown in broken lines representing environmental association matter being for illustrative purposes only and forming no part of the claimed invention.

FIG. 2 is a front elevational view of the combined hooded sweatshirt and jersey garment in full lines, wherein in this and subsequent views interior areas indicated by broken lines forming no part of the claimed invention and numbers shown in broken lines representing environmental association matter being for illustrative purposes only and forming no part of the claimed invention.

FIG. 3 is a rear elevational view thereof.

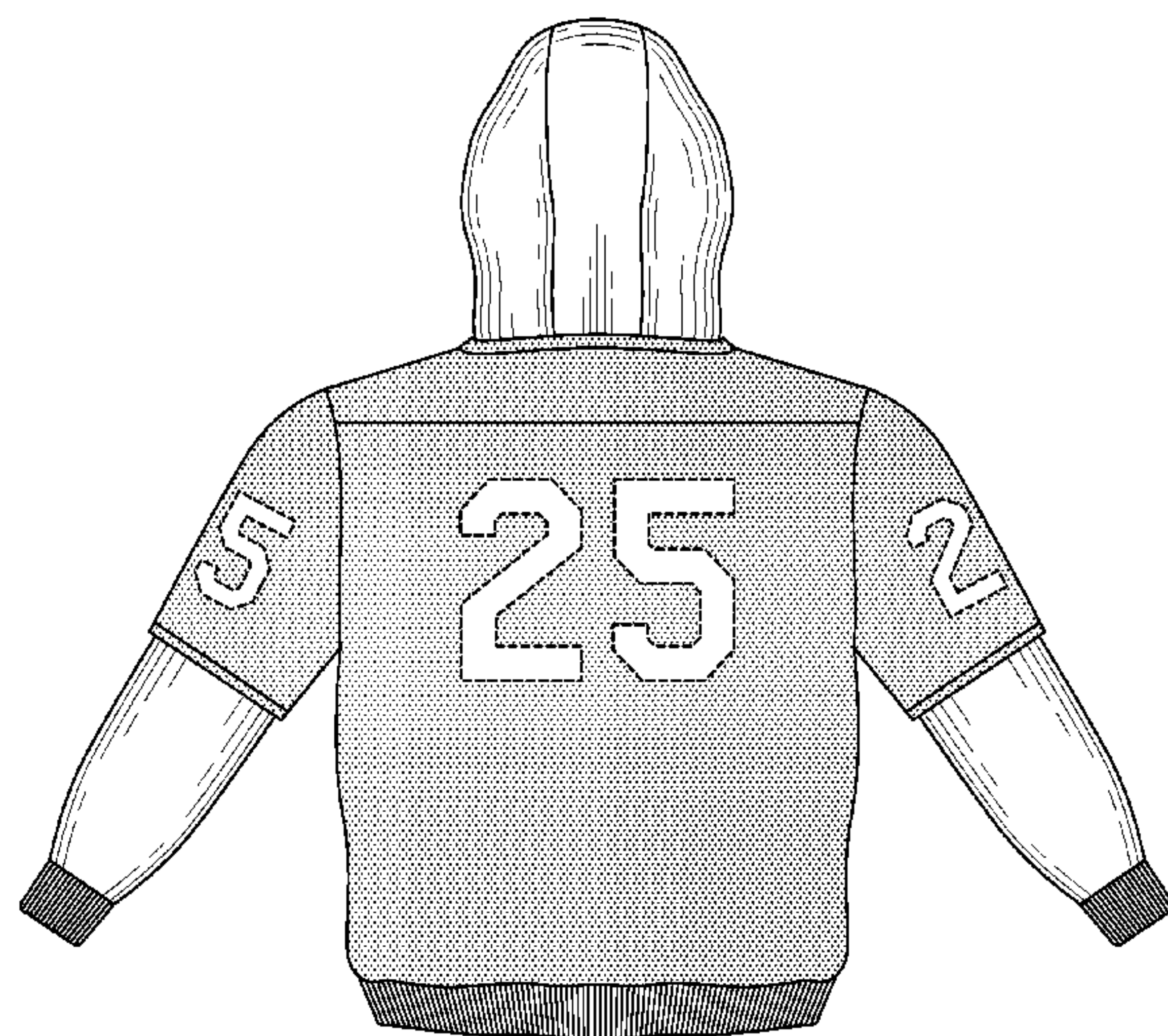
FIG. 4 is a right side elevational view thereof.

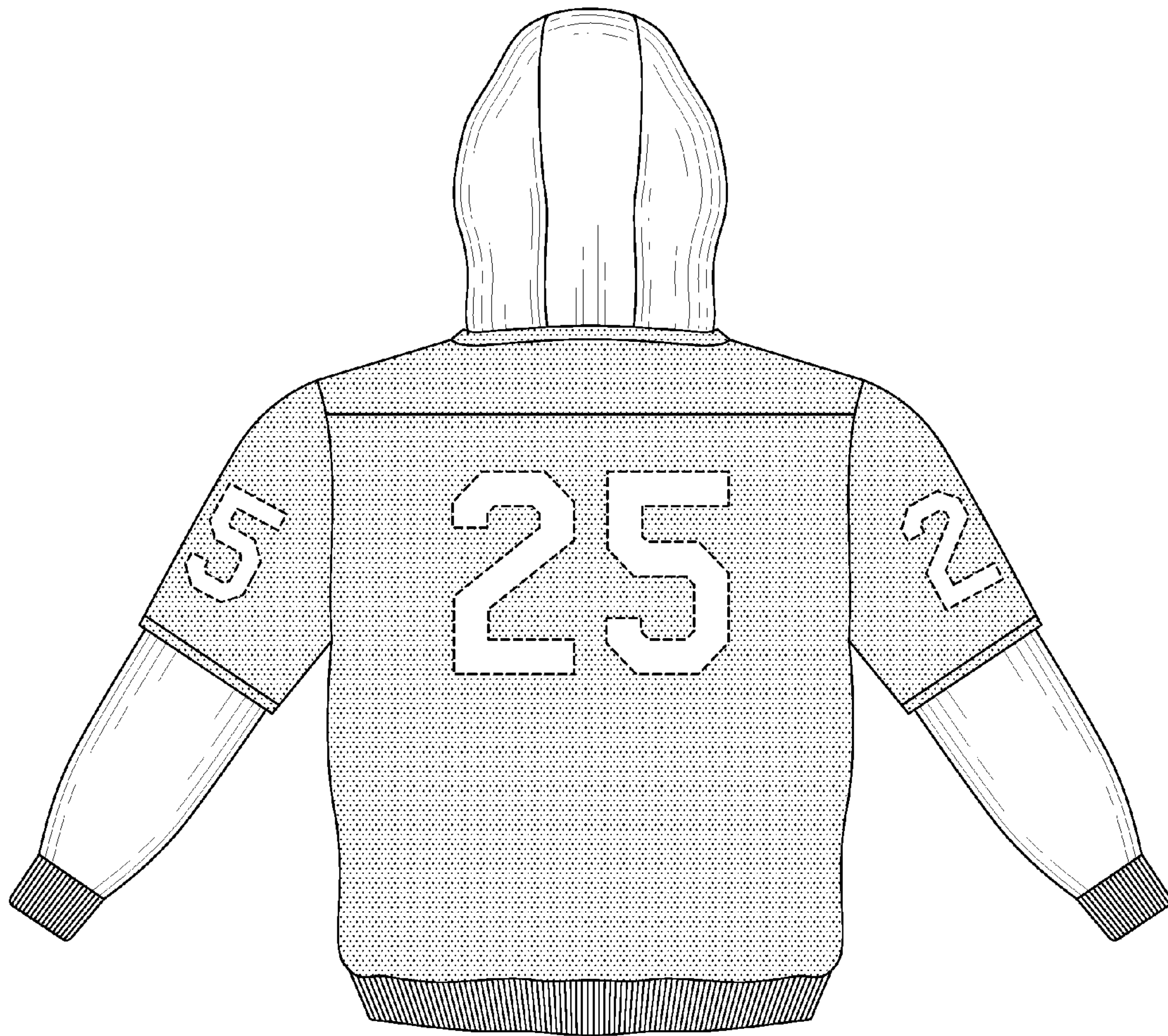

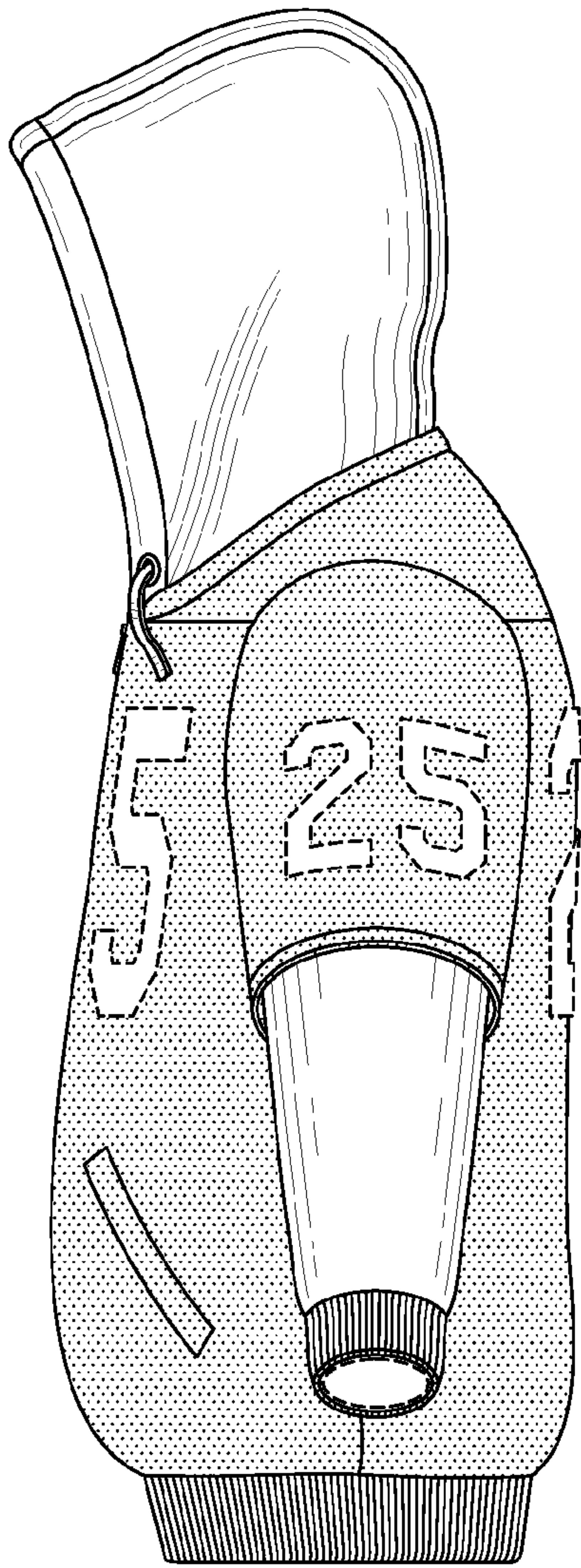




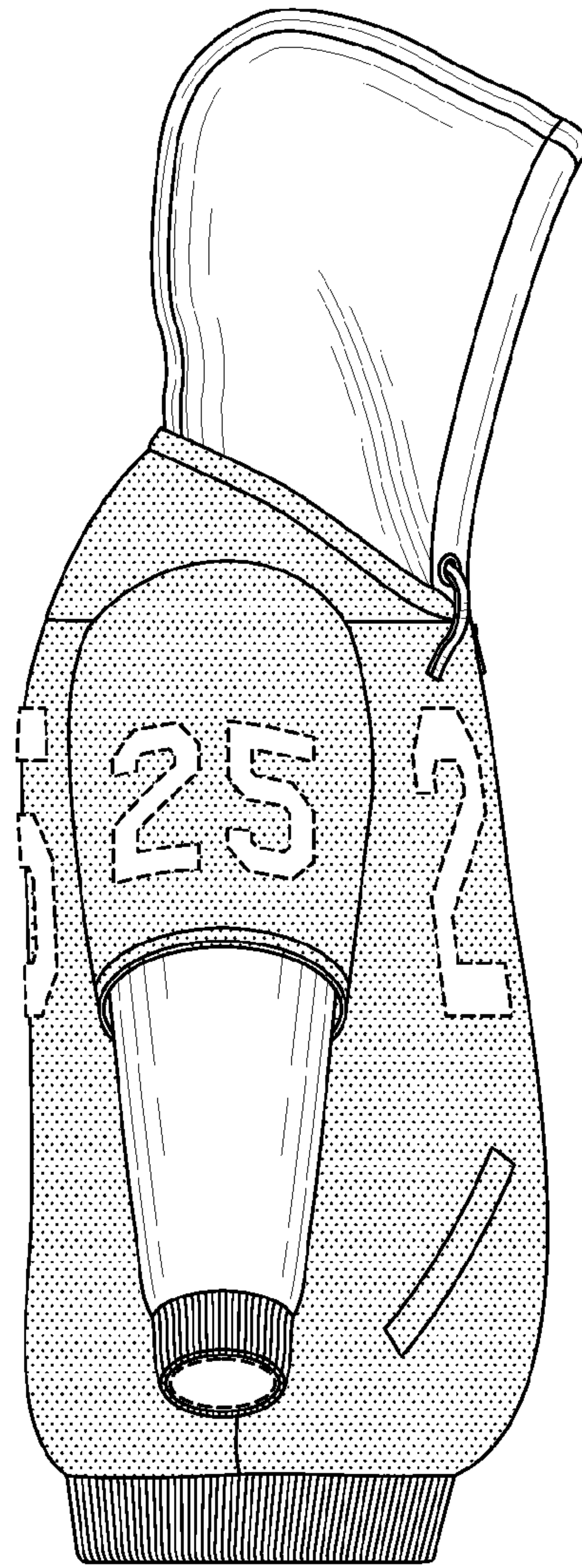

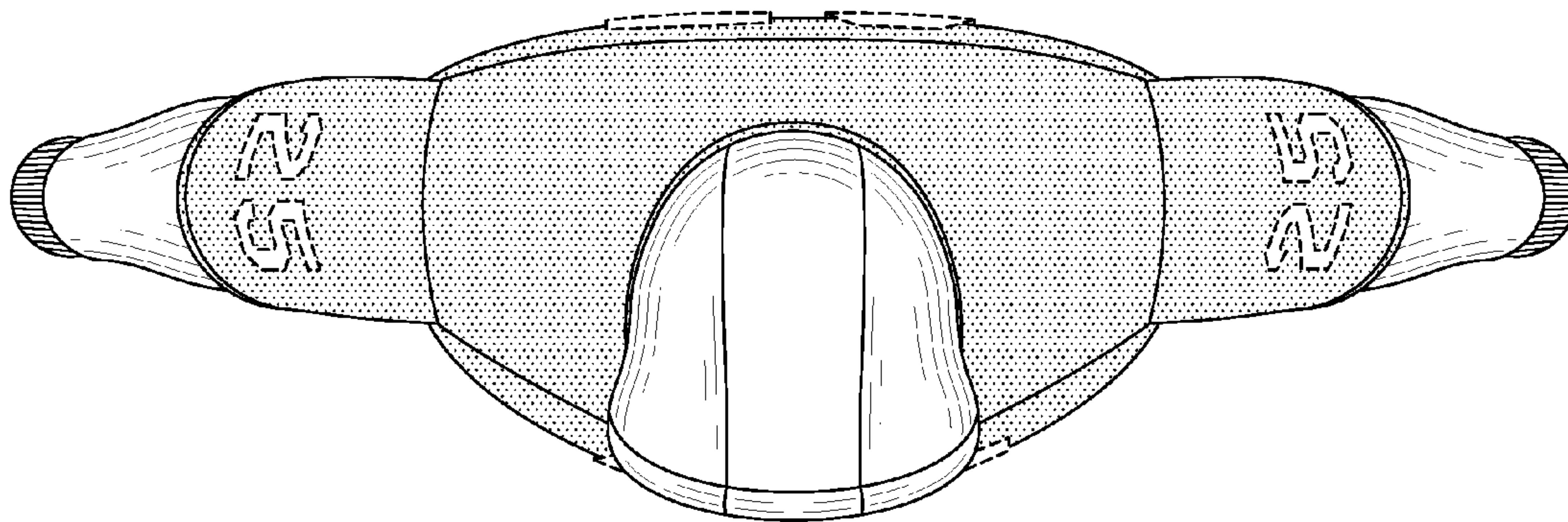

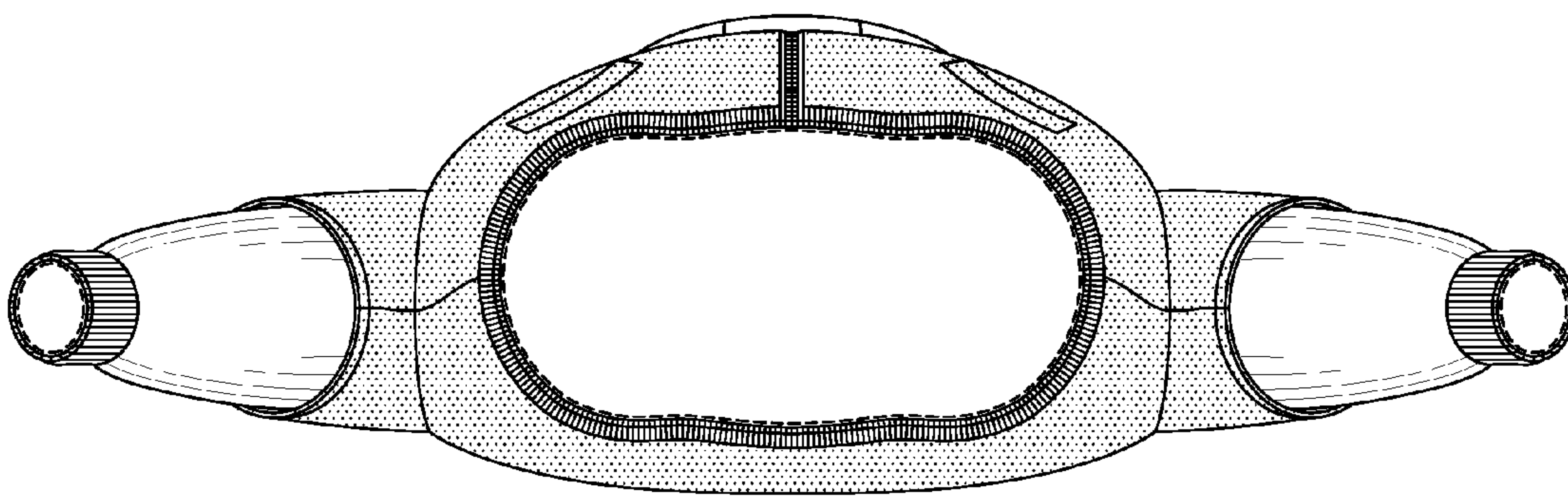
