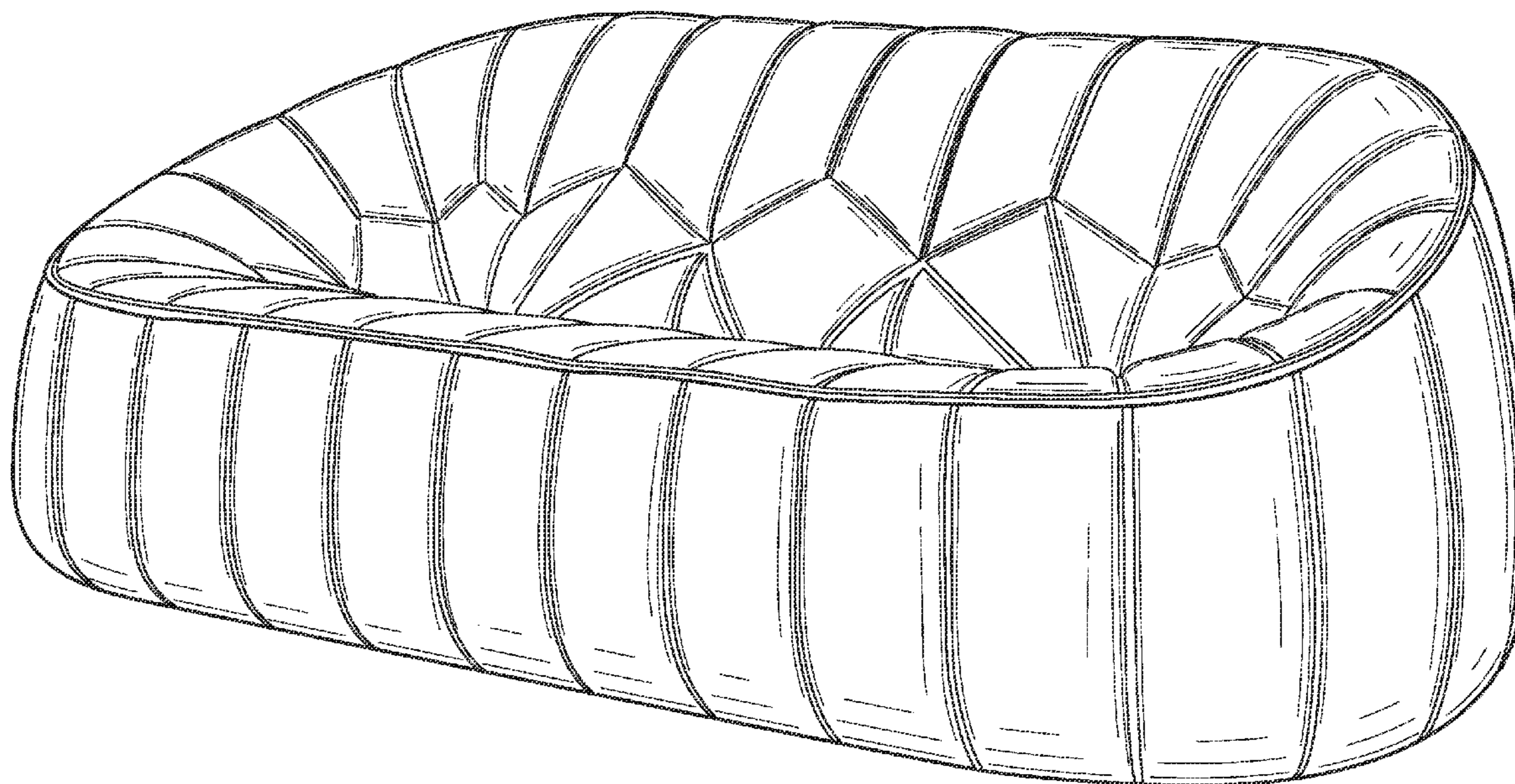
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a sofa, showing my new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a side view thereof taken from the right of FIG. 3, the opposite side being a mirror image thereof; and,

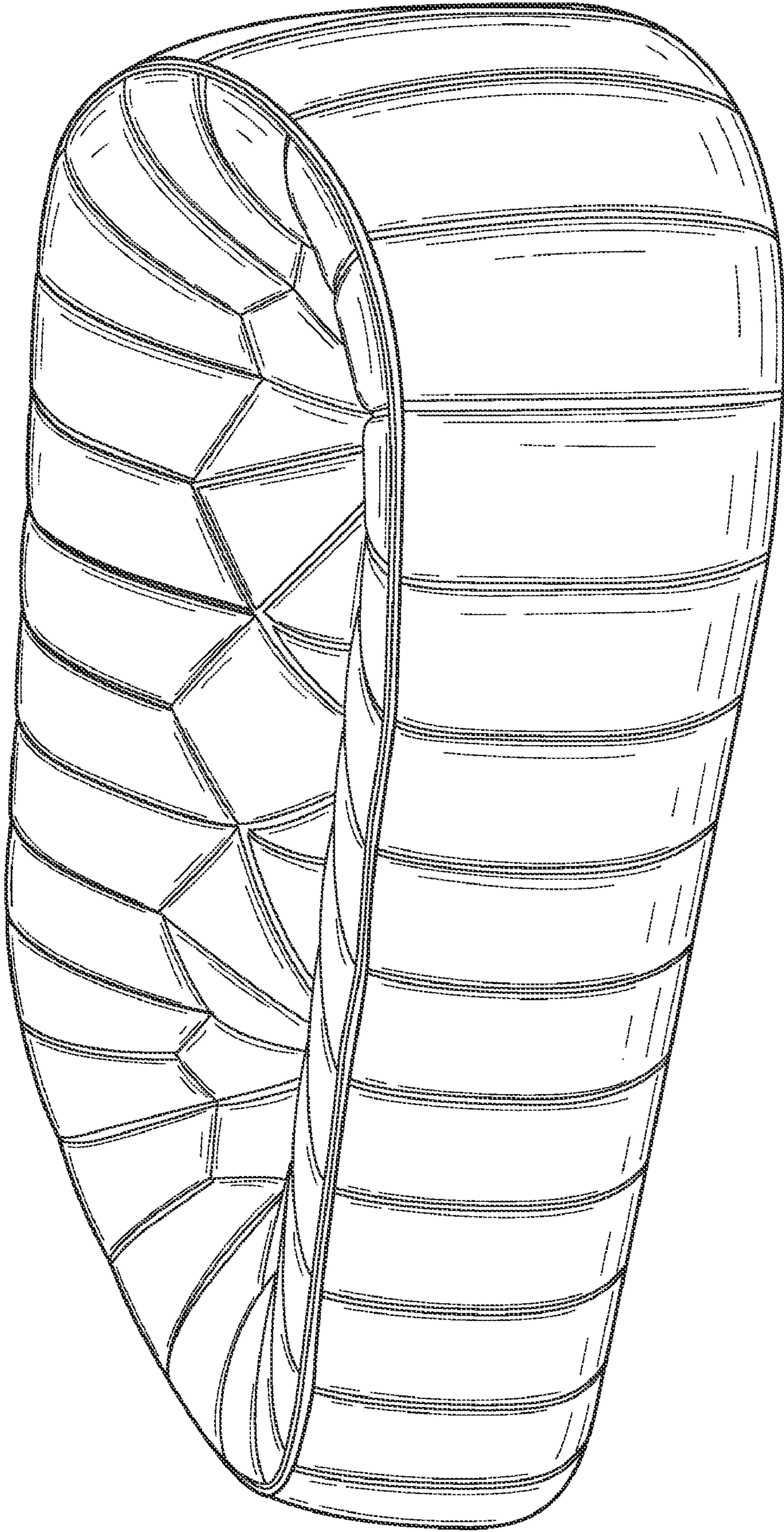

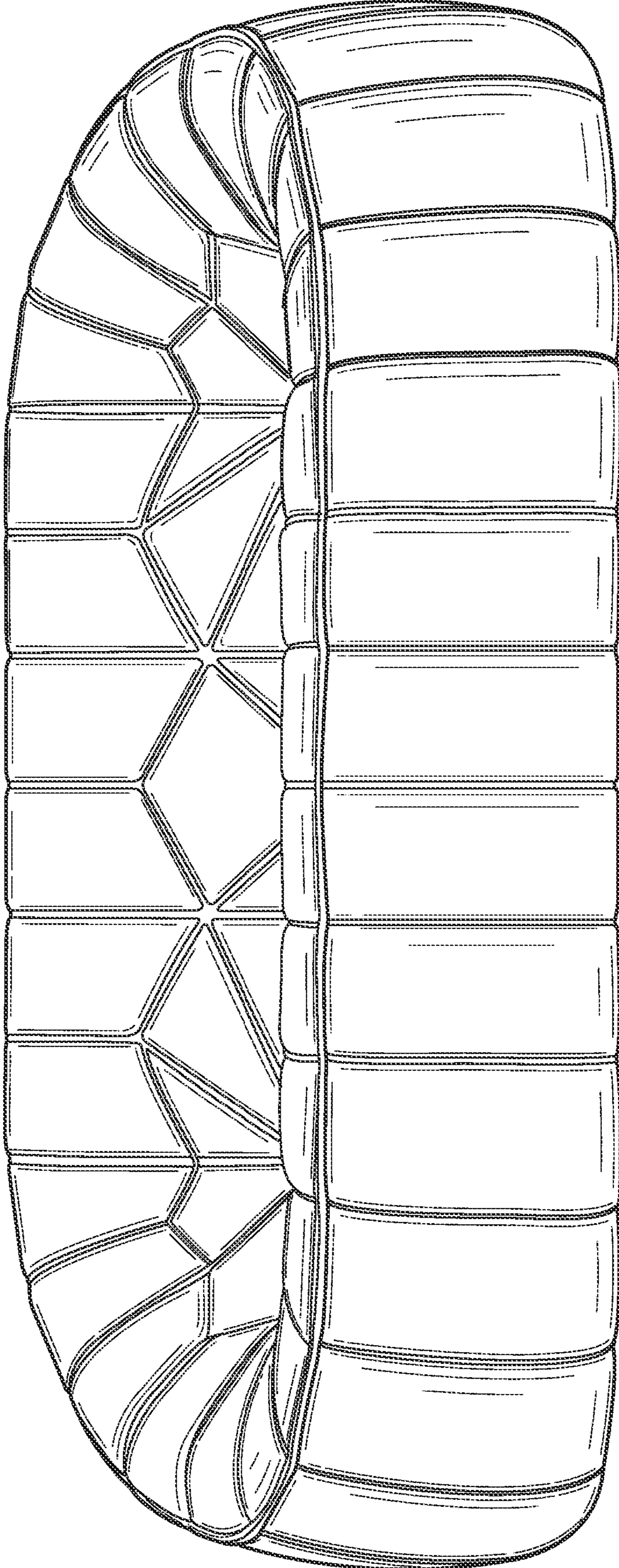

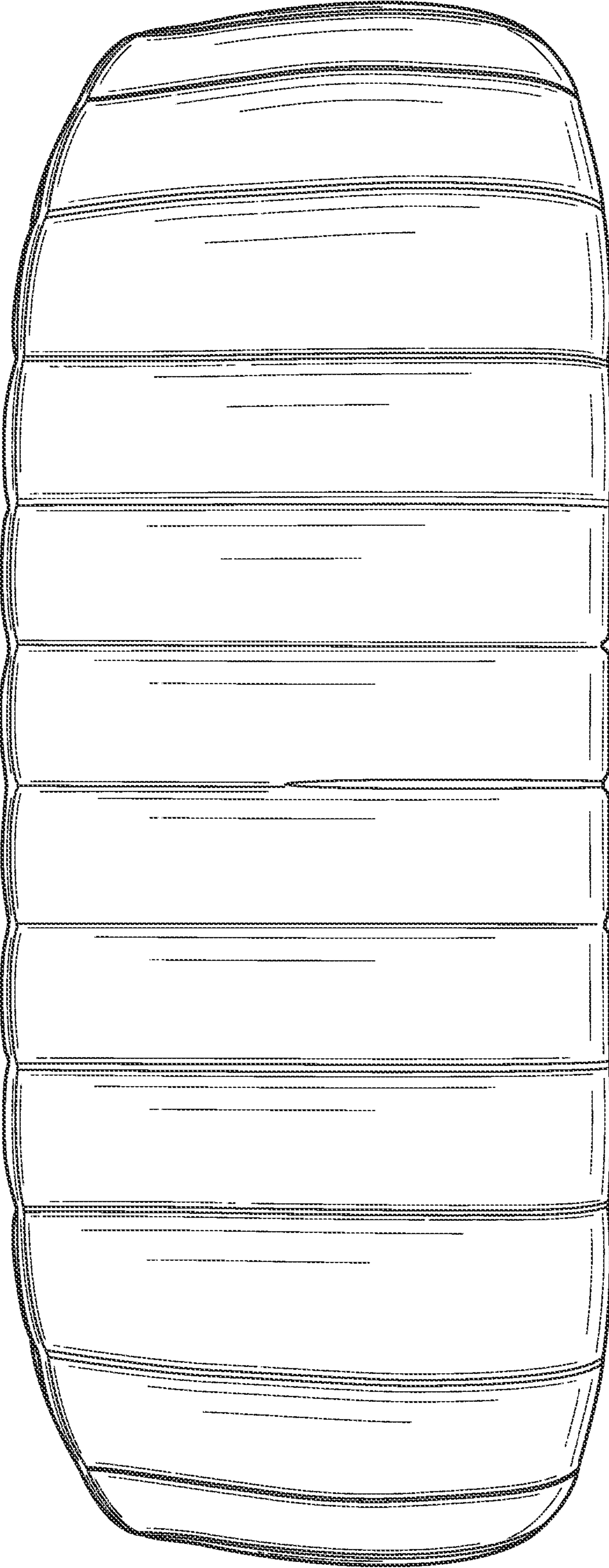

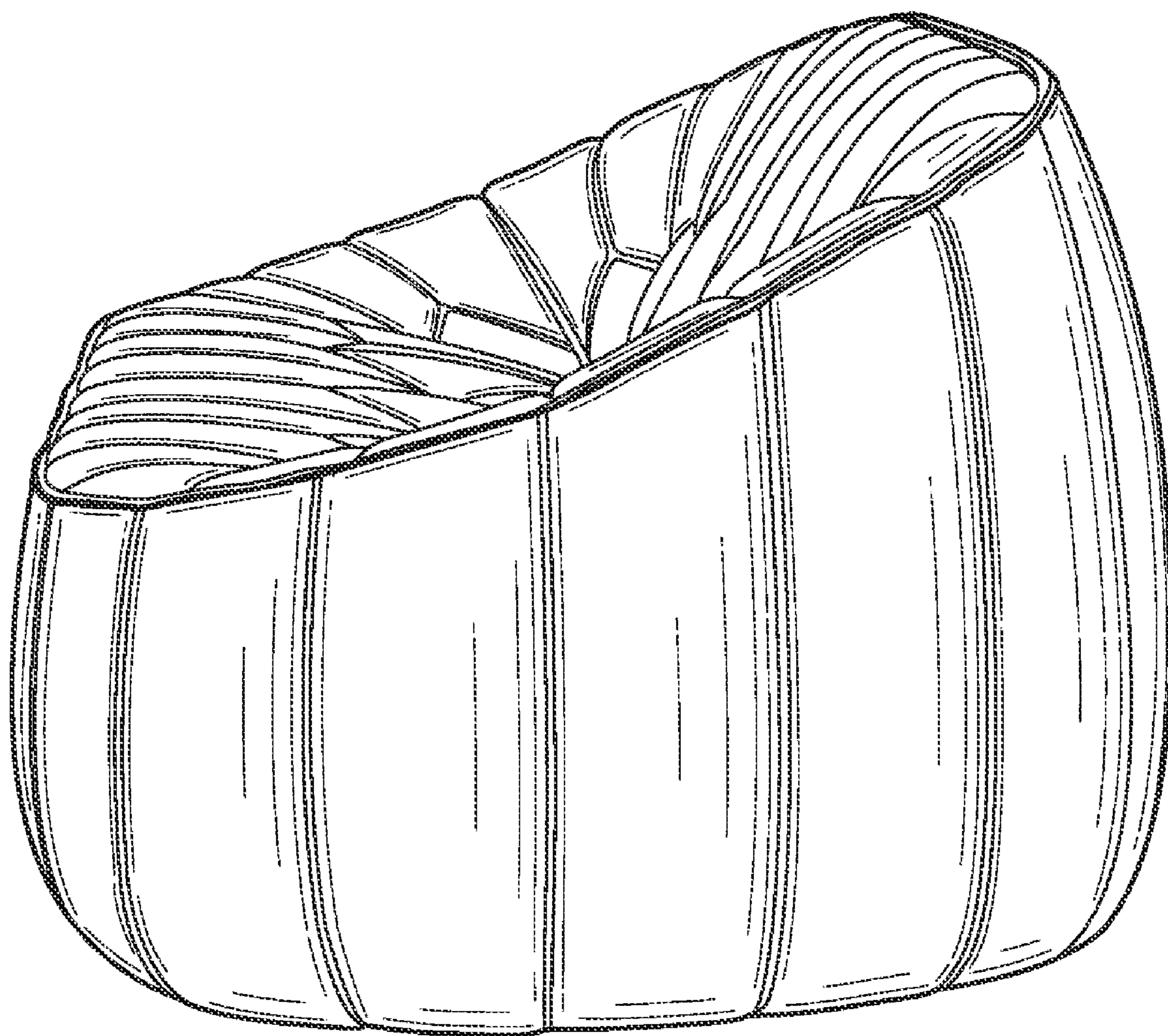

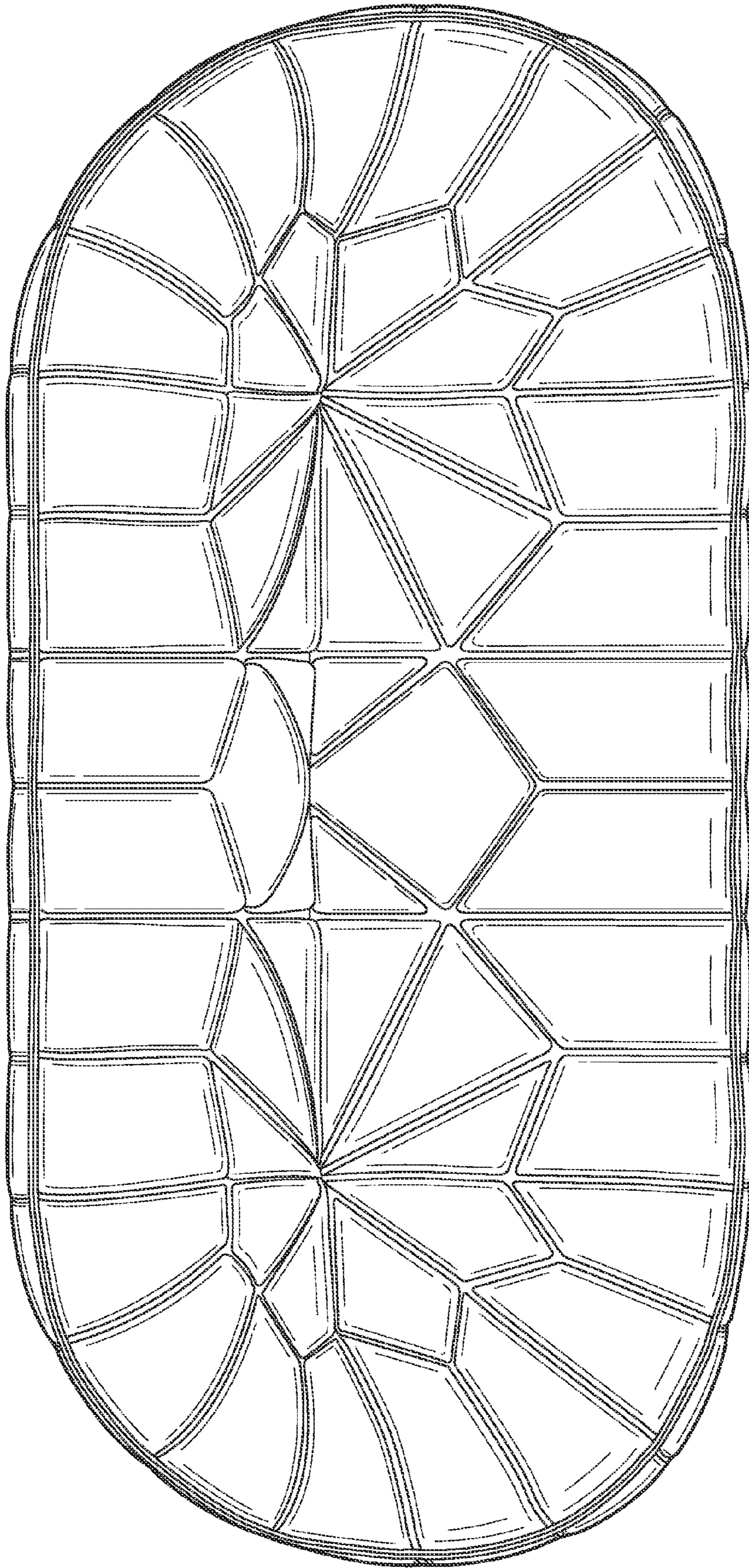
