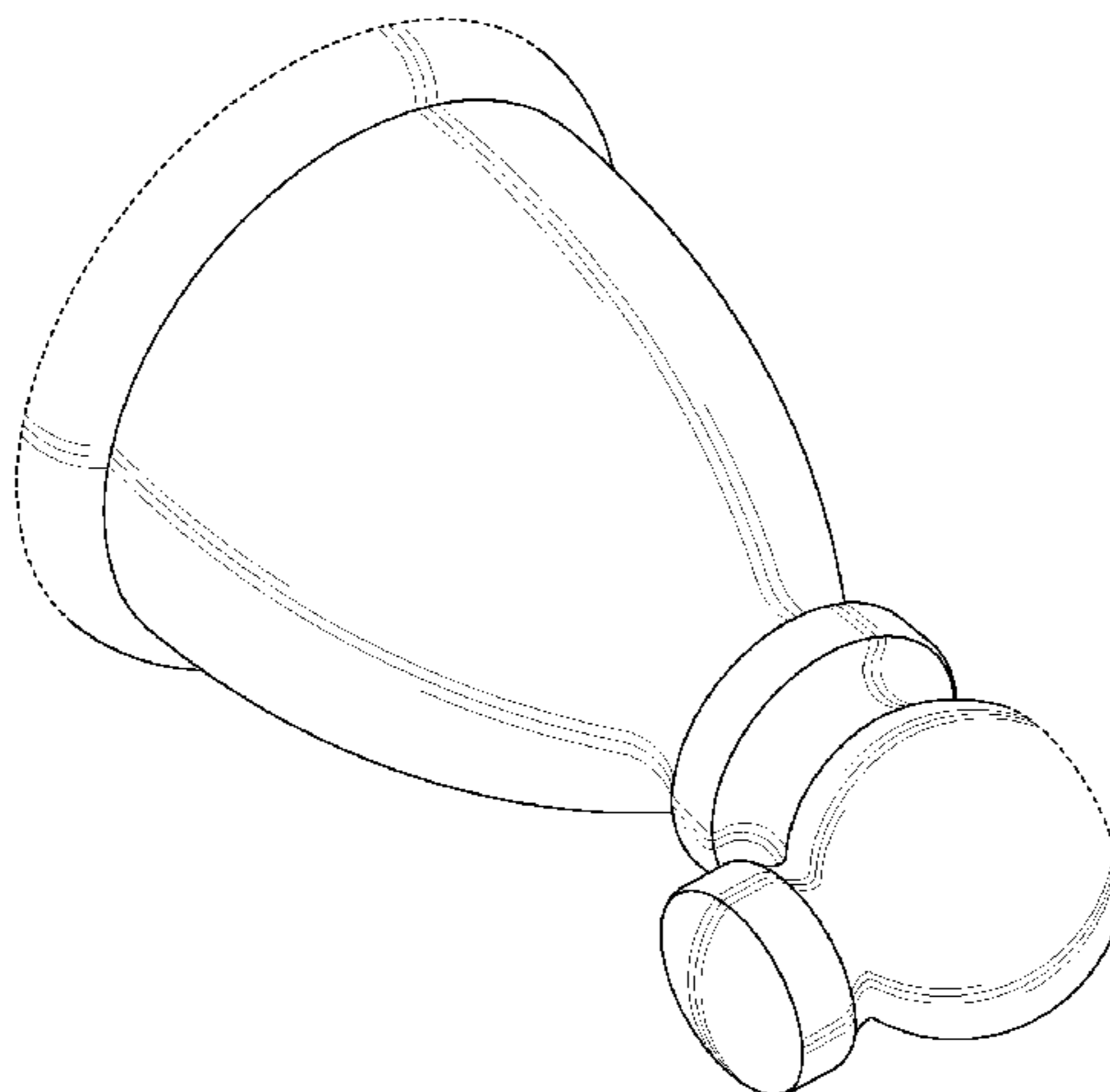

The ornamental design for an accessory post, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an accessory post of the new design;
FIG. 2 is a front elevational view of the accessory post of FIG. 1;
FIG. 3 is a left side elevational view of the accessory post of FIG. 1;
FIG. 4 is a right side elevational view of the accessory post of FIG. 1; and,
FIG. 5 is a top plan view of the accessory post of FIG. 1, the bottom plan view being a mirror image thereof.
The broken-line disclosure in the views is understood to represent portions of the article in which the claimed design is embodied, but which forms no part of the claimed design.

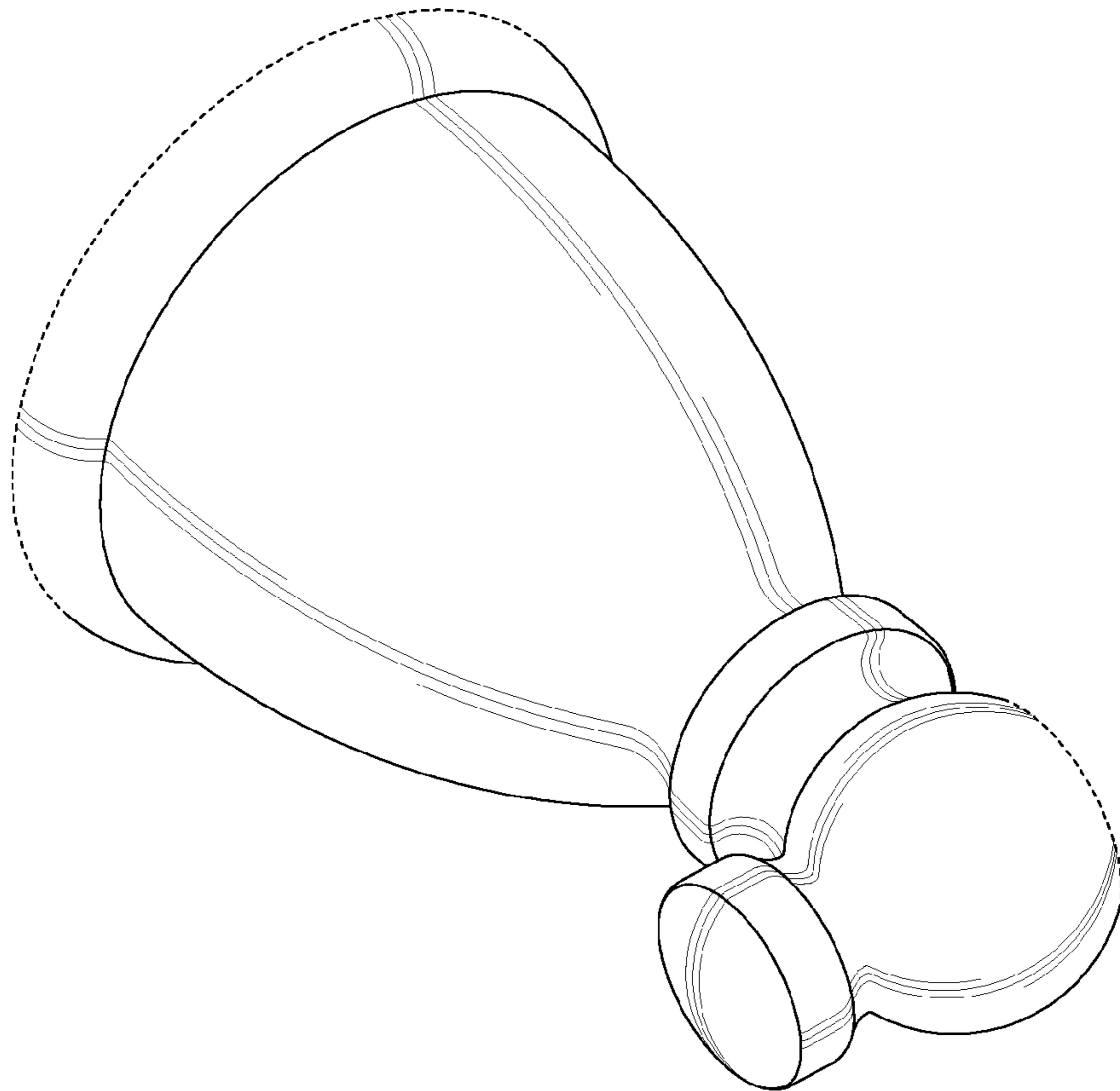

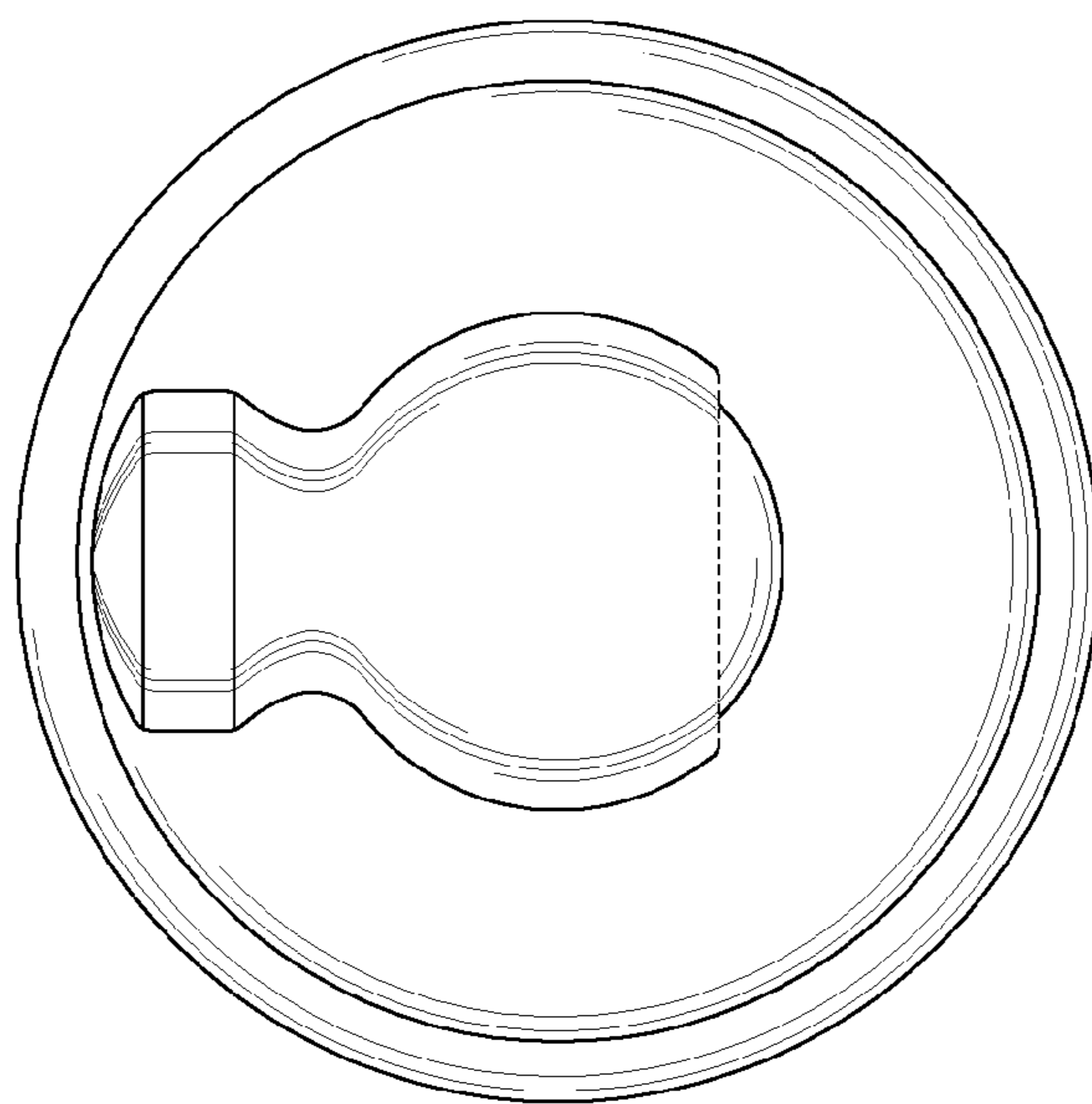

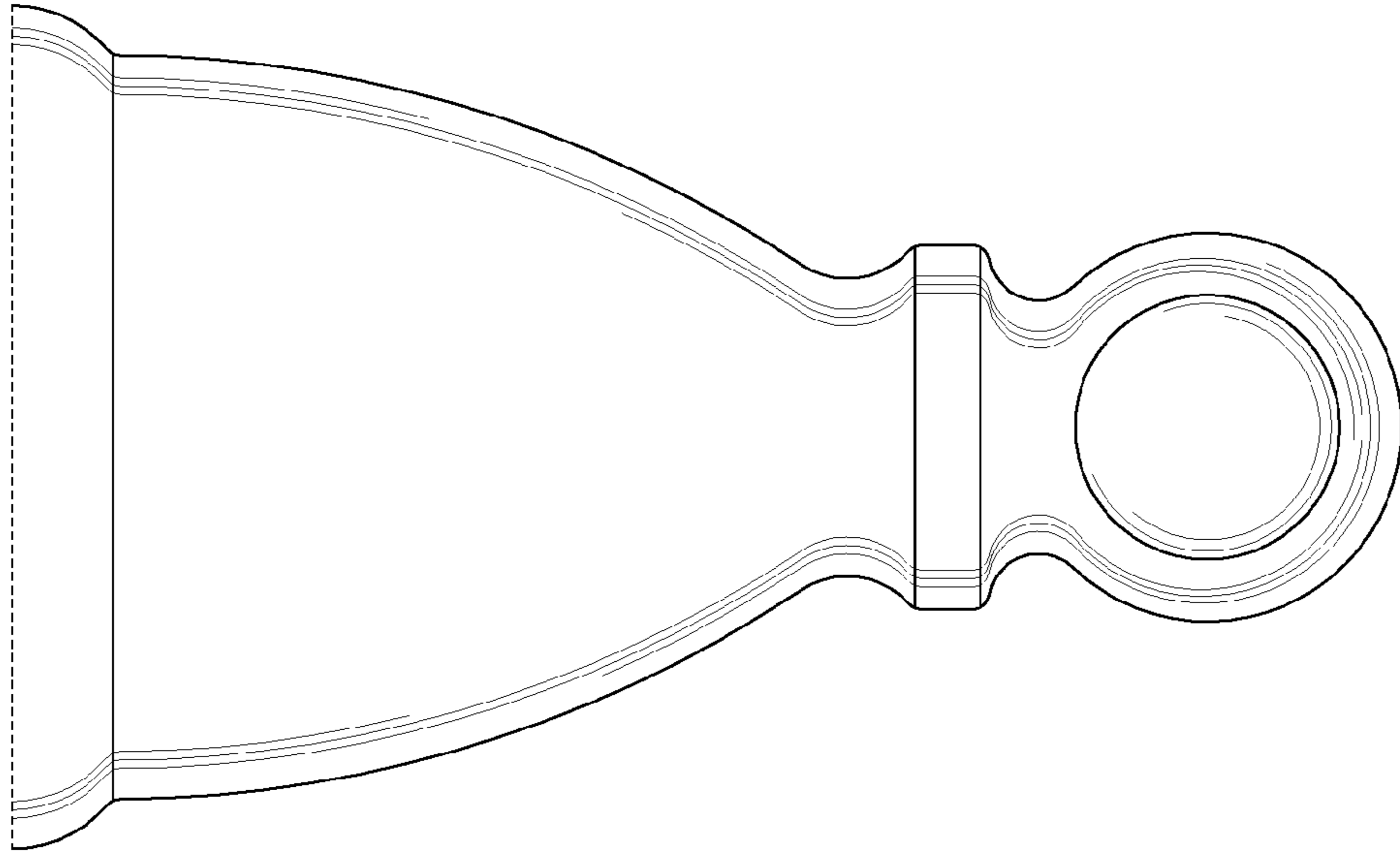

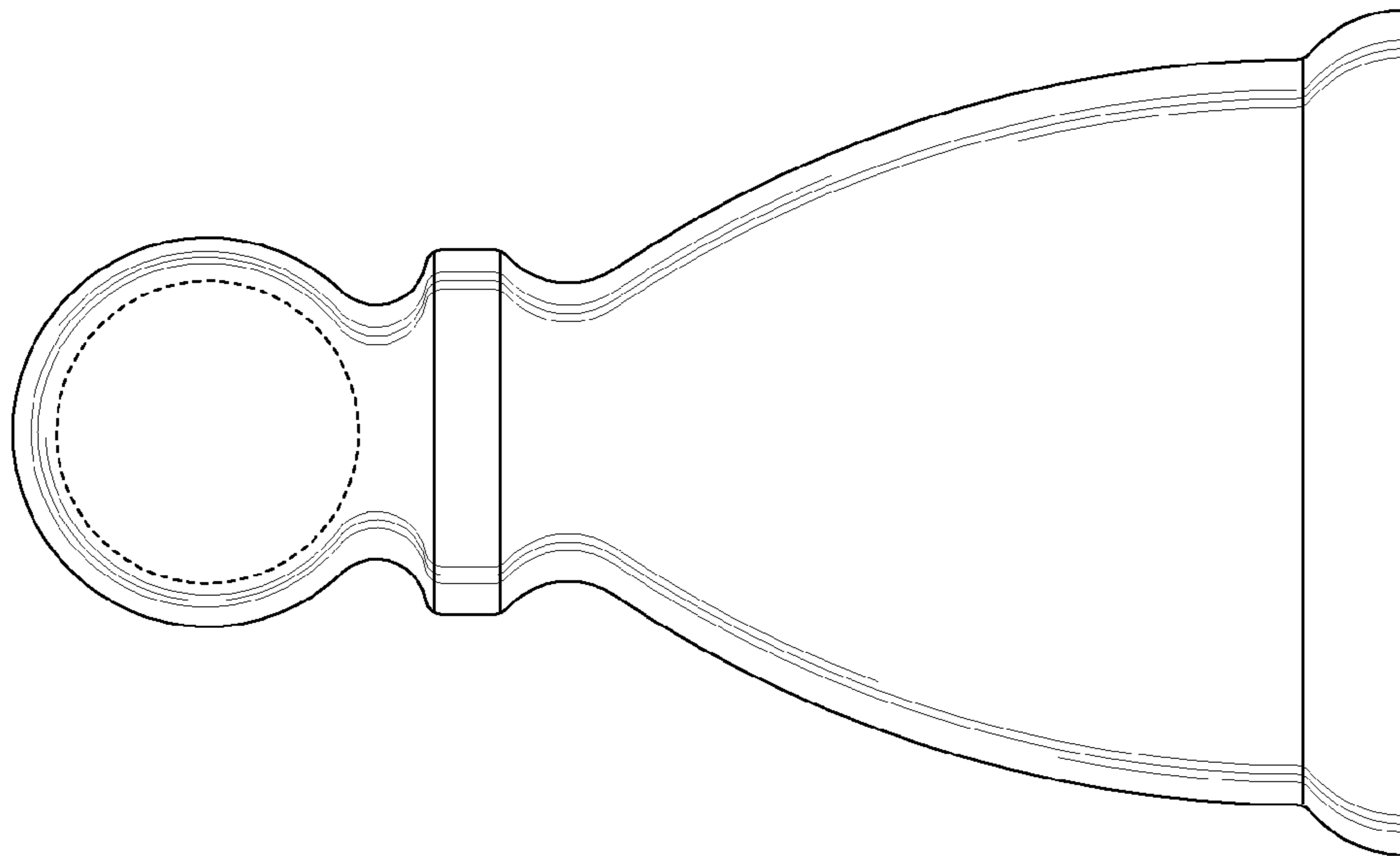

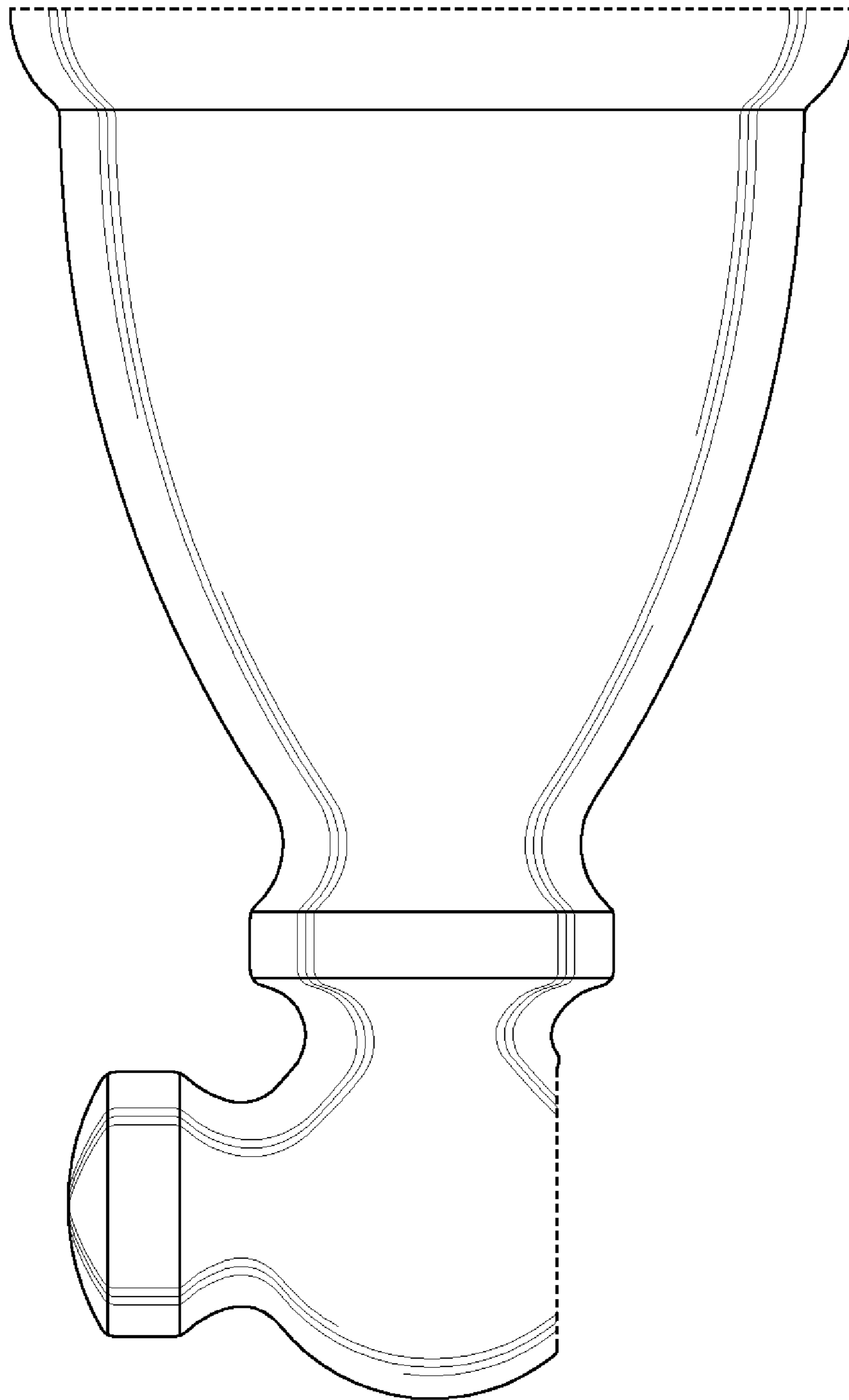
