FIG. 2 is a second perspective view thereof;

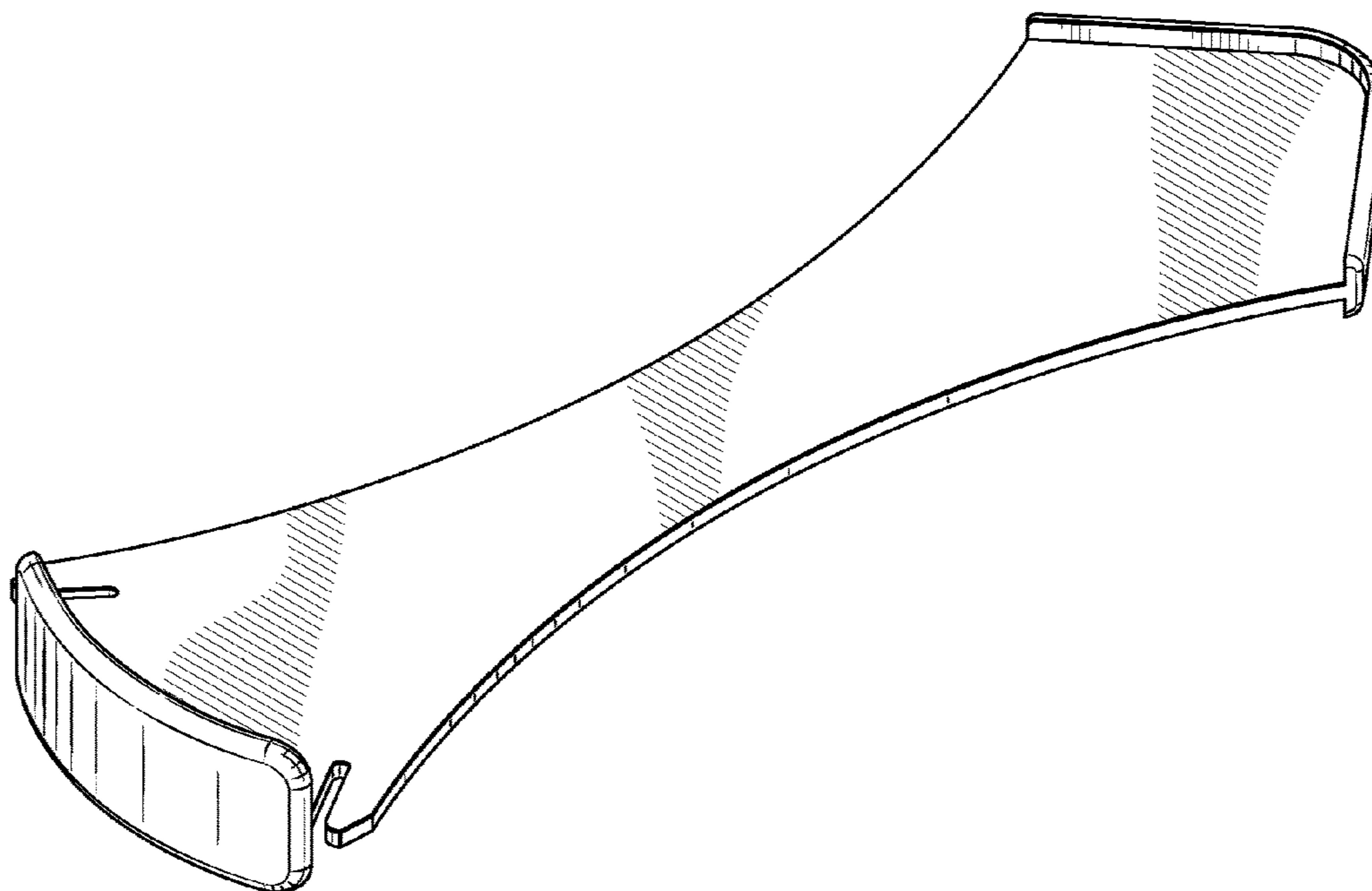
FIG. 3 is a top view thereof, the bottom view being a mirror

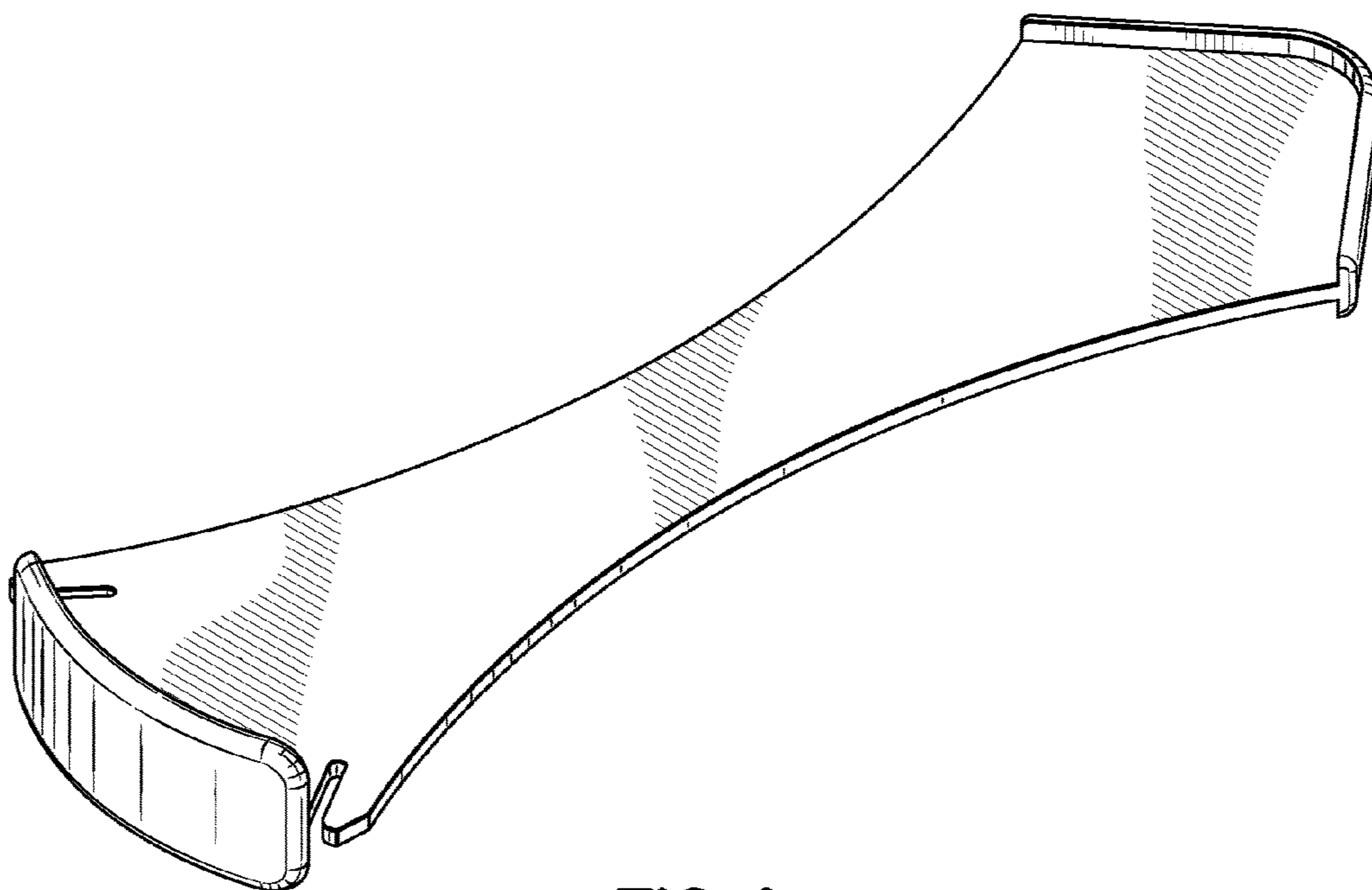

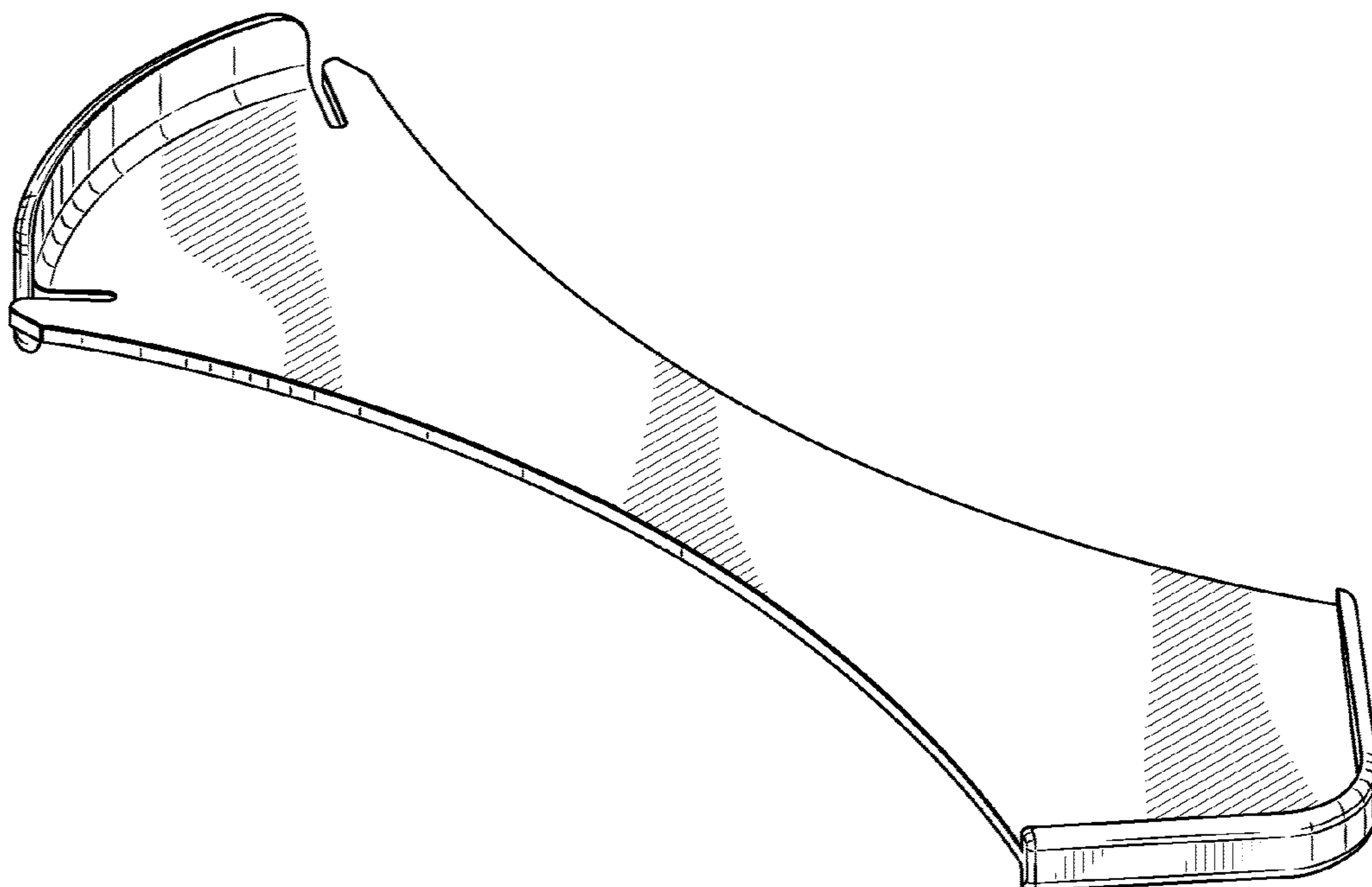

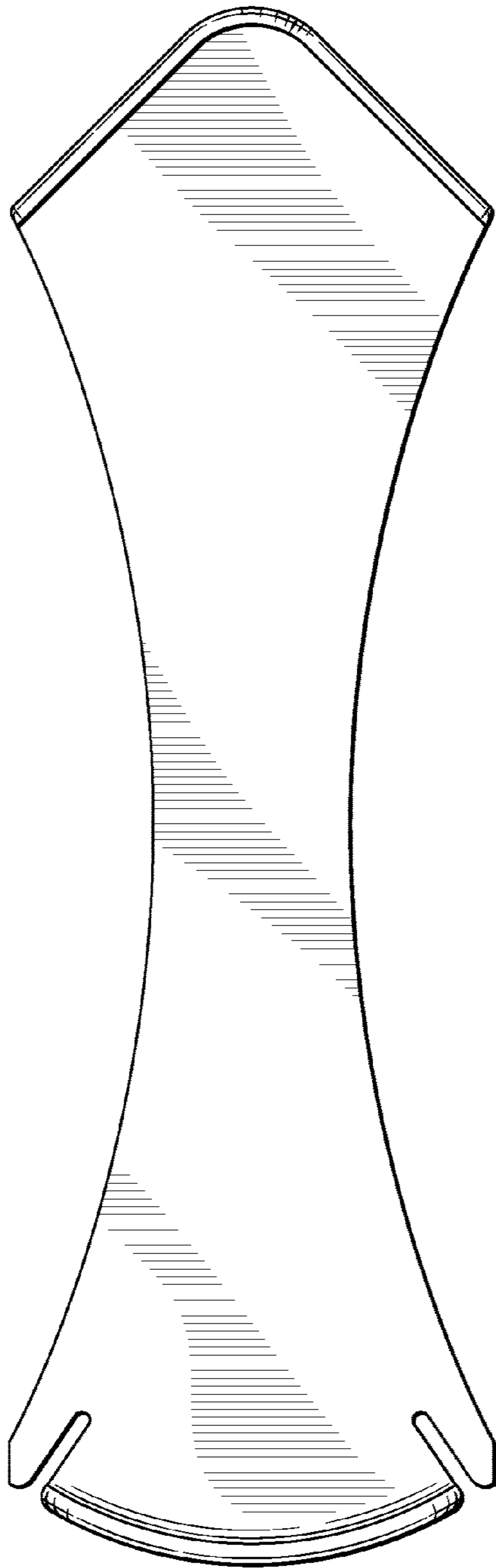

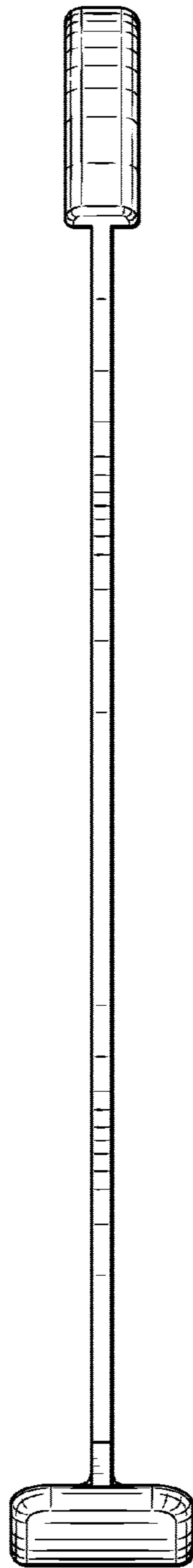

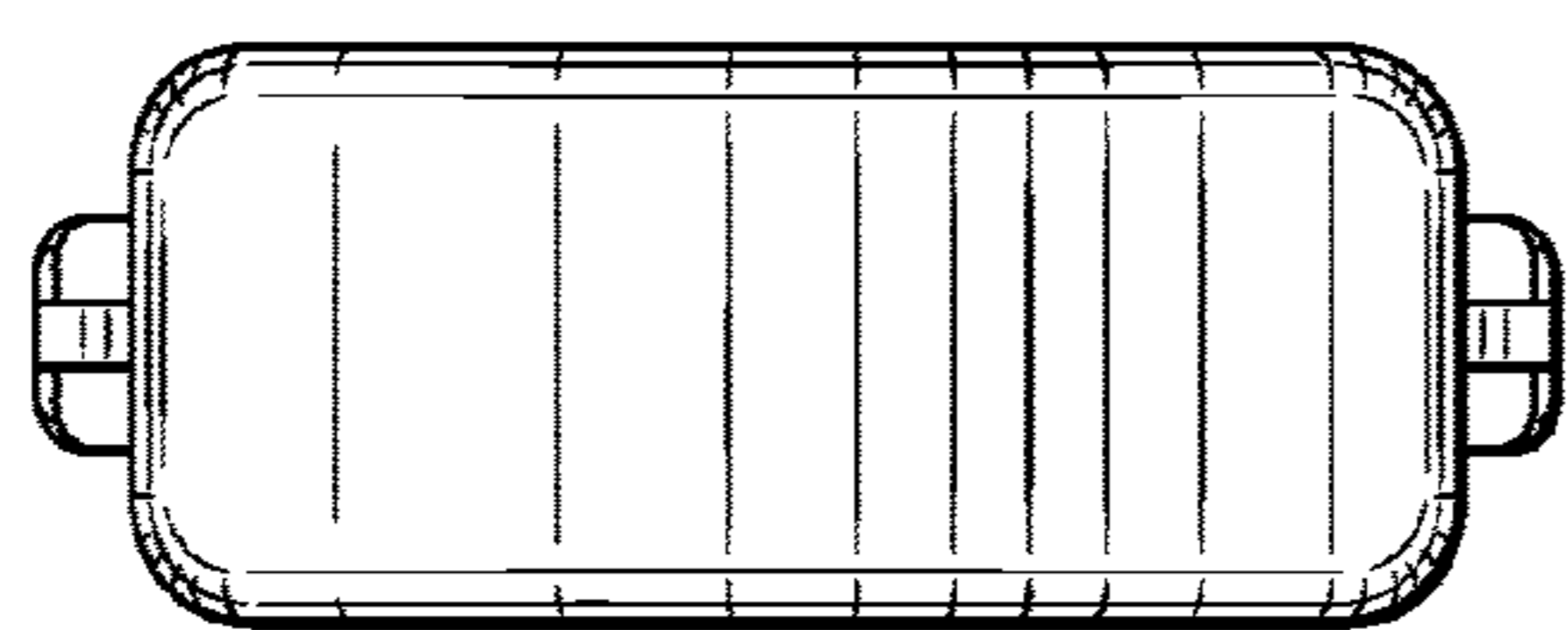

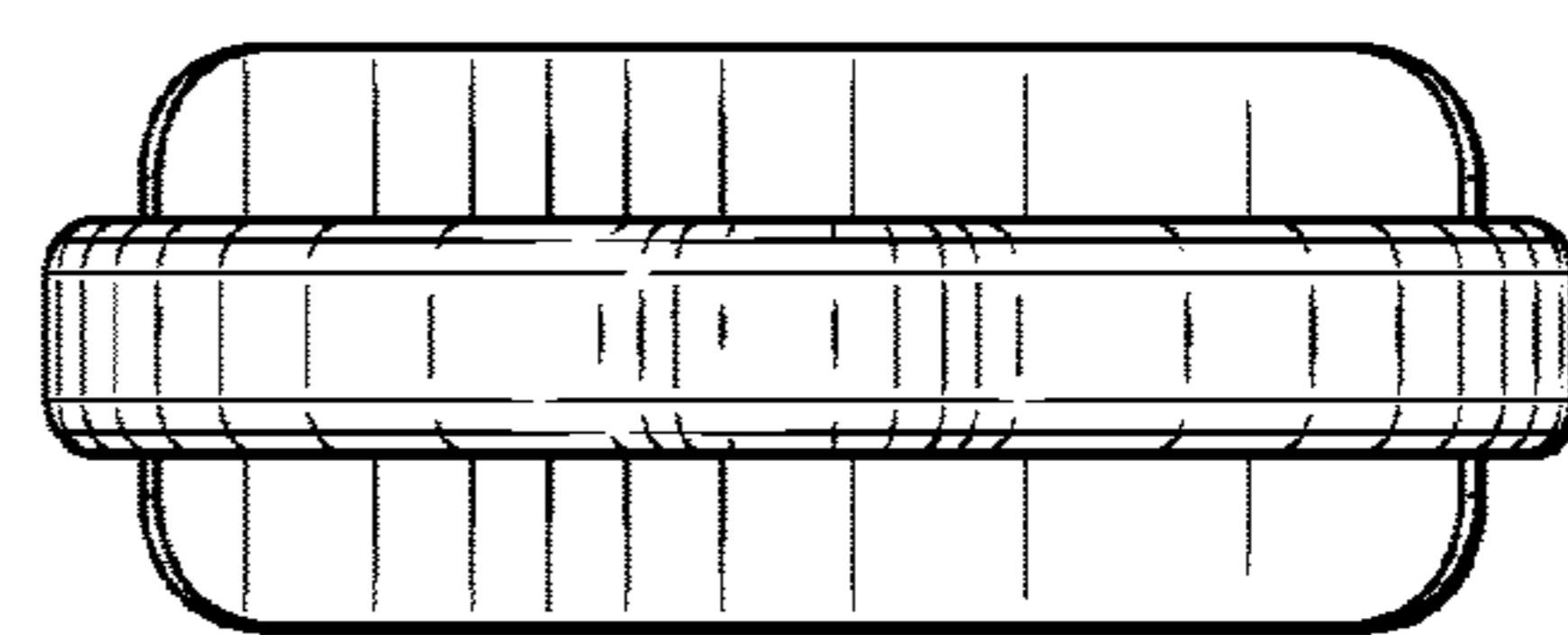
