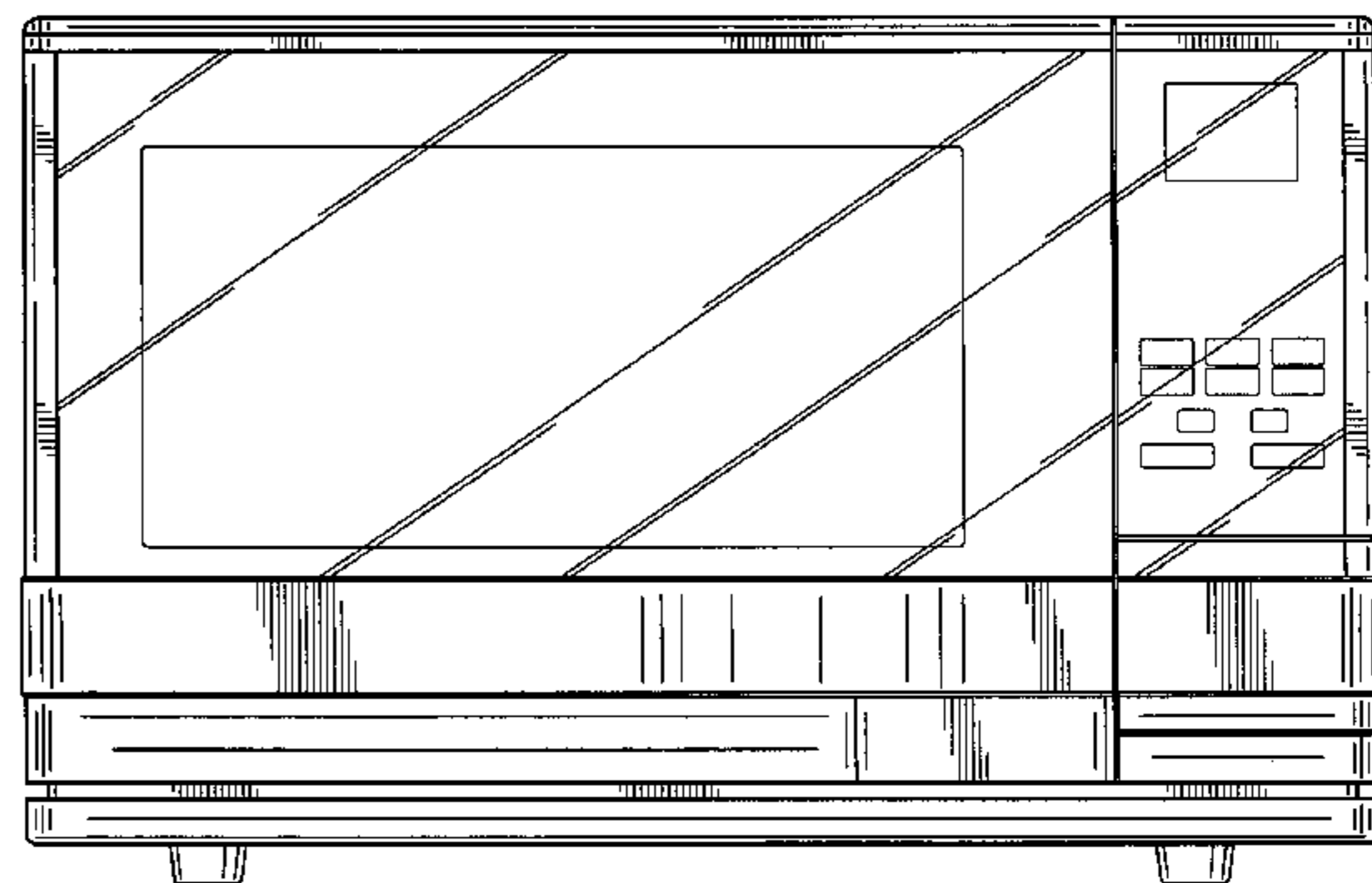
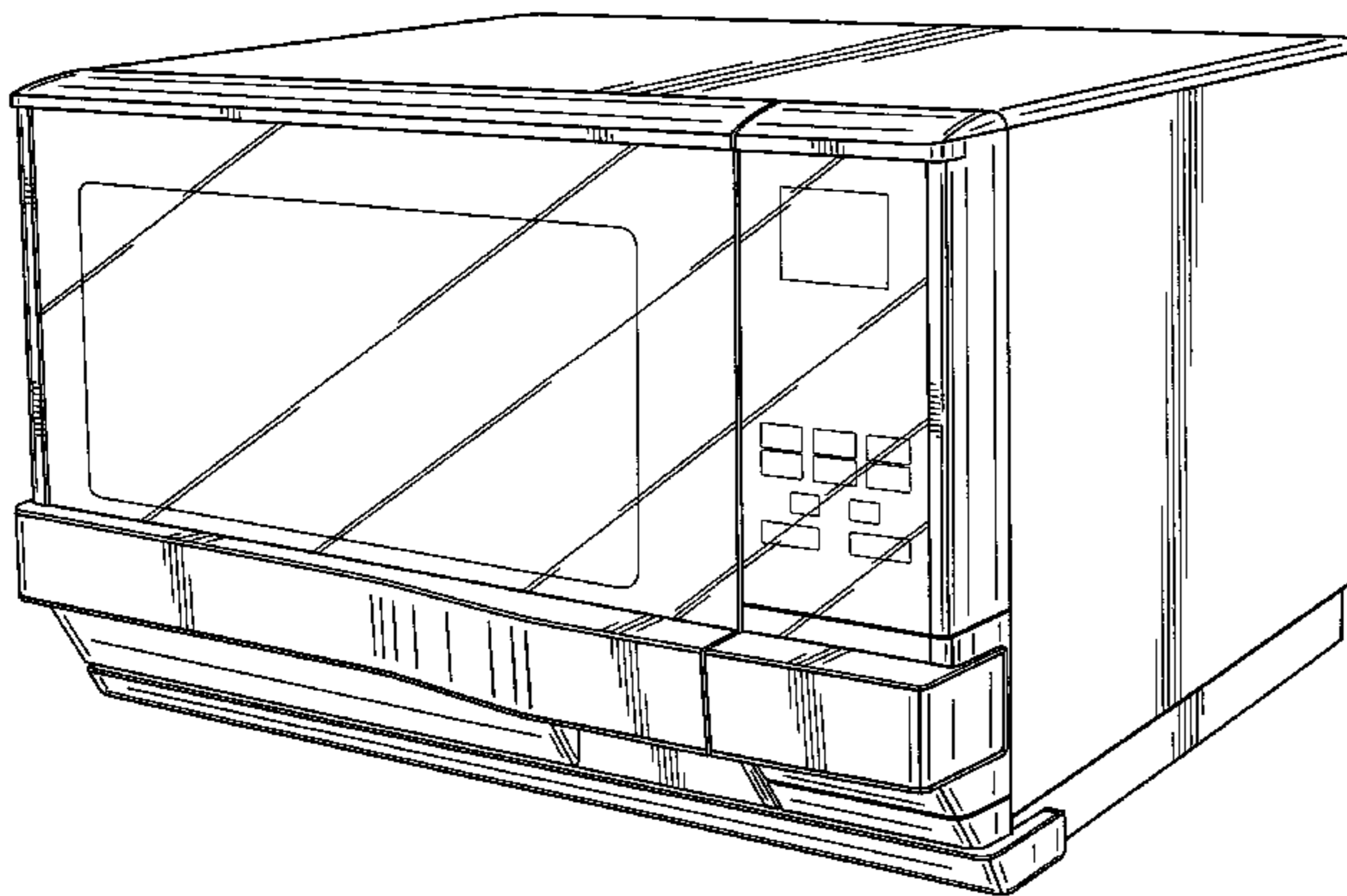
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top right front perspective view of a cooking oven in accordance with our new design;

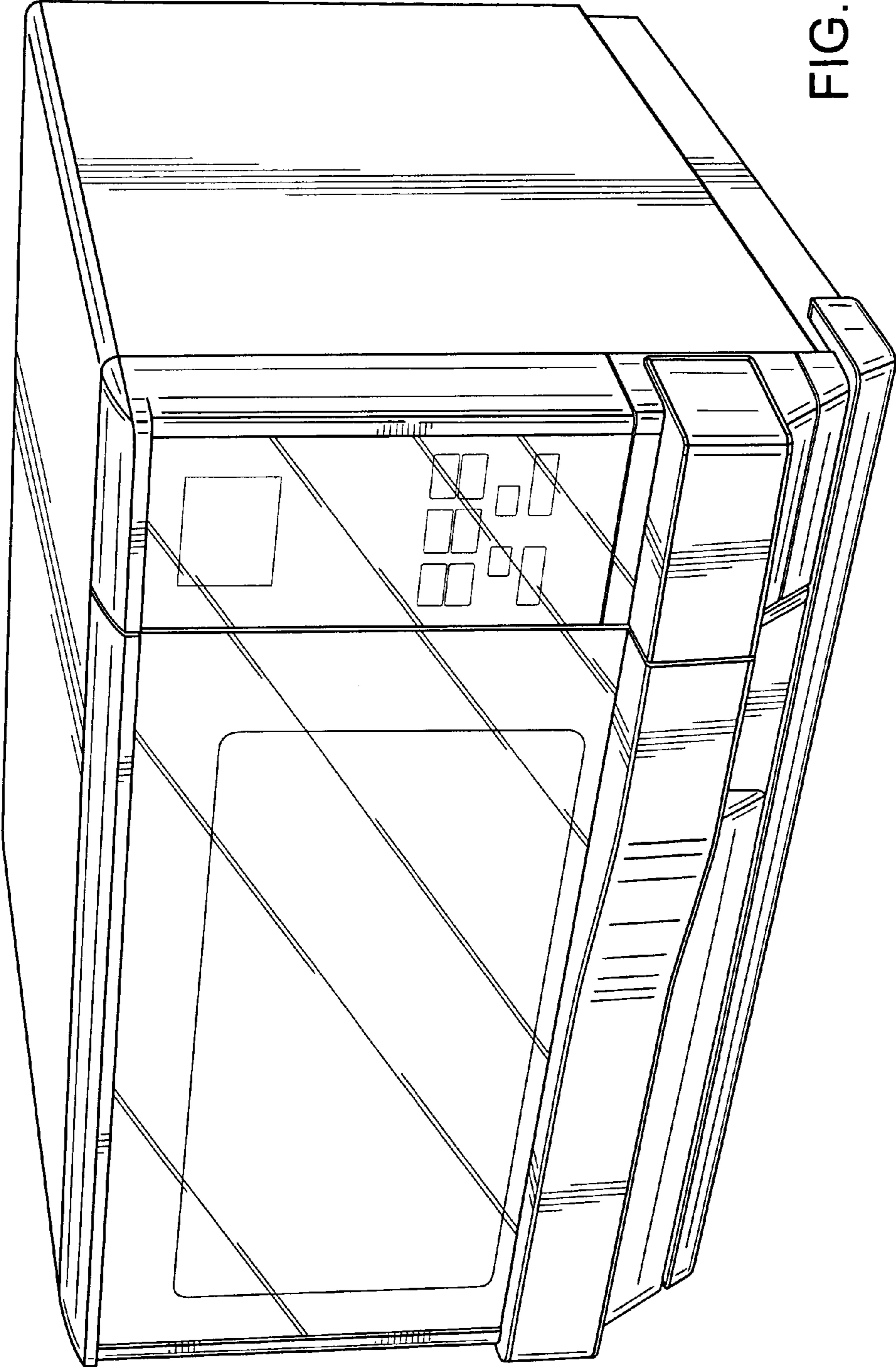

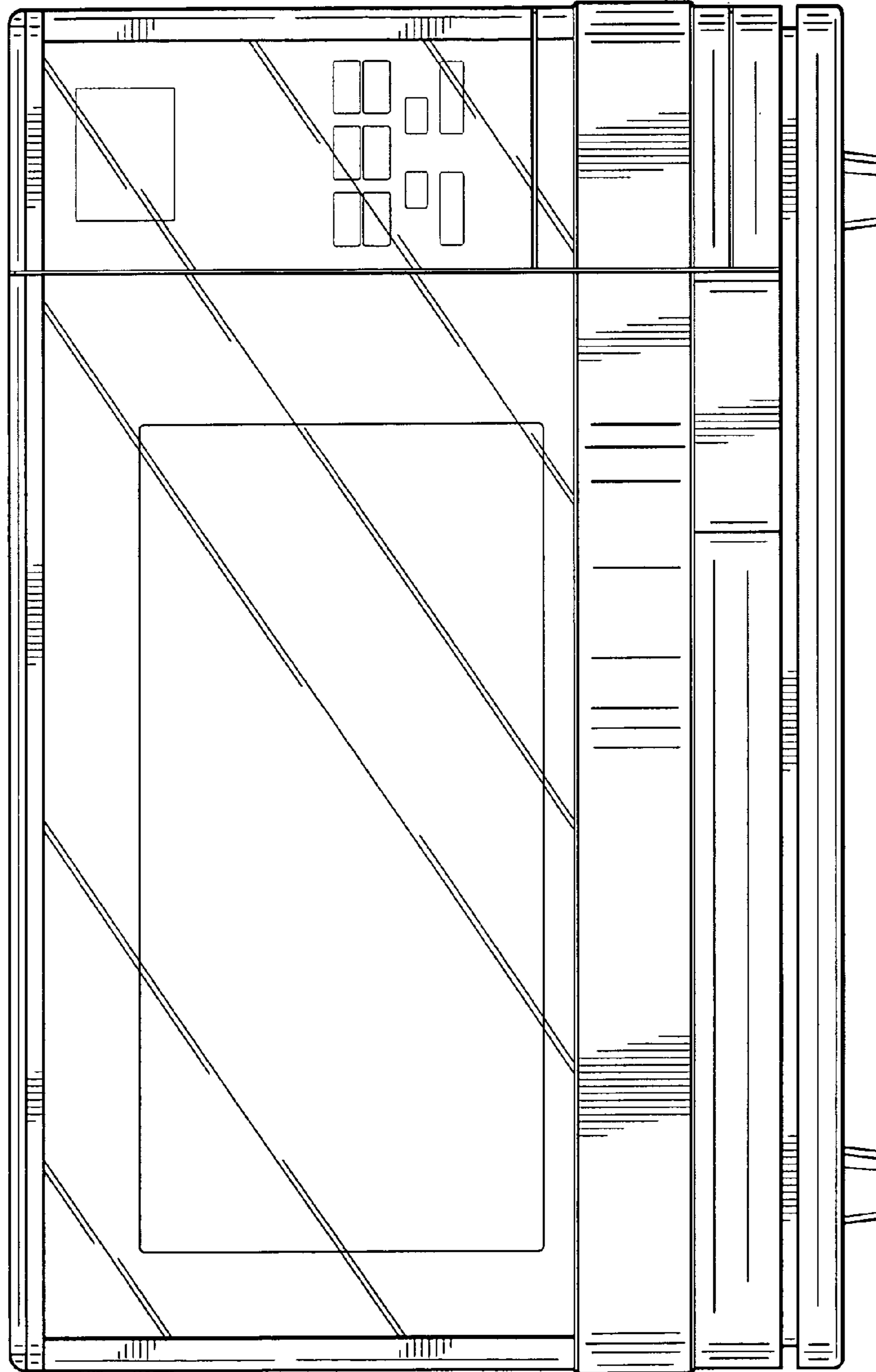

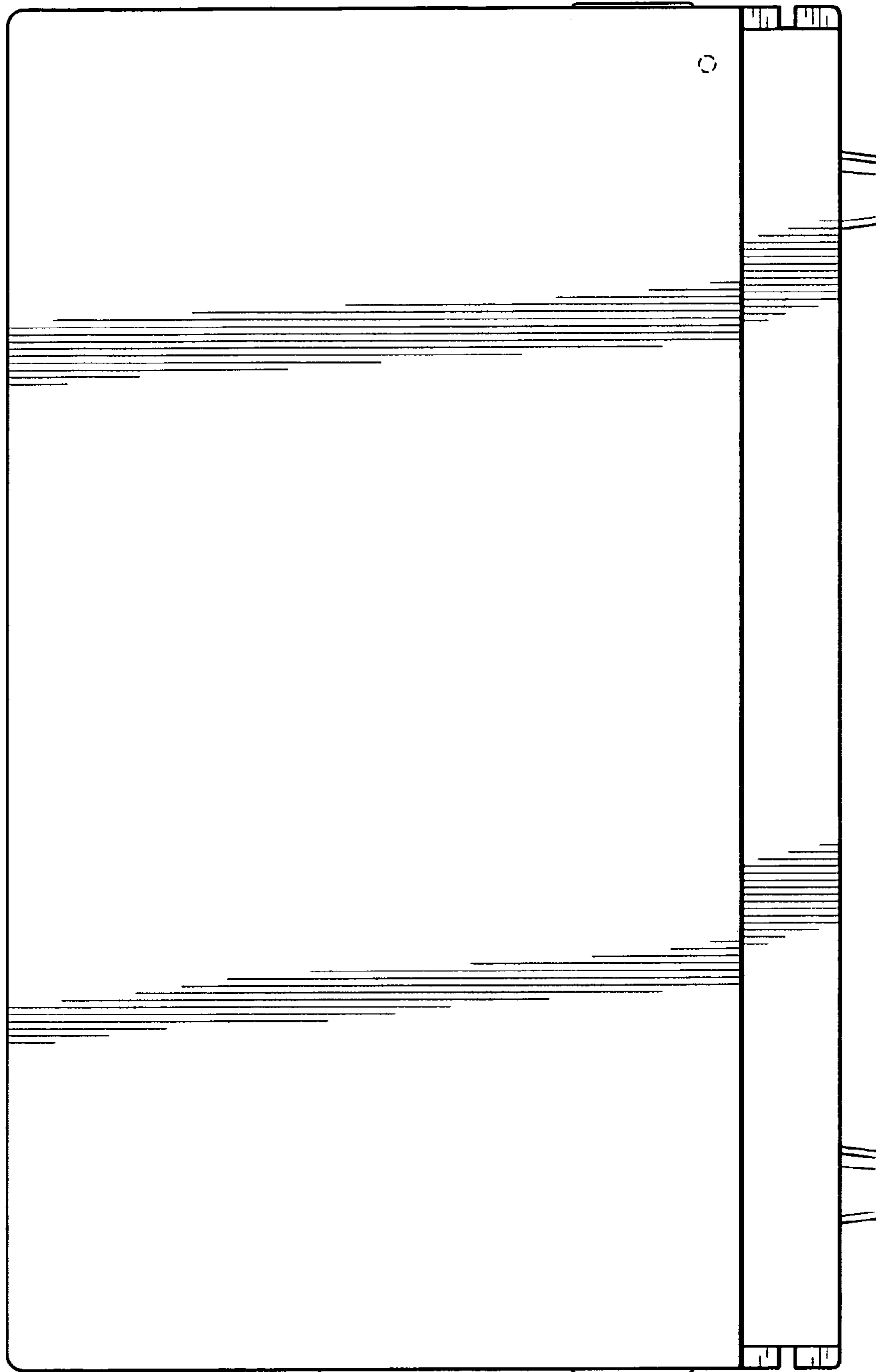

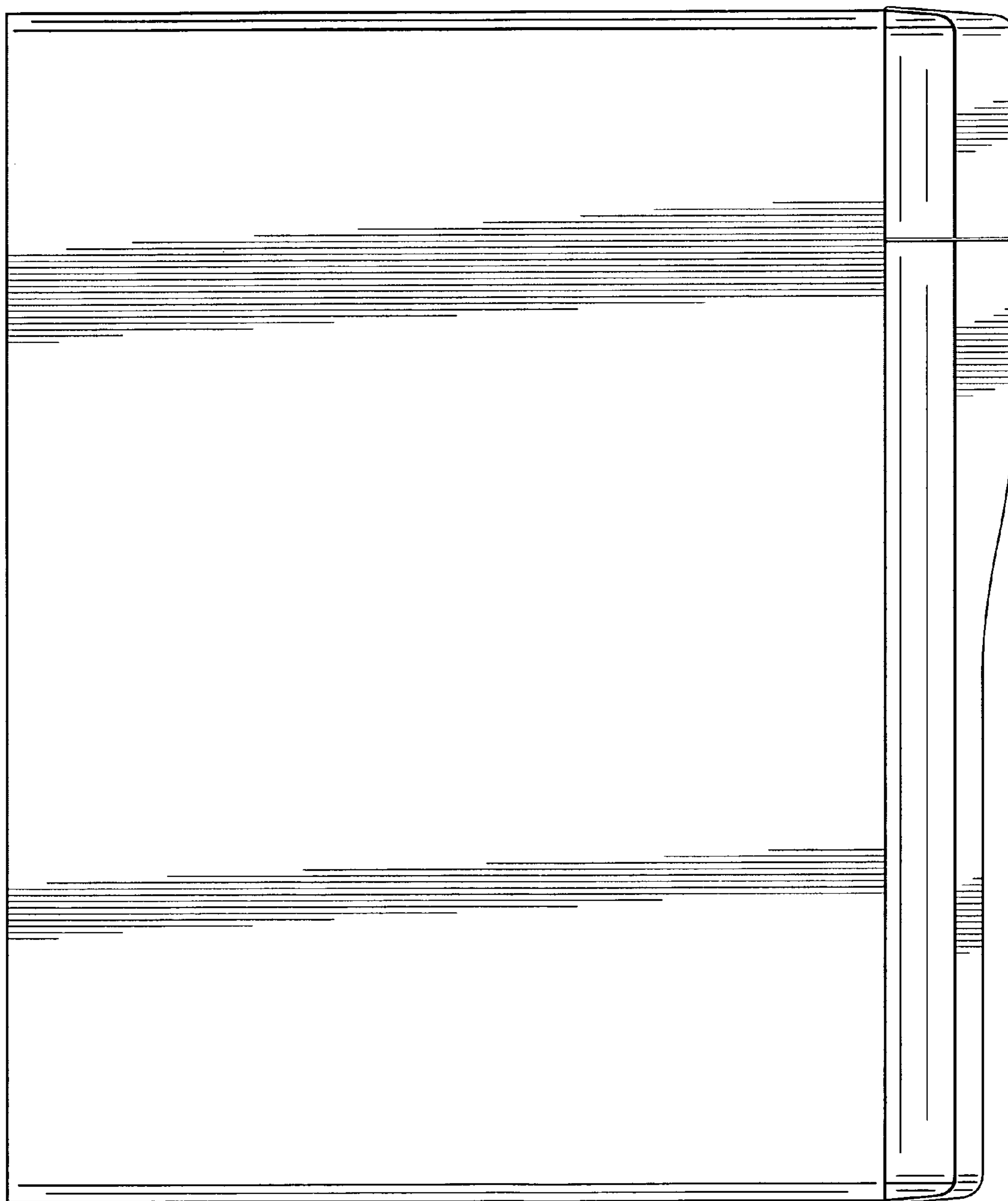
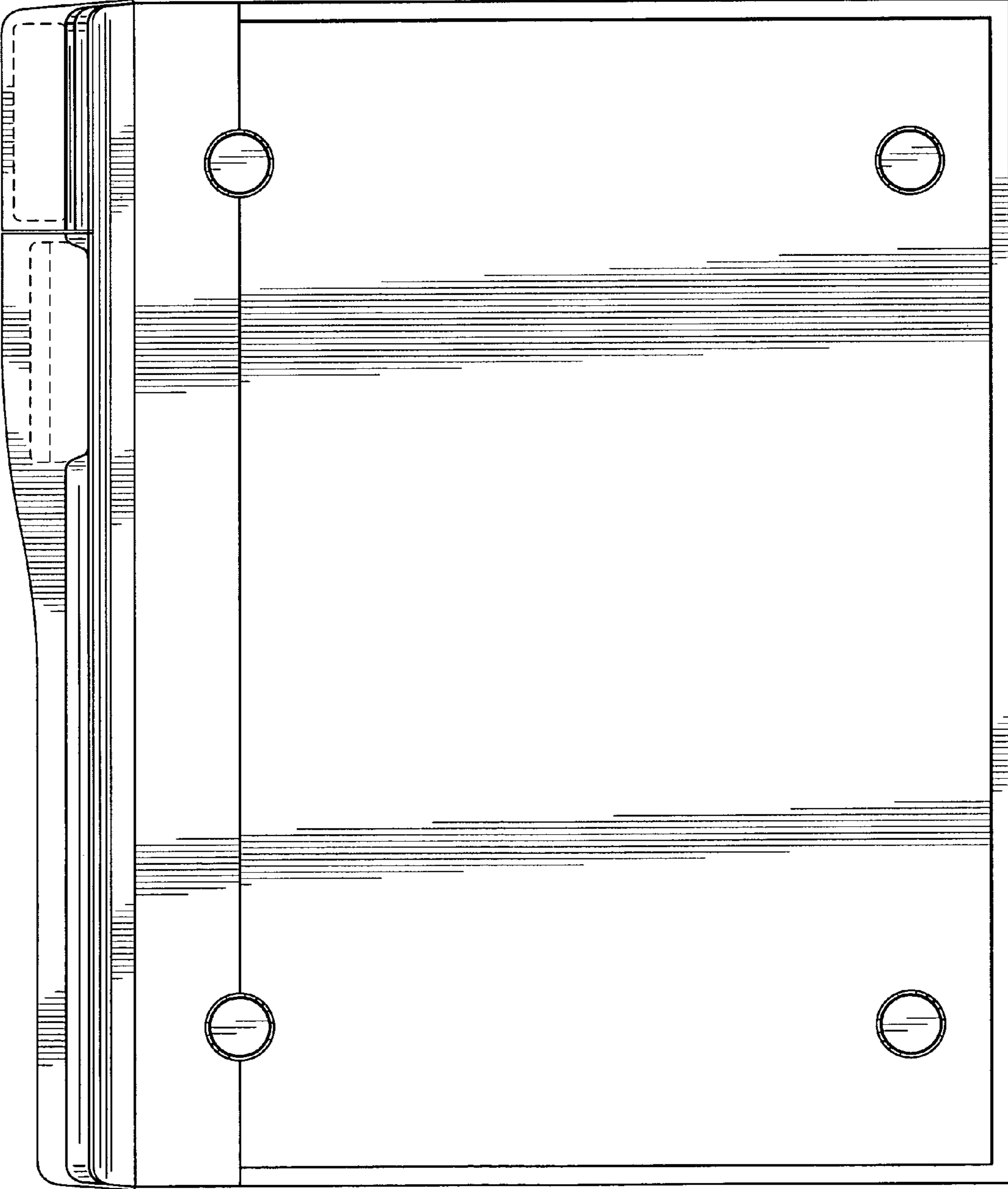

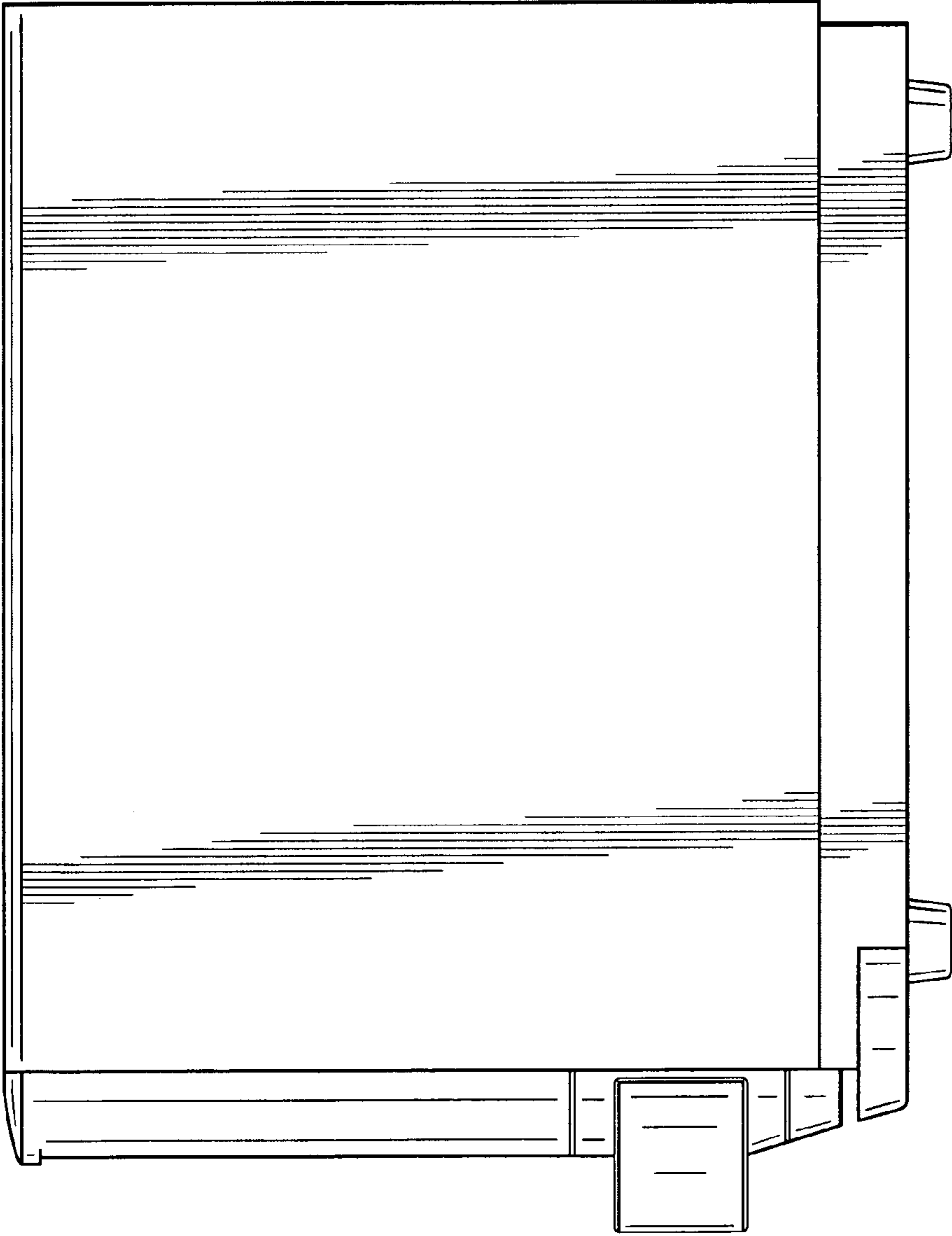

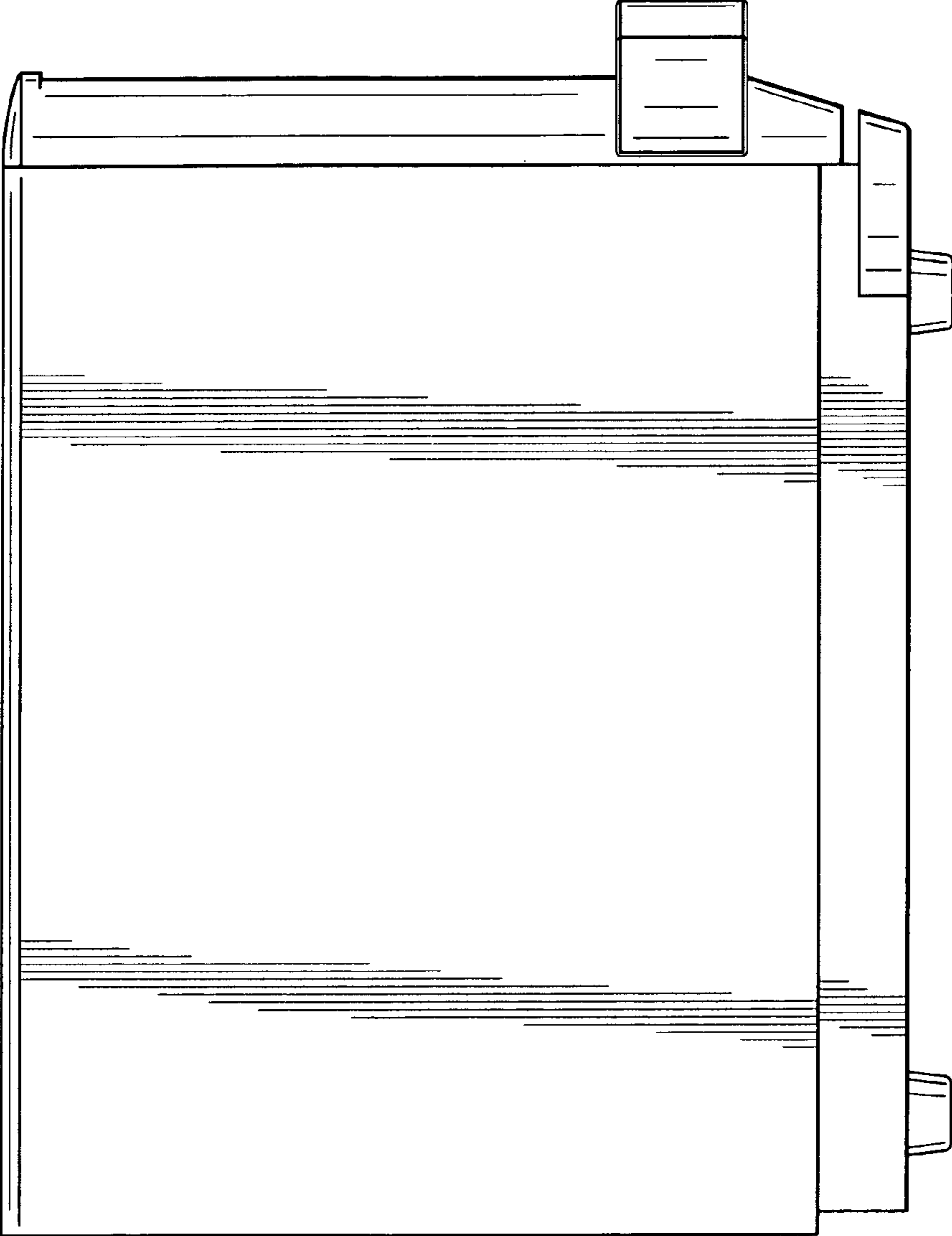
