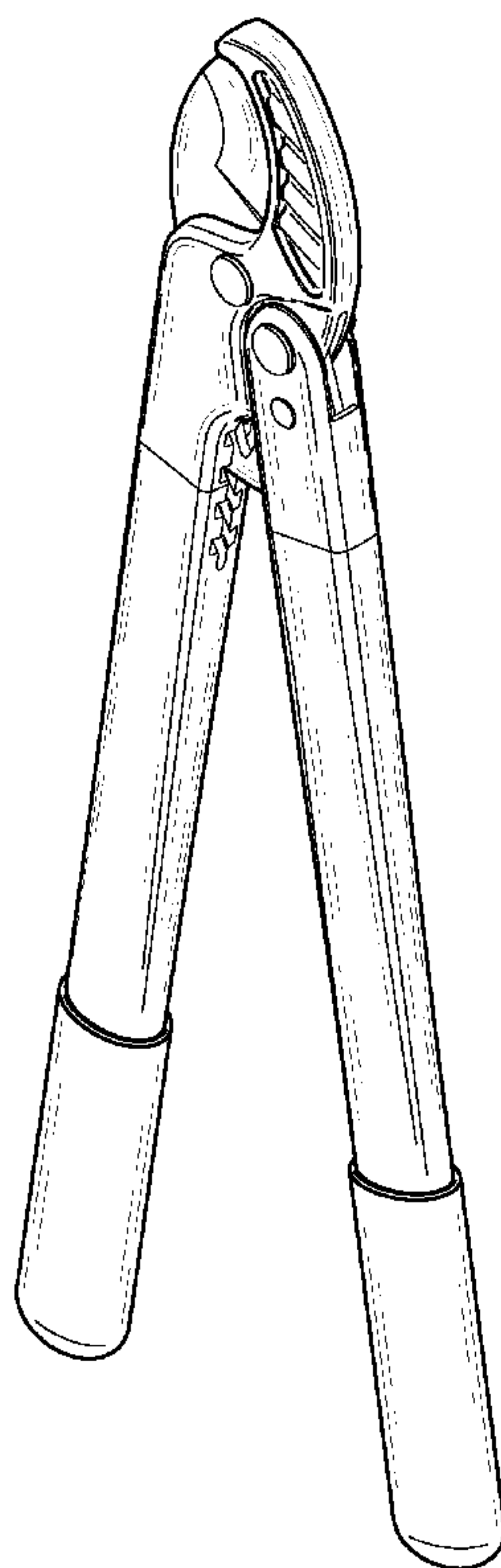
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a pair of shears showing my new design;

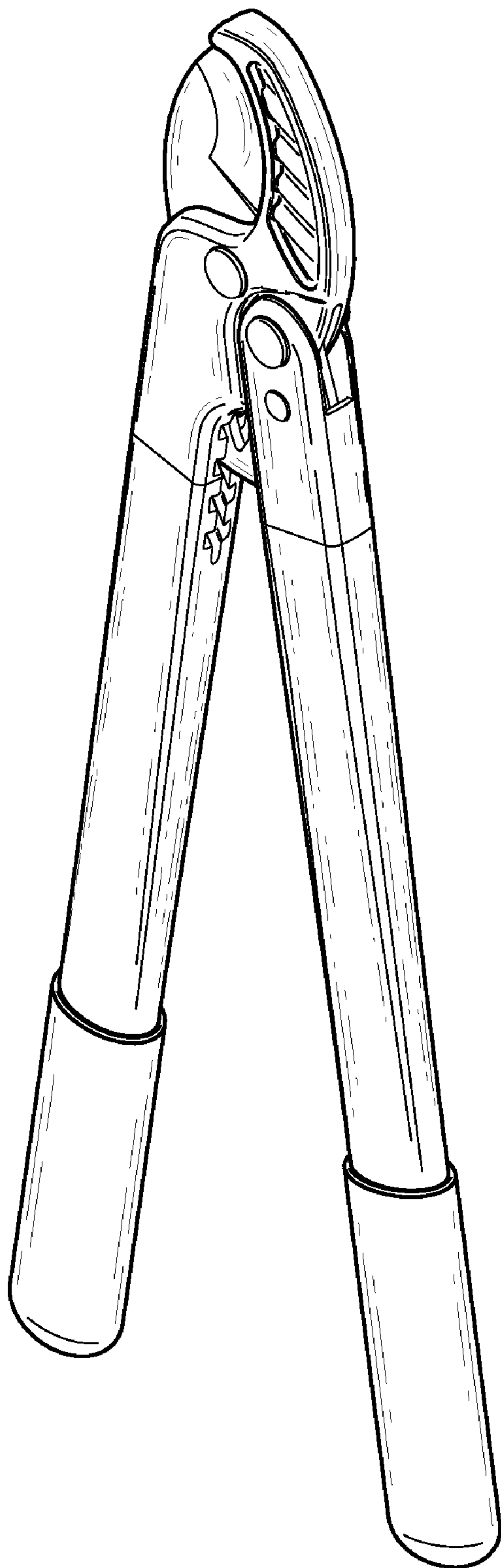

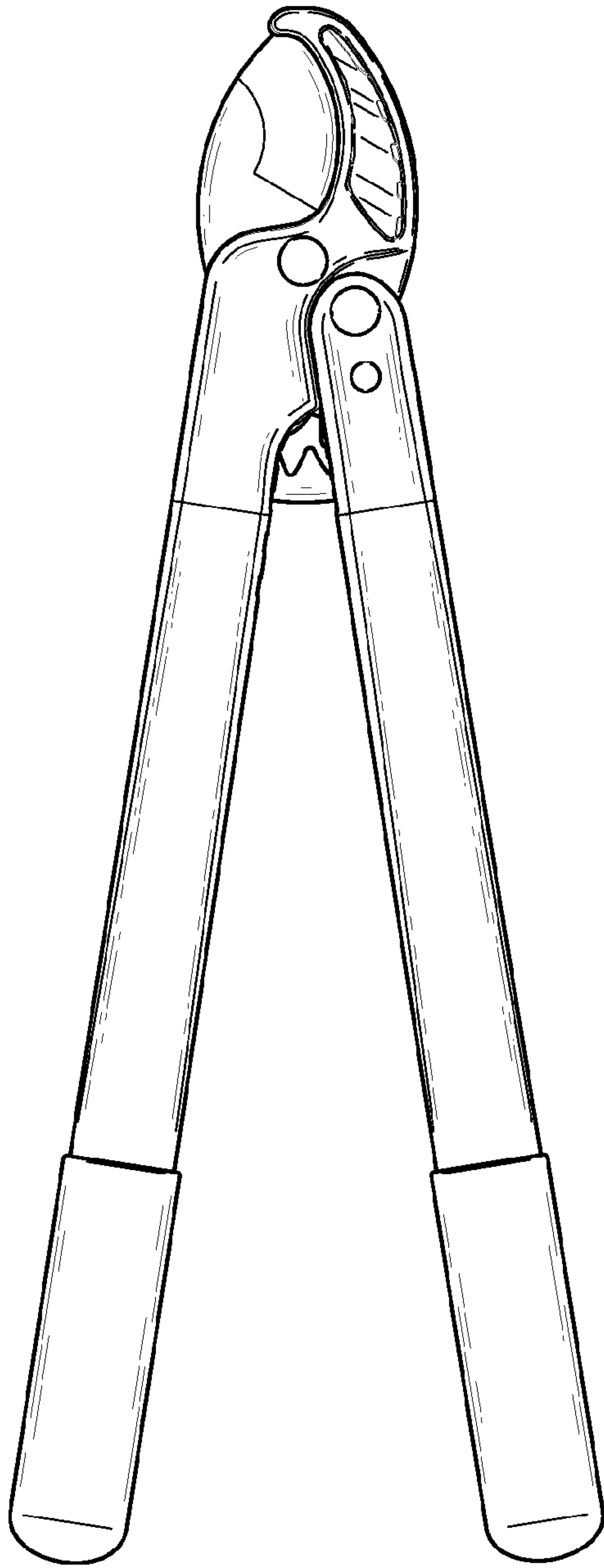

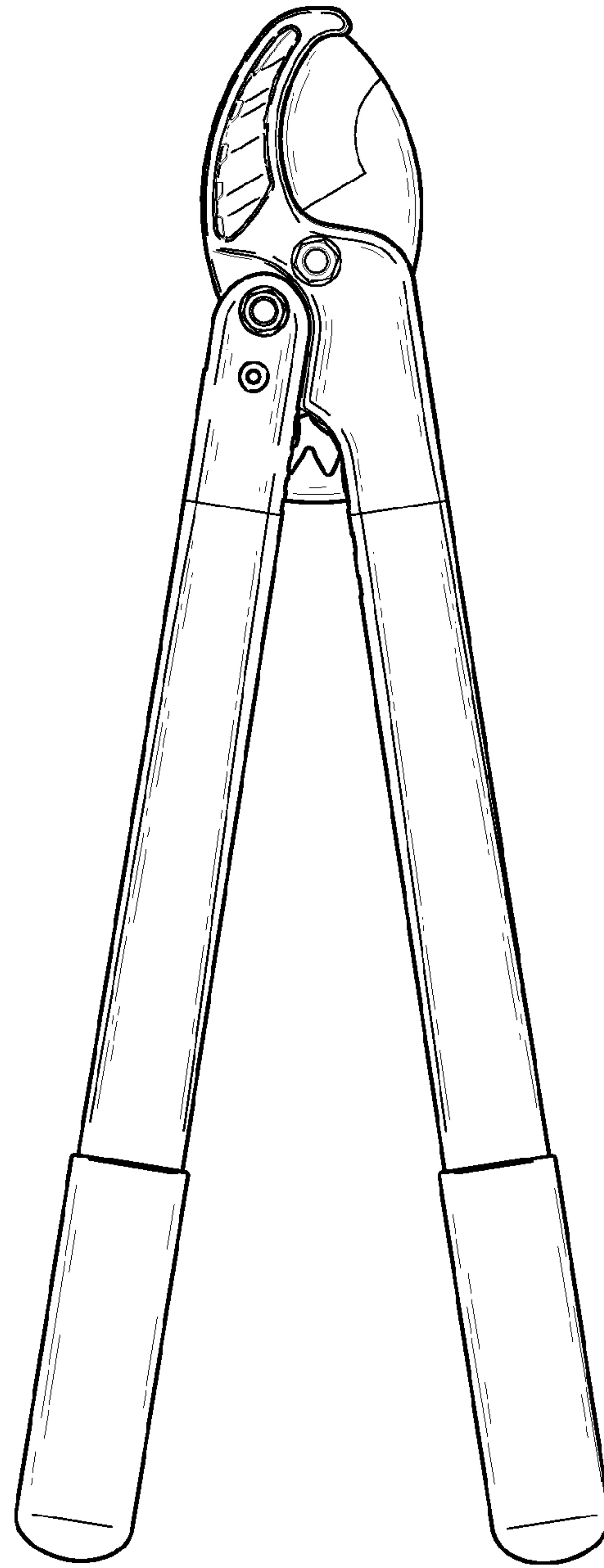

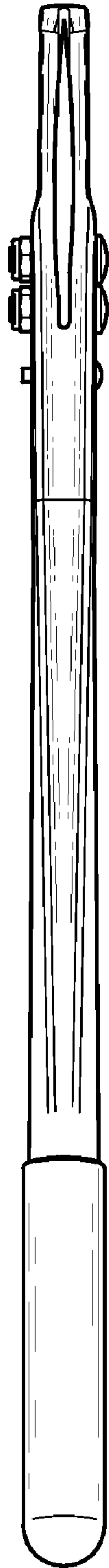

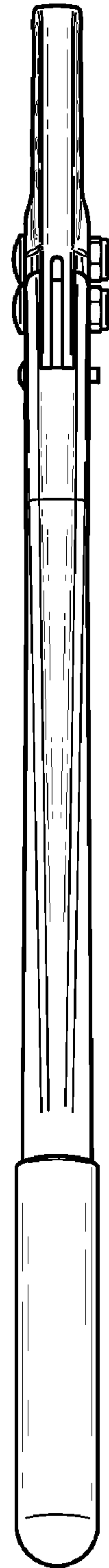

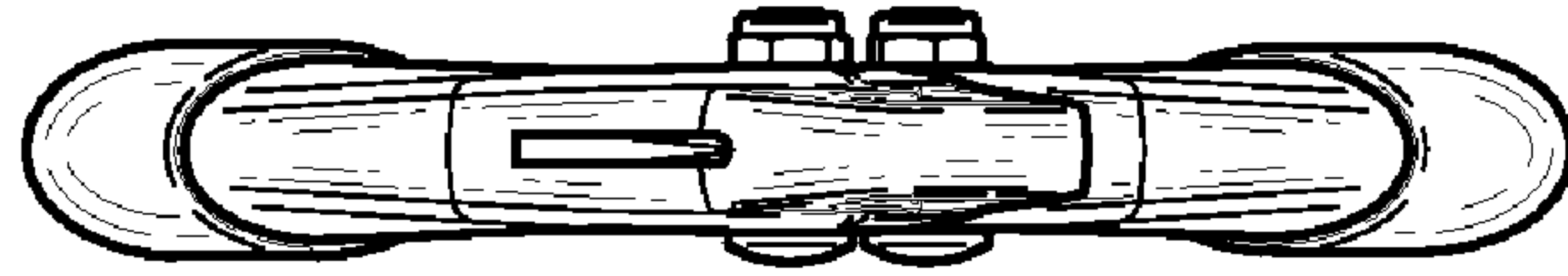

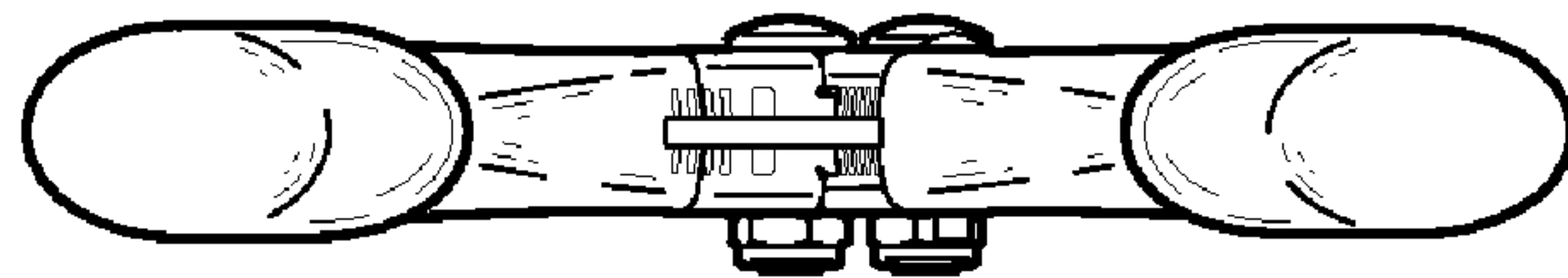
