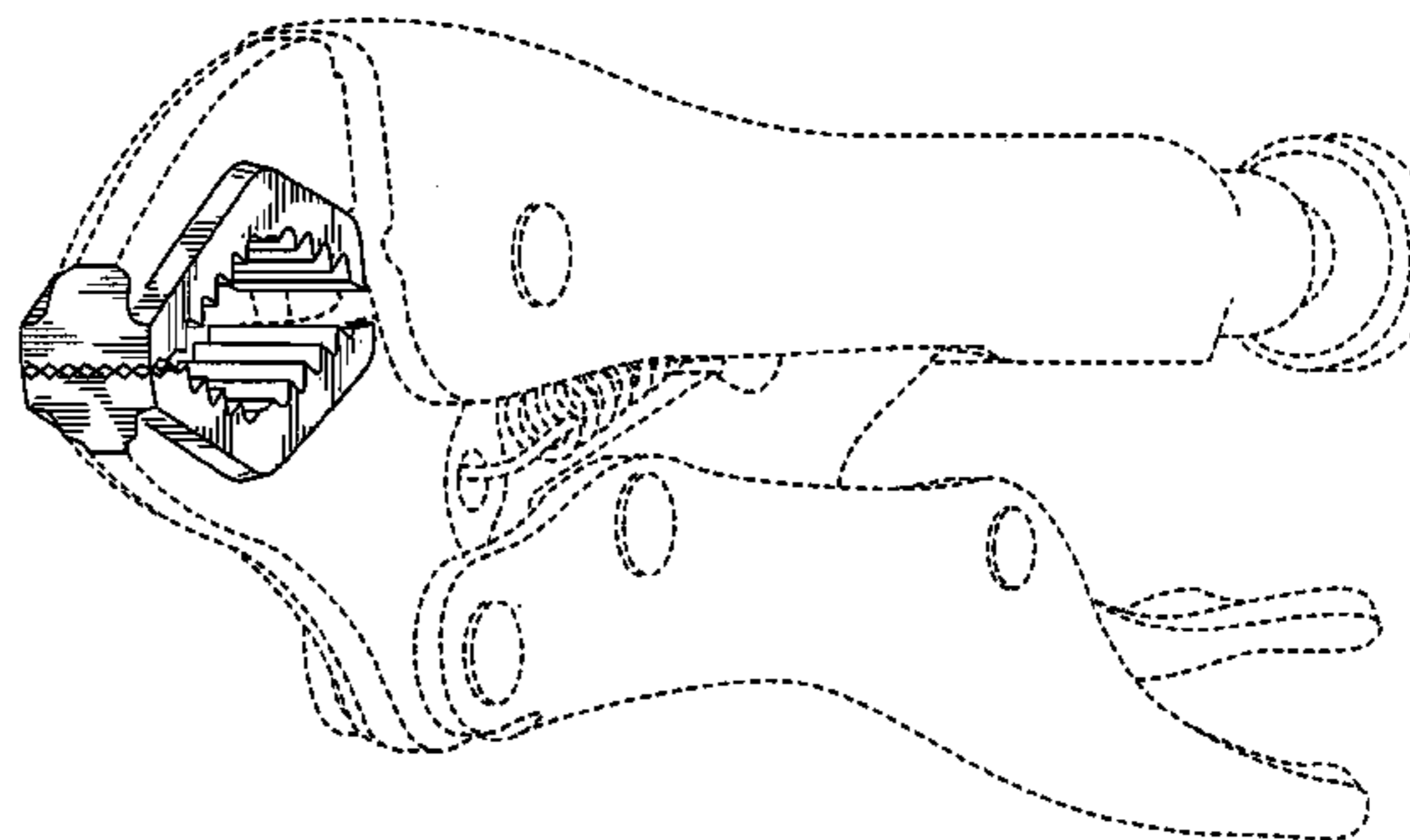
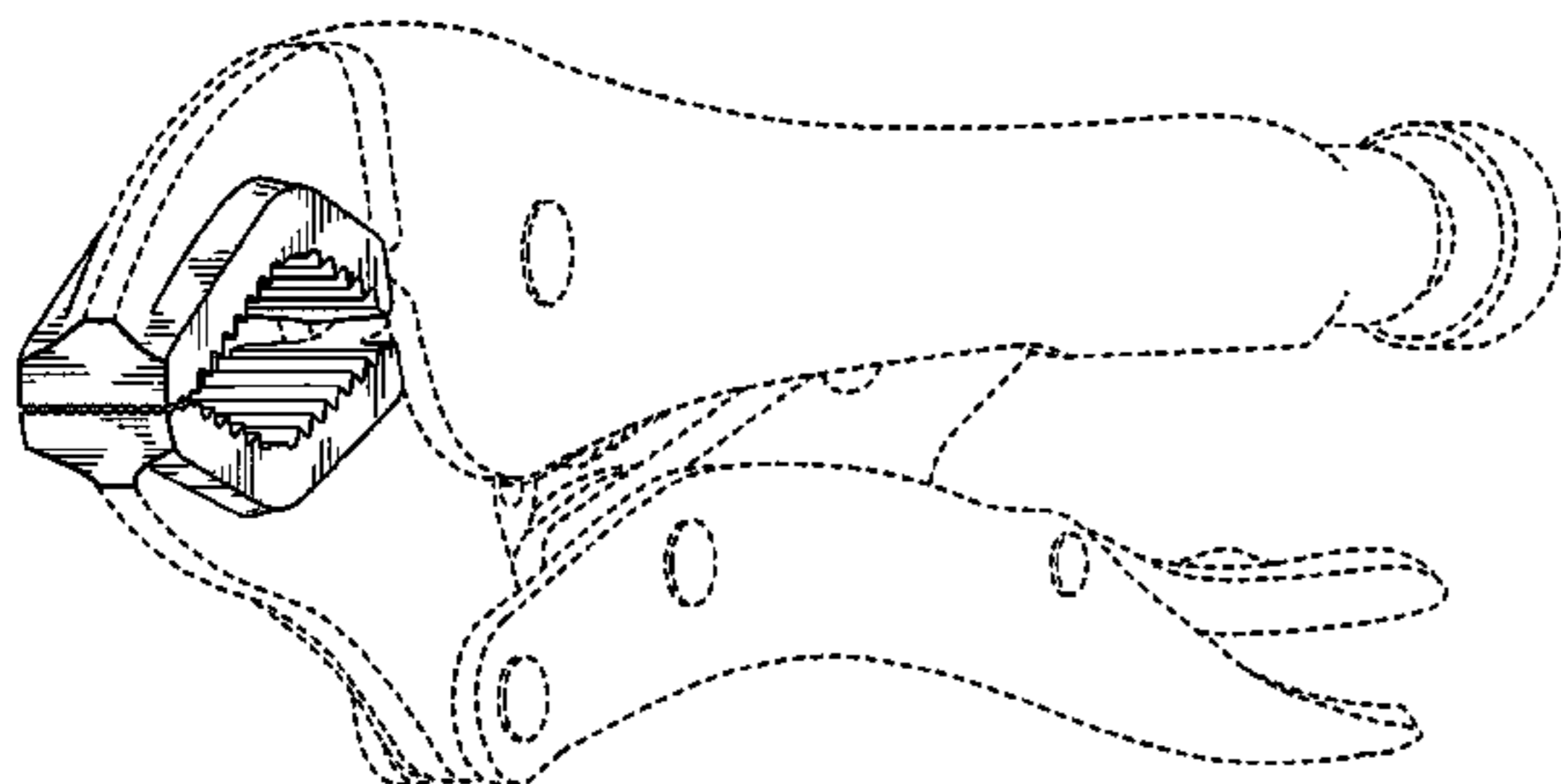
I claim the ornamental design design for a locking pliers jaw, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side view of our new design for a locking pliers jaw, the left side view being identical;  
 FIG. 2 is a front view showing my new design shown in FIG. 1;  
 FIG. 3 is a back view showing my new design shown in FIG. 1;  
 FIG. 4 is a top view showing my new design shown in FIG. 1;

 FIG. 7 is a right side view of a second embodiment of my new design for a locking pliers jaw, the left side view being identical;

 FIG. 10 is a top view showing my new design shown in FIG. 7;

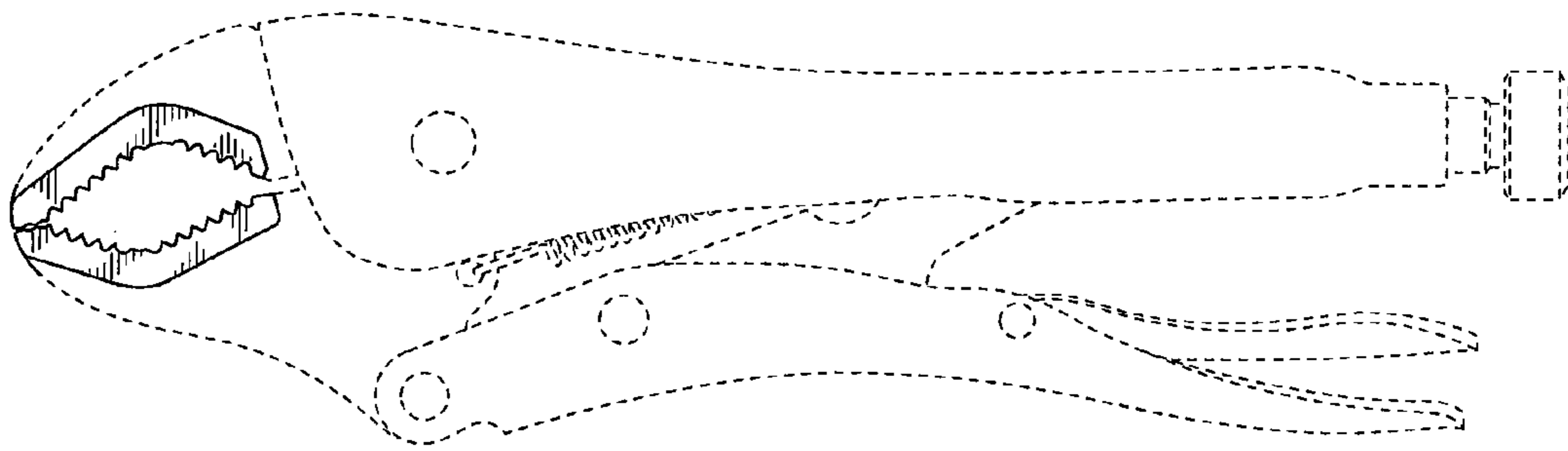

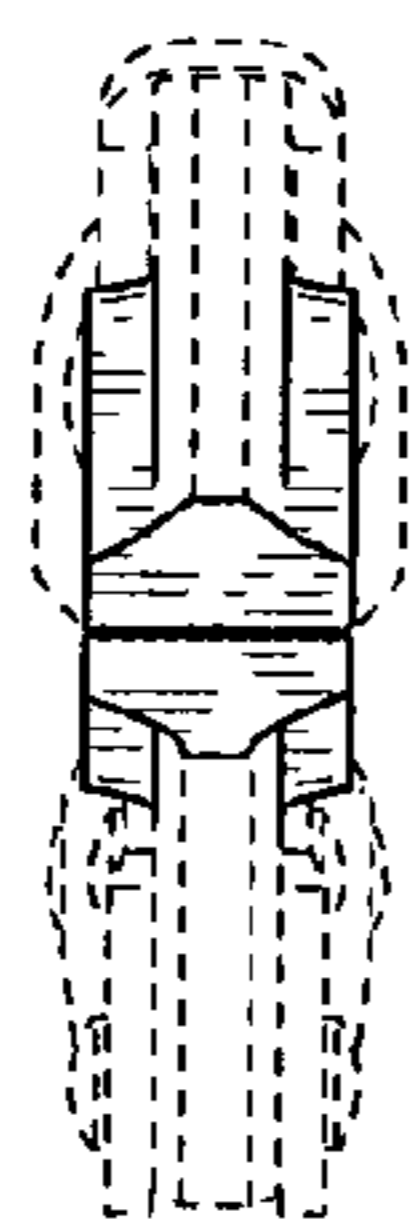

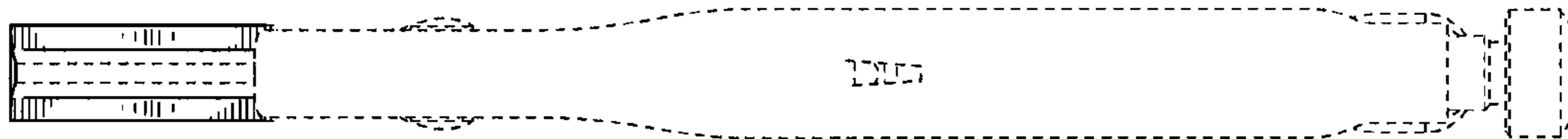

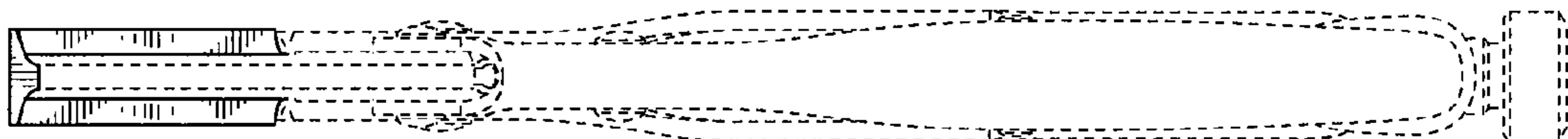
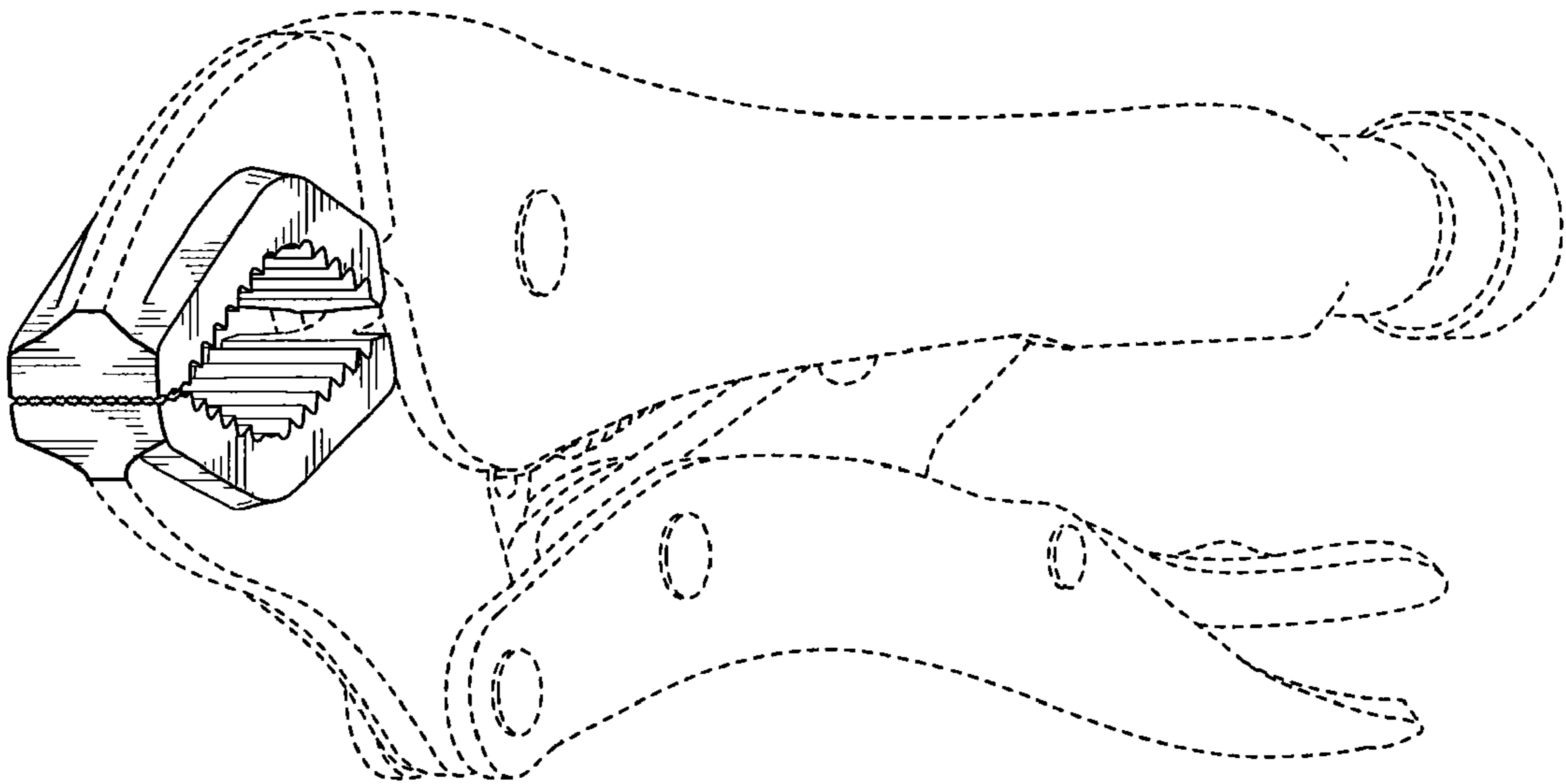

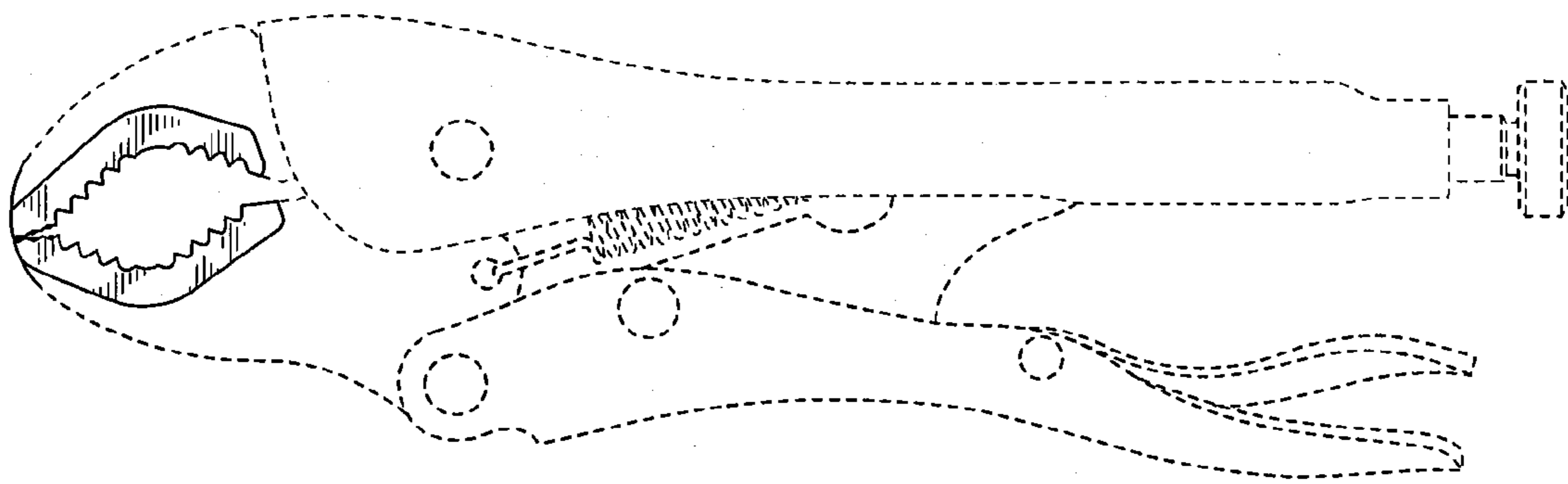

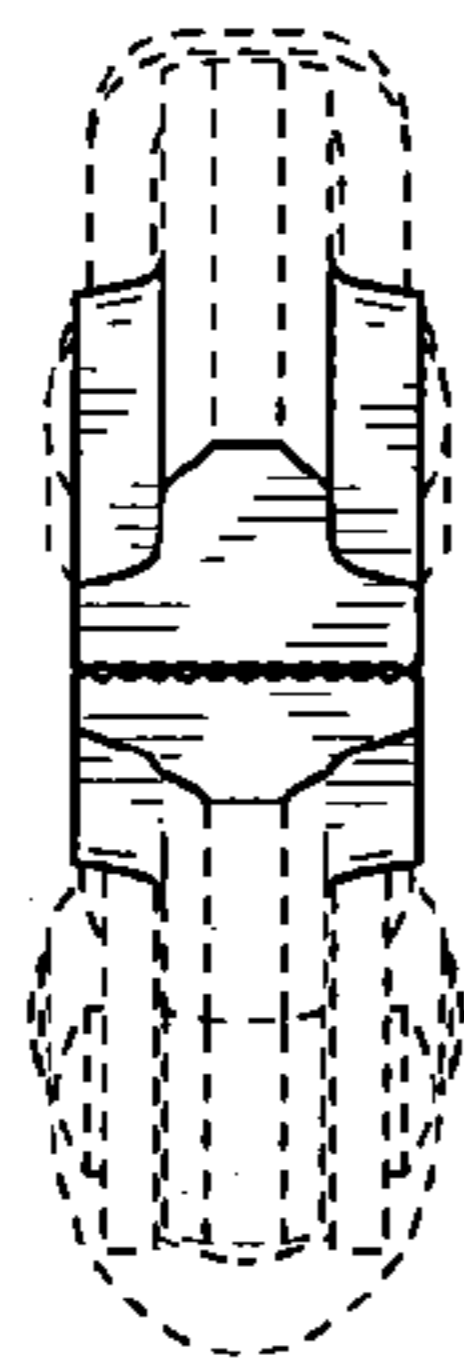

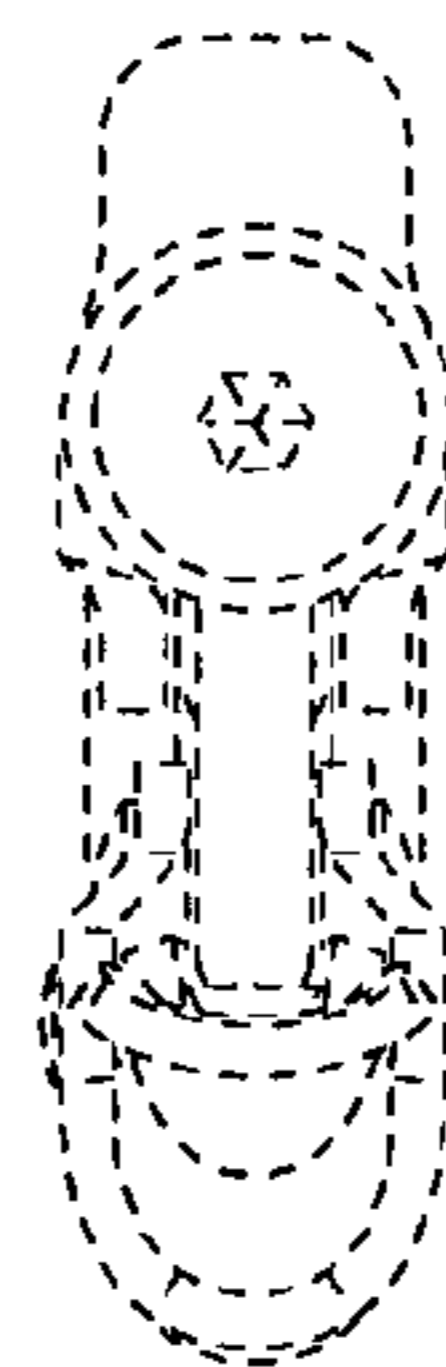

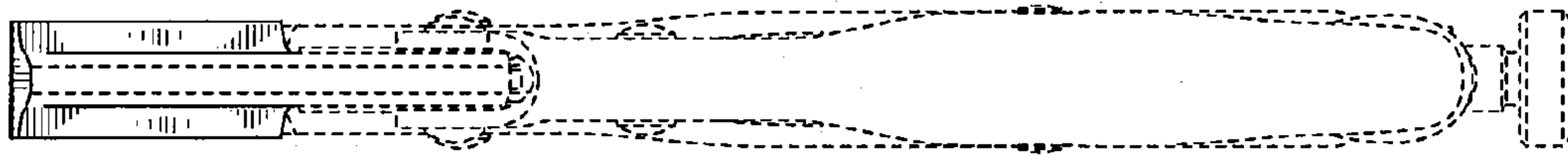

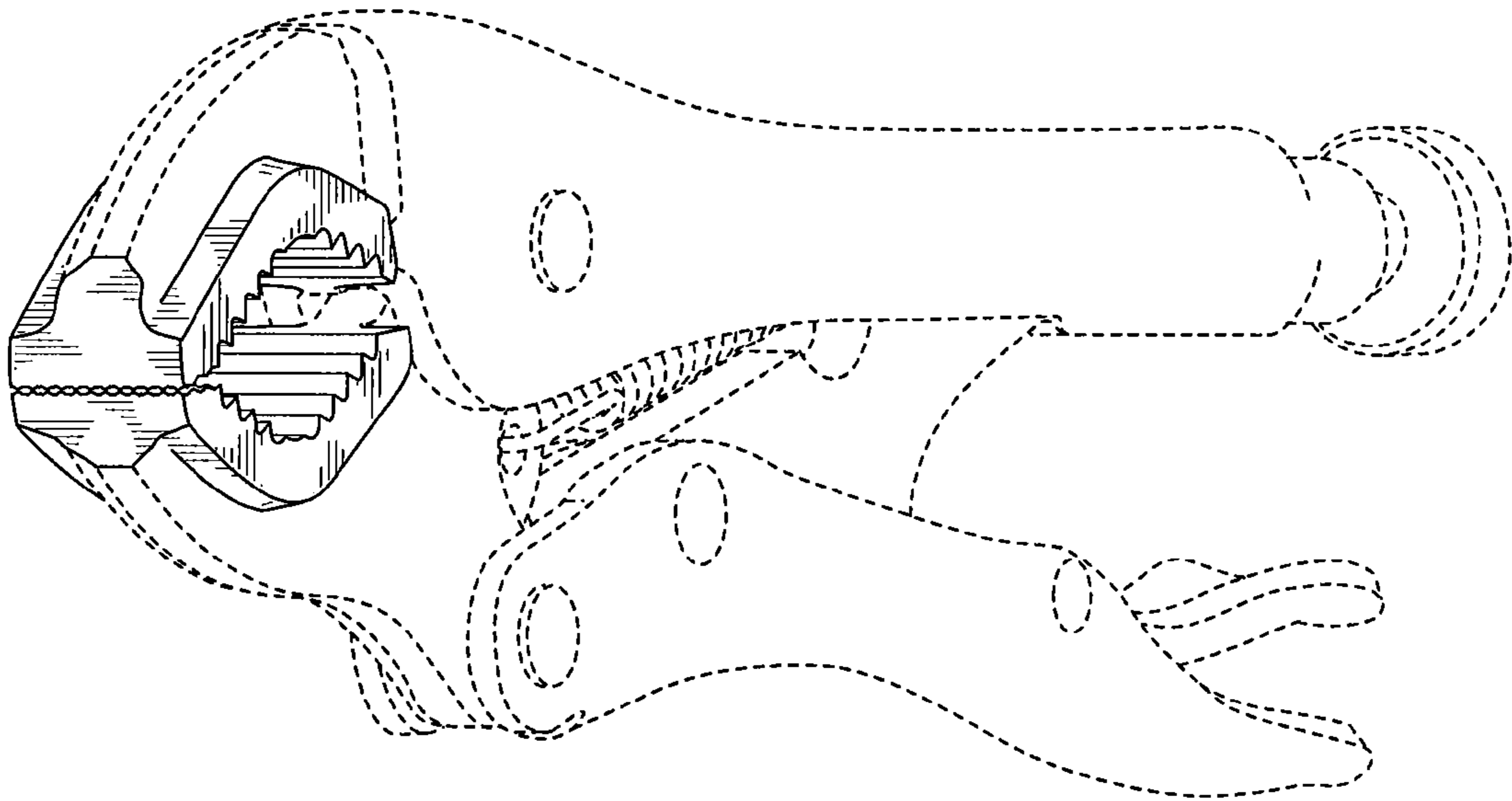
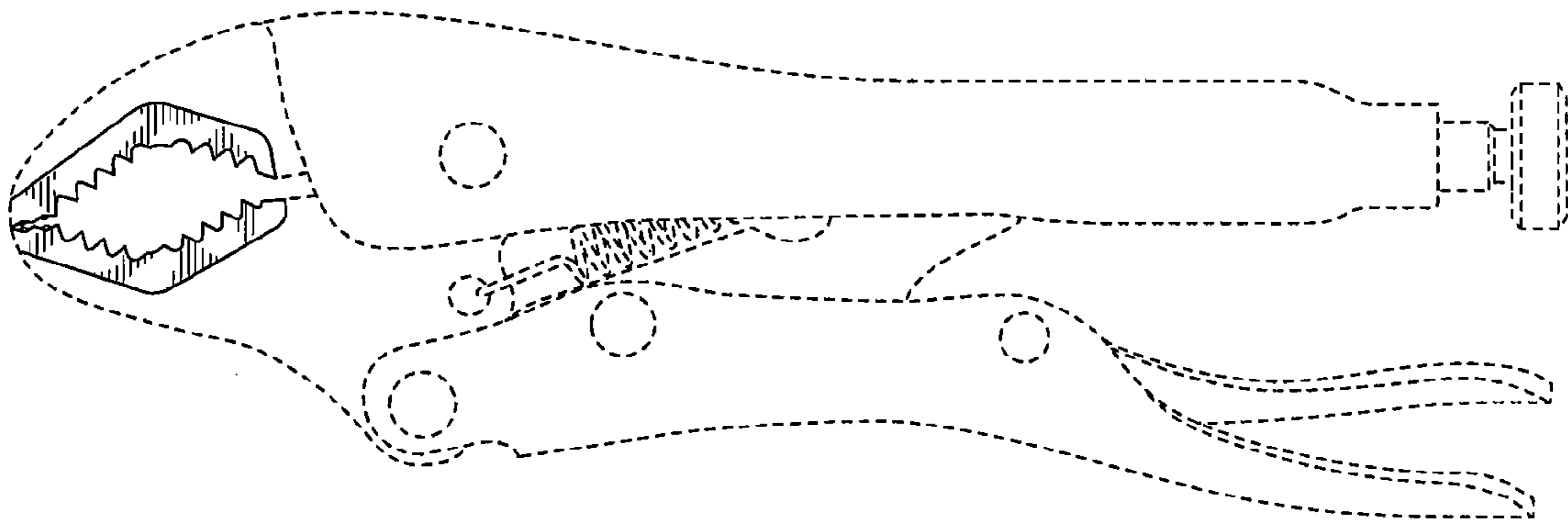
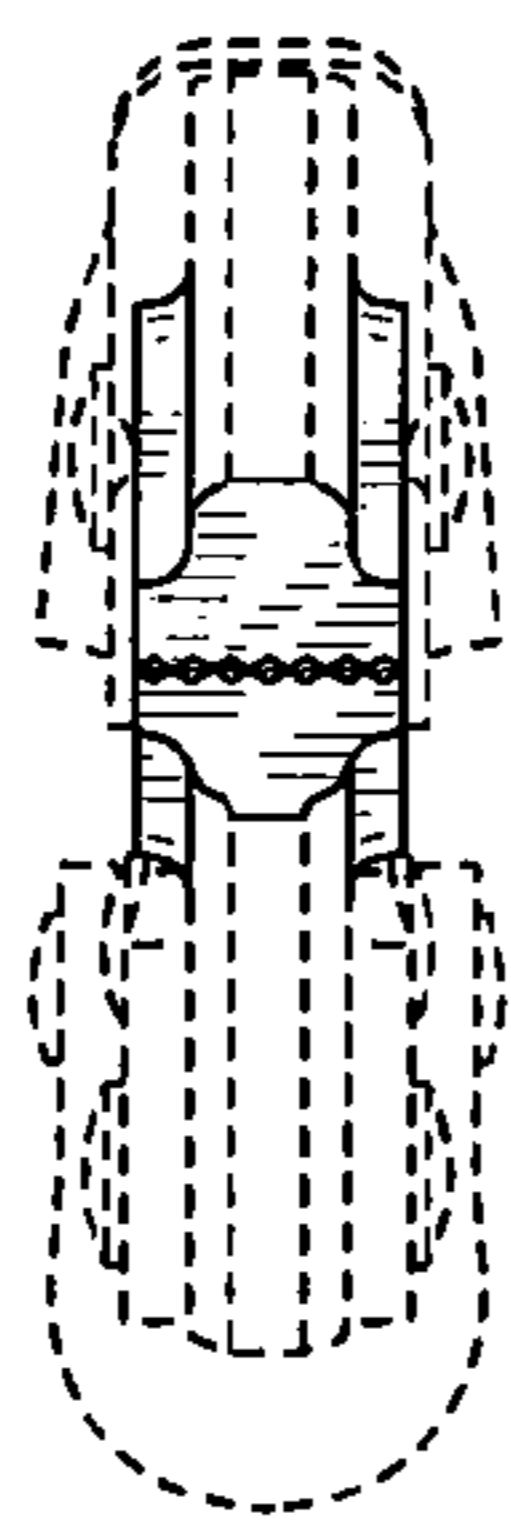

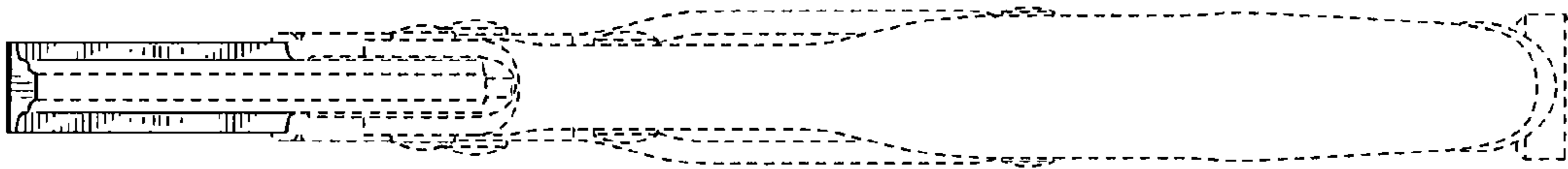
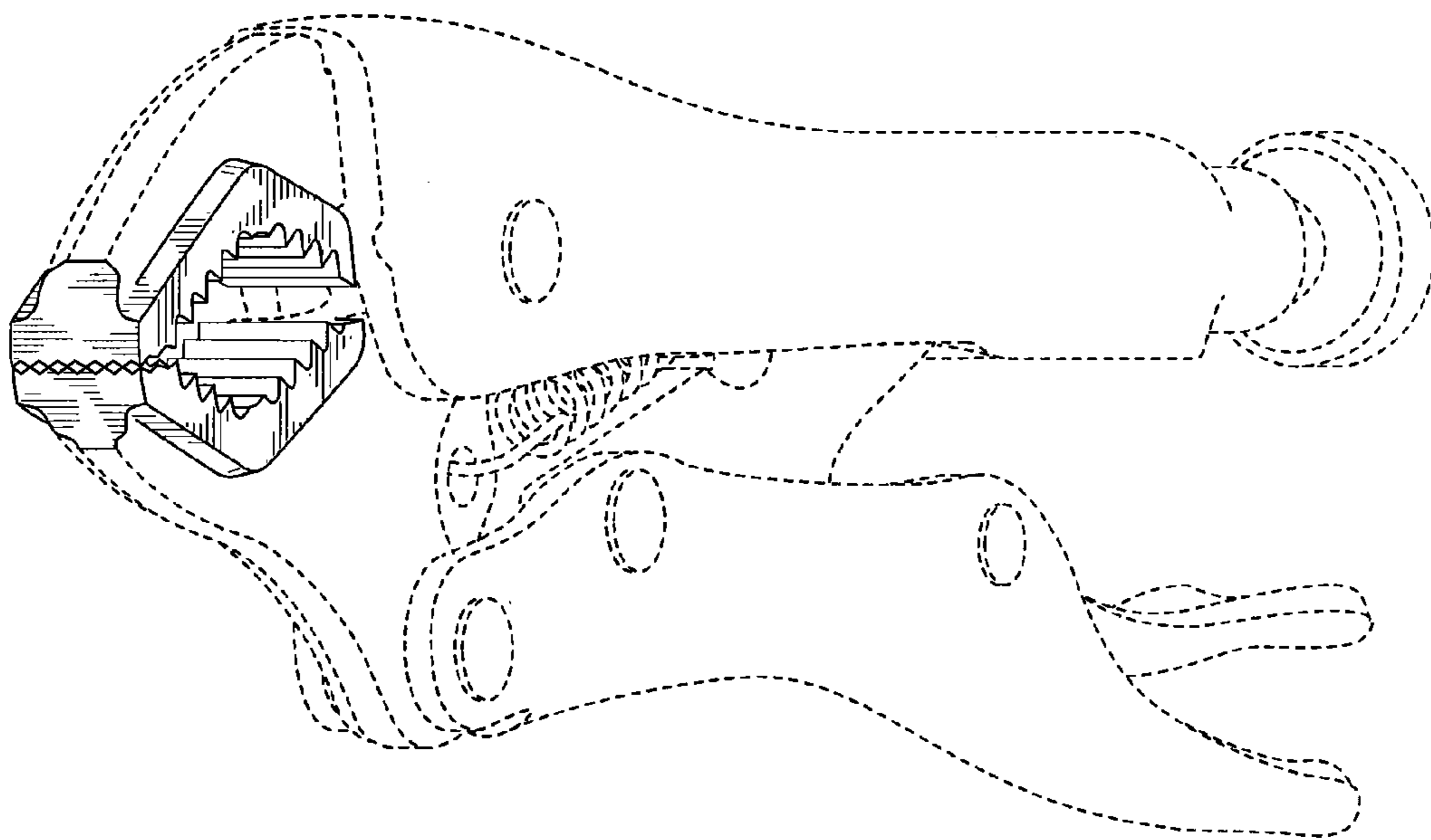
