**DESCRIPTION**

FIG. 3 is a front elevation view thereof, the rear elevation view being identical;

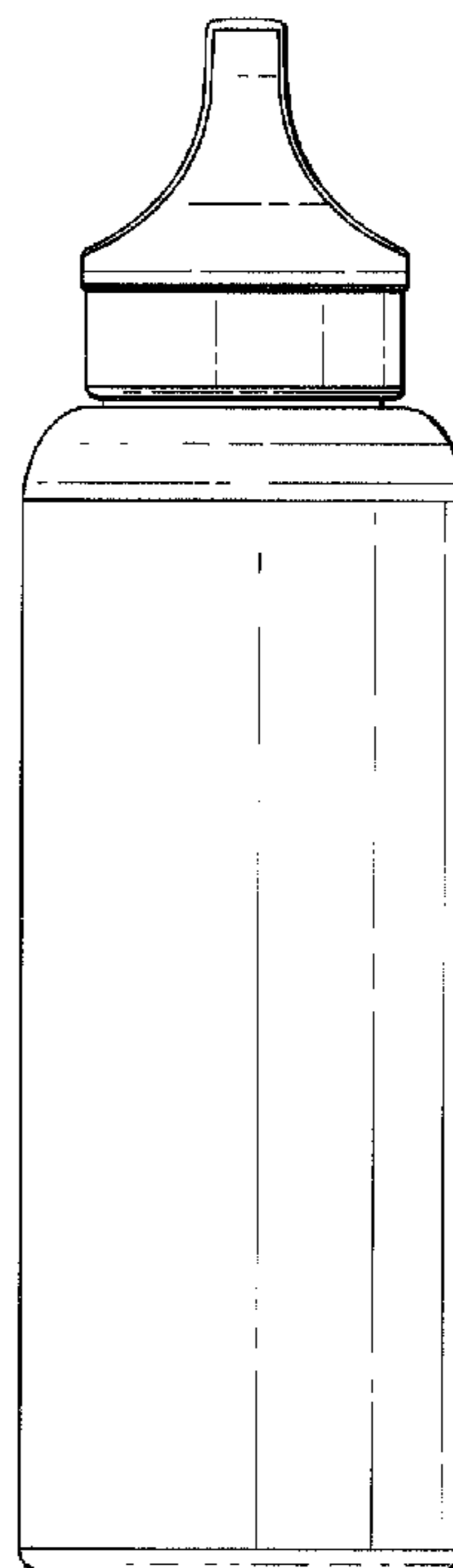
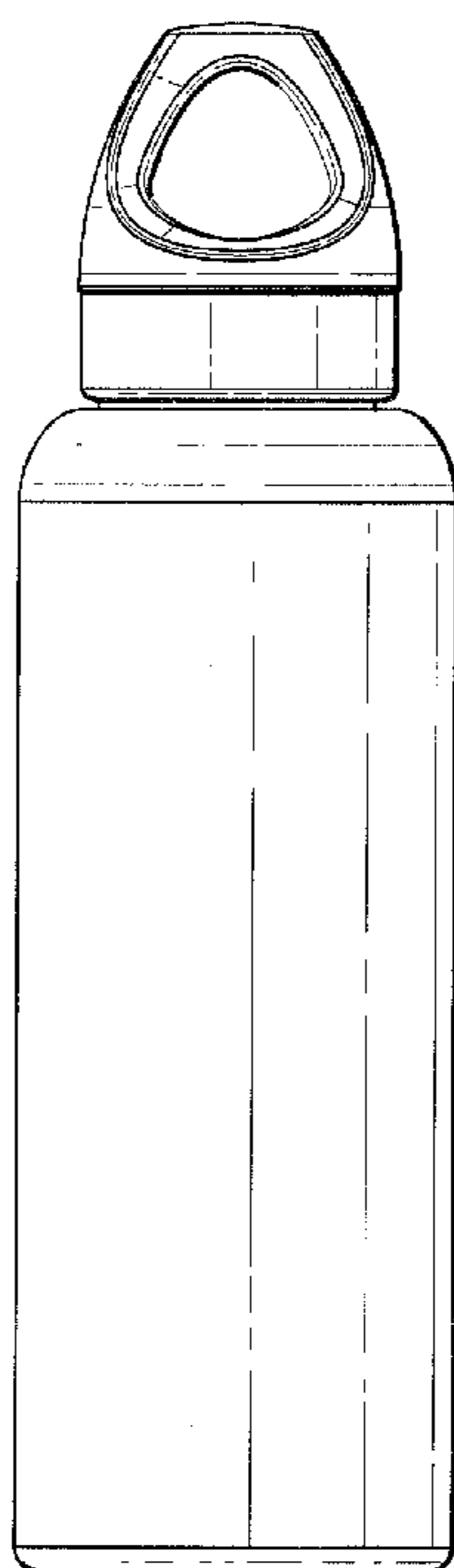
FIG. 4 is a right side elevation view thereof, the left side elevation view being identical;

FIG. 5 is a top plan view thereof; and,

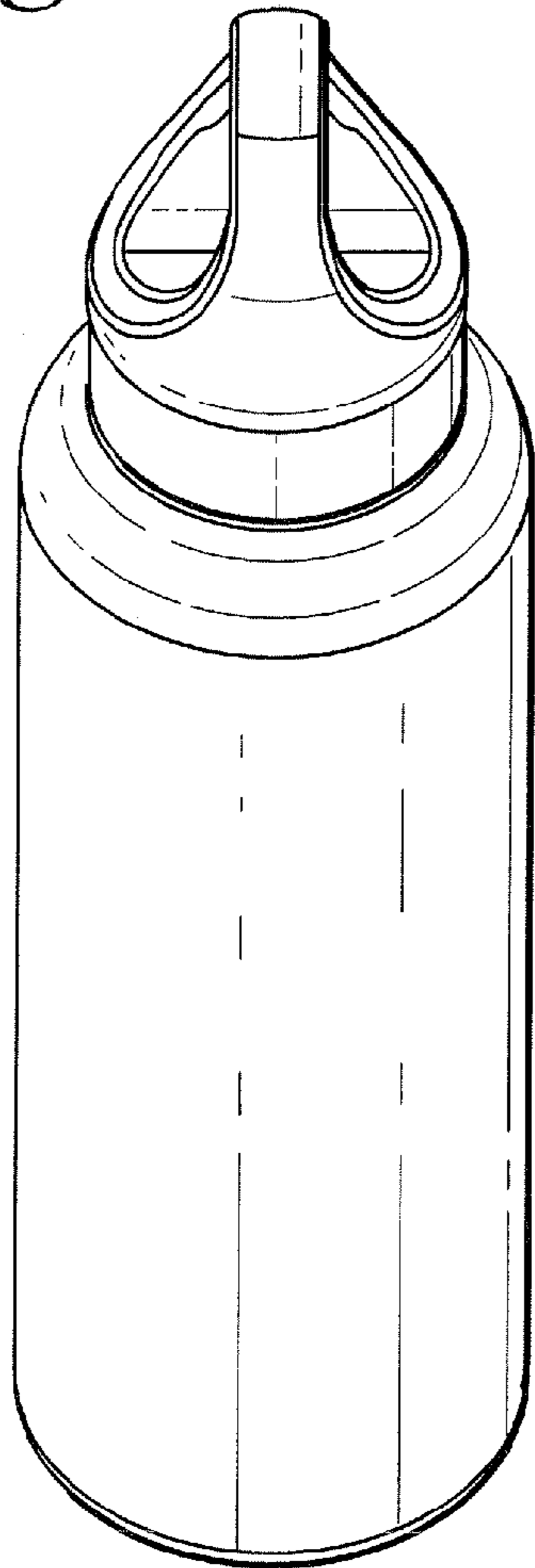
FIG. 6 is a bottom plan view thereof.

The broken lines in the drawings showing the bottom surface of the bottle illustrate the portions of the design that form no part of the claim.

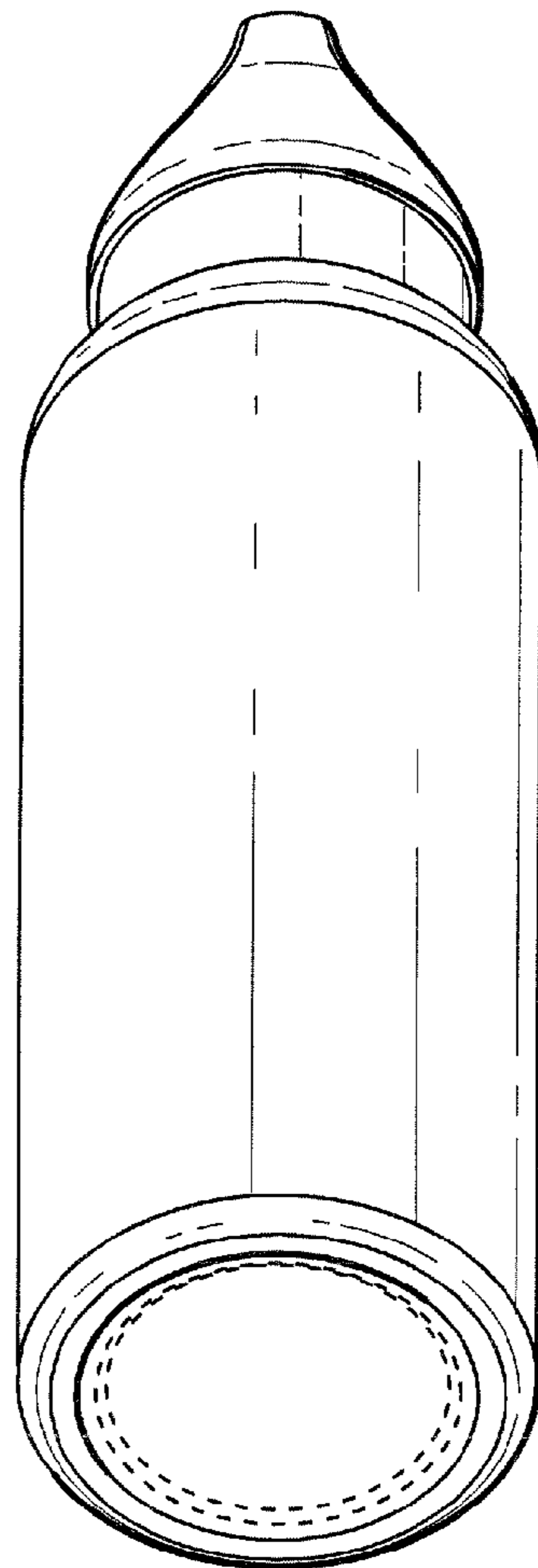

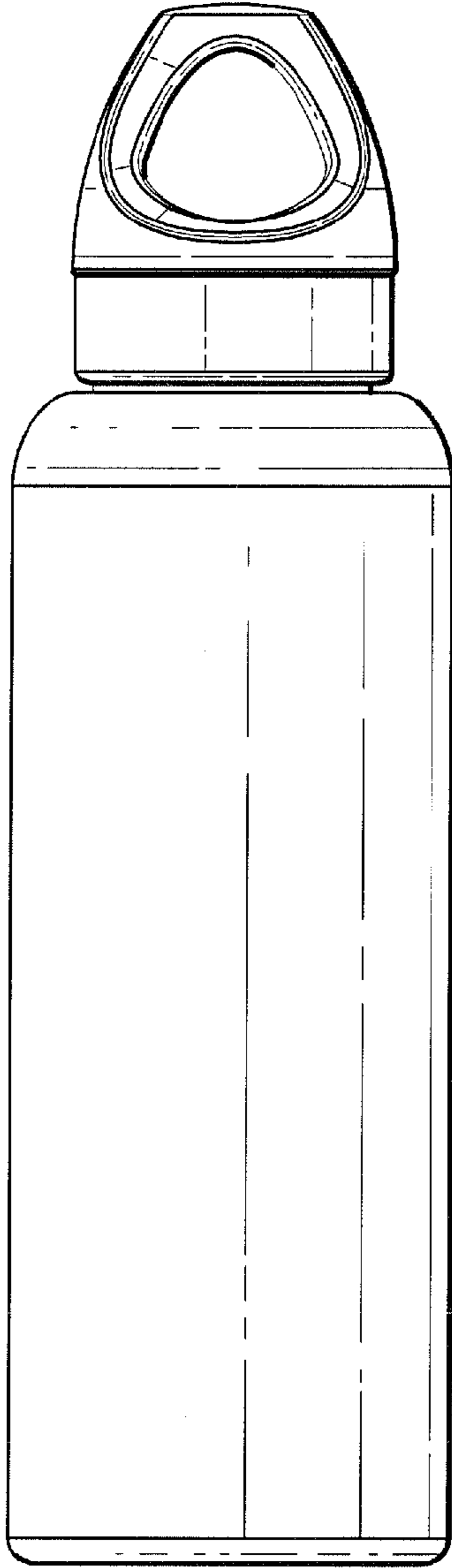

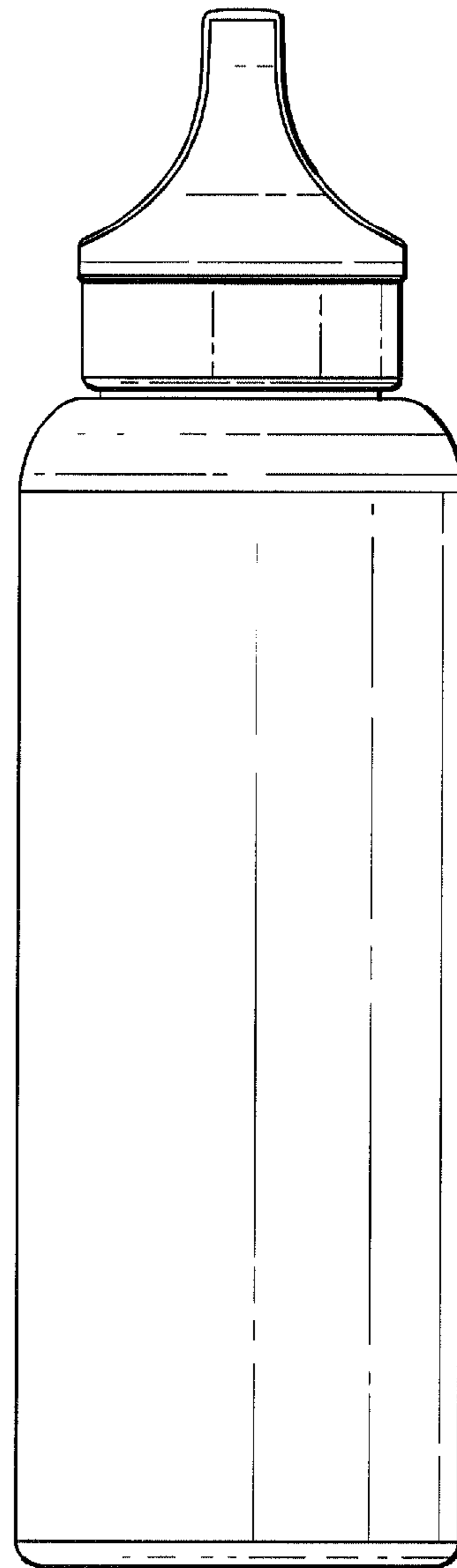

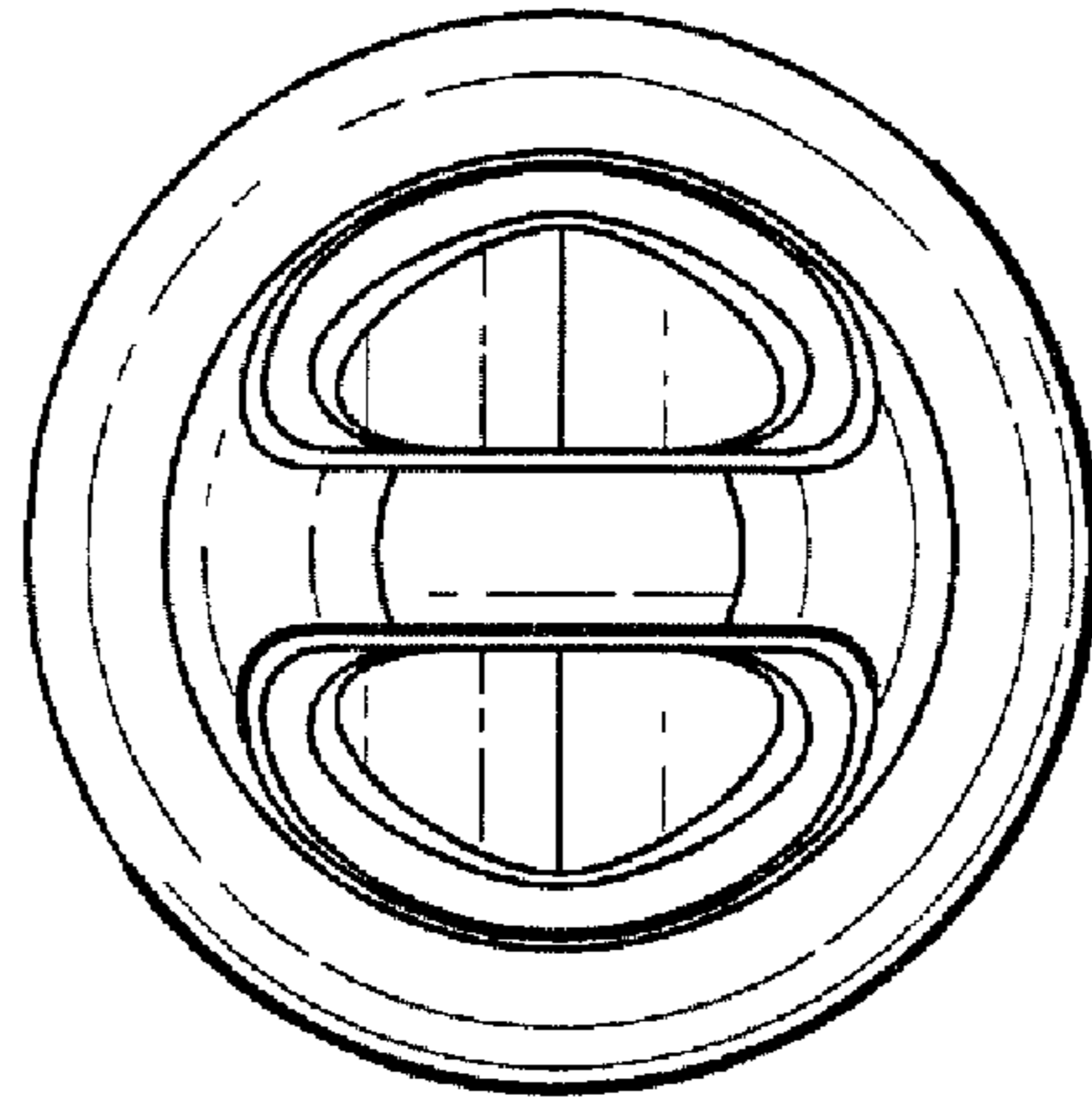
