(57) **CLAIM**

The ornamental design for a trash bag, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an embodiment of our design for a trash bag;

FIG. 2 is a front view of the trash bag of FIG. 1;

FIG. 3 is a side view of the trash bag of FIG. 1;

FIG. 4 is a top view of the trash bag of FIG. 1; and,

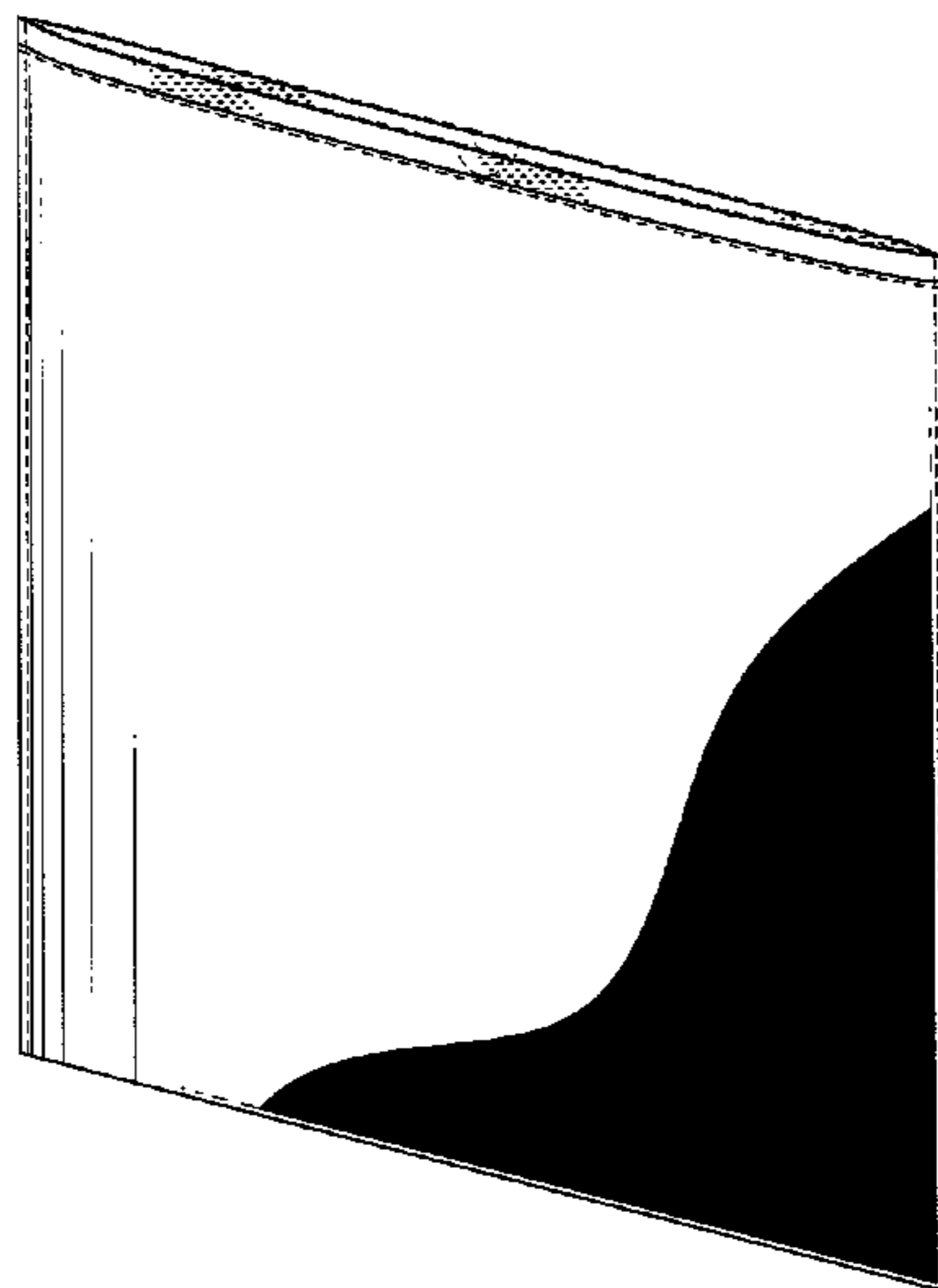
FIG. 5 is a bottom view of the trash bag of FIG. 1.

The broken lines shown throughout these figures illustrate environmental subject matter only and form no part of the claimed design.

The surface of the bag is partially lined with the drawing symbol for the color black, which extends across the entire delineated surface of the bag.

The surface of the drawtape is partially lined with the drawing symbol for the color gray, such as Pantone 430, which extends across the entire delineated surface of the drawtape.

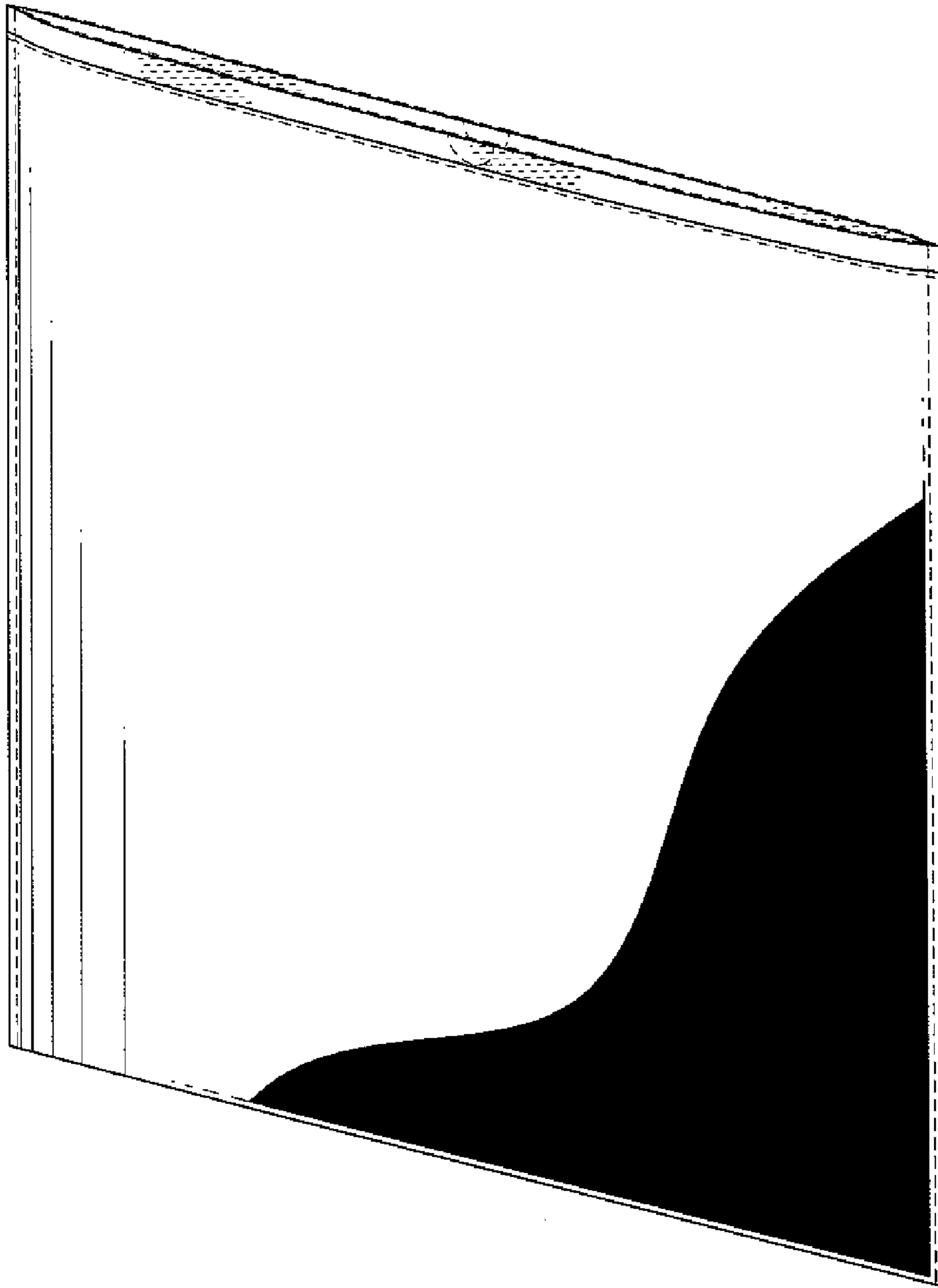

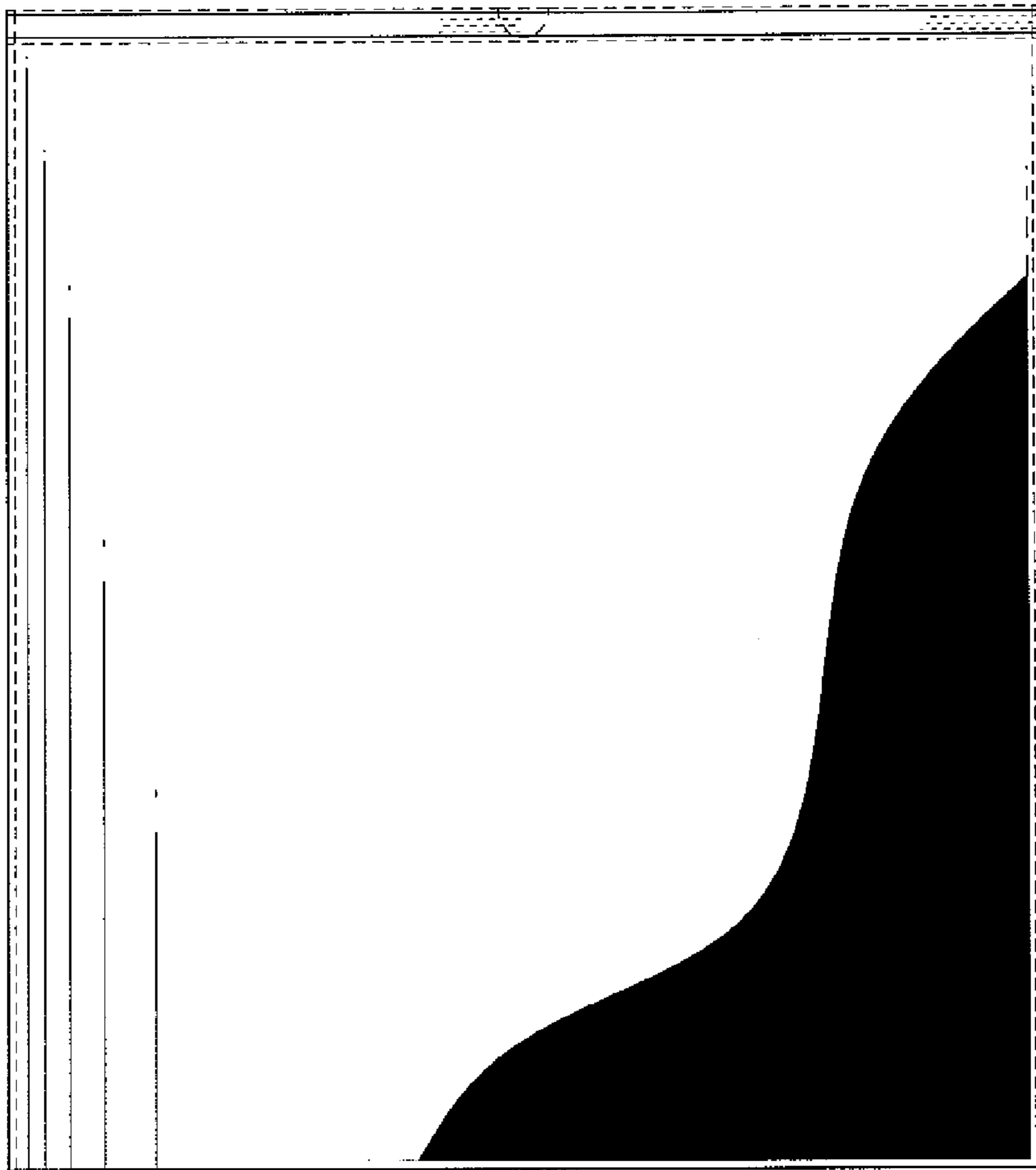

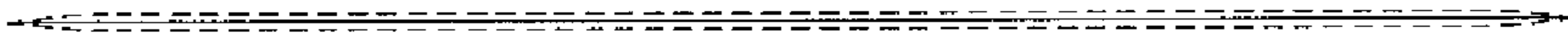
