DESCRIPTION

FIG. 1 is a top view of a watch showing our present design;
FIG. 2 is a bottom view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top perspective view from the right thereof; and,
FIG. 7 is a bottom perspective view from the right thereof.

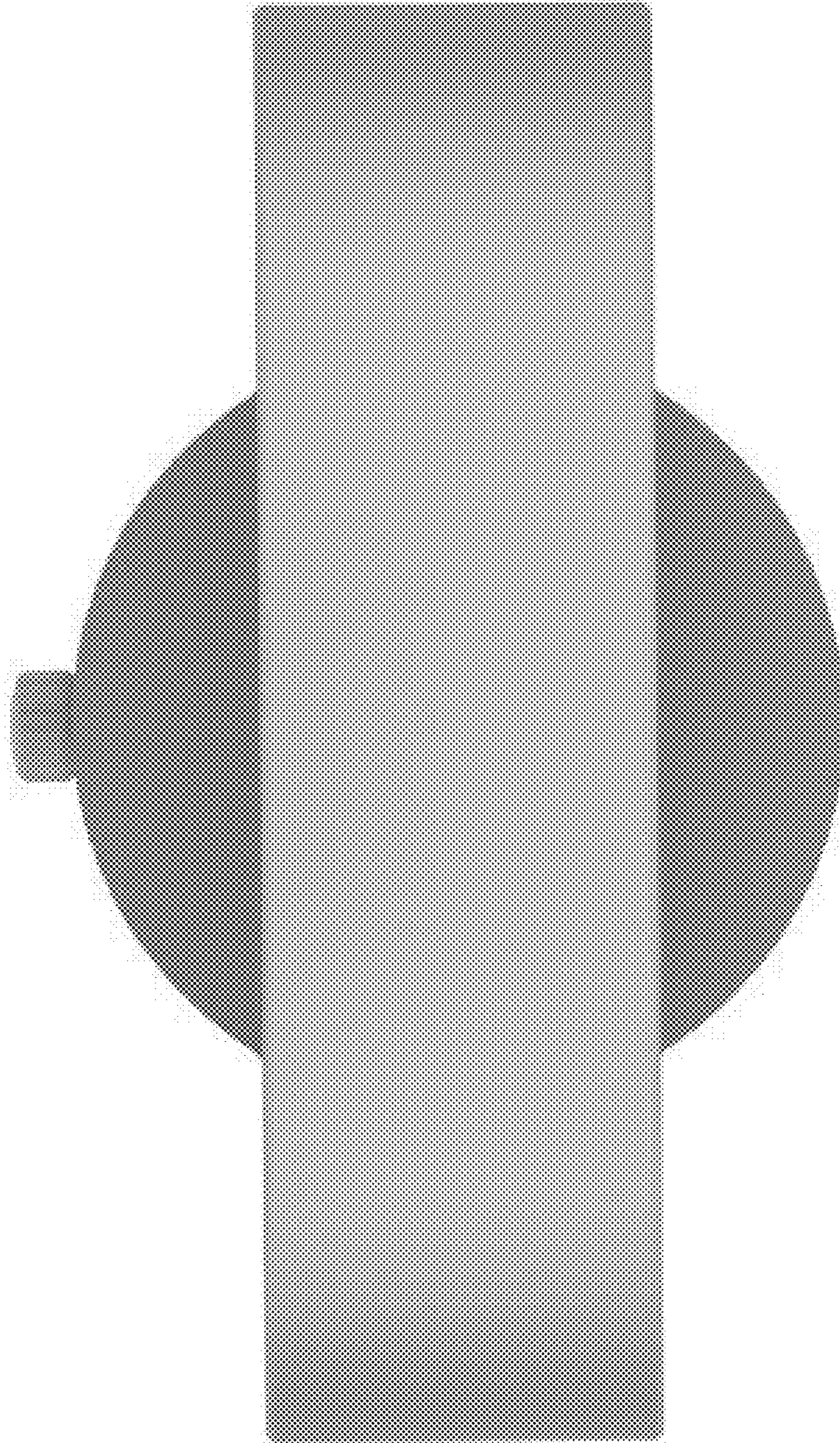

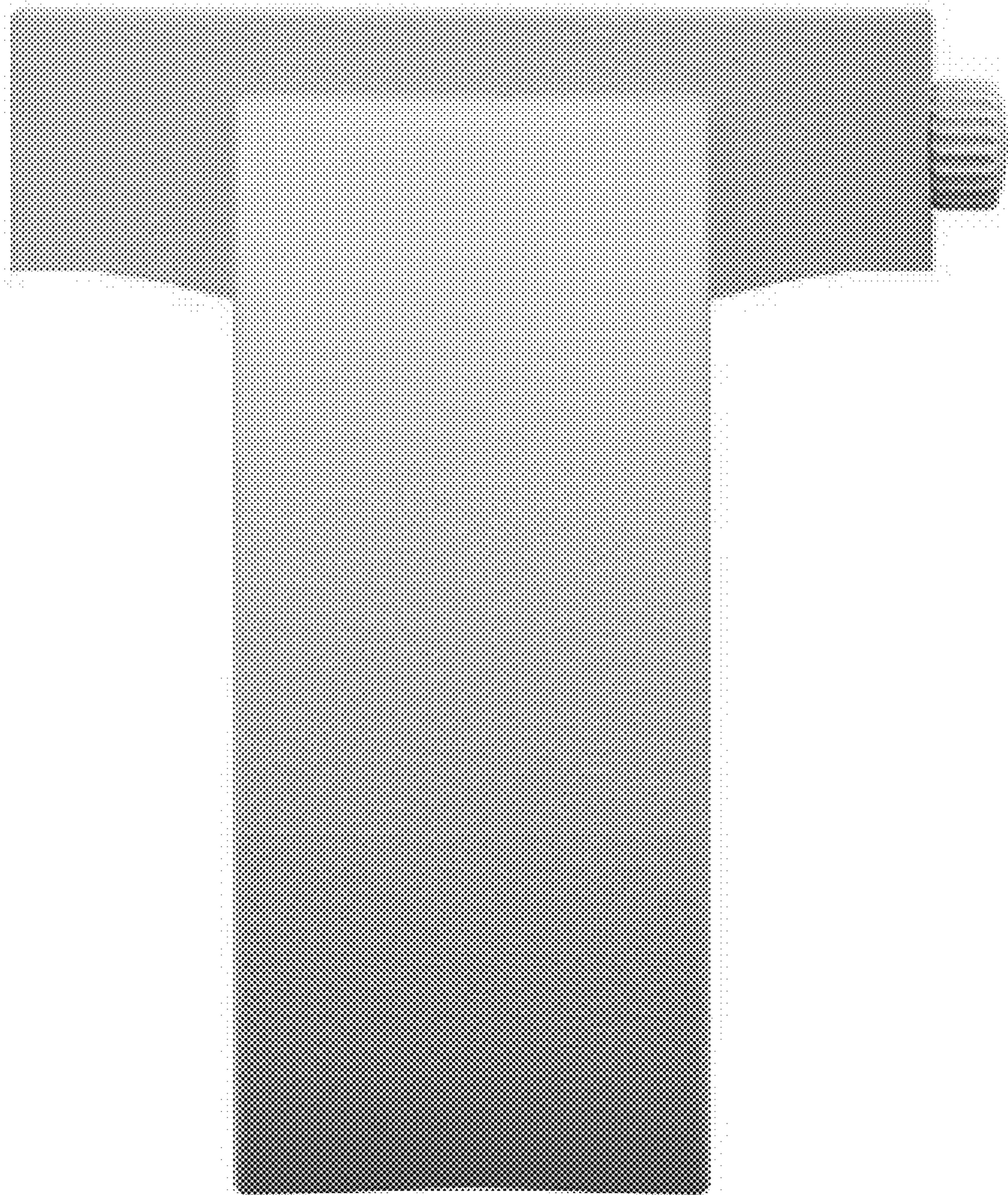

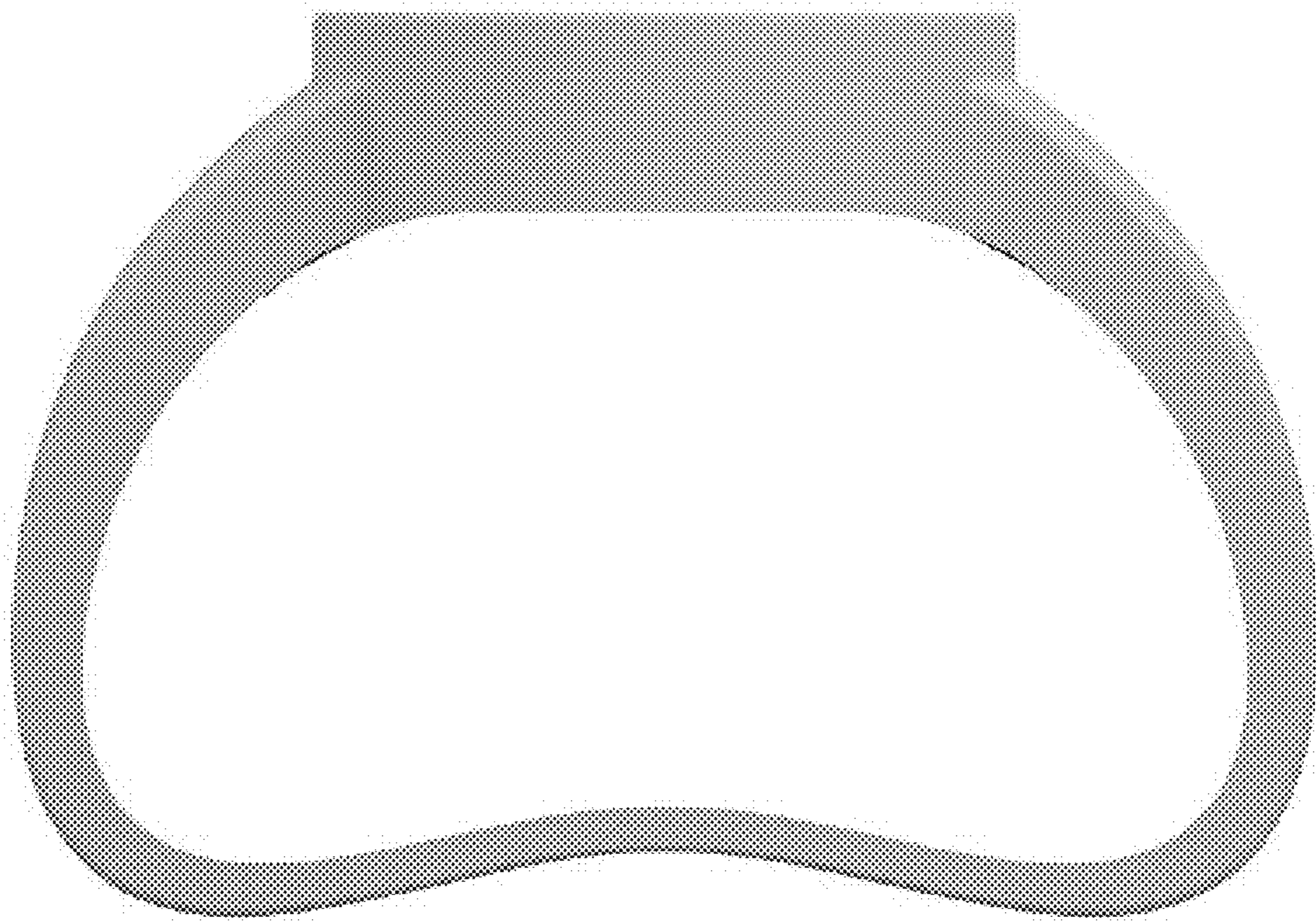

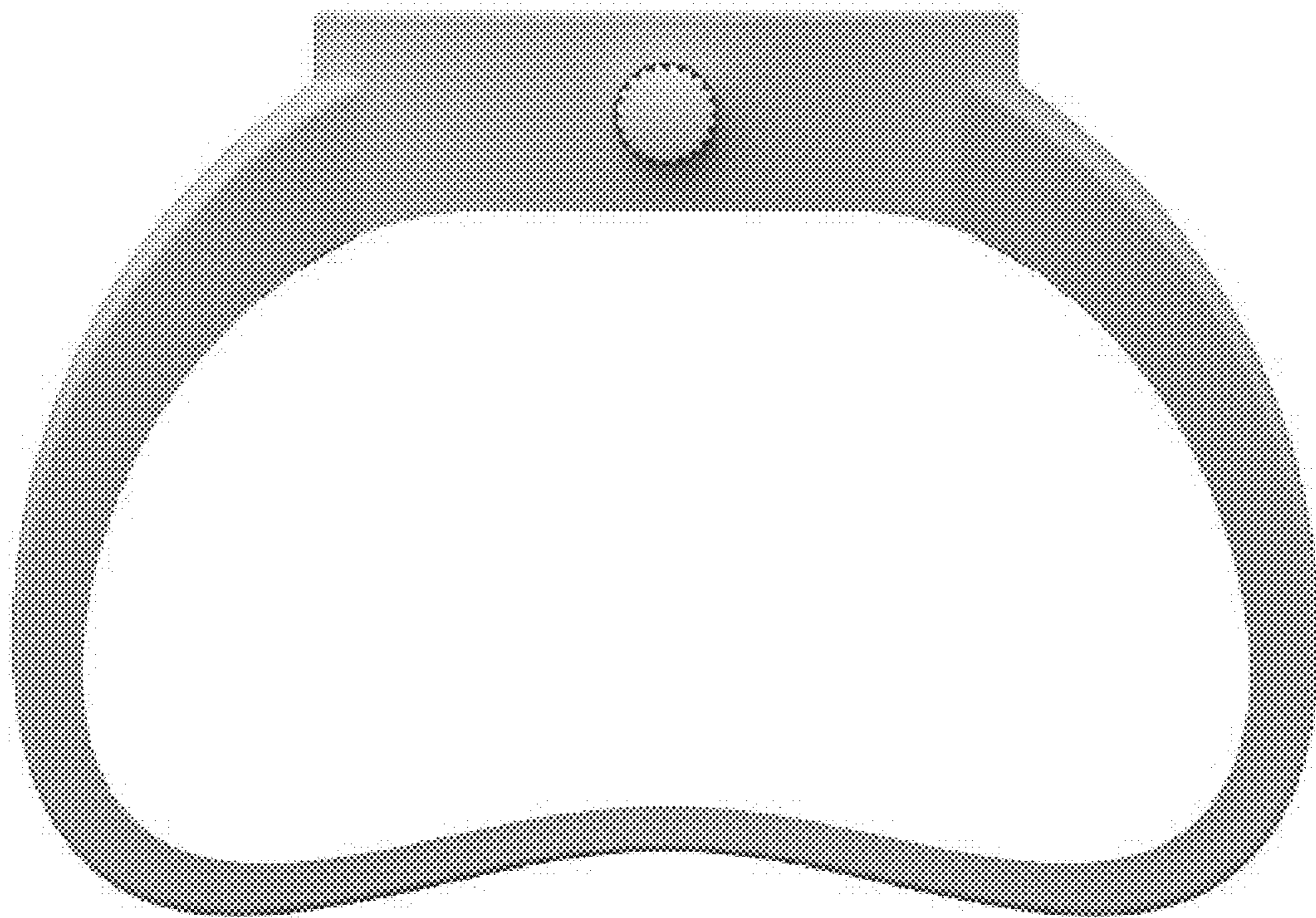
