FIG. 1 is a front perspective view showing my new design; FIG. 2 is a front elevational view thereof; the rear elevational view is identical;

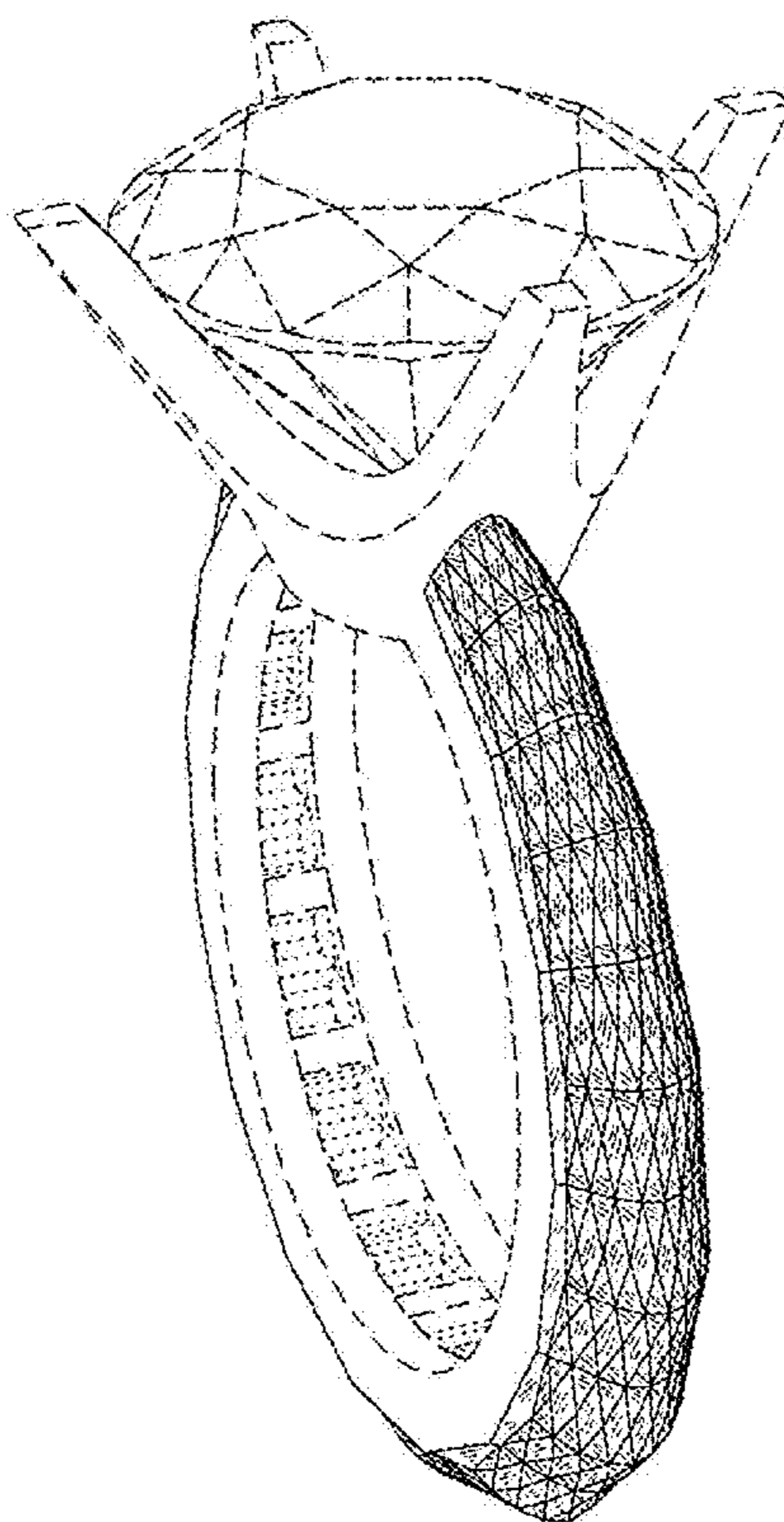
FIG. 3 is a top plan view thereof;

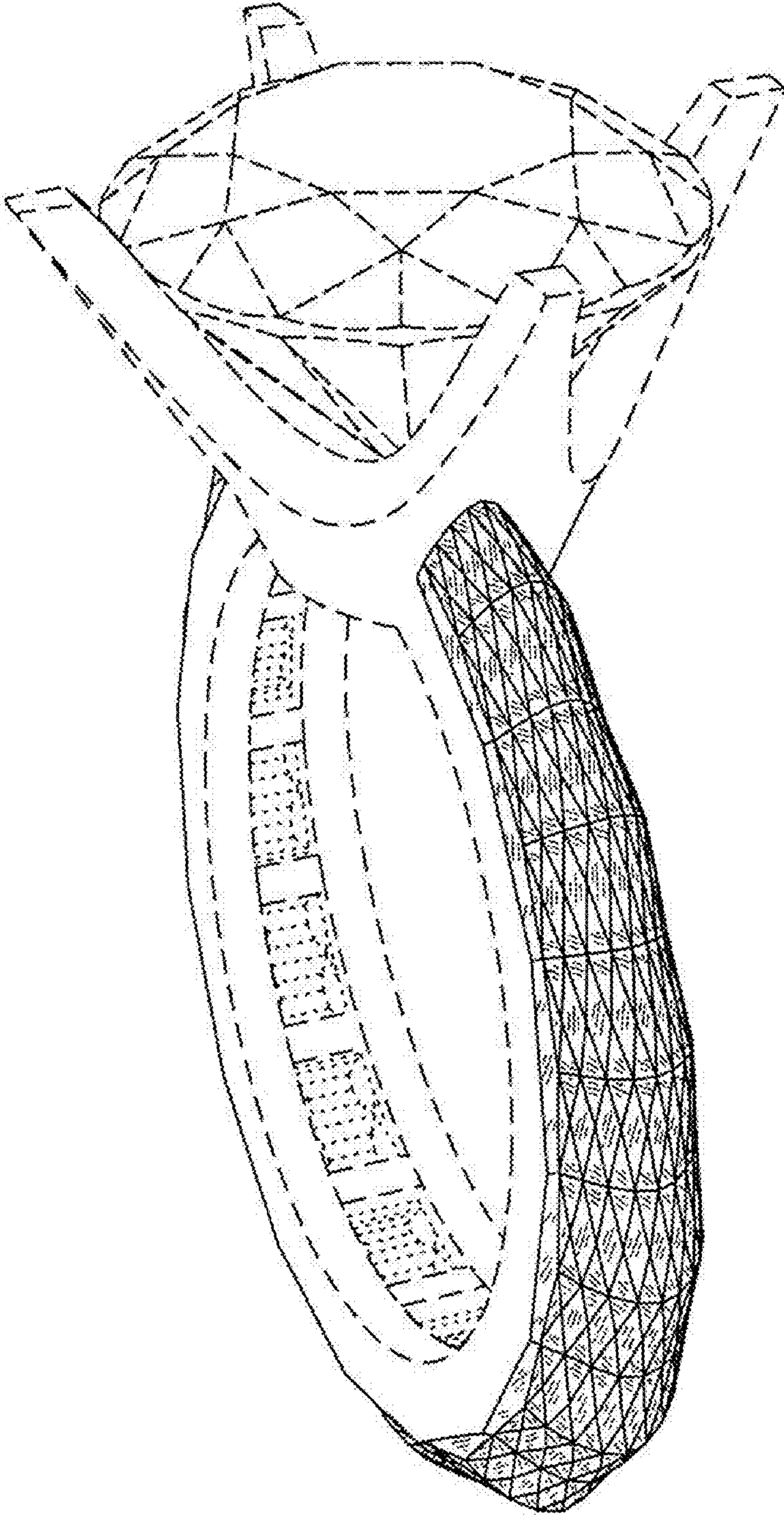

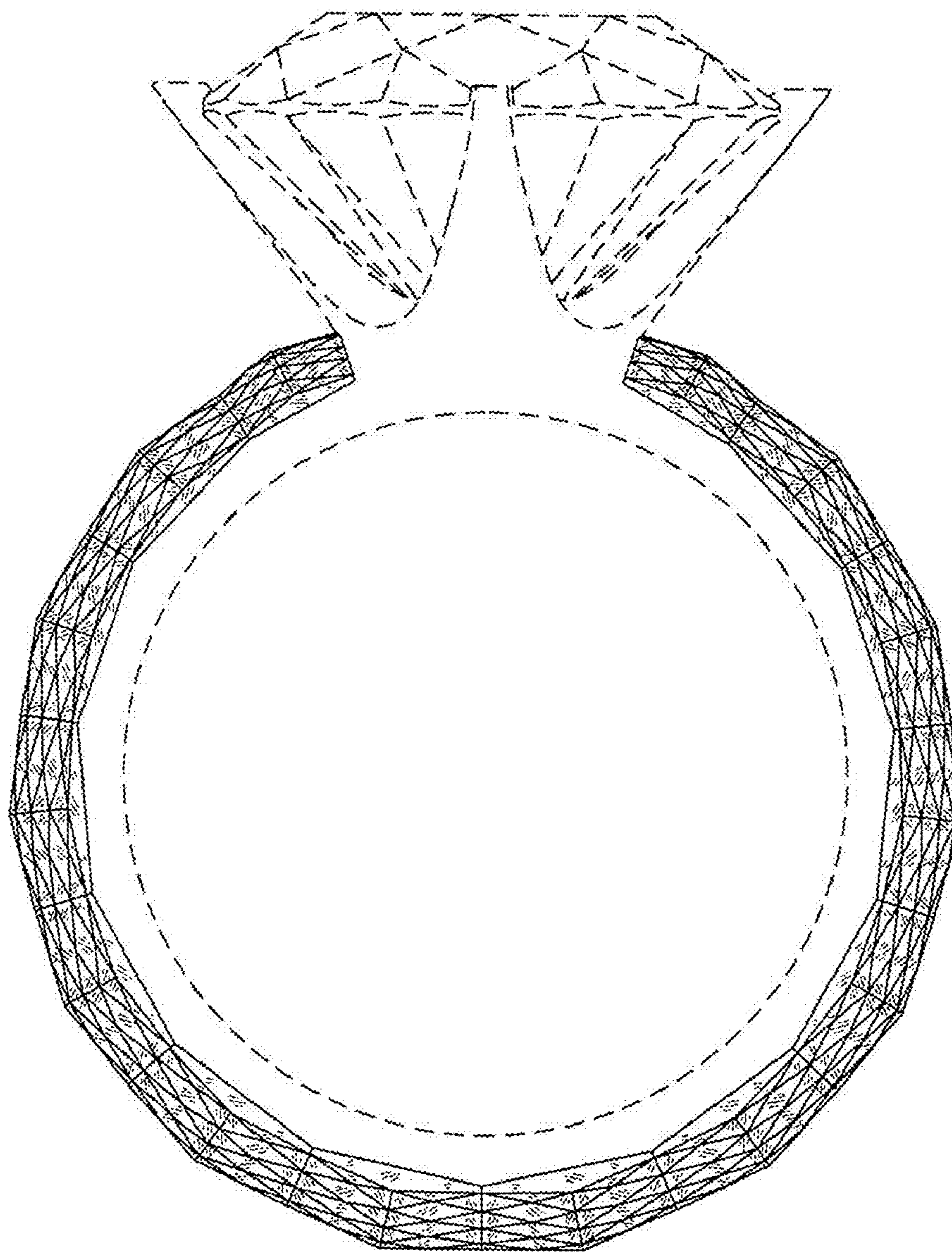

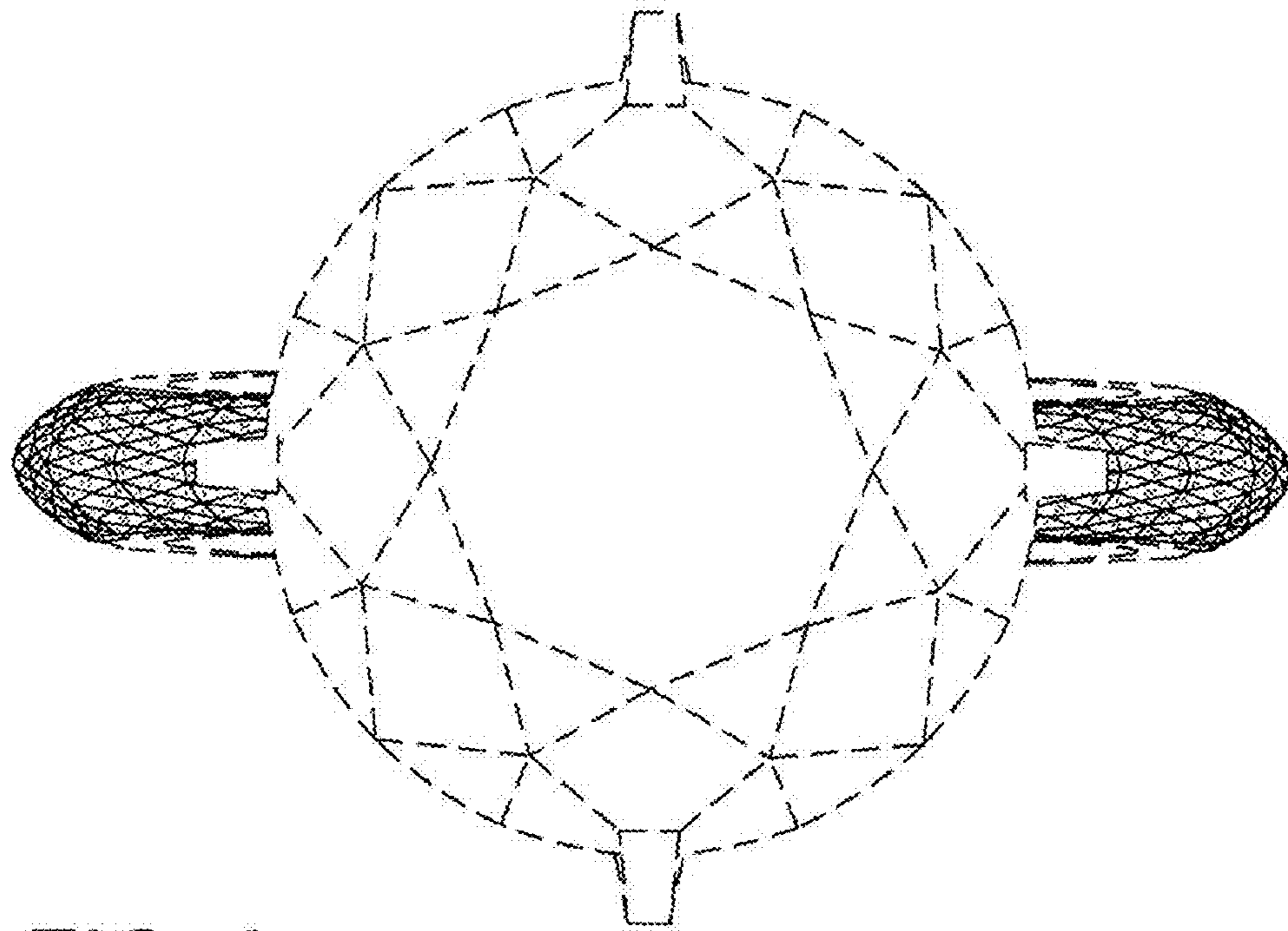

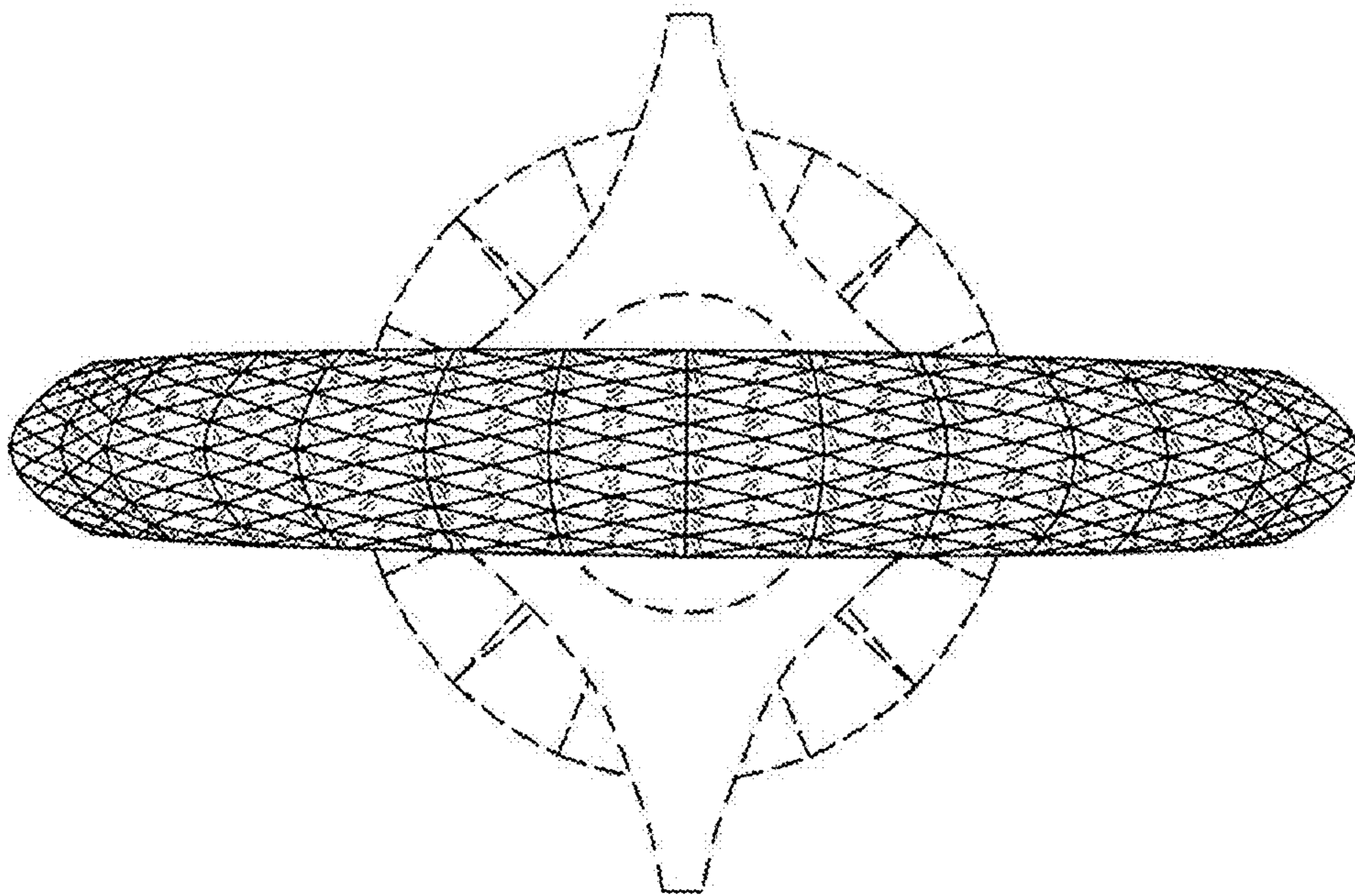

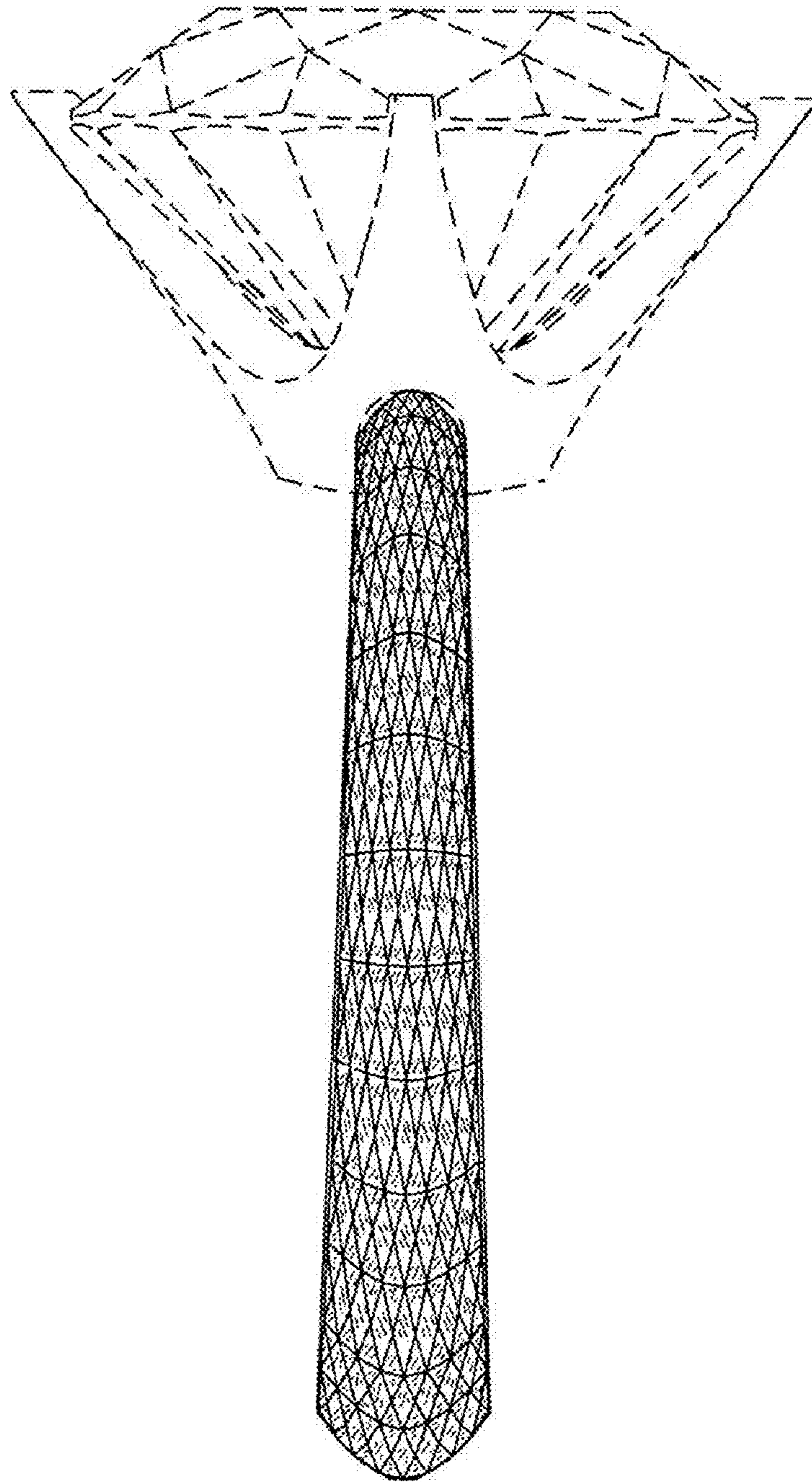
