The ornamental design for a ring, as shown and described.

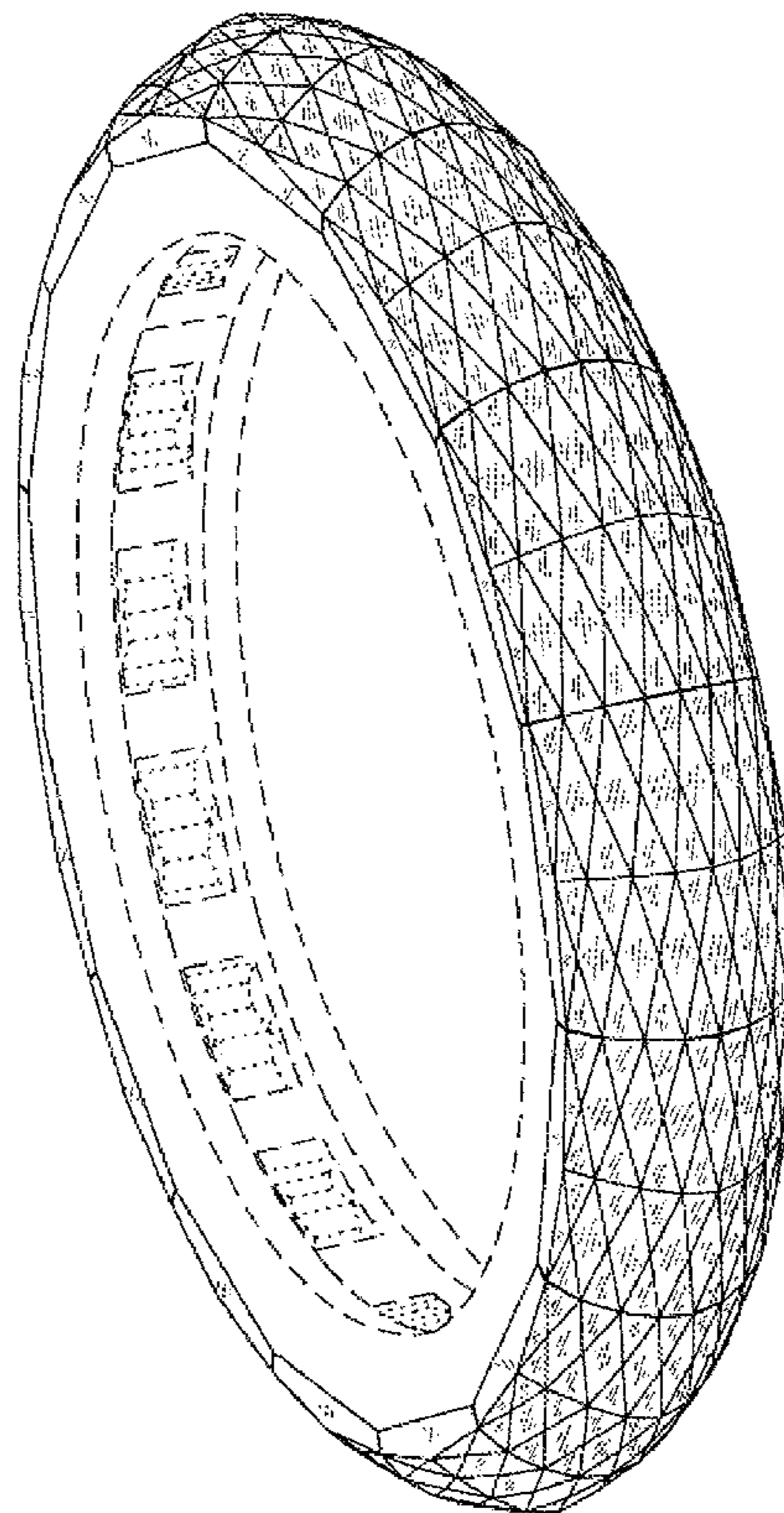
DESCRIPTION

FIG. 1 is a front perspective view showing my new design; FIG. 2 is a front elevational view thereof; the rear elevational view is identical;

FIG. 3 is a right side elevational view thereof (the left side elevational view being substantially identical thereto); and, FIG. 4 is a top plan view thereof; the bottom plan view is identical.

The broken lines shown in the drawings represent unclaimed portions of the ring and form no part of the claimed design.

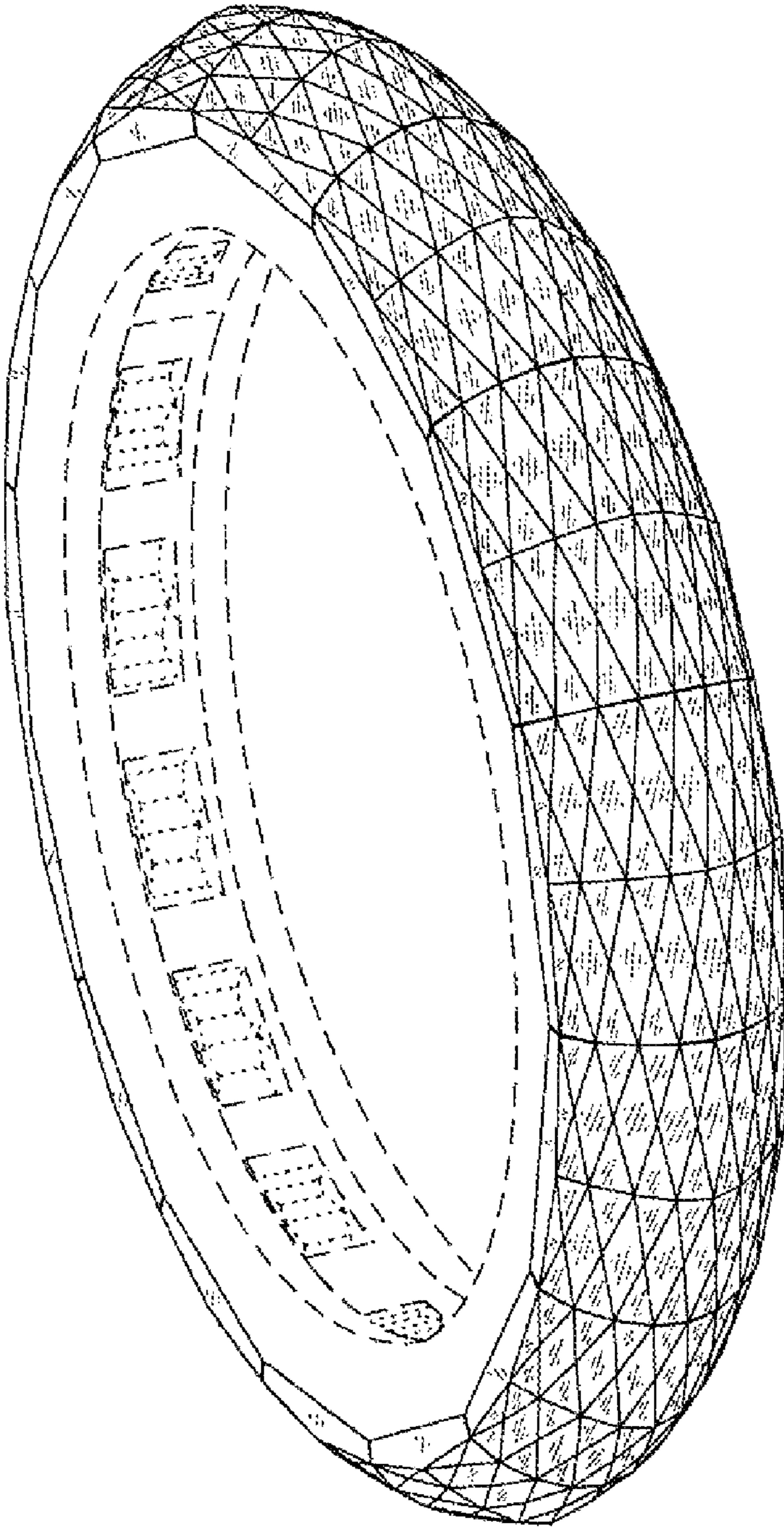

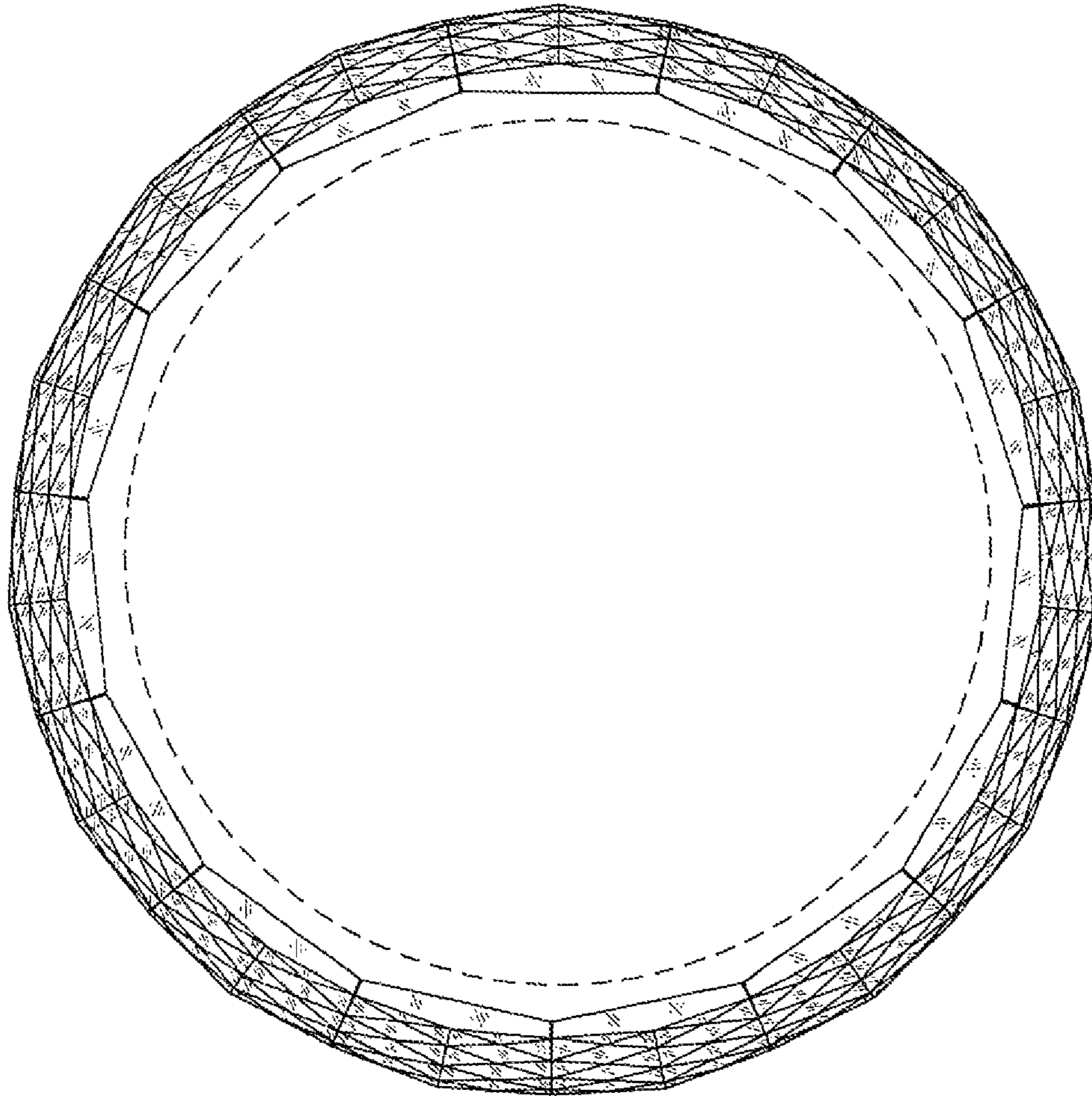

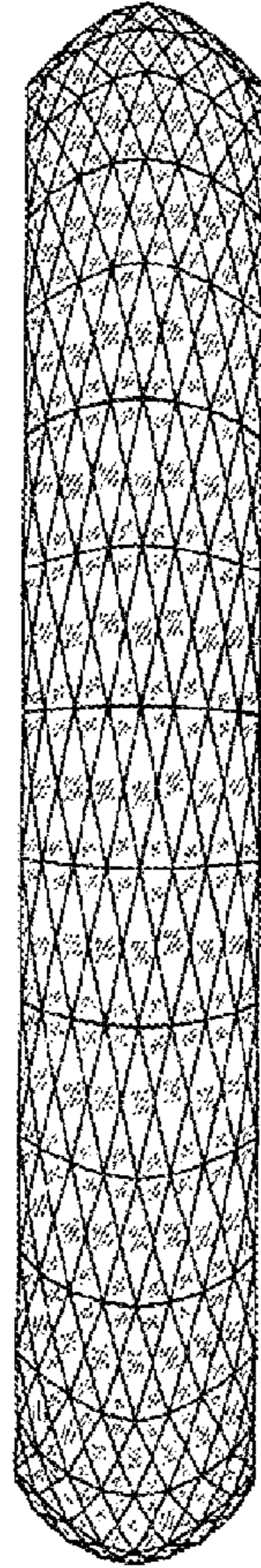

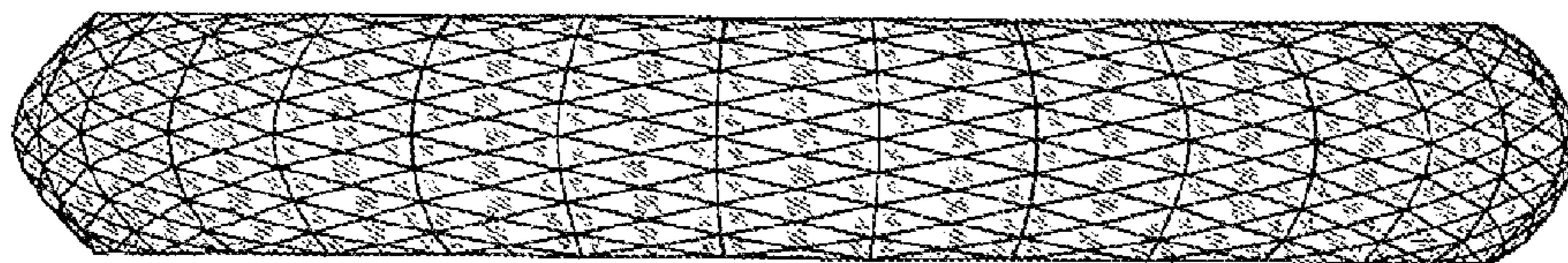
