(57) **CLAIM**

The ornamental design for a rear cover for skid steer loader, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a rear cover for skid steer loader showing our new design;

FIG. 6 is a bottom view thereof;

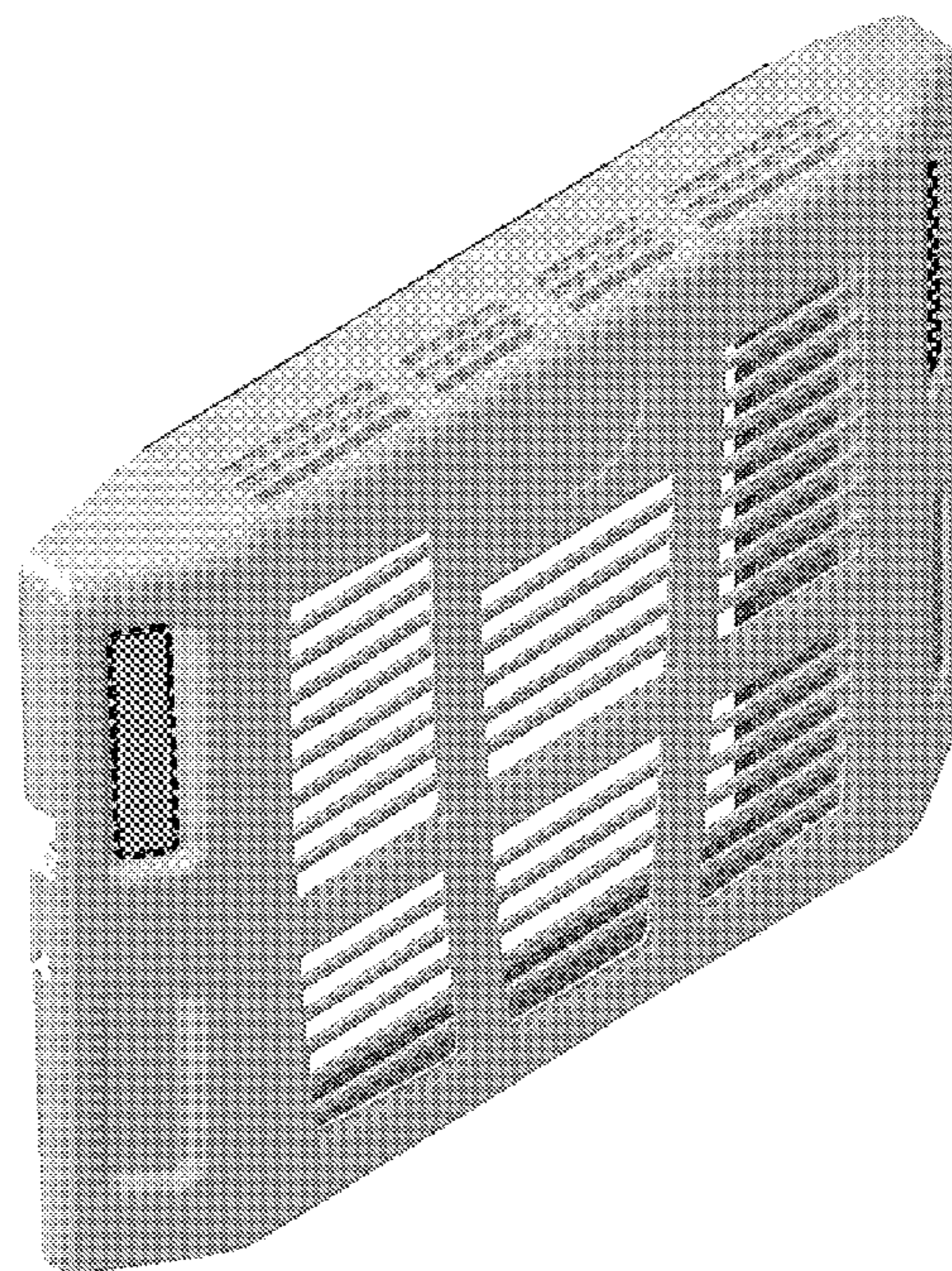
FIG. 7 is a perspective view thereof 1;

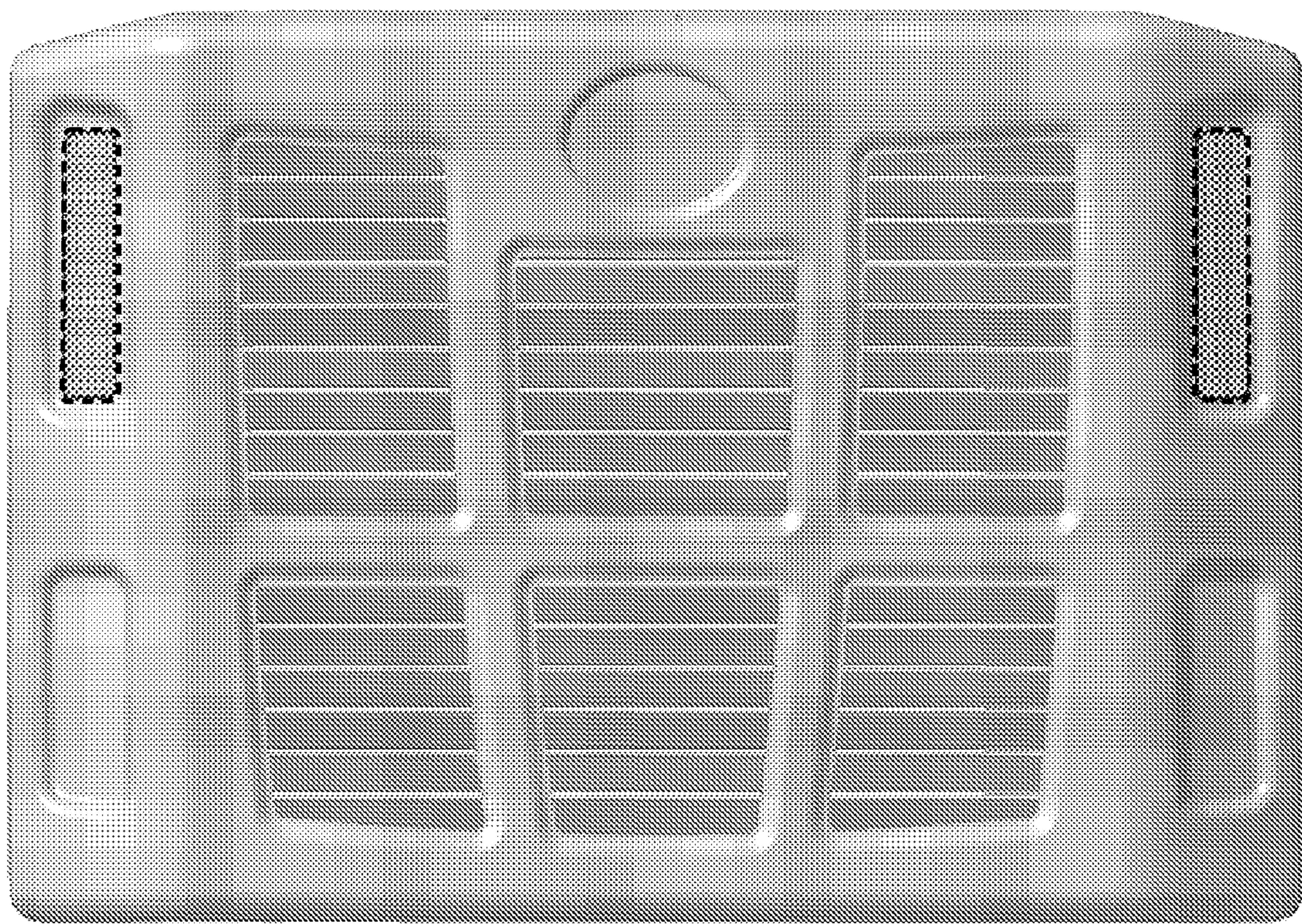

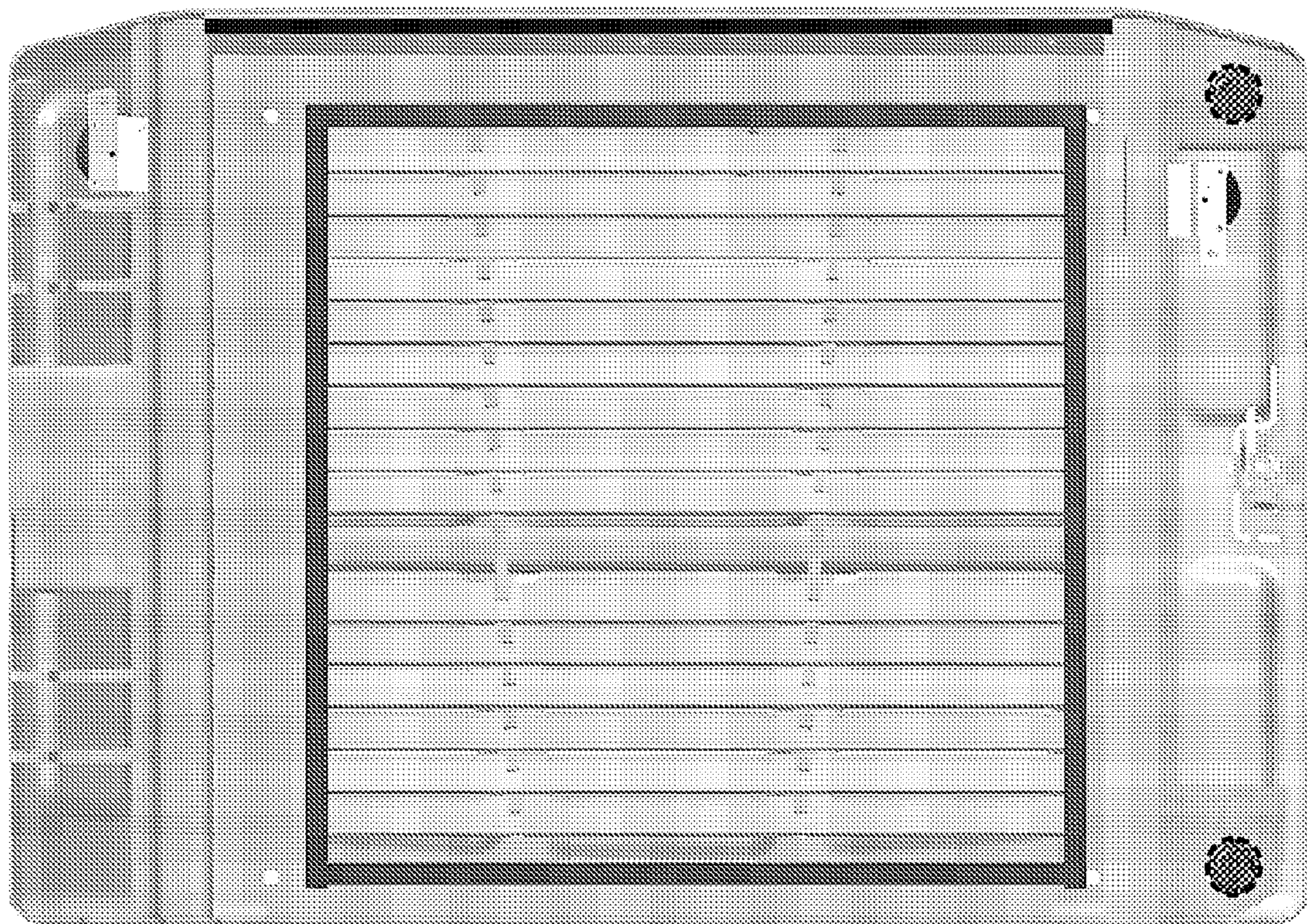

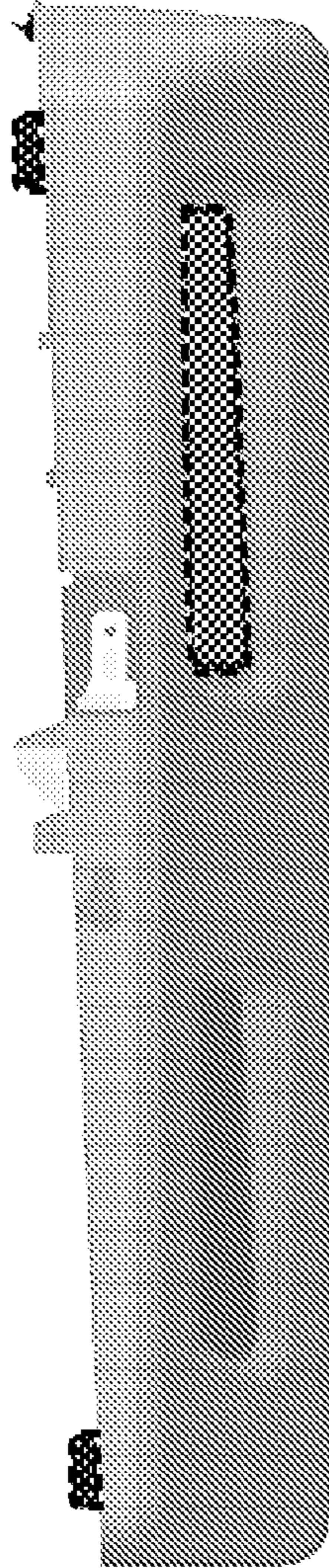

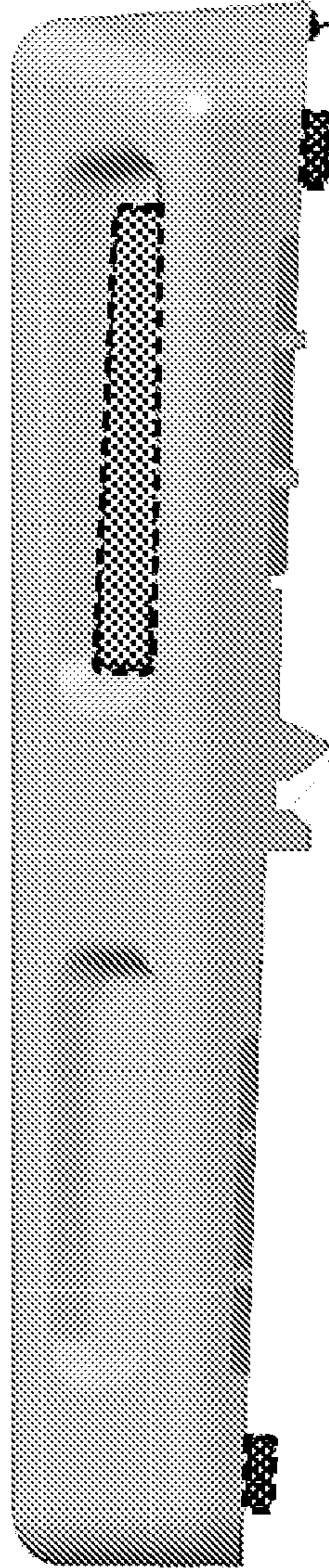

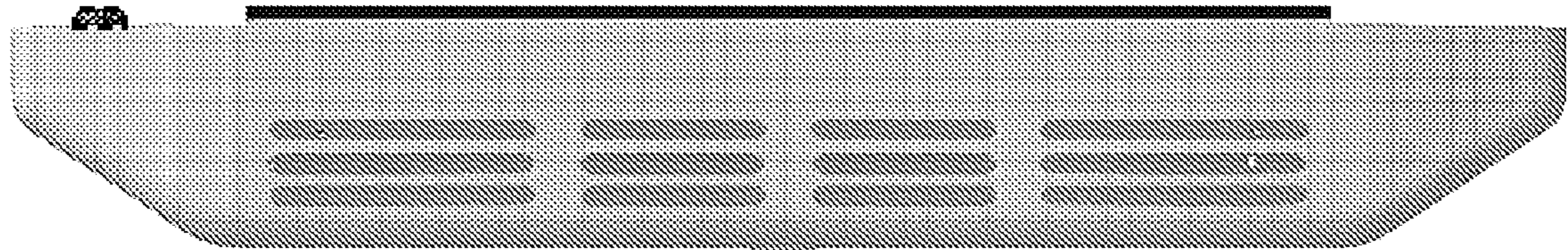

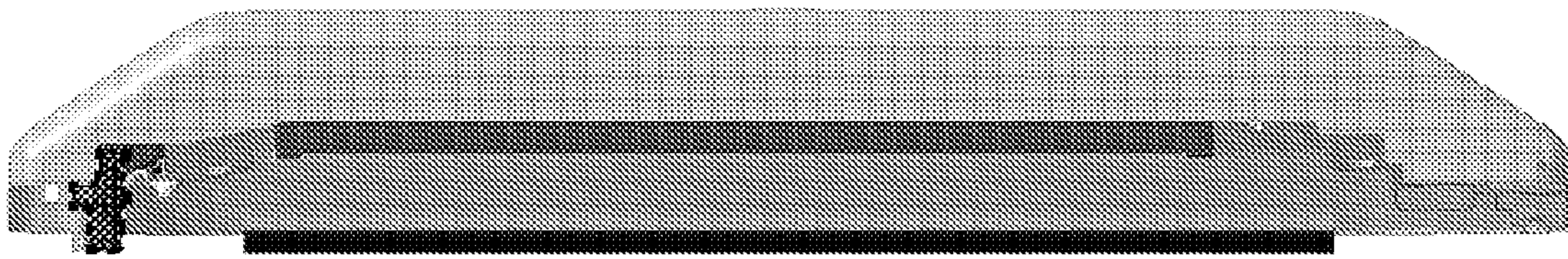

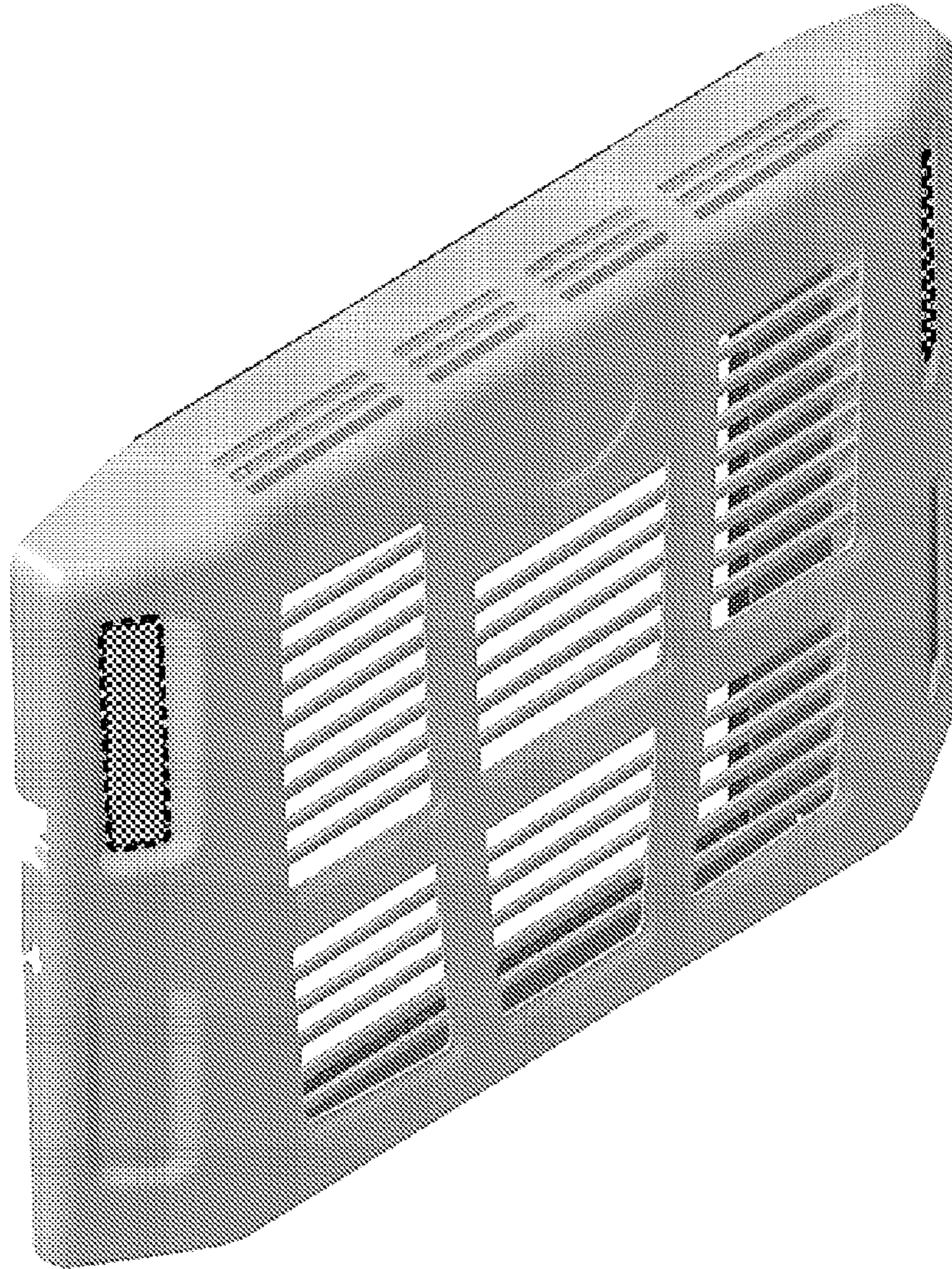

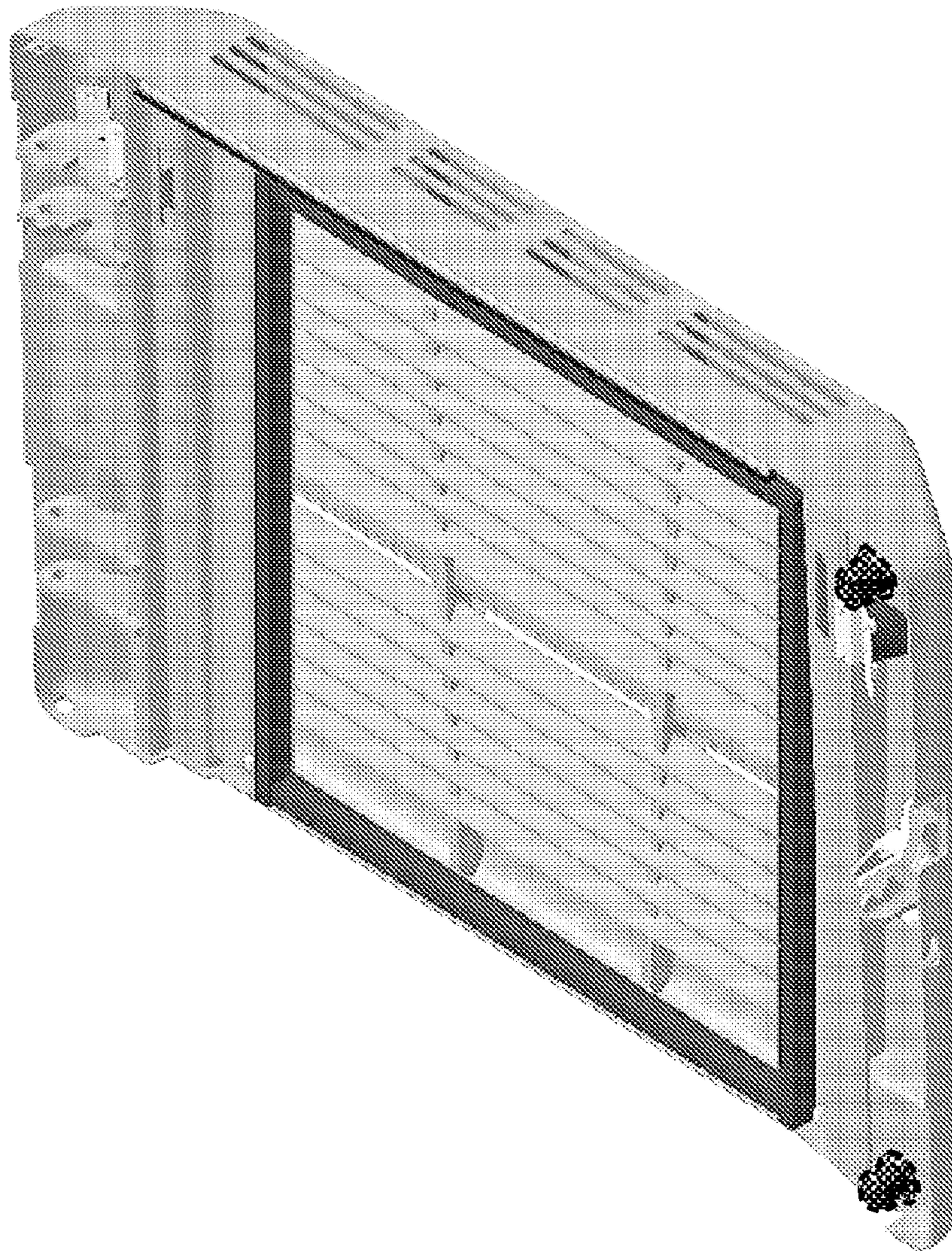

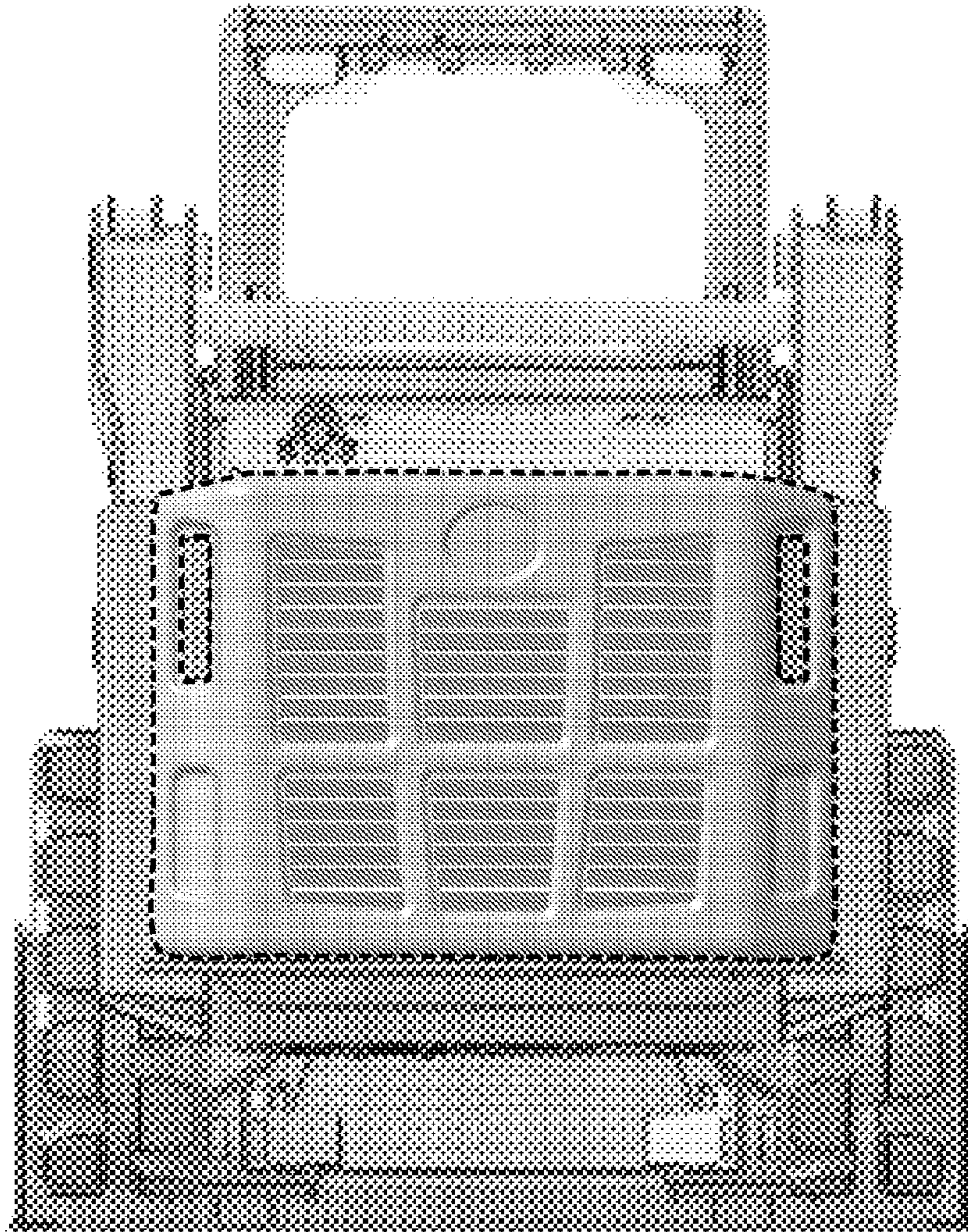
