**DESCRIPTION**

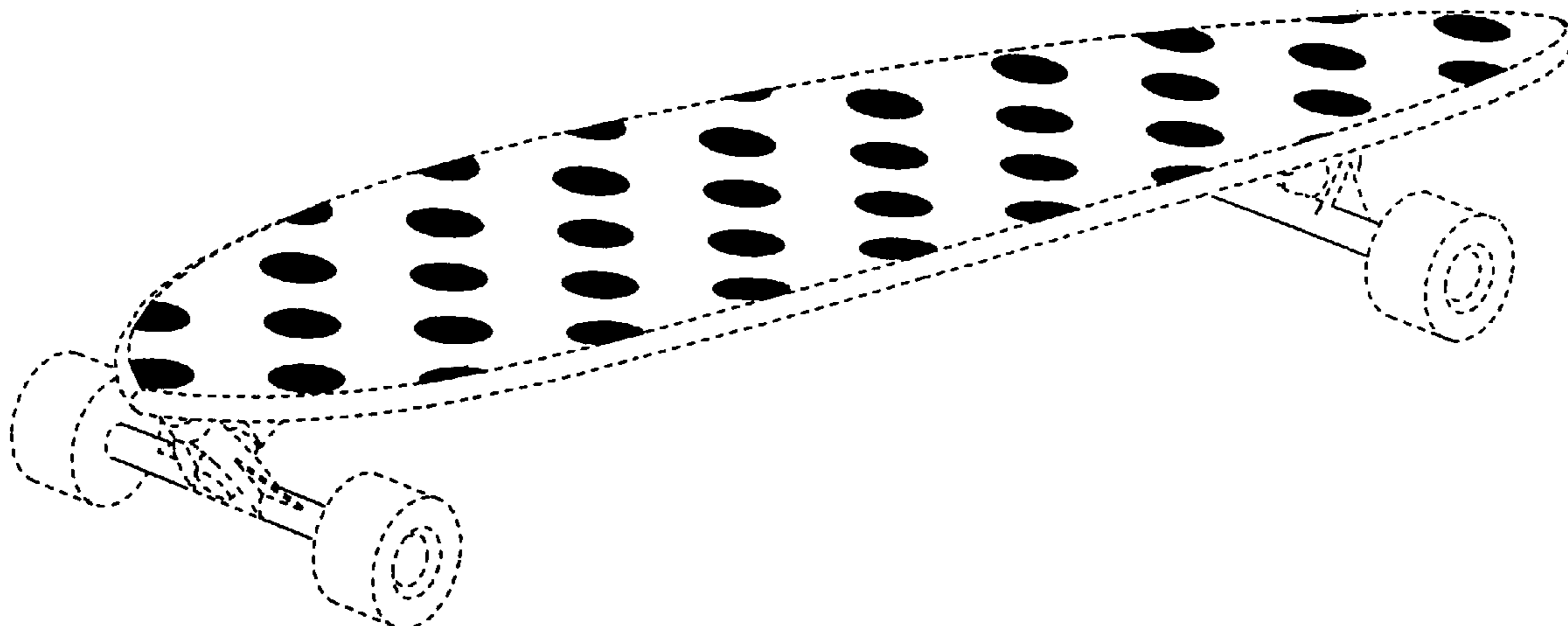
FIG. 1 is a left front perspective view of my new, original design for skateboard;

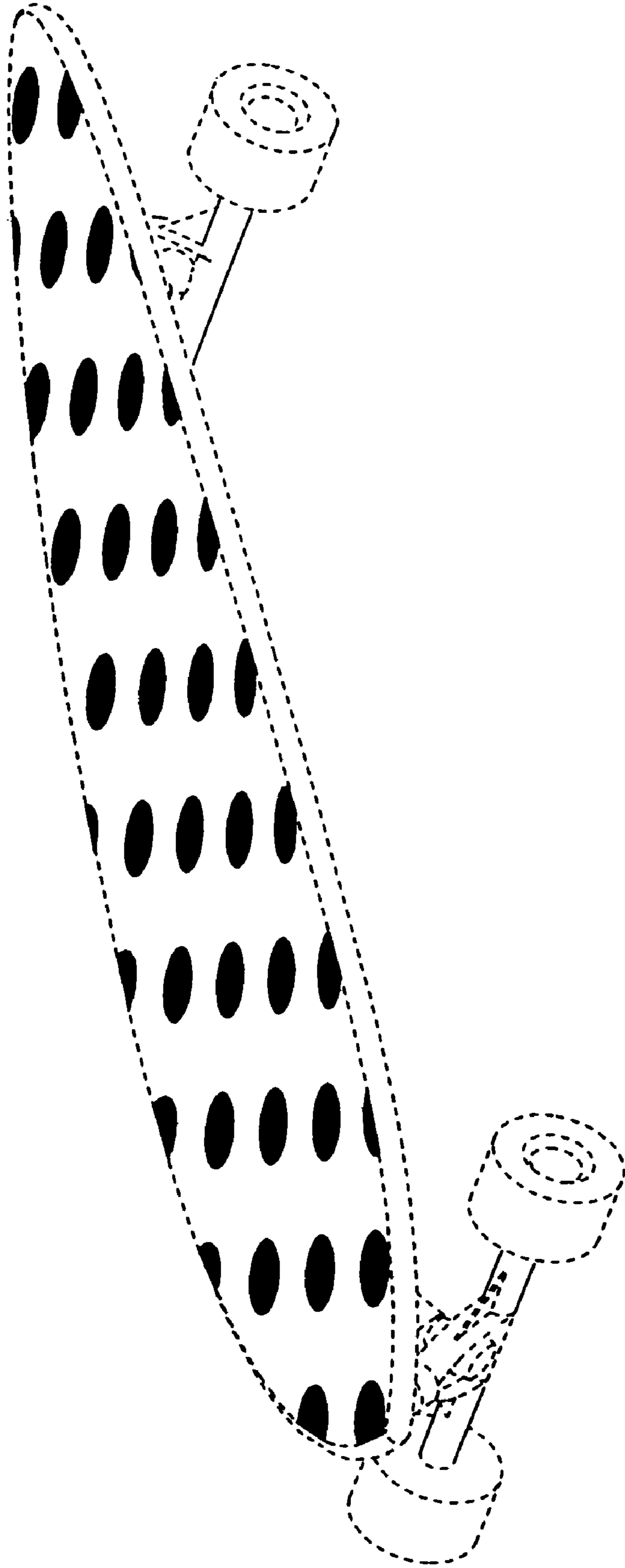

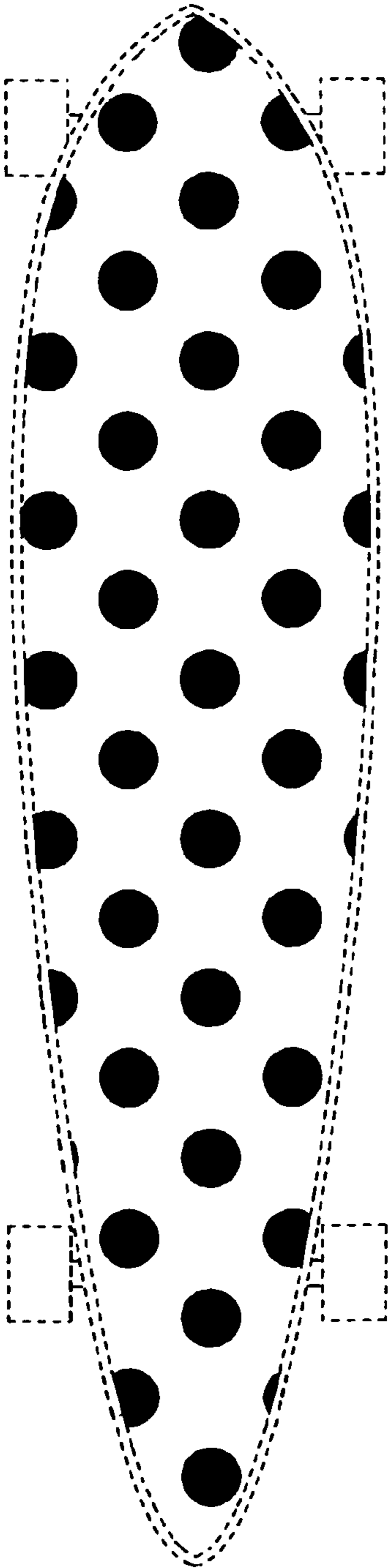

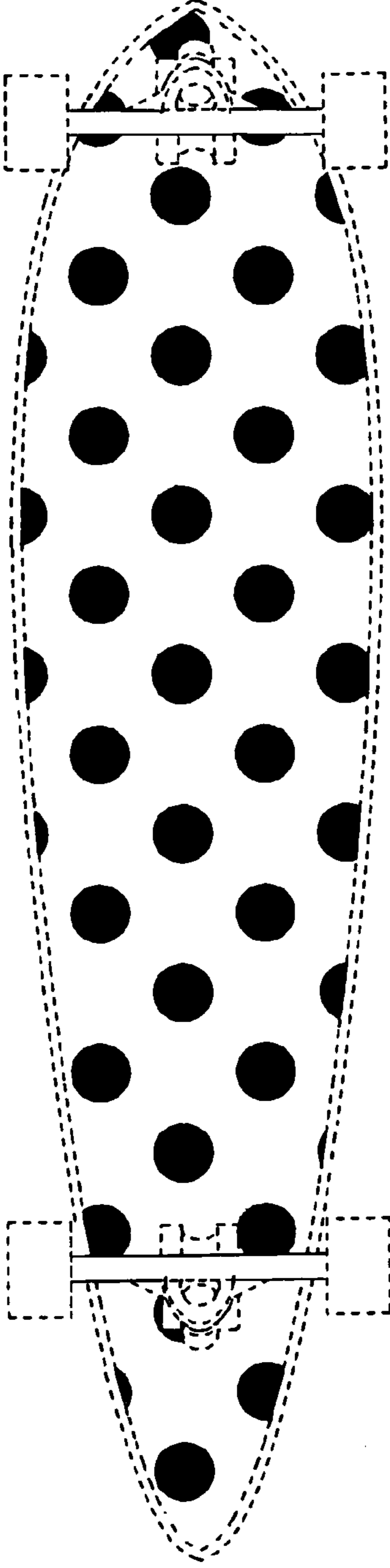
