FIG. 3 is a back view;

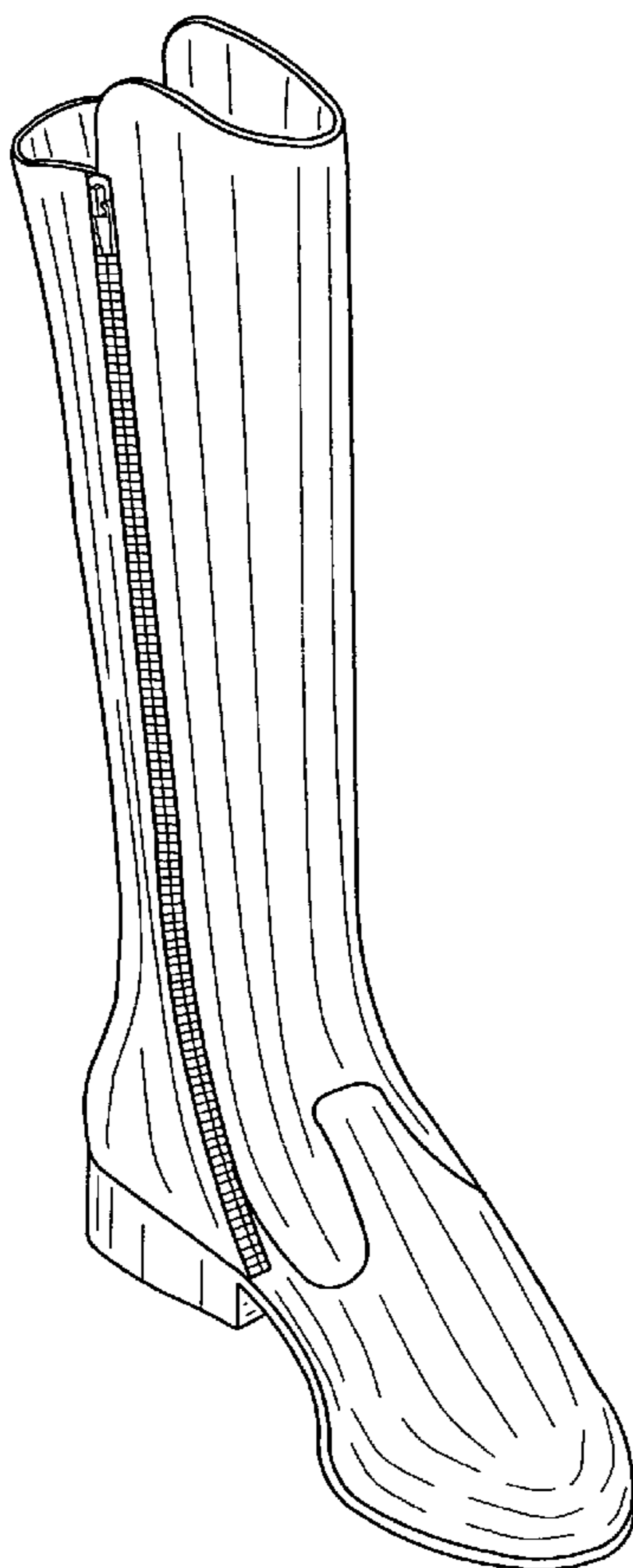
FIG. 4 is an inner elevation view of the left shoe;

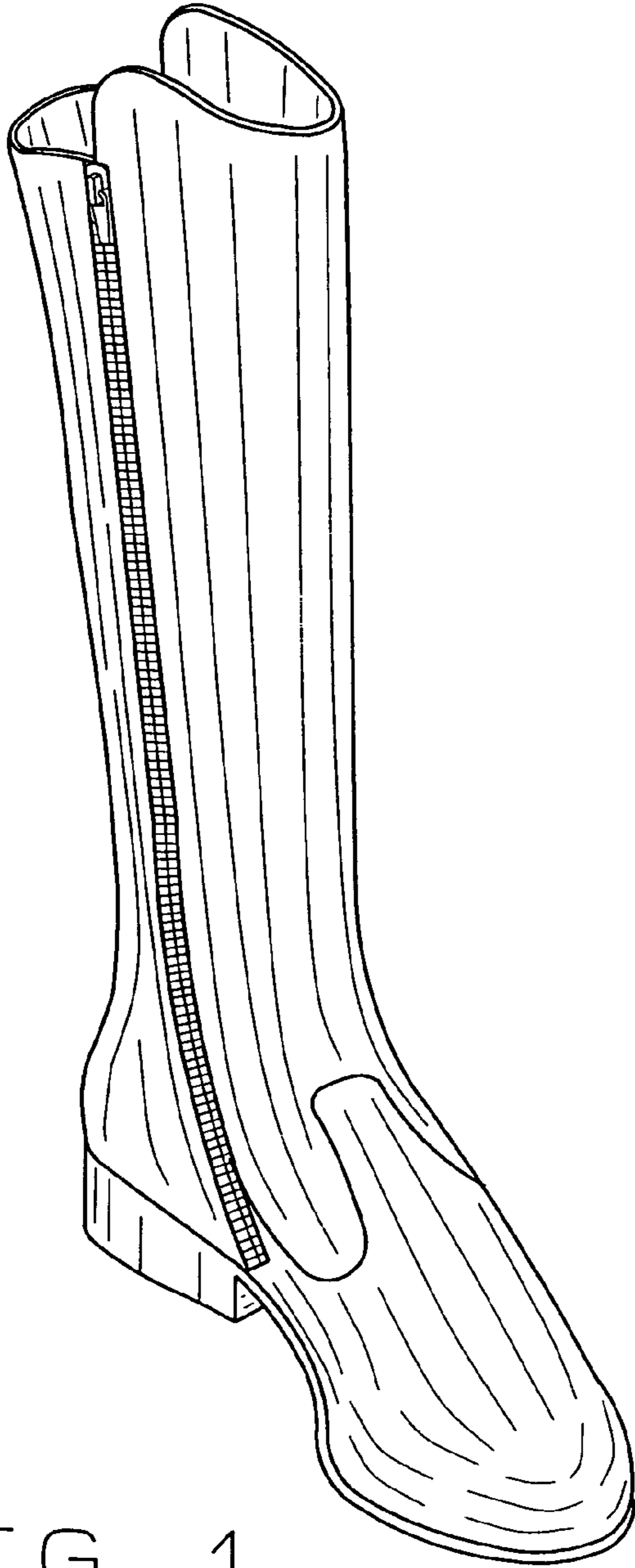

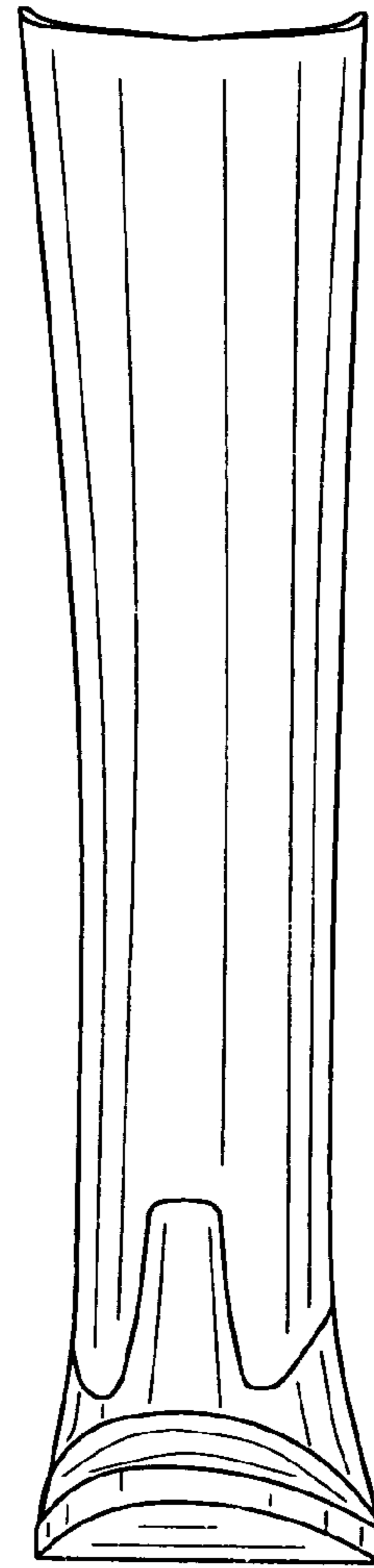

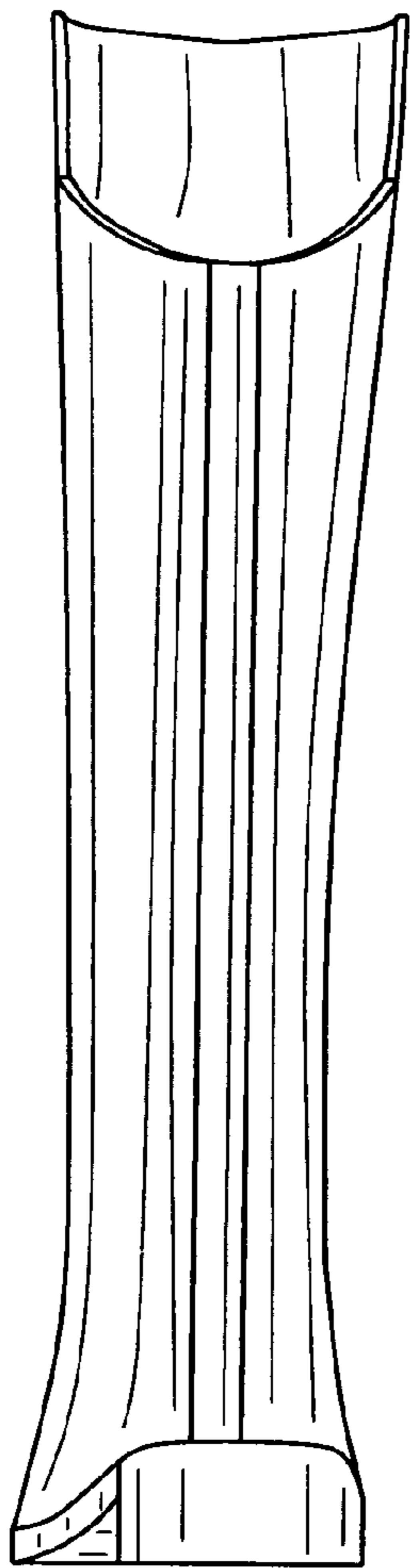

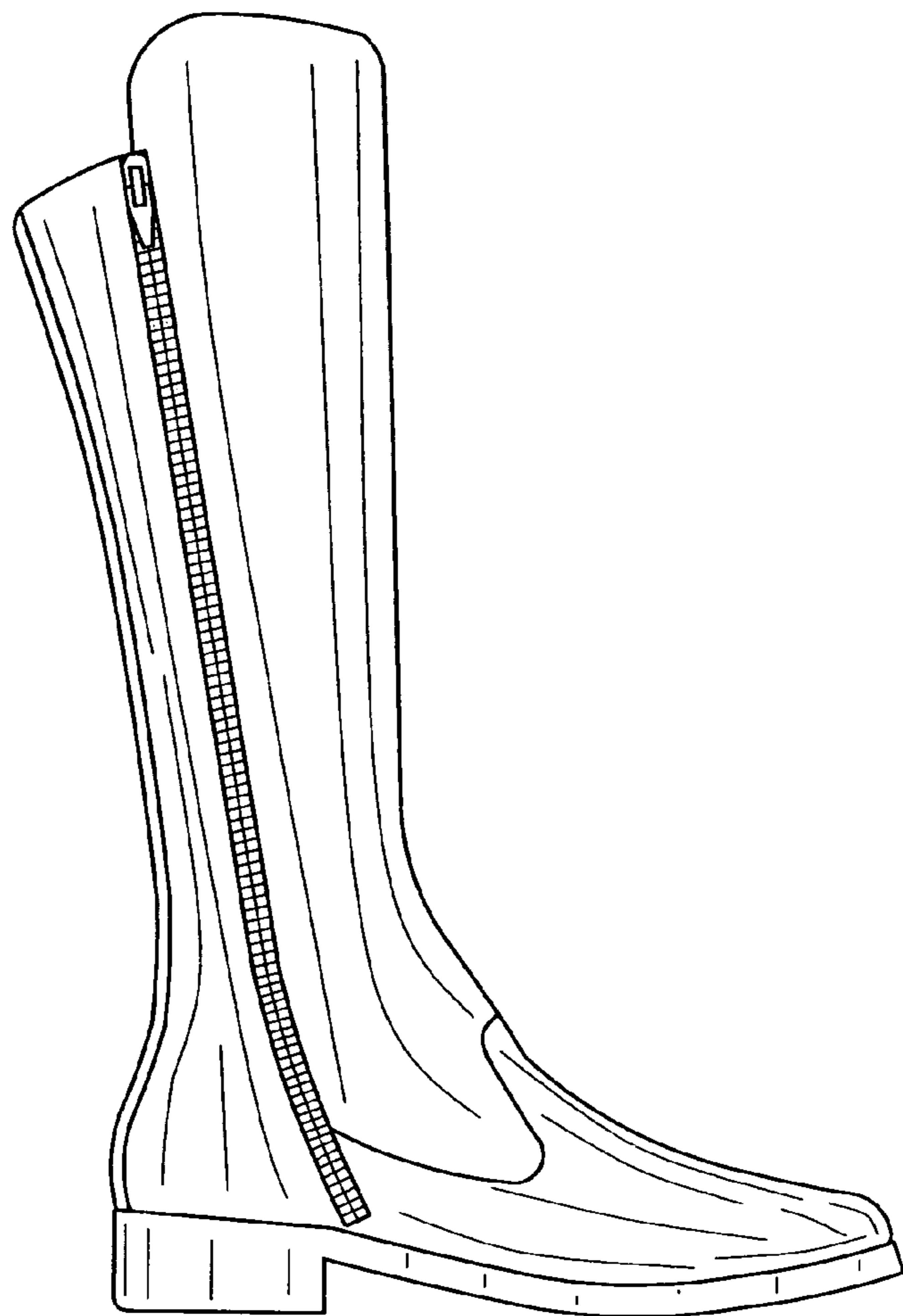

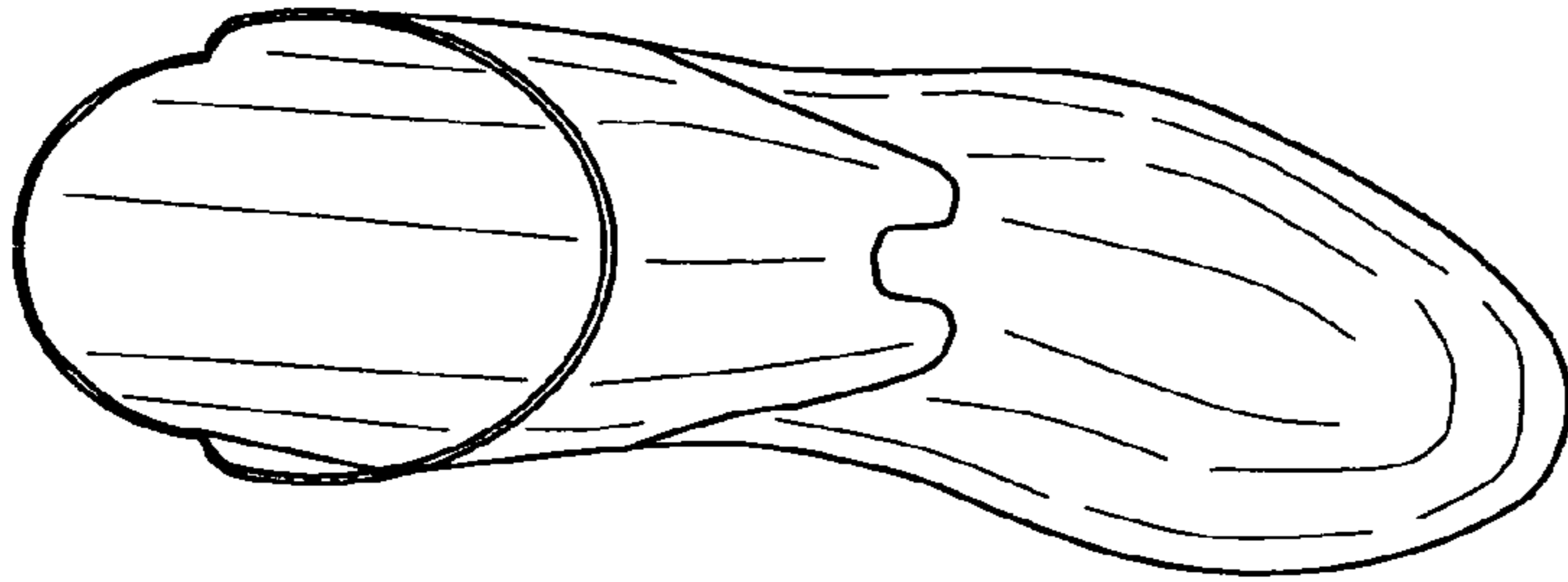

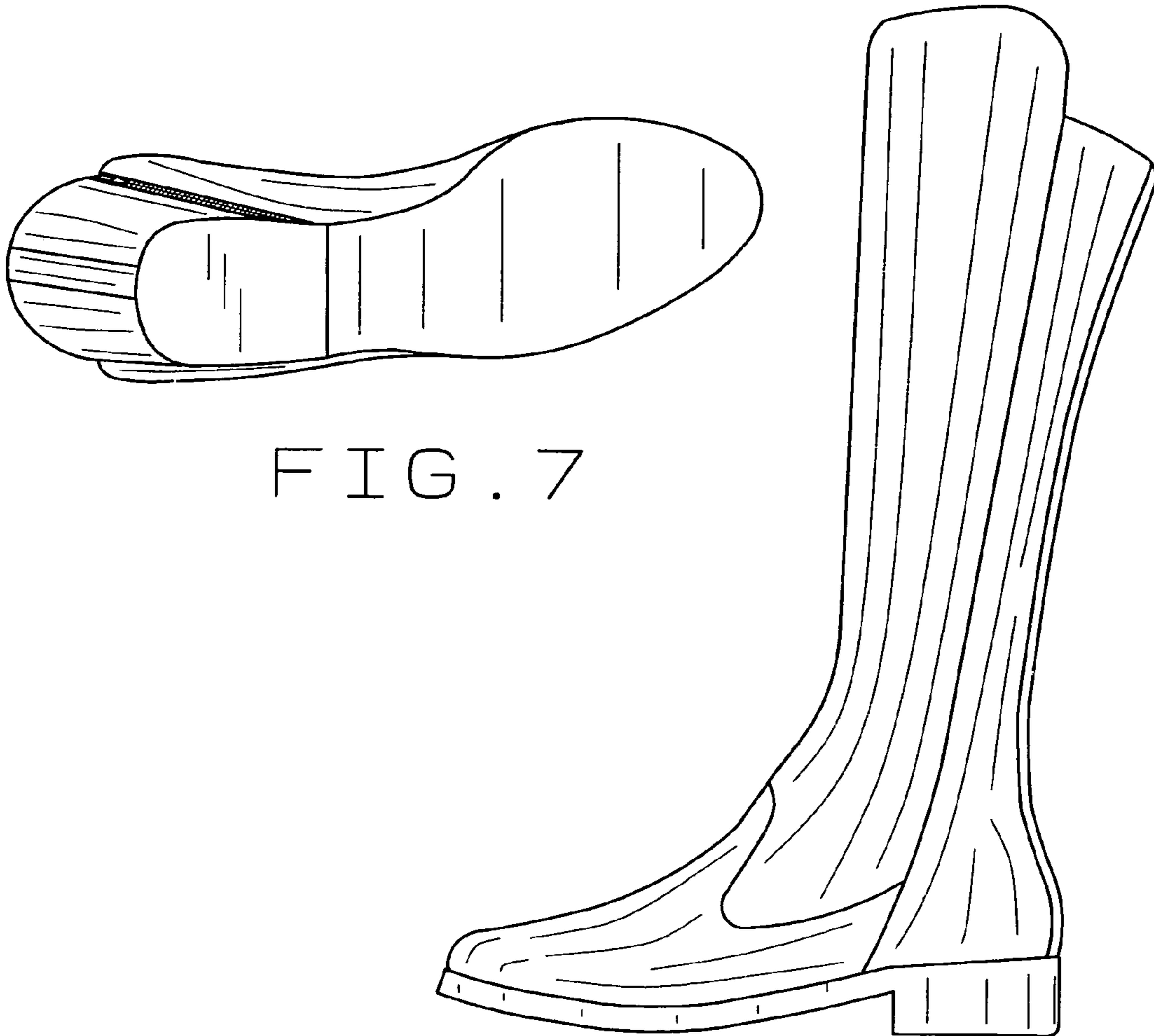
