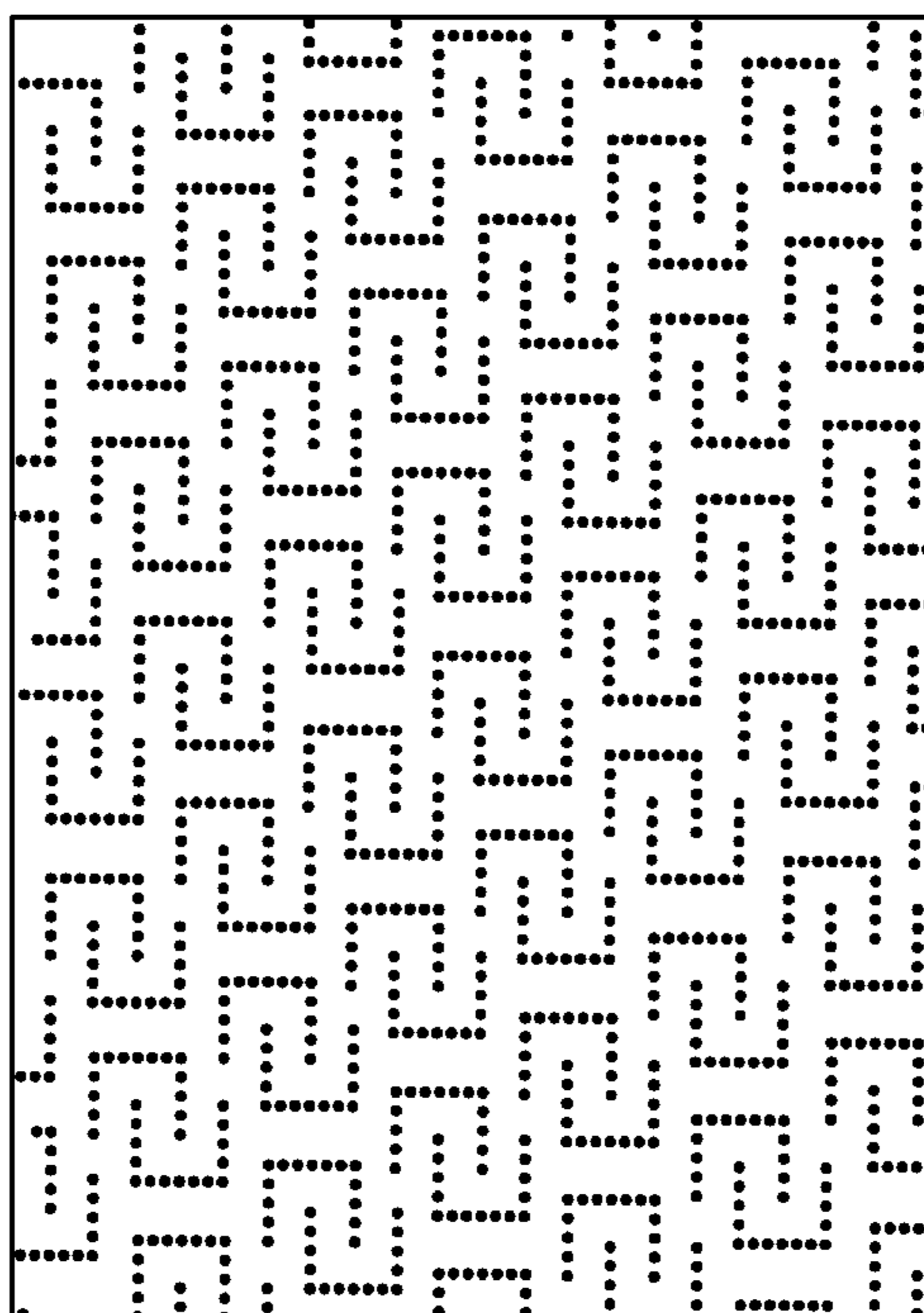
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is front perspective view of my cleaning wipe;

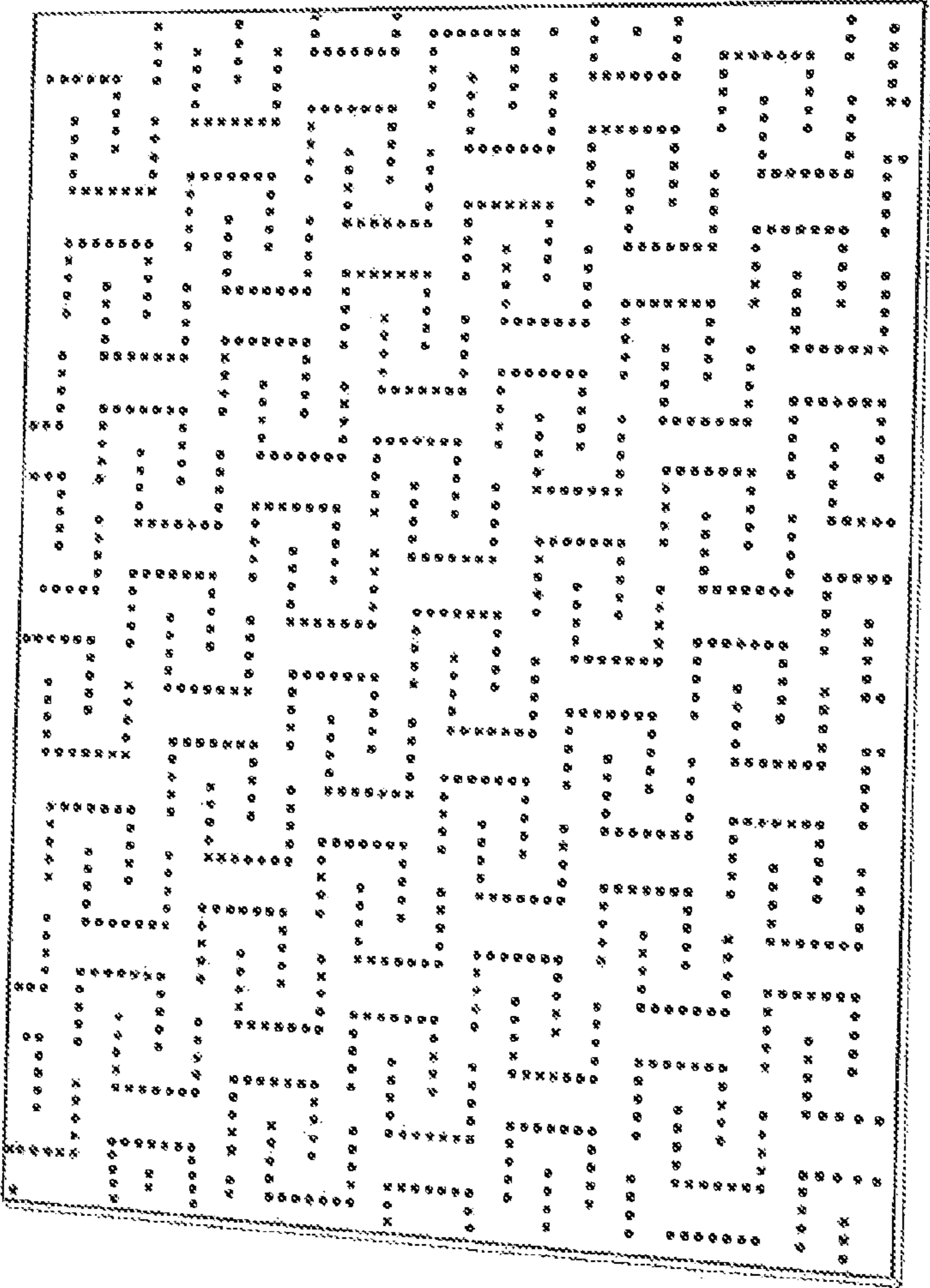
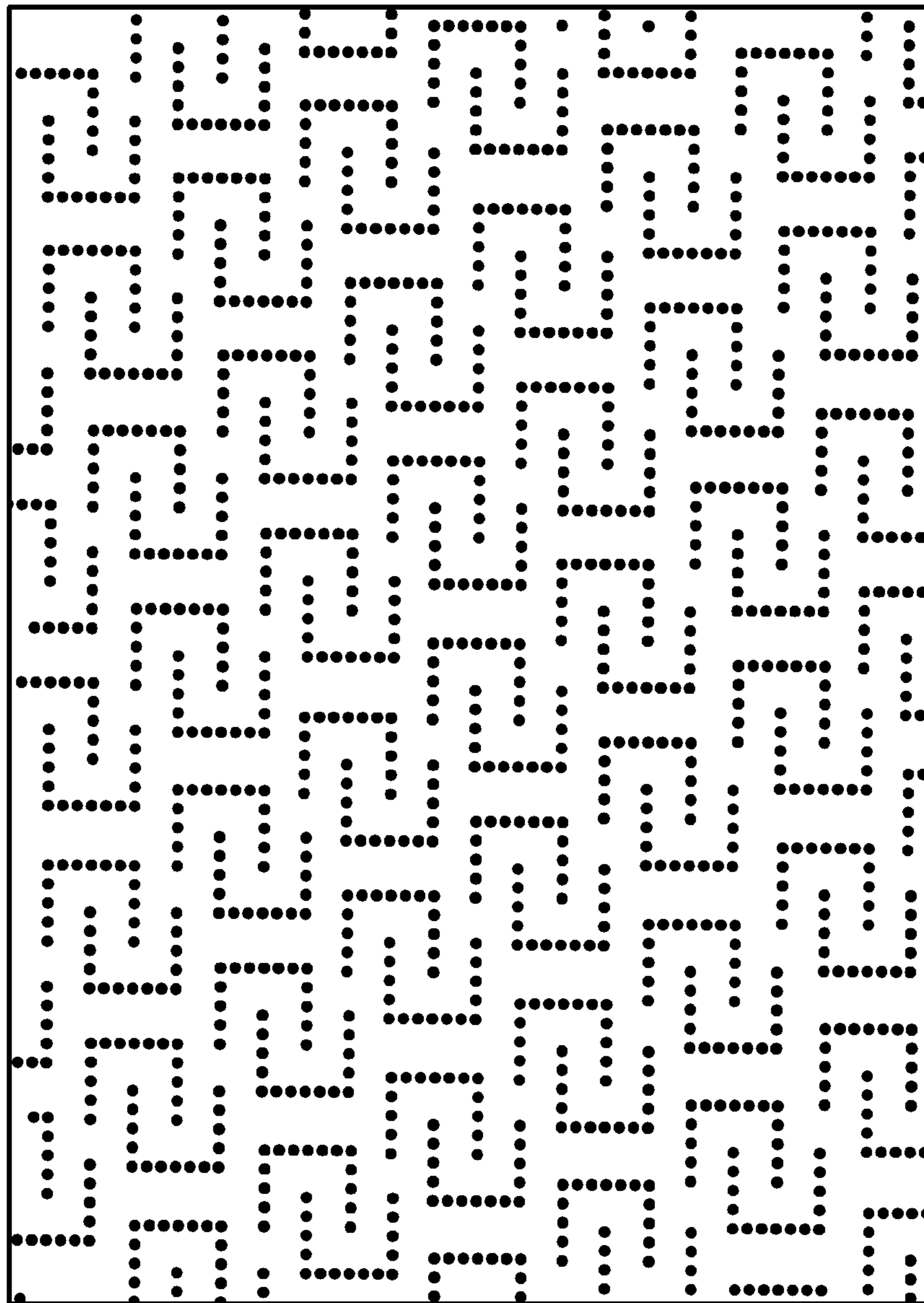
