The ornamental design for a pedicure spa, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the front, left and upper side of my new pedicure spa;

FIG. 2 is a top view of the pedicure spa, such as that shown in FIG. 1;

FIG. 3 is a left side view of the pedicure spa, such as that shown in FIG. 1;

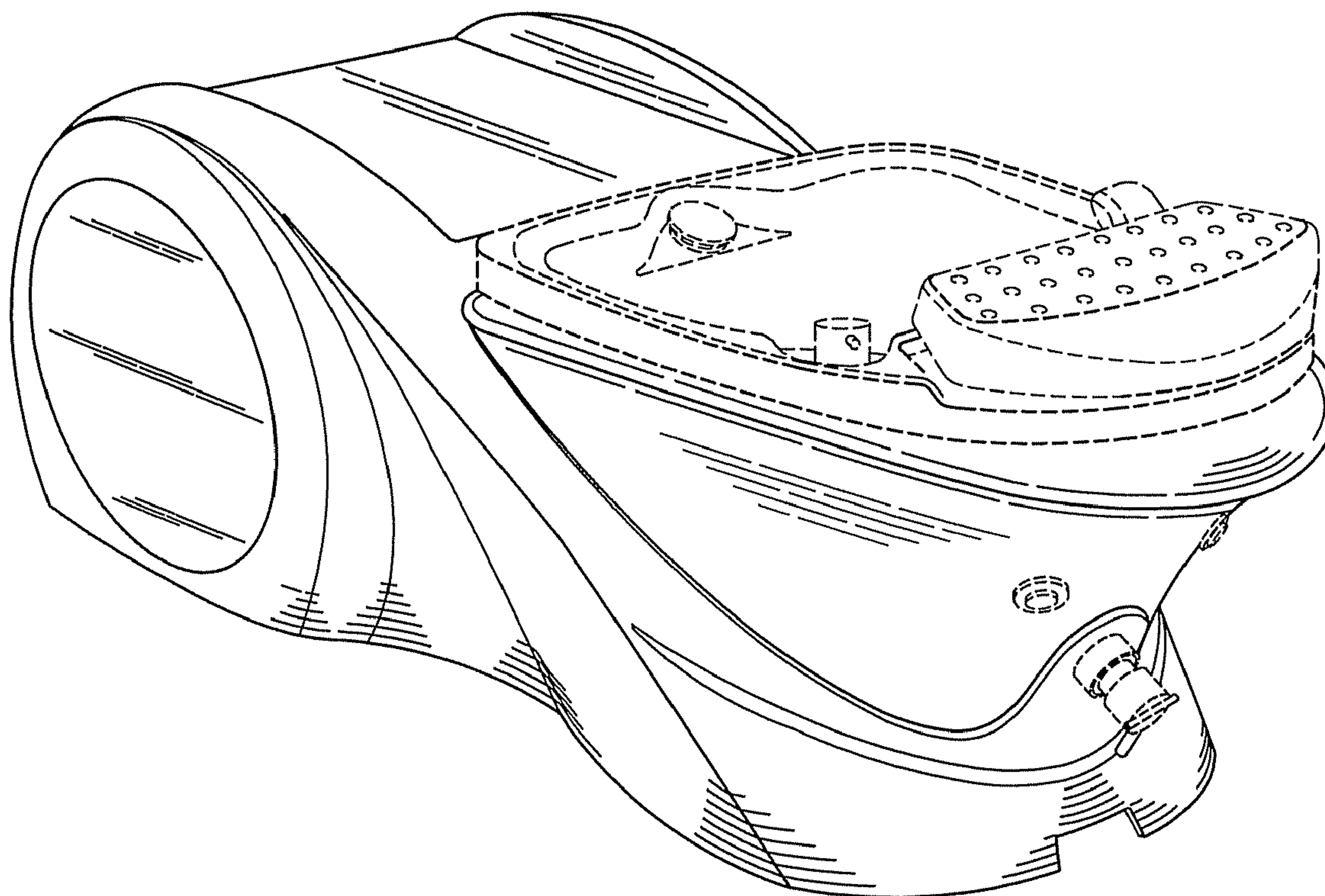
FIG. 4 is a right side view of the pedicure spa, such as that shown in FIG. 1;

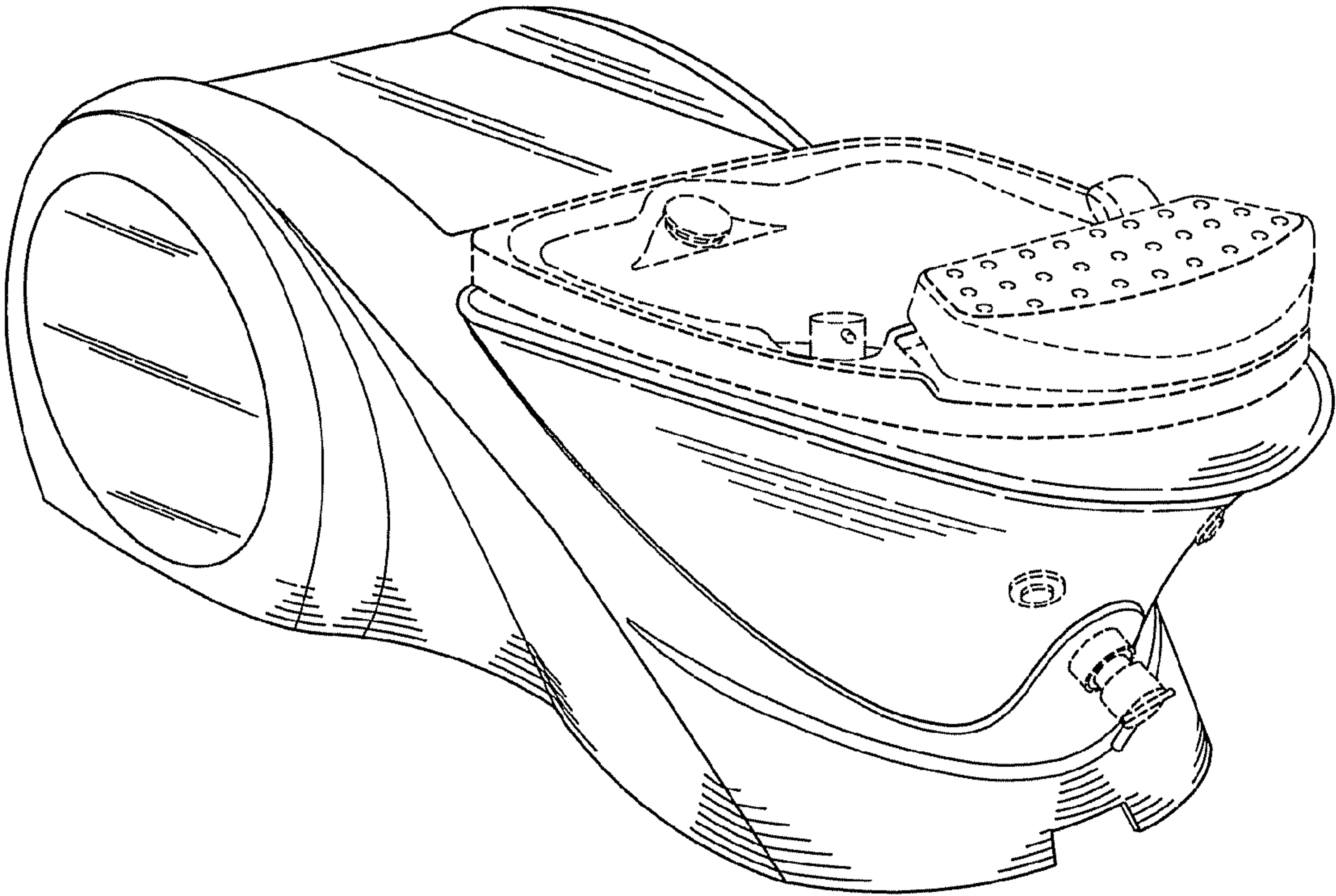

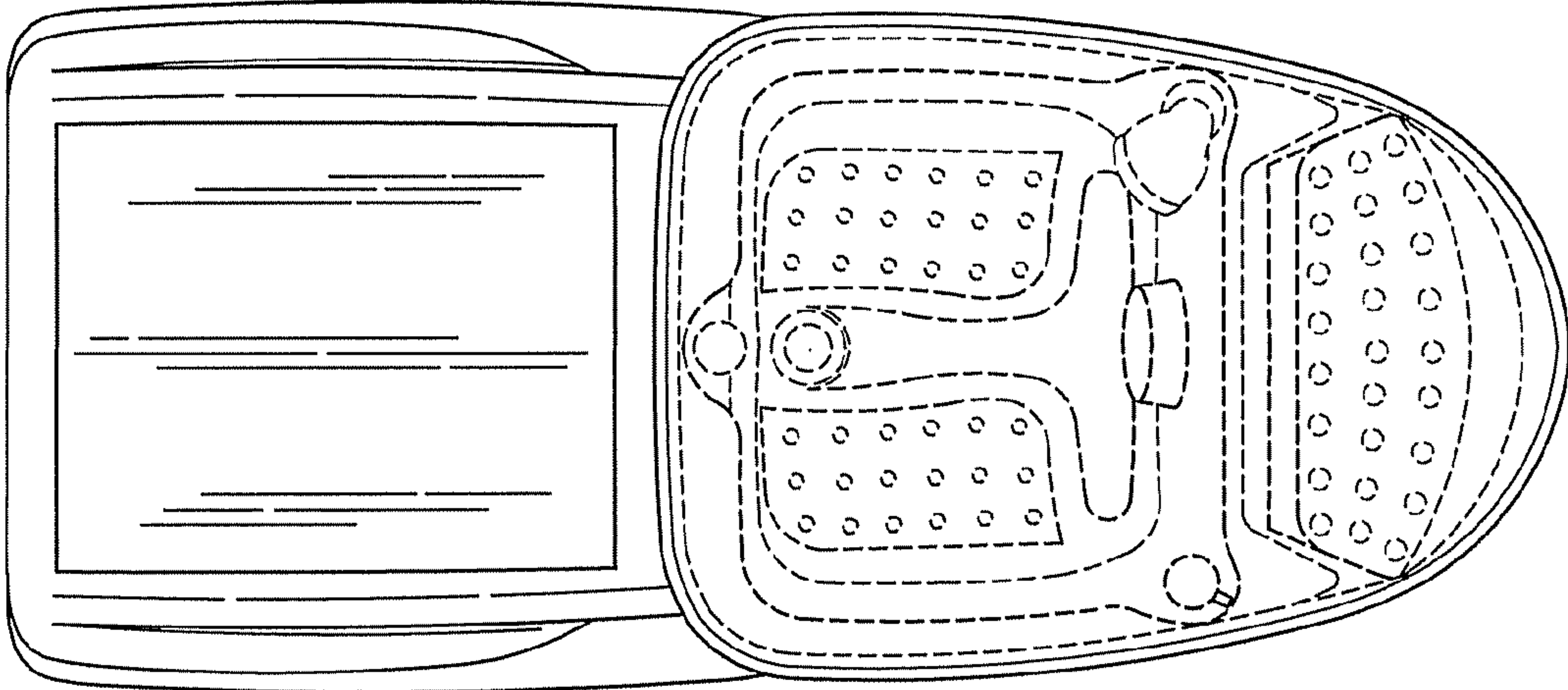

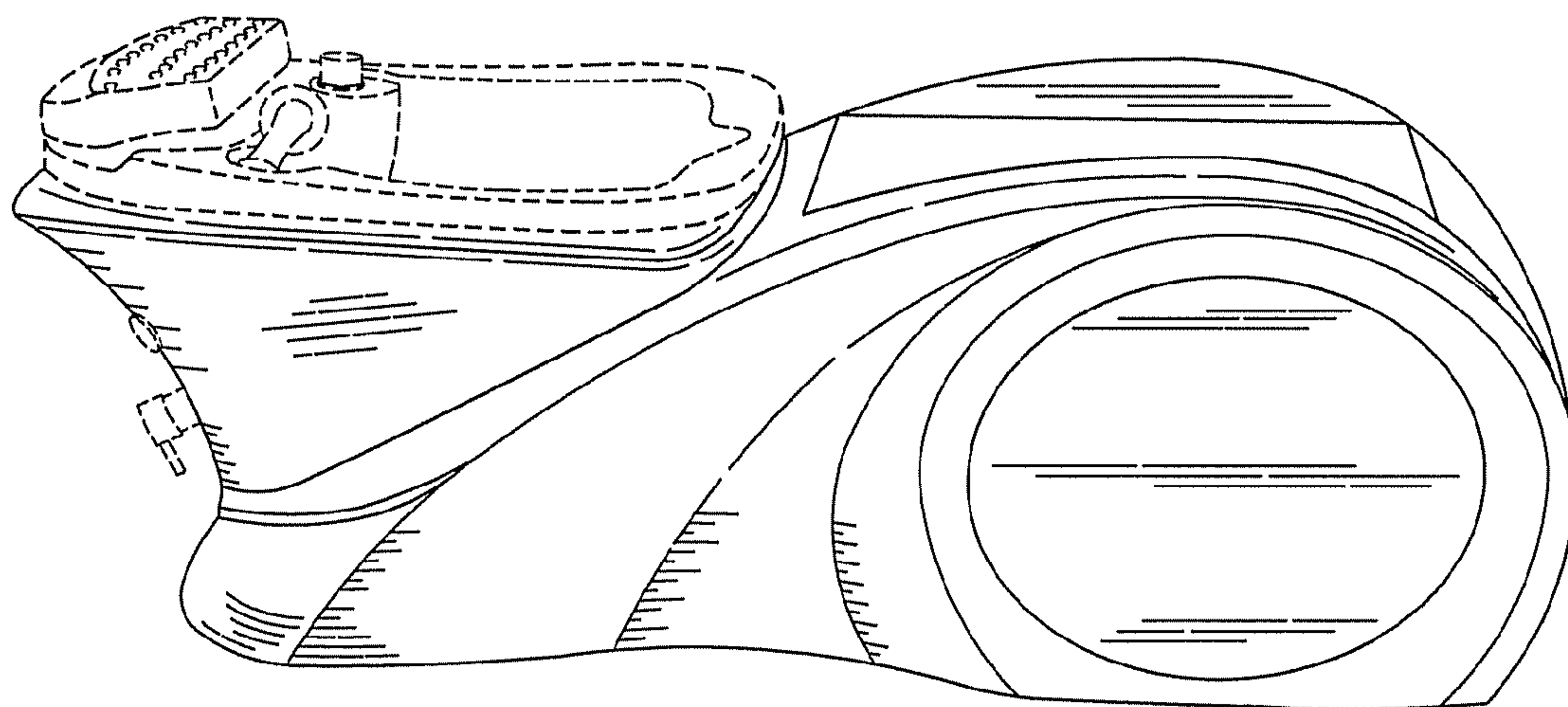

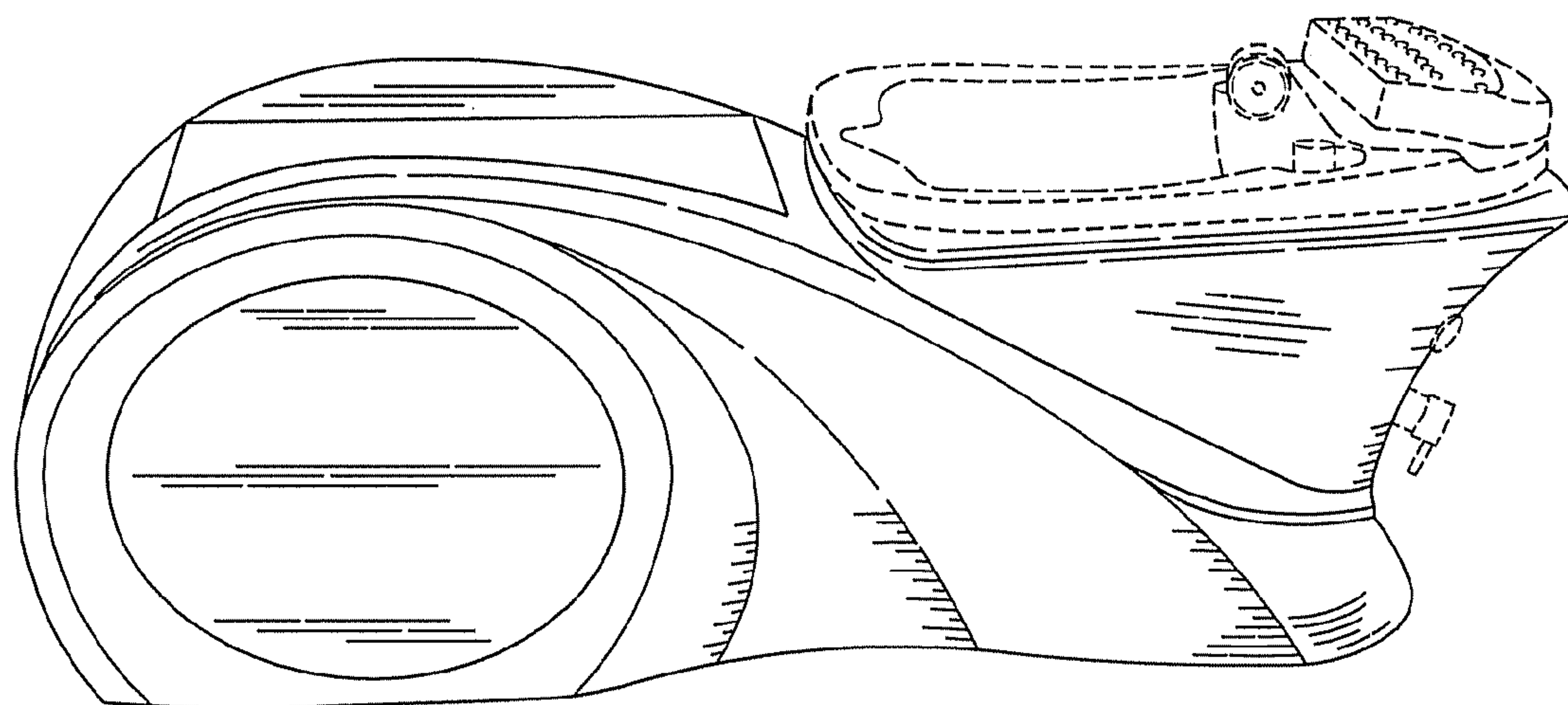

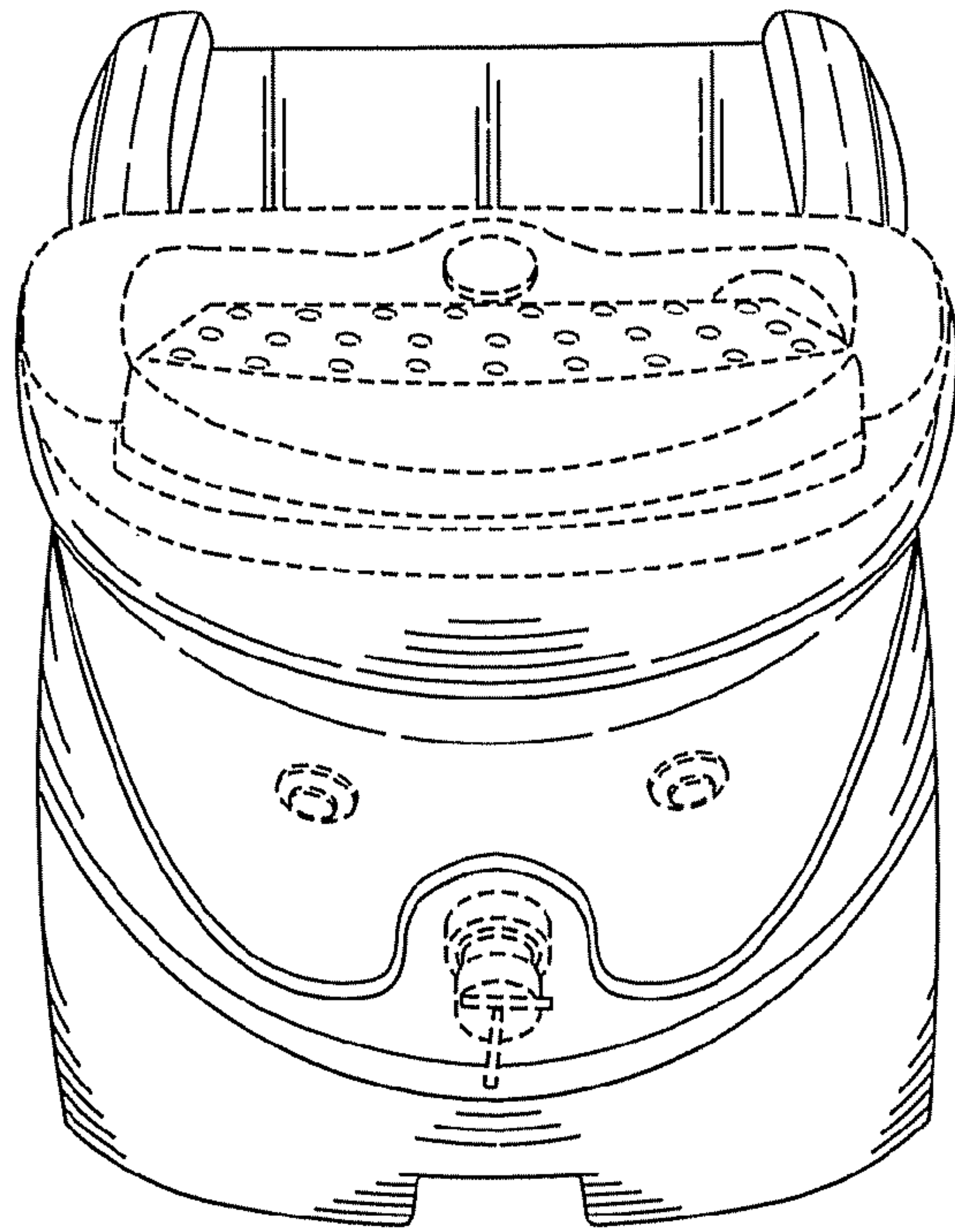

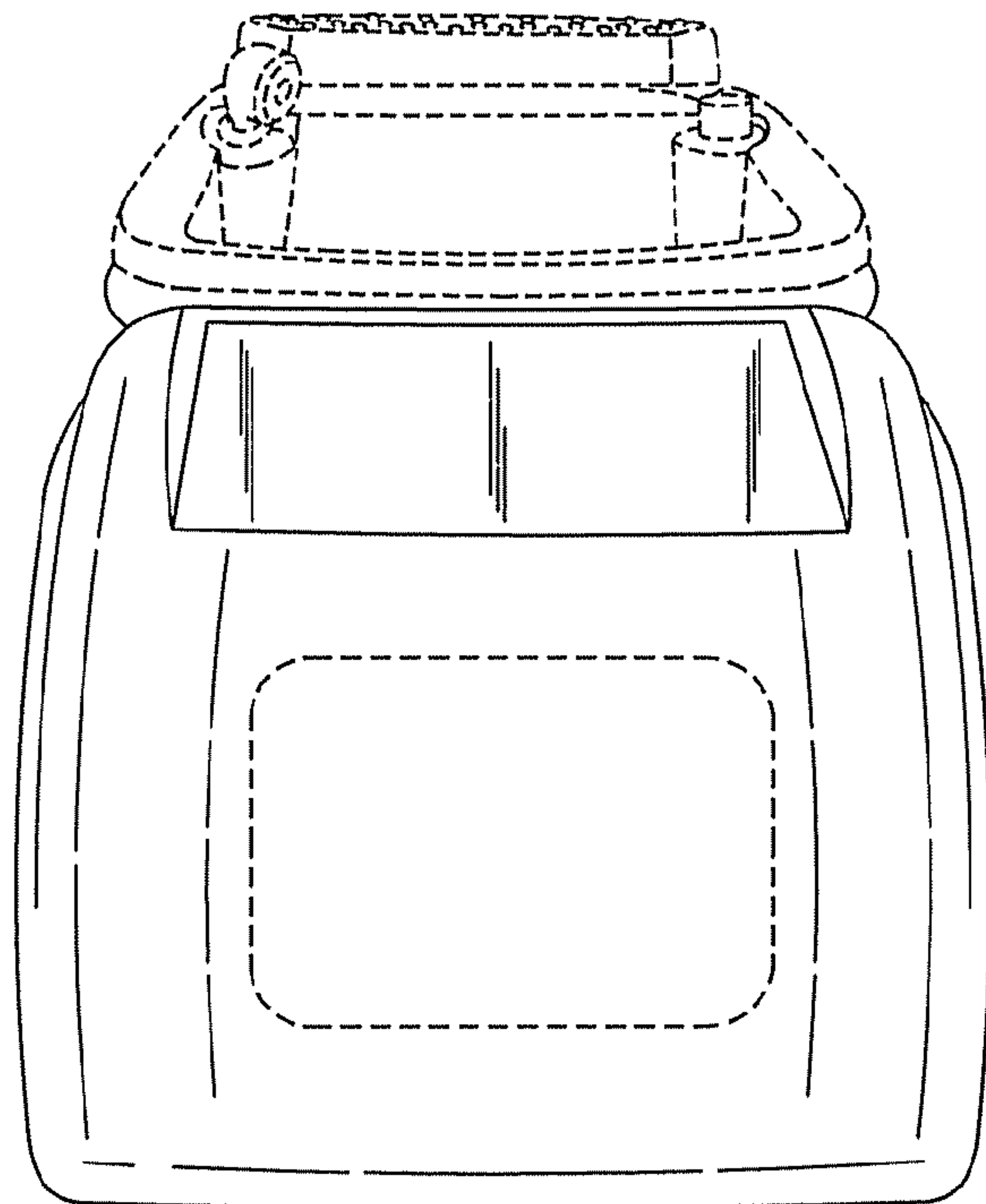
