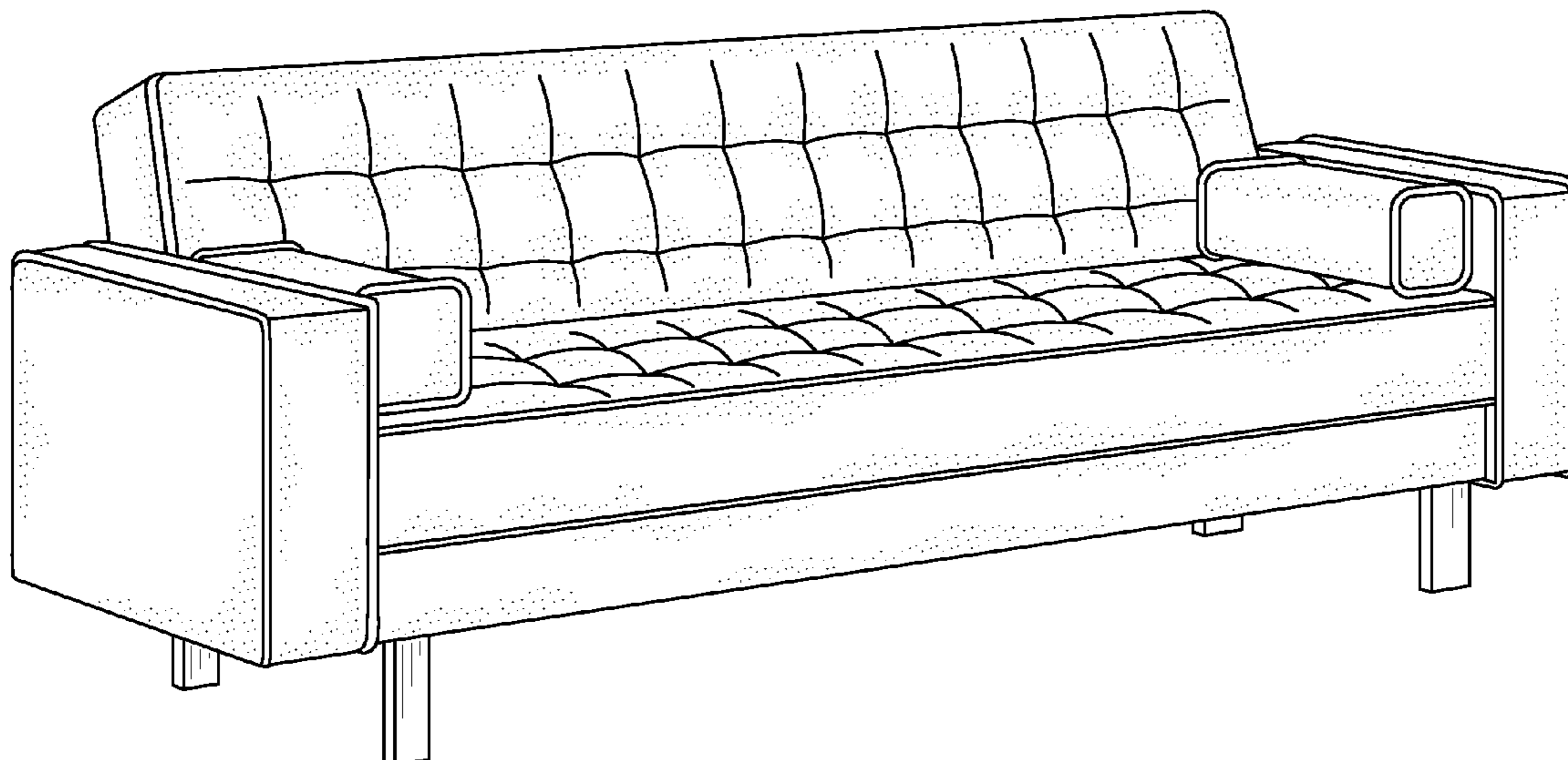
(57) **CLAIM**

The ornamental design for a three seater convertible sofa with multiple positions, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the three seater sofa convertible being in a sofa position; FIG. 2 is a side perspective view of the three seater sofa convertible being in a sofa position; FIG. 3 is a rear perspective view of the three seater sofa convertible being in a sofa position; FIG. 4 is a top perspective view of the three seater sofa convertible being in a sofa position; FIG. 5 is a front perspective view of the three seater sofa convertible being in a lounge position; and, FIG. 6 is a side perspective view of the three seater sofa convertible being in a bed position.

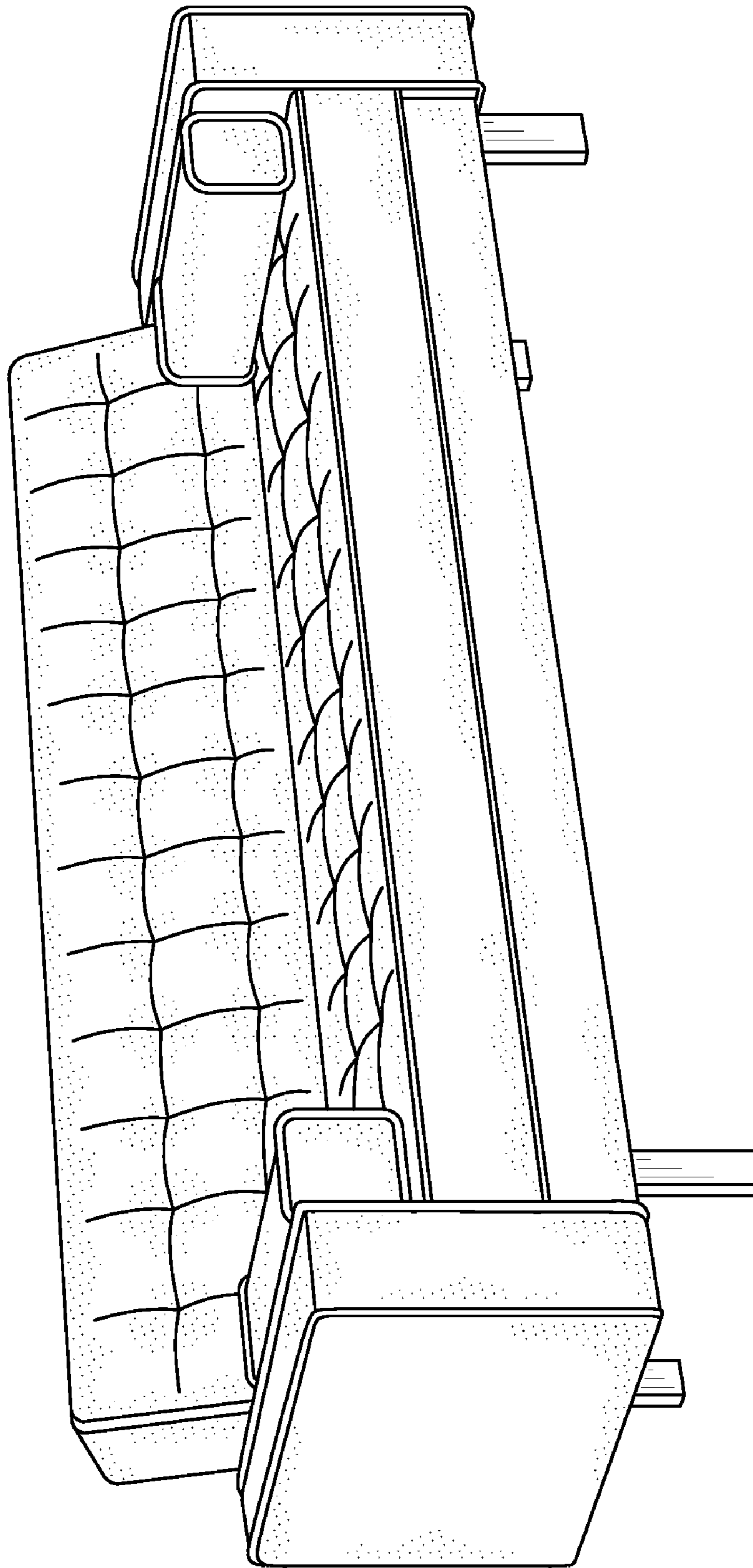

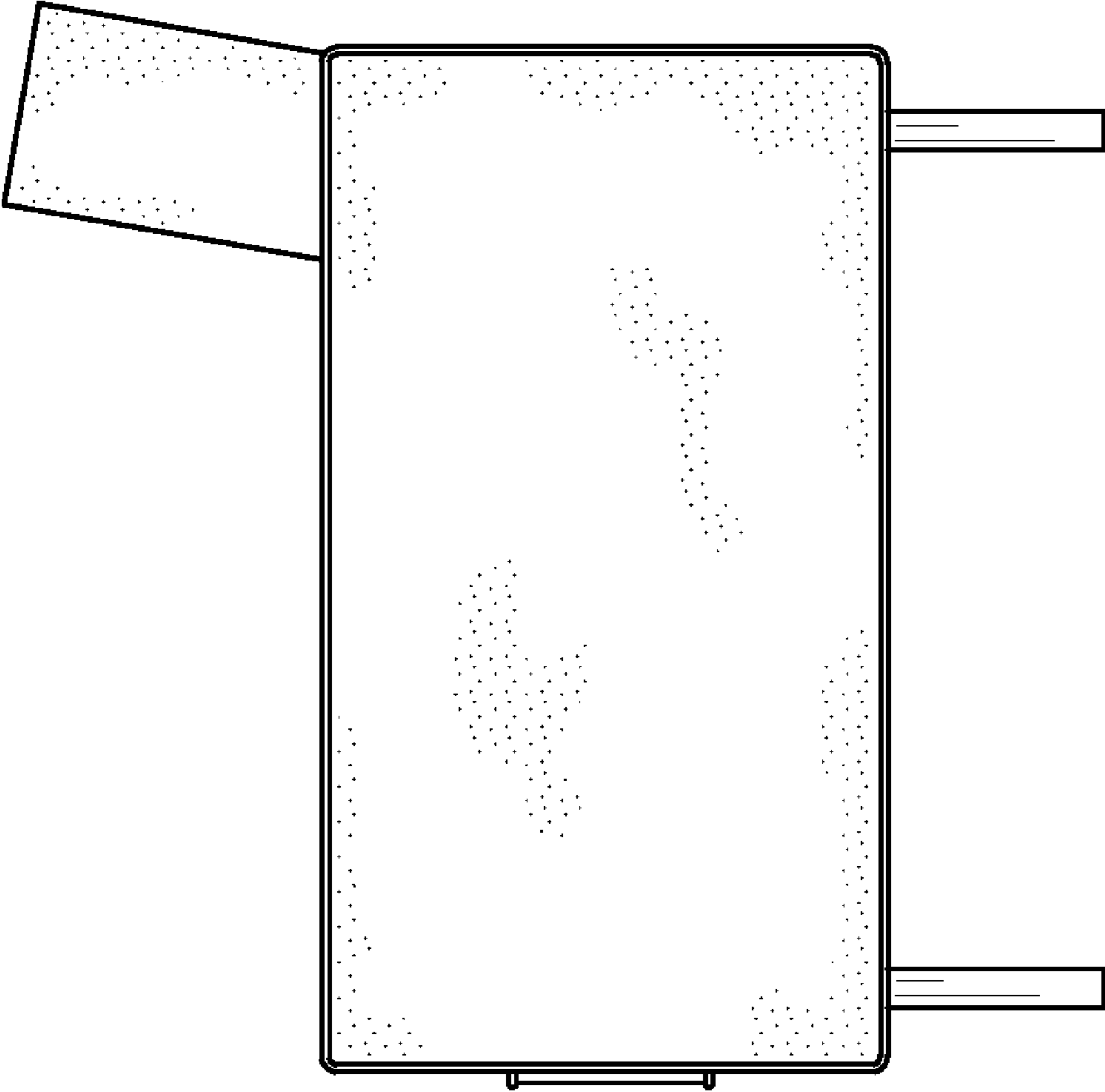

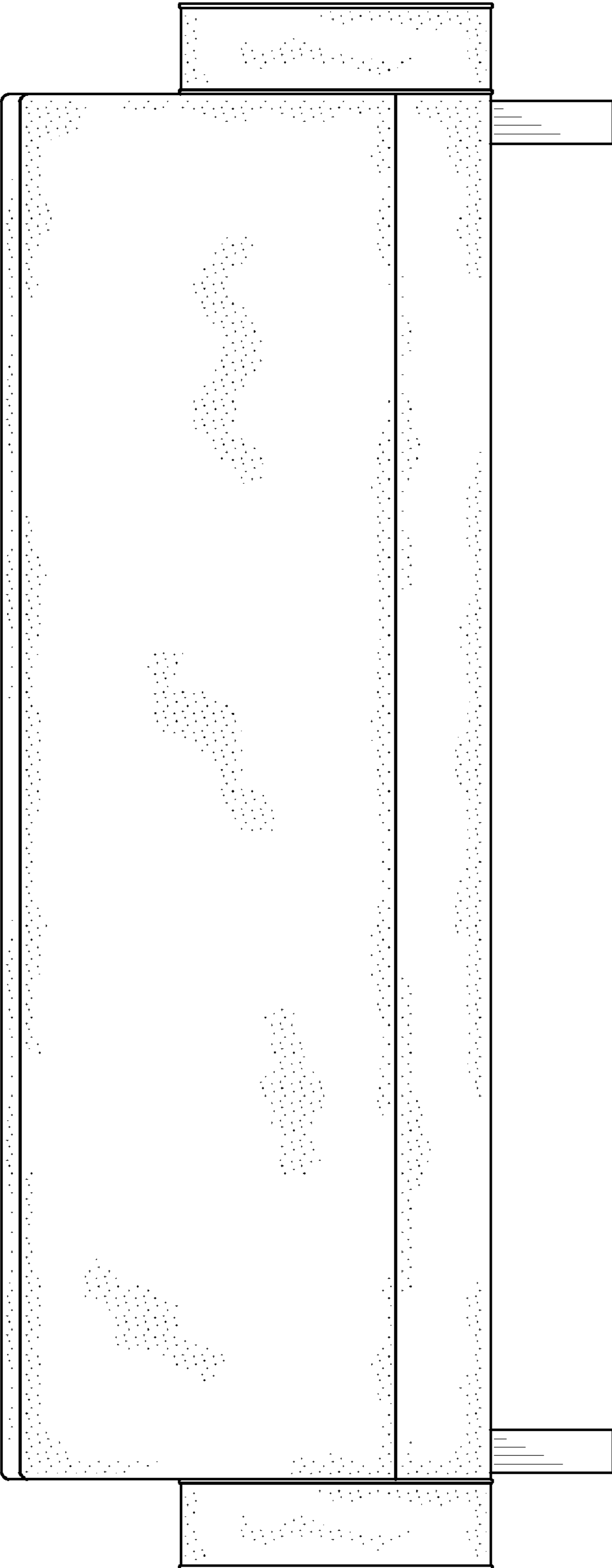

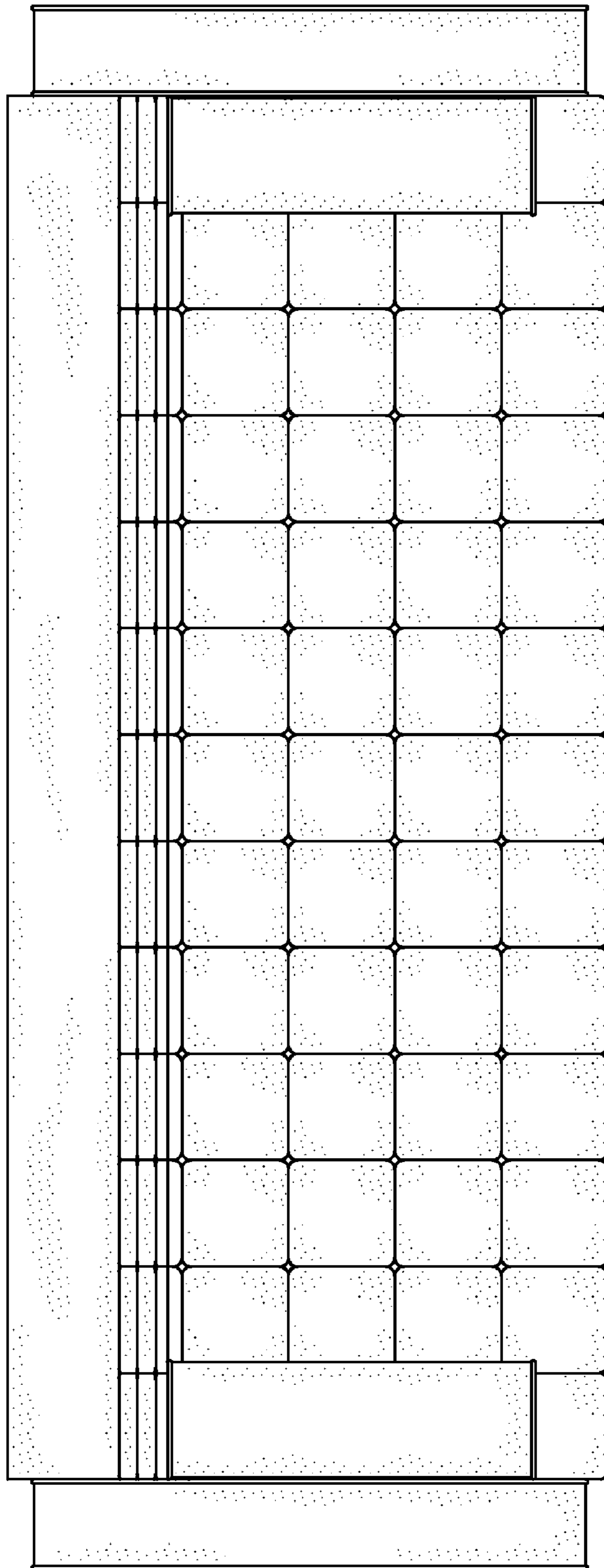

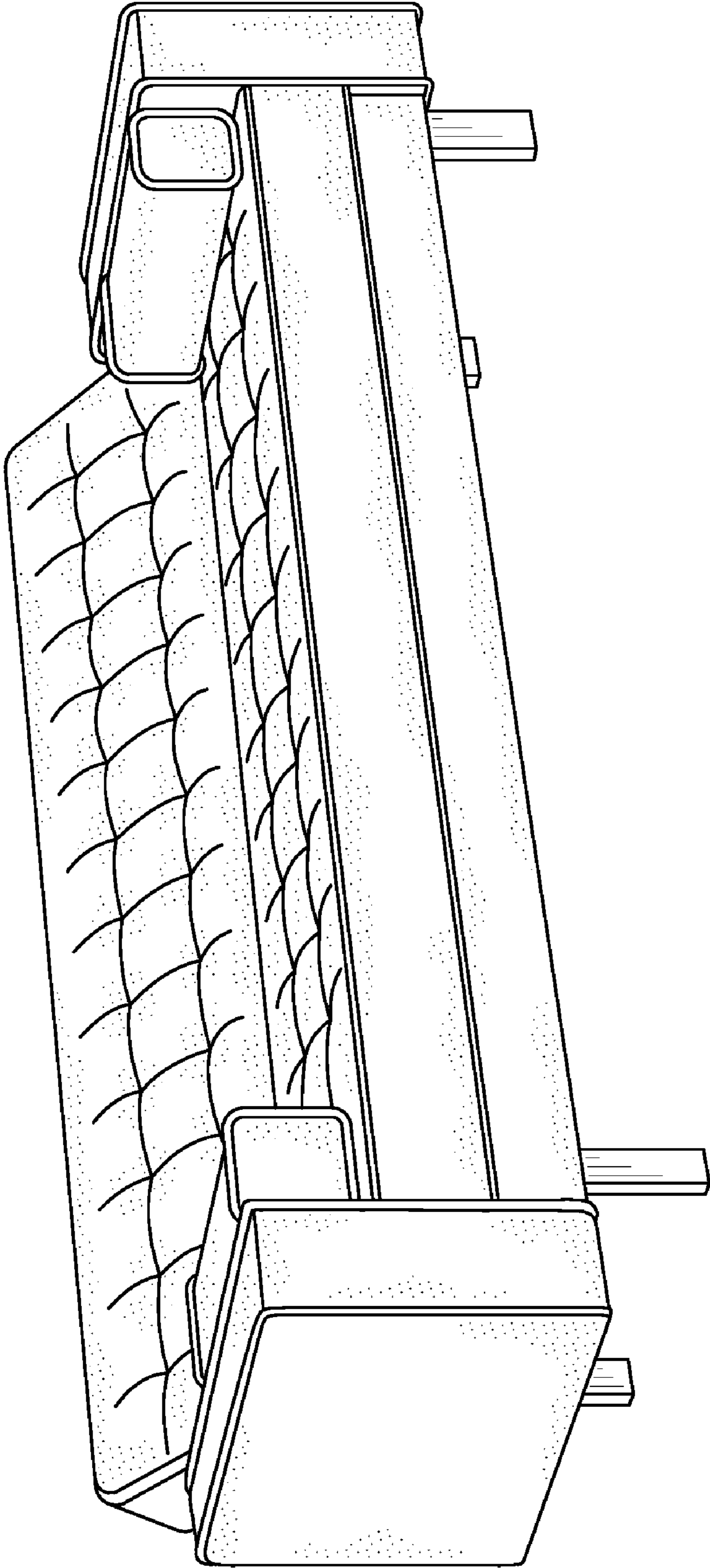

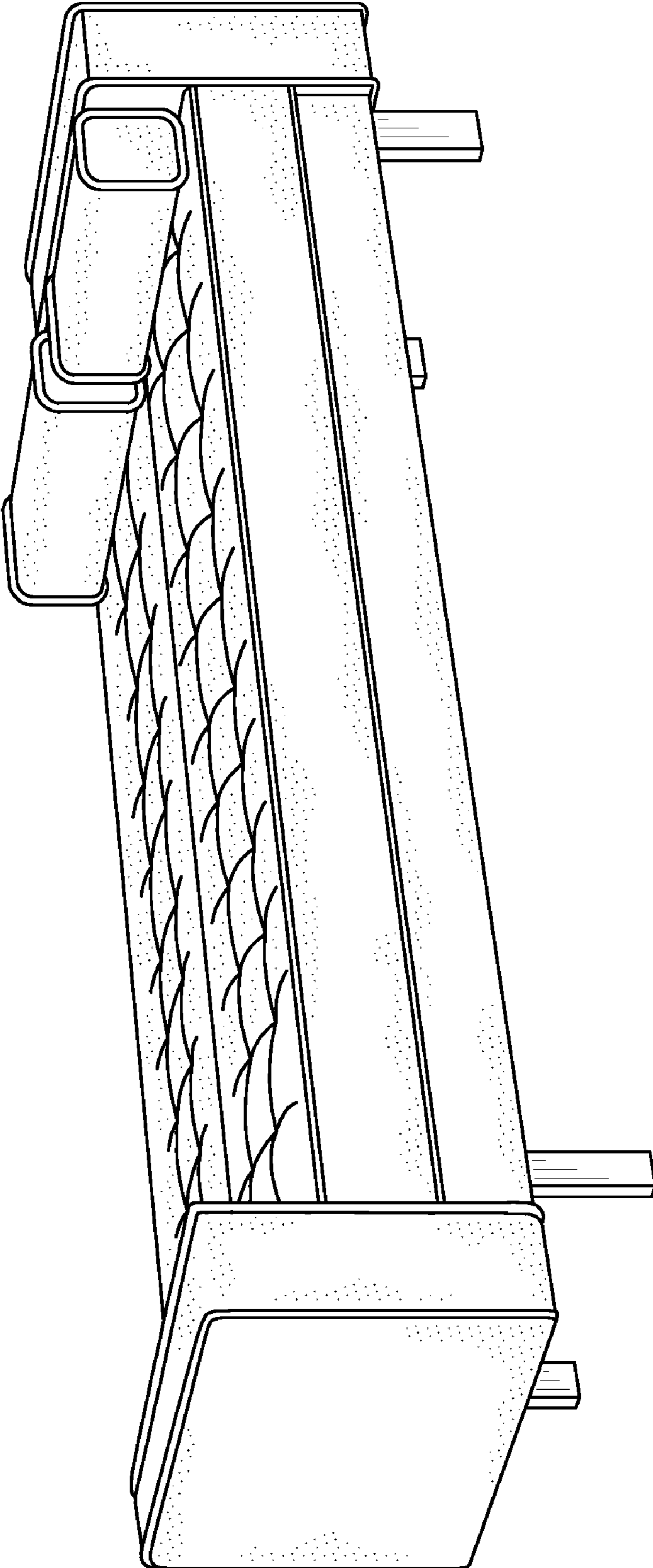
