DESCRIPTION

FIG. 1: is the isometric view of the beauty scissors showing my new design;

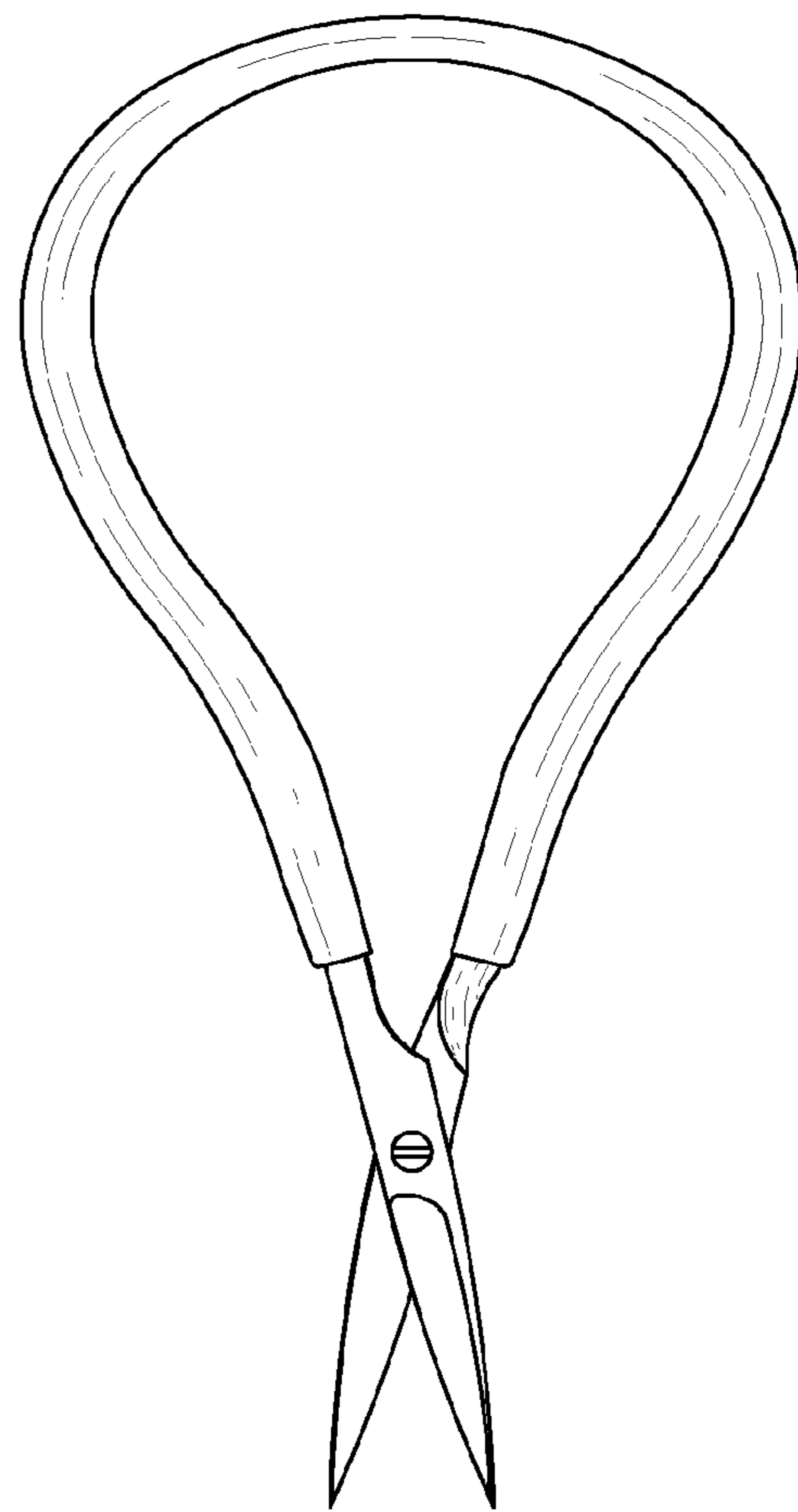

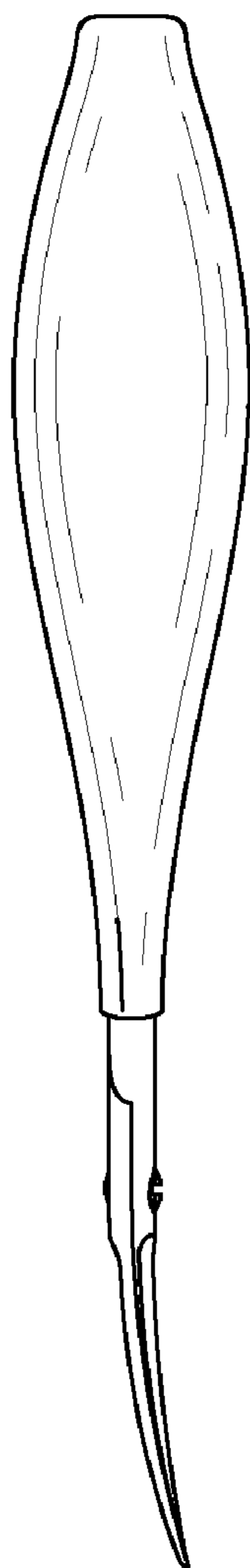

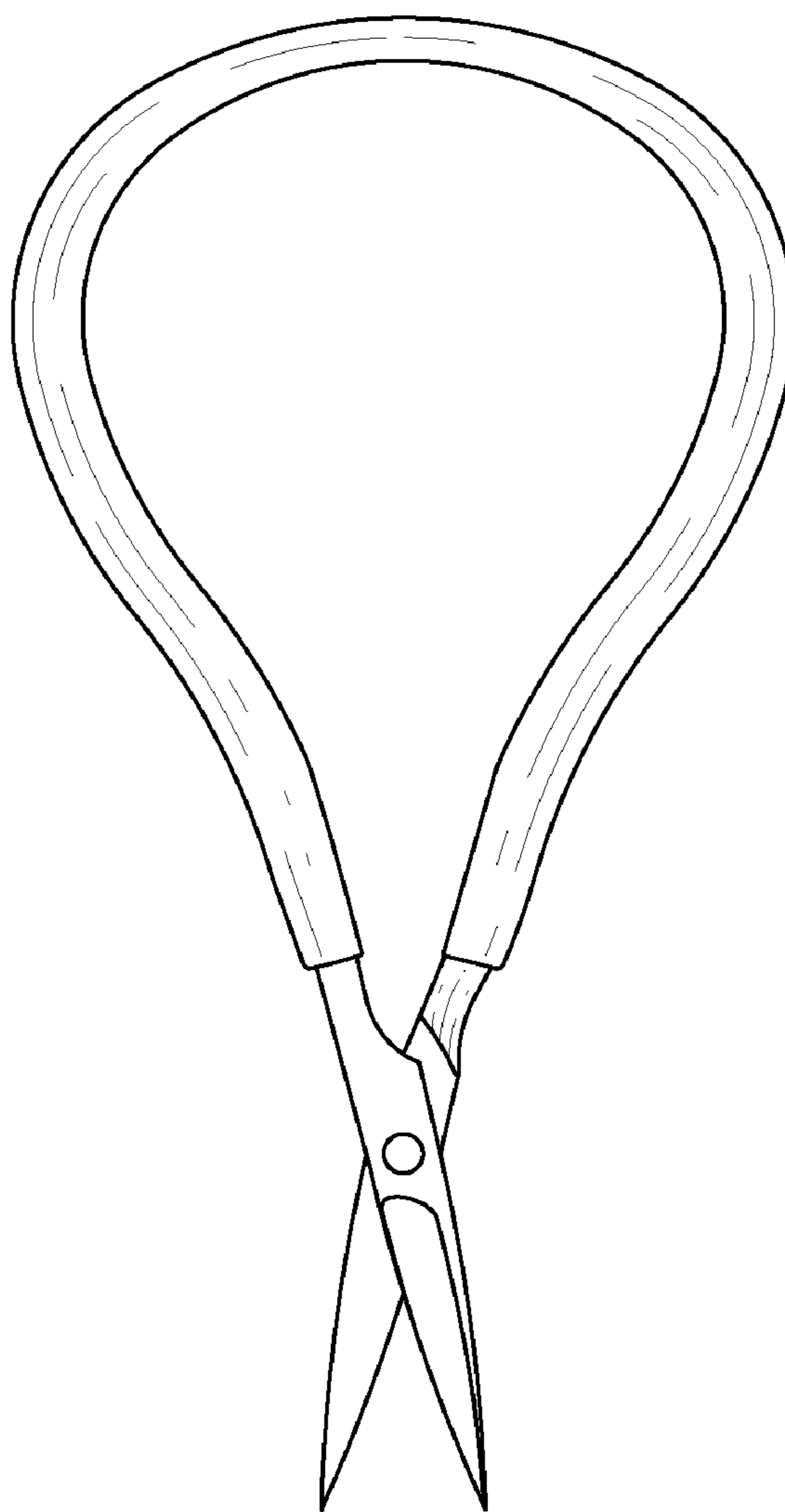

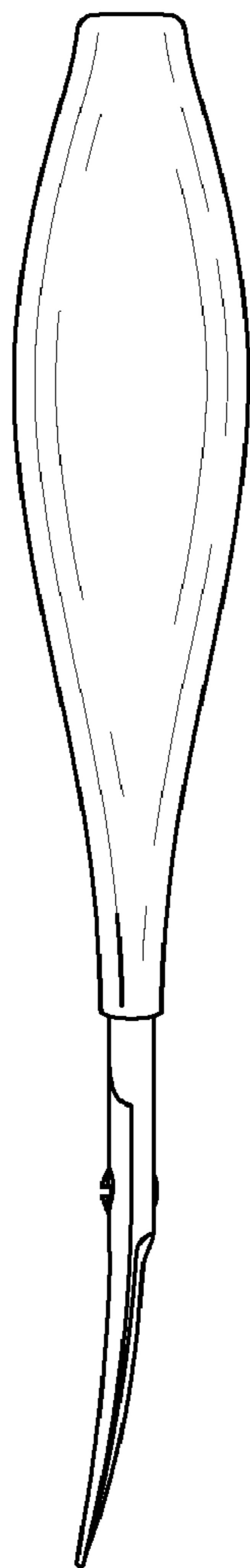

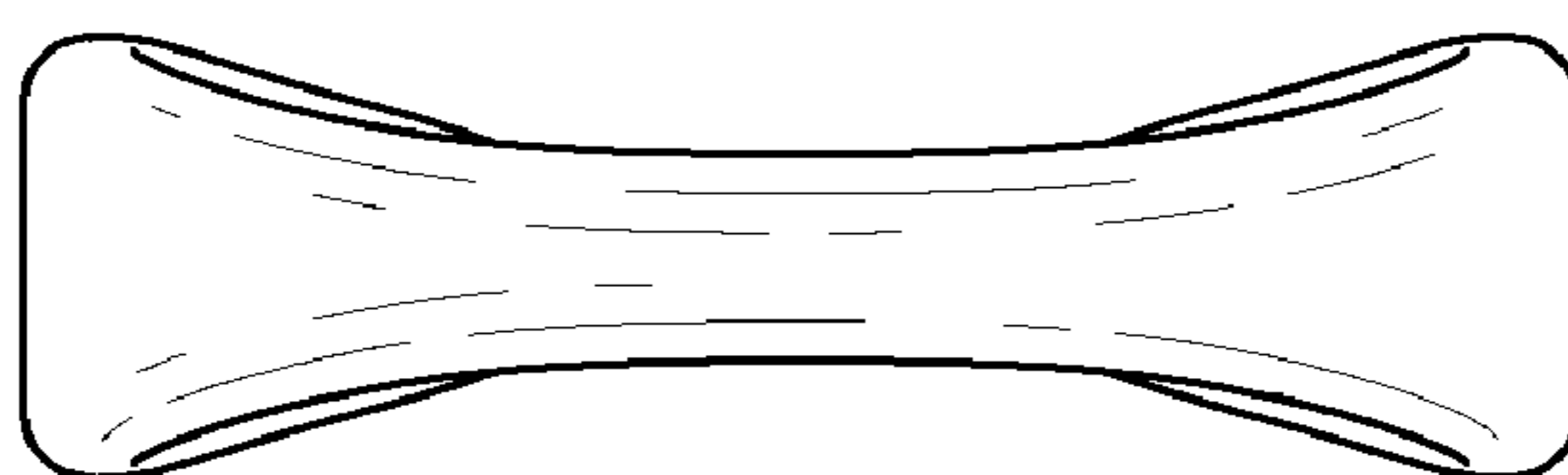

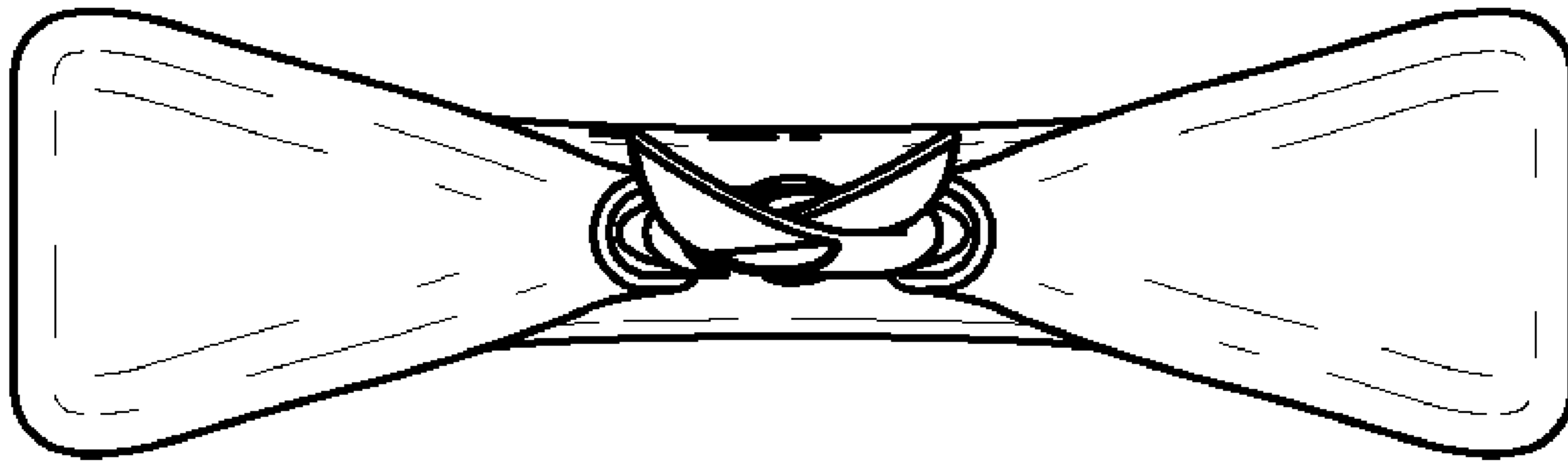
