(57) **CLAIM**

The ornamental design for a food bowl display container, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a first embodiment of a food bowl display container, showing my new design, the rear elevational view being a mirror image of the front elevational view shown;

FIG. 2 is a top plan view thereof;

FIG. 3 is a right side elevational view thereof, the left side elevational view being a mirror image of the right side elevational view shown;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a front elevational view of a second embodiment of a food bowl display container, showing my new design, the rear elevational view being a mirror image of the front elevational view shown;

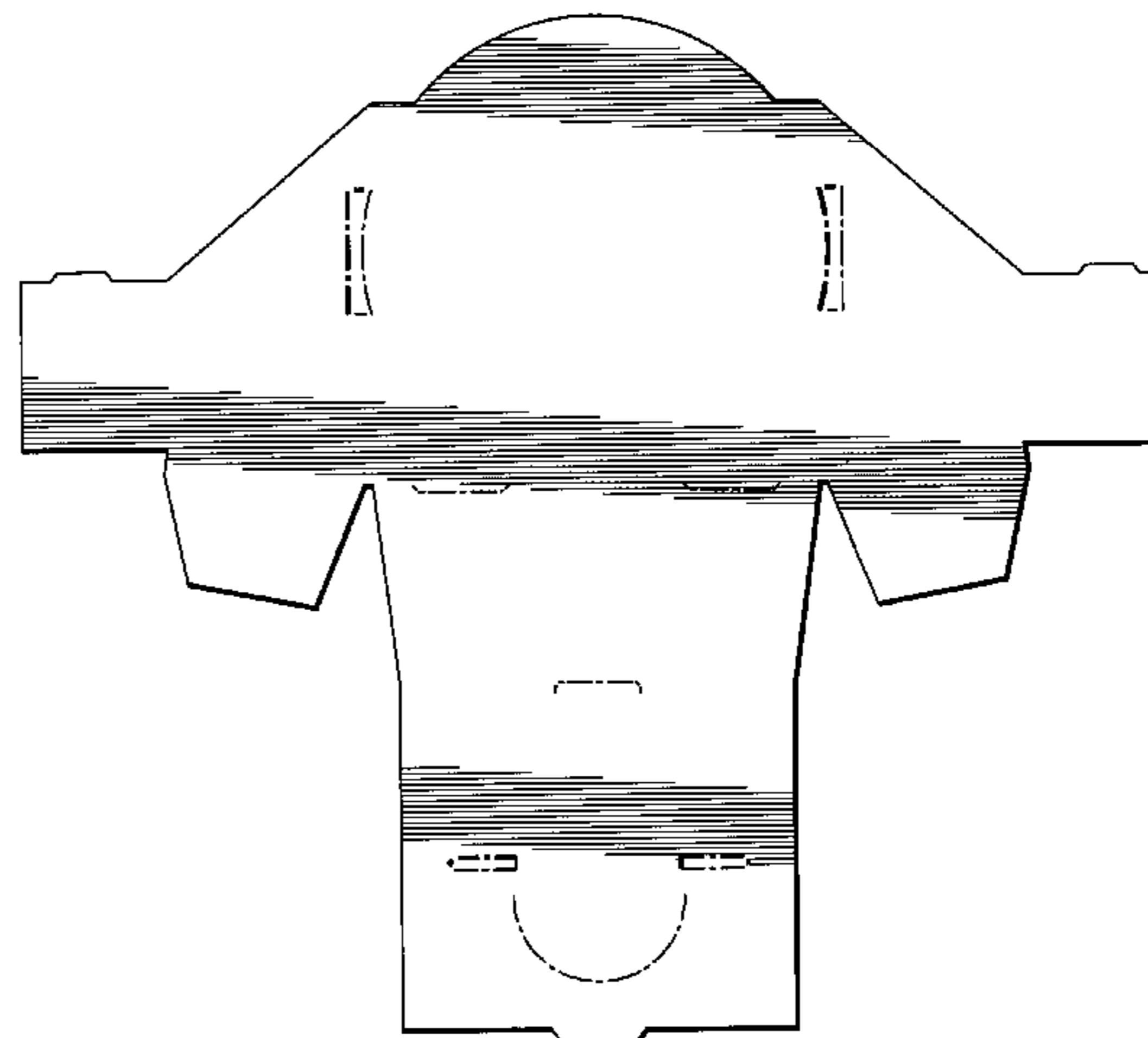
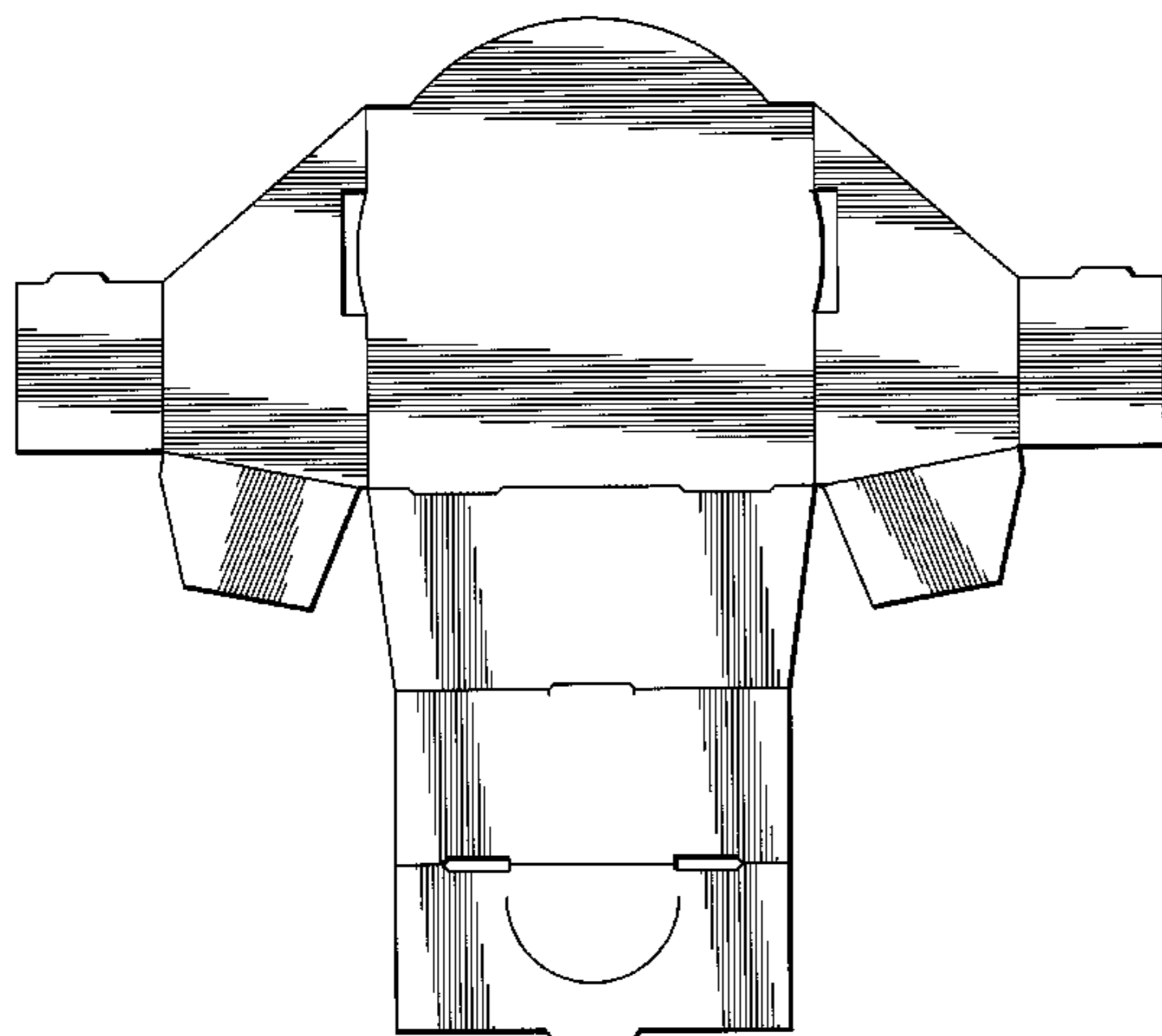
FIG. 6 is a top plan view thereof;

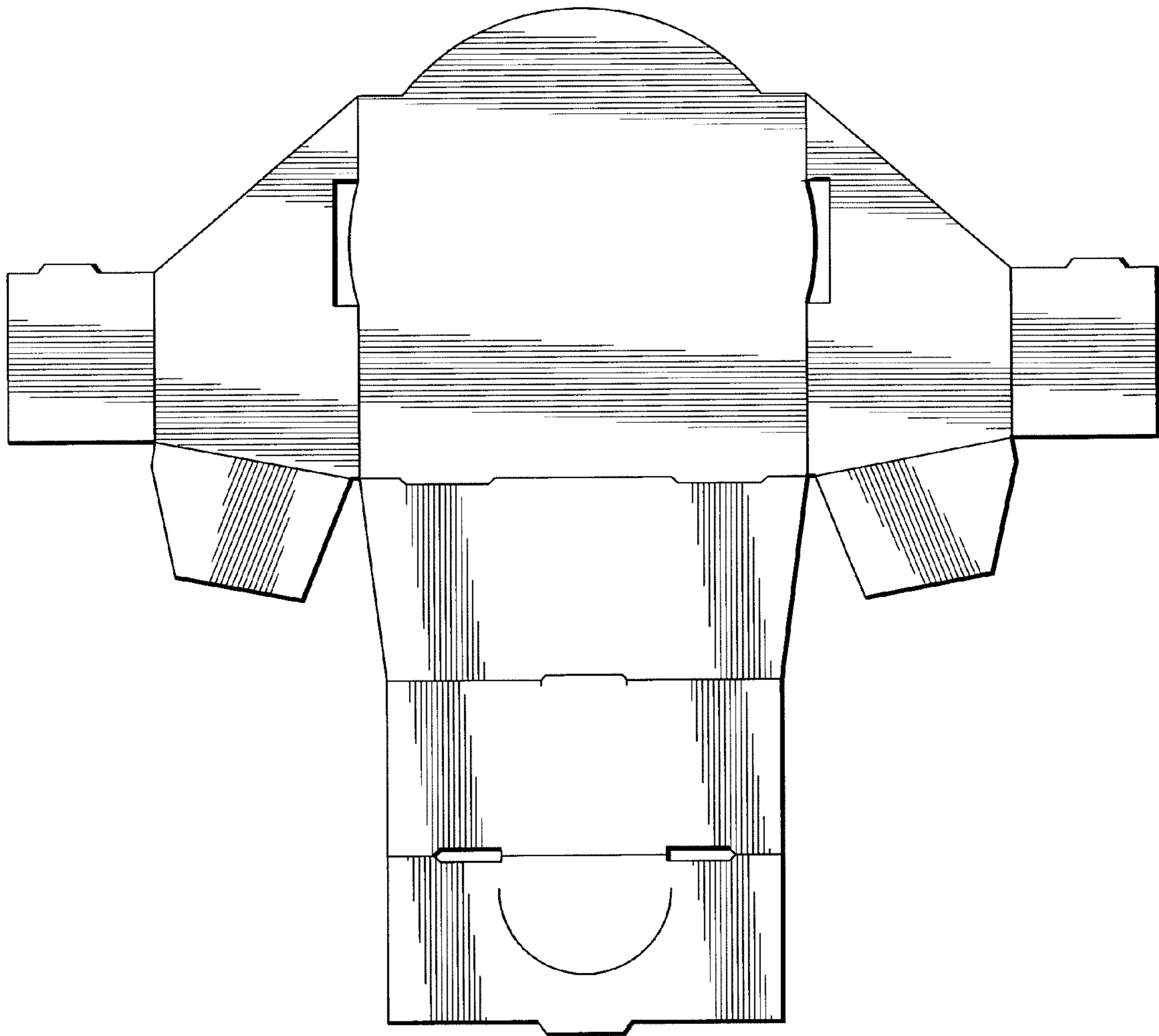
FIG. 7 is a right side elevational view thereof, the left side elevational view being a mirror image of the right side elevational view shown; and,

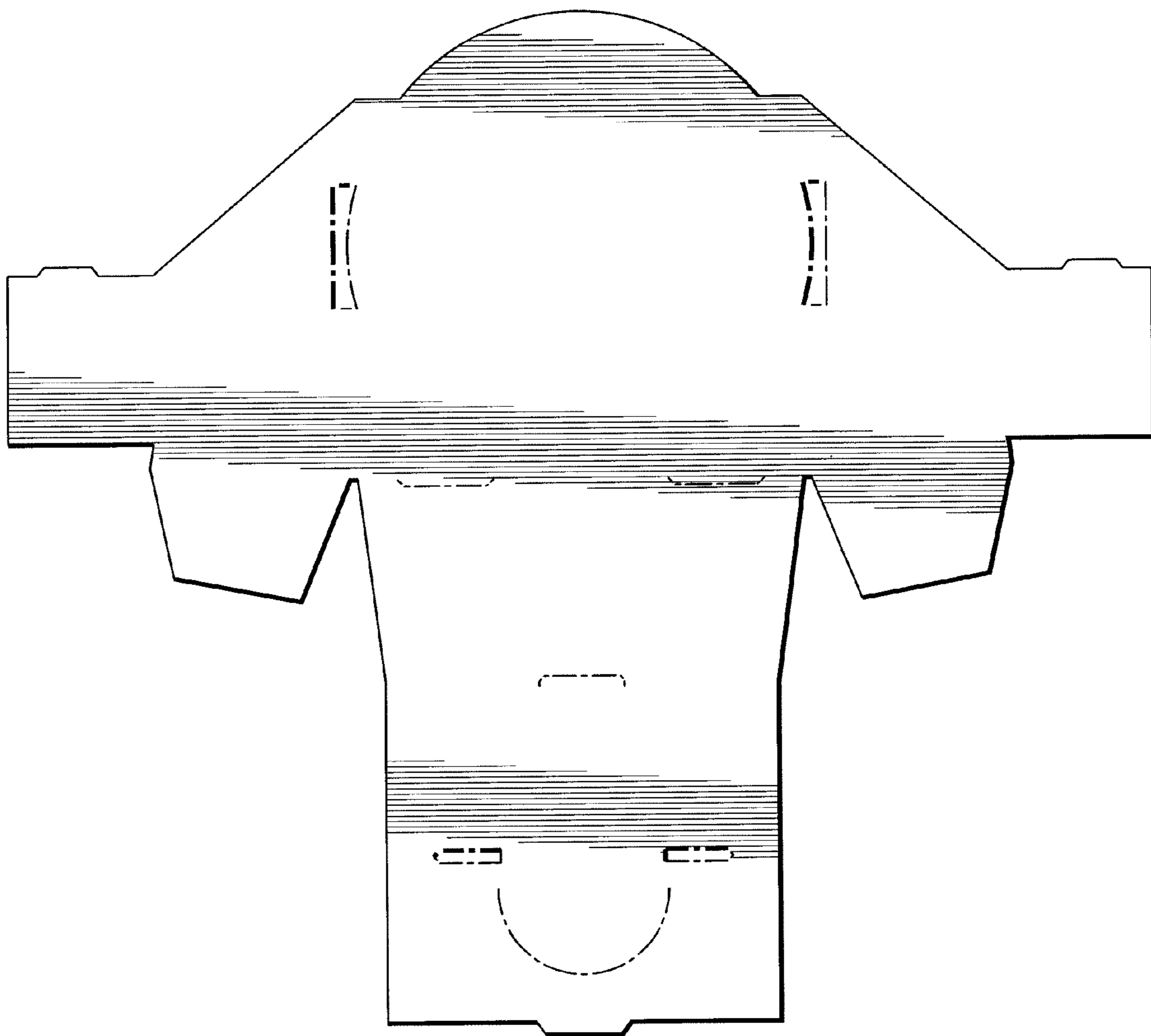
