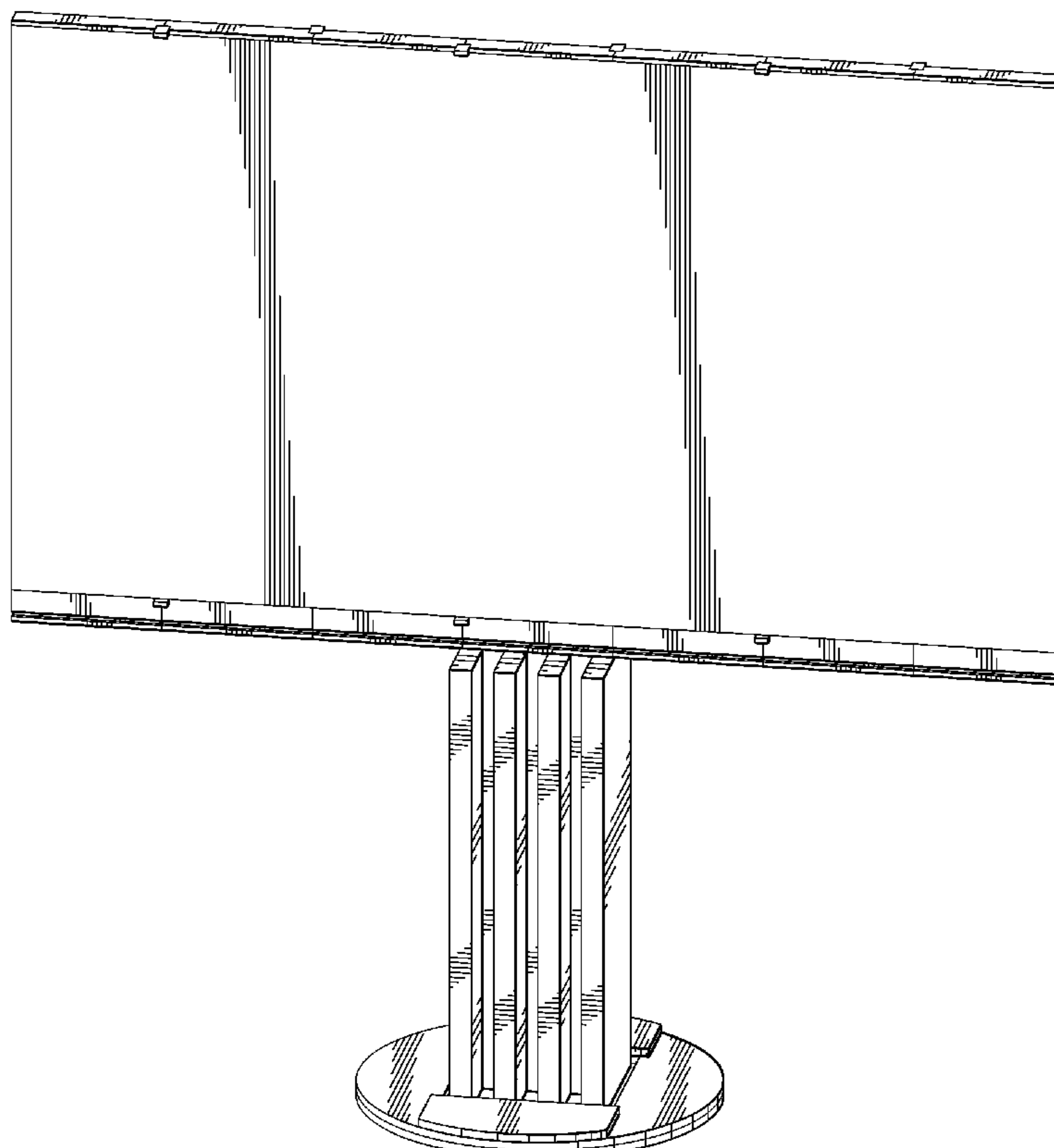
FIG. 1 is a perspective view of a large picture screen;

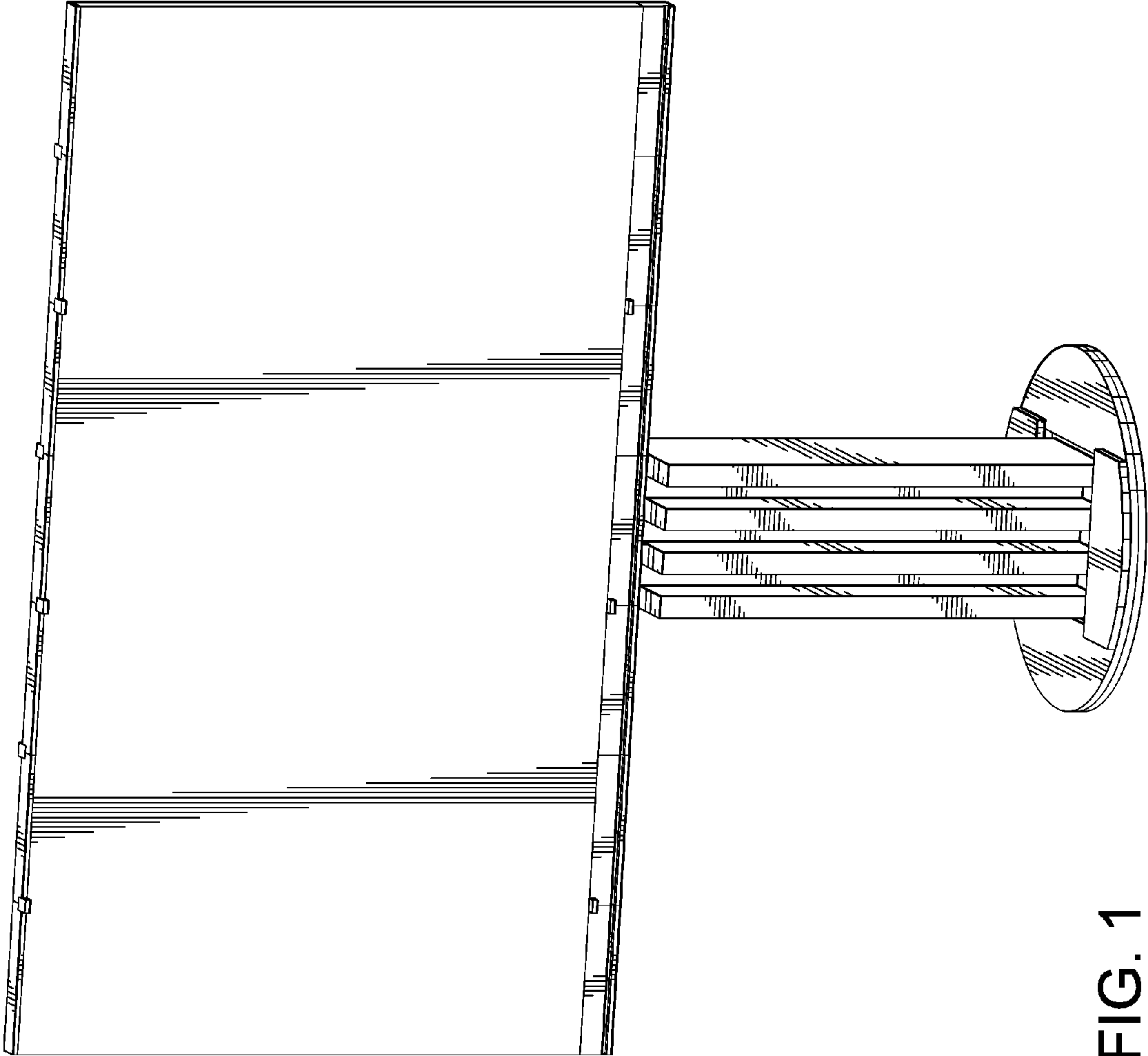

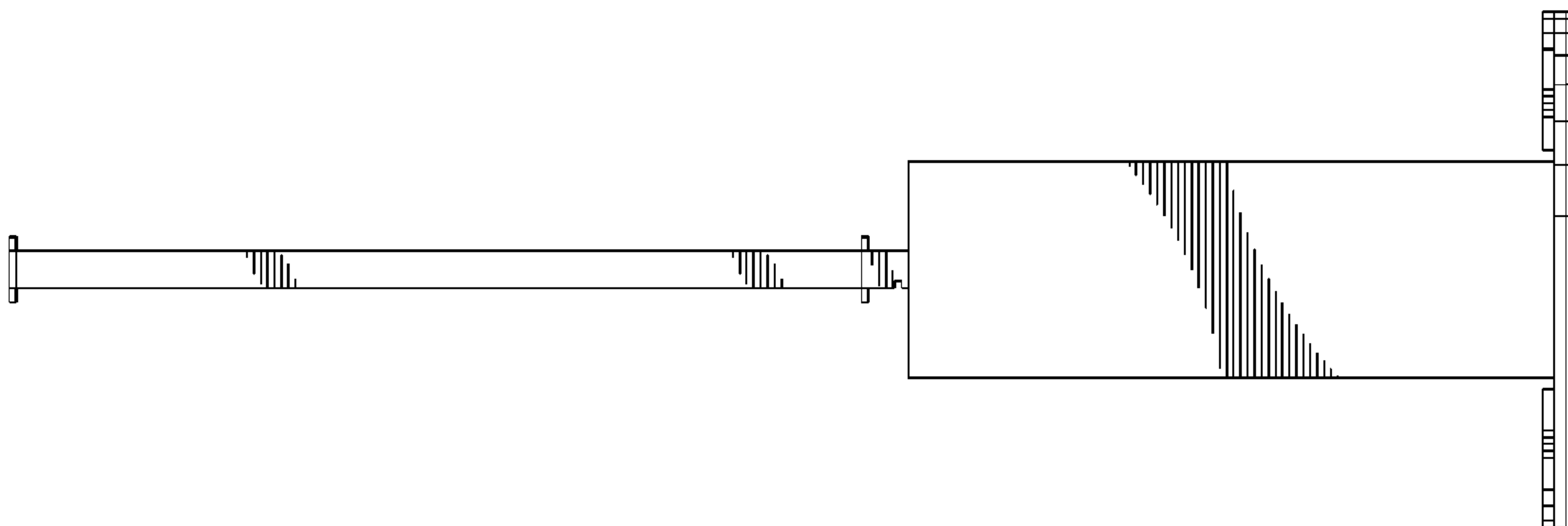

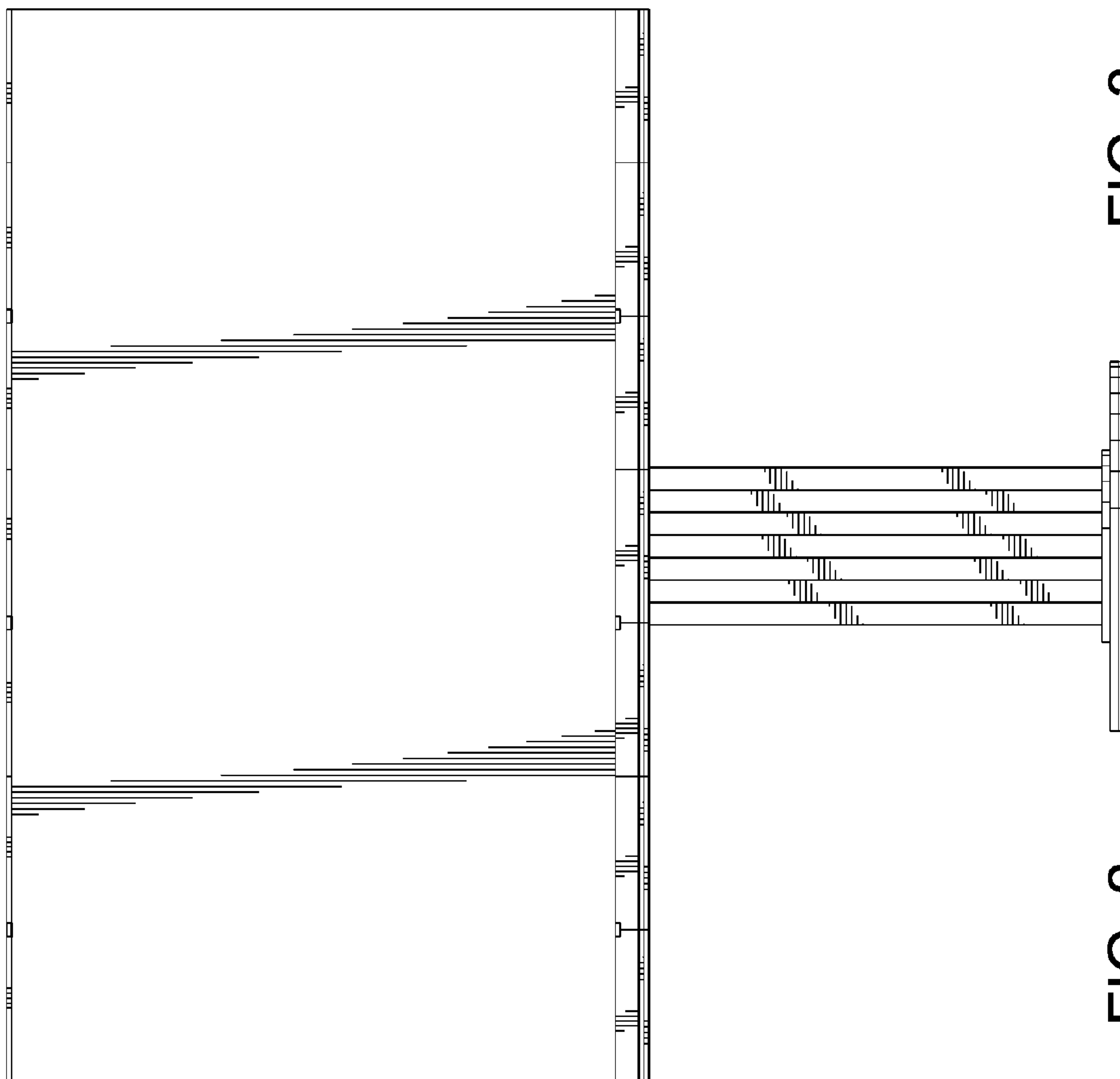

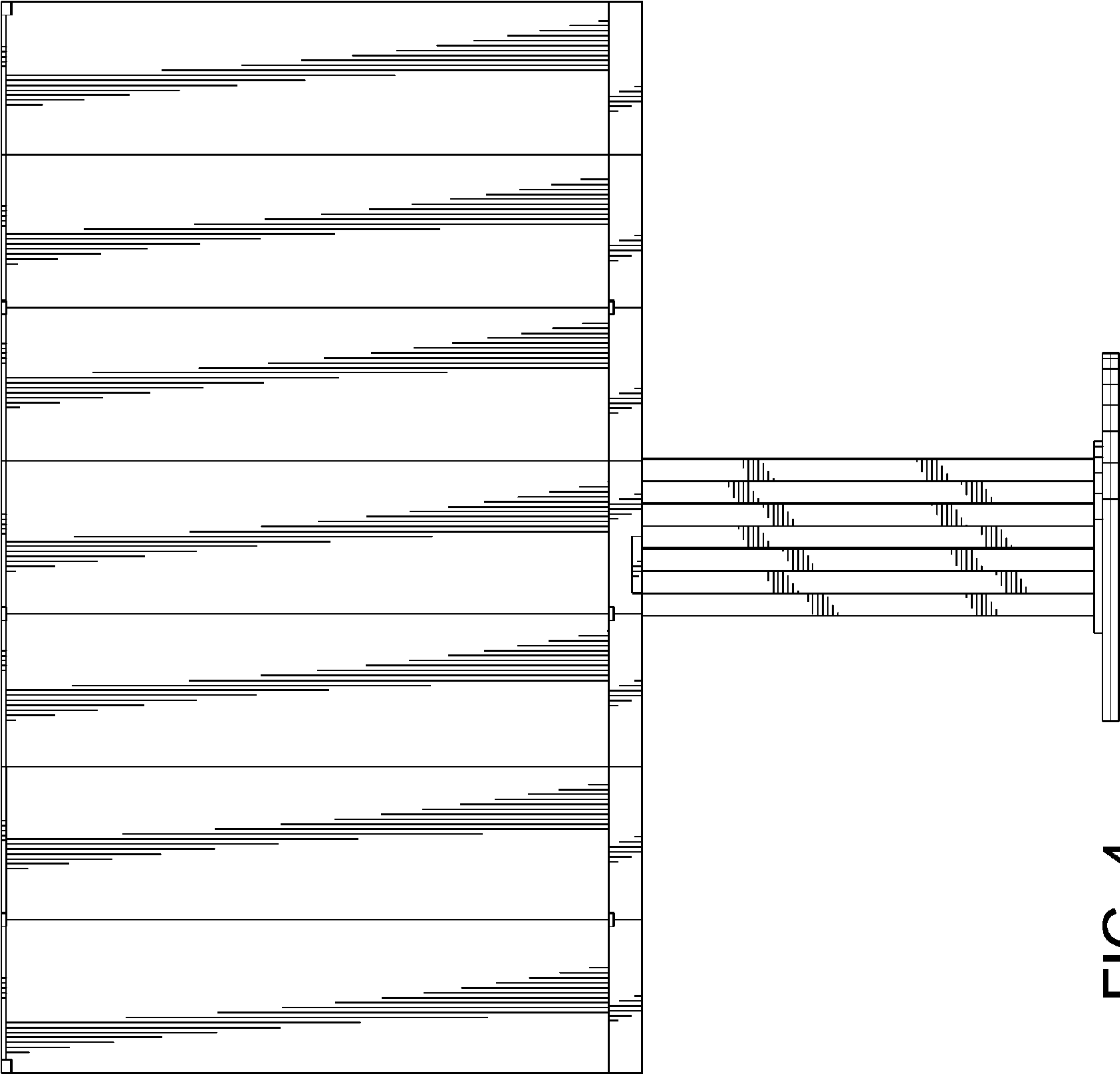

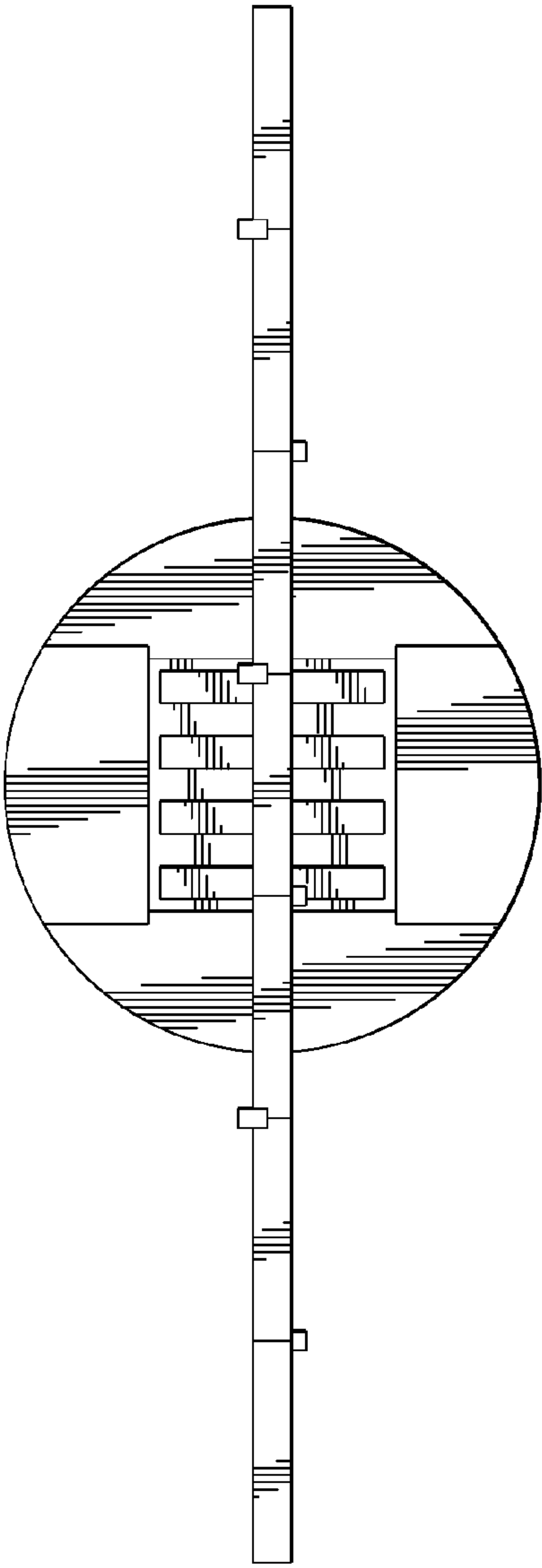

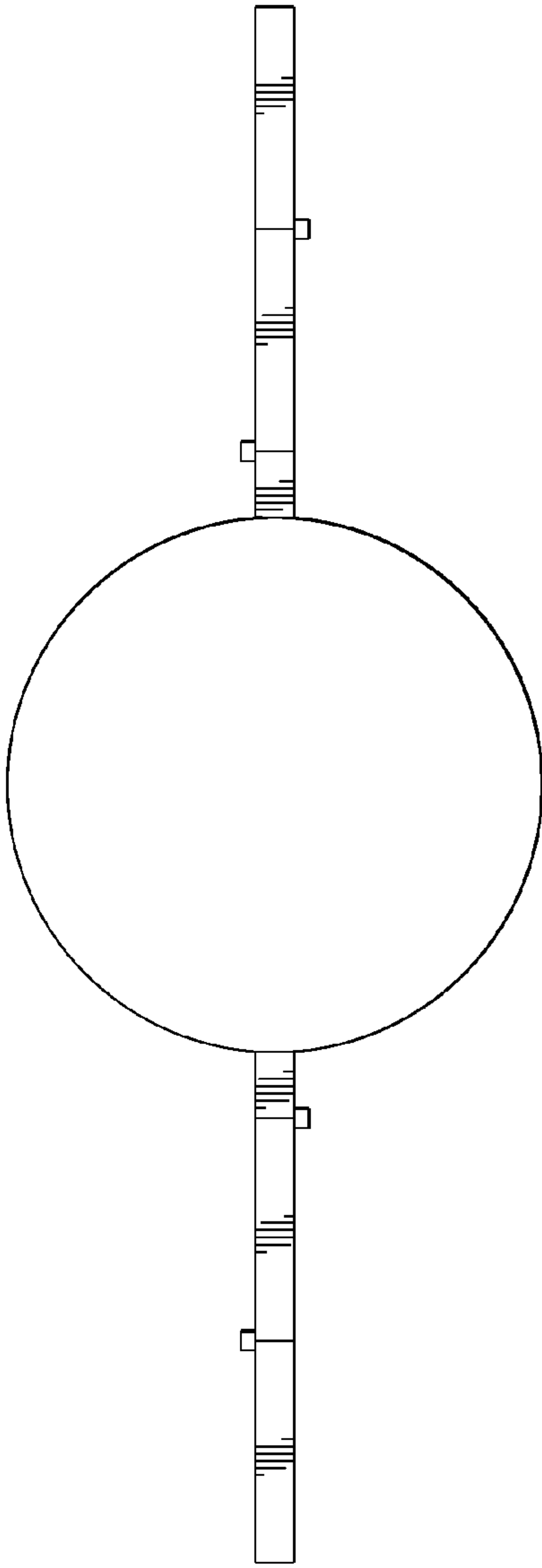
