The ornamental design for portable device, as shown and described.

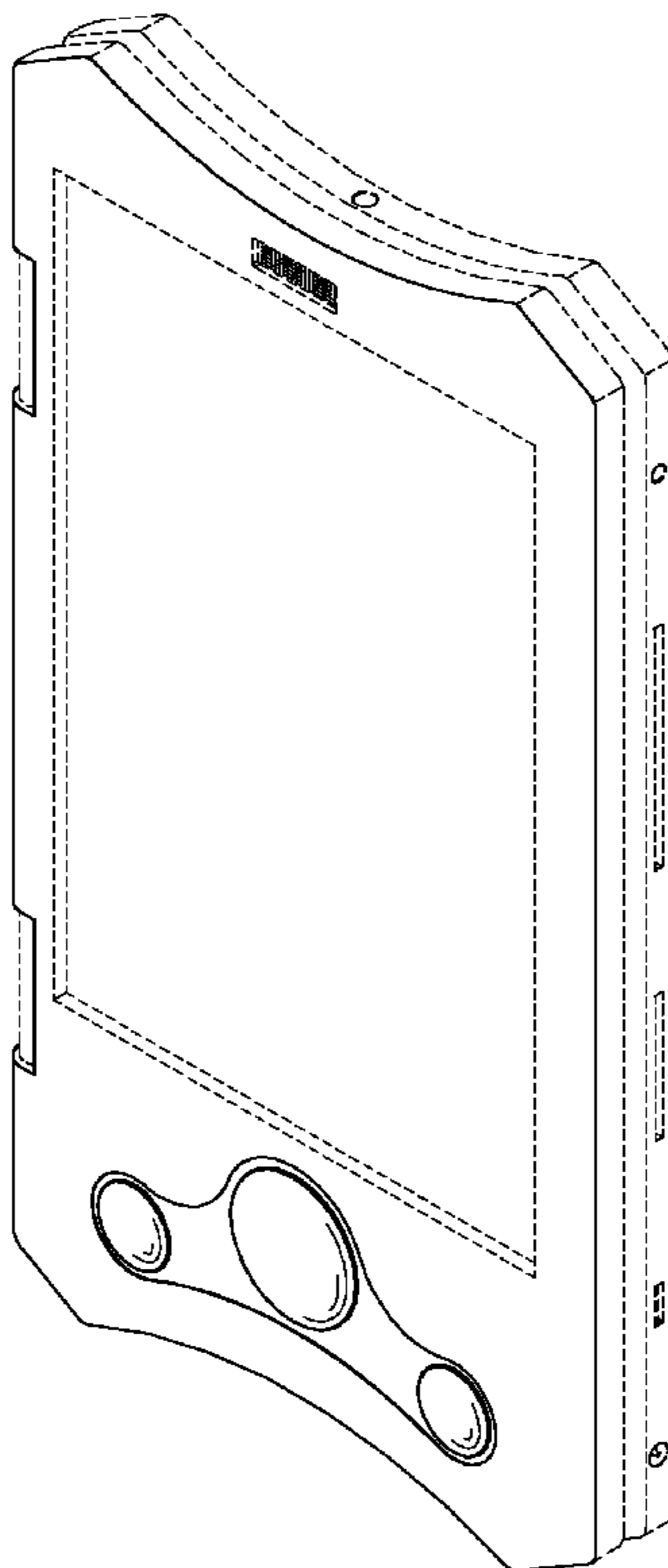
**DESCRIPTION**

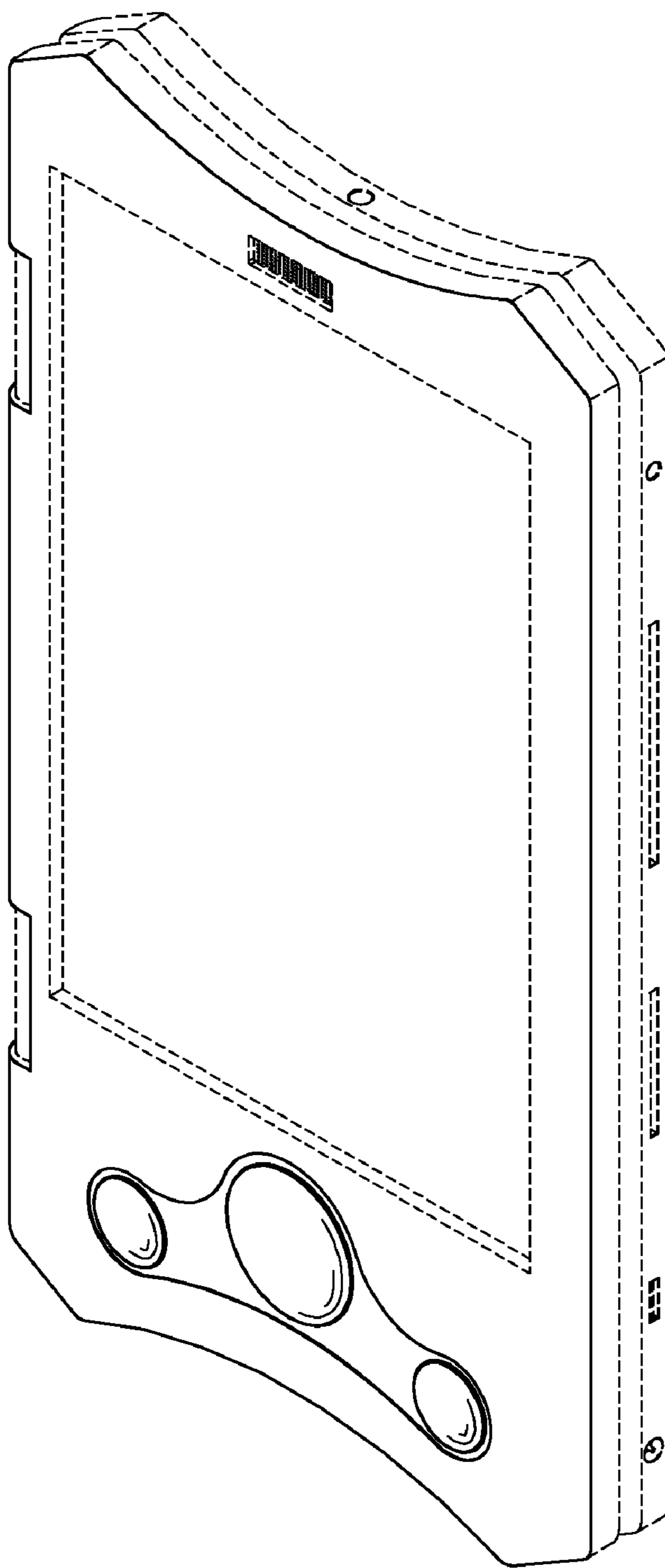

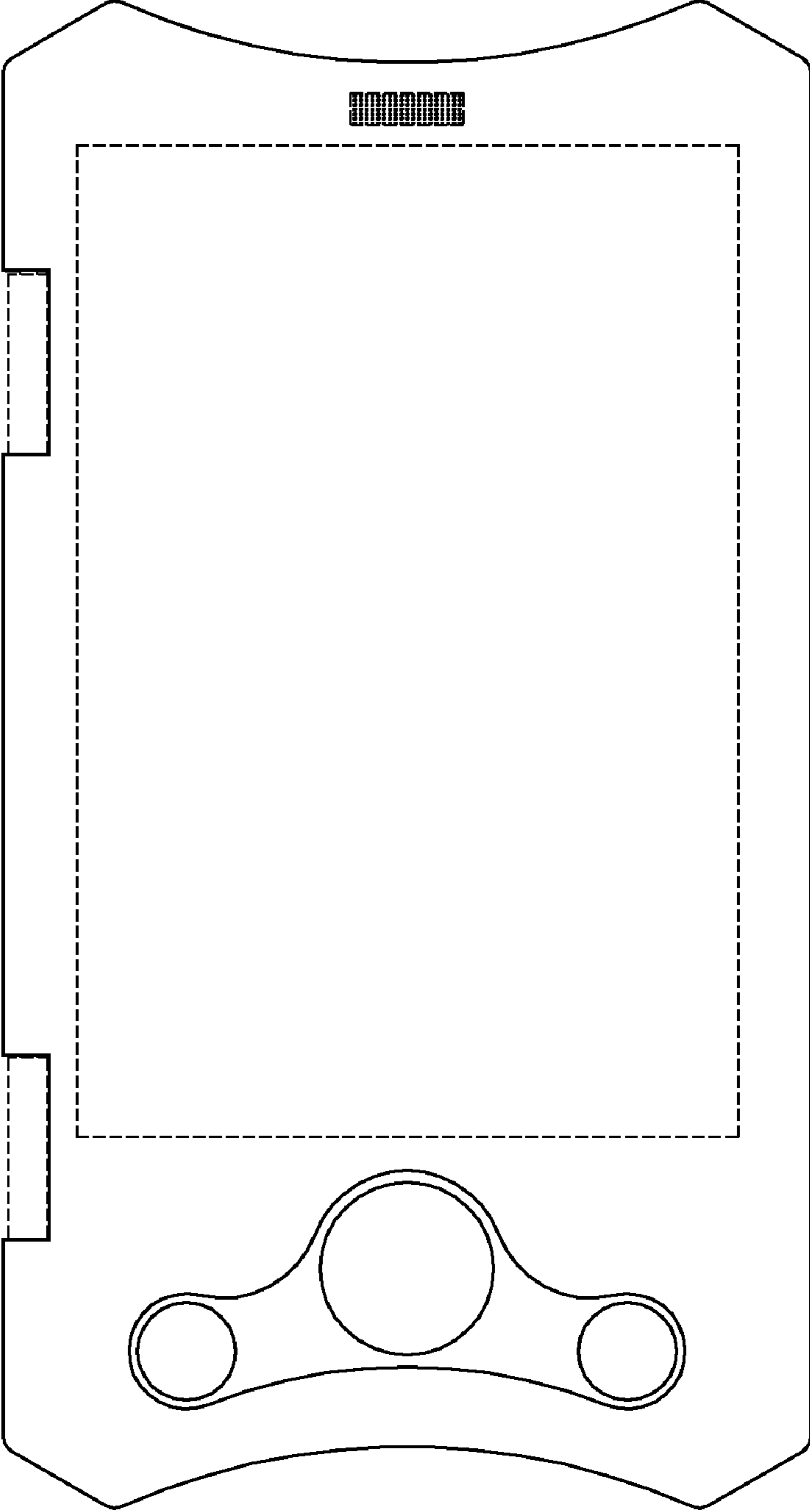
