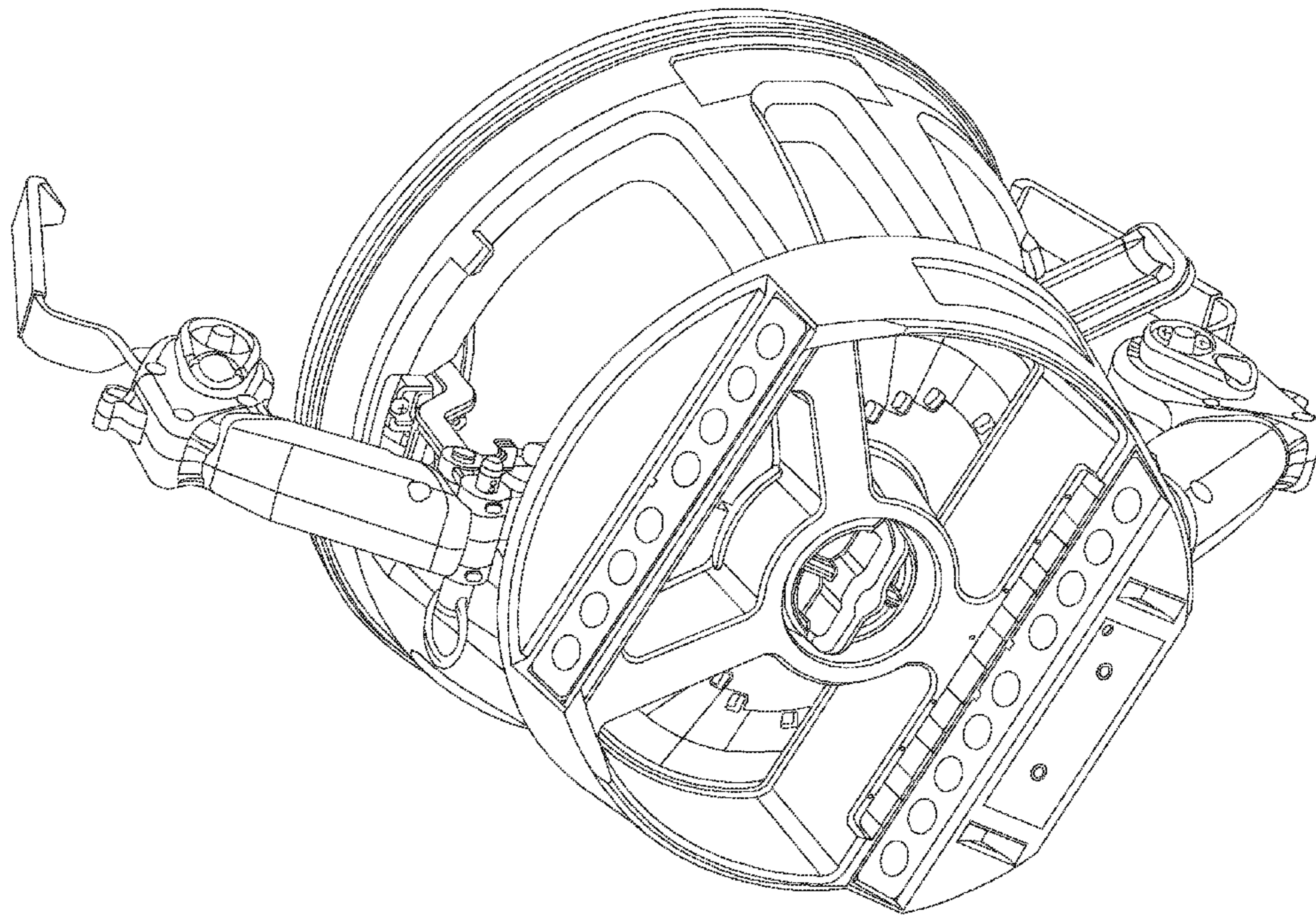
(57) **CLAIM**

The ornamental design for a vehicle wheel target mount assembly, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective upper front-left view of the vehicle wheel target mount assembly of the present invention; FIG. 2 is a perspective lower front-right view of the embodiment shown in FIG. 1; FIG. 3 is a perspective back view of the embodiment shown in FIG. 1; FIG. 4 is a left side perspective view of the embodiment shown in FIG. 1; FIG. 5 is a bottom plan view of the embodiment shown in FIG. 1; FIG. 6 is a front elevation view of the embodiment shown in FIG. 1; and, FIG. 7 is a back elevation view of the embodiment shown in FIG. 1.

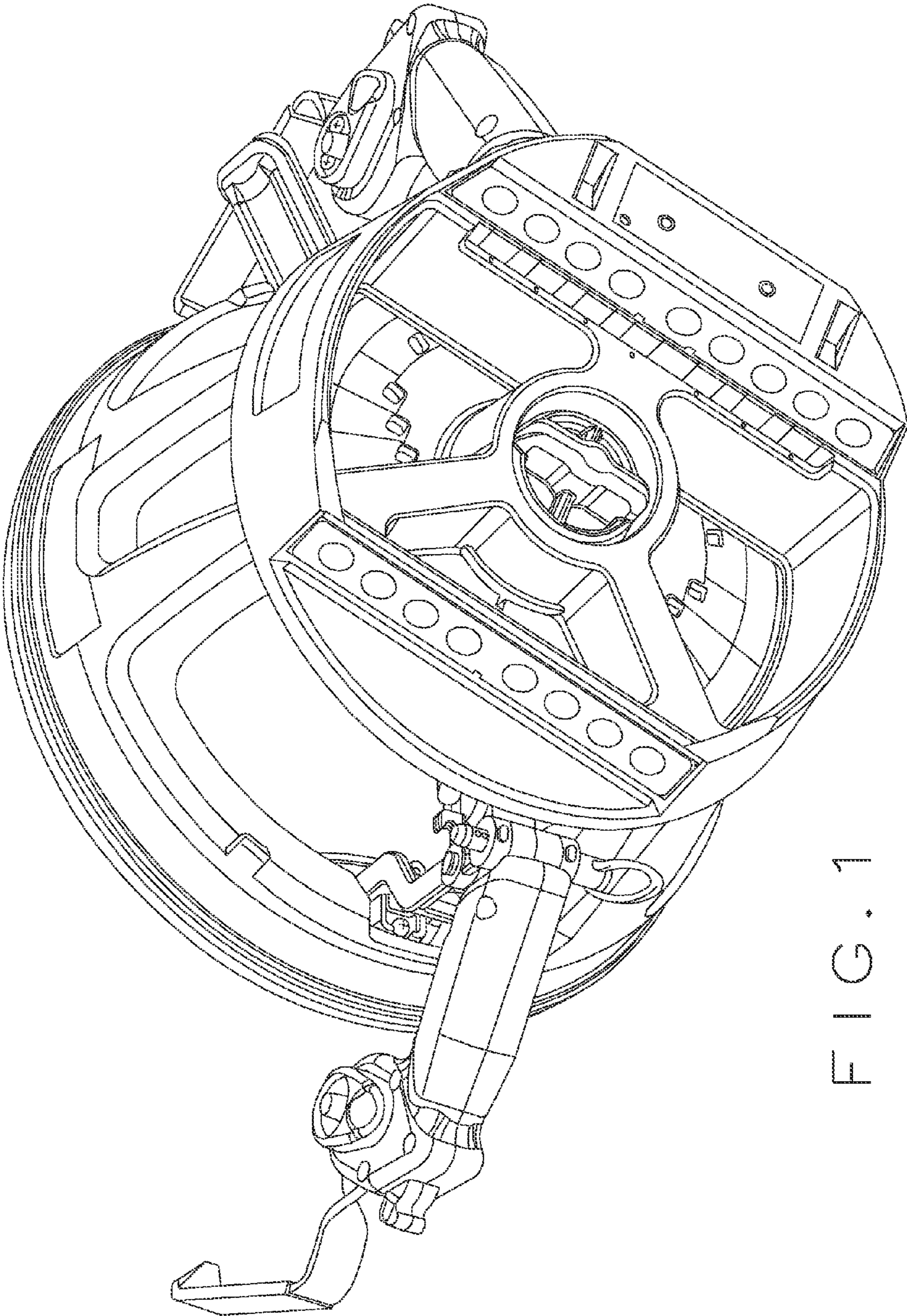

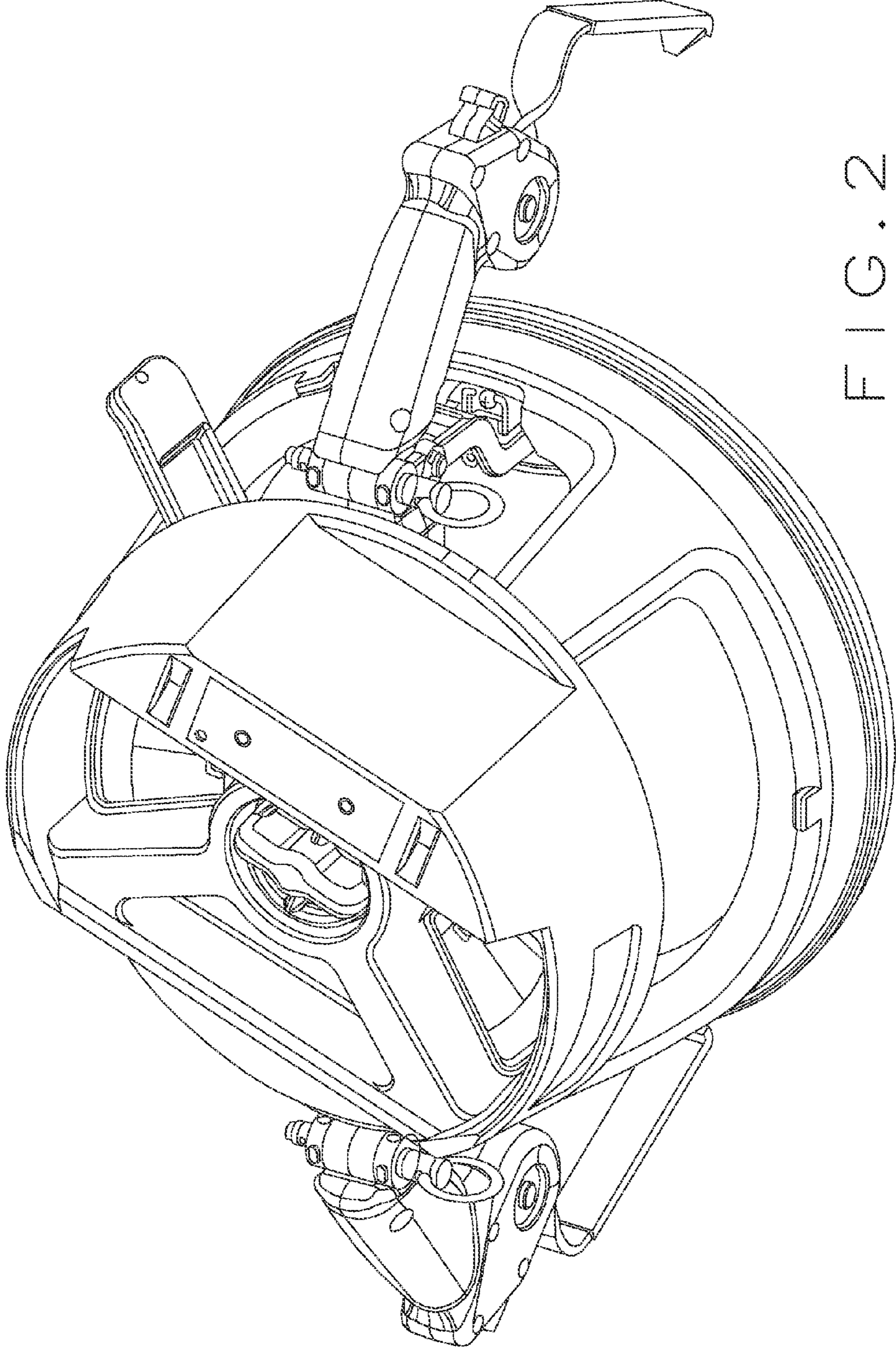

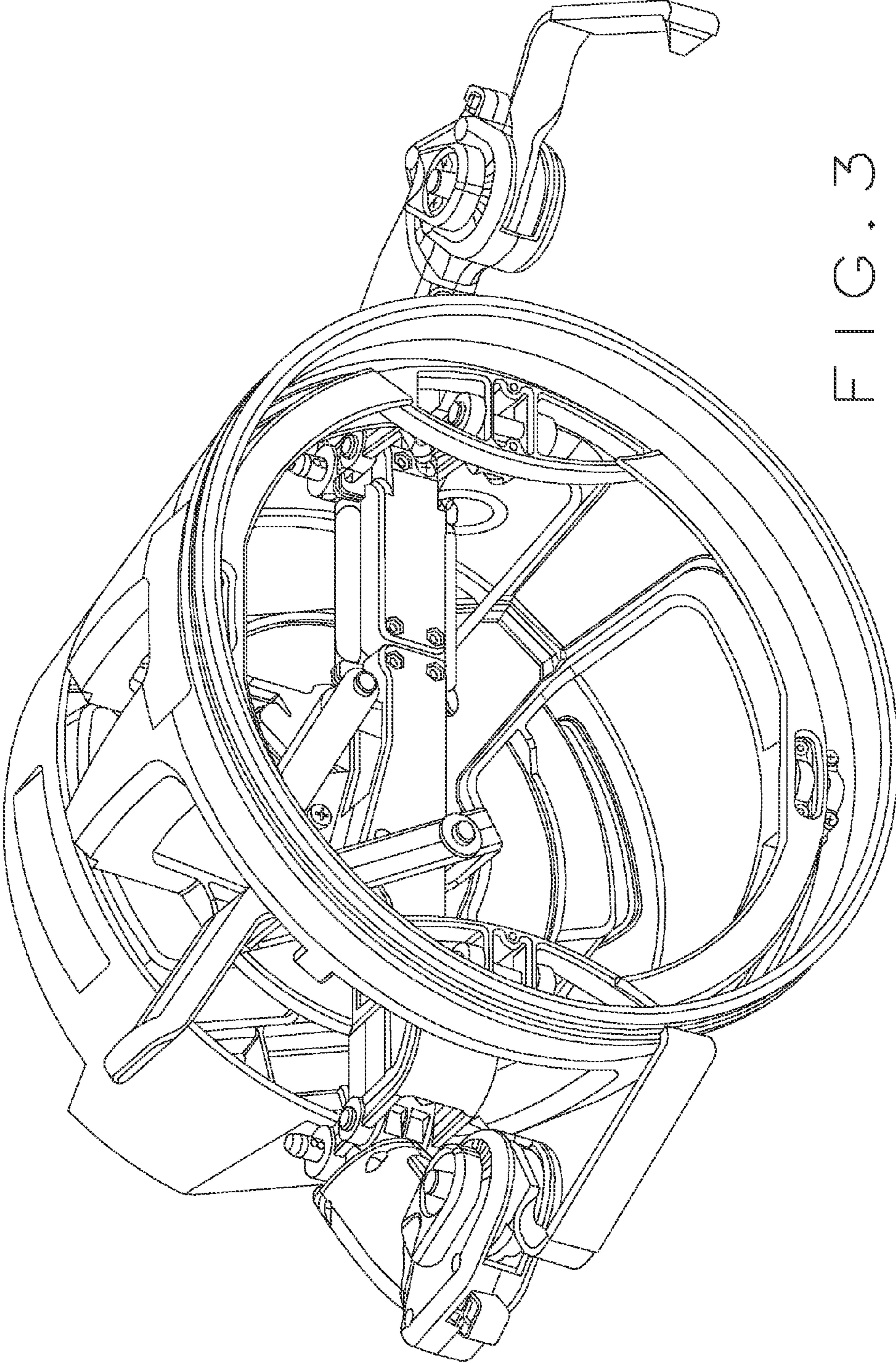

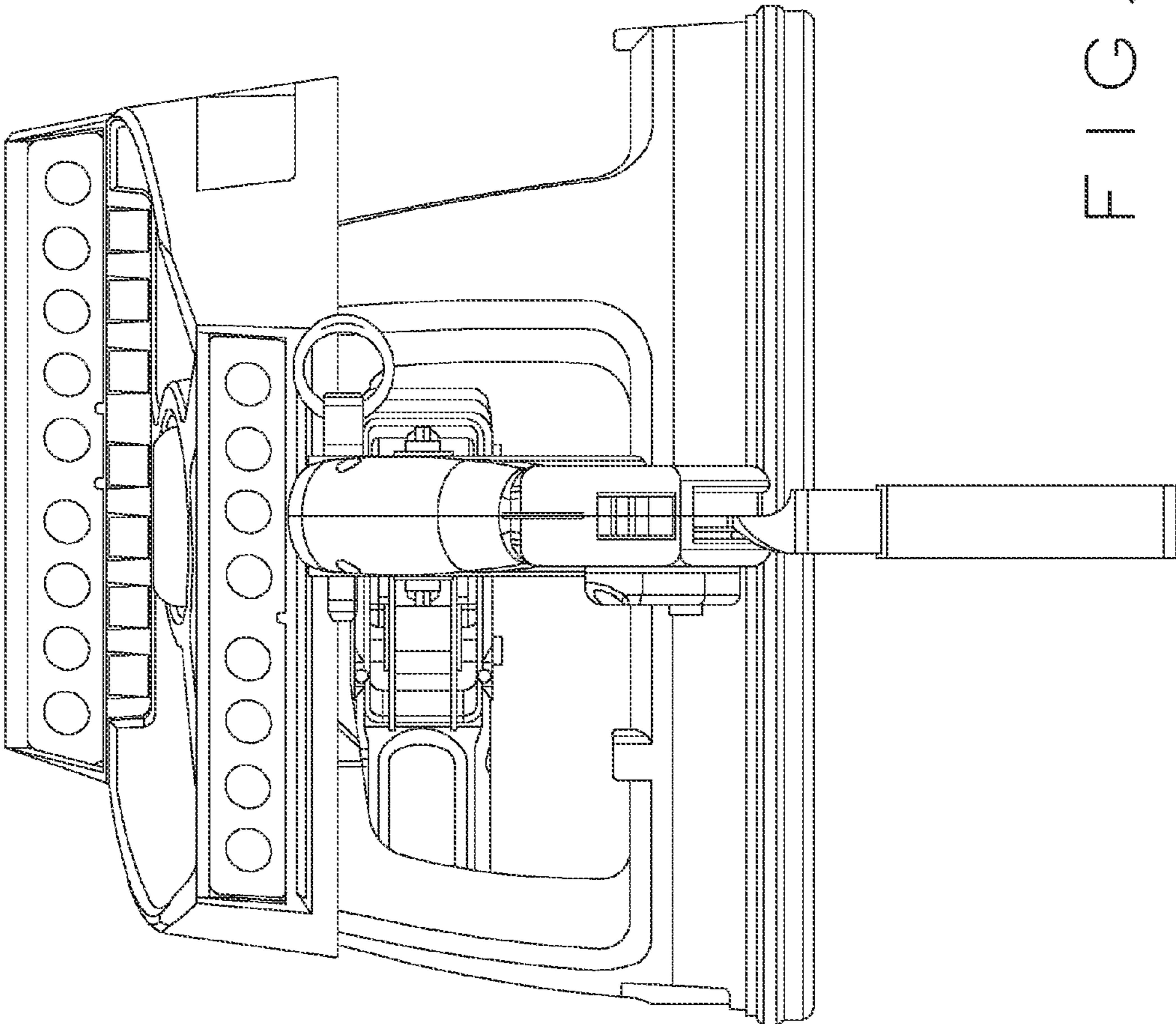

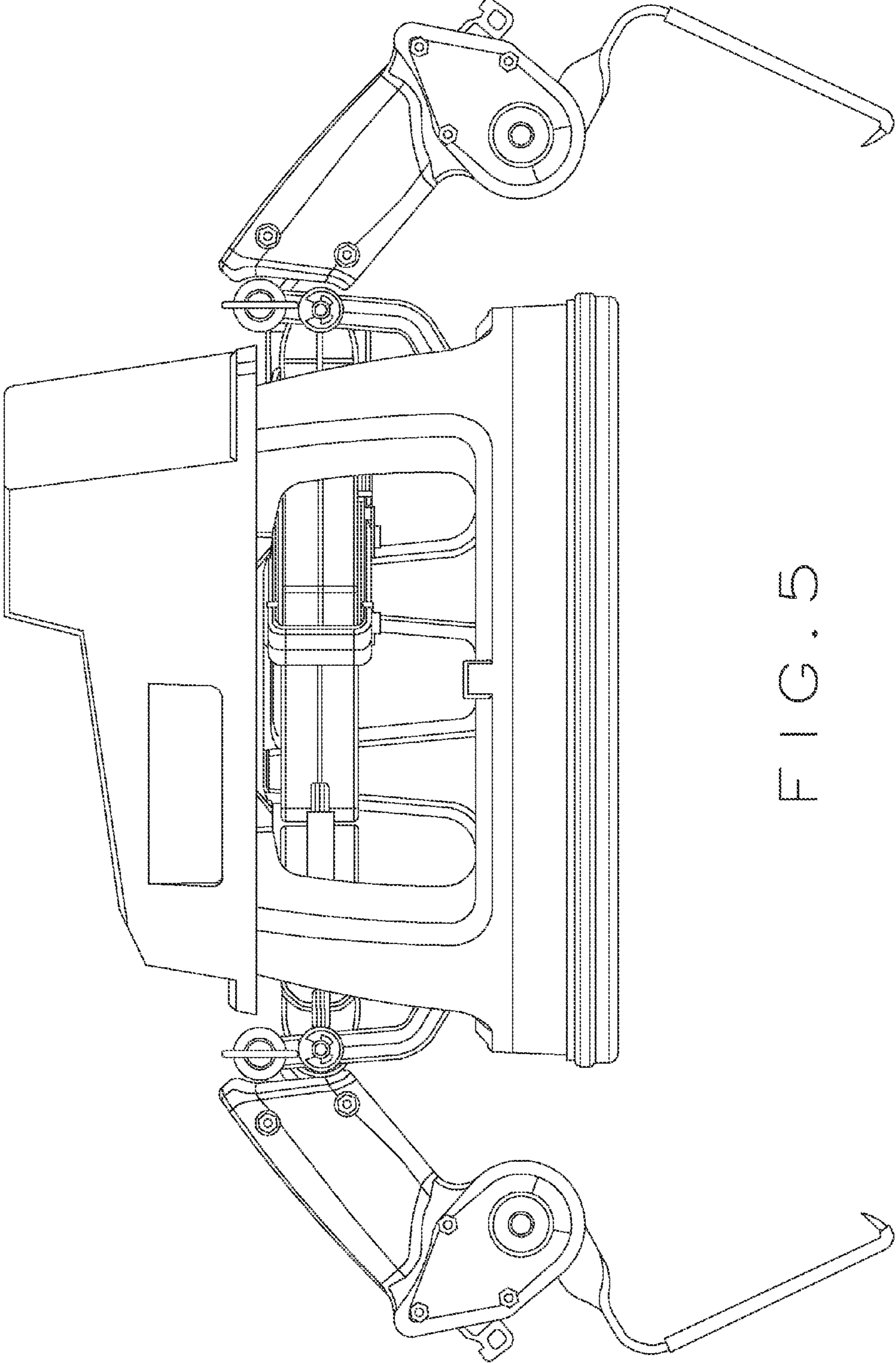

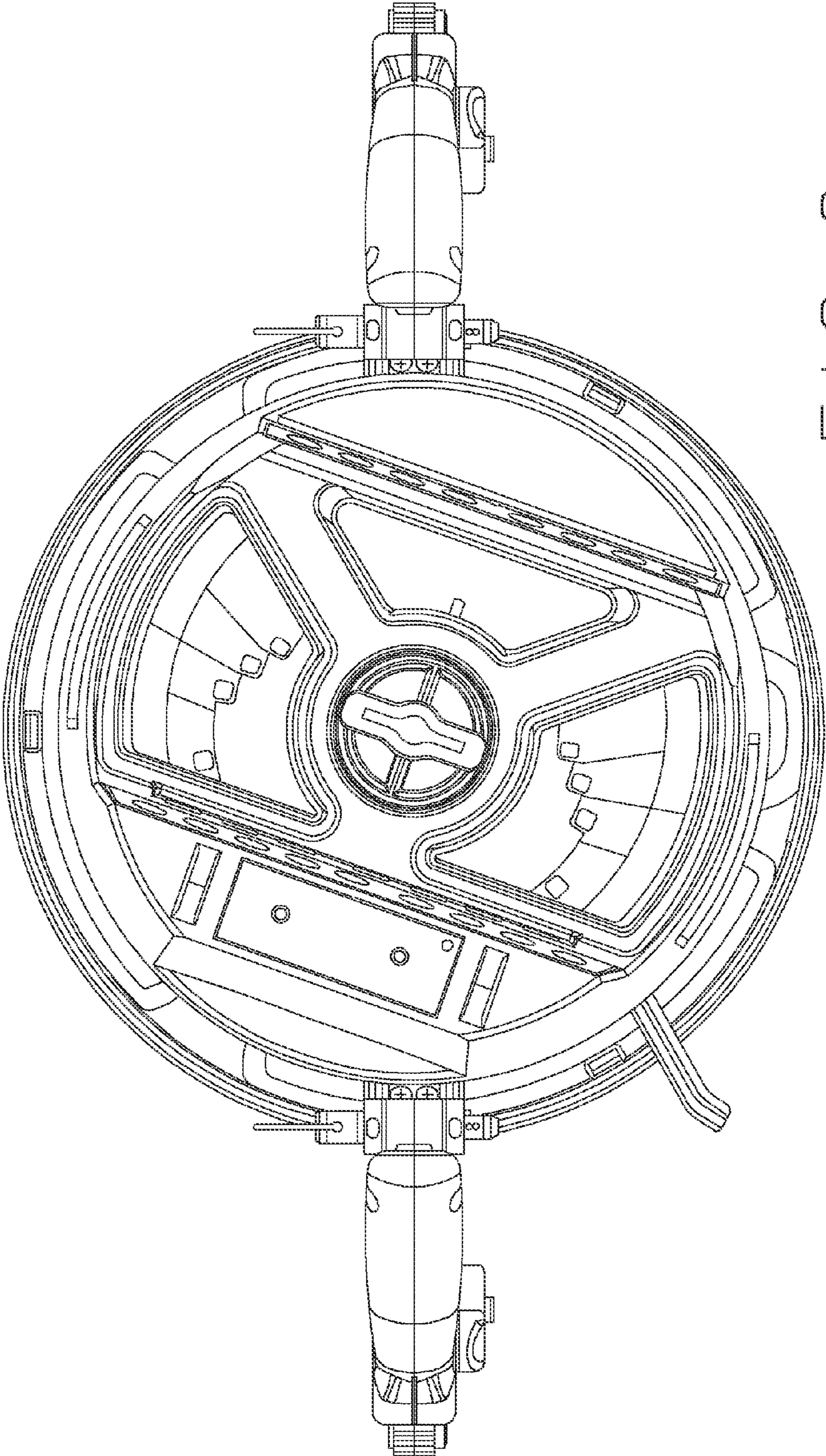

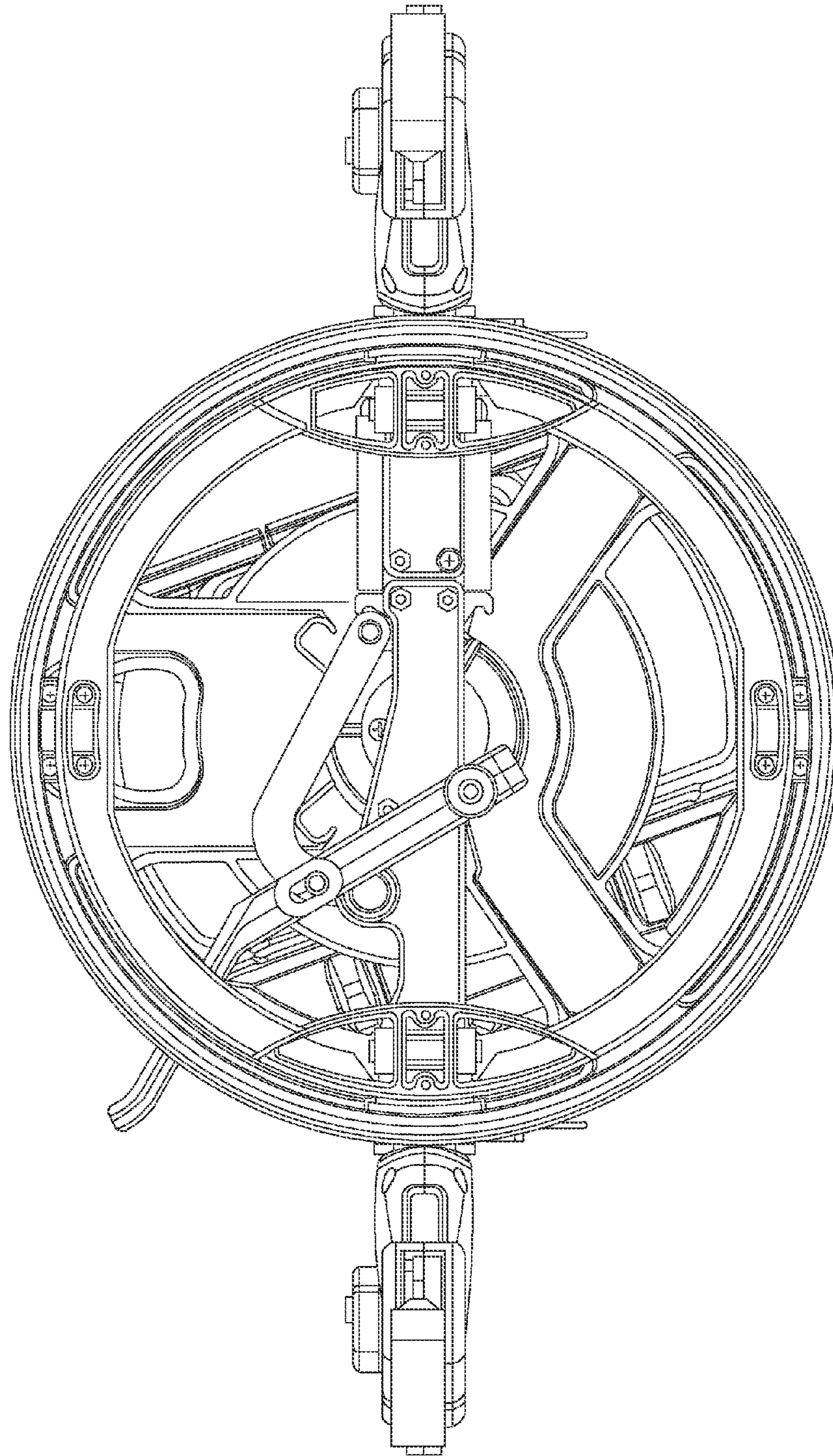
